
(57) **CLAIM**

The ornamental design for a luminaire, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the new design for a luminaire as seen from the top, right side; FIG. 2 is a right side elevational view, the left side being a mirror image thereof; FIG. 3 is a front elevational view, the rear elevational view being a mirror image thereof; FIG. 4 is a top plan view thereof; and, FIG. 5 is a bottom plan view thereof. The broken lines depicting portions of the luminaire in the drawing are for illustrative purposes only and form no part of the claimed design.










