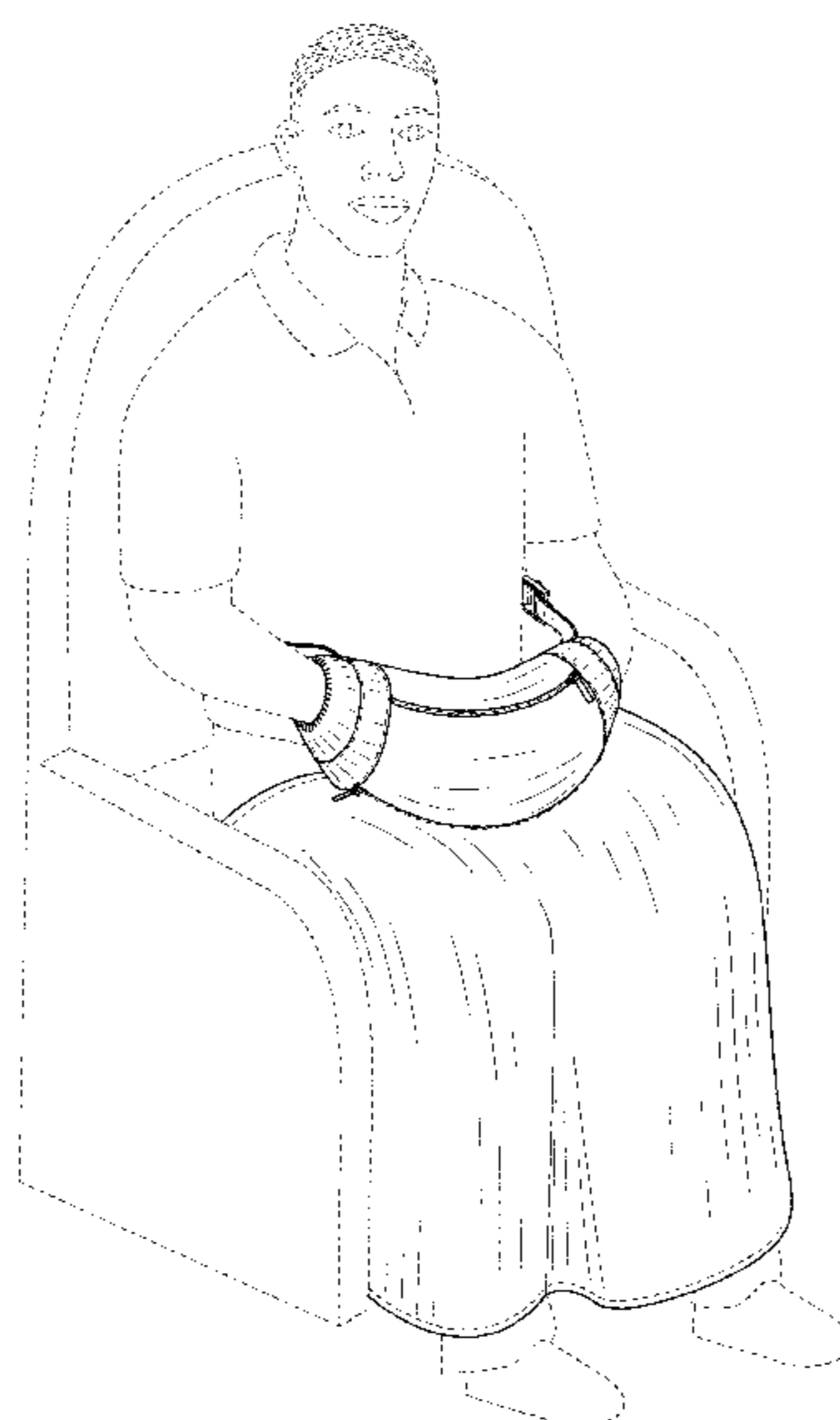
(57) **CLAIM**

The ornamental design for a combination blanket, hand warmer, and carrying pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a combination blanket, hand warmer, and carrying pack, showing our new design in a condition of use in an extended configuration;
FIG. 2 is a front elevational view thereof, illustrated in a flat and extended configuration;
FIG. 3 is a rear elevational view of FIG. 2;
FIG. 4 is a left-side elevational view of FIG. 2;
FIG. 5 is a right-side elevational view of FIG. 2;
FIG. 6 is a top plan view of FIG. 2;
FIG. 7 is a bottom plan view of FIG. 2;
FIG. 8 is a perspective view thereof, illustrated with the blanket stowed in the carrying pack in a collapsed configuration;
FIG. 9 is a front elevational view of FIG. 8;
FIG. 10 is a rear elevational view of FIG. 8;
FIG. 11 is a left-side elevational view of FIG. 8;
FIG. 12 is a rear elevational view of FIG. 8;
FIG. 13 is a top plan view of FIG. 8; and,
FIG. 14 is a bottom plan view of FIG. 8.
The broken lines showing a person and a chair in FIG. 1 depict environmental matter and form no part of the claimed design. The remaining broken lines represent stitching, and are part of the claimed design.

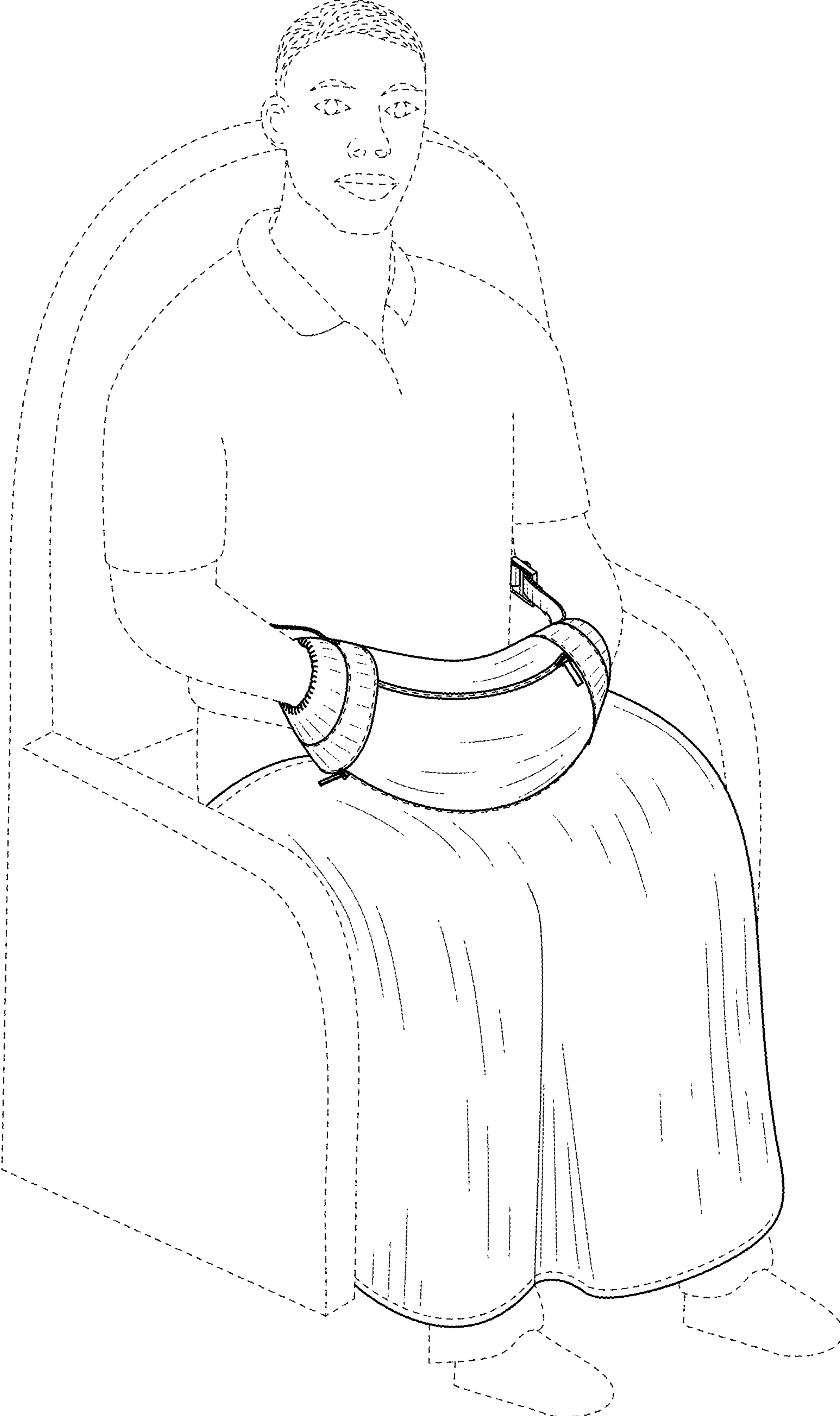

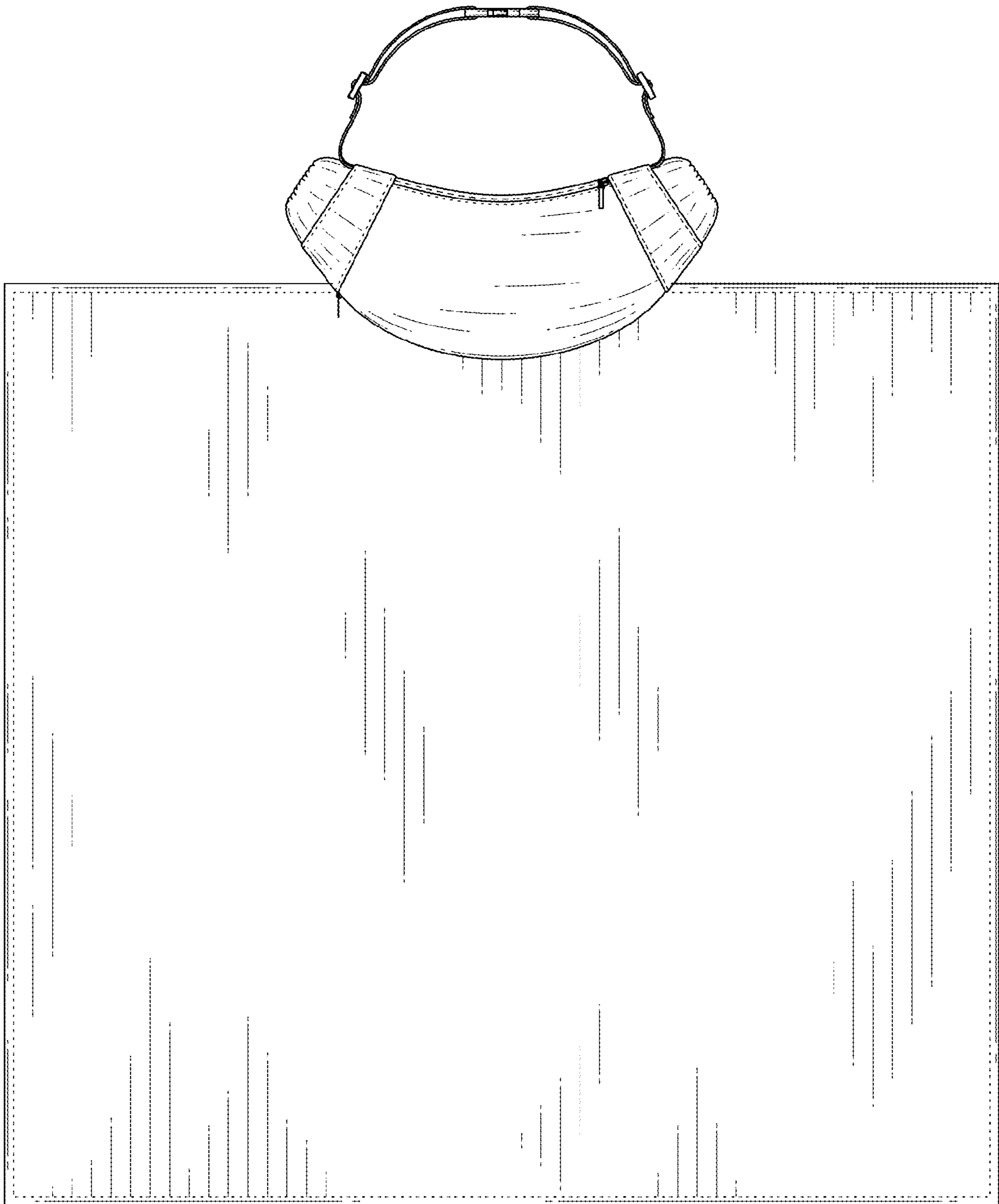

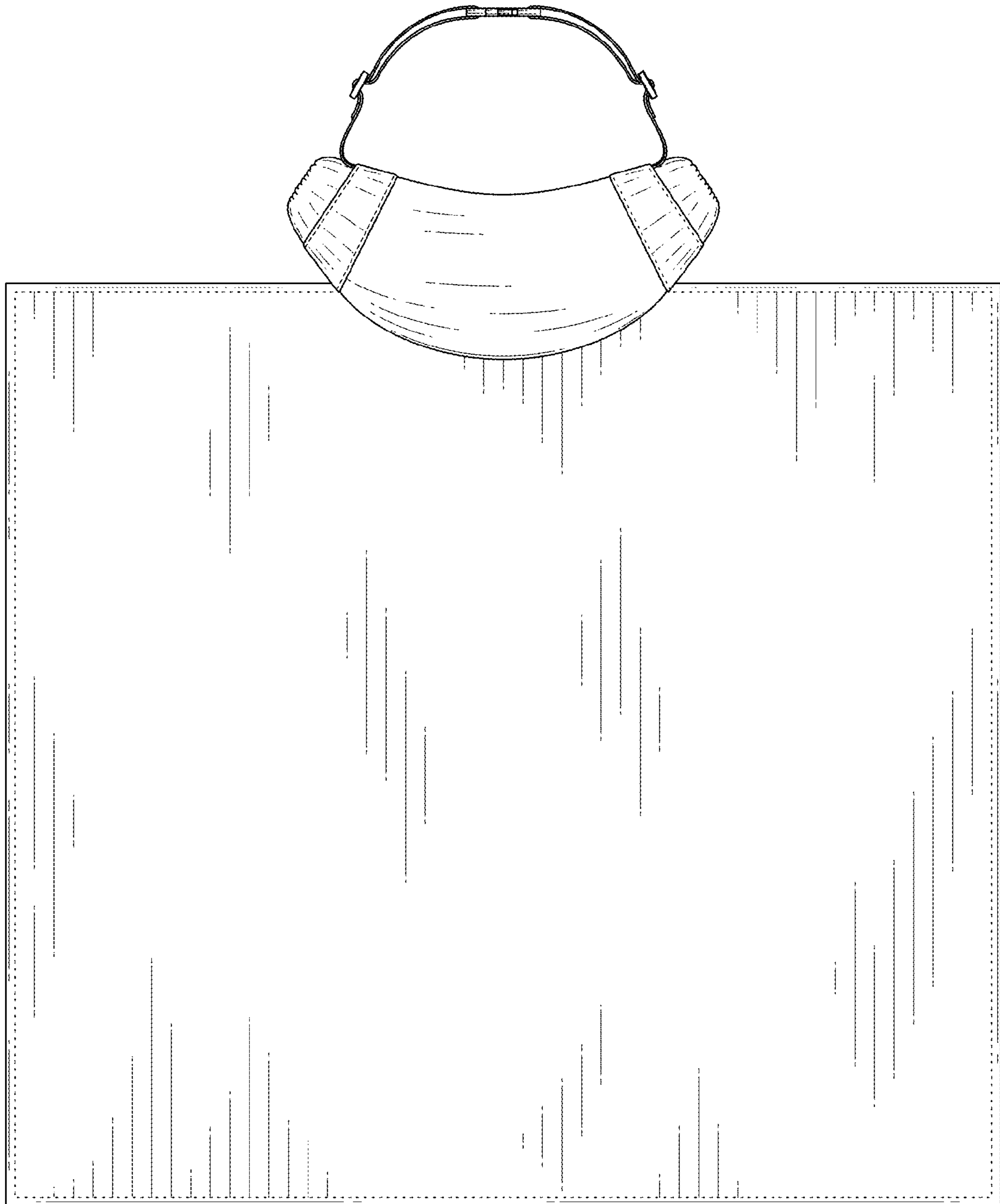

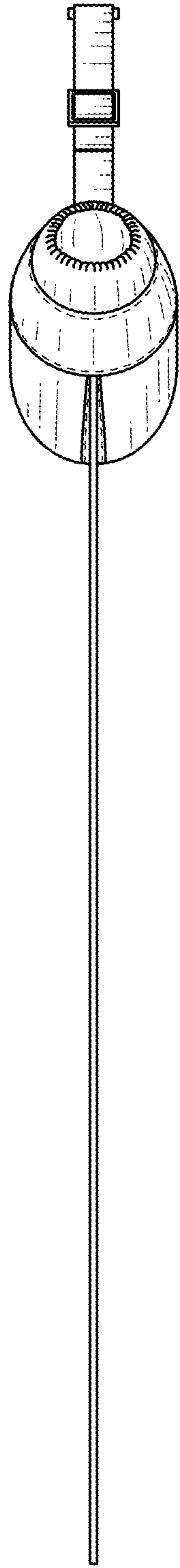

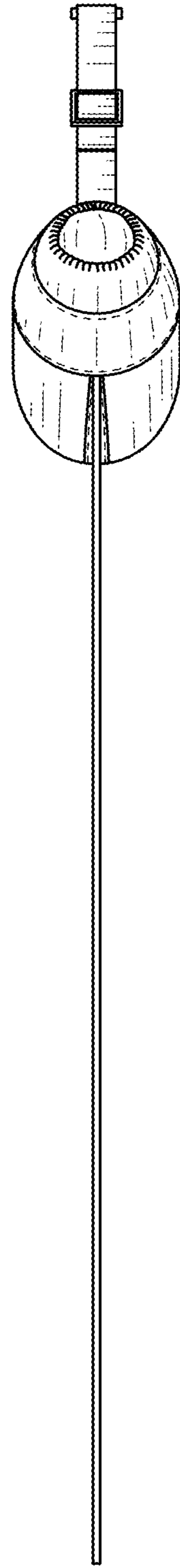

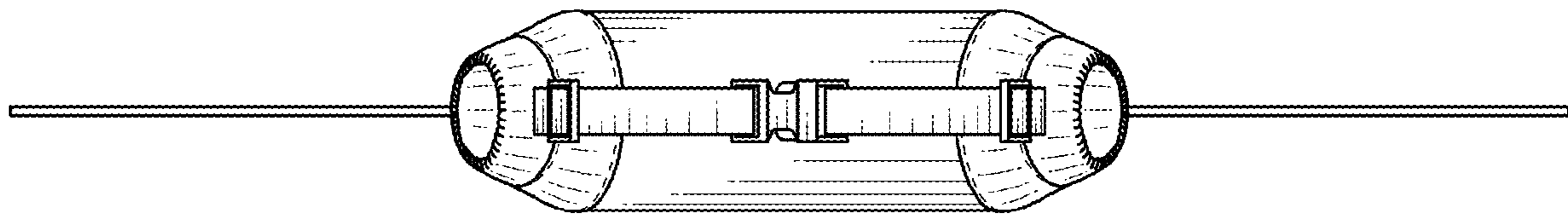

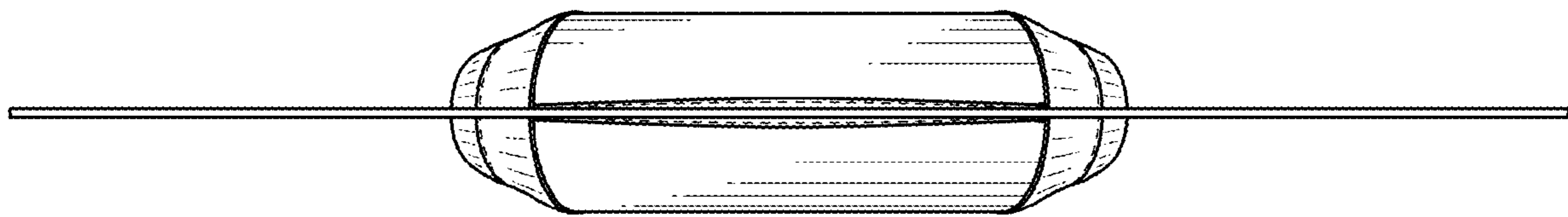

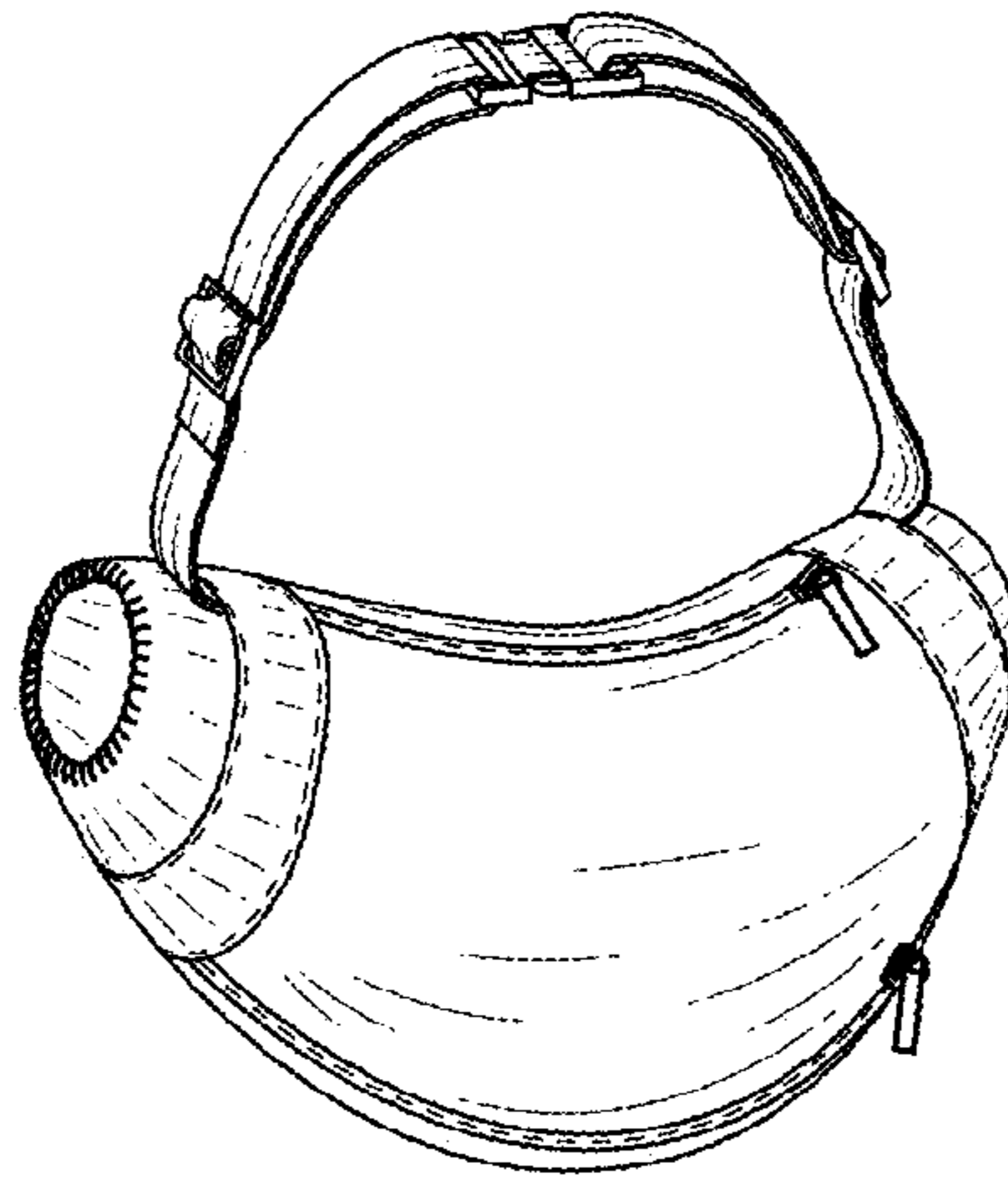

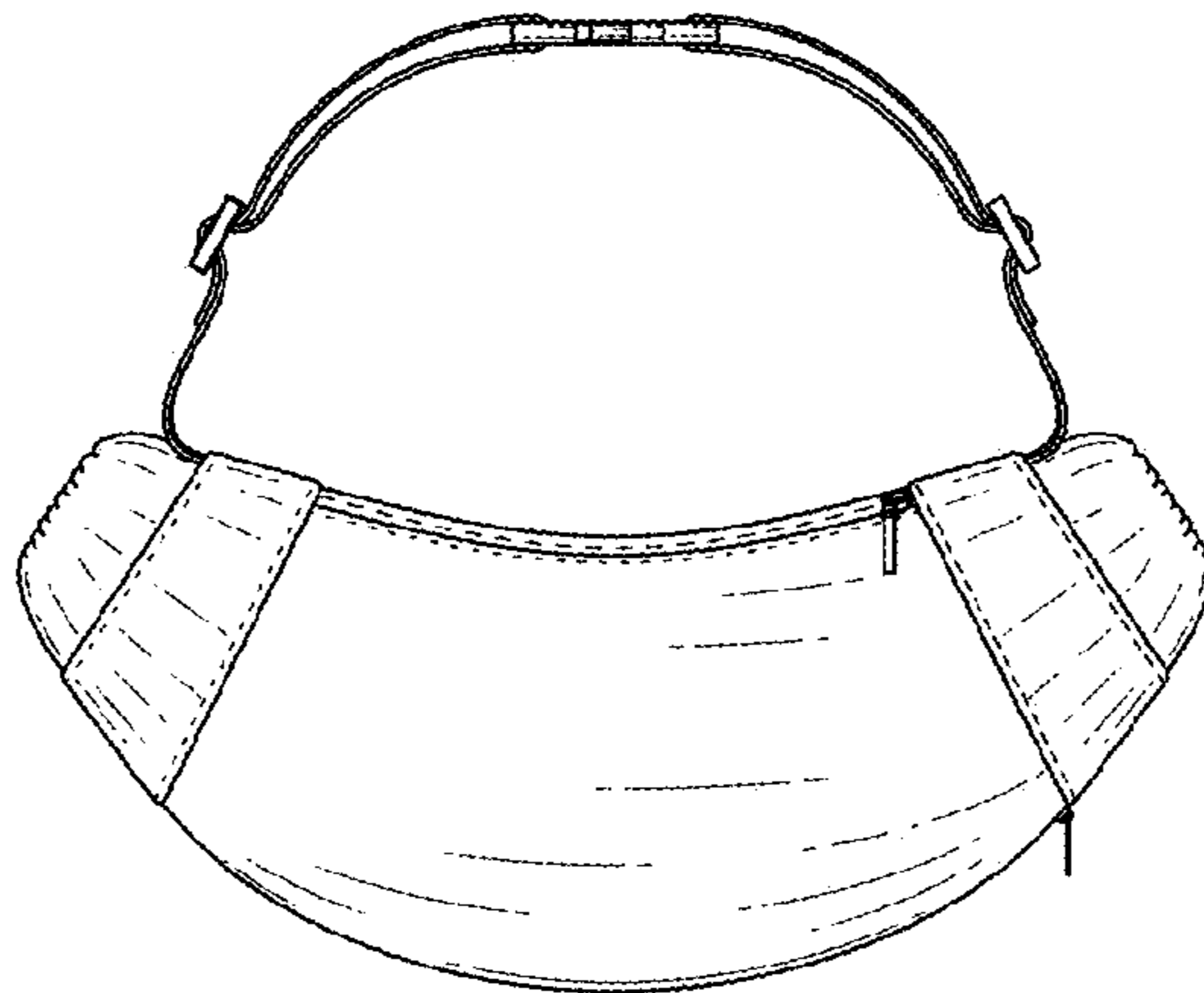

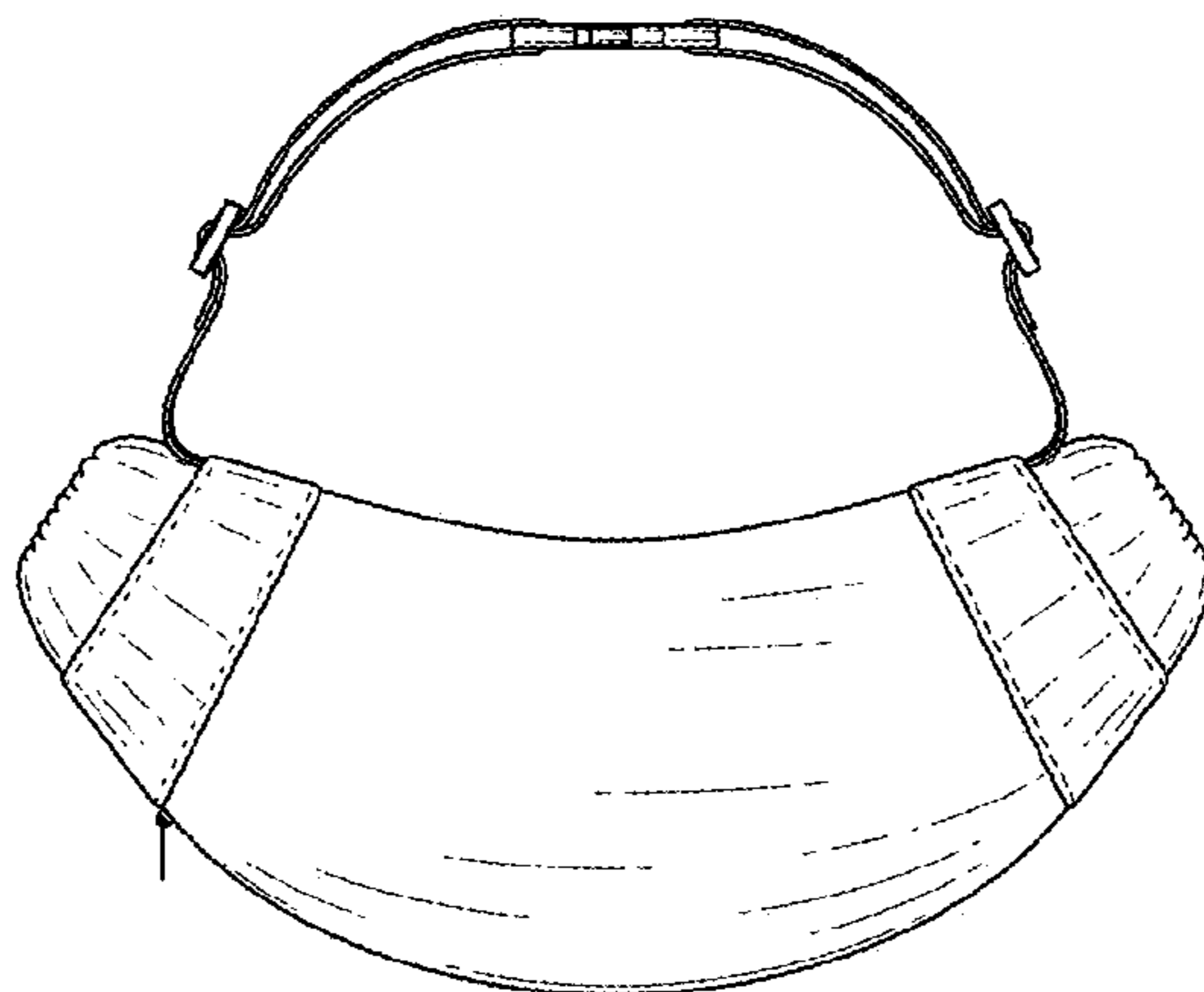

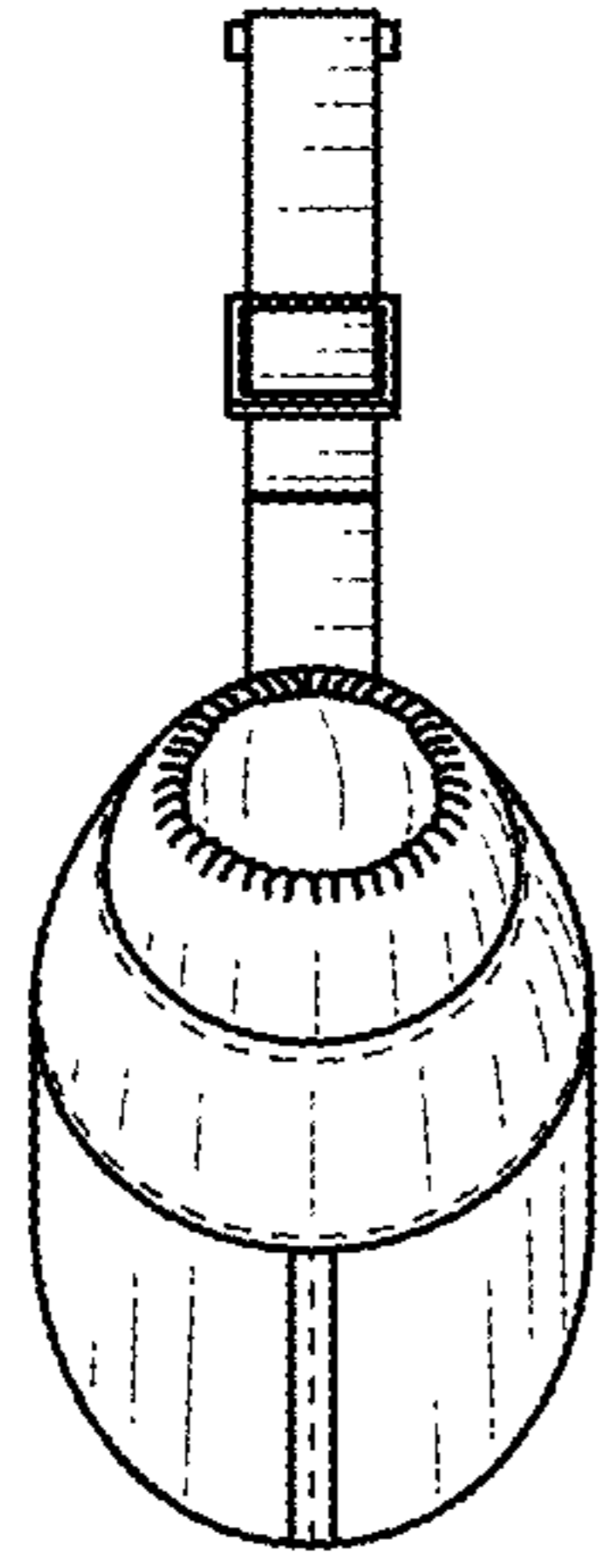

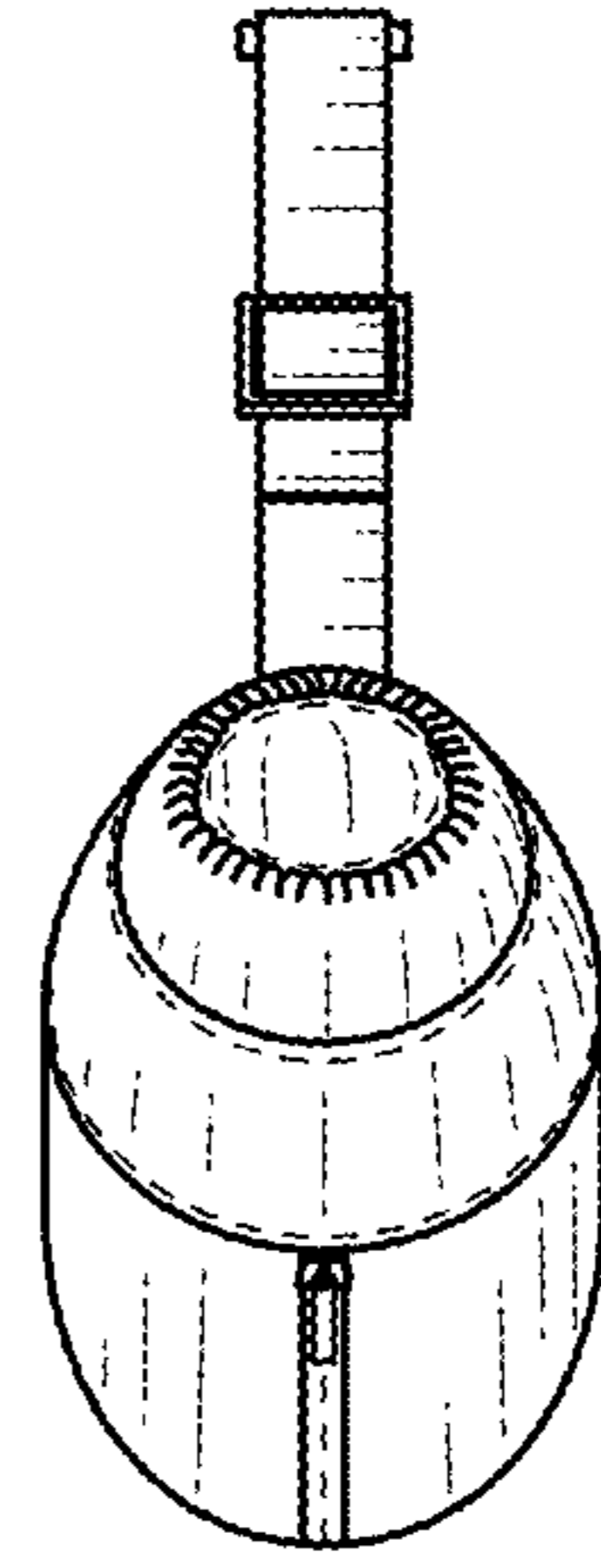

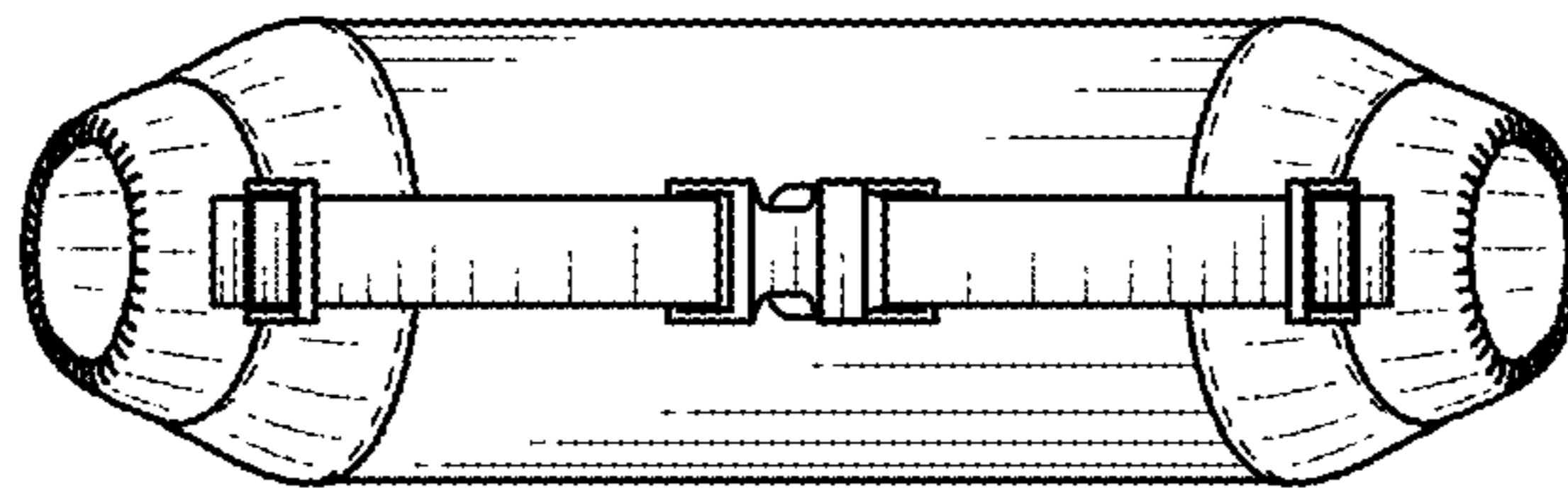

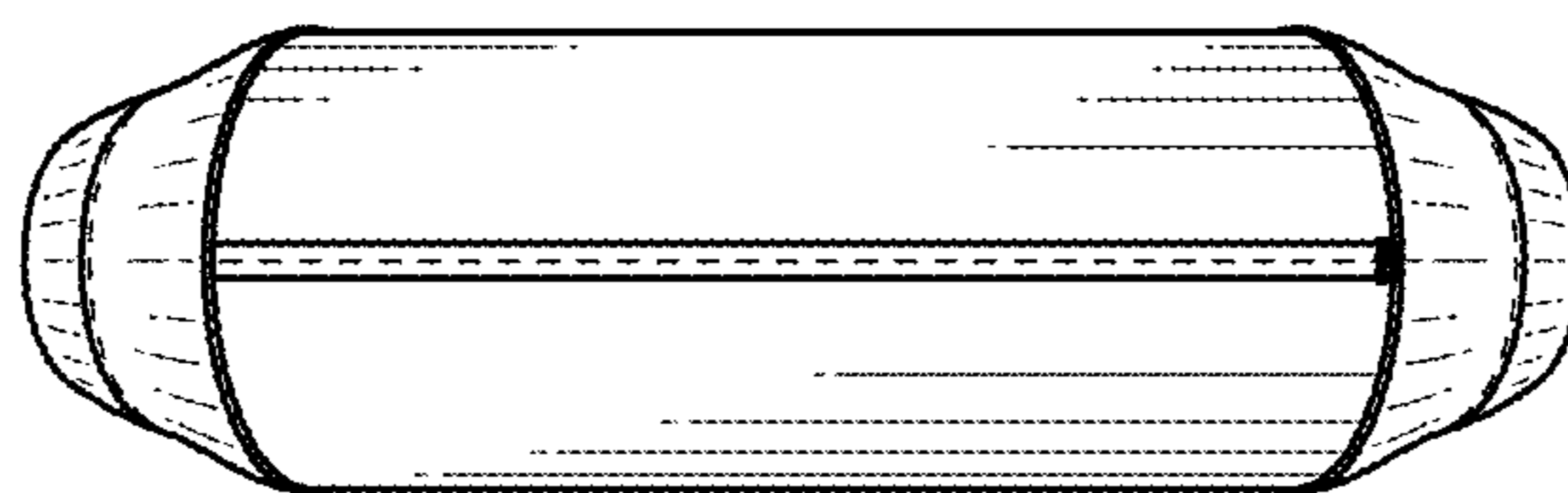
