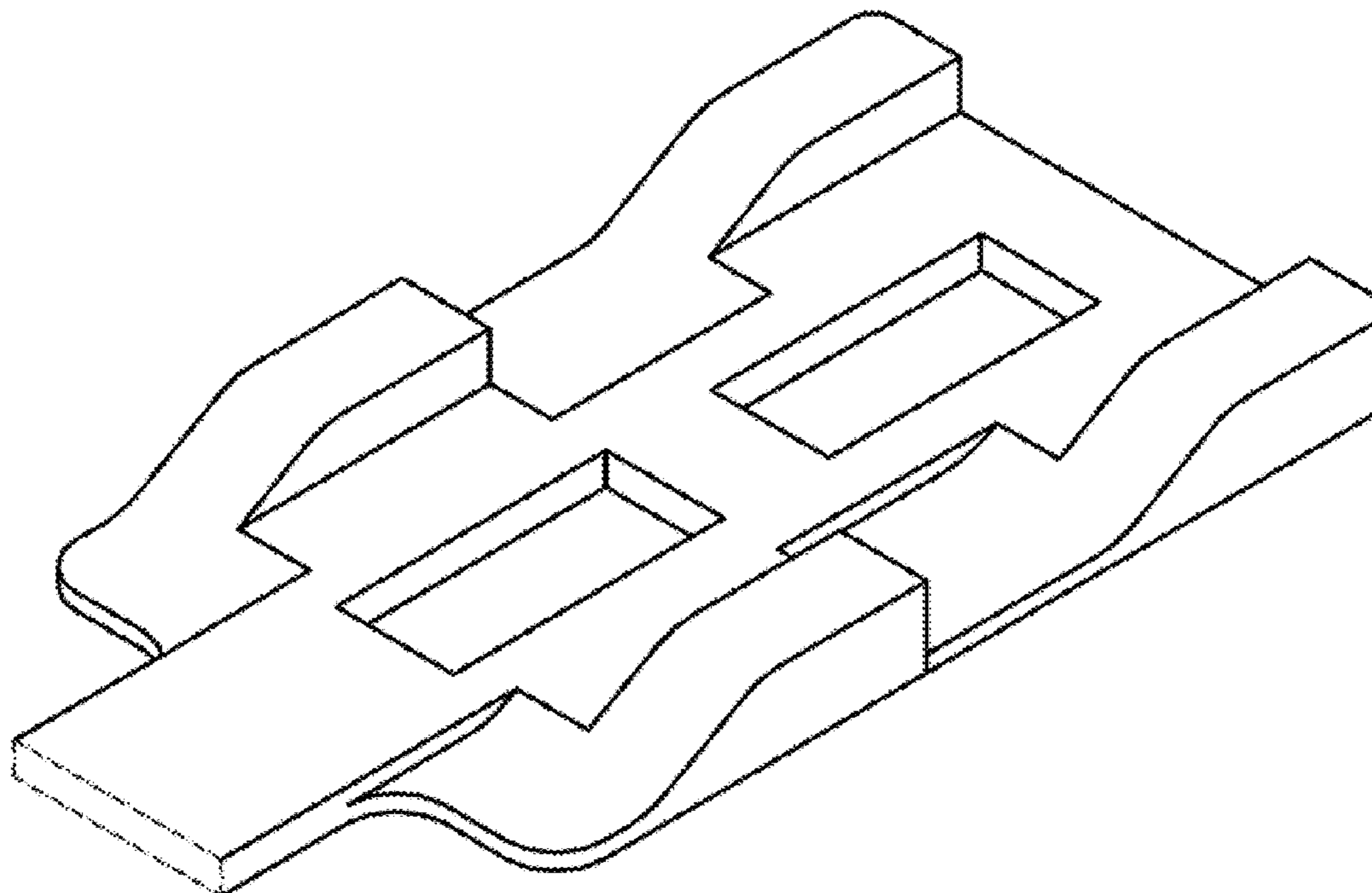

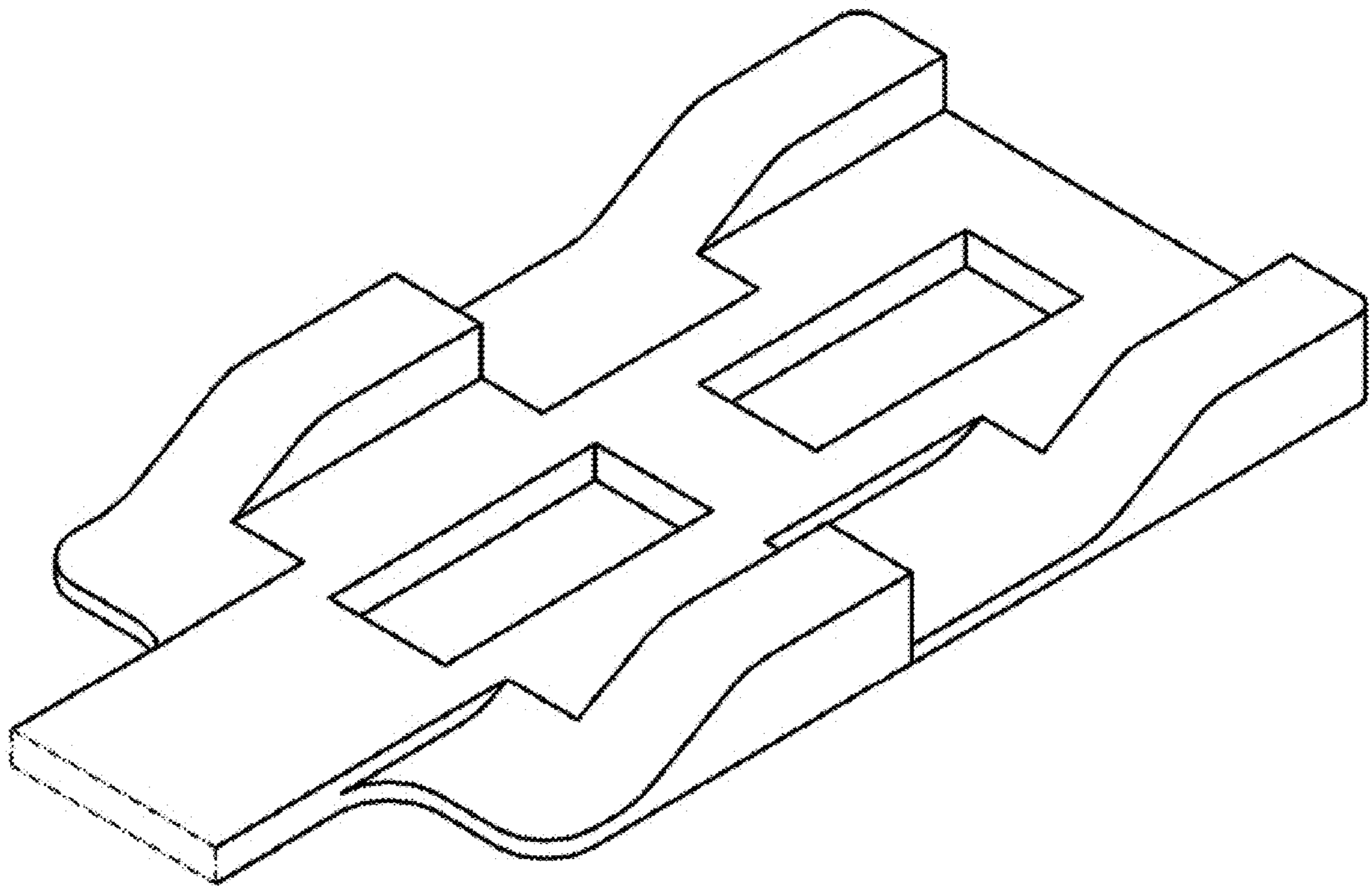

The claimed design is a partial design for the shoe studs support; the two-dotted chain lines in the figures indicate the boundary lines between the claimed part and the unclaimed part.

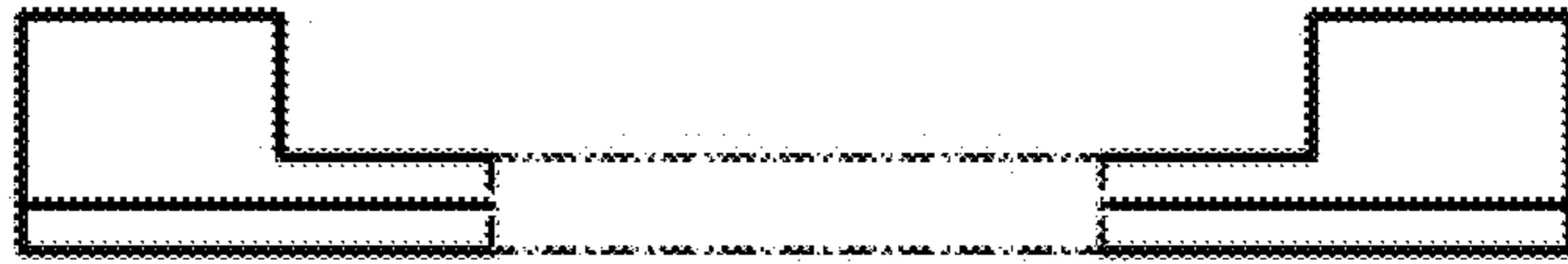

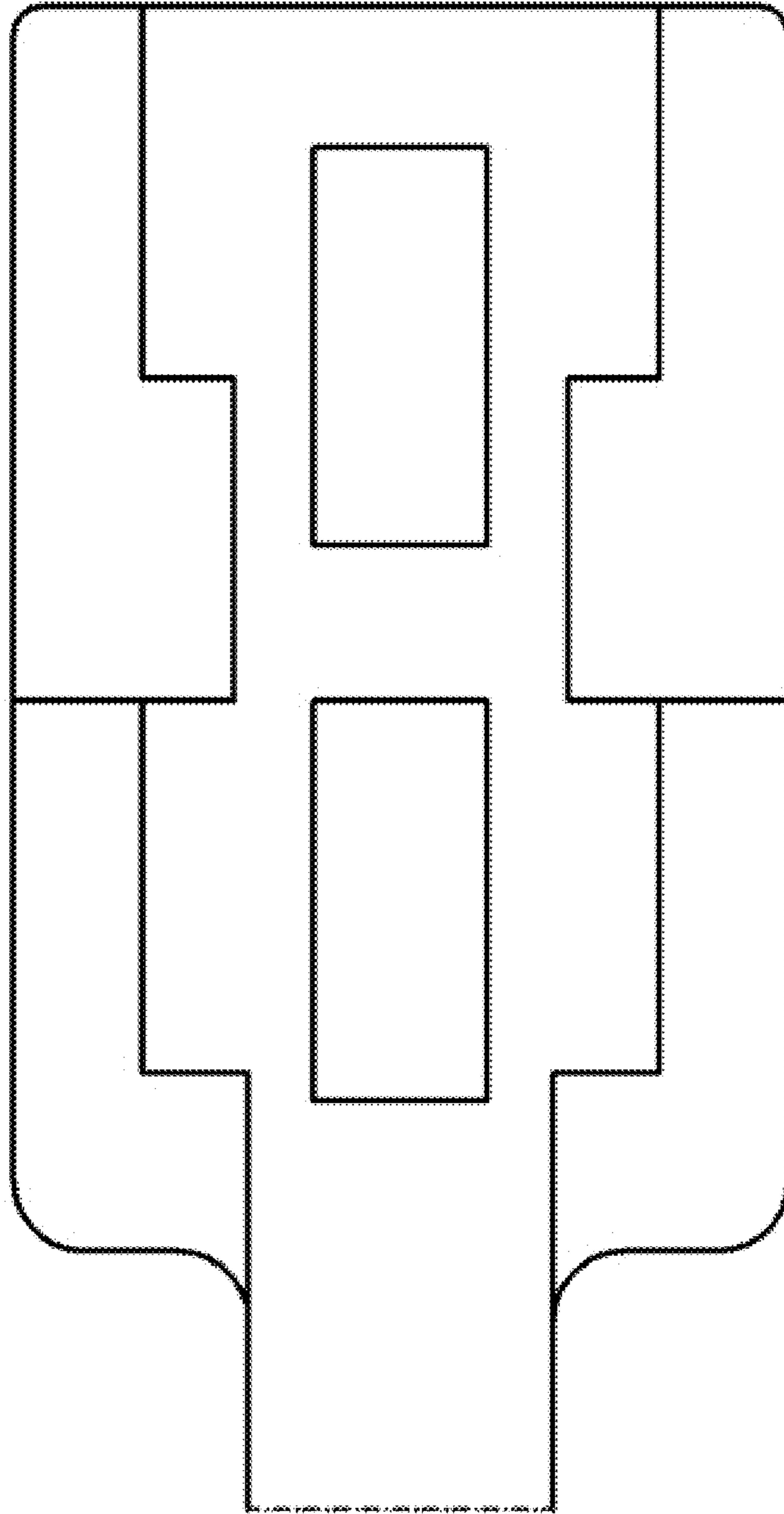

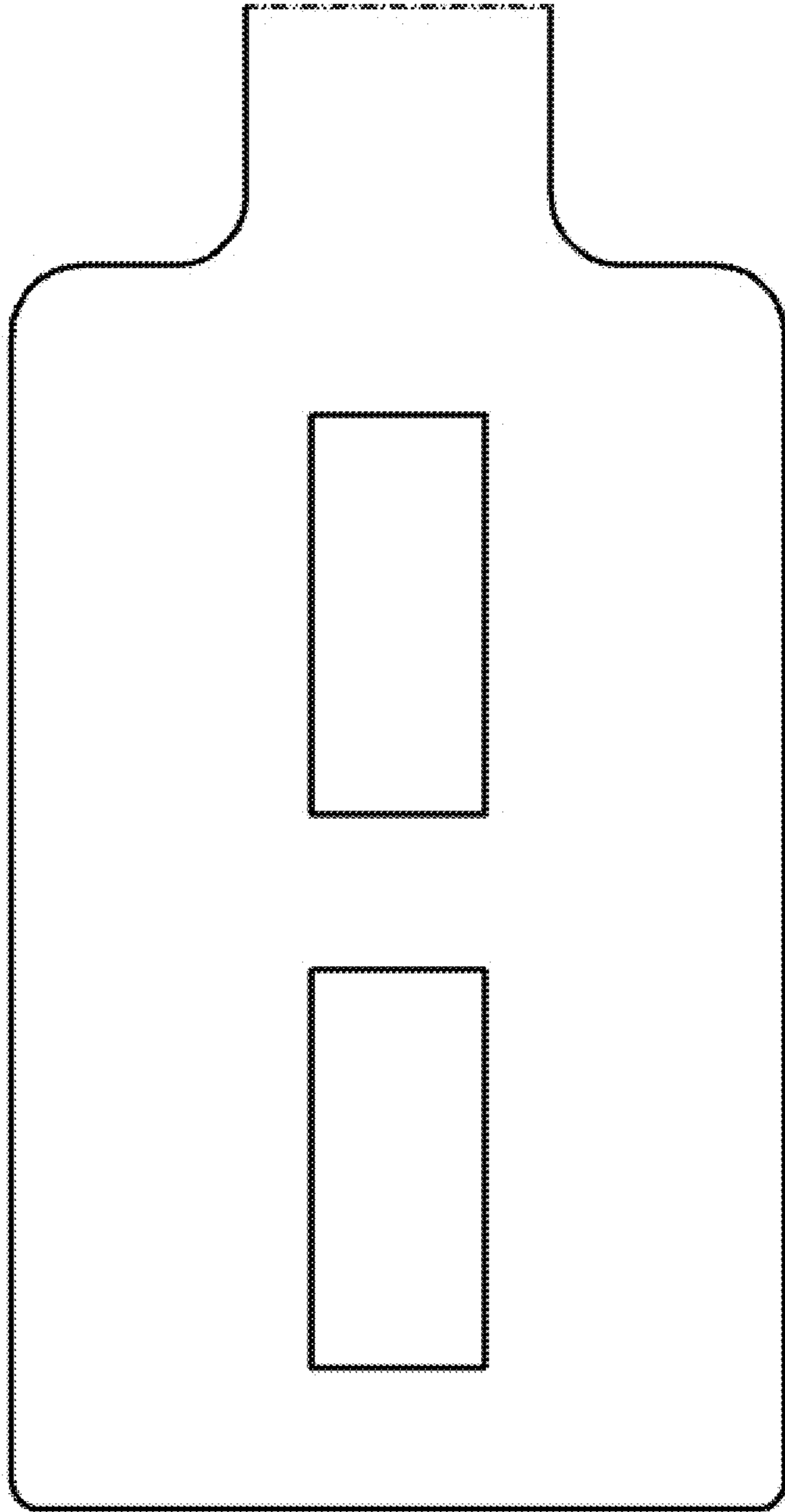

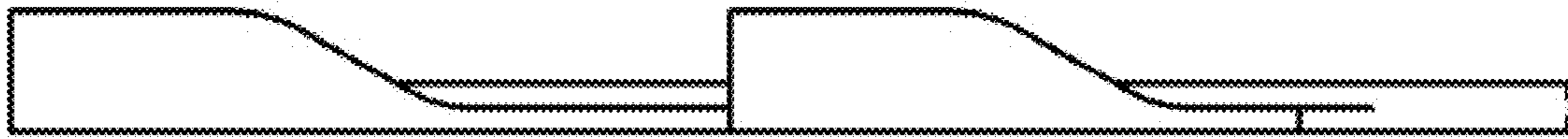
