**DESCRIPTION**

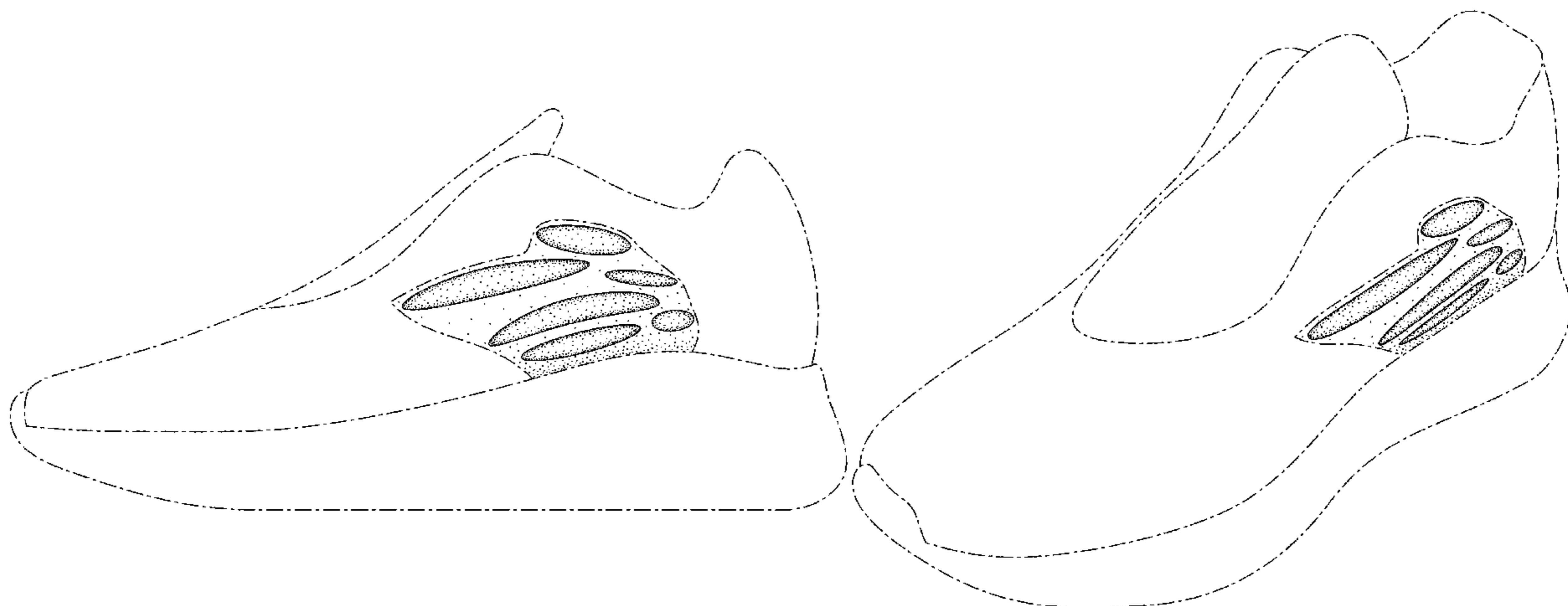
FIG. 1 is a side view of a shoe showing my new design;

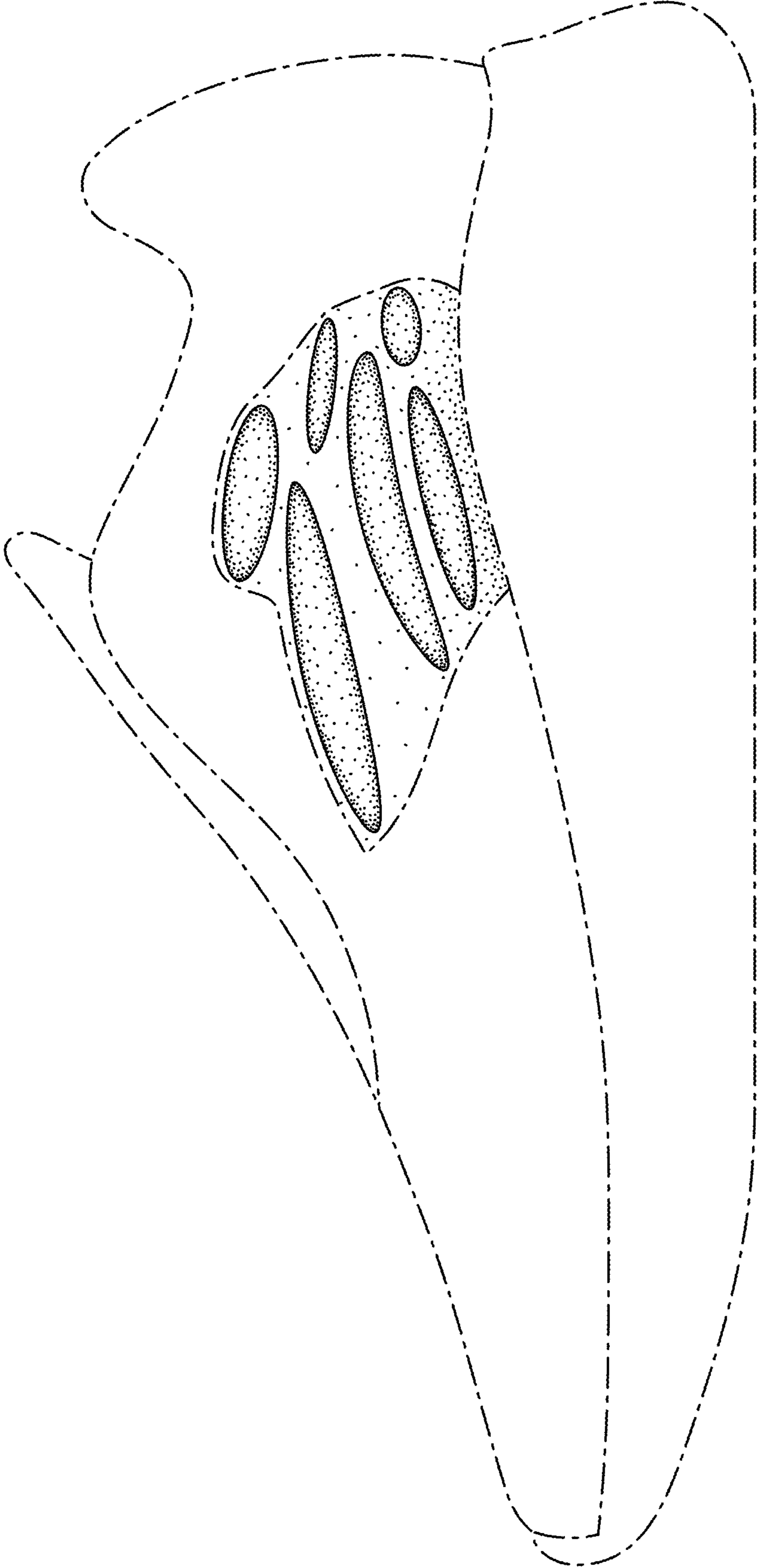

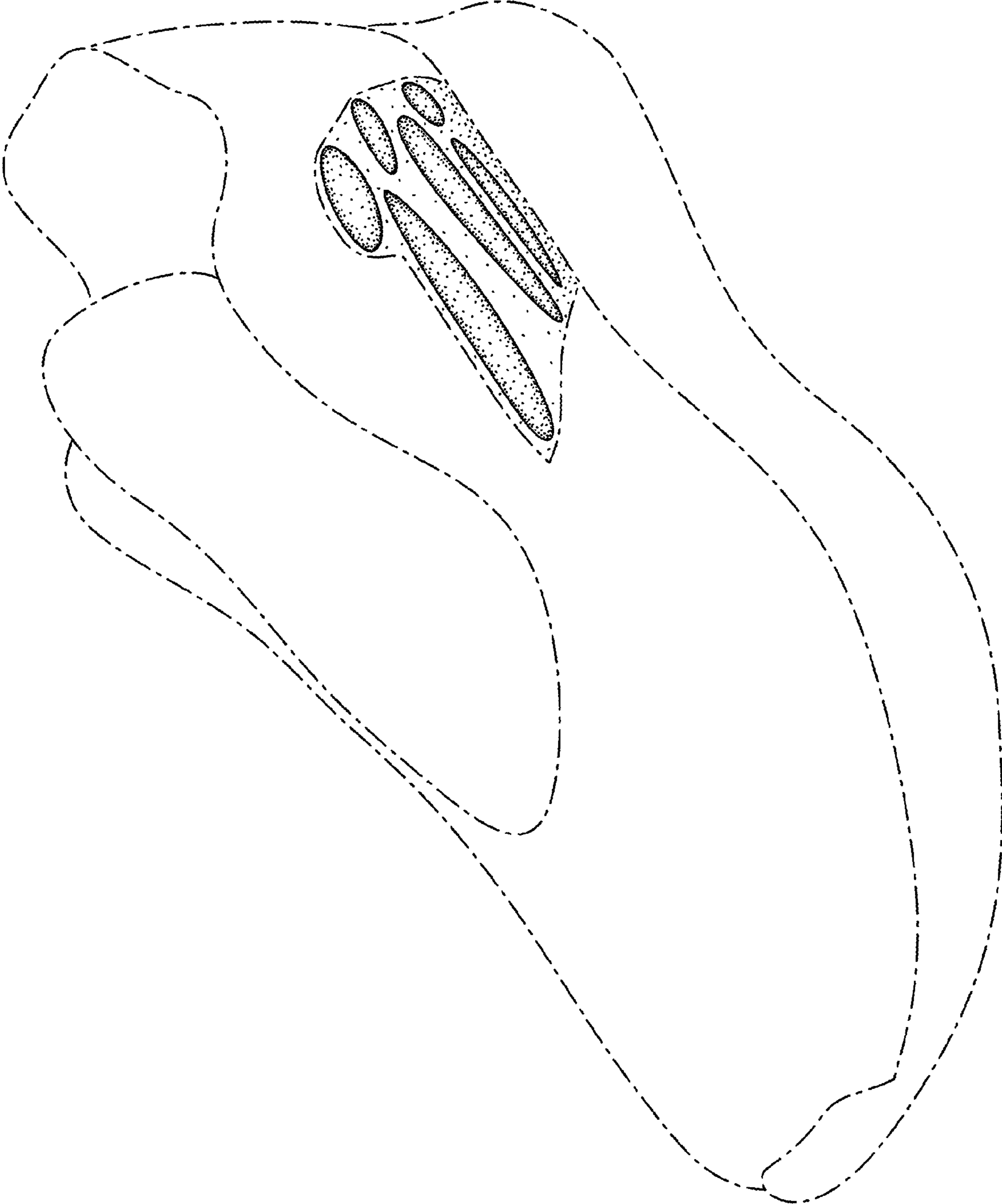

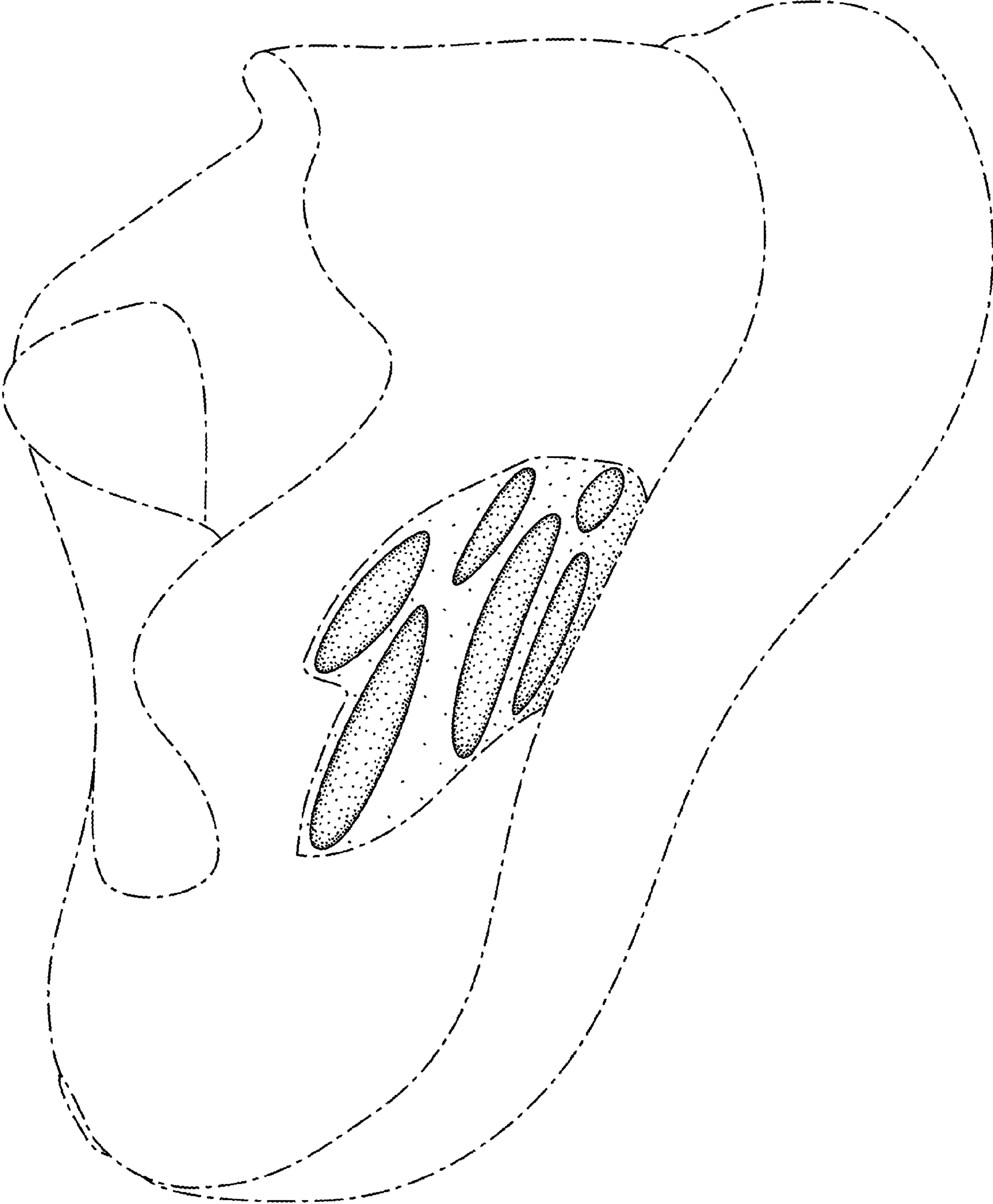
