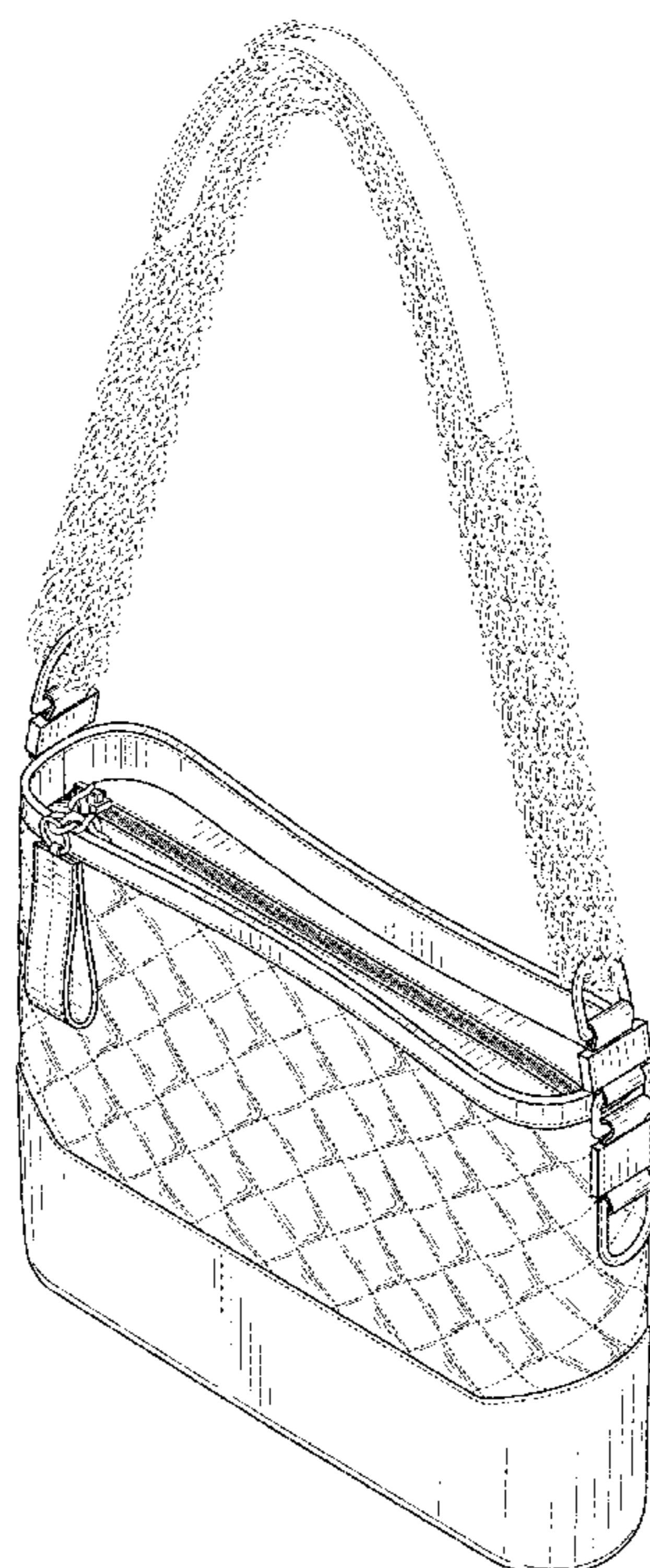
The ornamental design for bag, as shown and described.

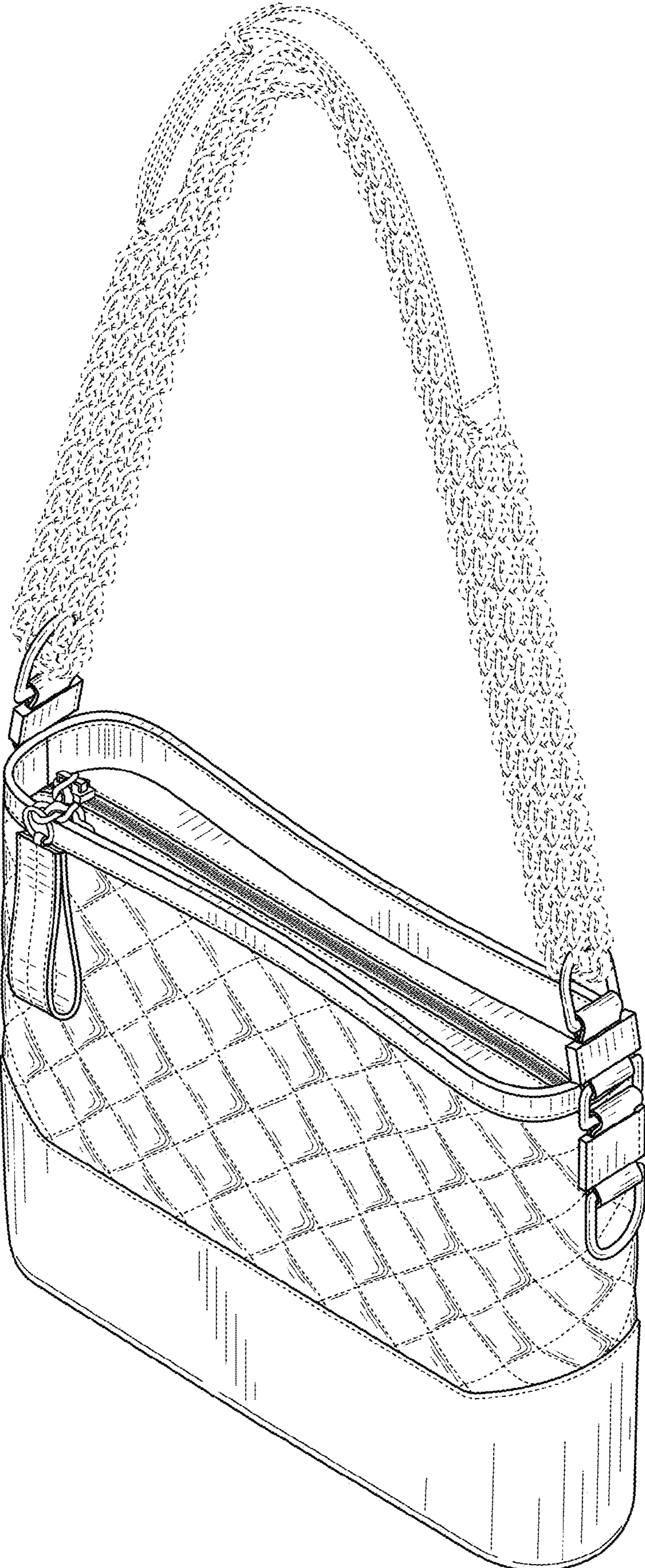

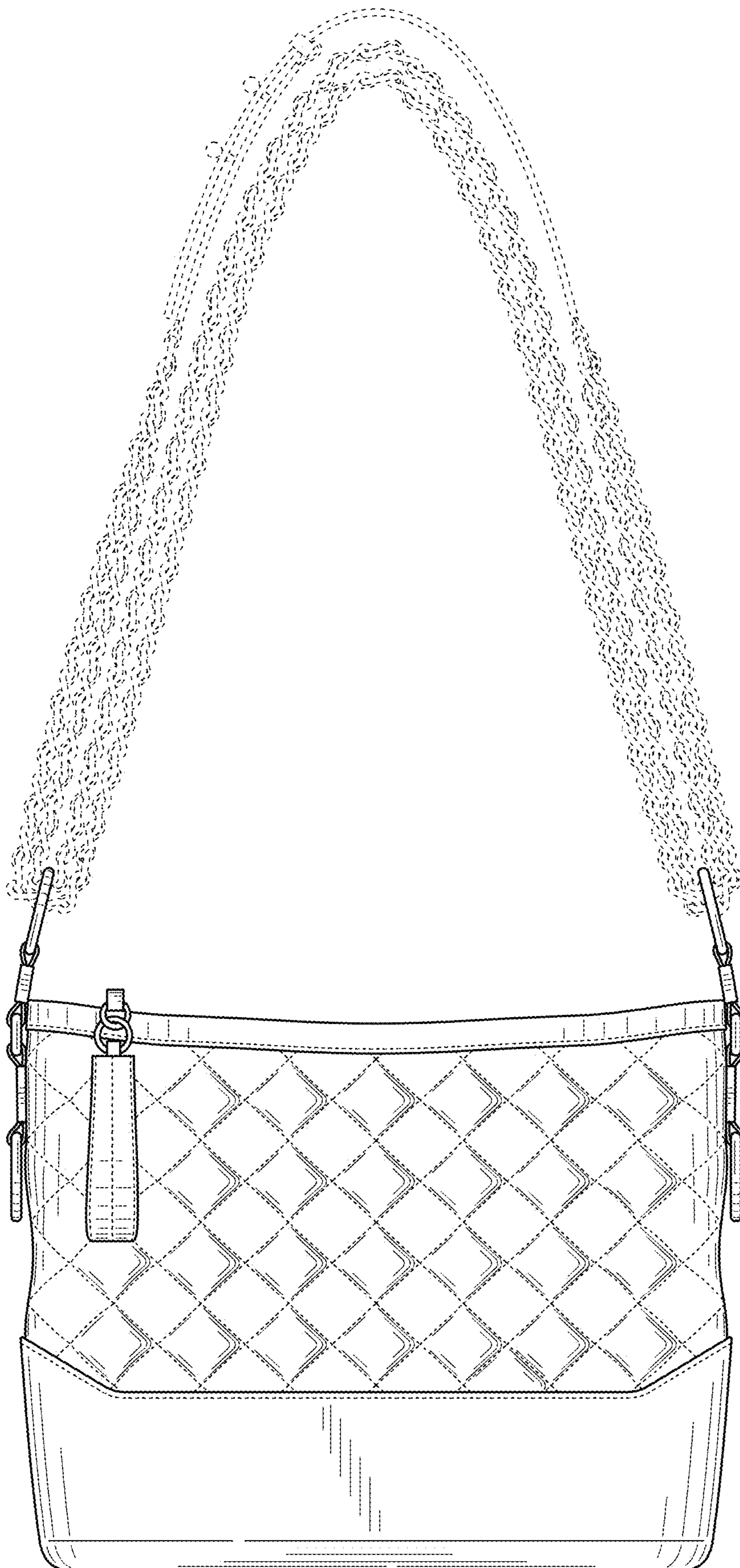

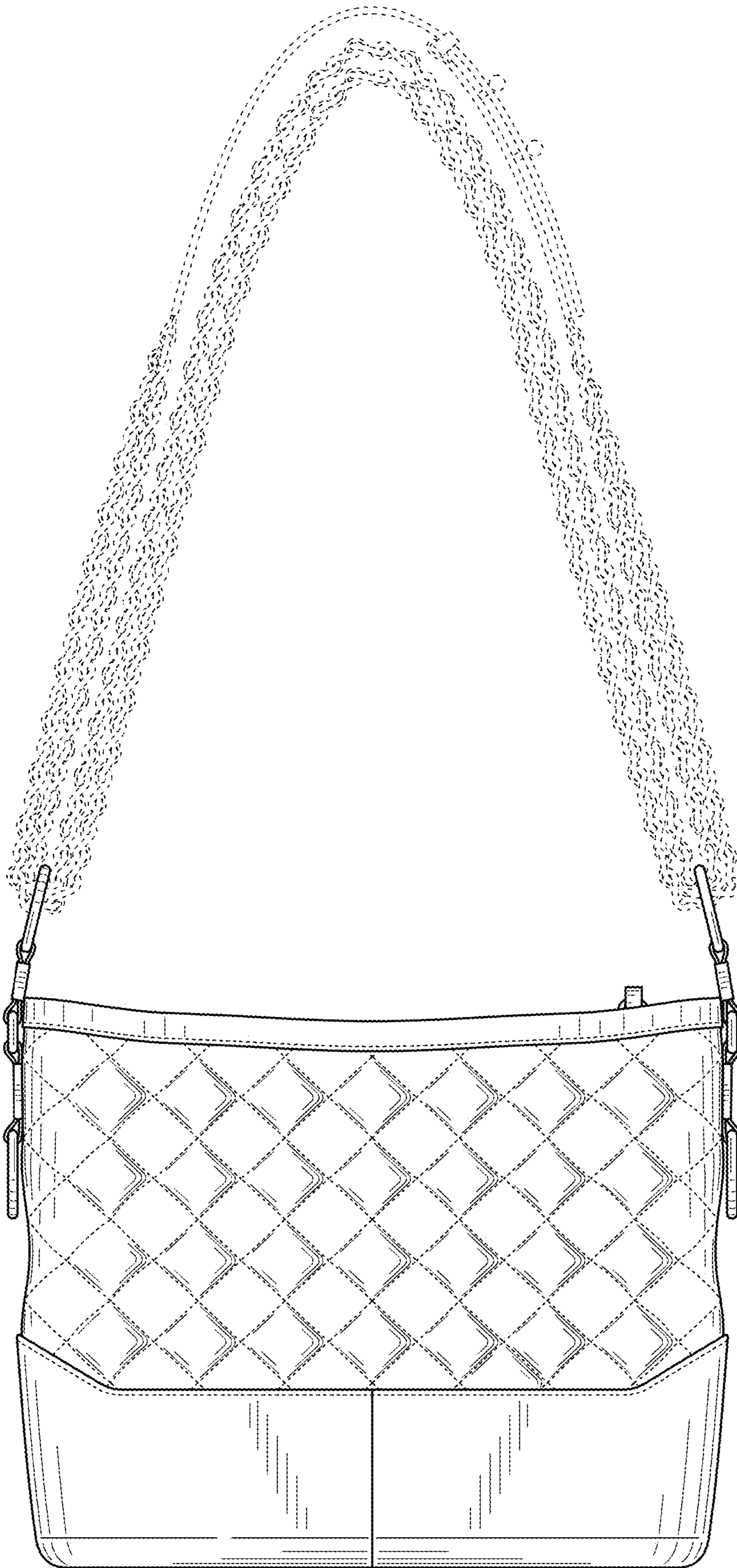

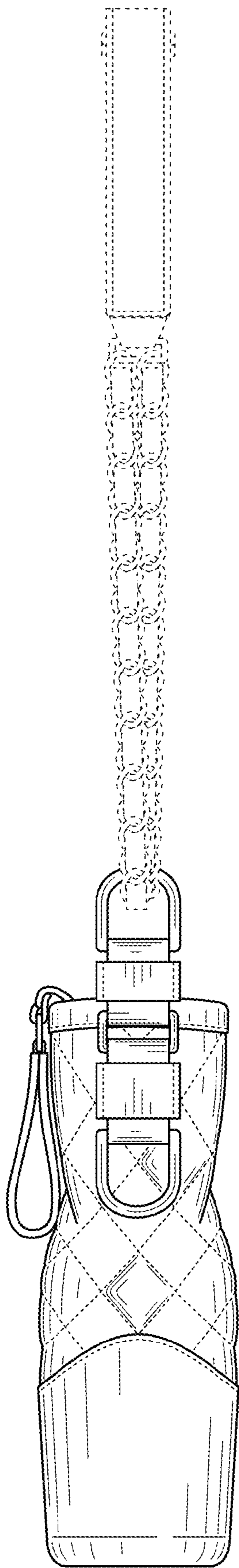

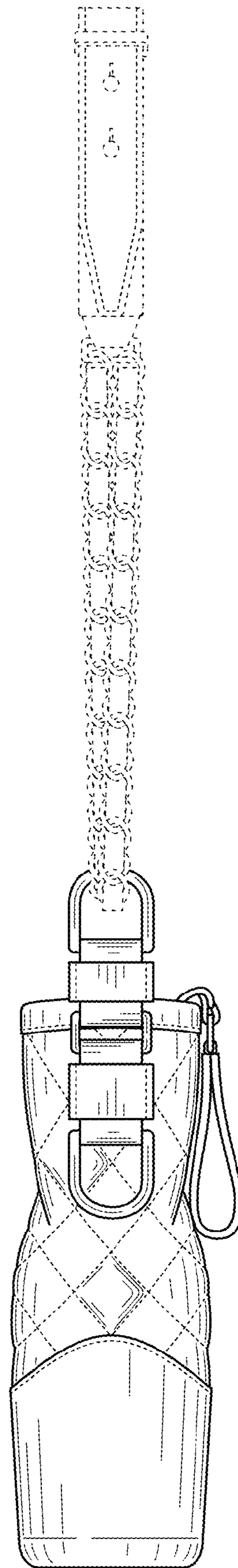

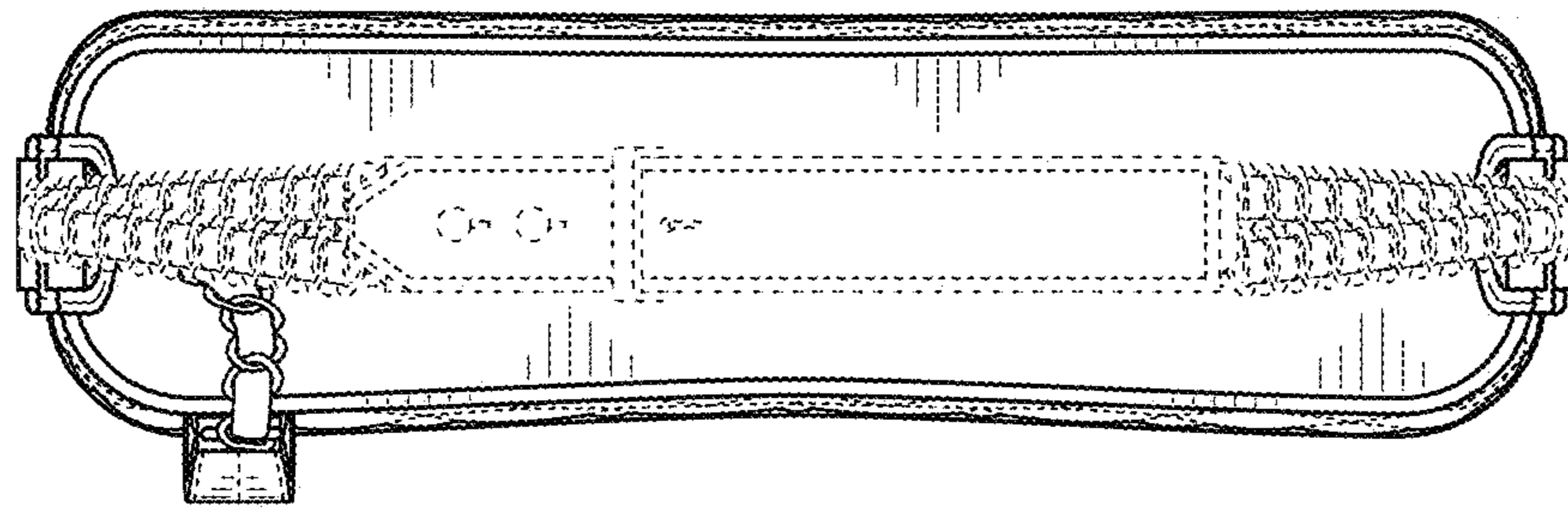

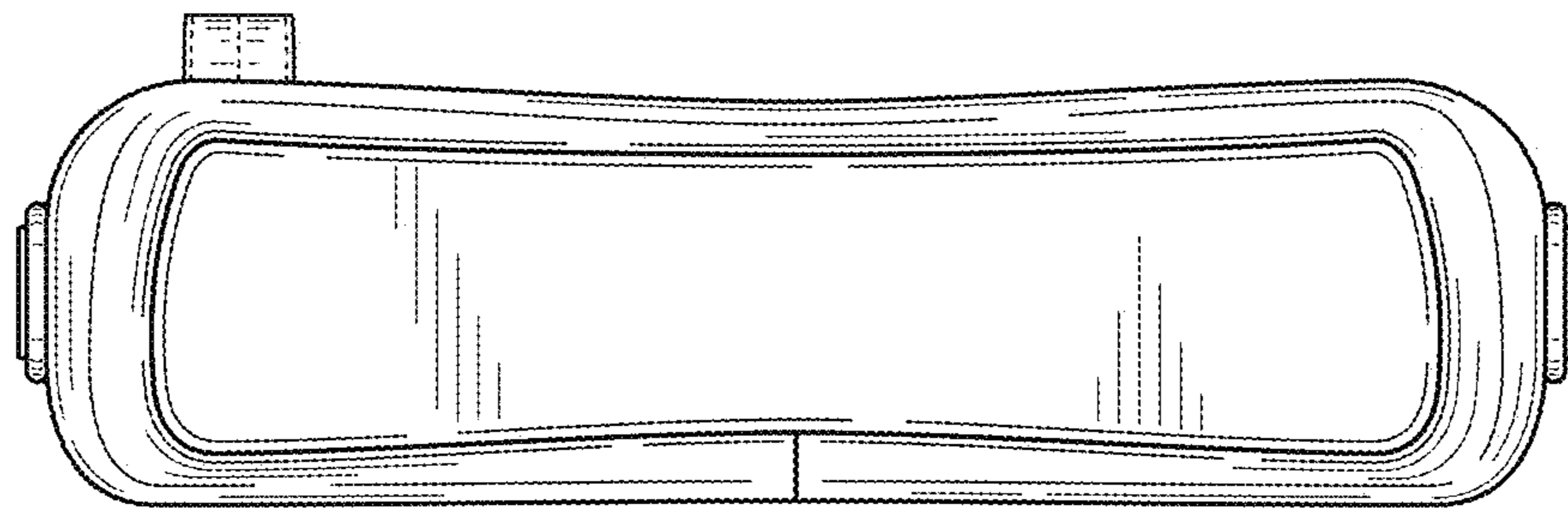

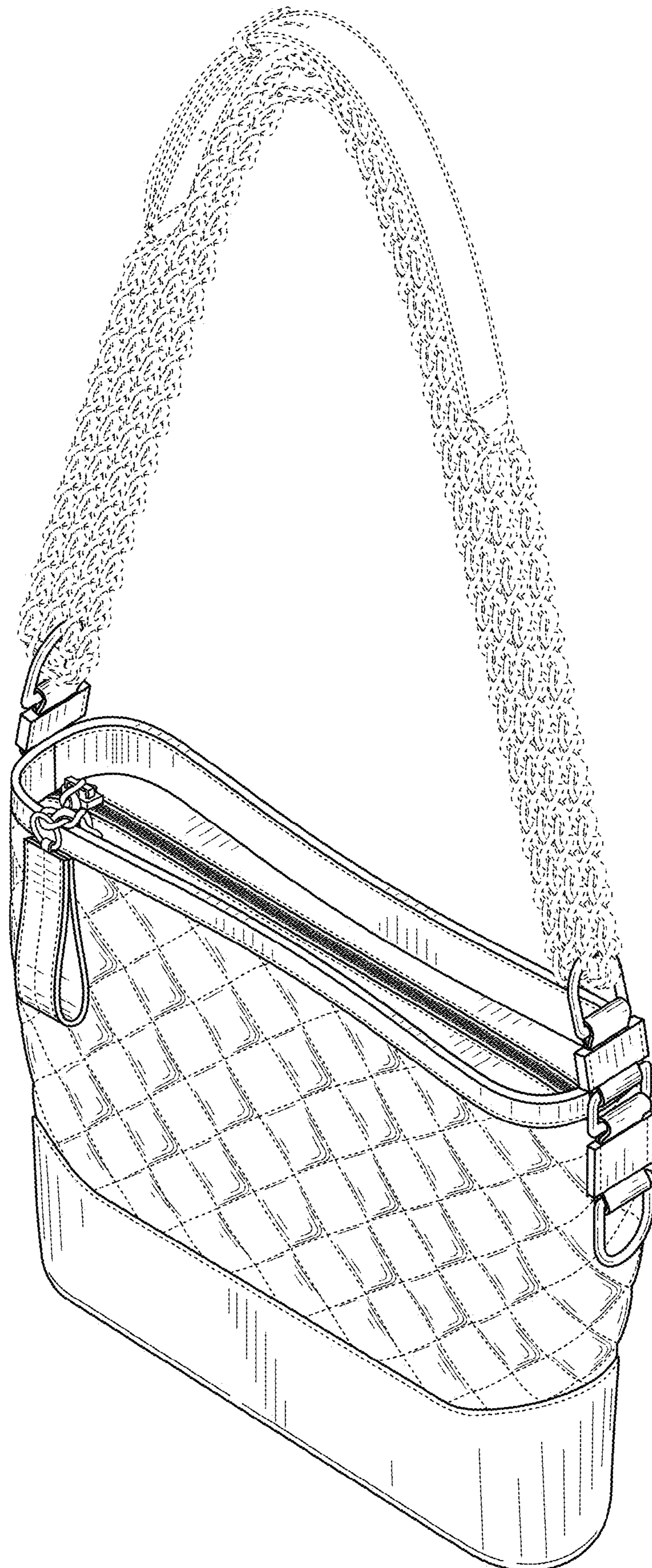

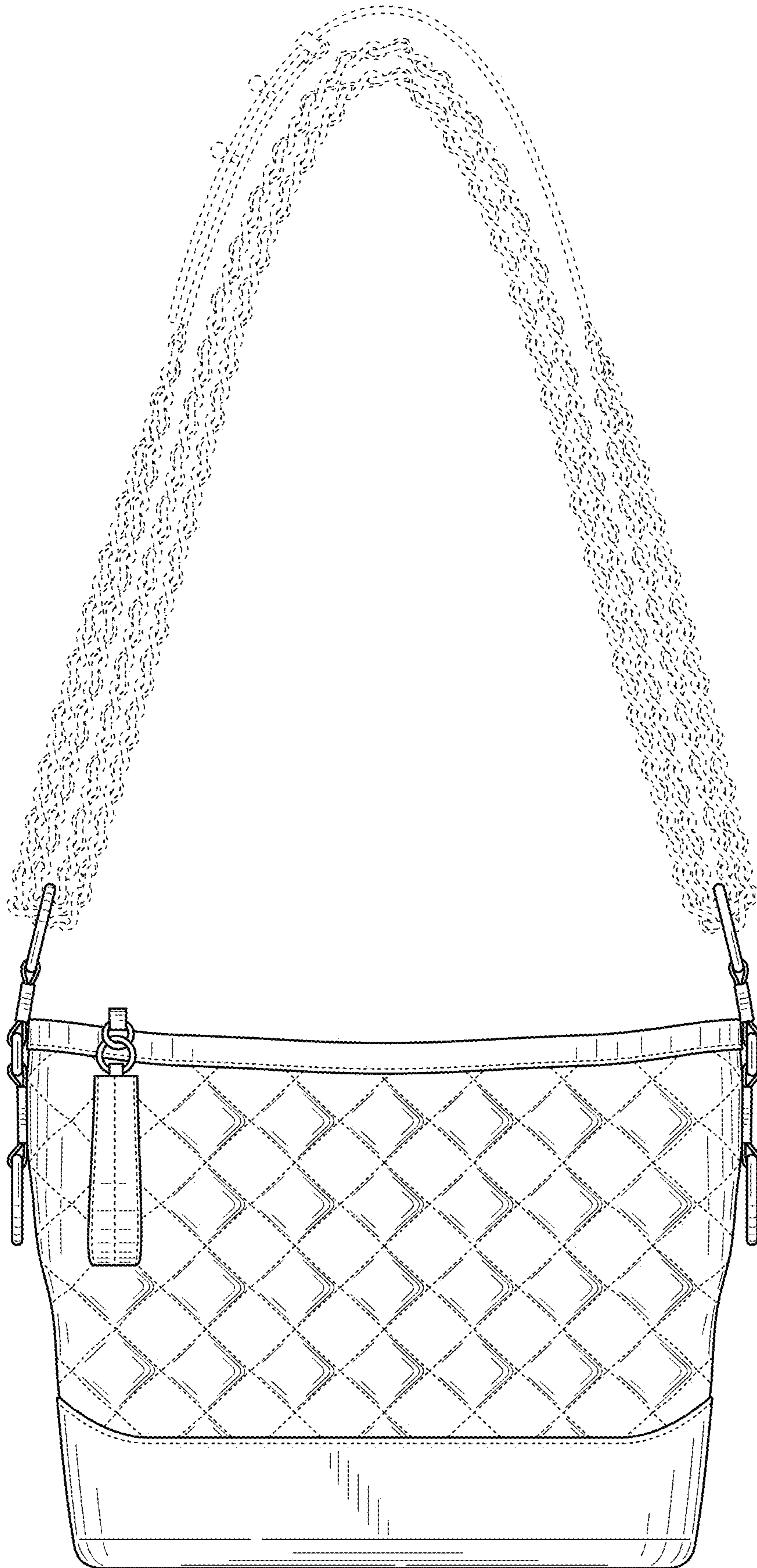

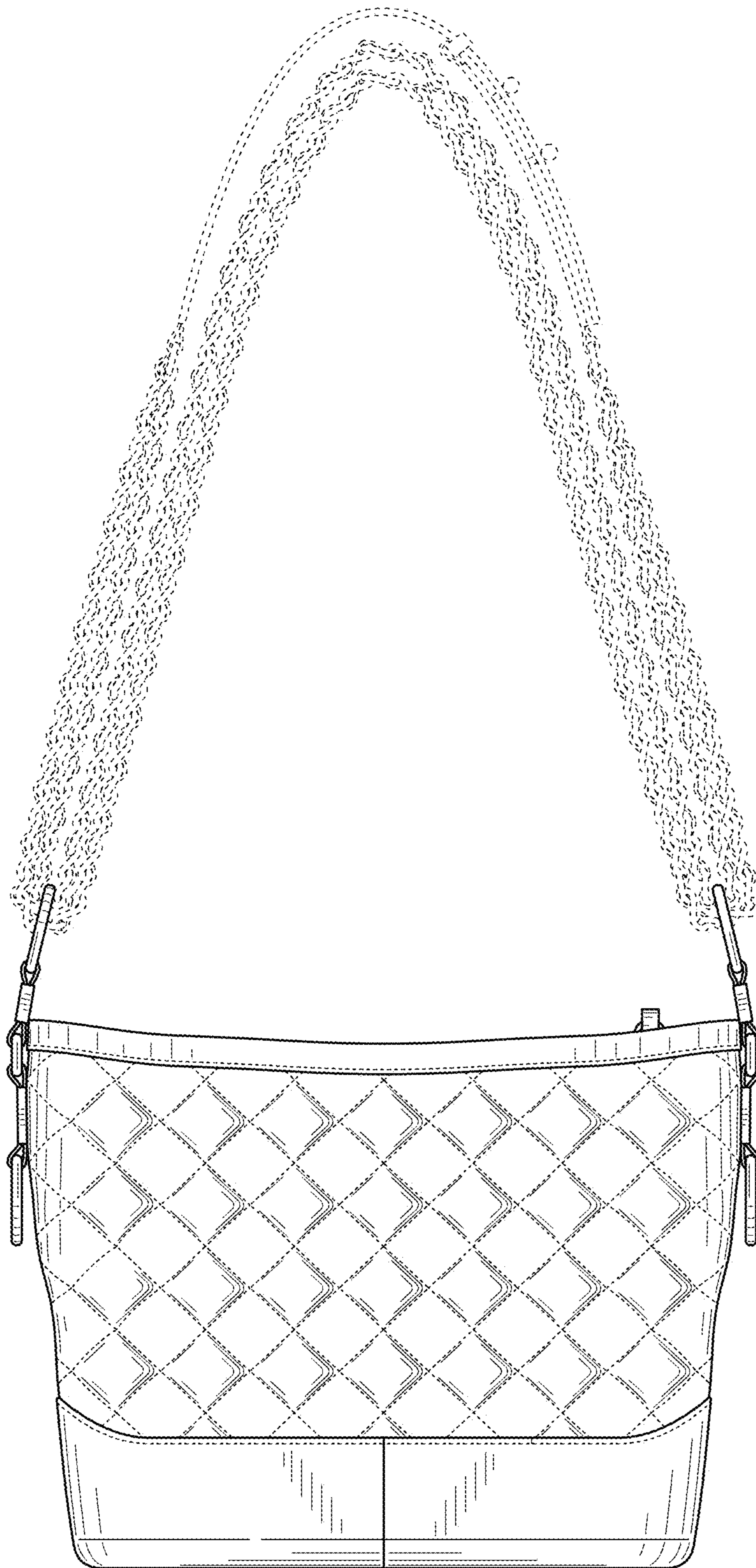

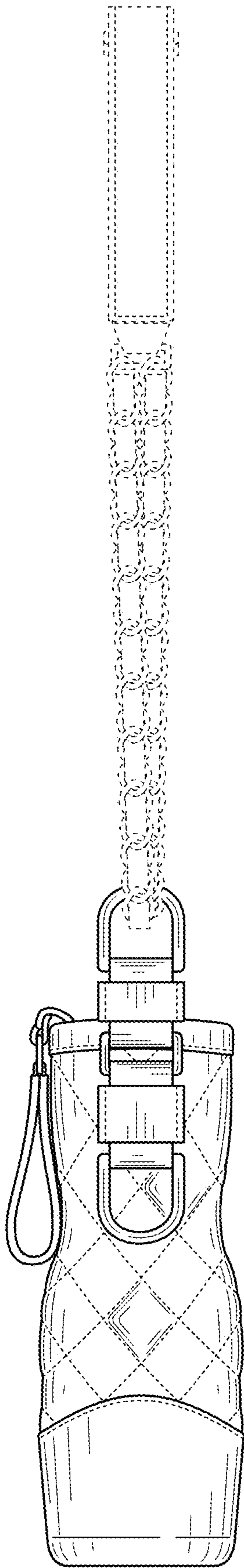

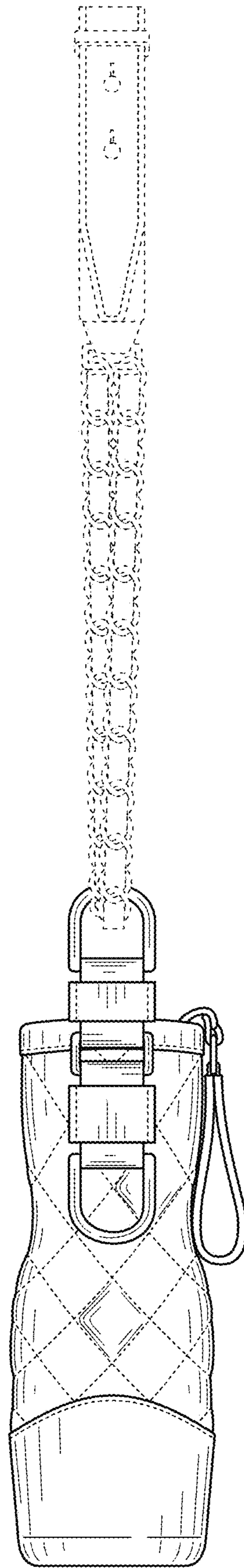

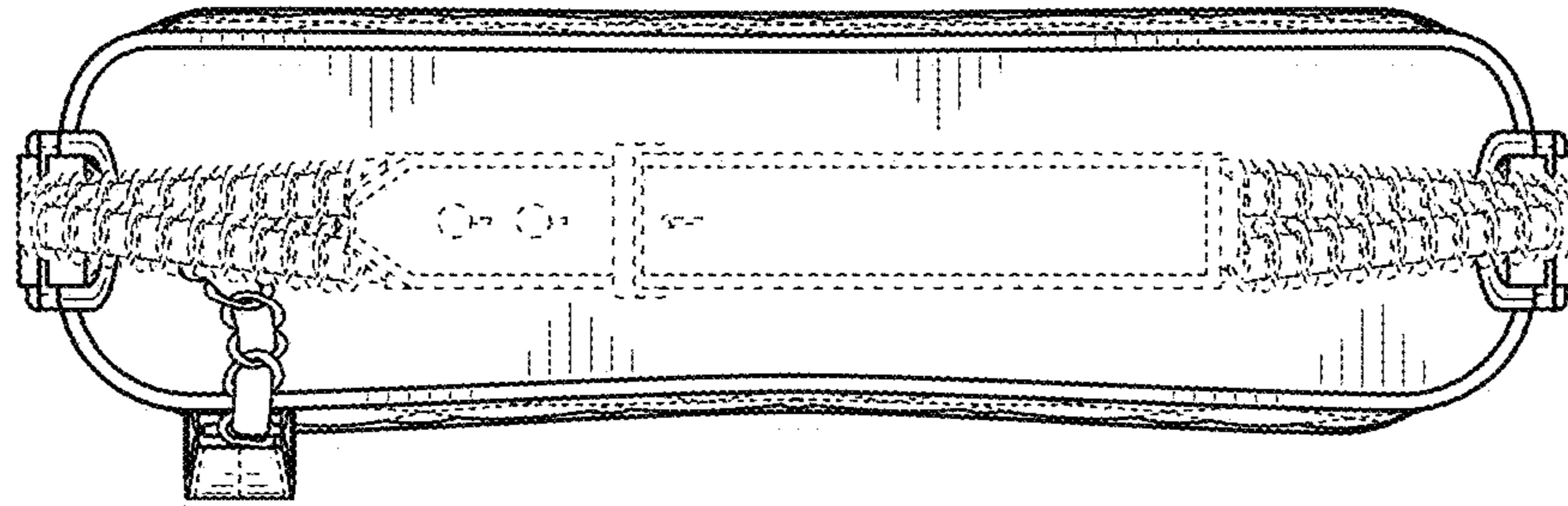

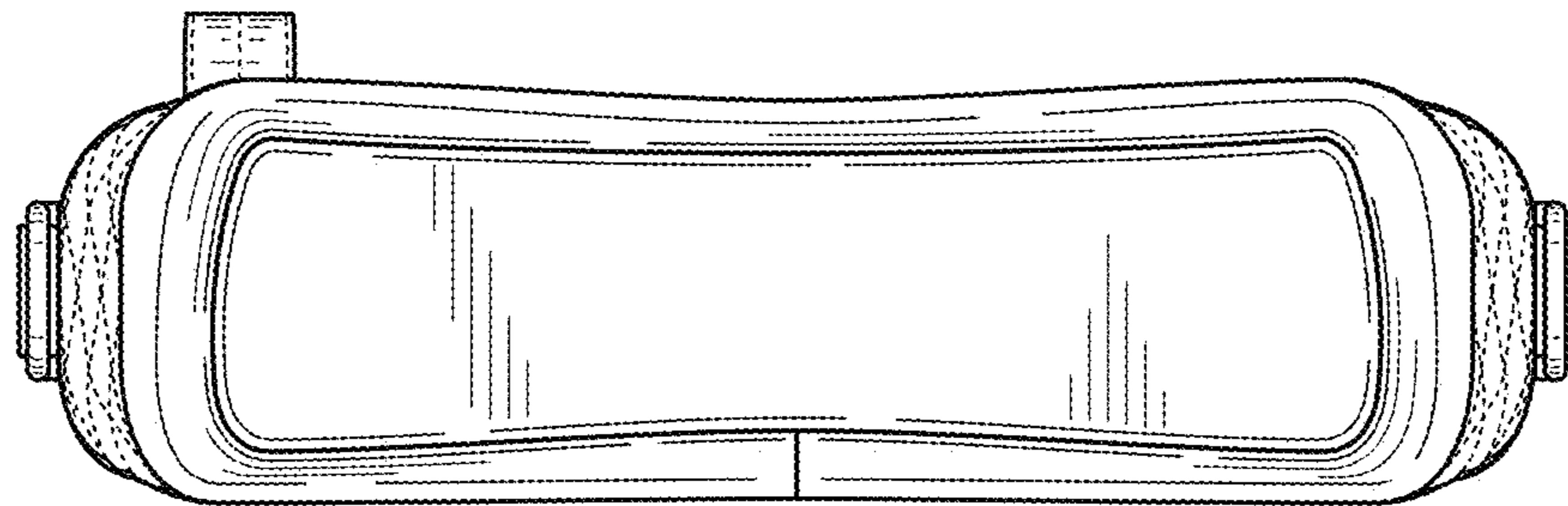

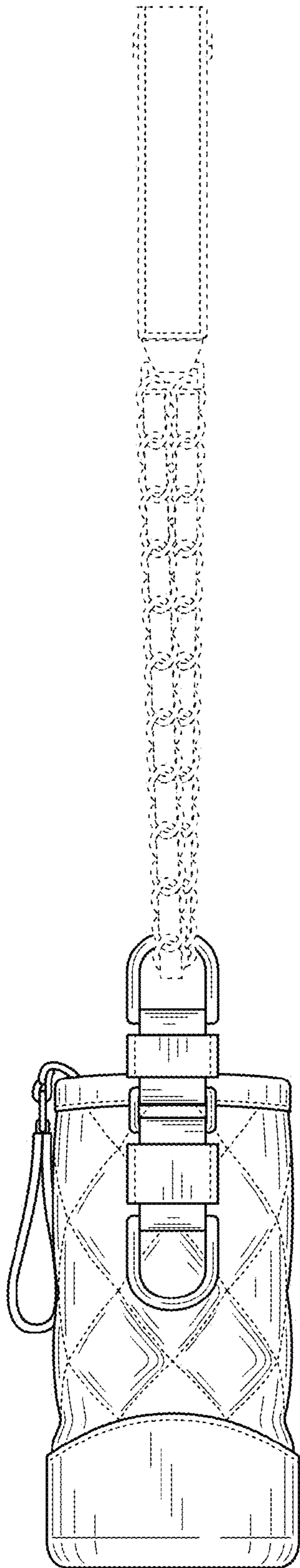

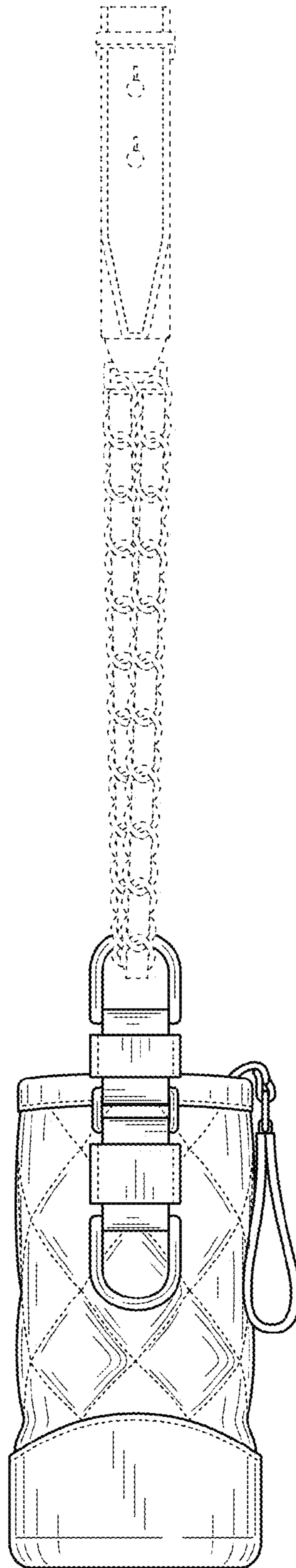

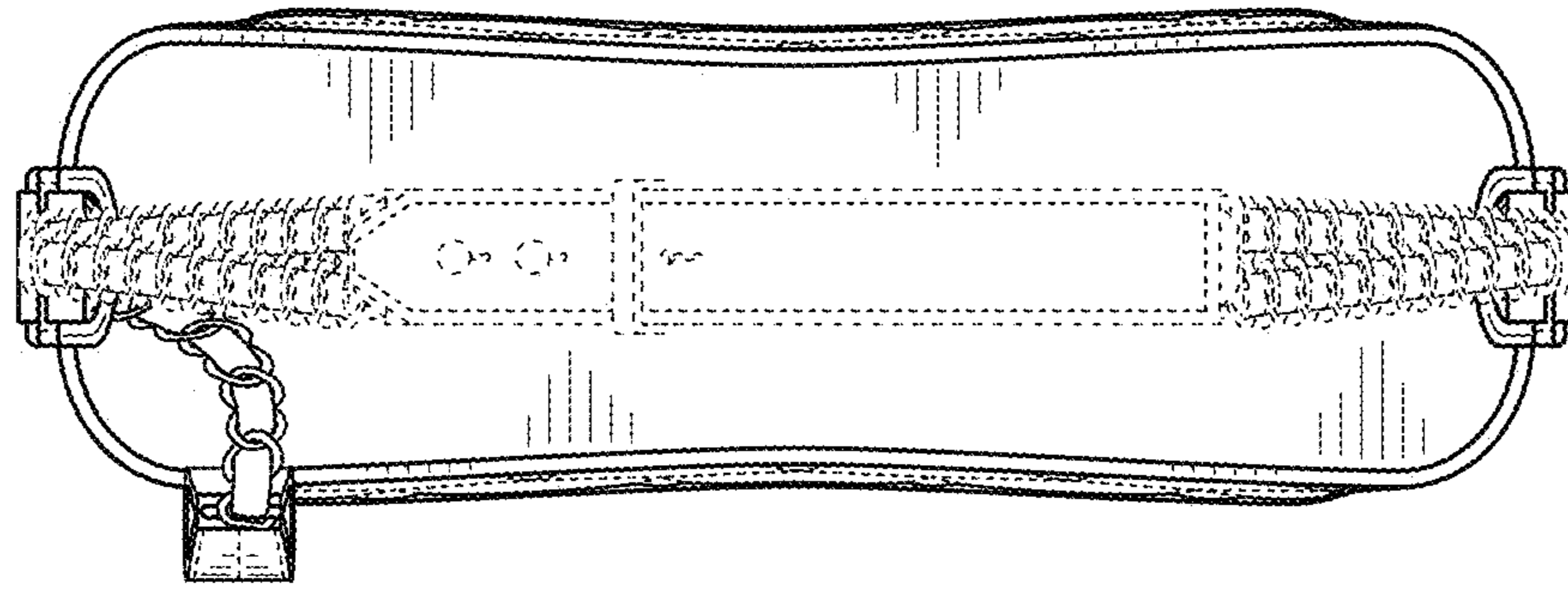

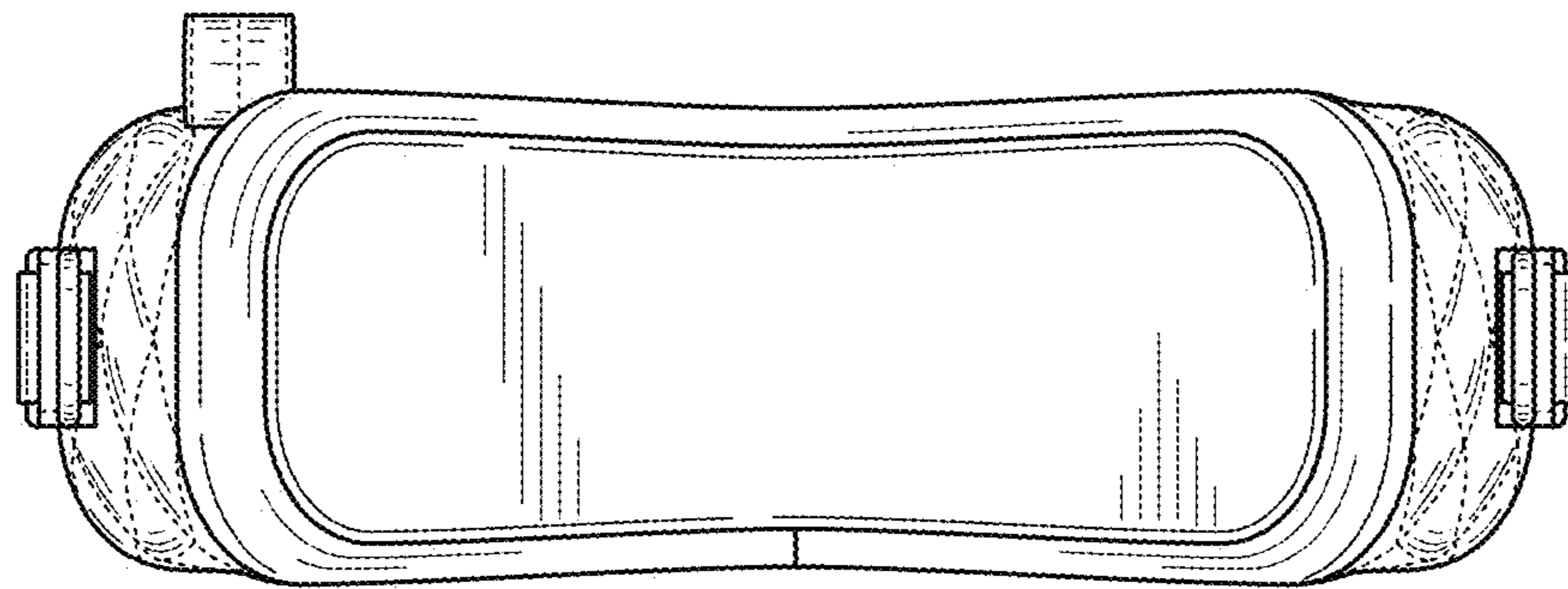
