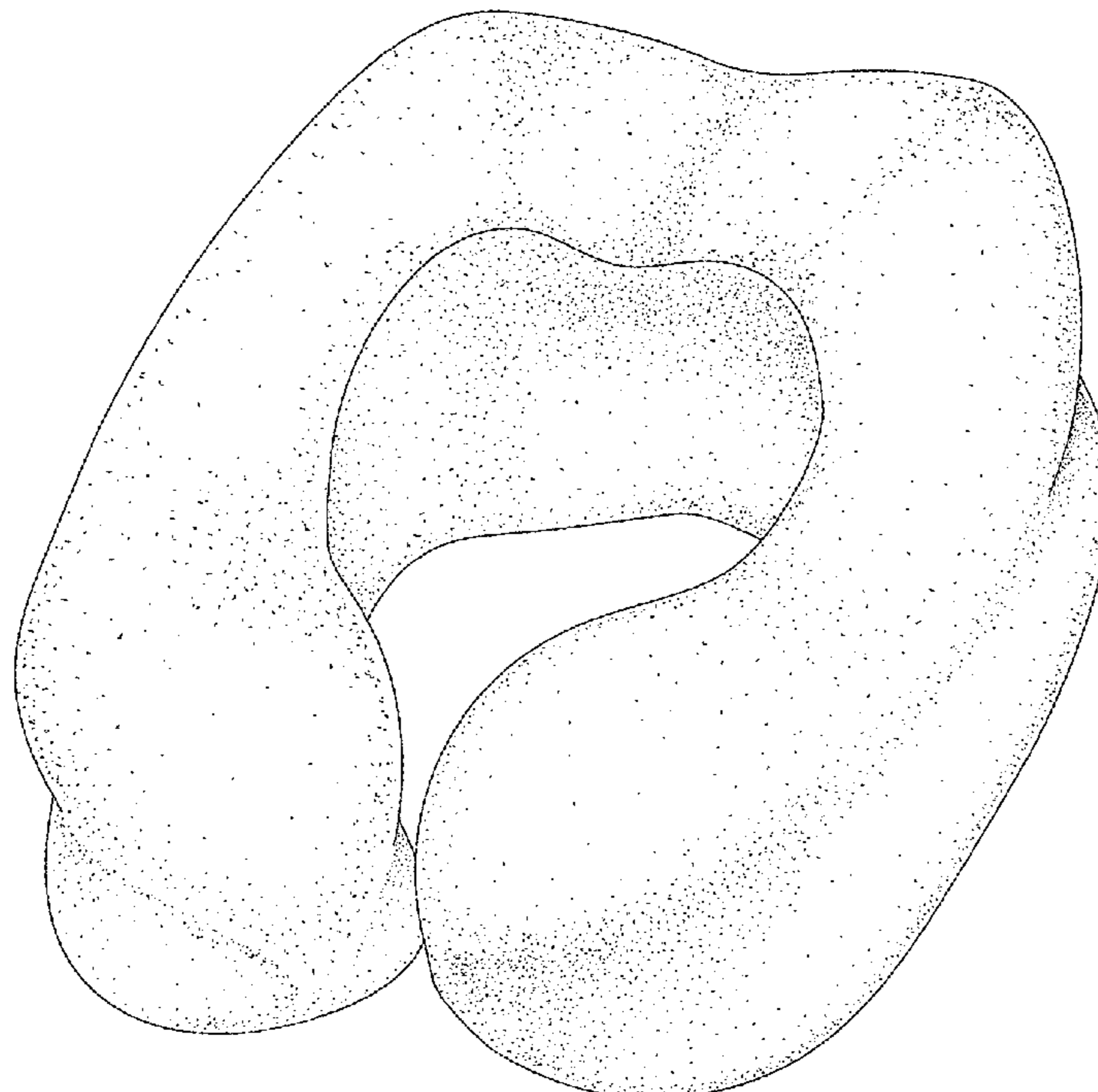
(57) **CLAIM**

The ornamental design for a neck pillow, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a first embodiment of a neck pillow showing my new design;
FIG. 2 is a bottom perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a left view thereof;
FIG. 6 is a right view thereof;
FIG. 7 is a rear view thereof;
FIG. 8 is a front view thereof;
FIG. 9 is a top perspective view of a second embodiment of a neck pillow, illustrating two locking members provided at two front opening ends of the neck pillow; and,
FIG. 10 is bottom perspective view of the neck pillow, illustrating a hanger provided at a rear side of the neck pillow.

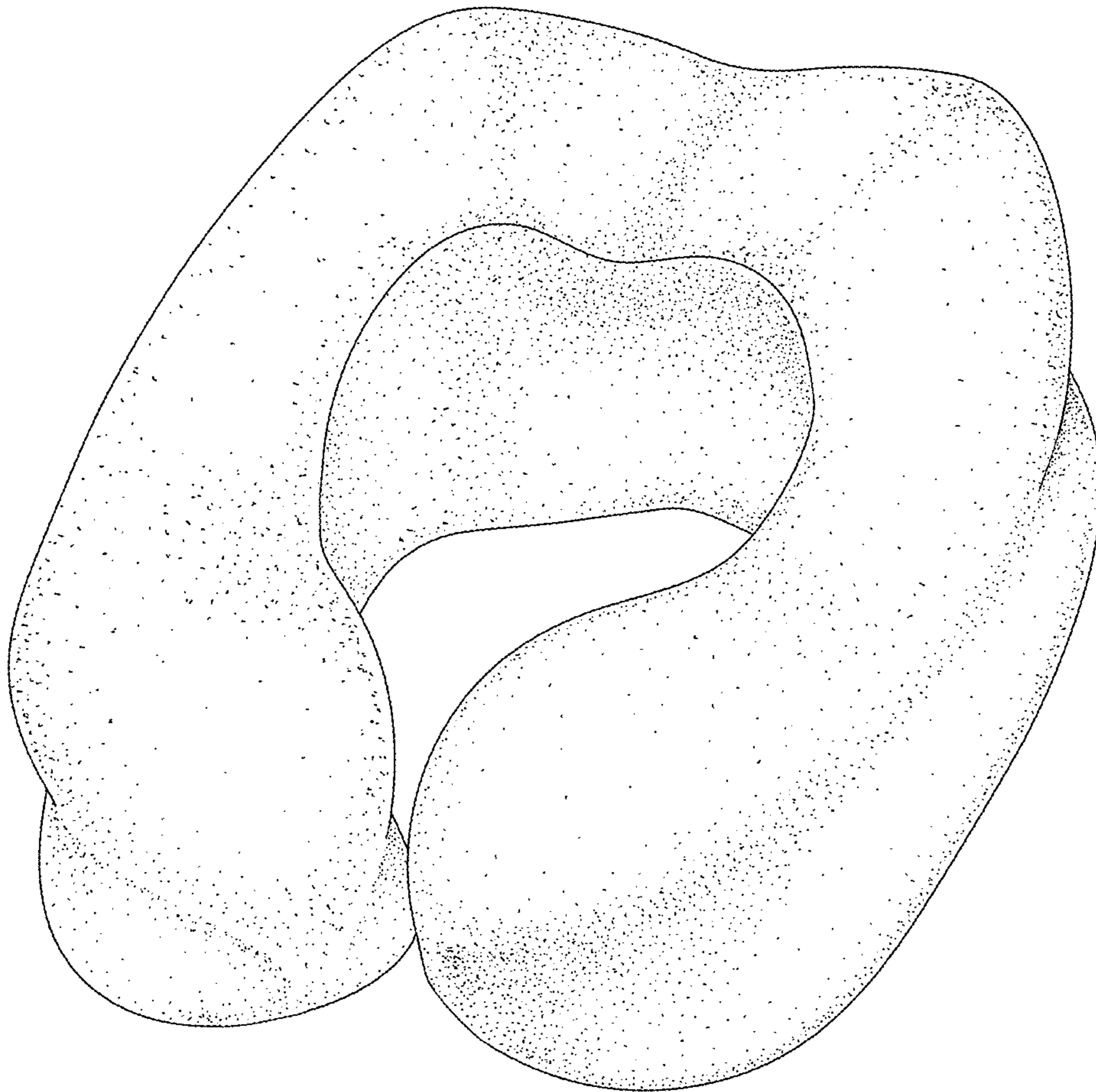

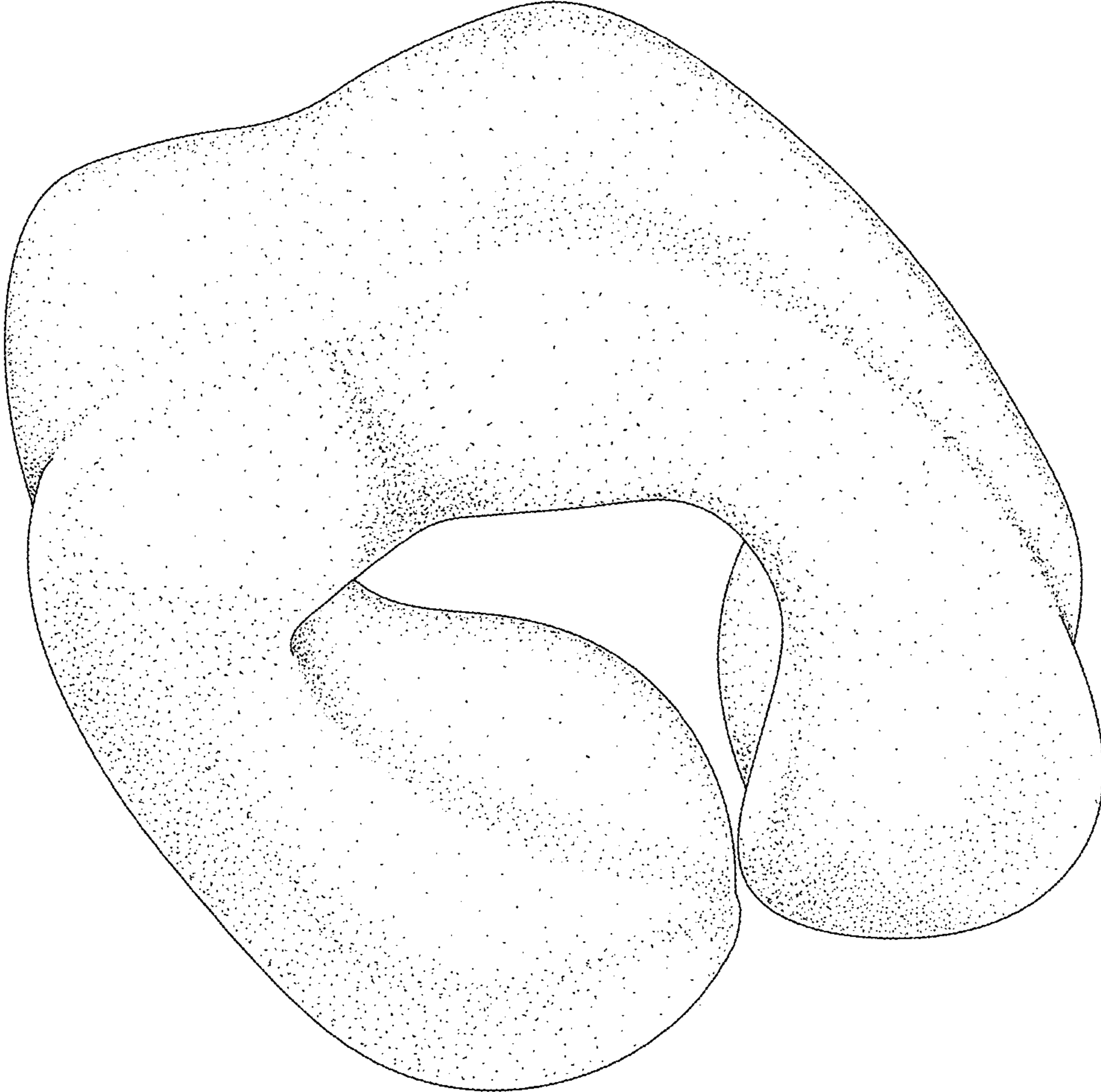

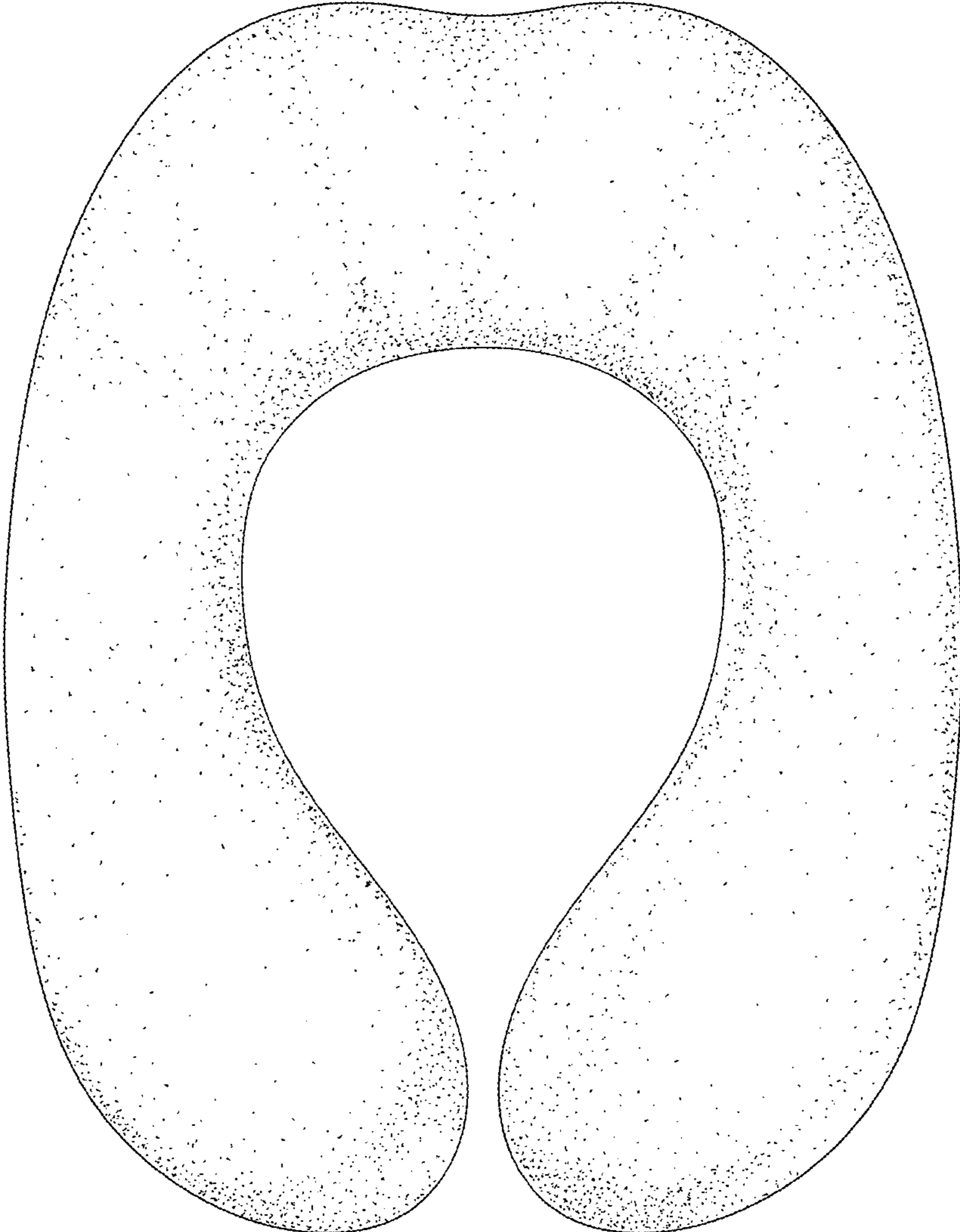

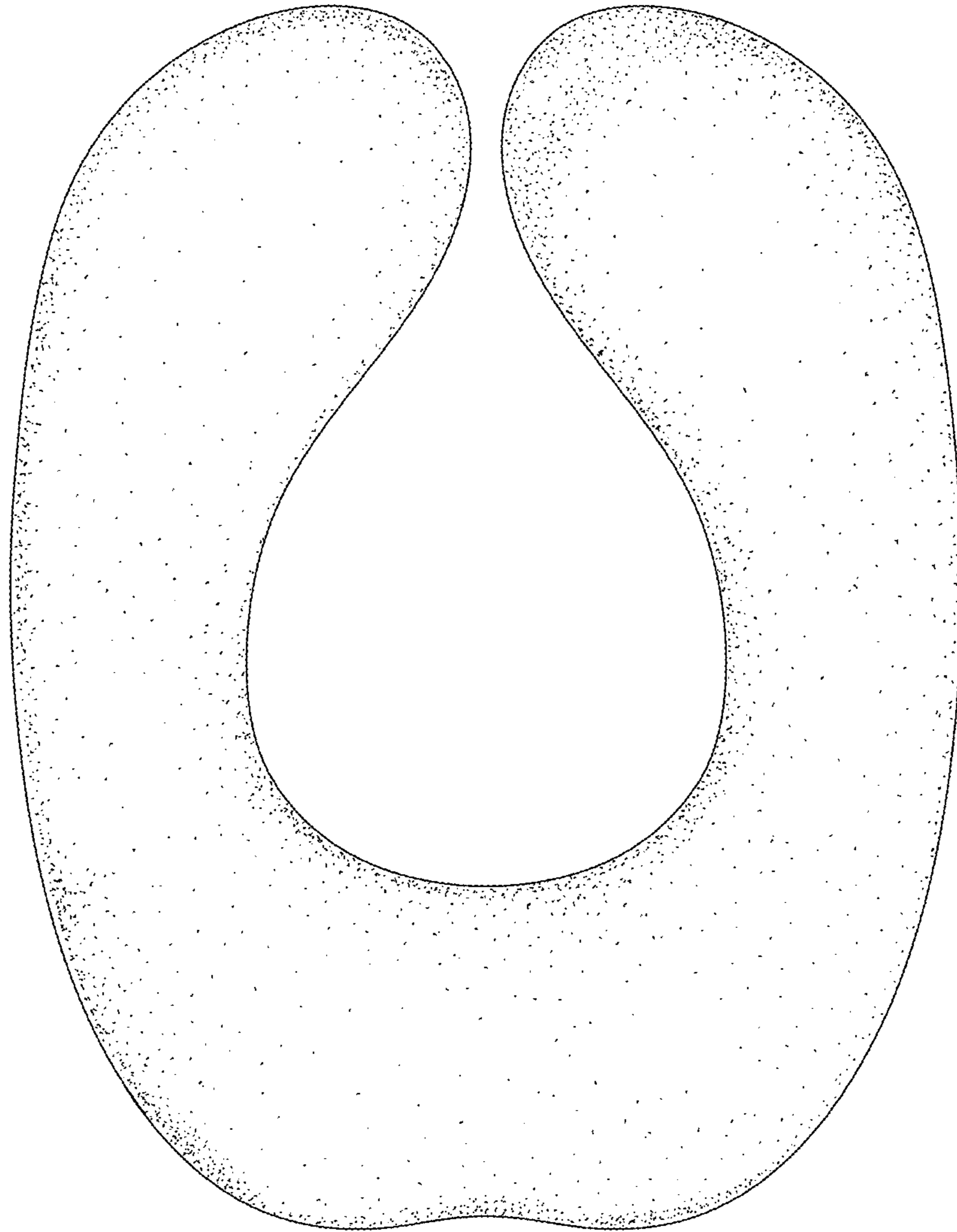

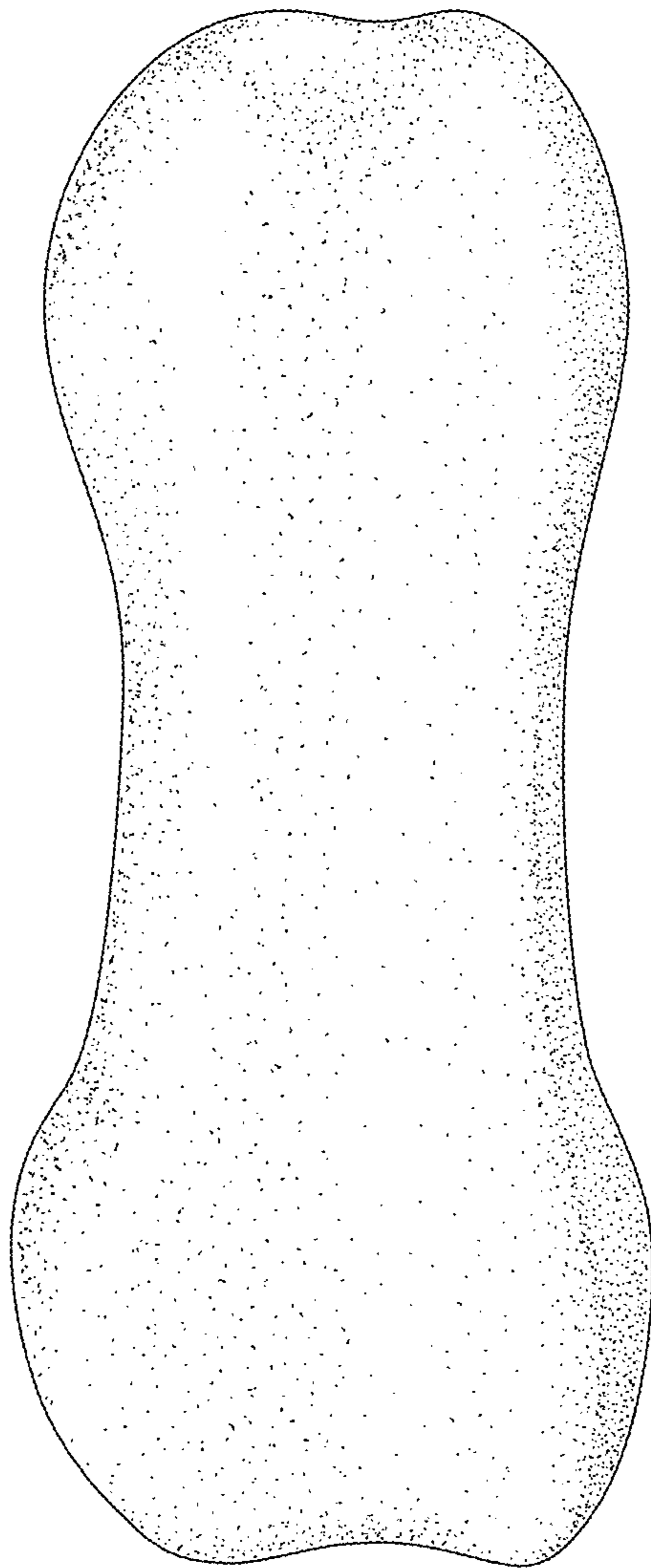

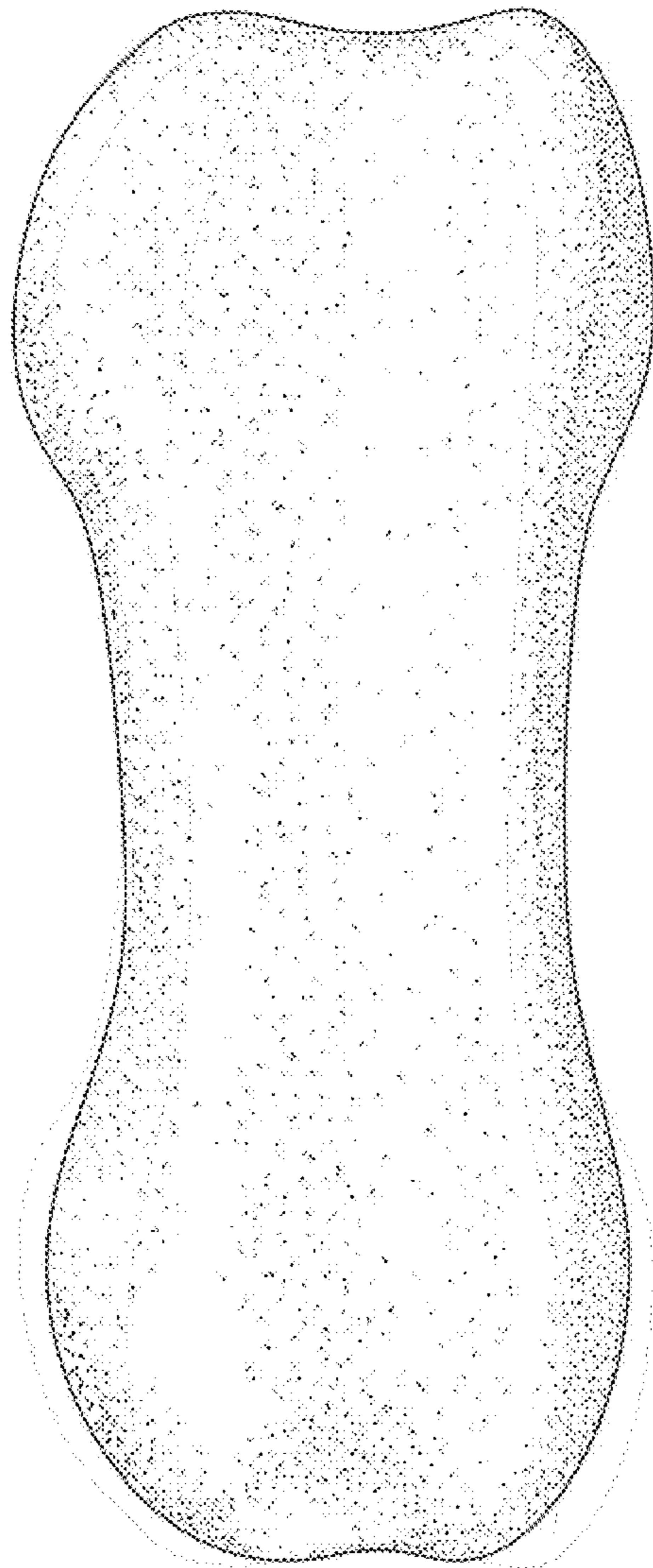

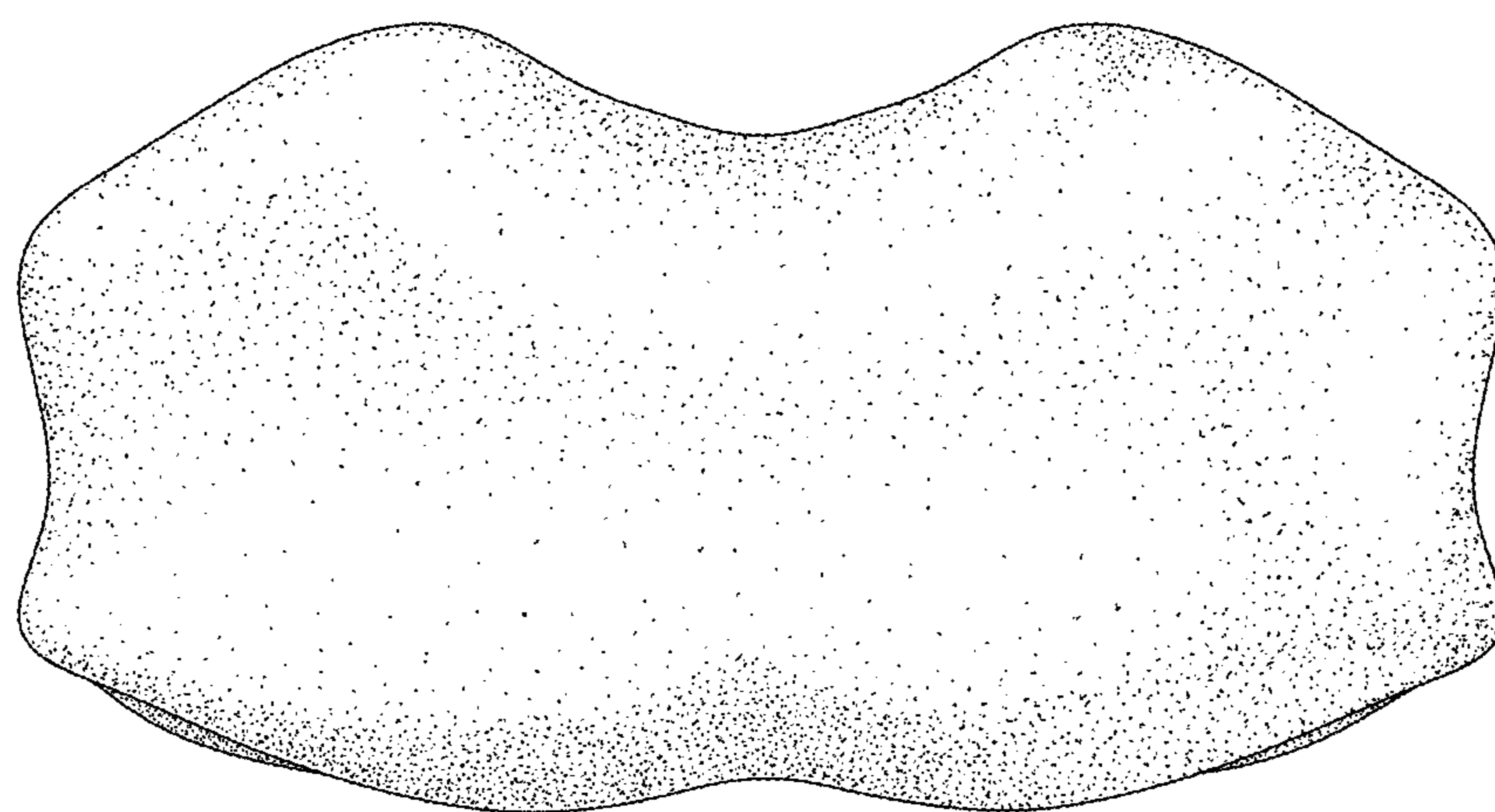

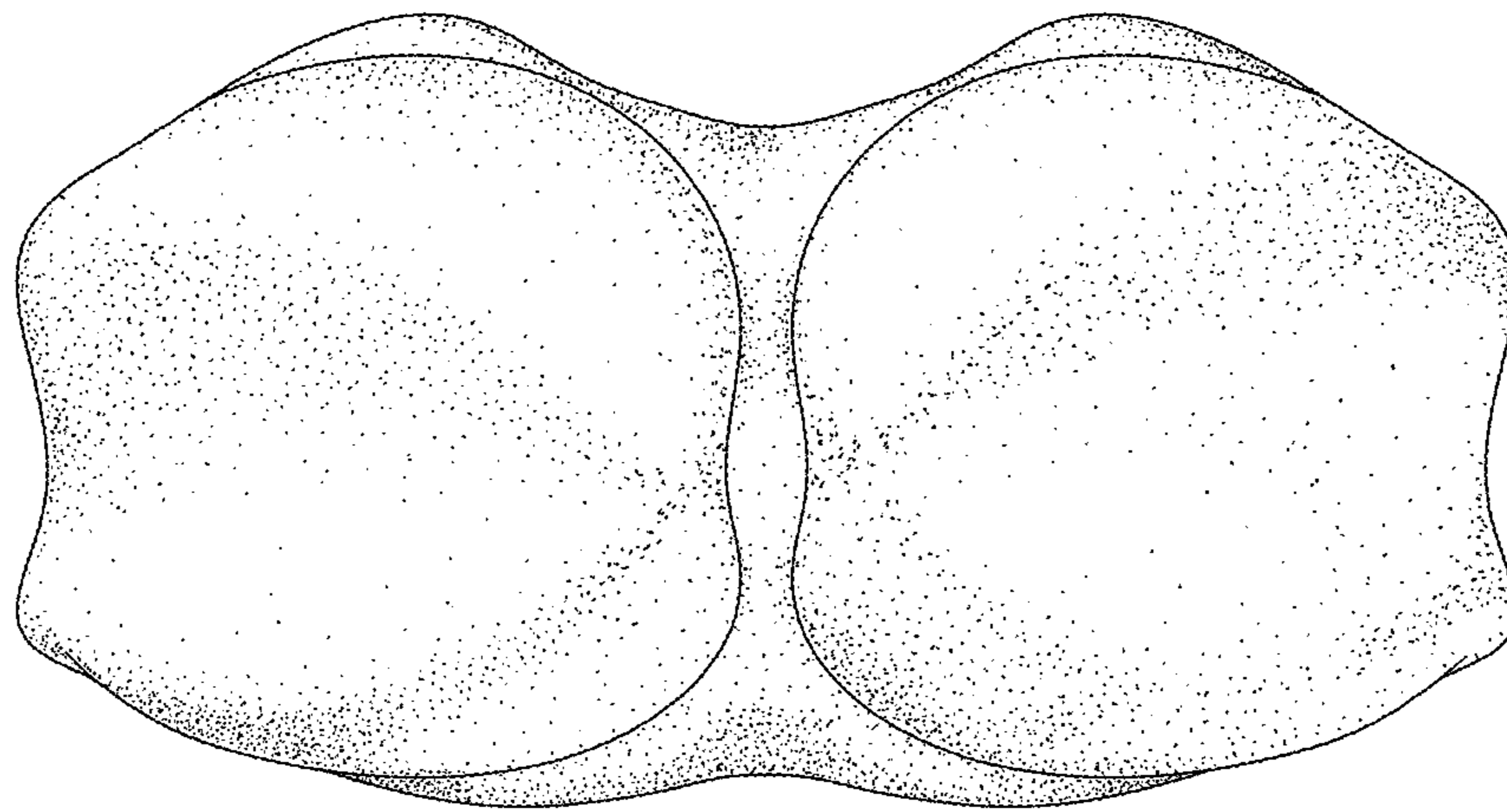

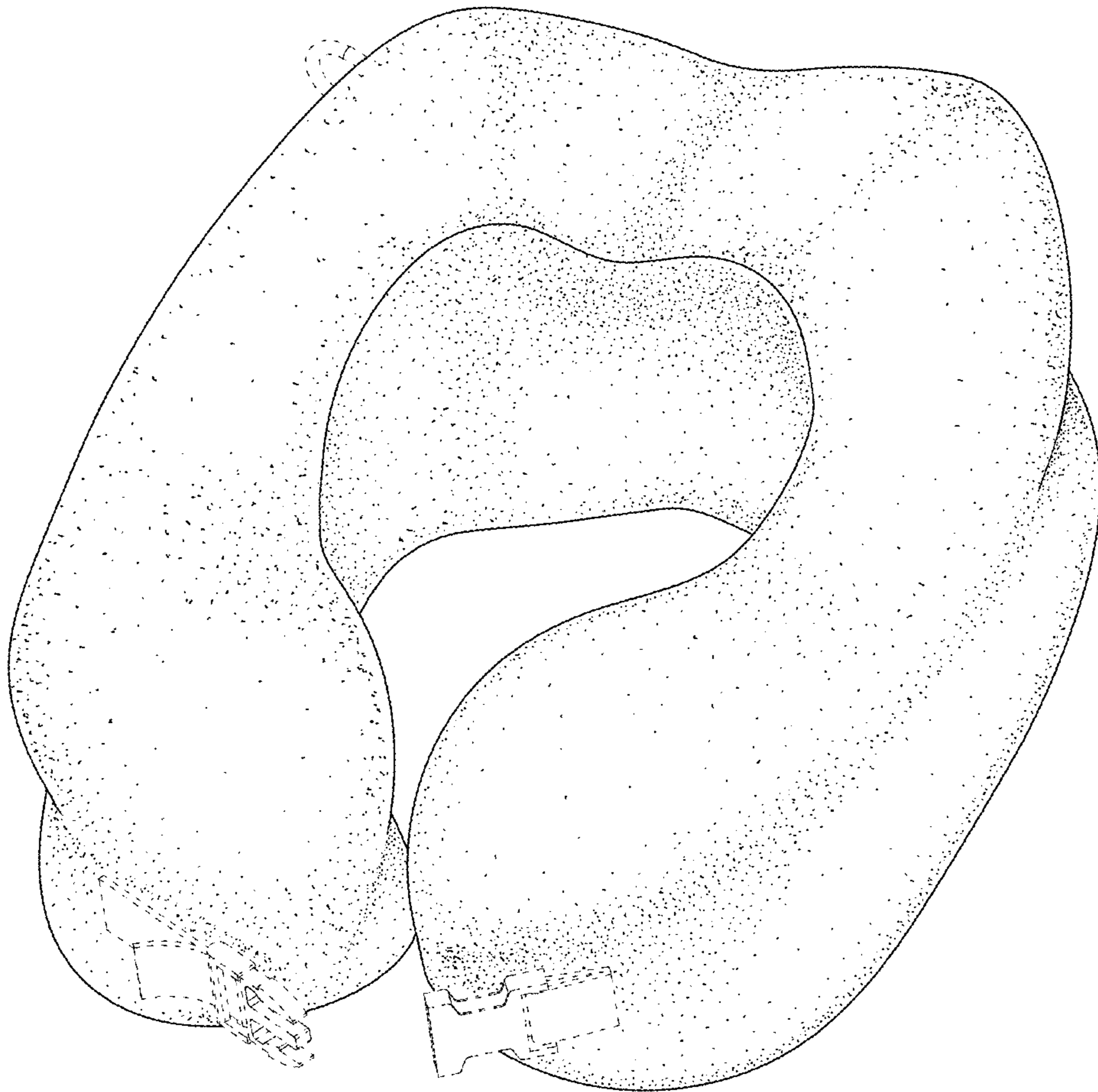

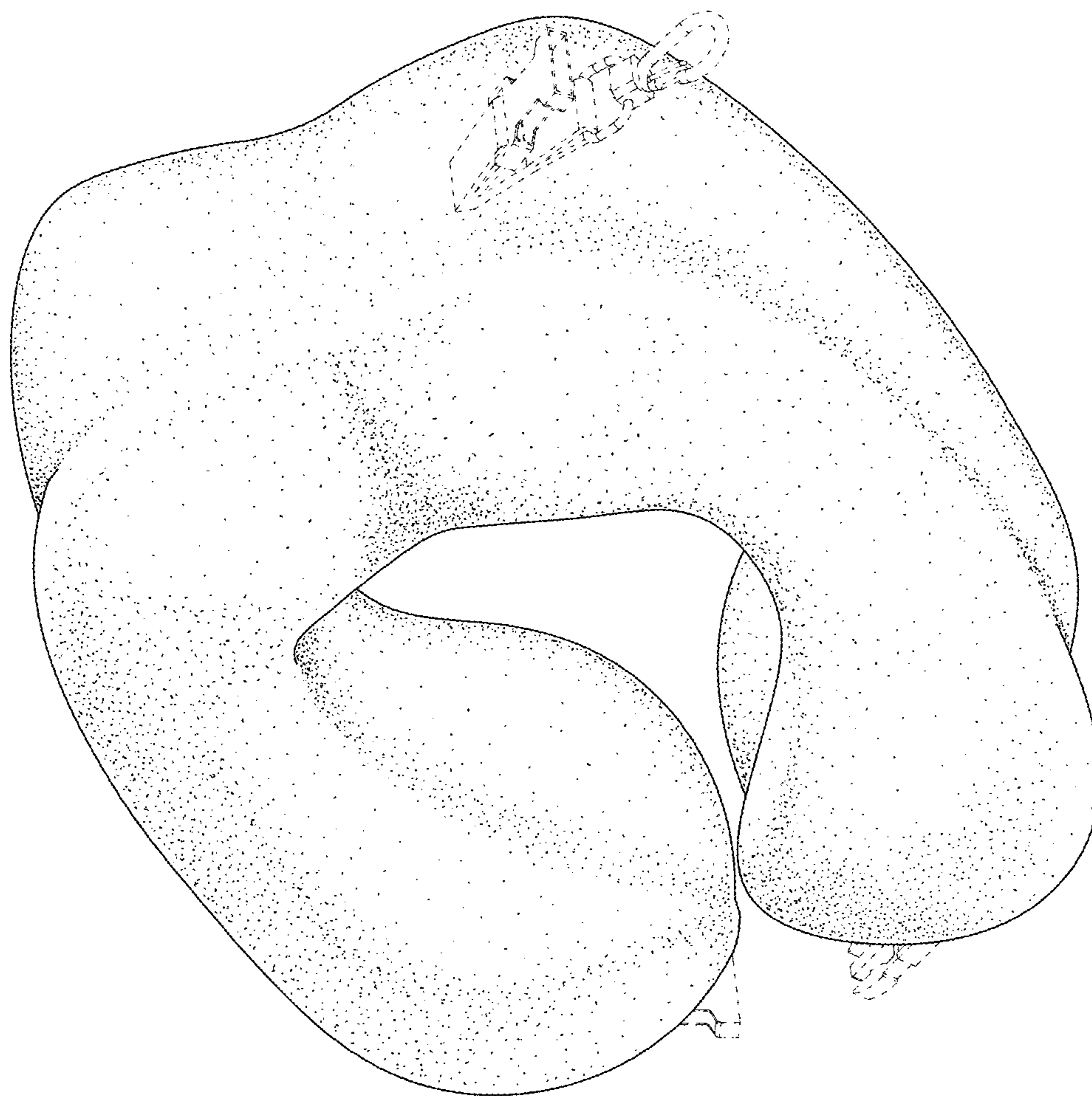
