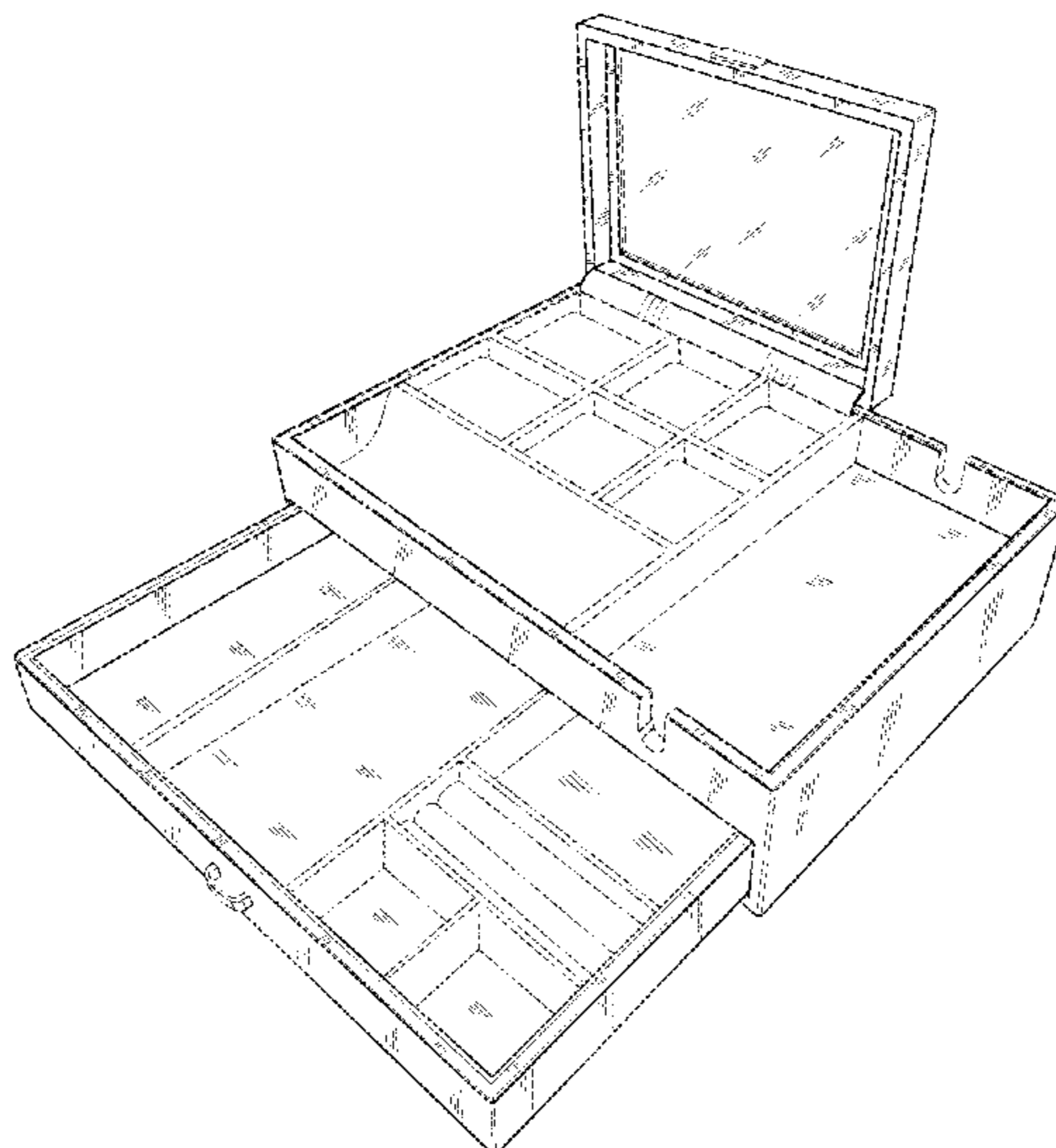
(57) **CLAIM**

The ornamental design for a combined dresser valet and charging station, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of a combined dresser valet and charging station showing the new design, open position according to a first embodiment;  
FIG. 2 is a perspective view, closed position of the combined dresser valet and charging station of FIG. 1;  
FIG. 3 is a front perspective view, open position of the combined dresser valet and charging station of FIG. 1;  
FIG. 4 is a front perspective, closed position of the combined dresser valet and charging station of FIG. 1;  
FIG. 5 is a right side elevational view, open position of the combined dresser valet and charging station of FIG. 1;  
FIG. 6 is a top plan view, open position of the combined dresser valet and charging station of FIG. 1;  
FIG. 7 is a back side elevational view, closed position of the combined dresser valet and charging station of FIG. 1;  
FIG. 8 is a bottom plan view, closed position of the combined dresser valet and charging station of FIG. 1; and,  
FIG. 9 is a left side elevational view, open position of the combined dresser valet and charging station of FIG. 1.

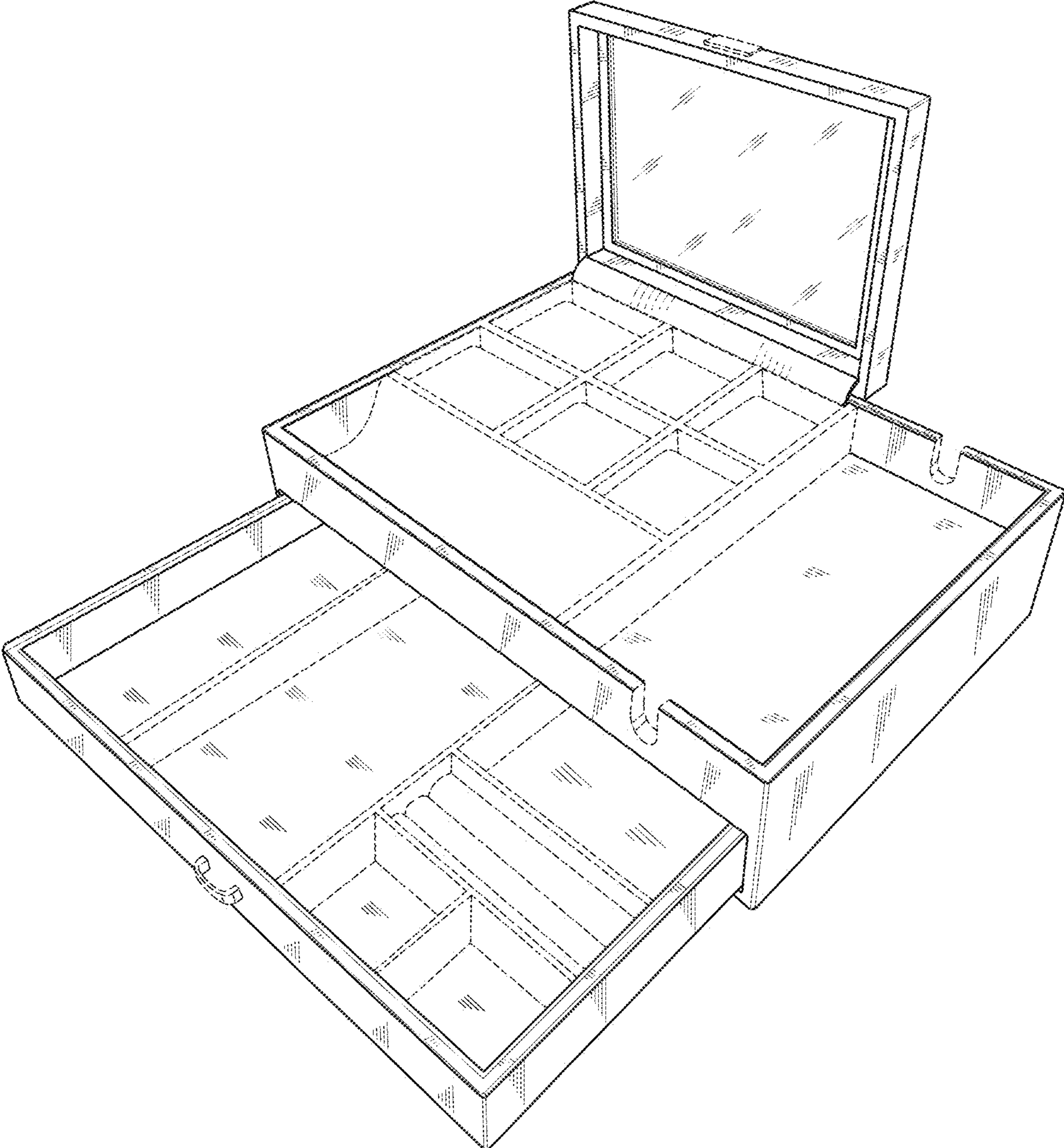

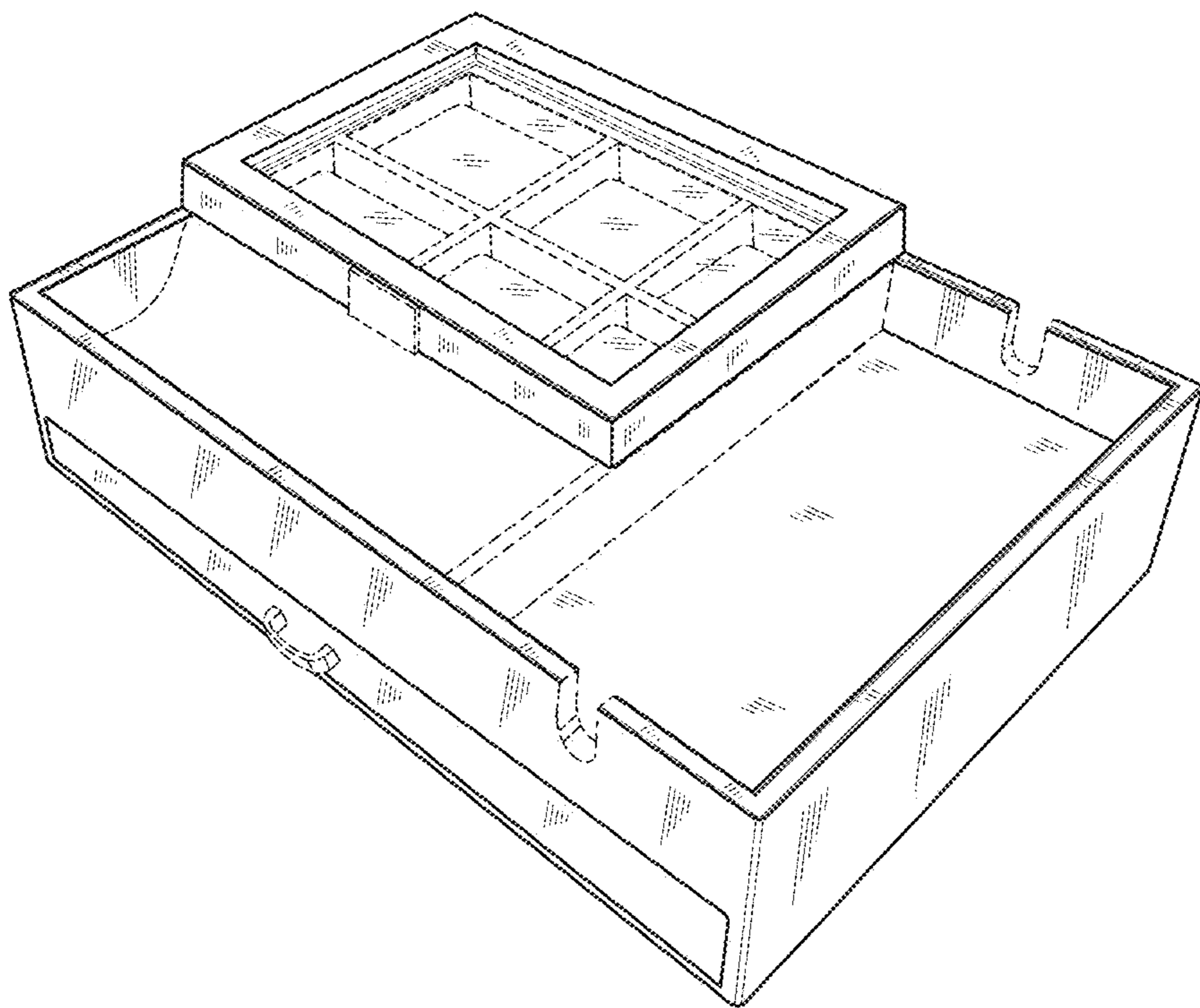

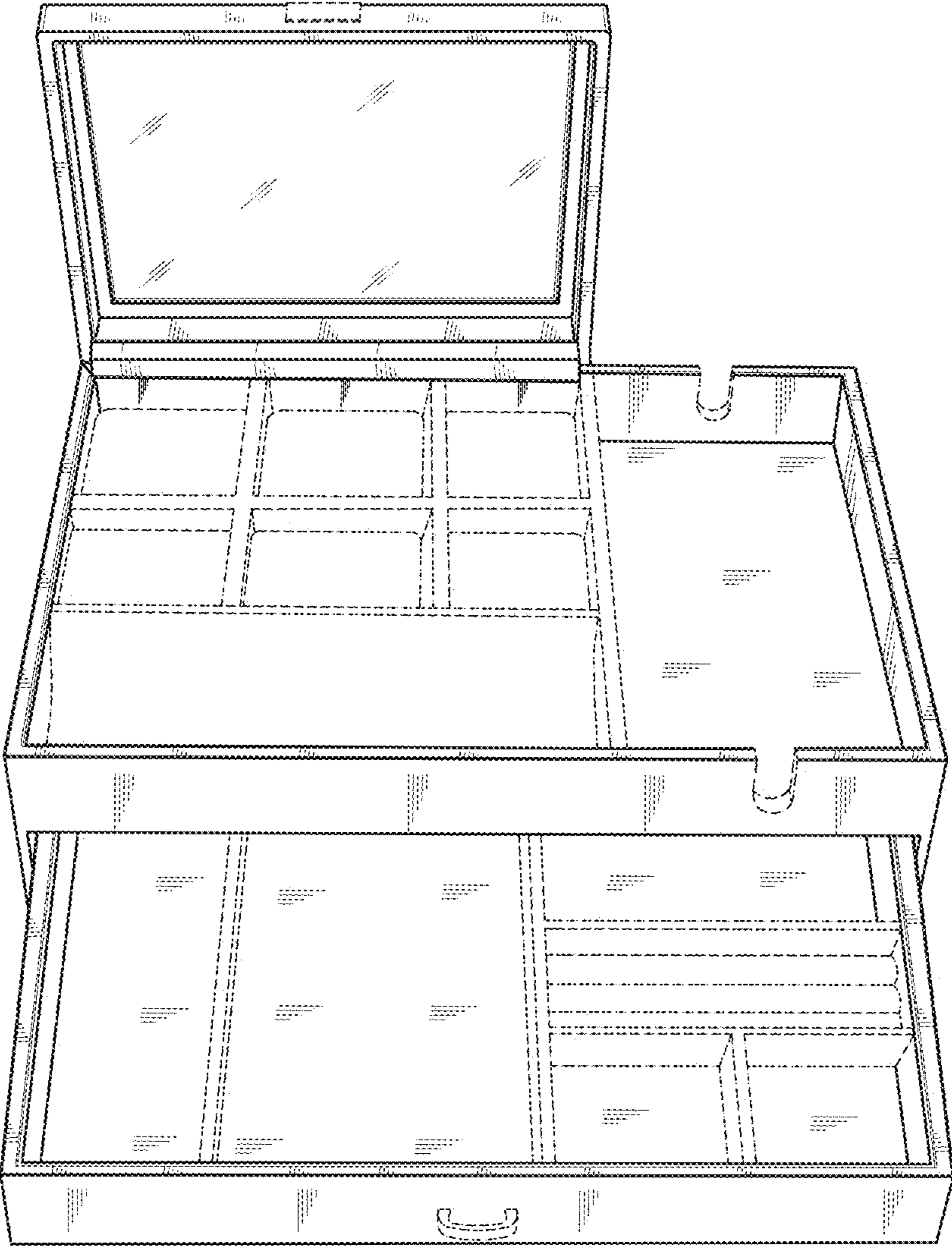

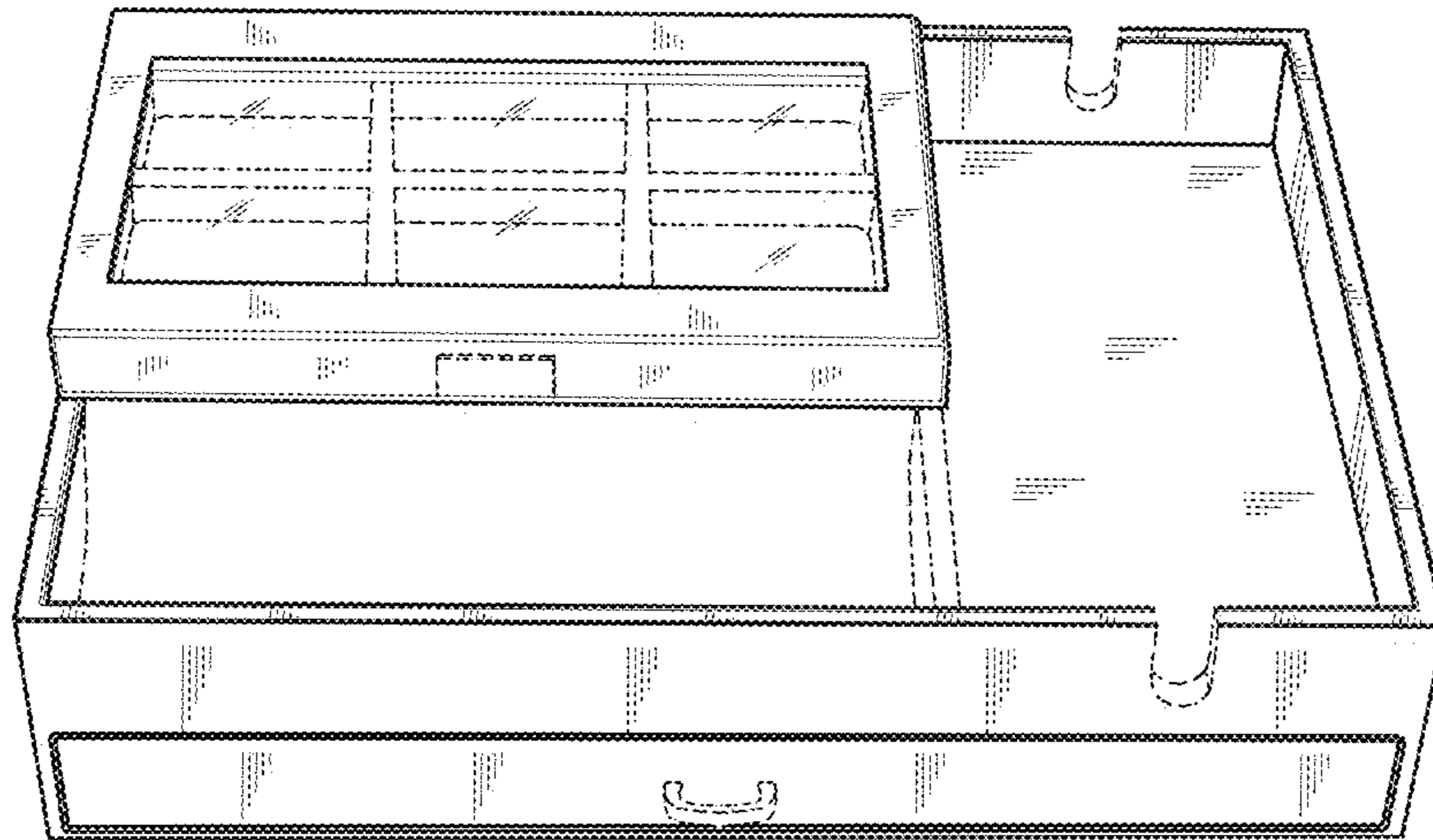

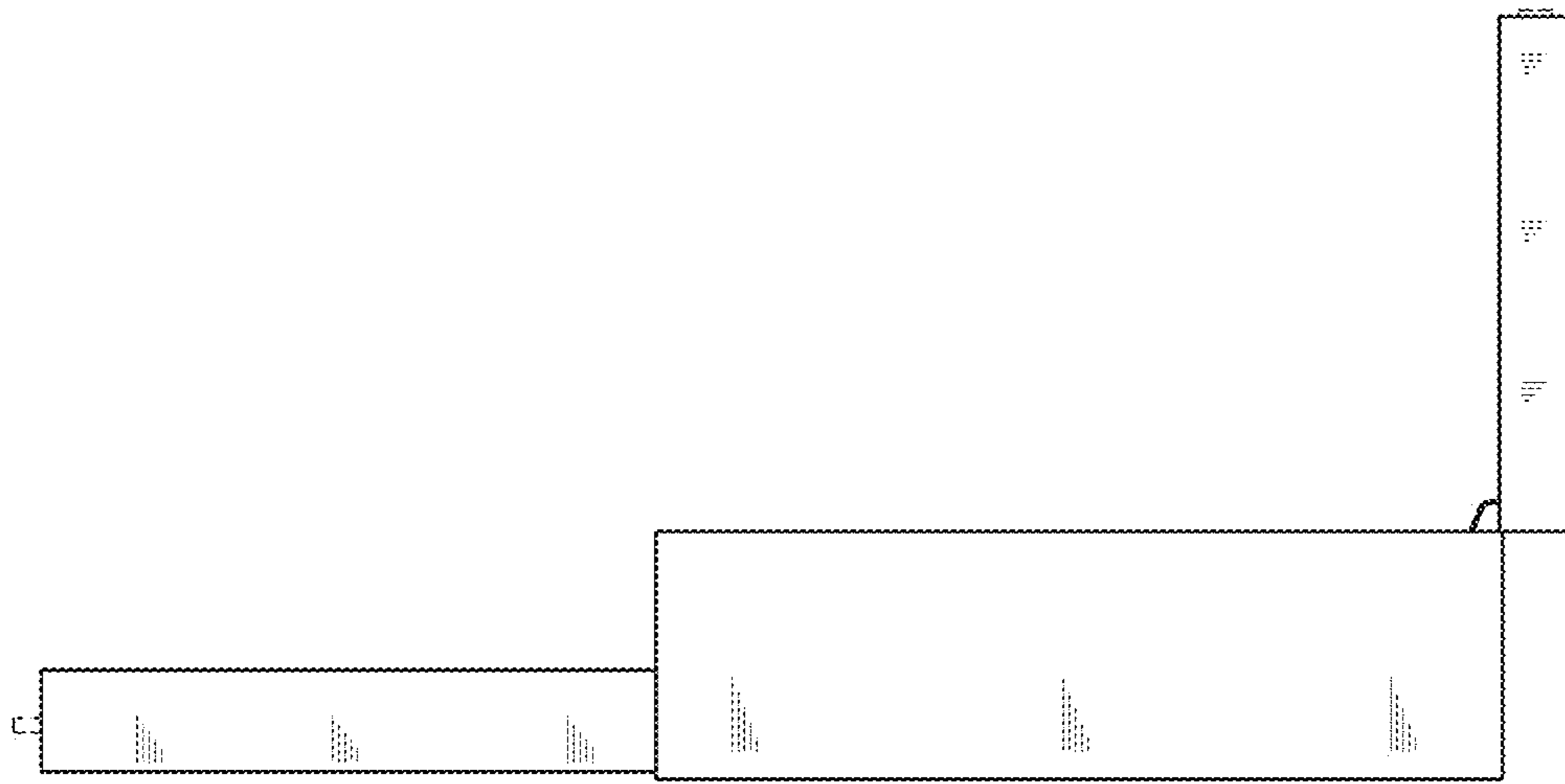

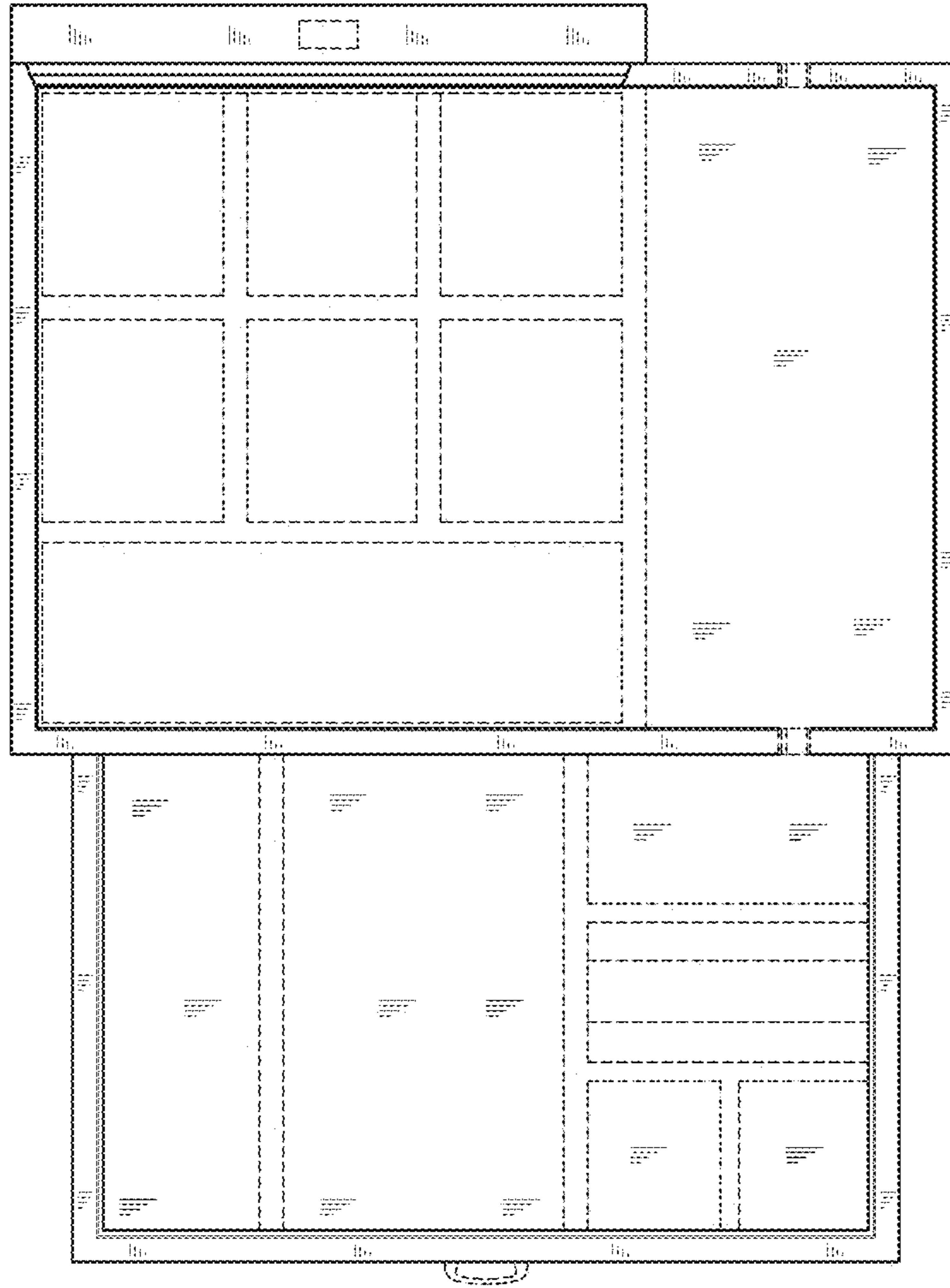

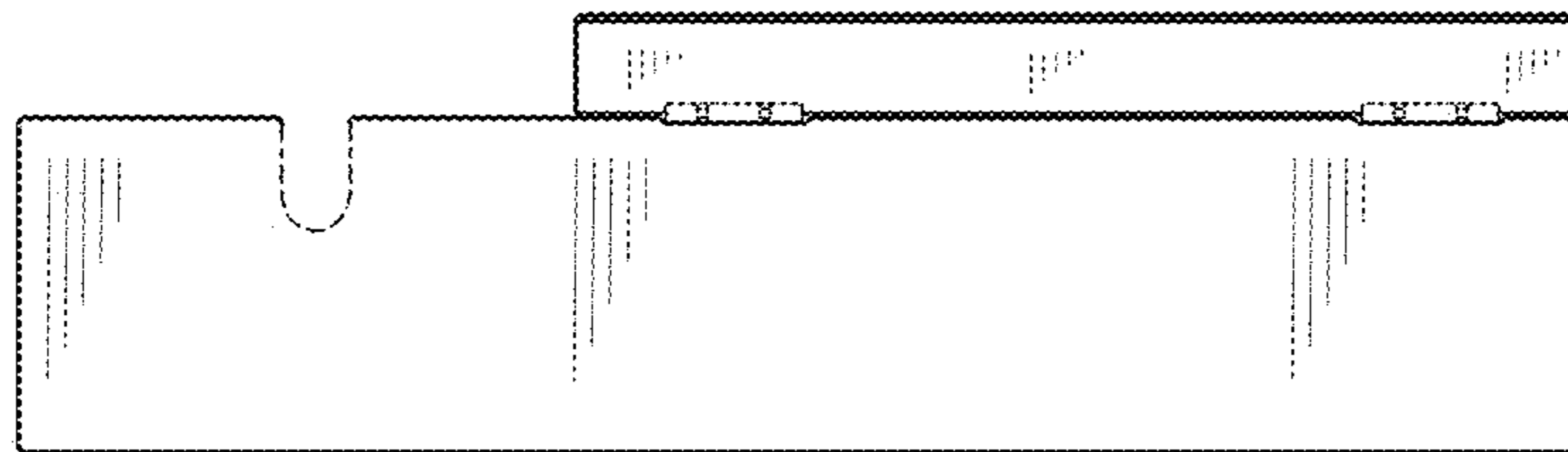

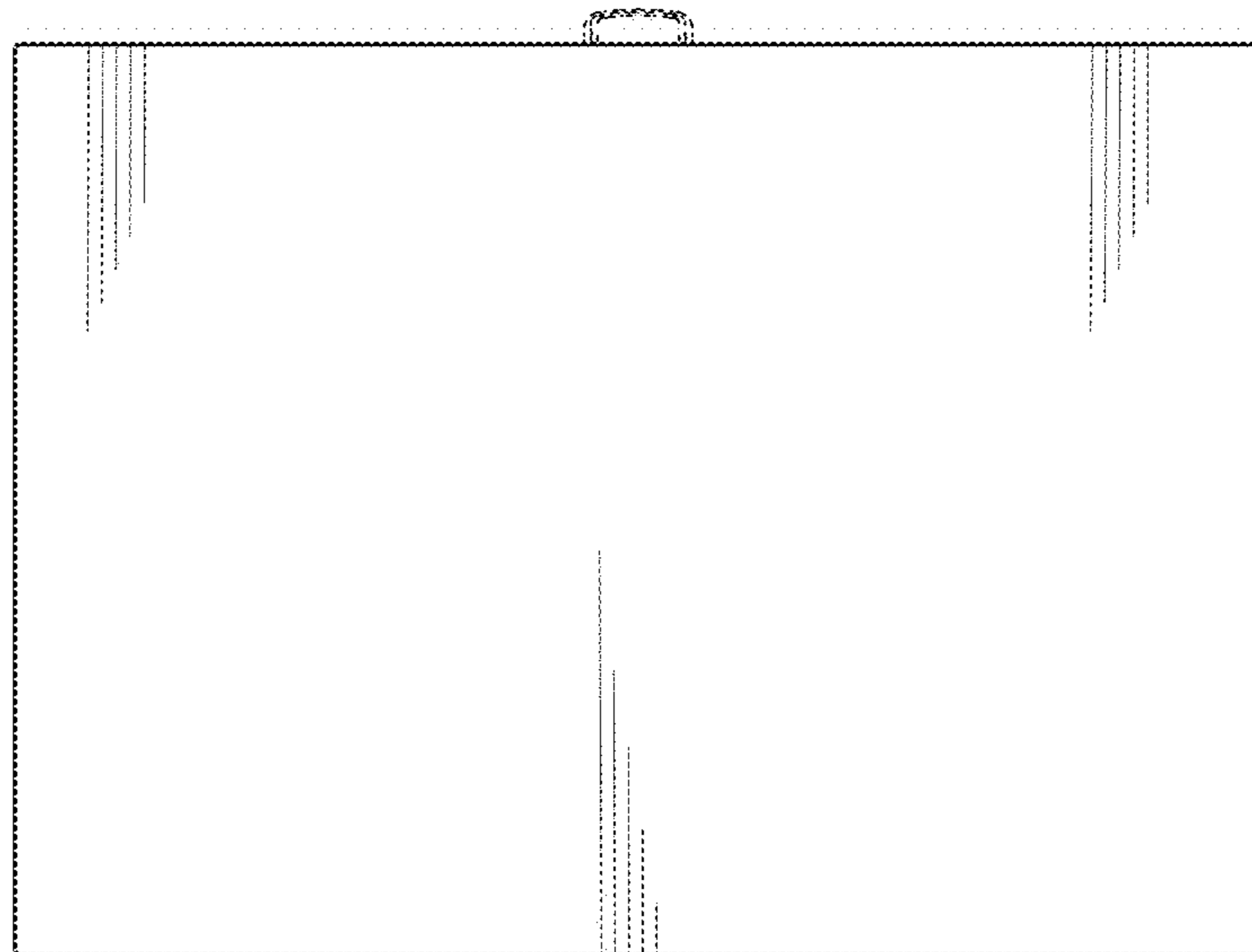

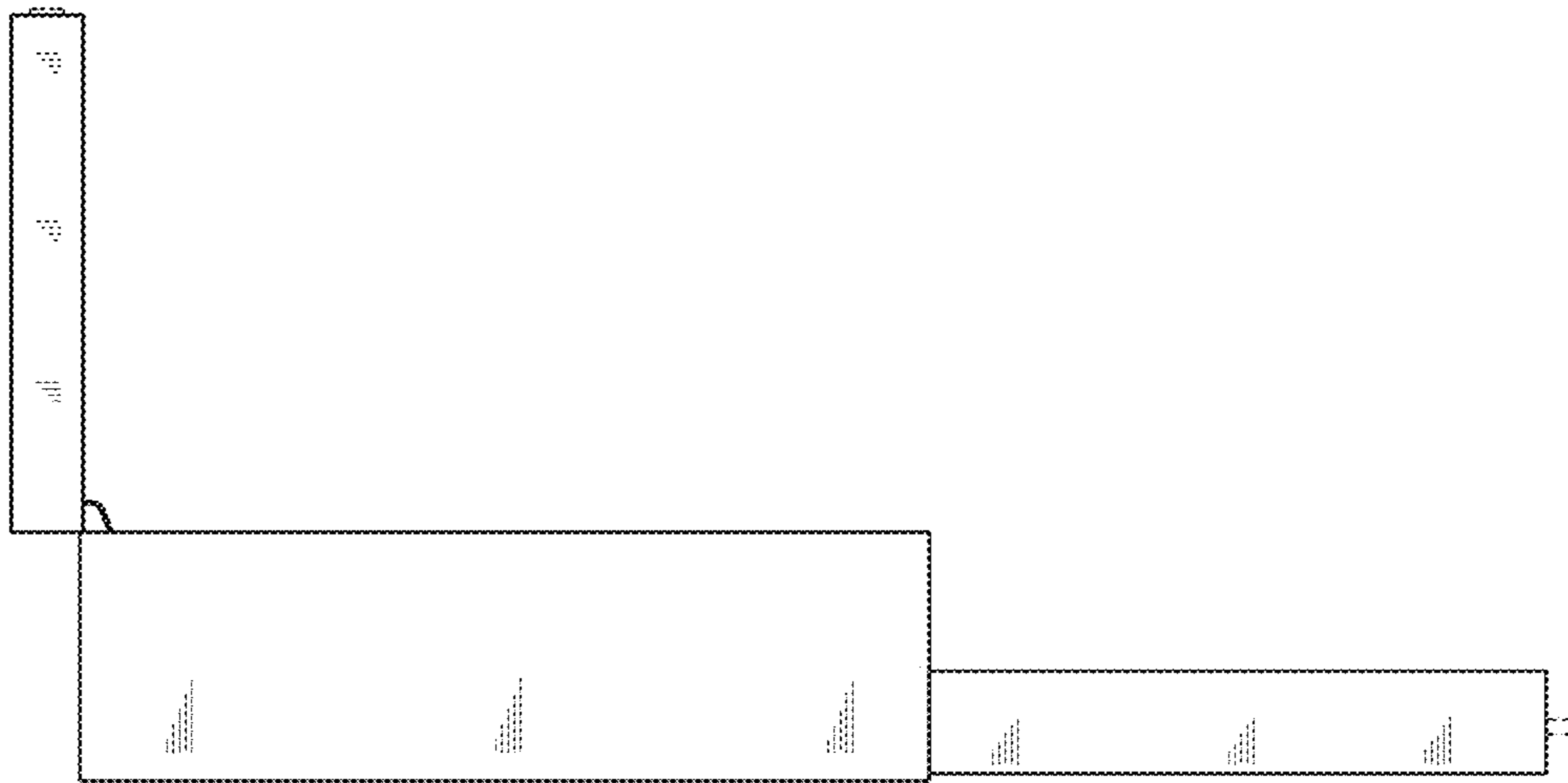
