(57) **CLAIM**

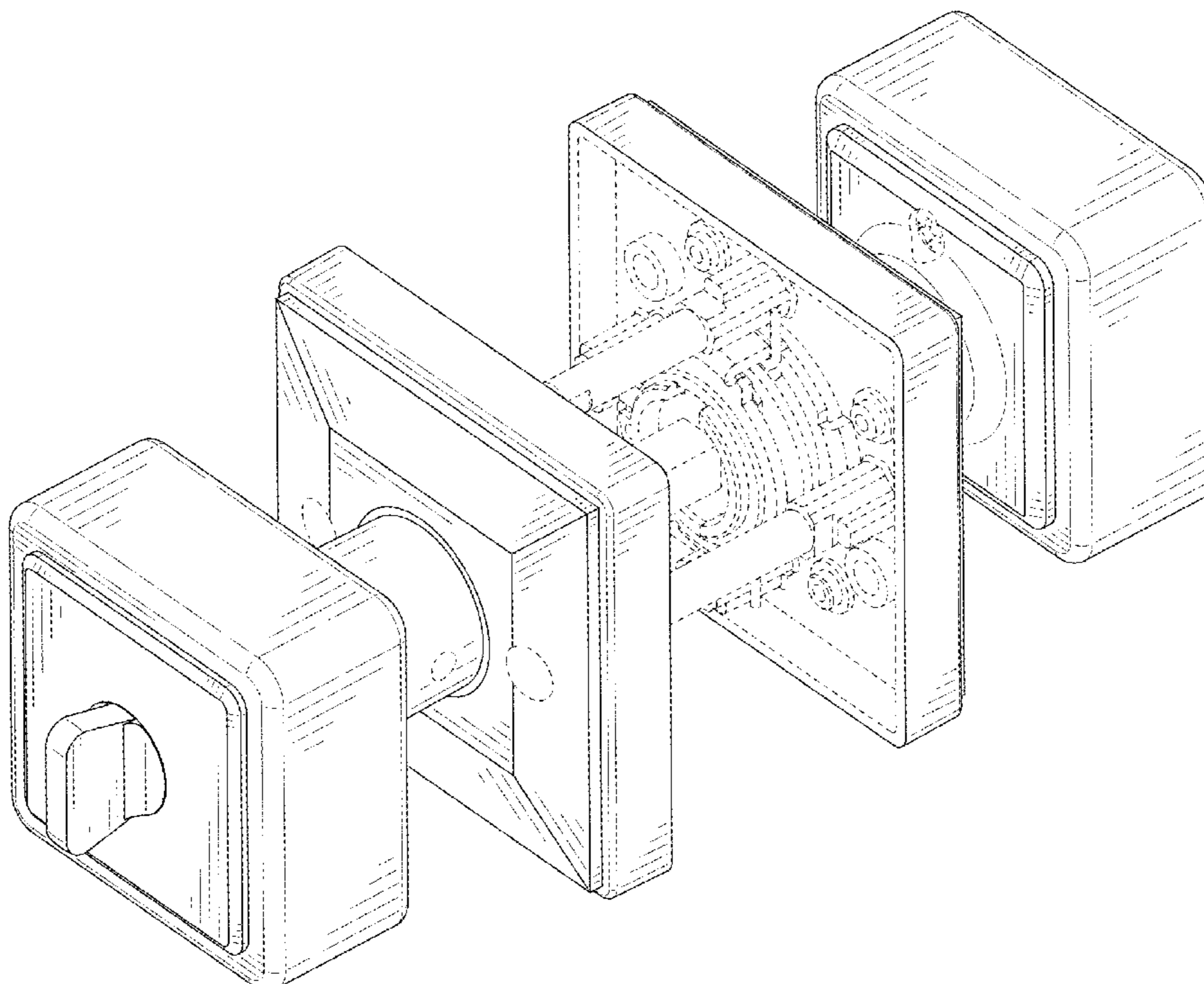
The ornamental design for a door lock, as shown and described.

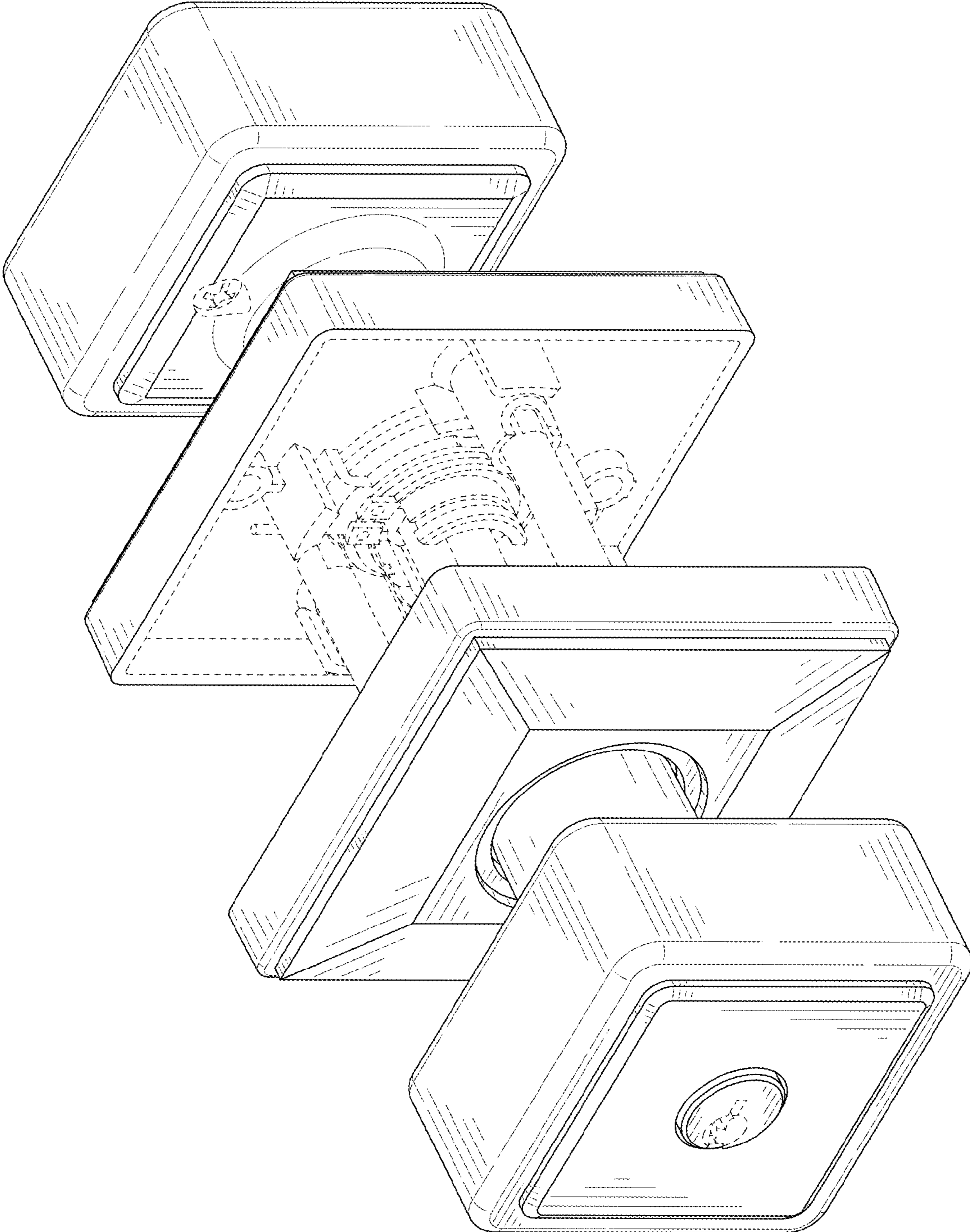

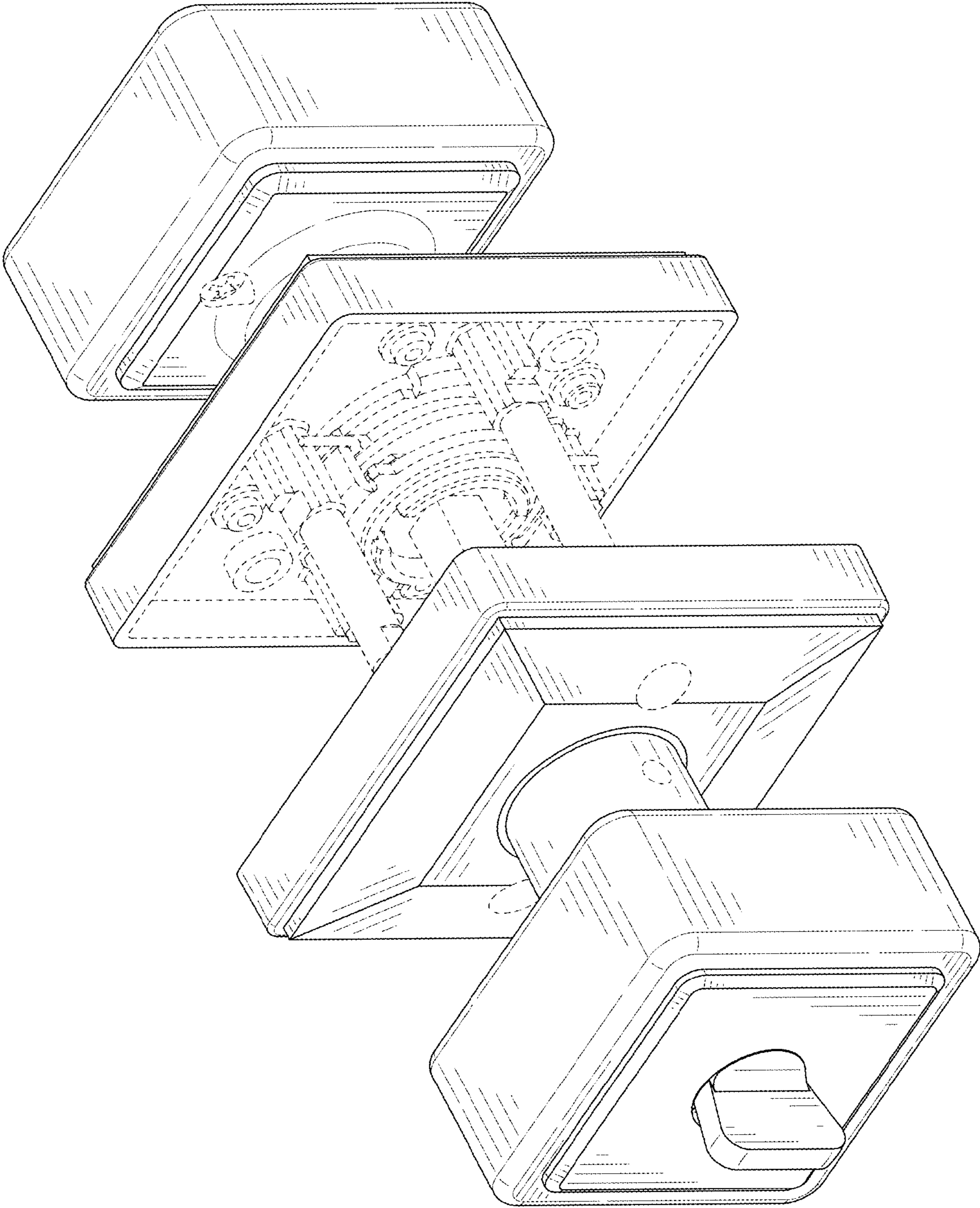

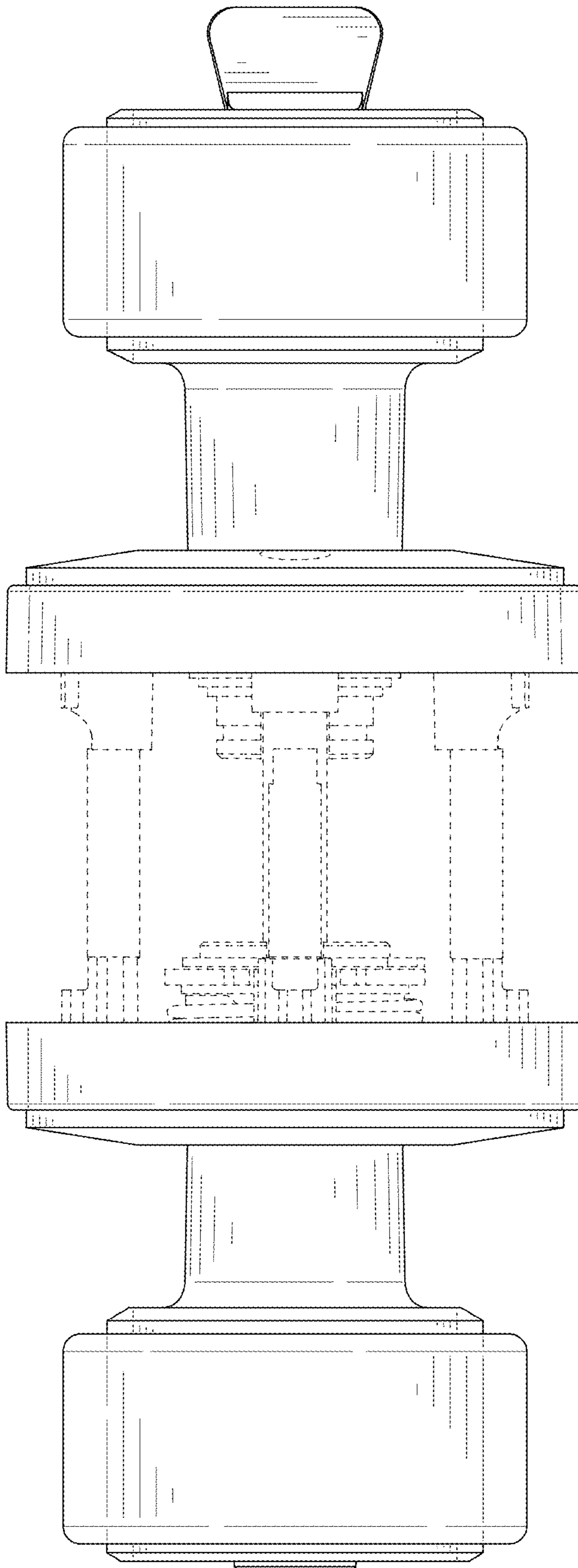

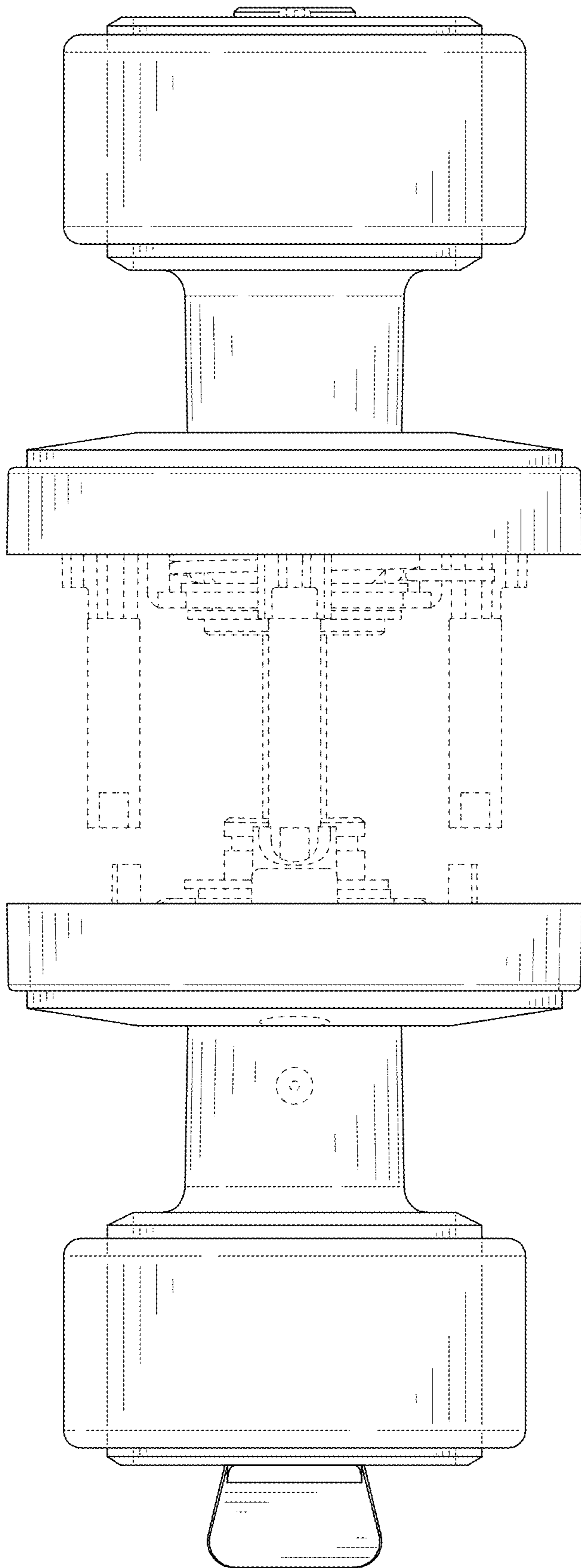

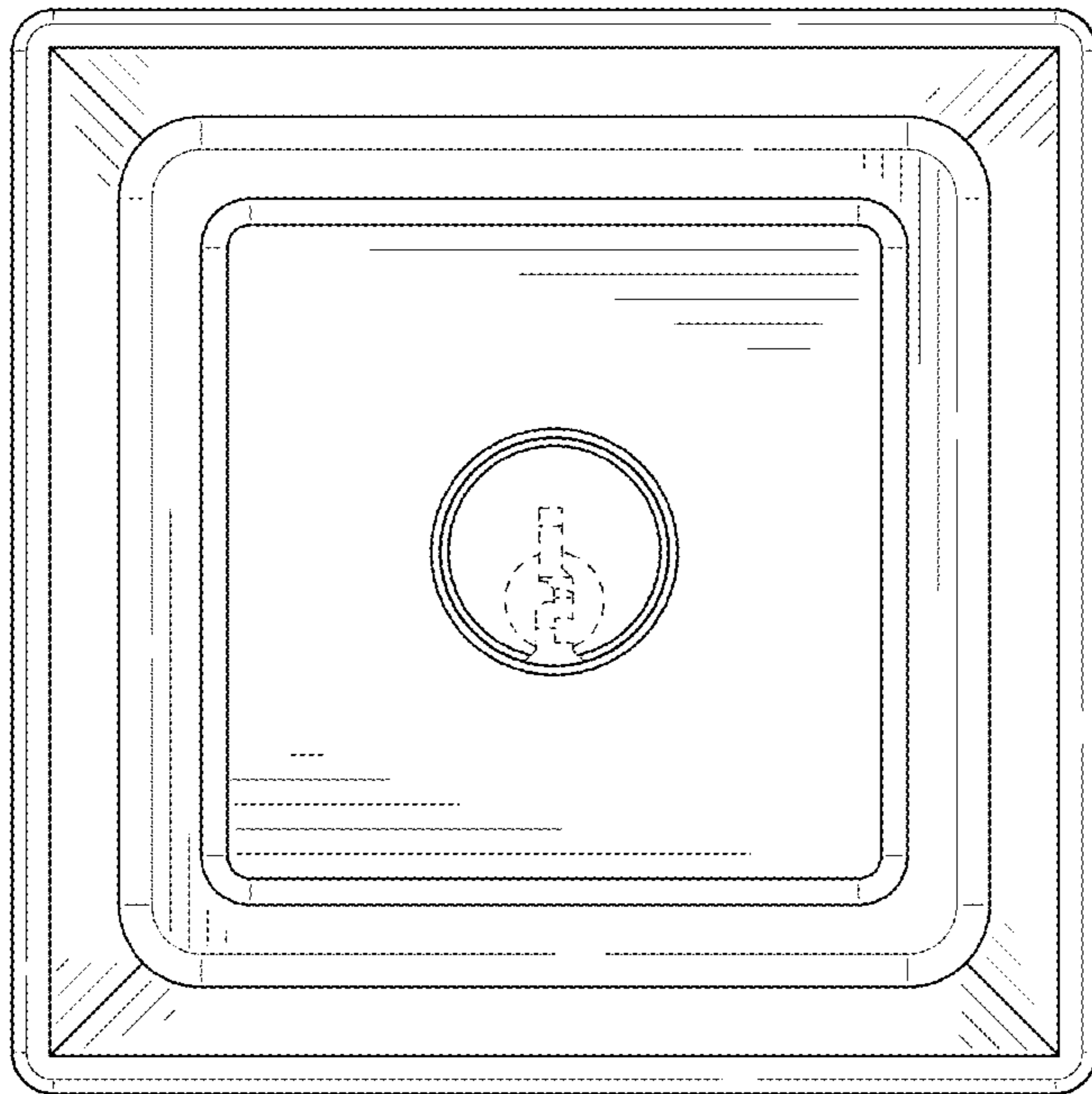

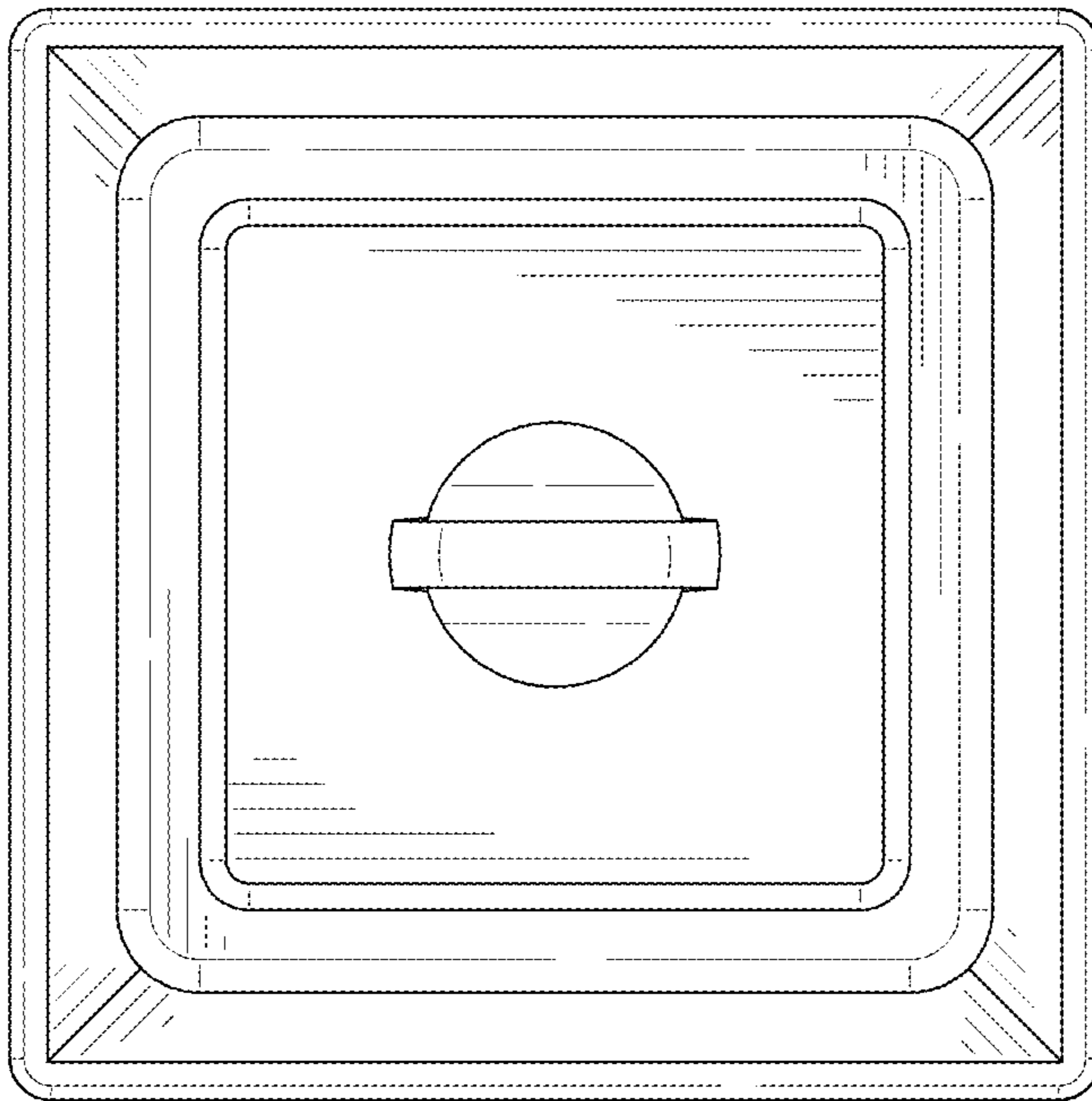

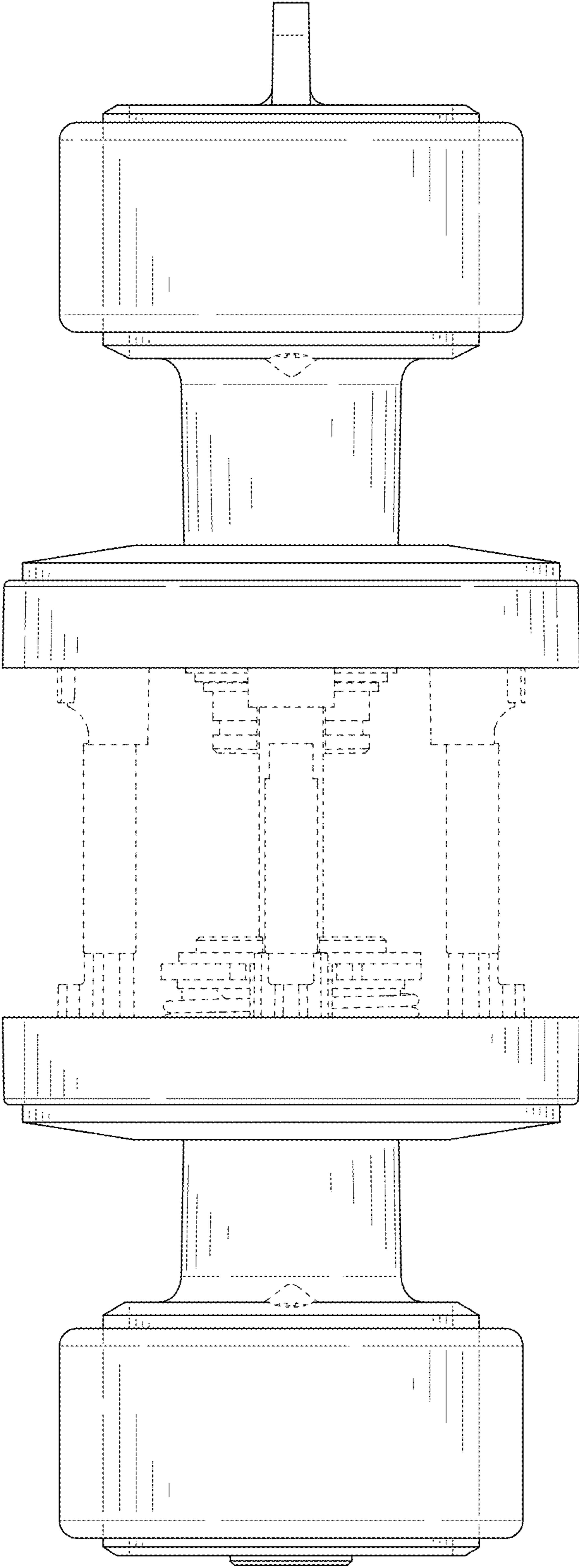

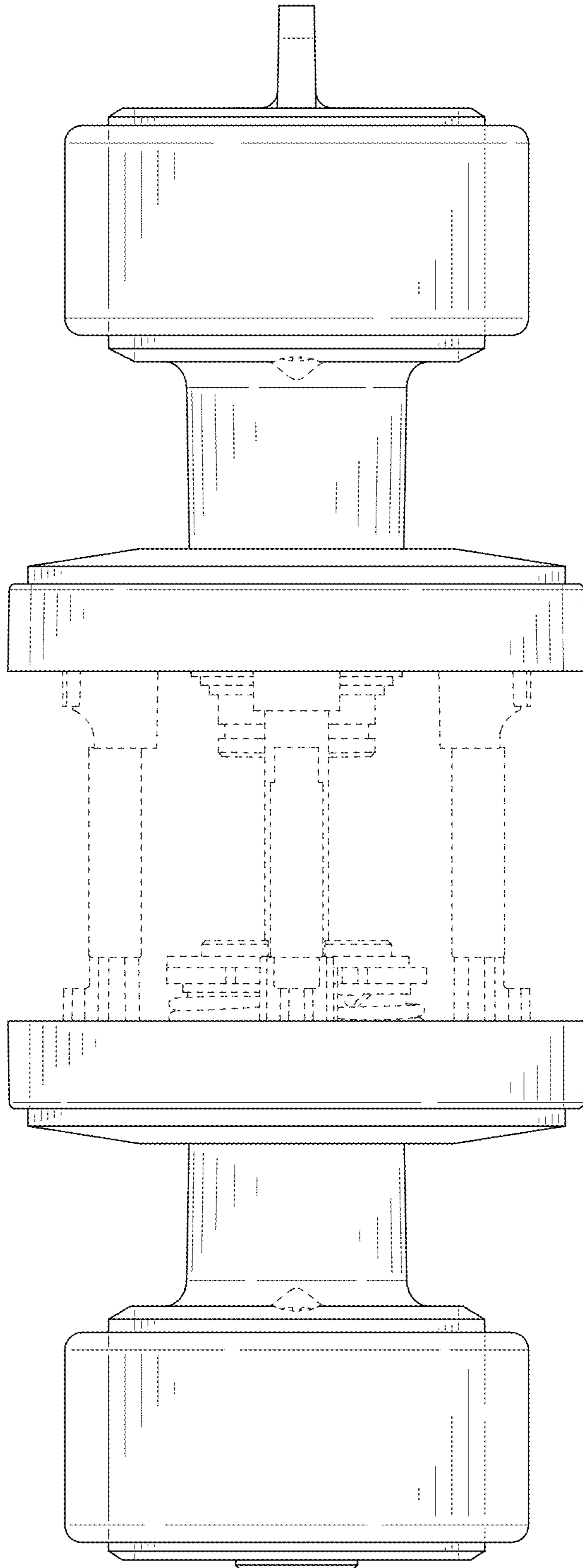
