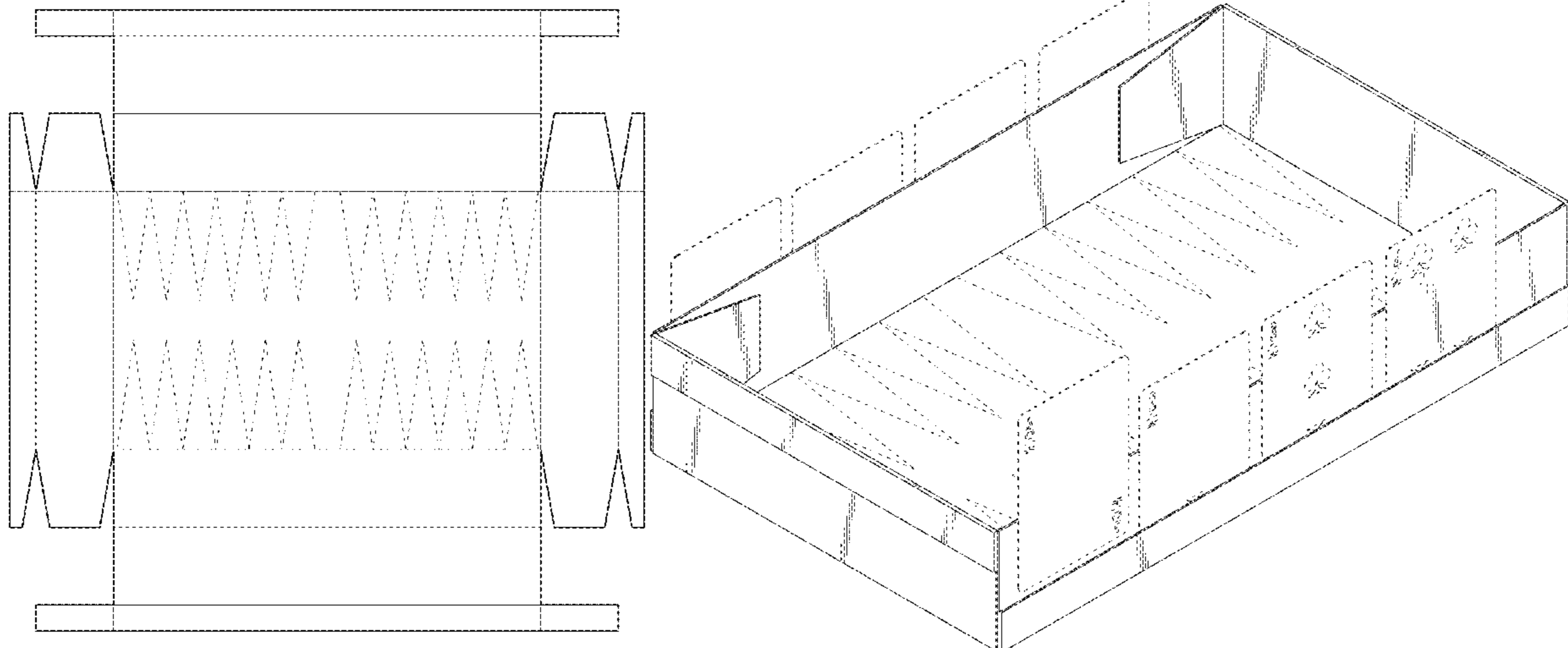
FIG. 7 is a top front left perspective view thereof featuring an environmental backgammon board pattern where the edges of the sheet are folded upward; and,

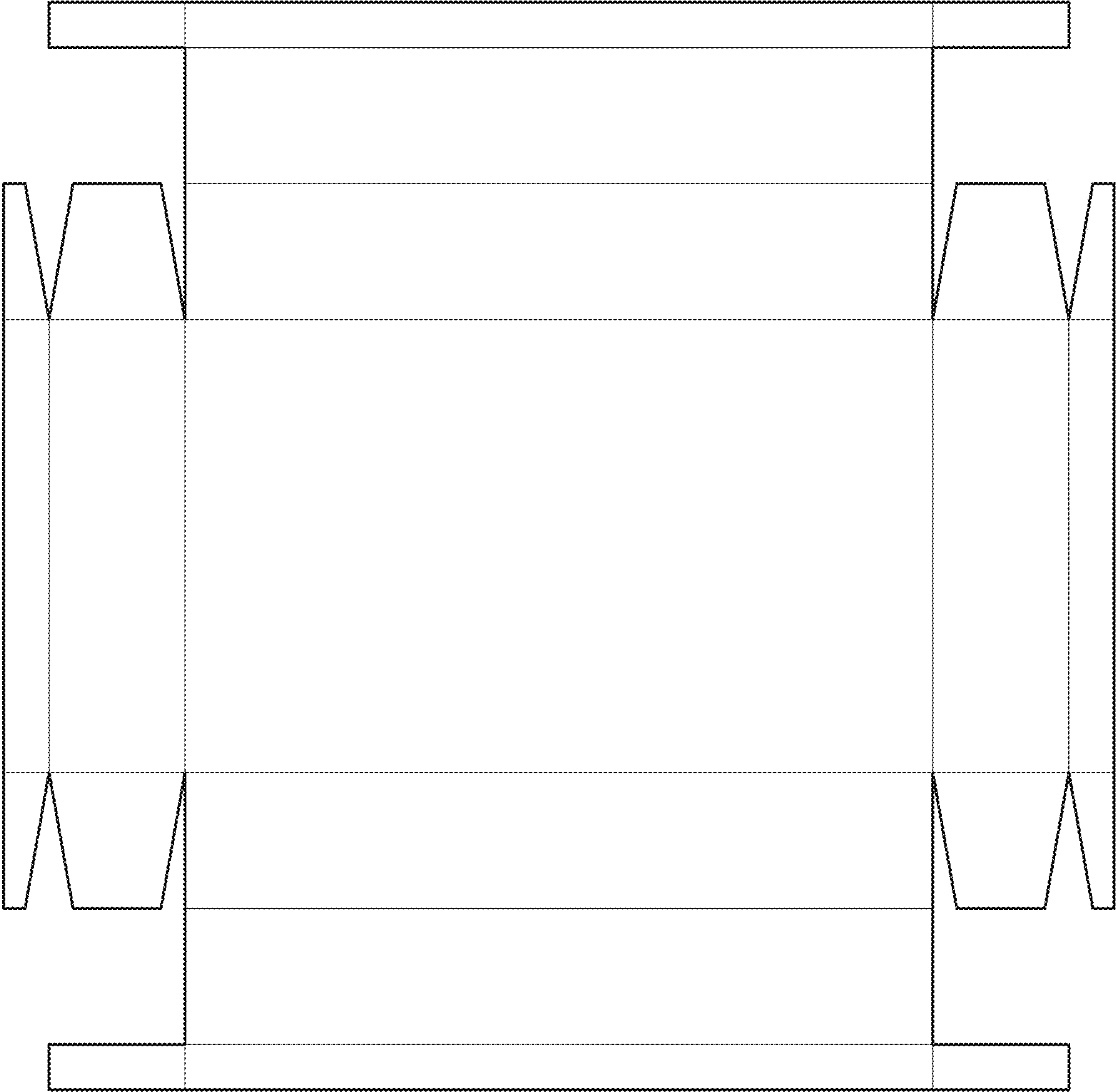

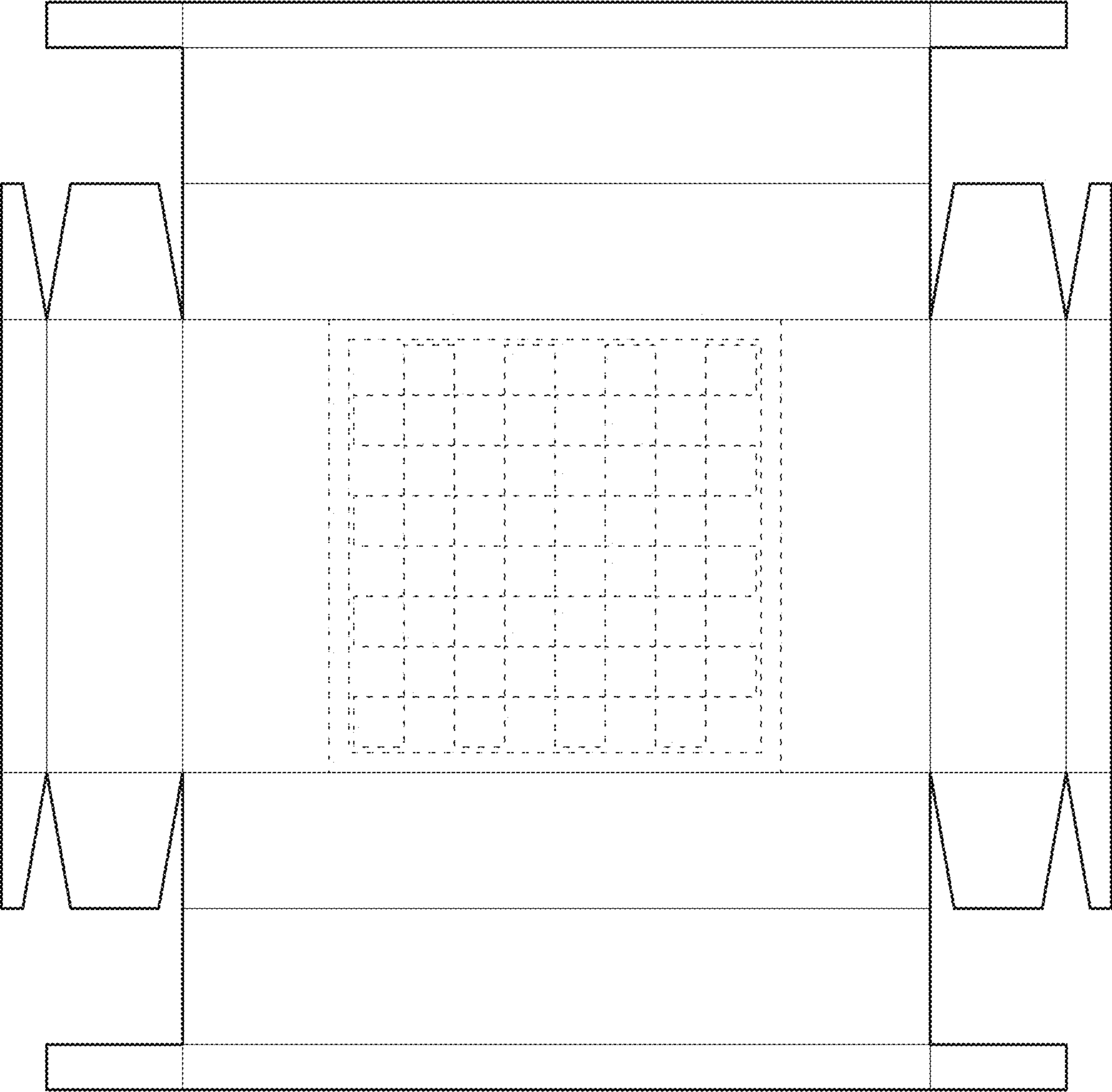

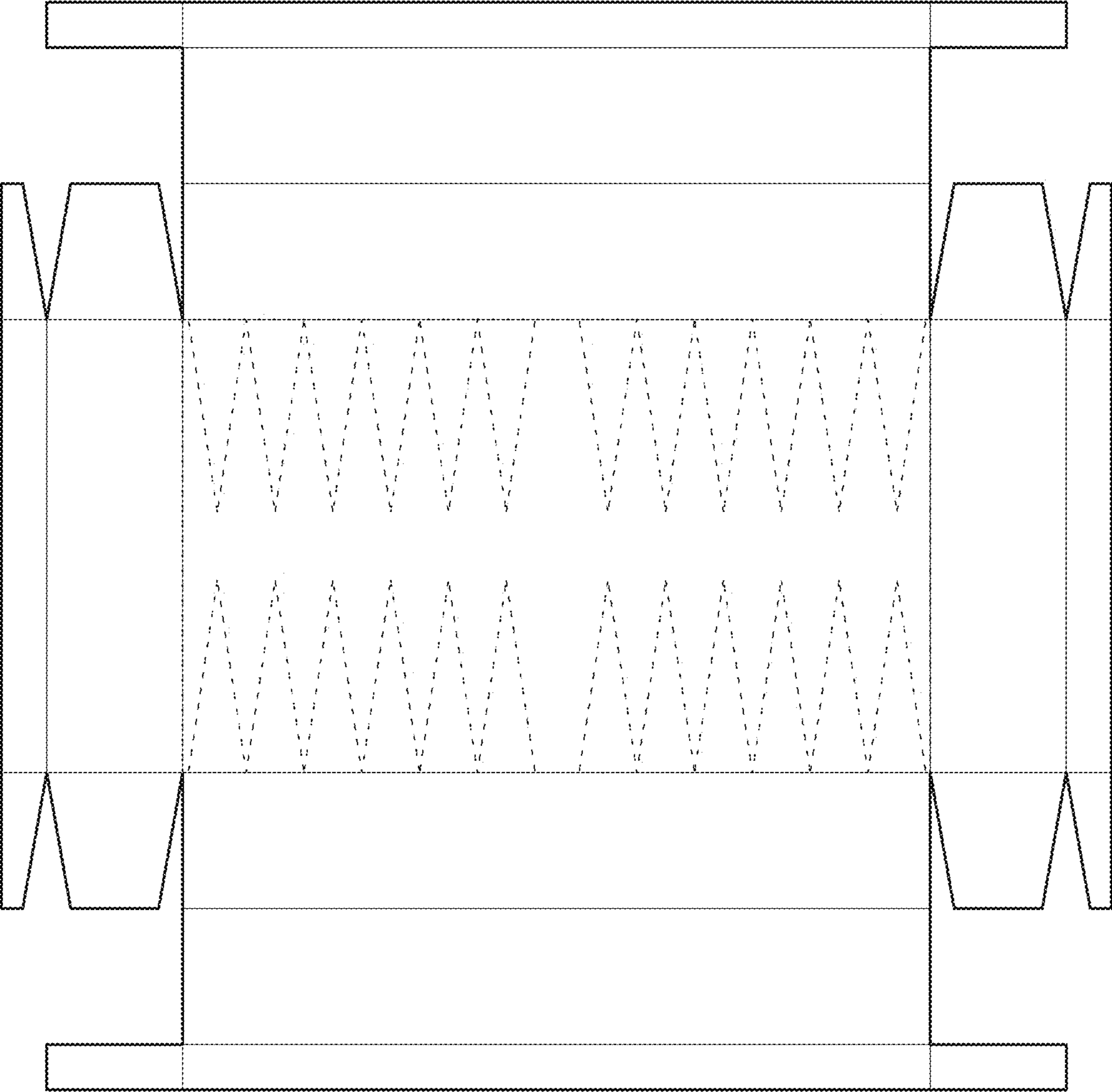

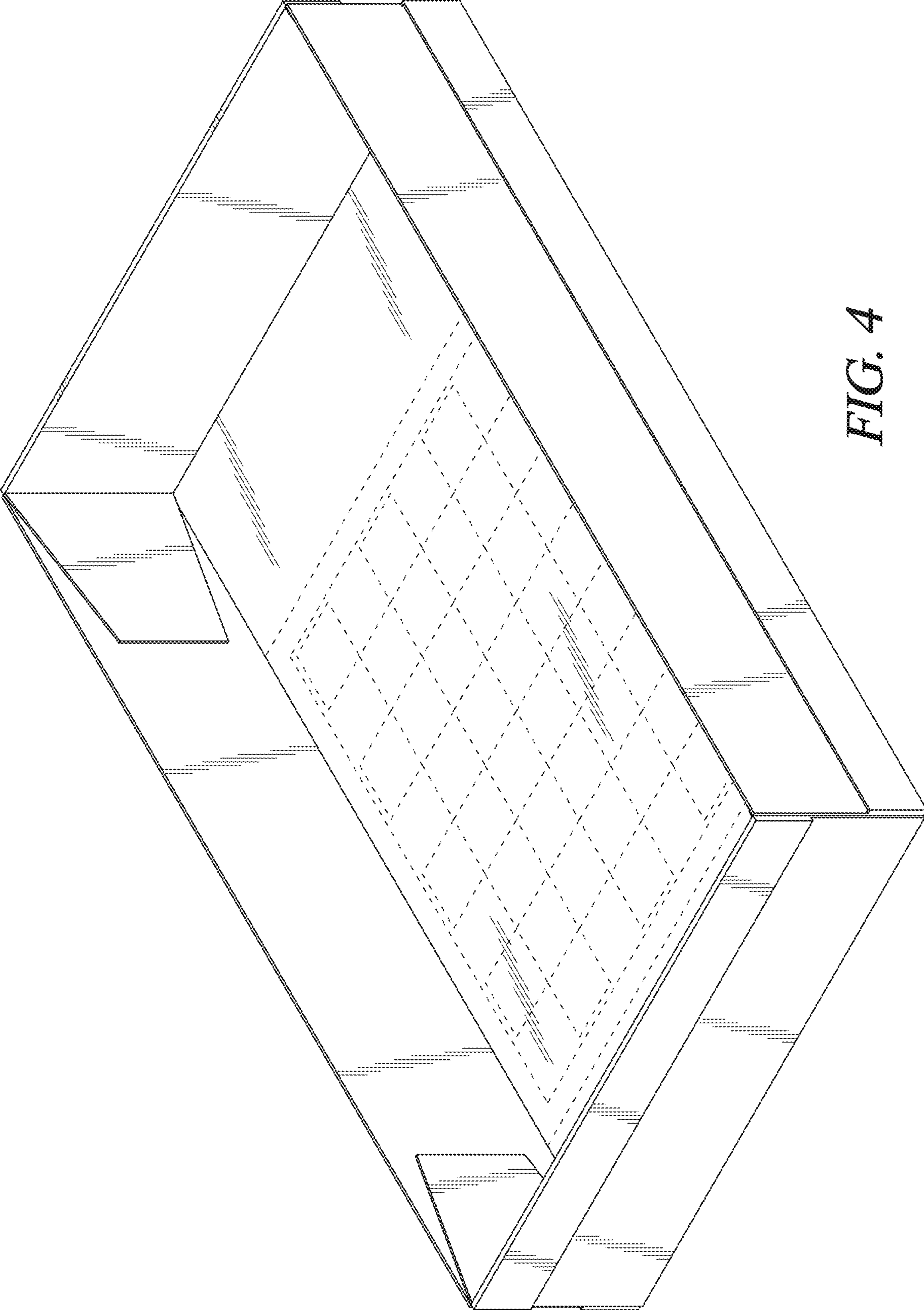

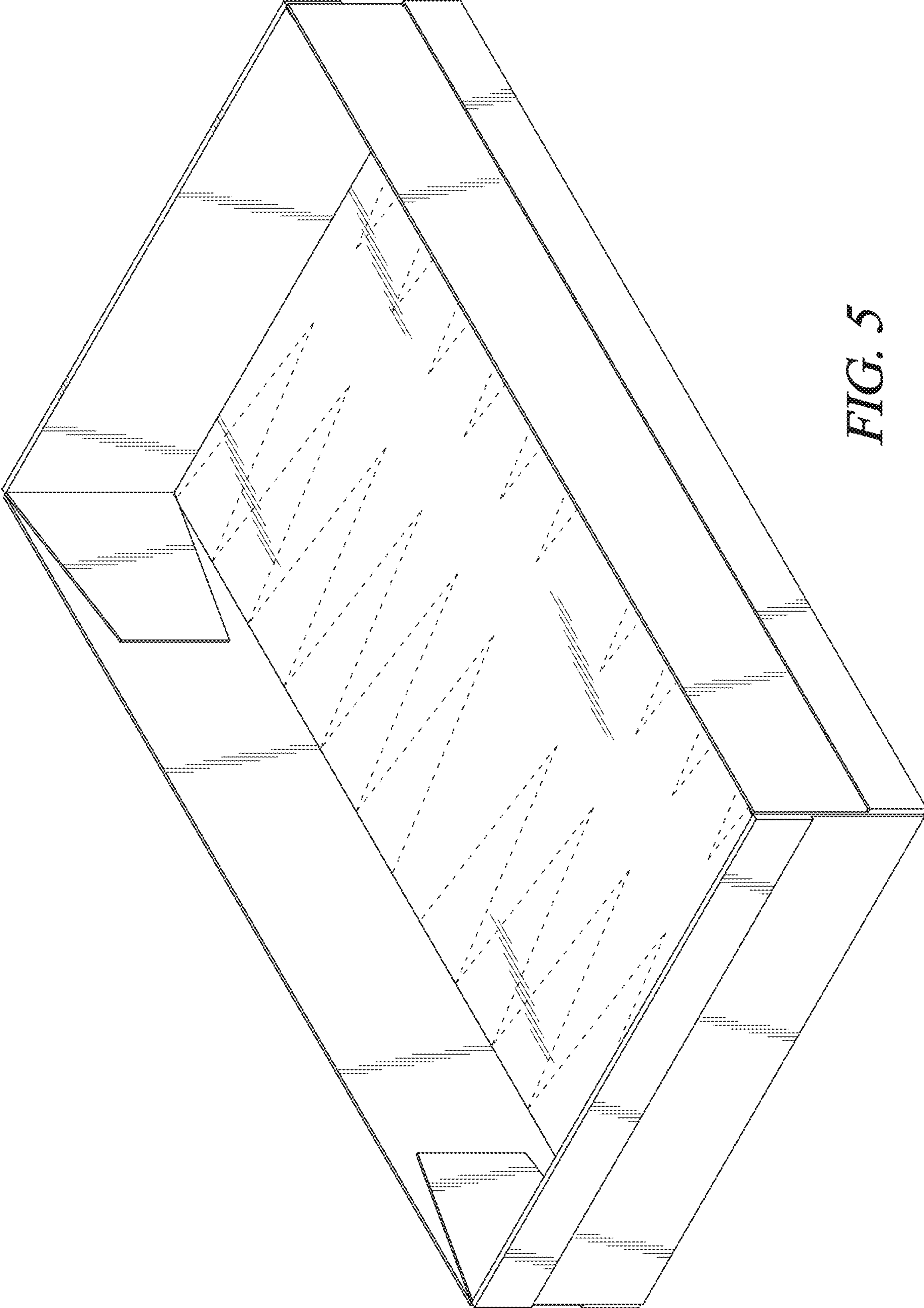

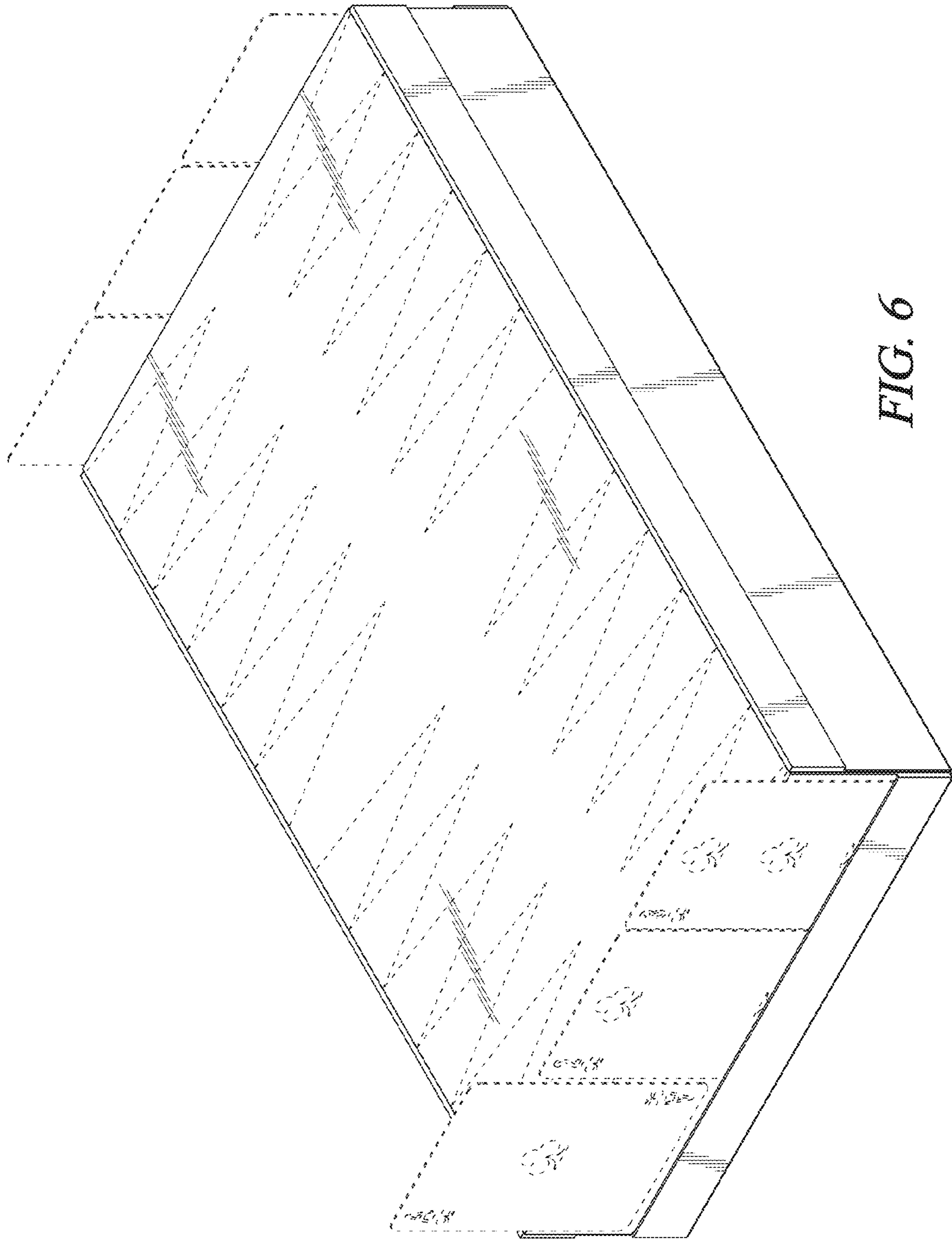

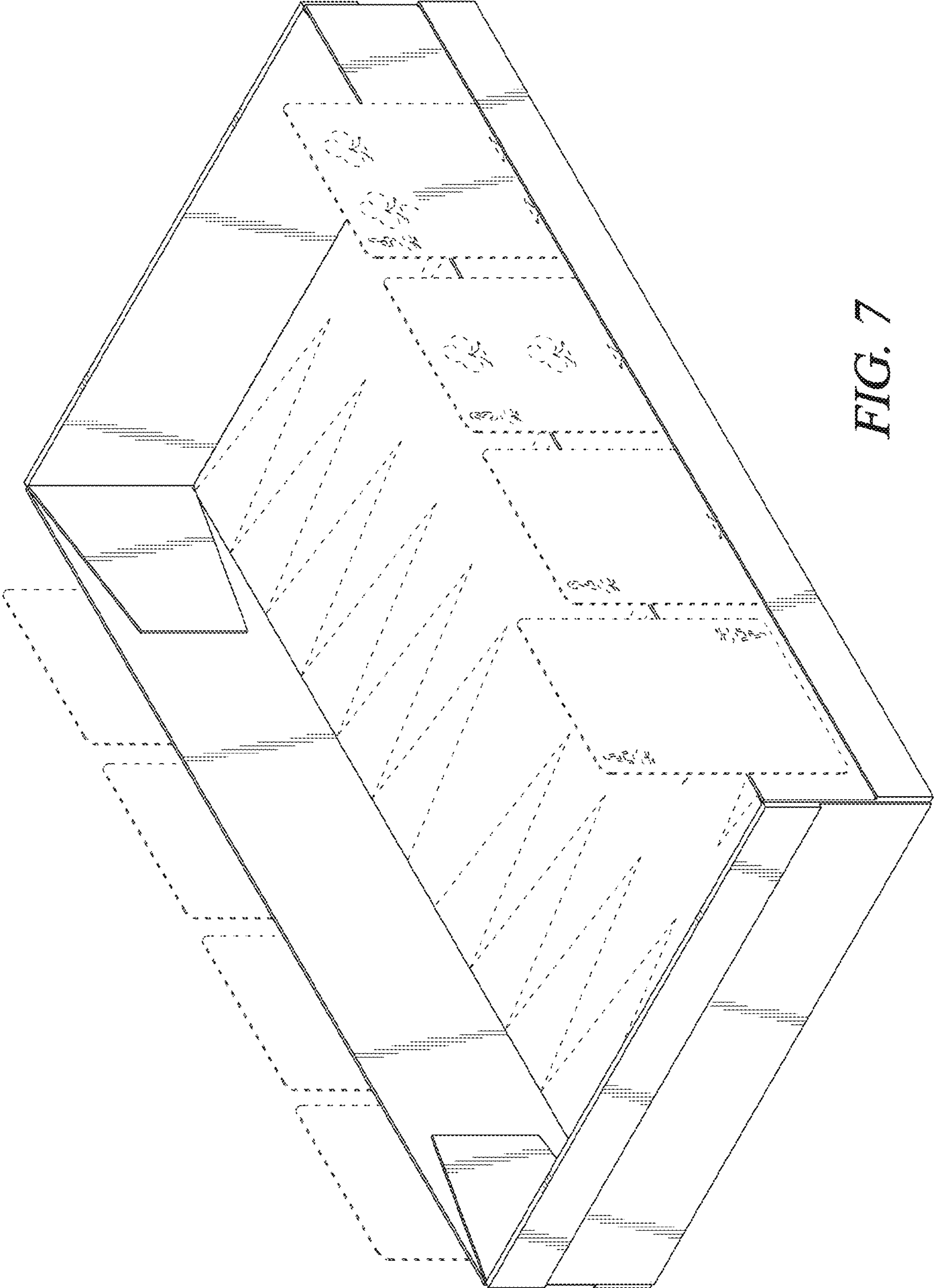

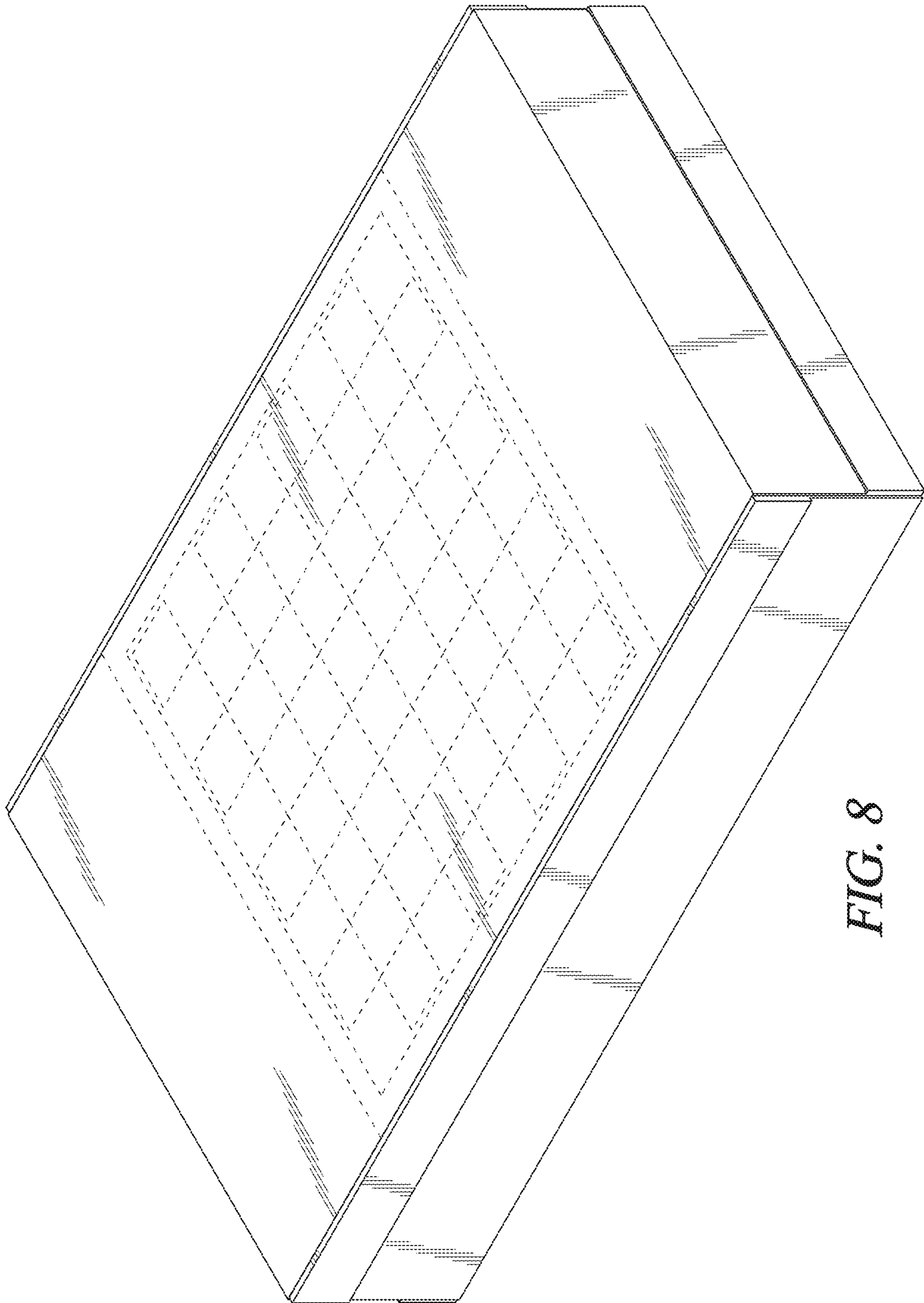
