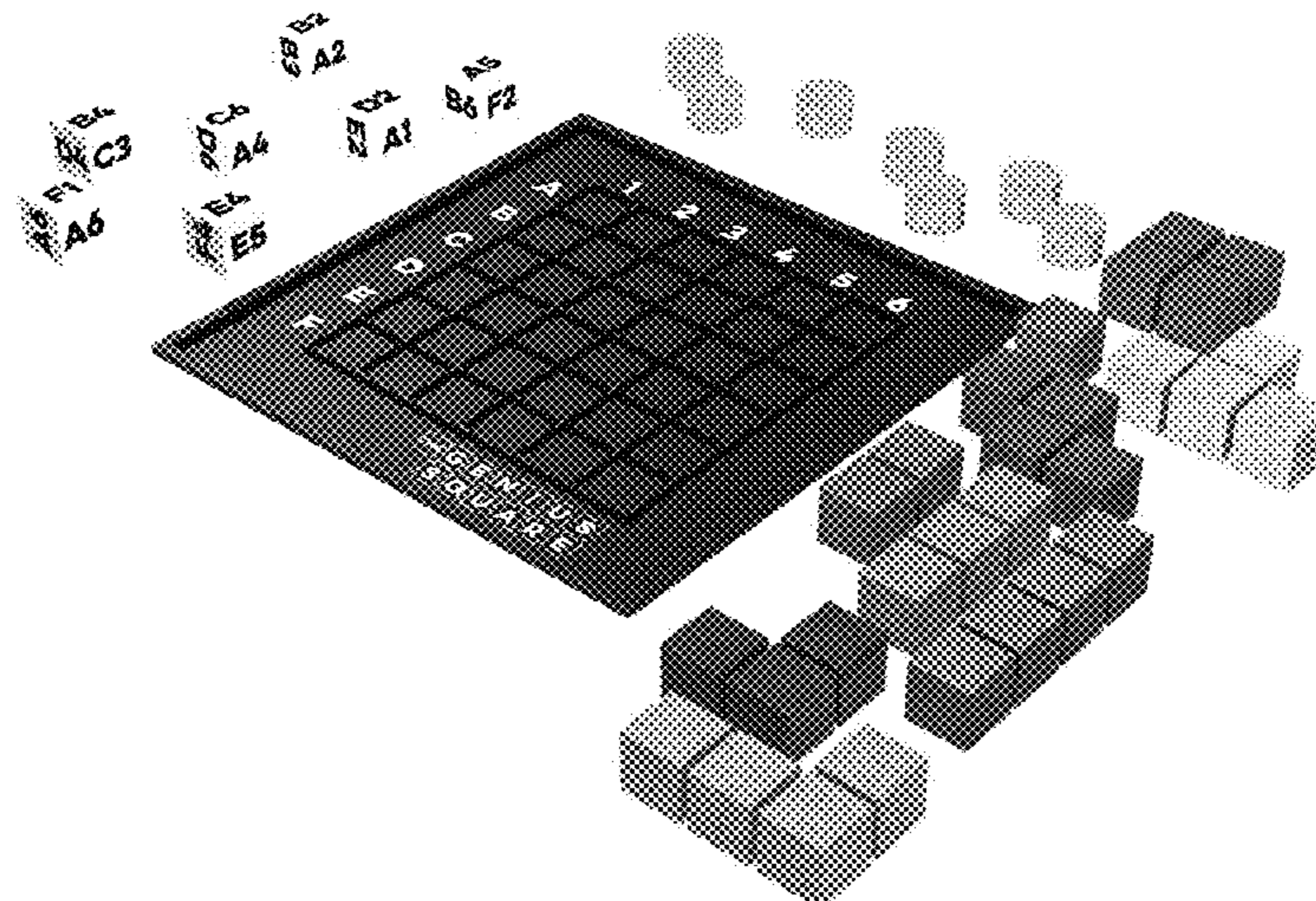
FIG. 1.4 is a front, top, right side perspective view of the puzzle game of FIG. 1.1.

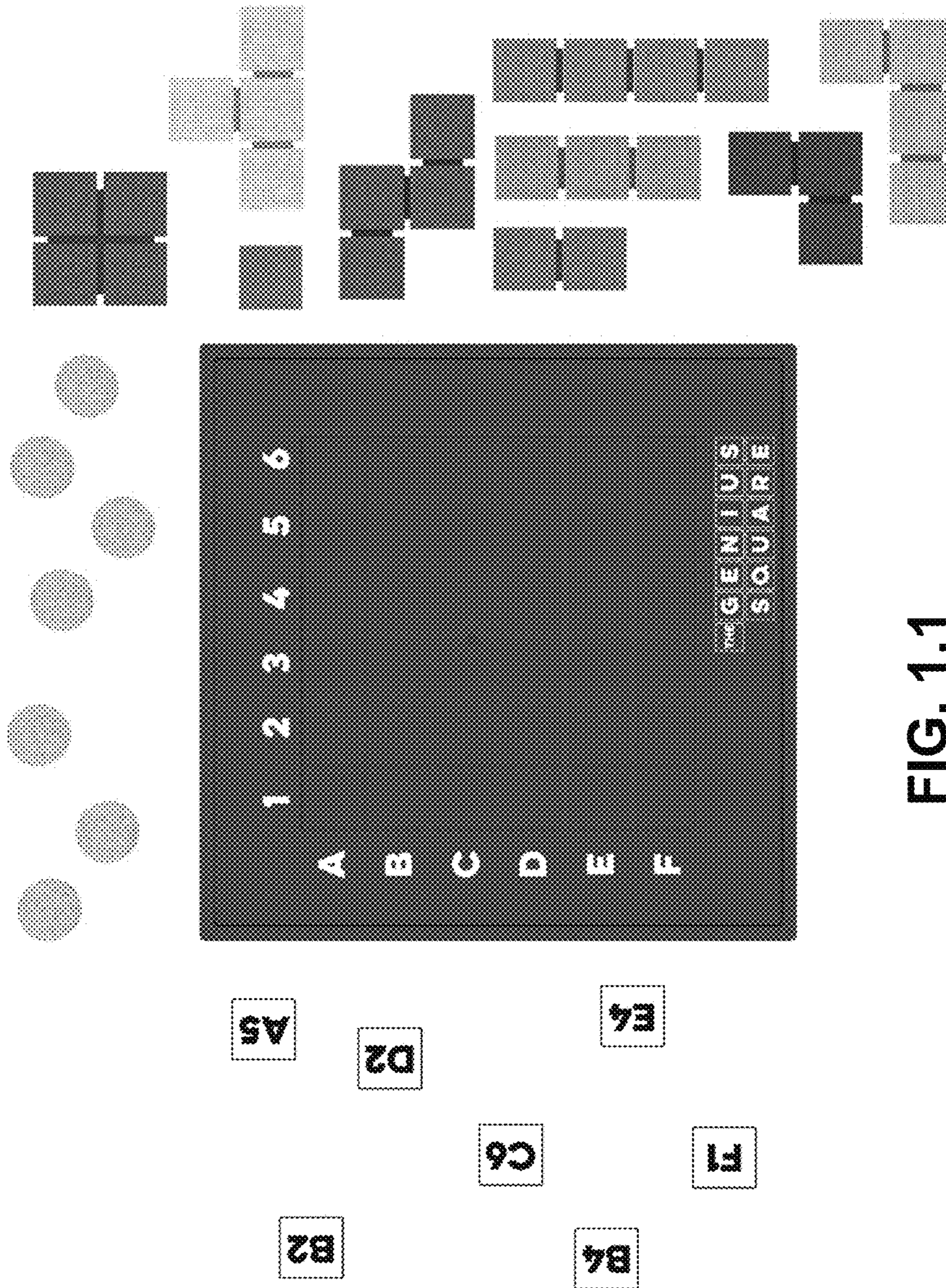

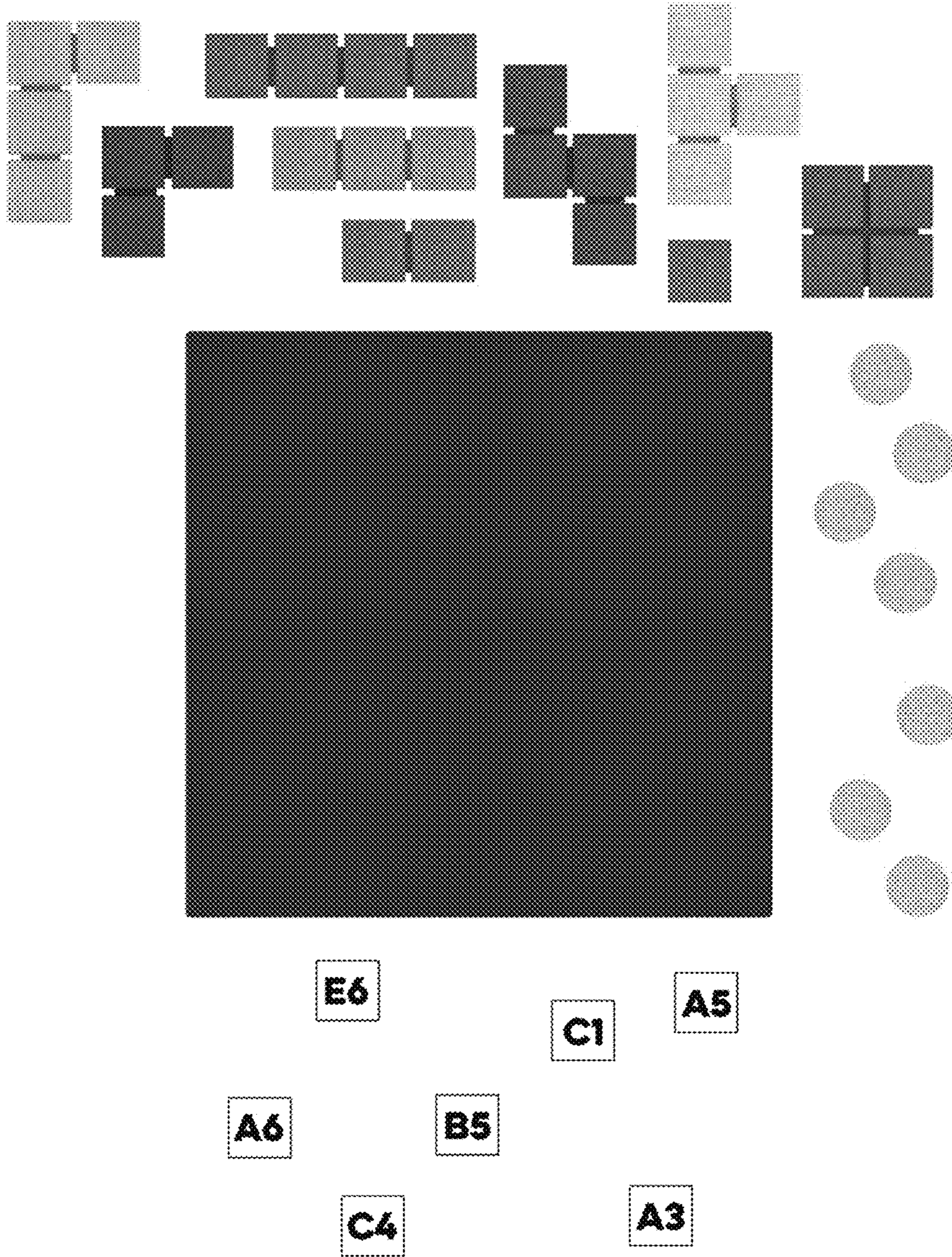

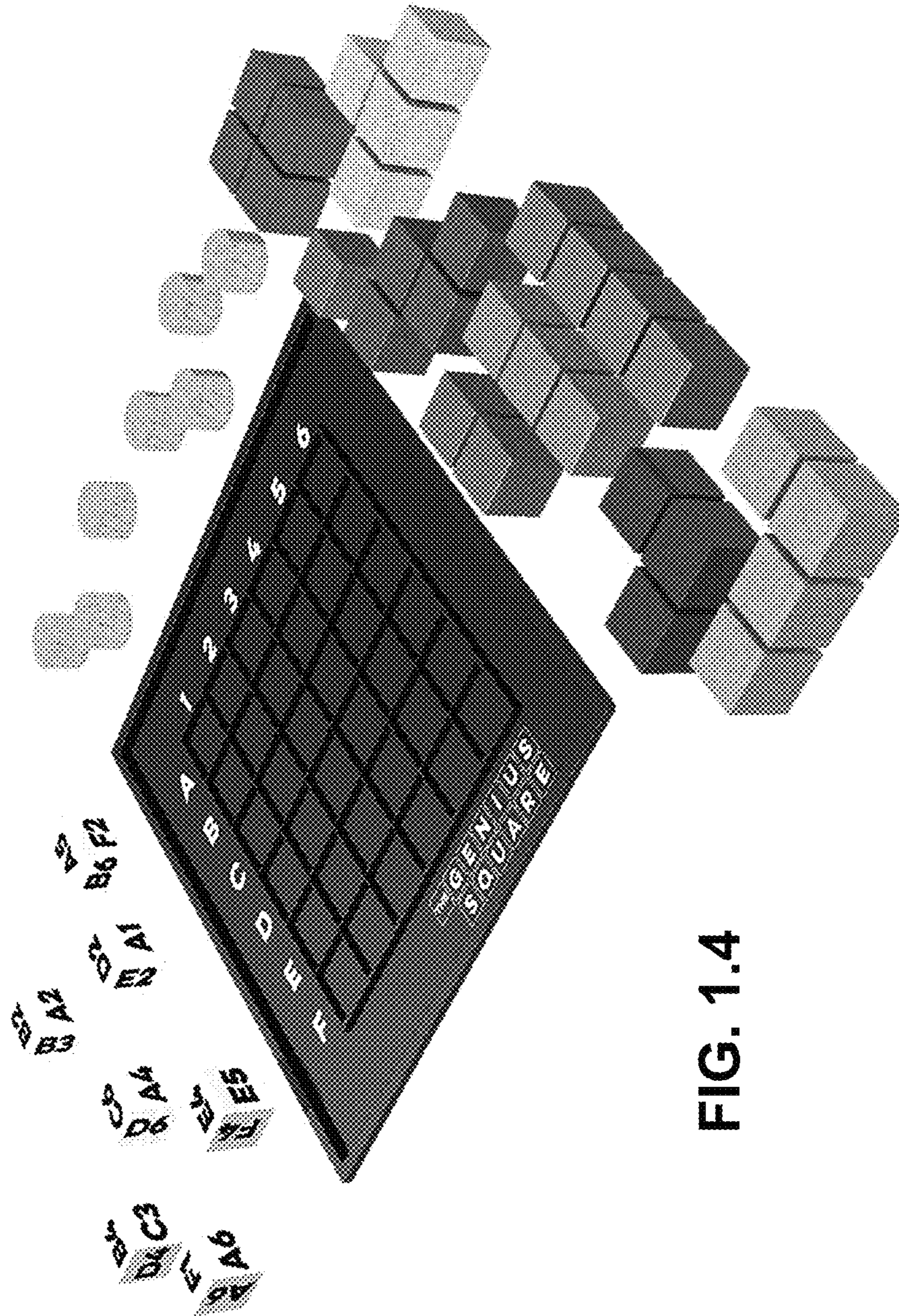

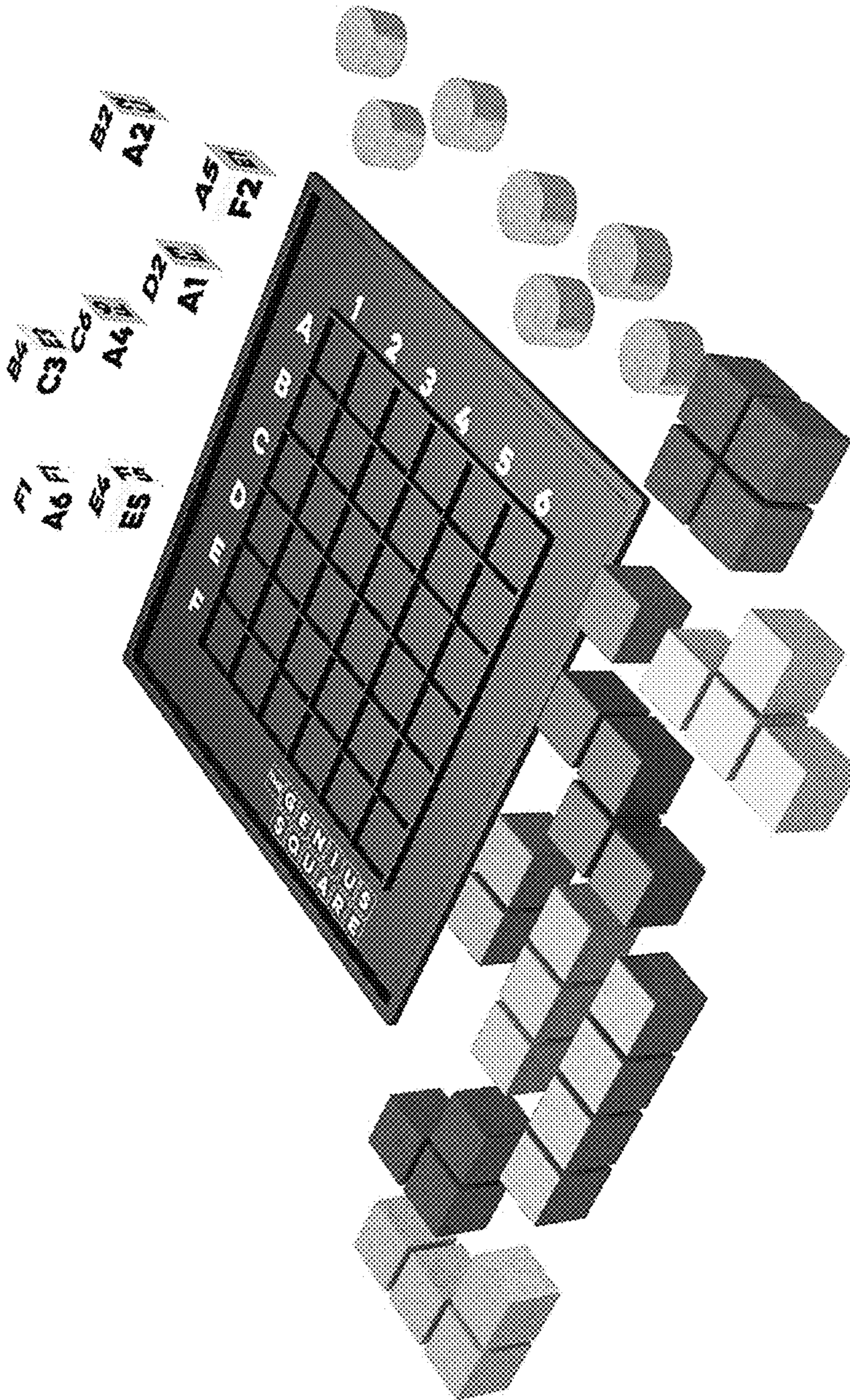

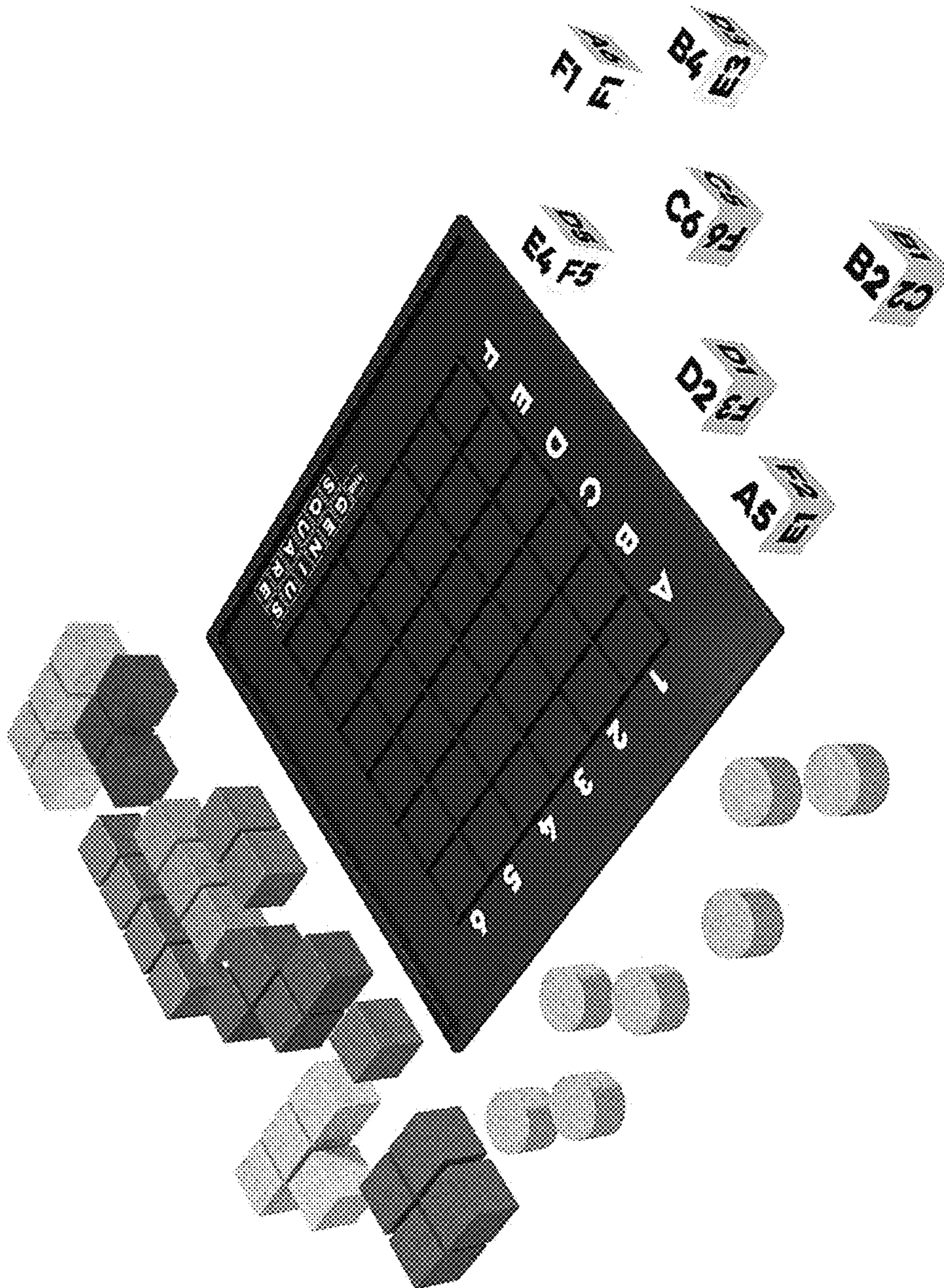
