DESCRIPTION

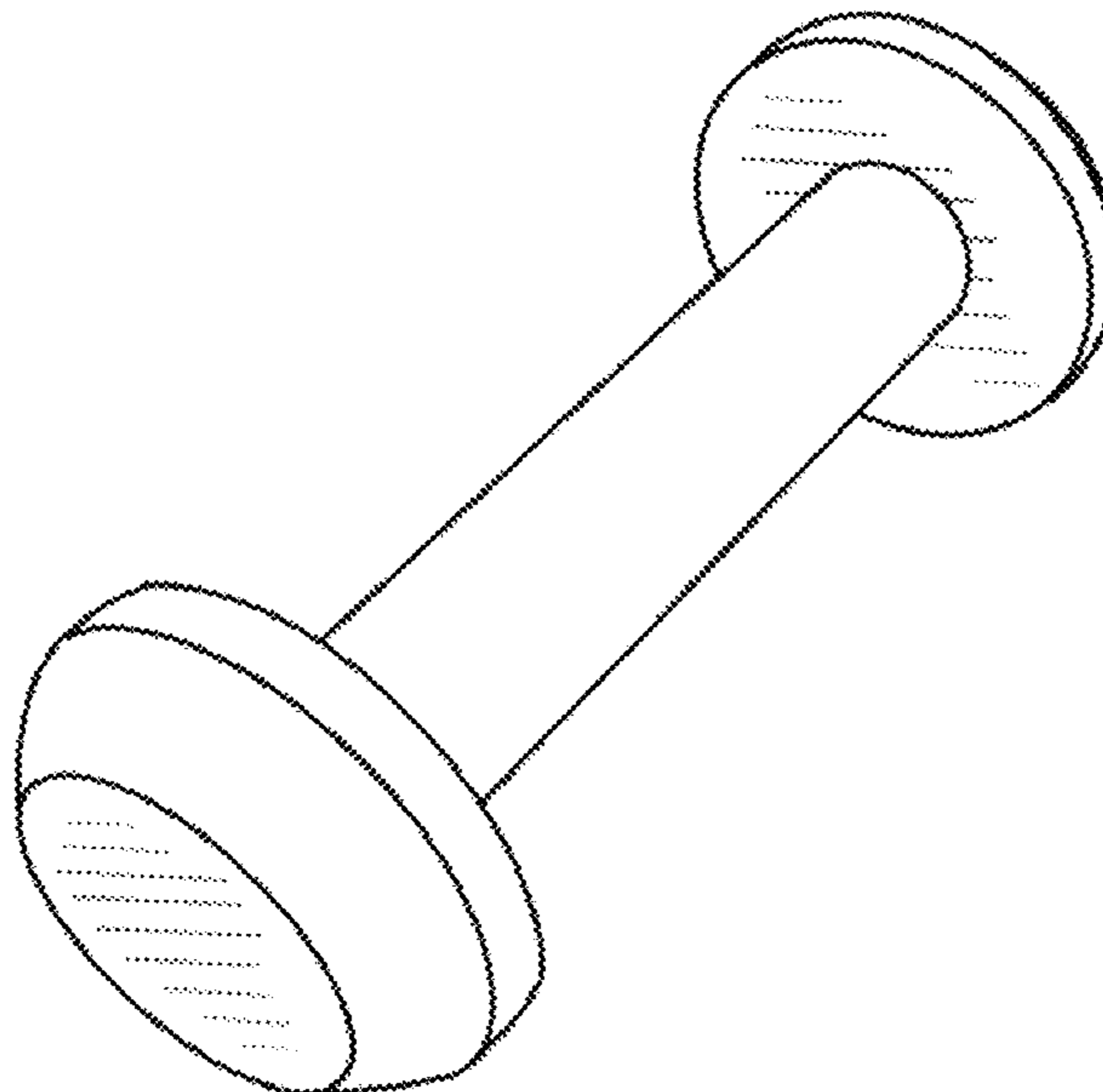
The FIGURE is the attachment band in three-dimensional view, highlighting the flat ends of the device. The attachment band has a flat end on both ends of the device.
