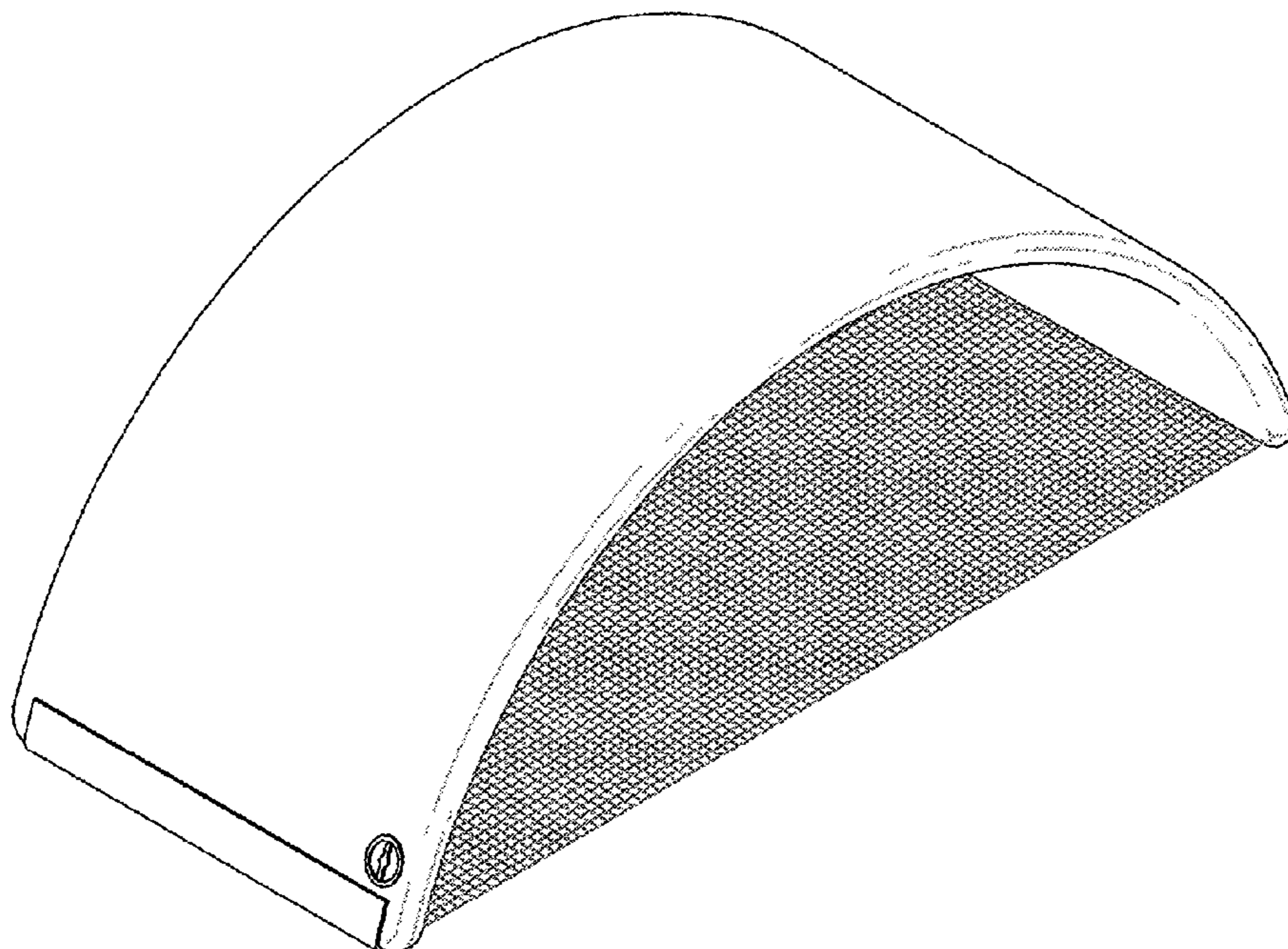
(57) **CLAIM**

I claim the design for an exercise mat combined hammock, as shown and described.

**DESCRIPTION**

FIG. 1 is a perspective view of an exercise mat combined hammock showing my new design;  
FIG. 2 is a front elevational view thereof;  
FIG. 3 is a rear elevational view thereof;  
FIG. 4 is a left side elevational view thereof; a right side elevational view being a mirror image thereof;  
FIG. 5 is a top view thereof; and,

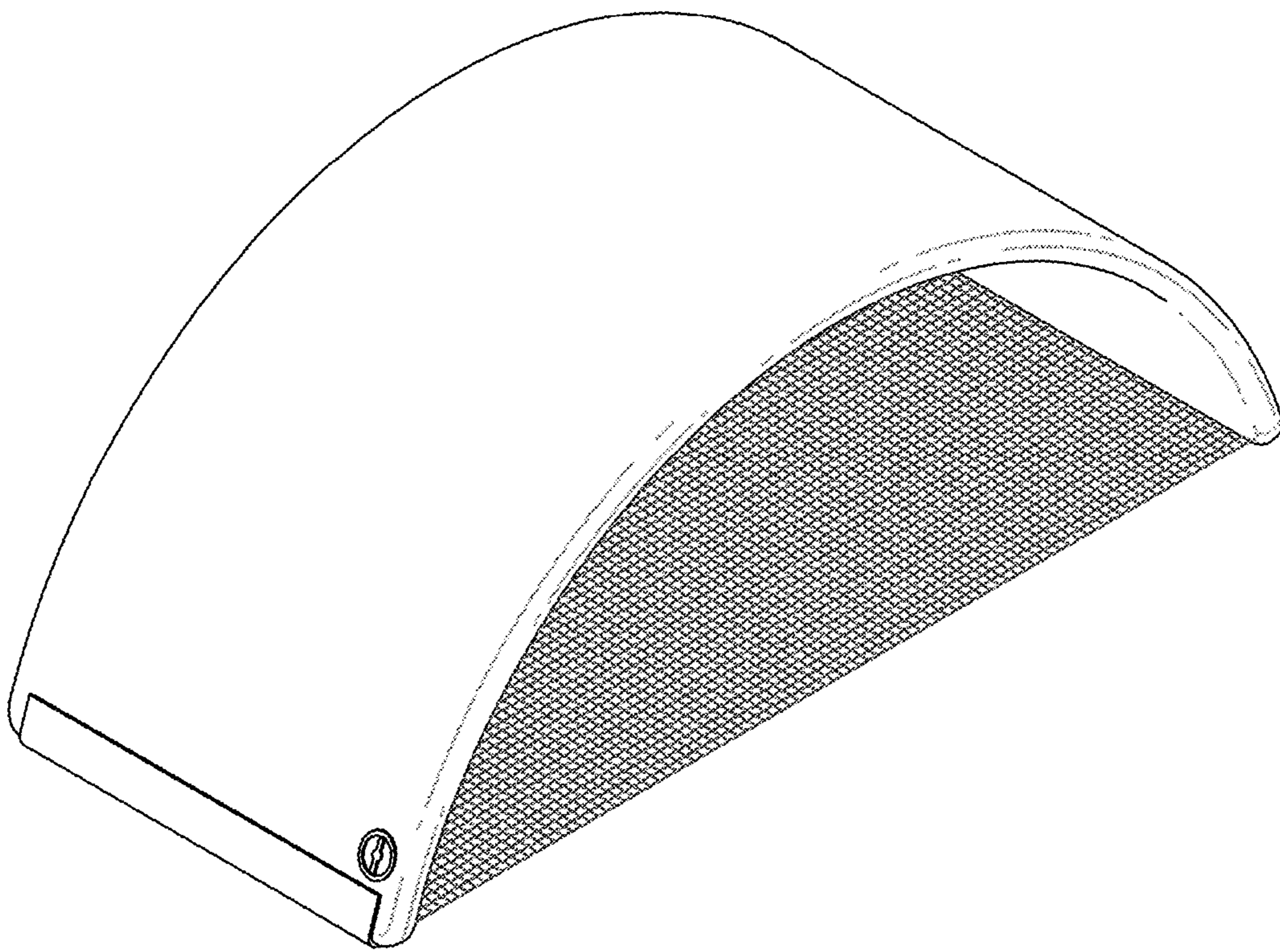

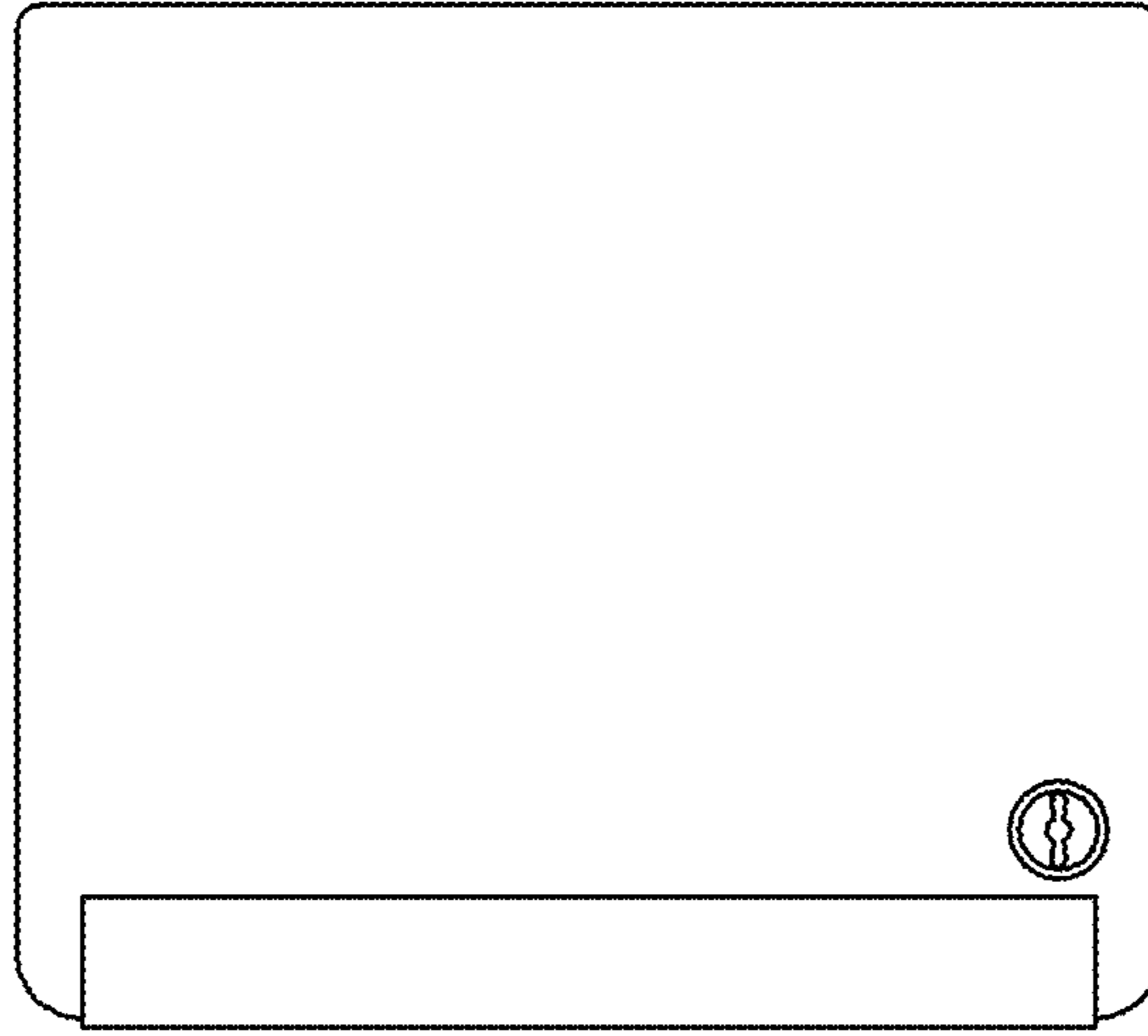

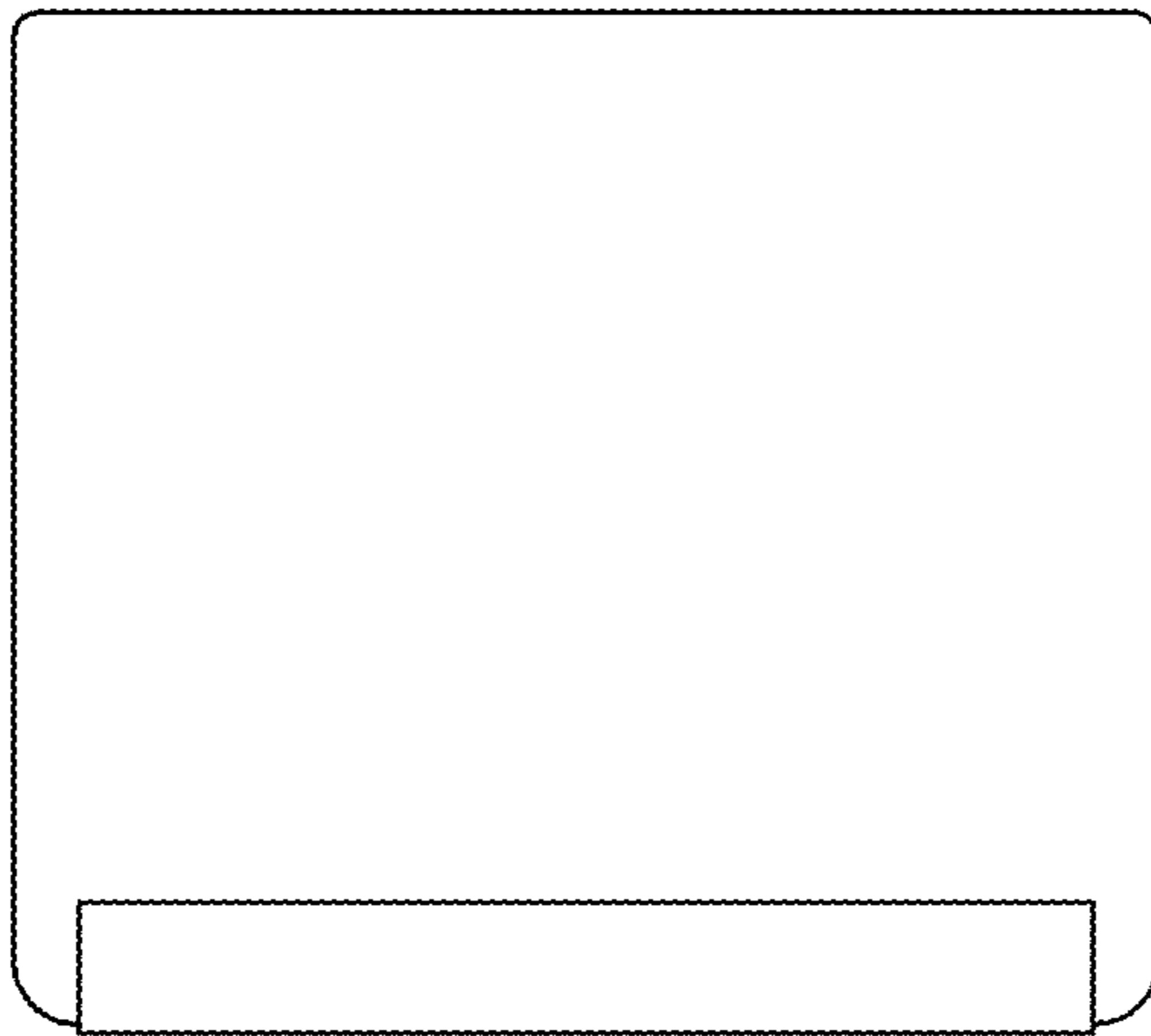

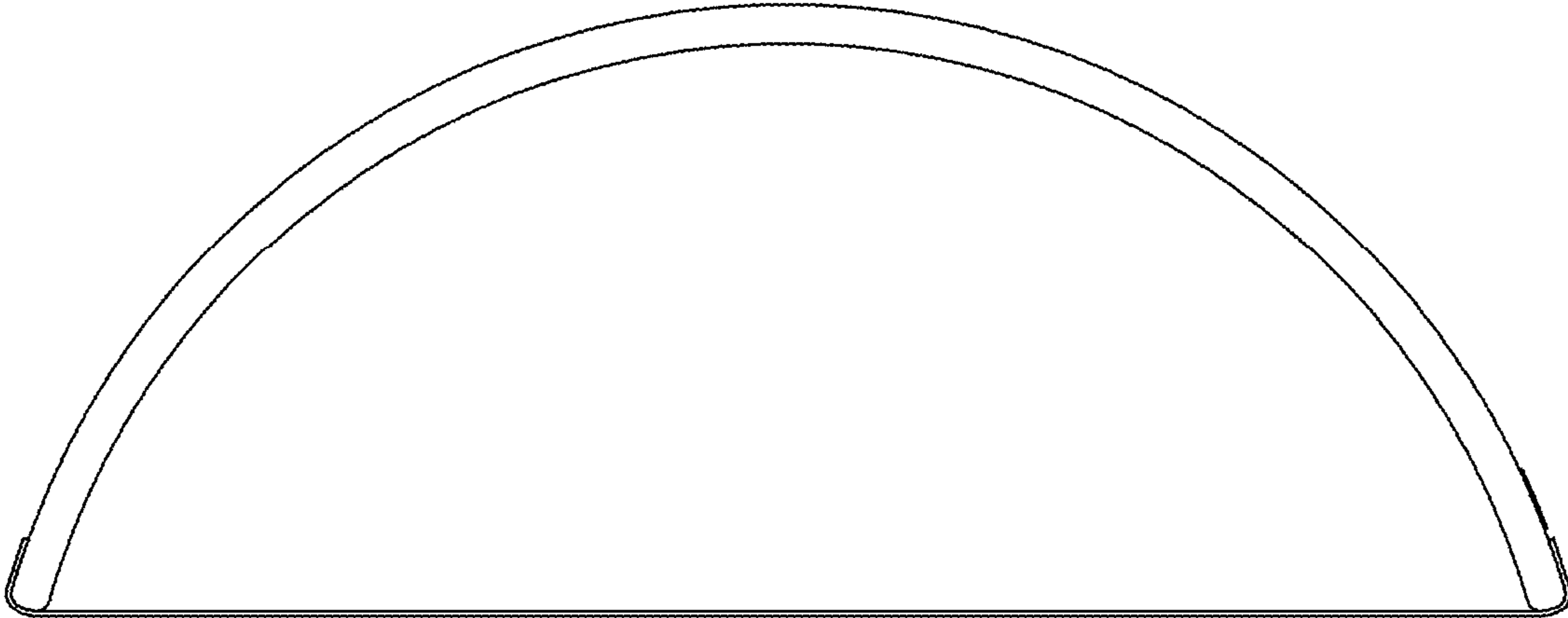

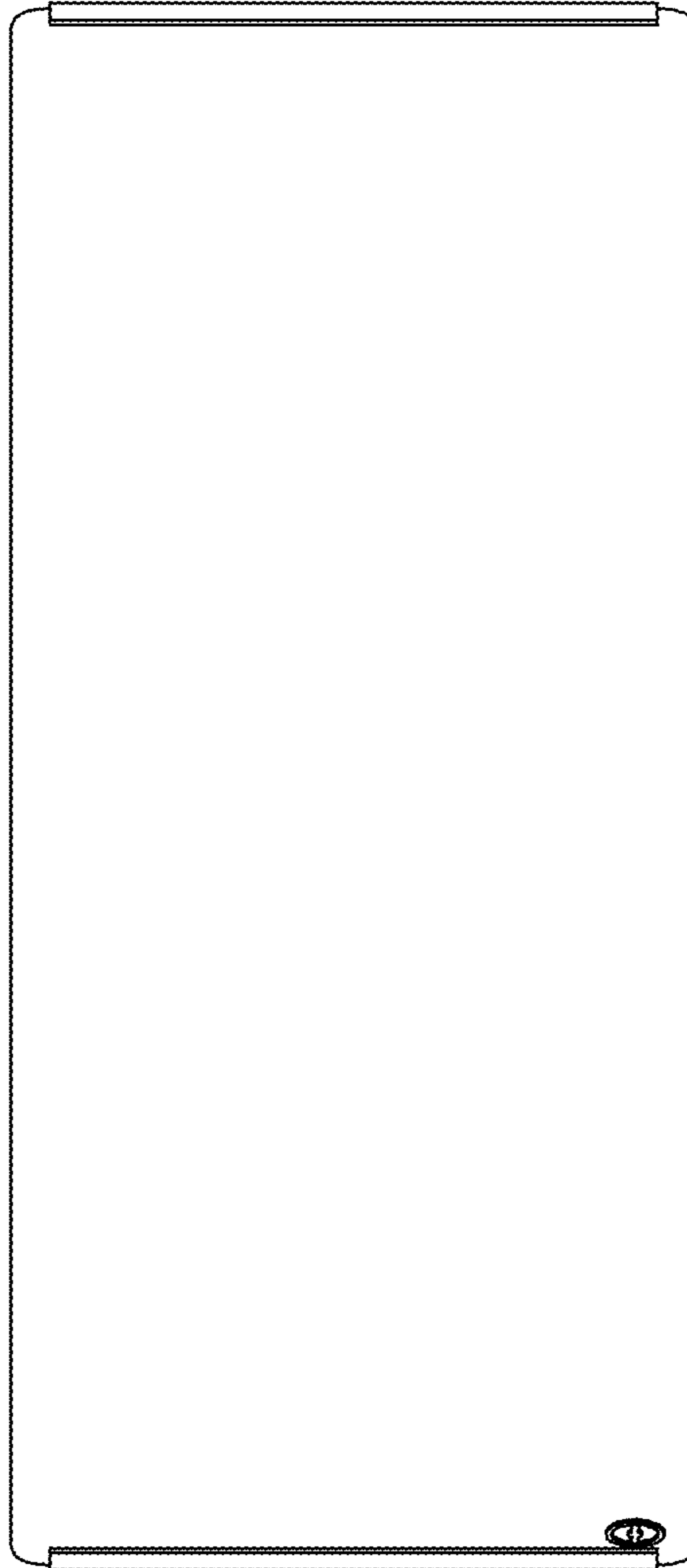

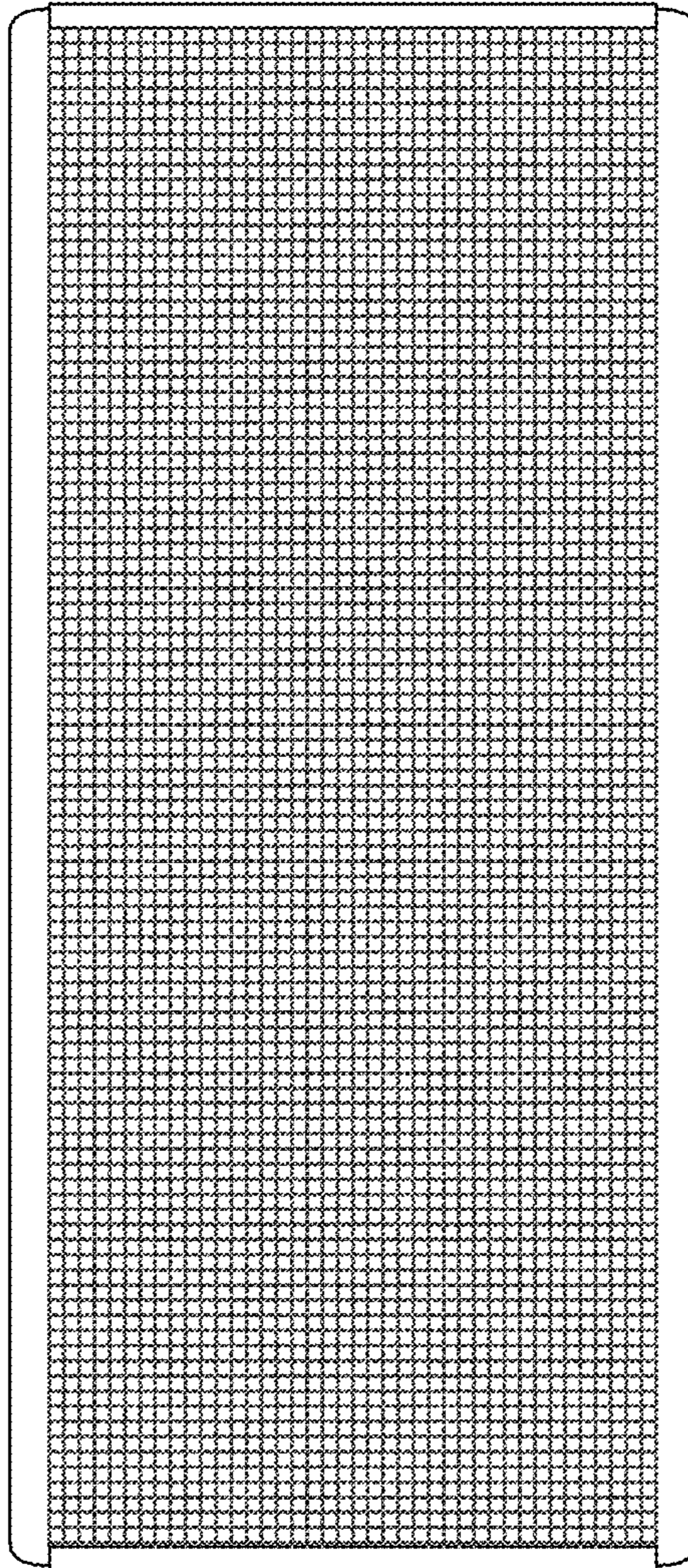
