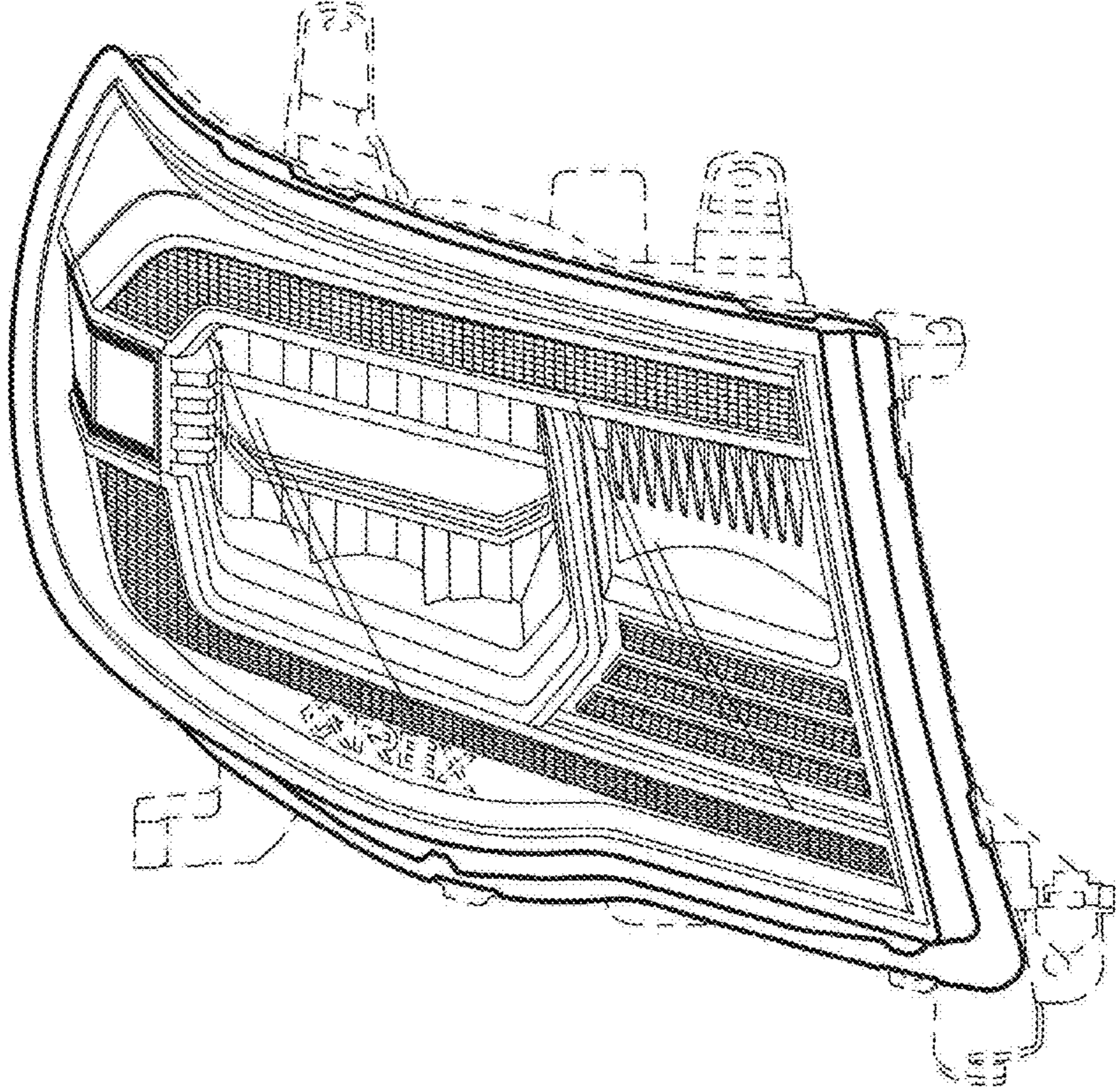

The ornamental design of a headlight for a vehicle, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a headlight for a vehicle according to the novel design;
FIG. 2 is left side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a right side view thereof;
FIG. 5 is a back side view thereof;
FIG. 6 is an alternative perspective view thereof; and,
FIG. 7 is a top view thereof.

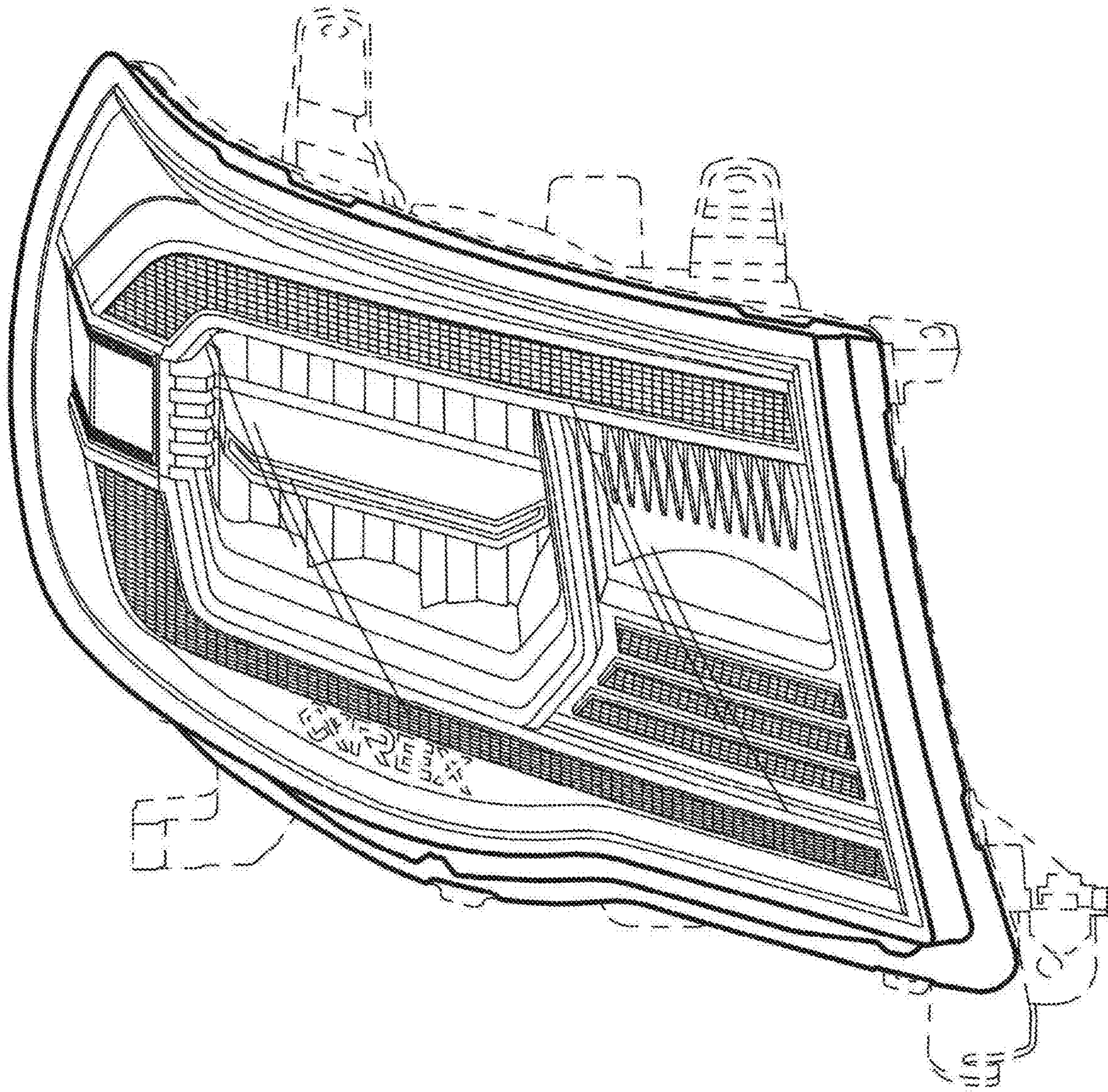

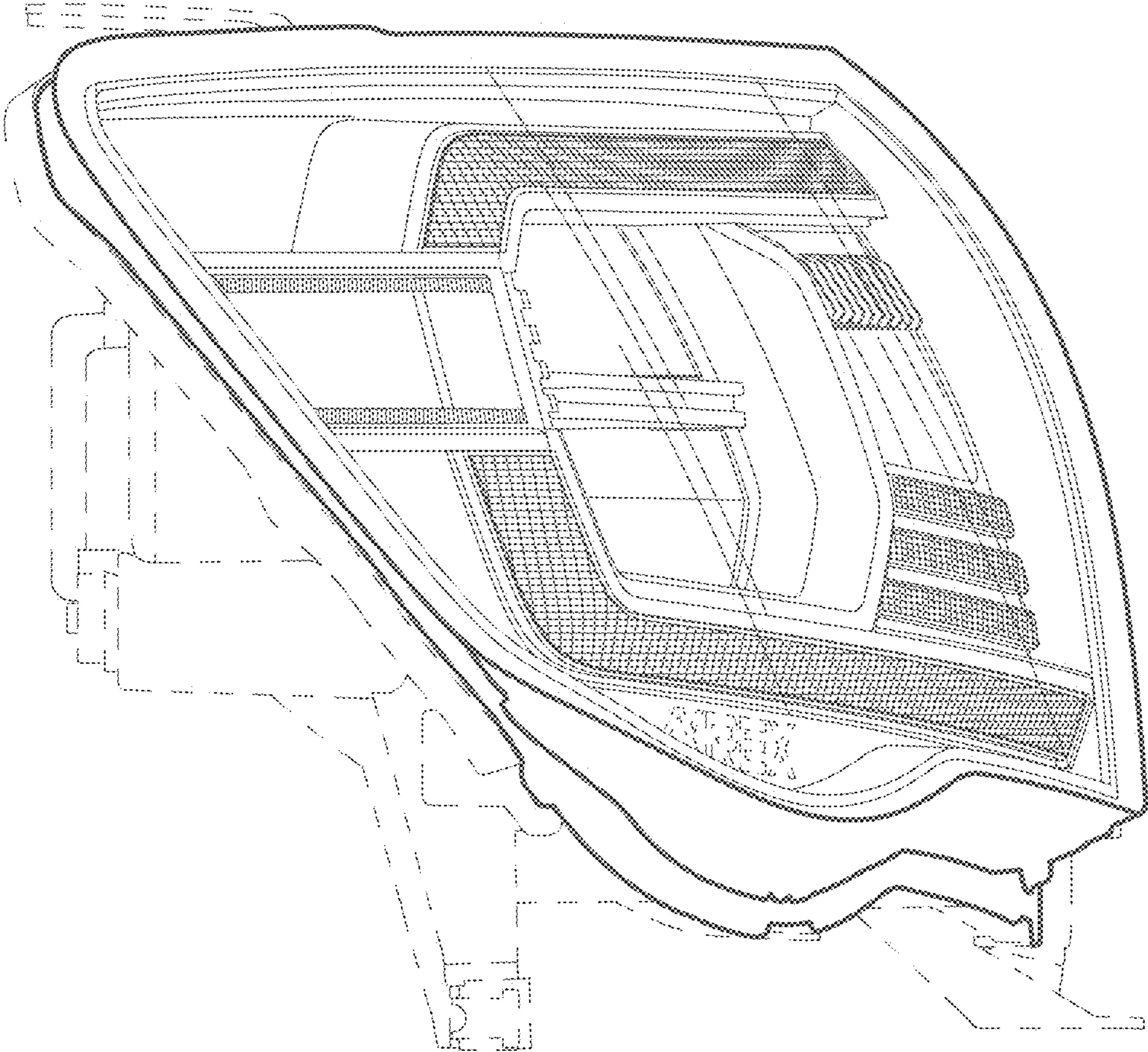

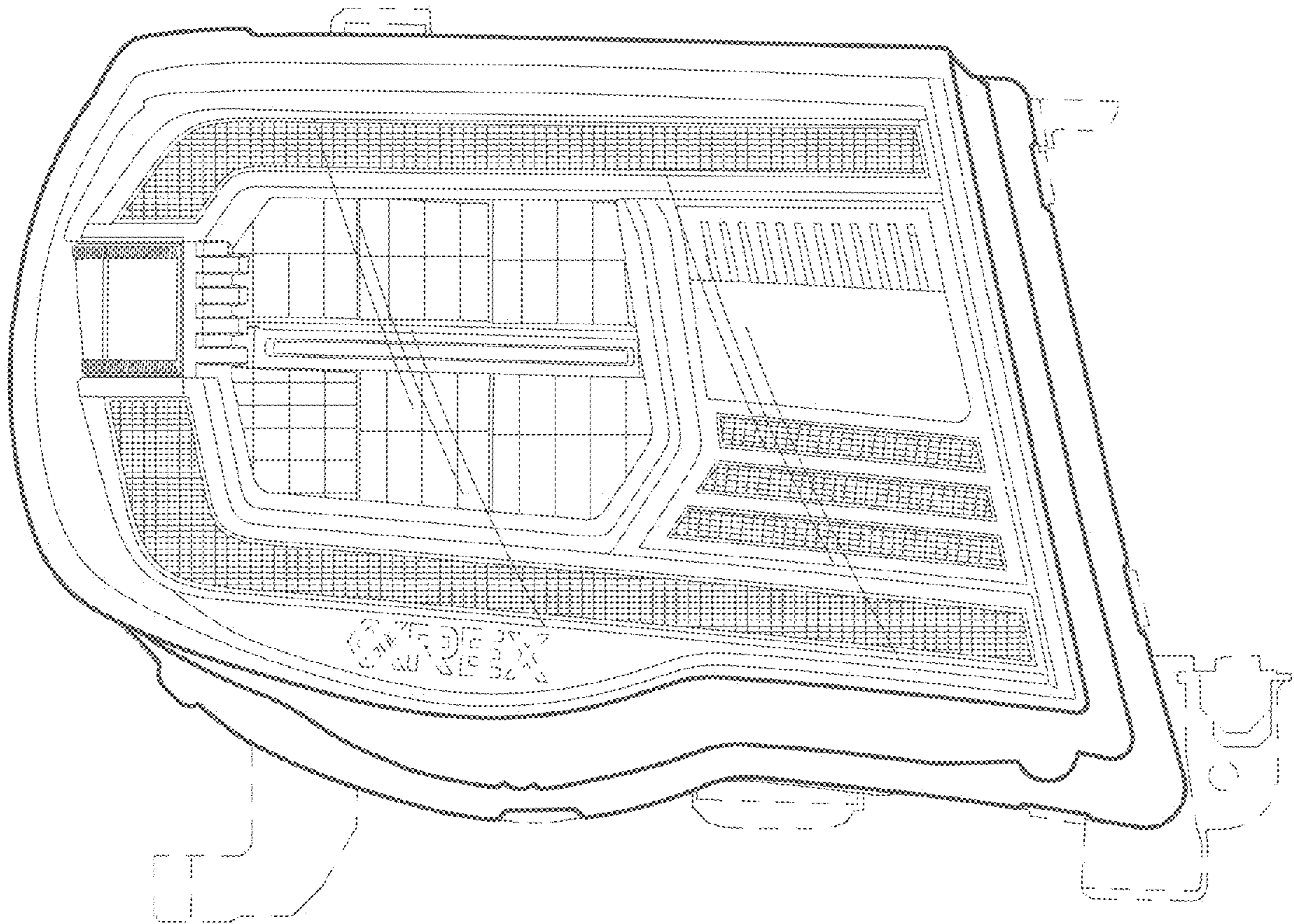

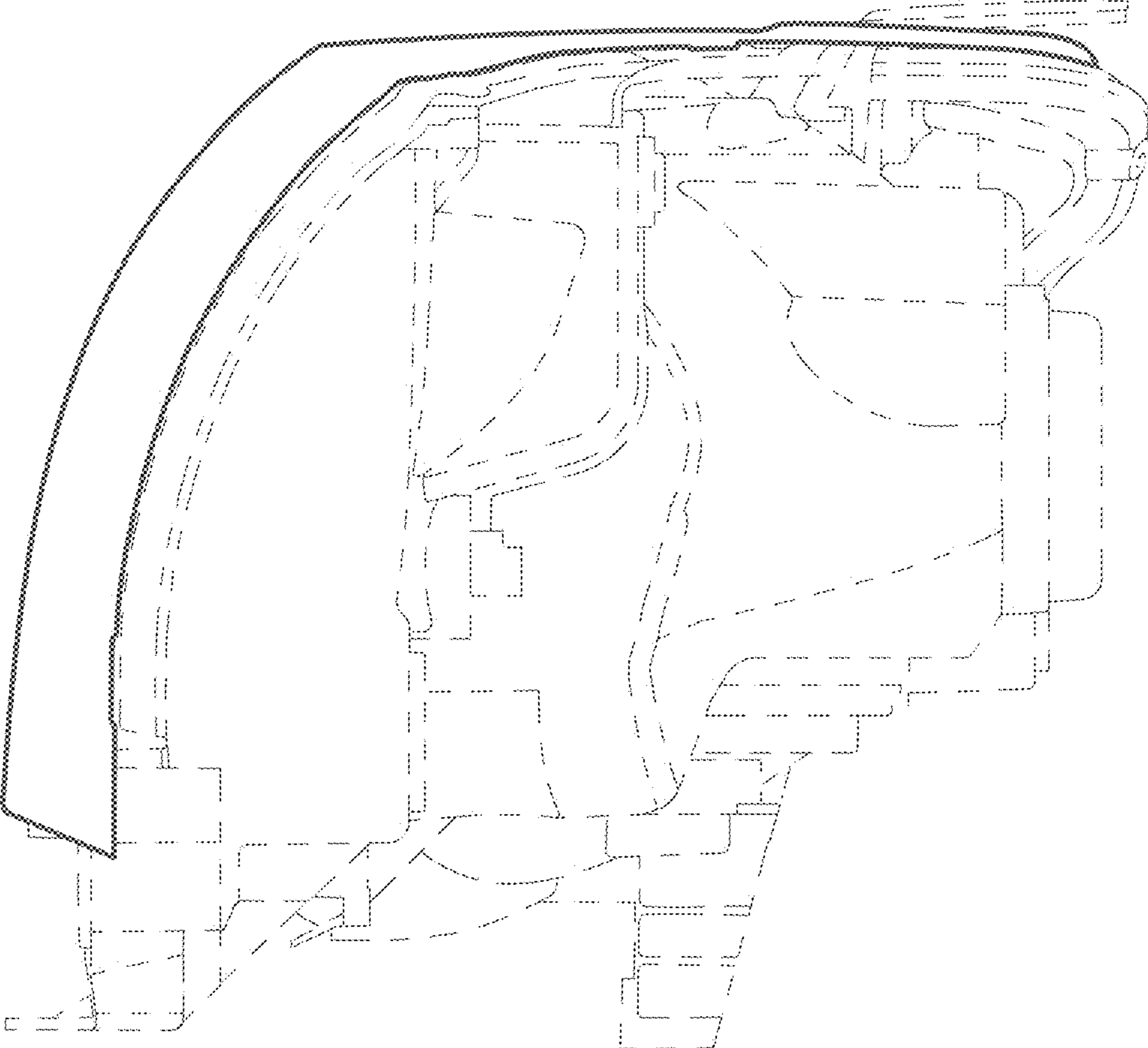

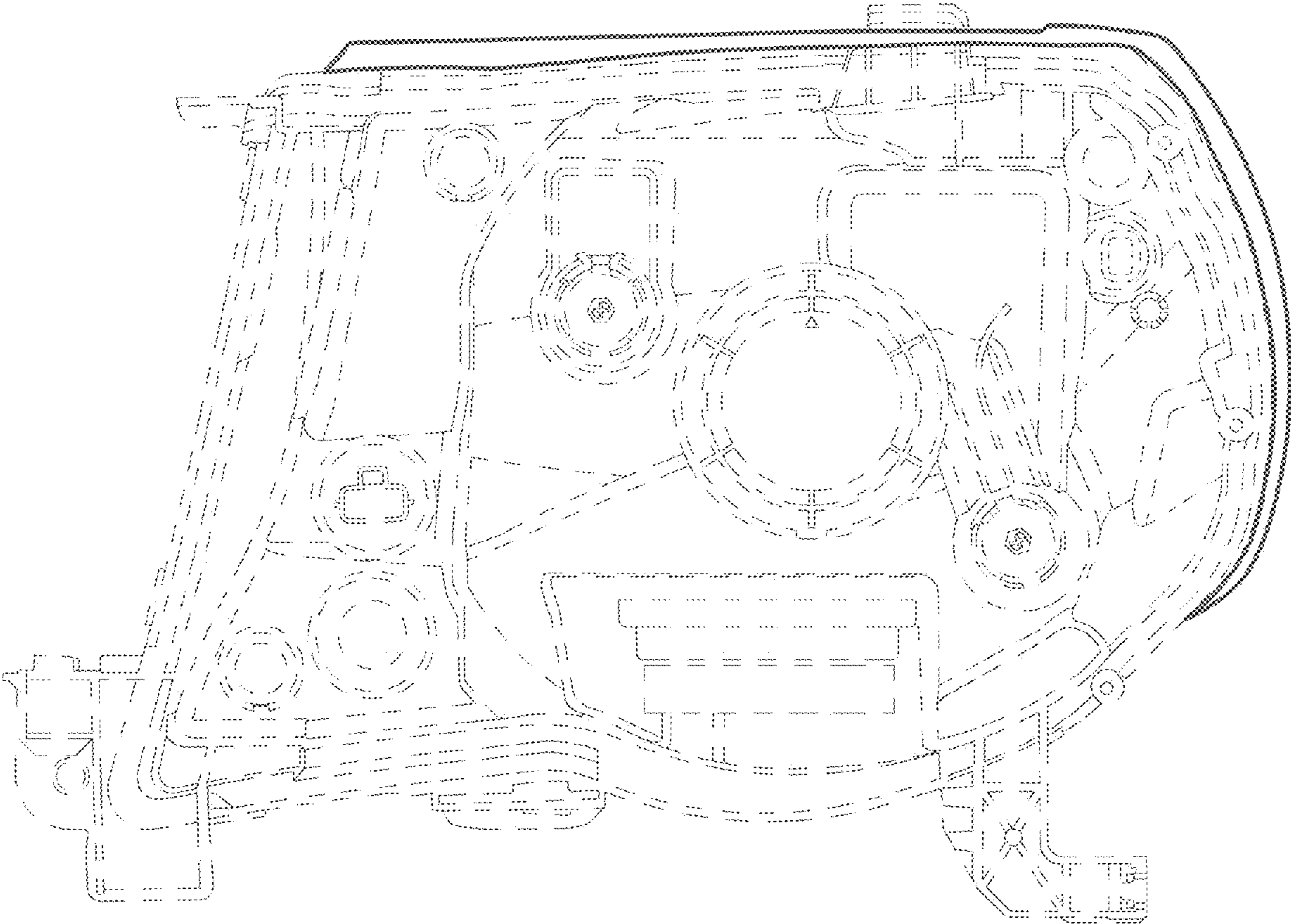

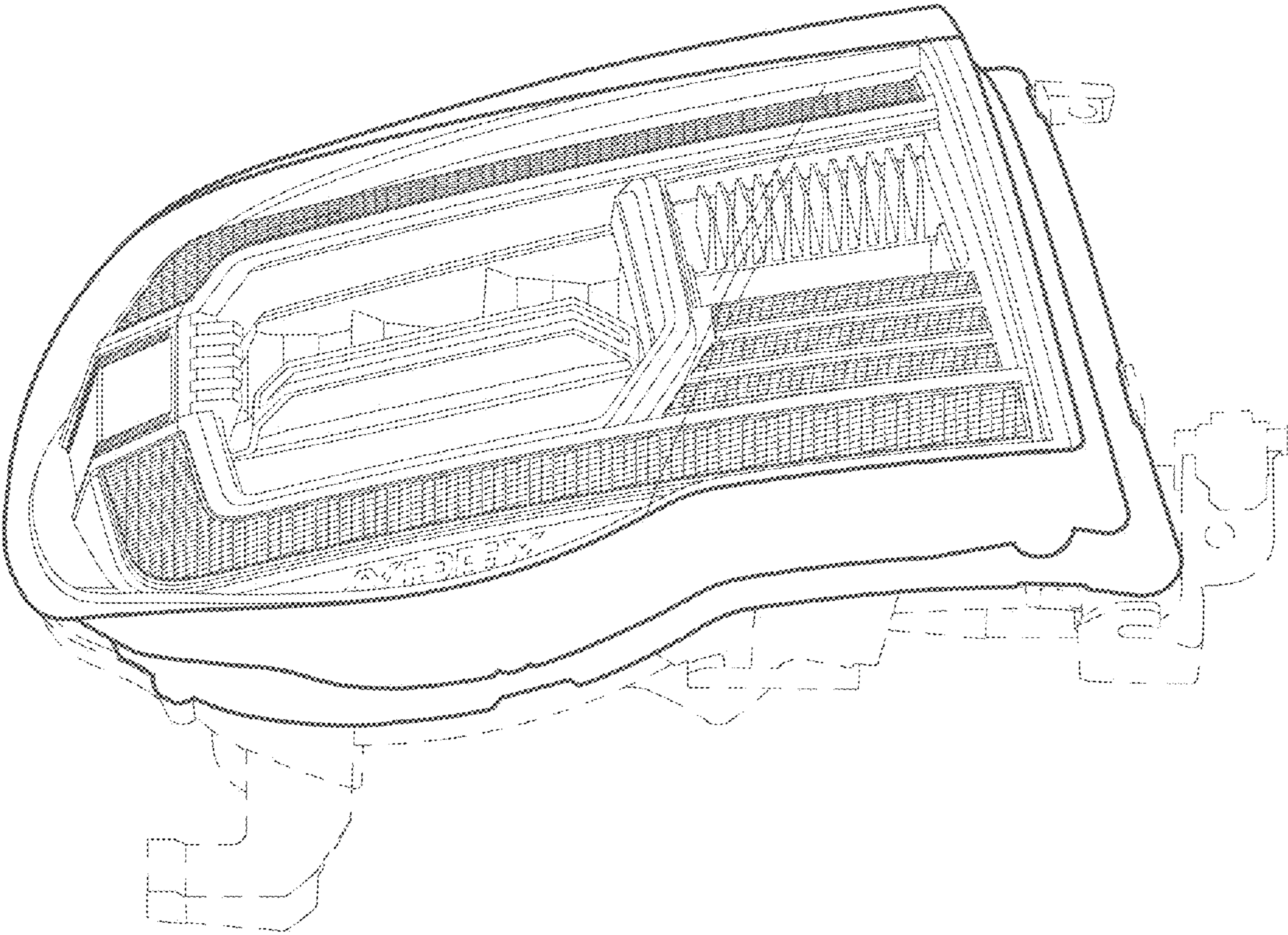

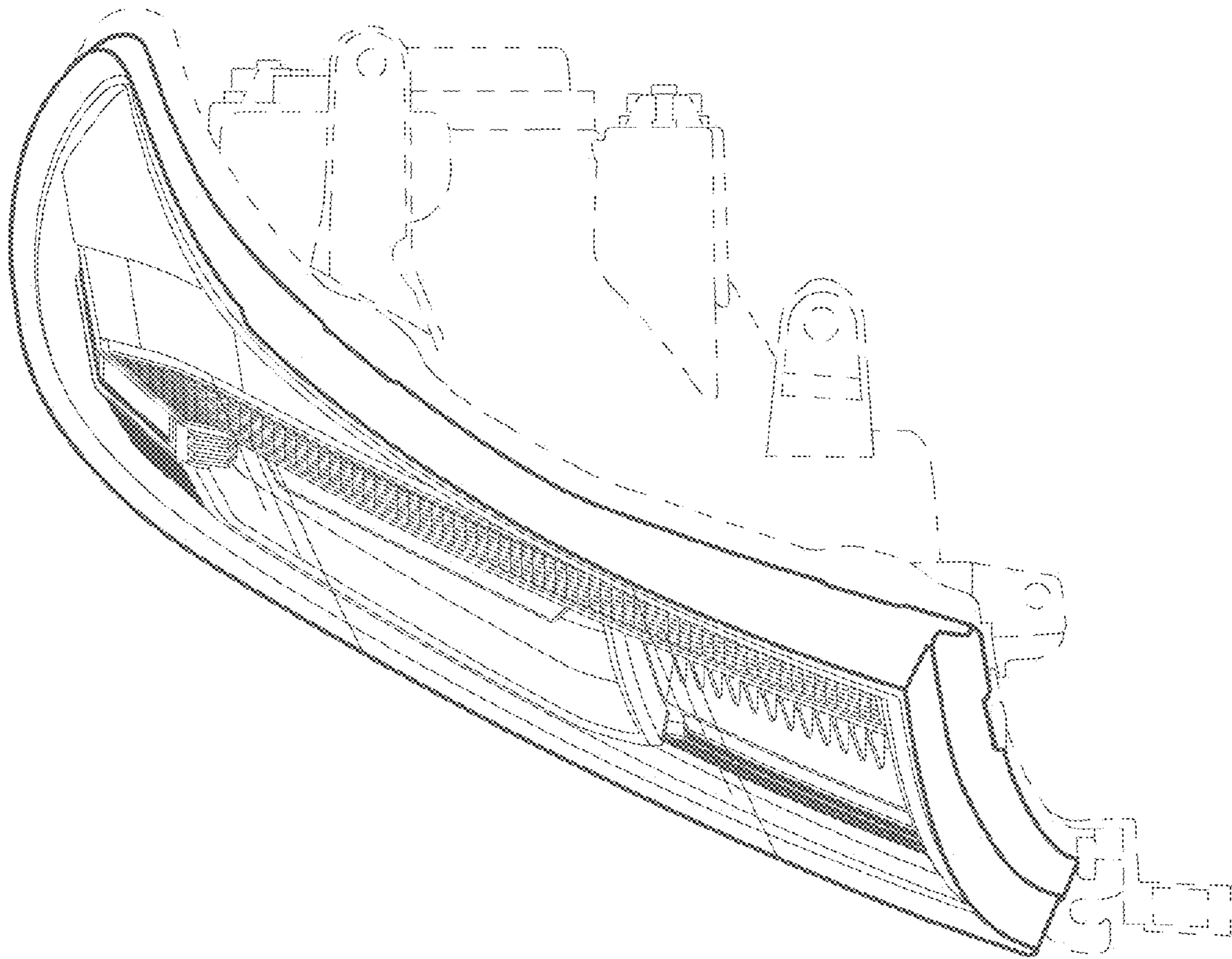
