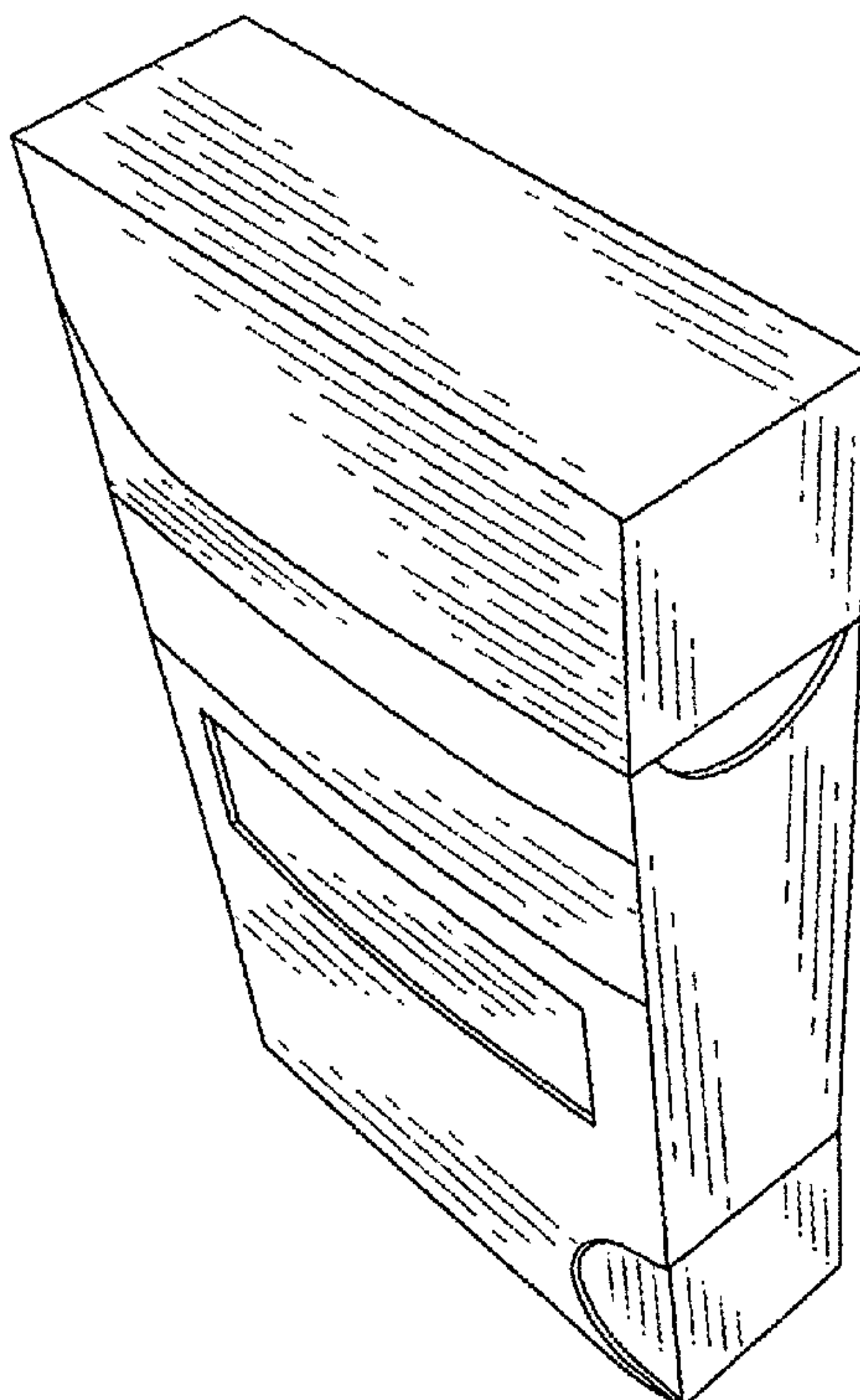
(57) **CLAIM**

The ornamental design for a cannabis joint pack, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a cannabis joint pack showing my new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof;
FIG. 5 is a right side elevational view thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view thereof, shown the bottom case is pulled out; and,
FIG. 9 is a perspective view thereof, shown the state of the bottom case is pulled out again and the cover is open.
The broken lines in the drawings depict portions of the cannabis joint pack that form no part of the claimed design.

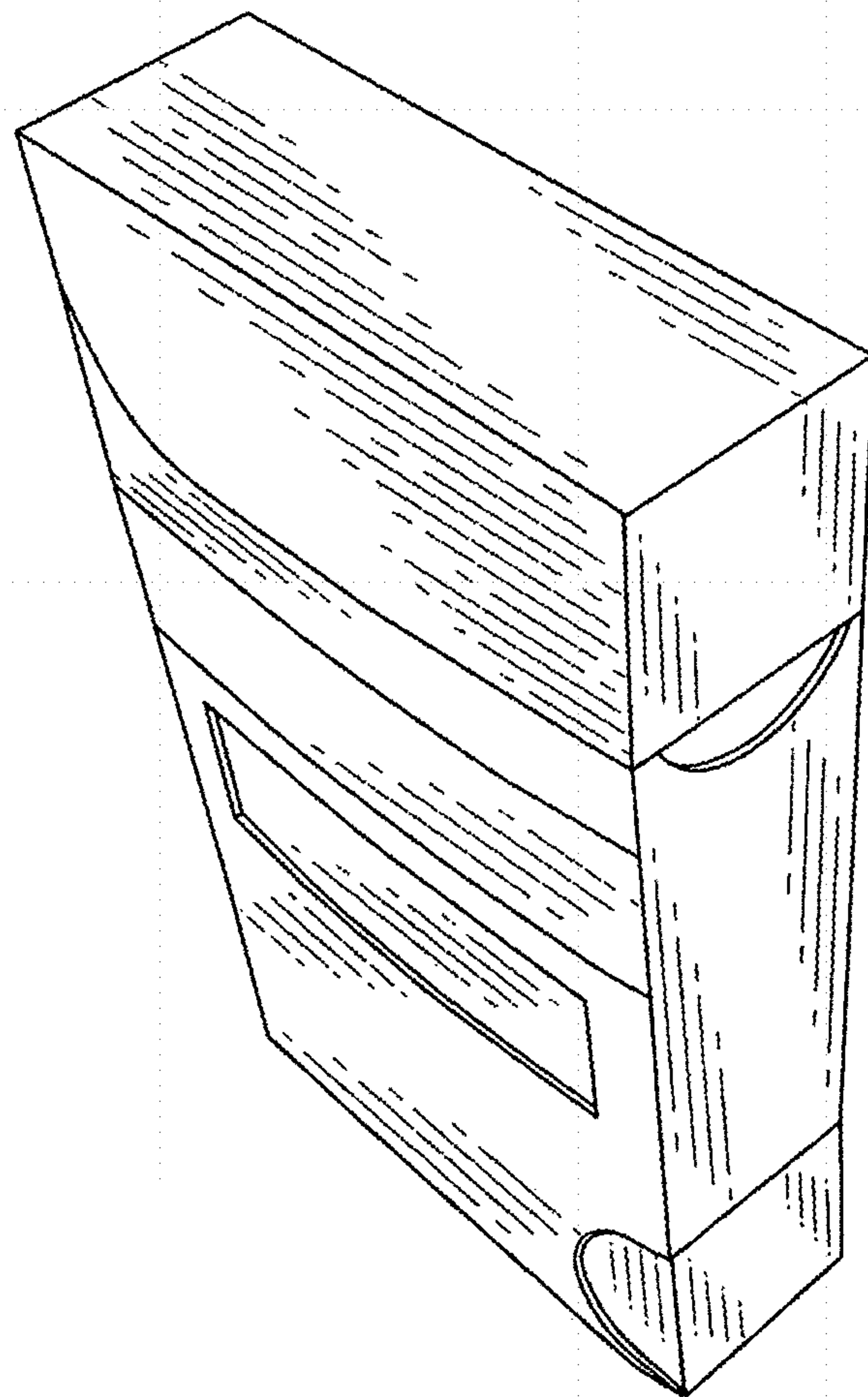

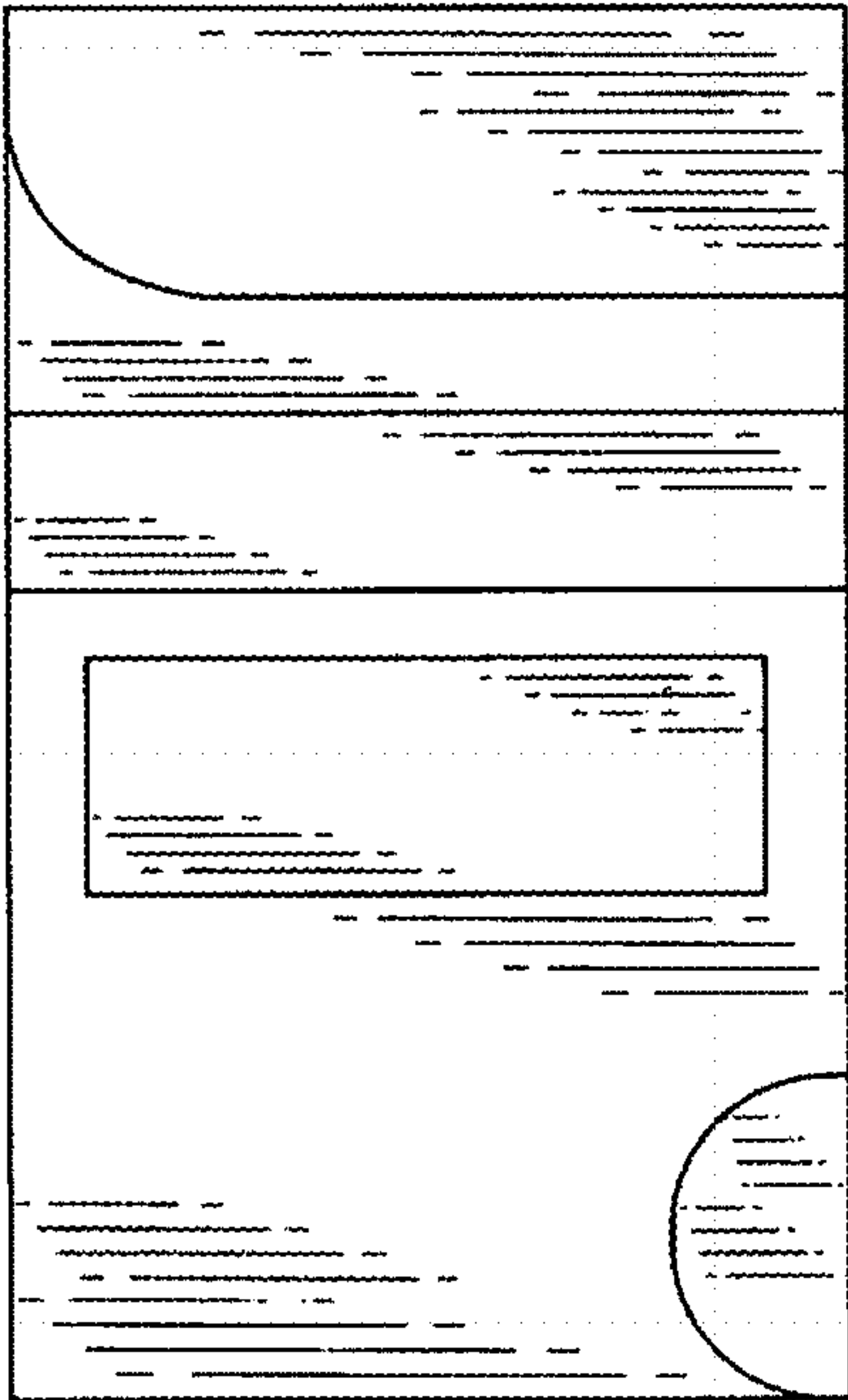

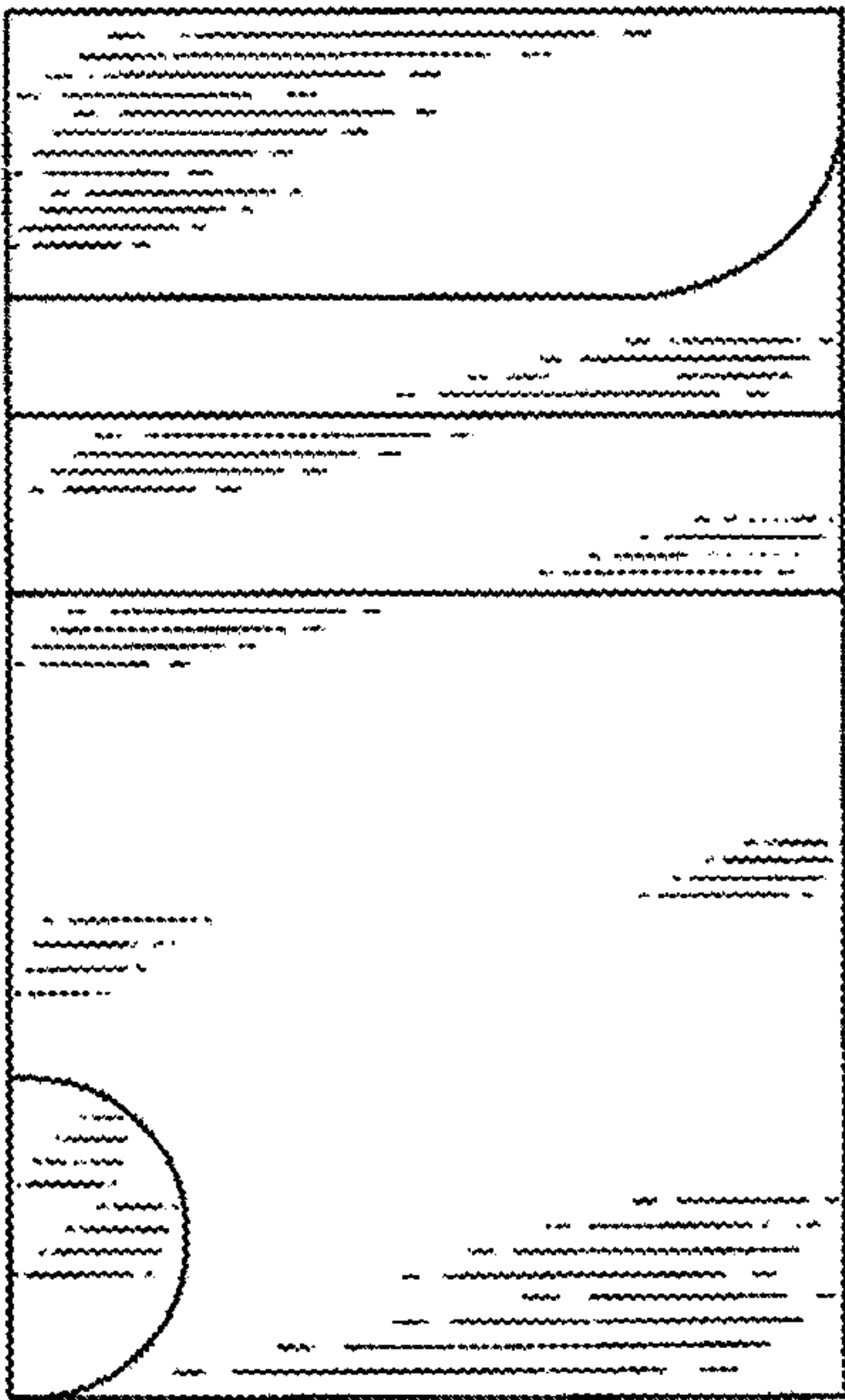

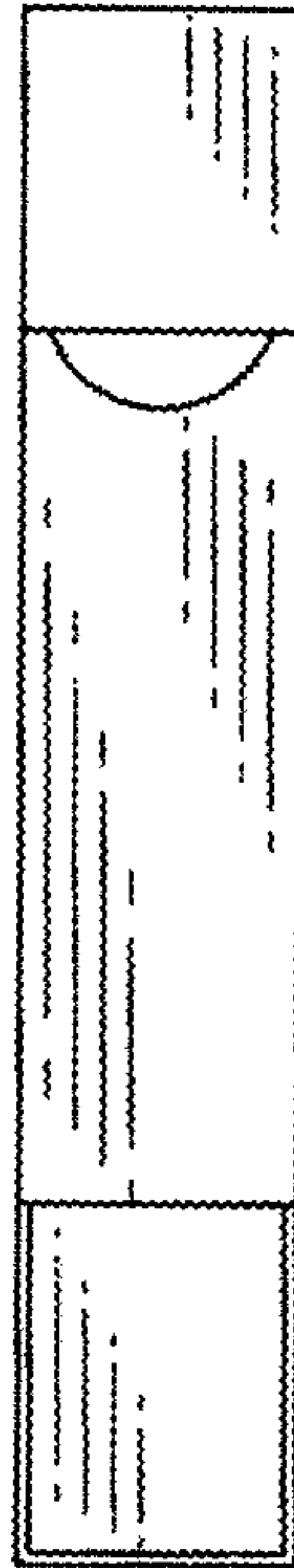

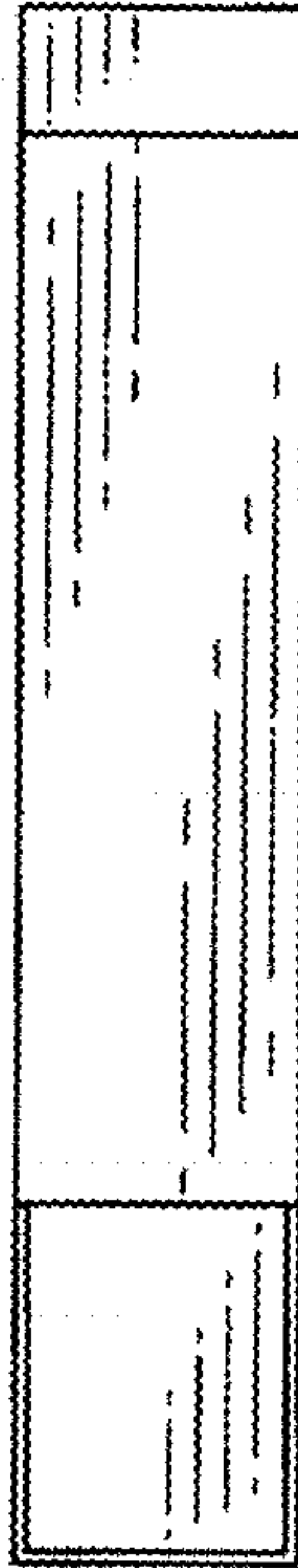

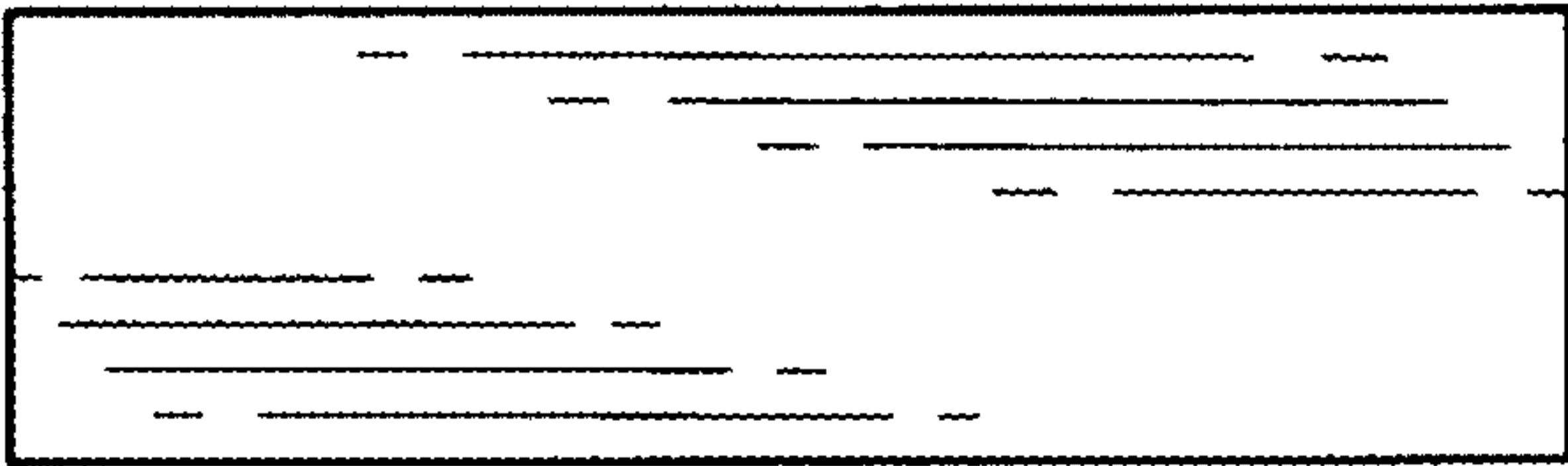

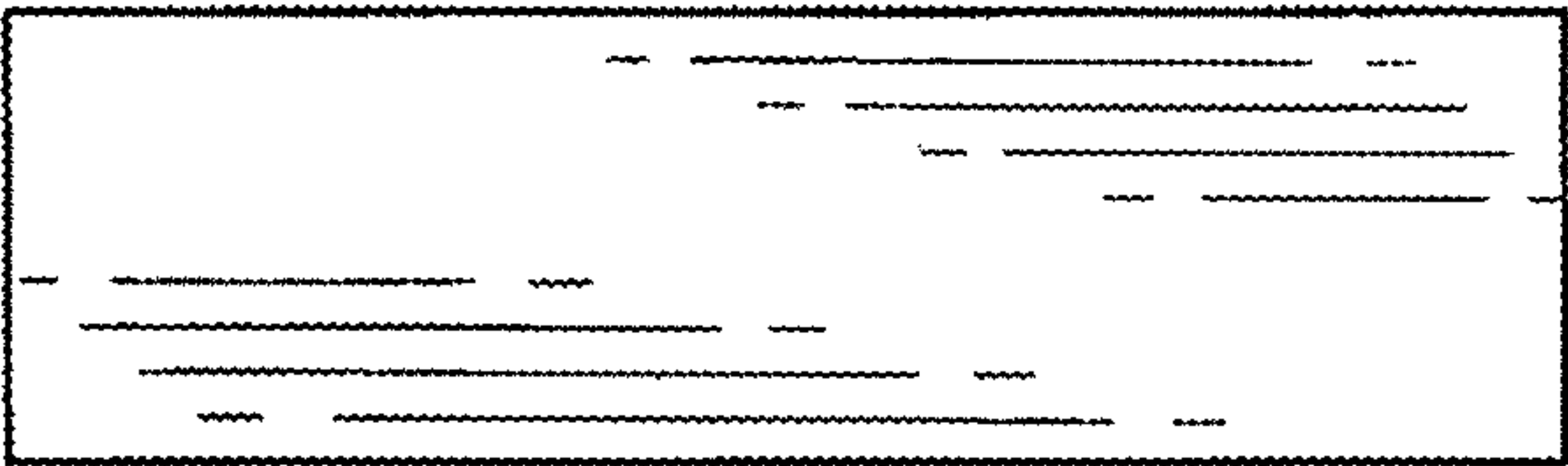

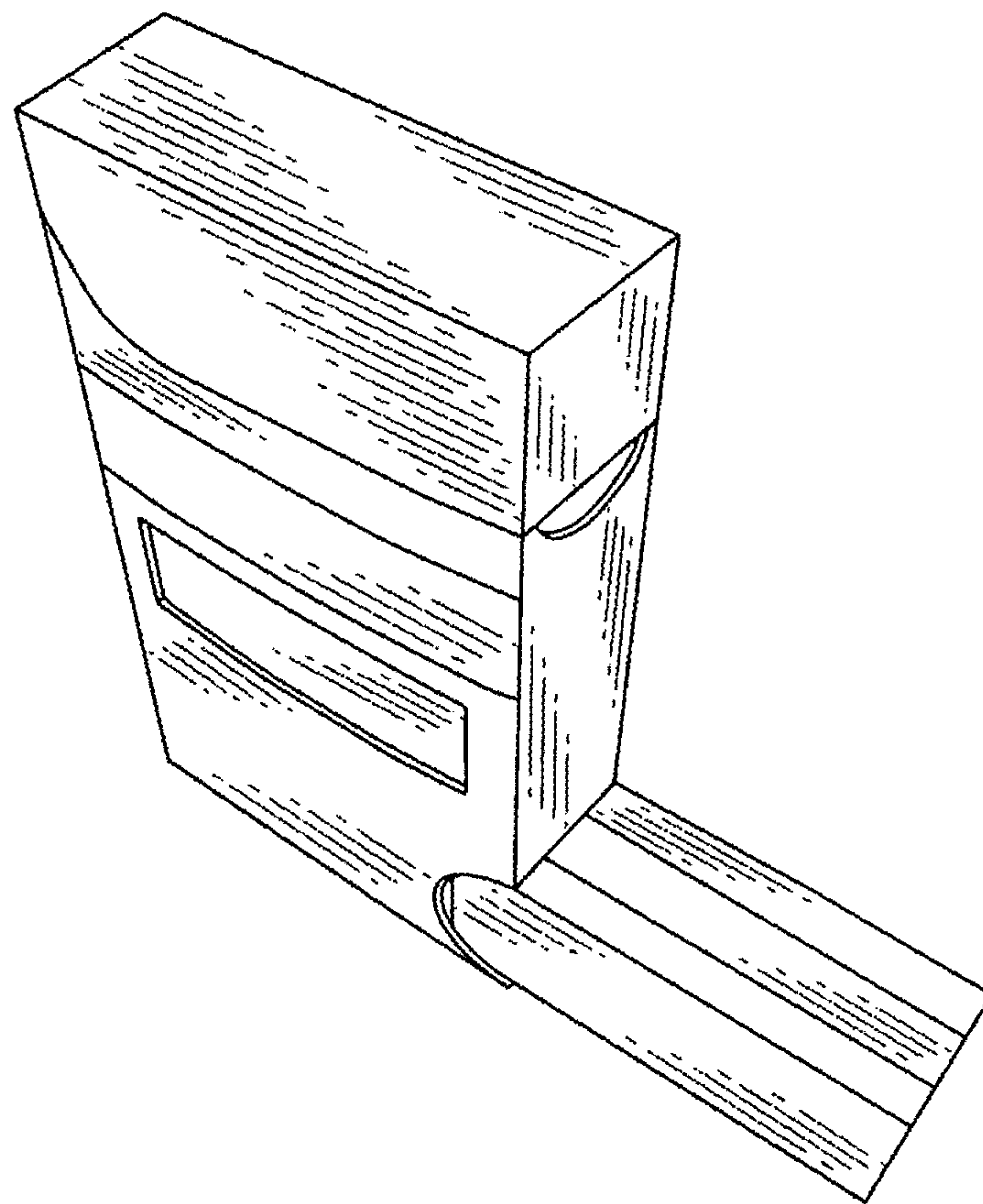

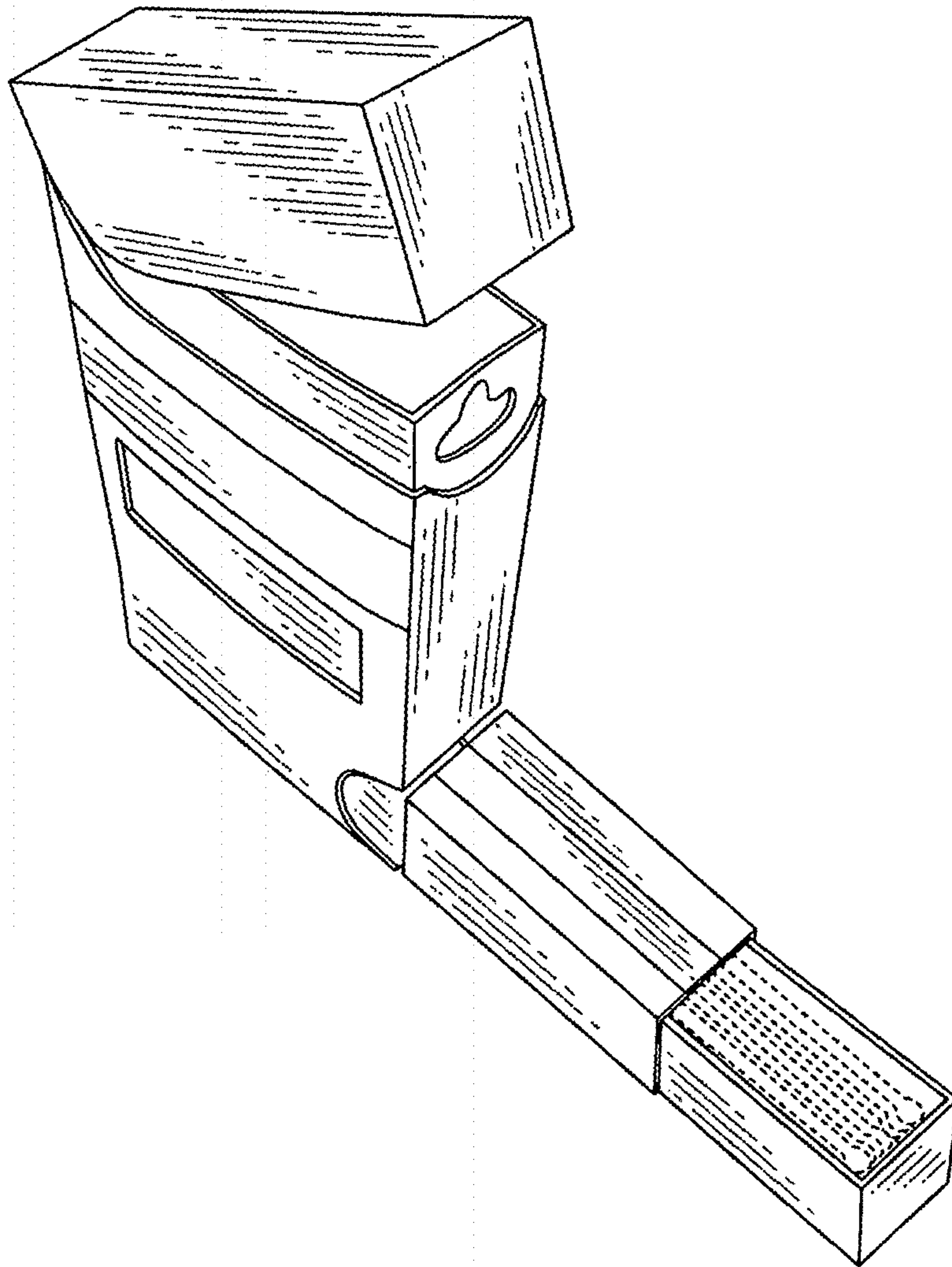
