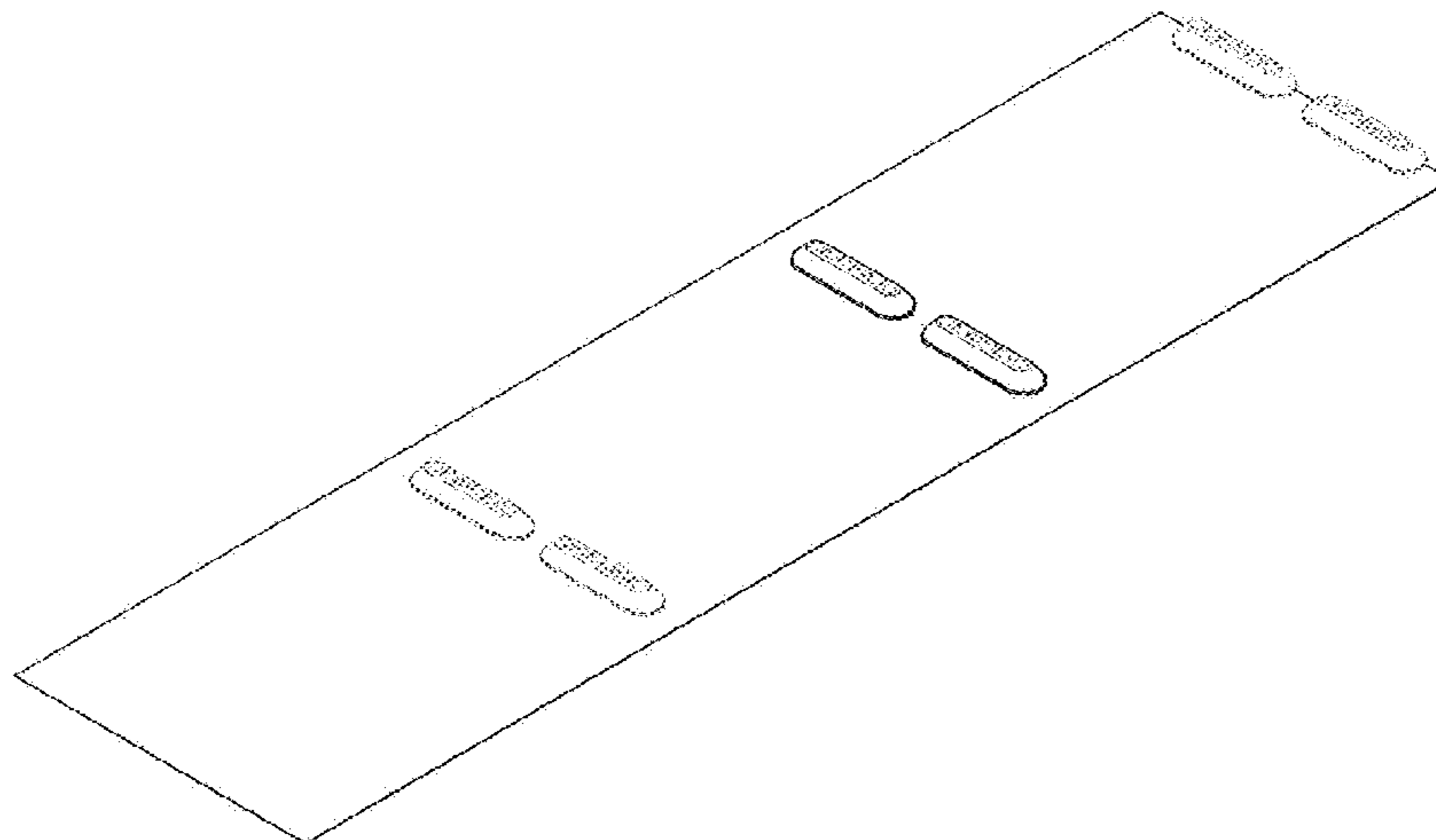
The ornamental design for a set of washing machine drum lifters, as shown and described.

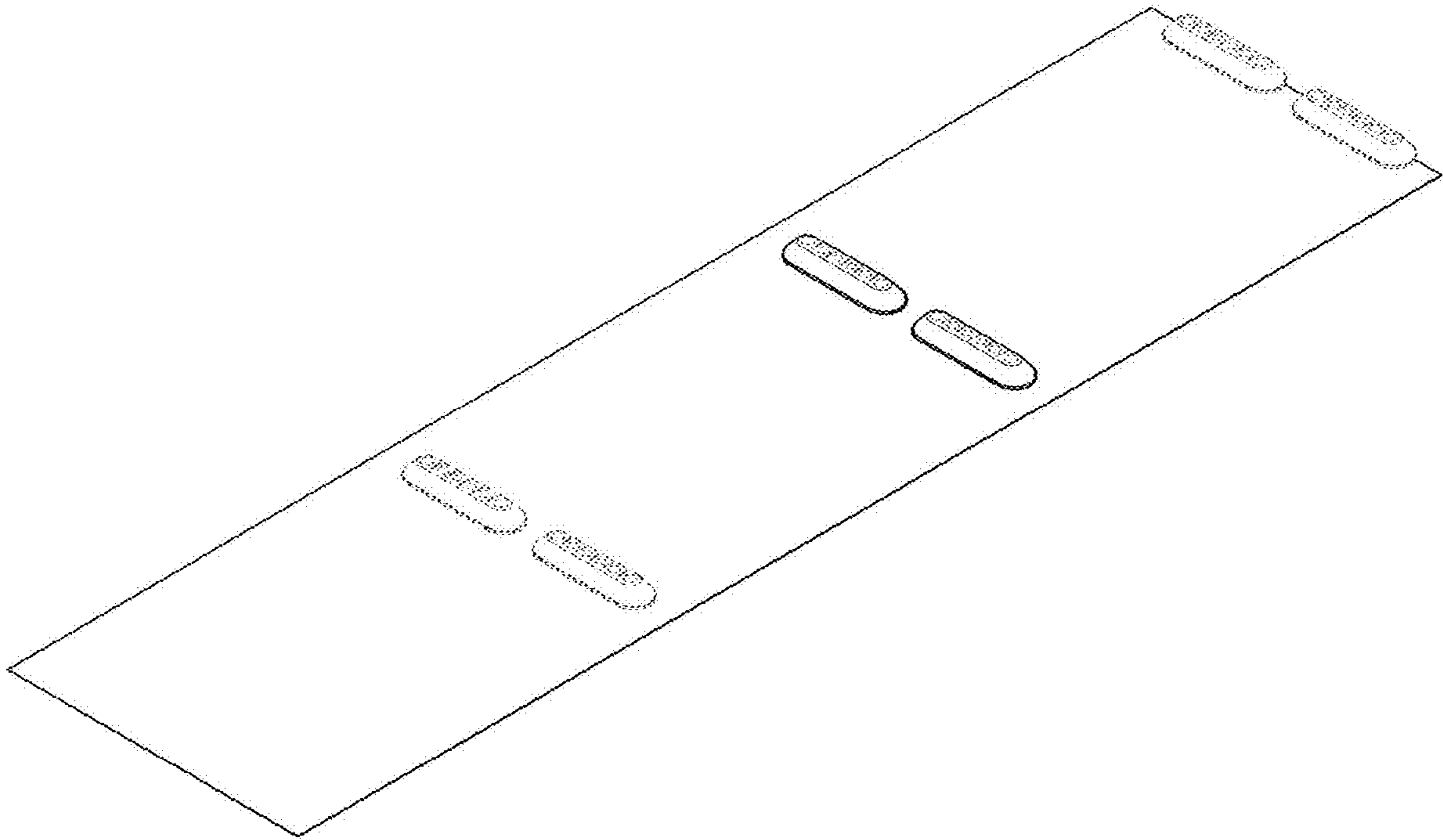

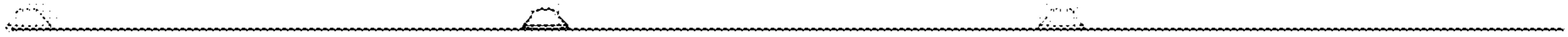

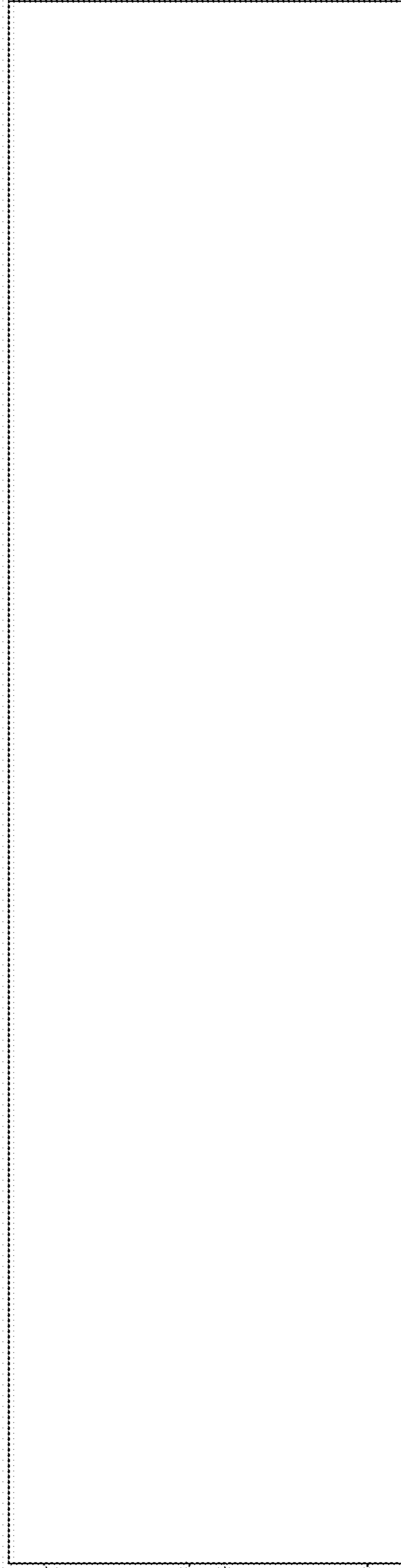
