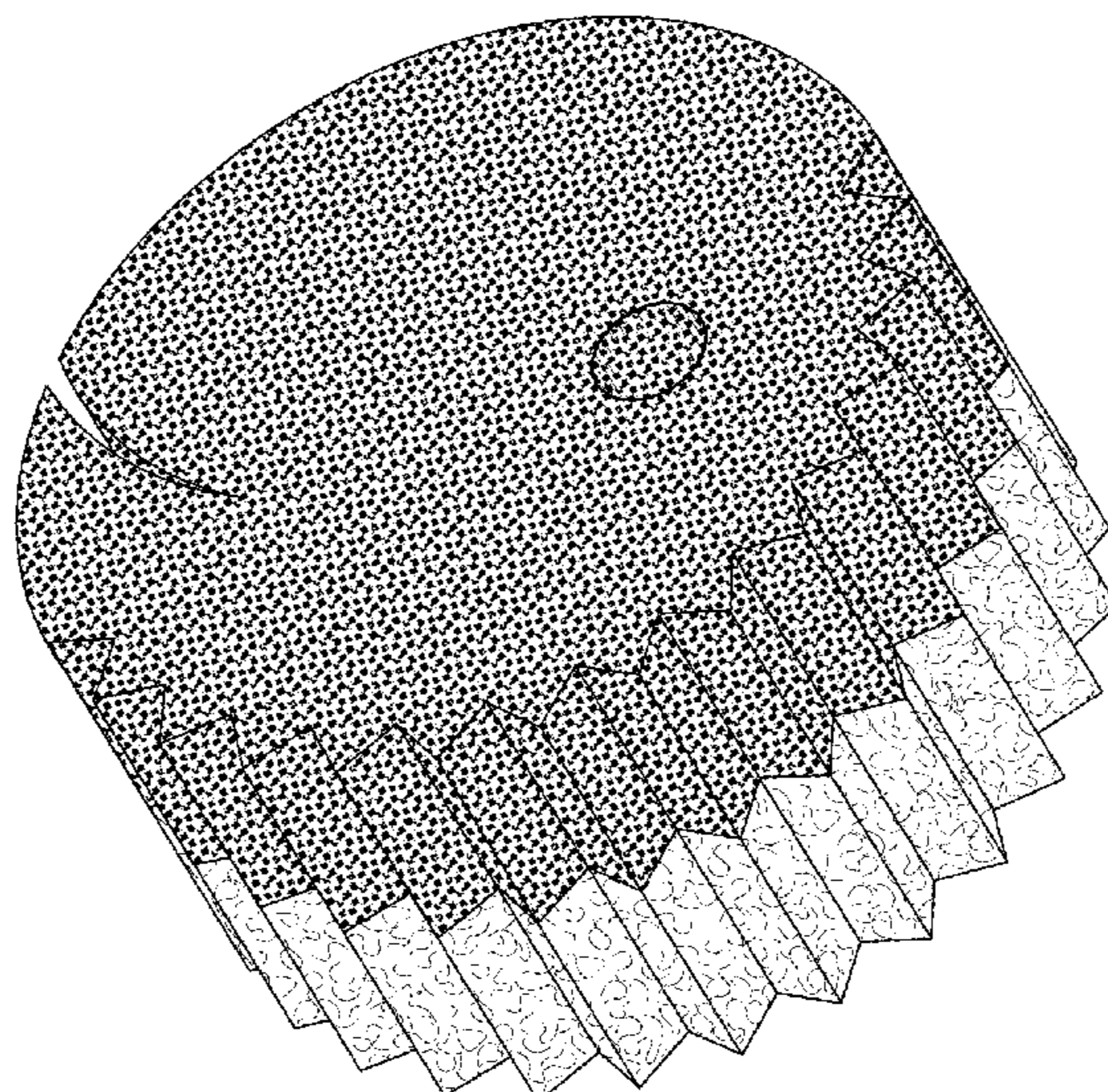
FIG. 1 depicts a top, front perspective view showing a first

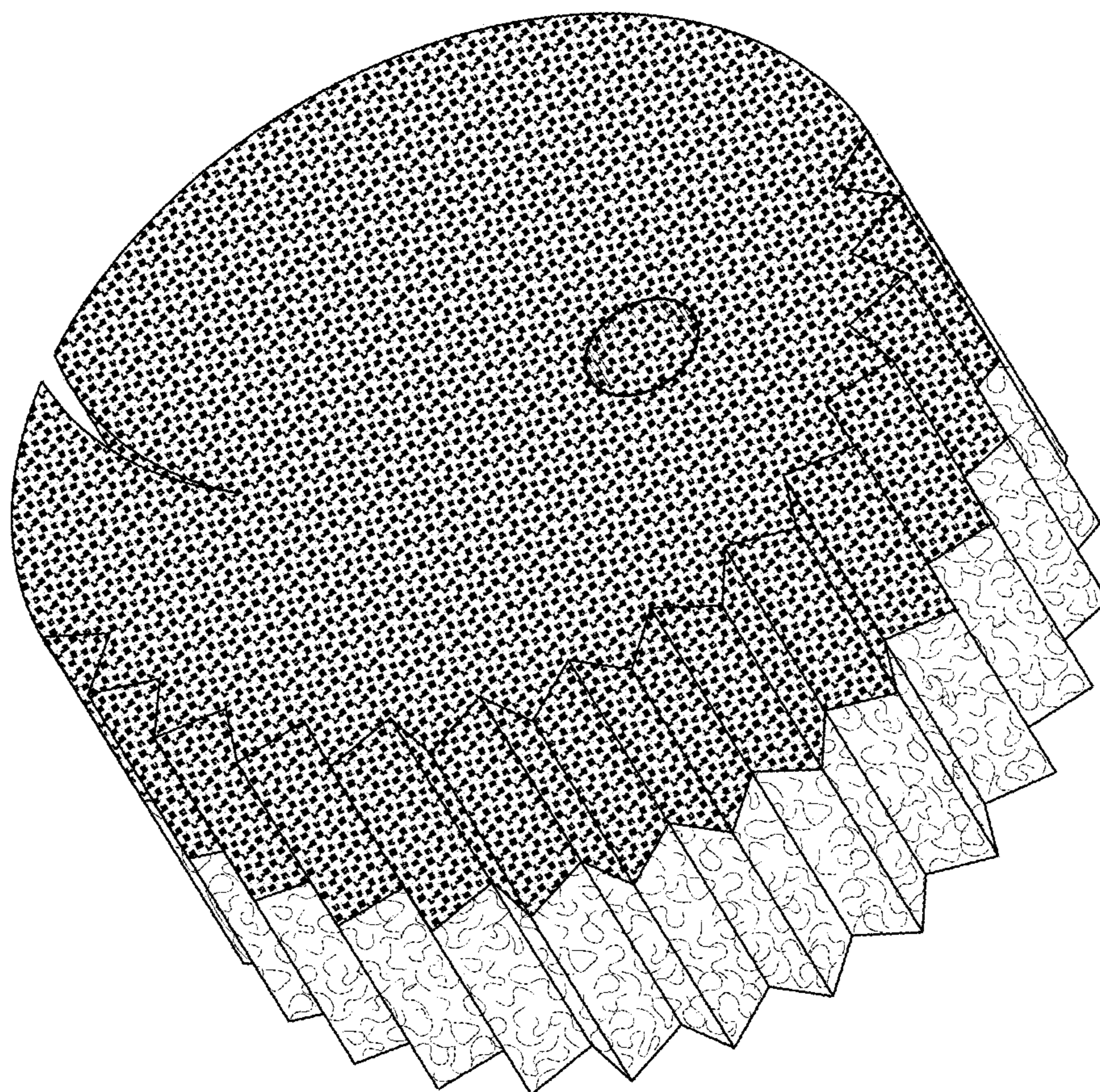

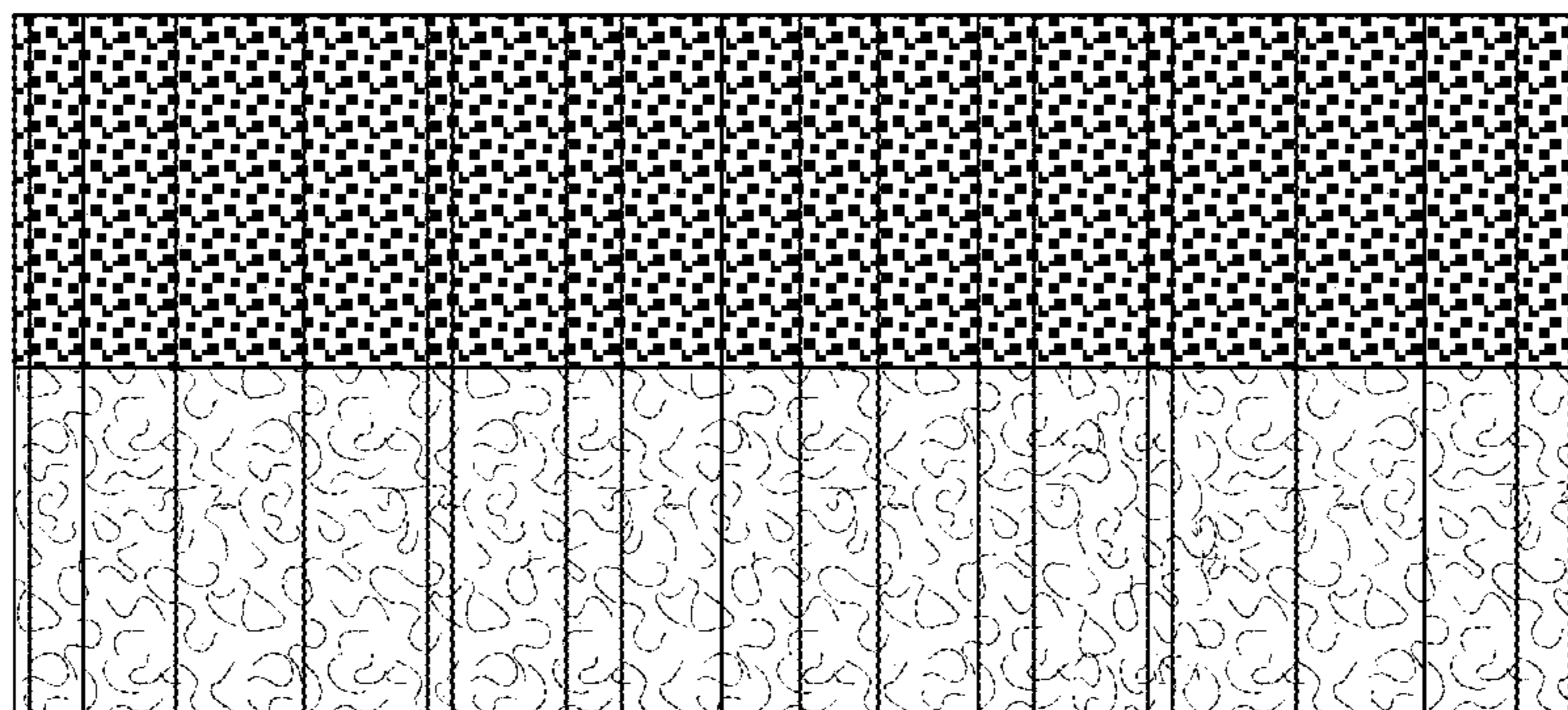

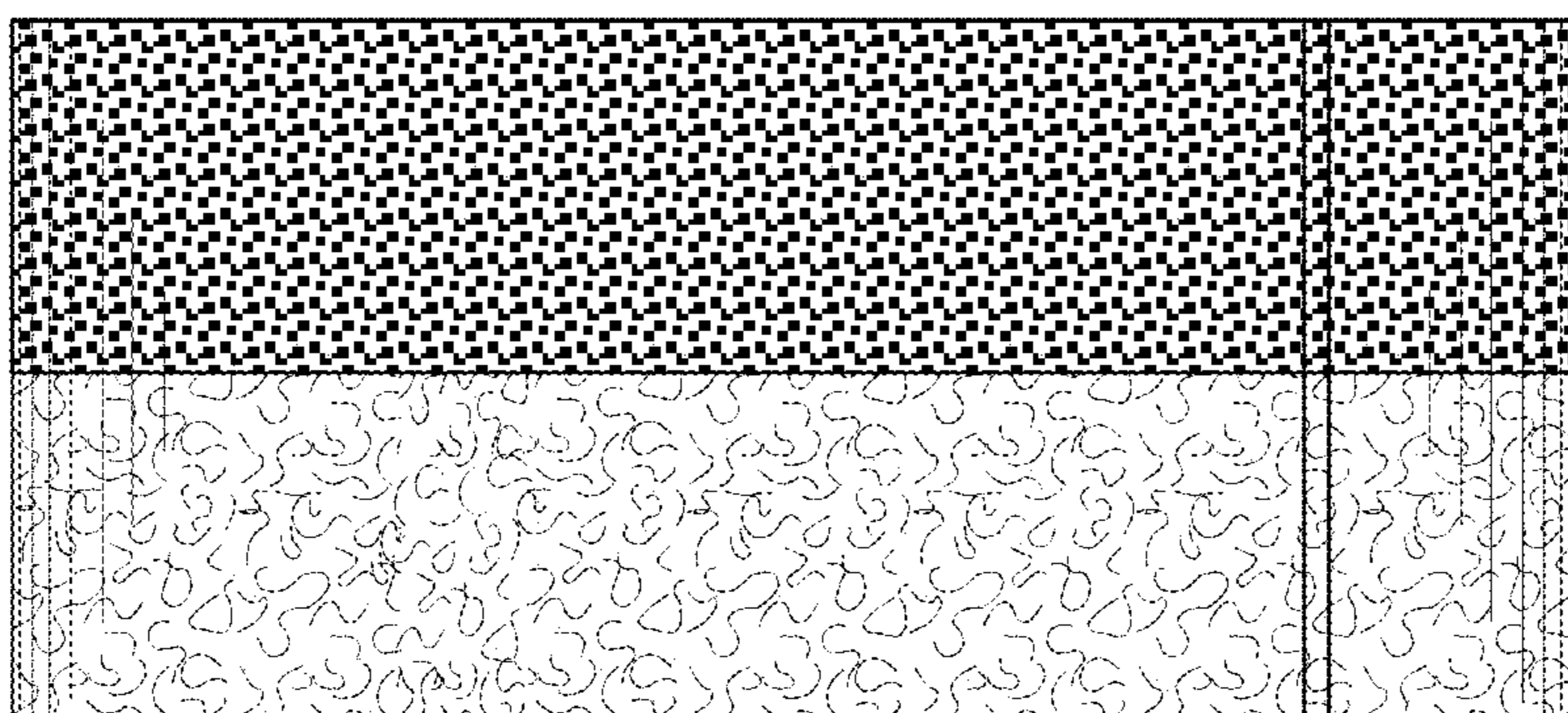

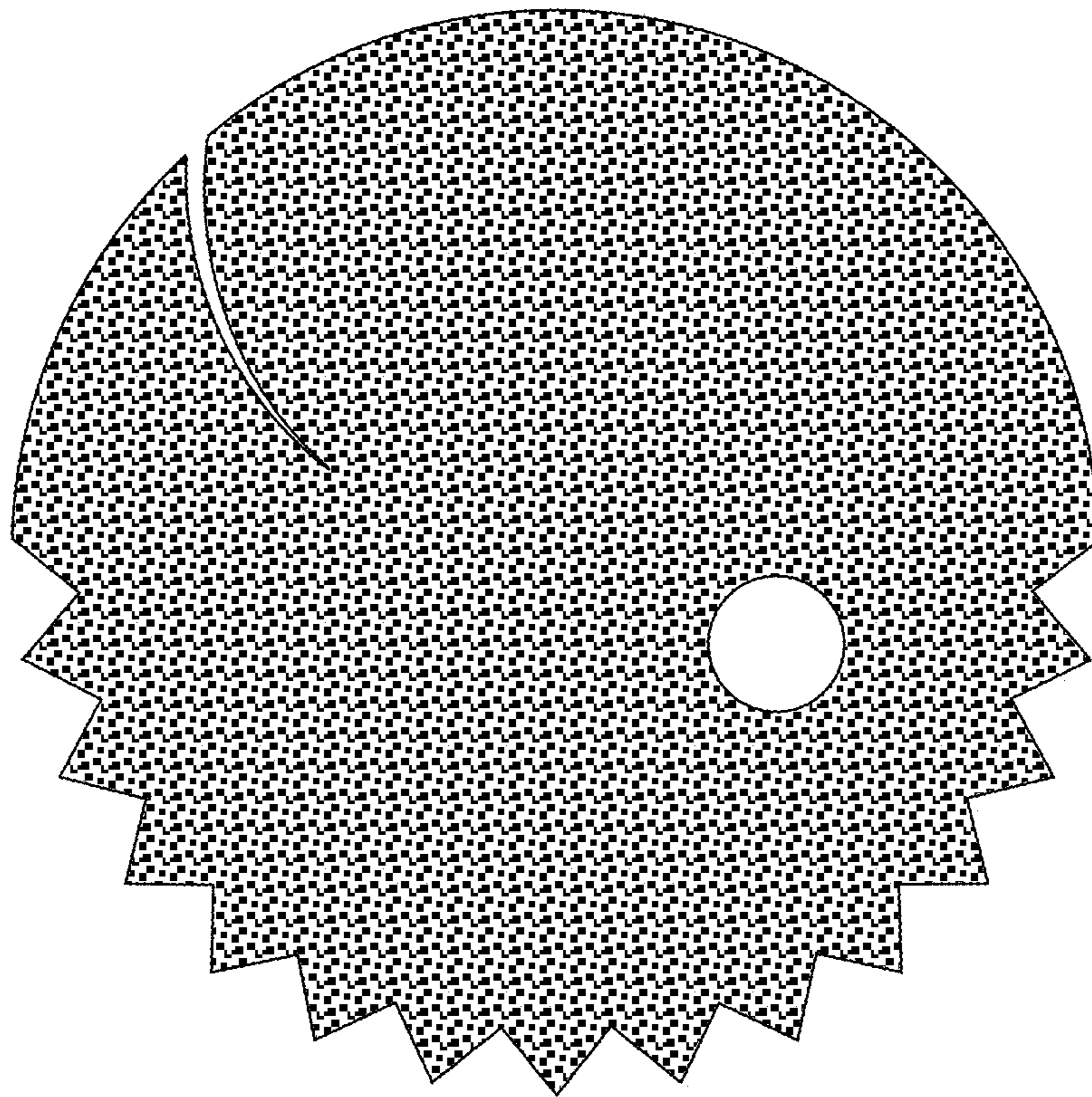

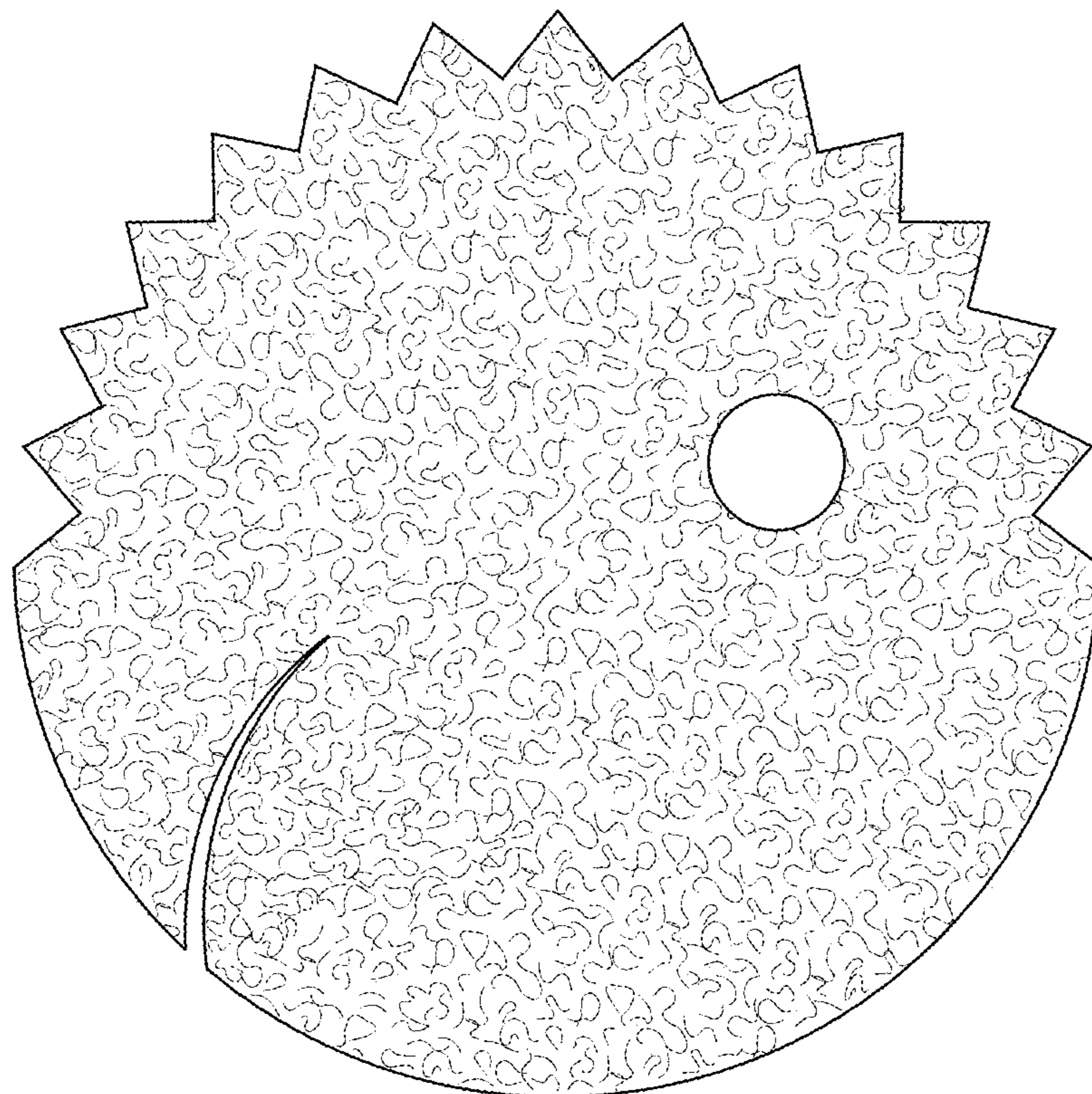

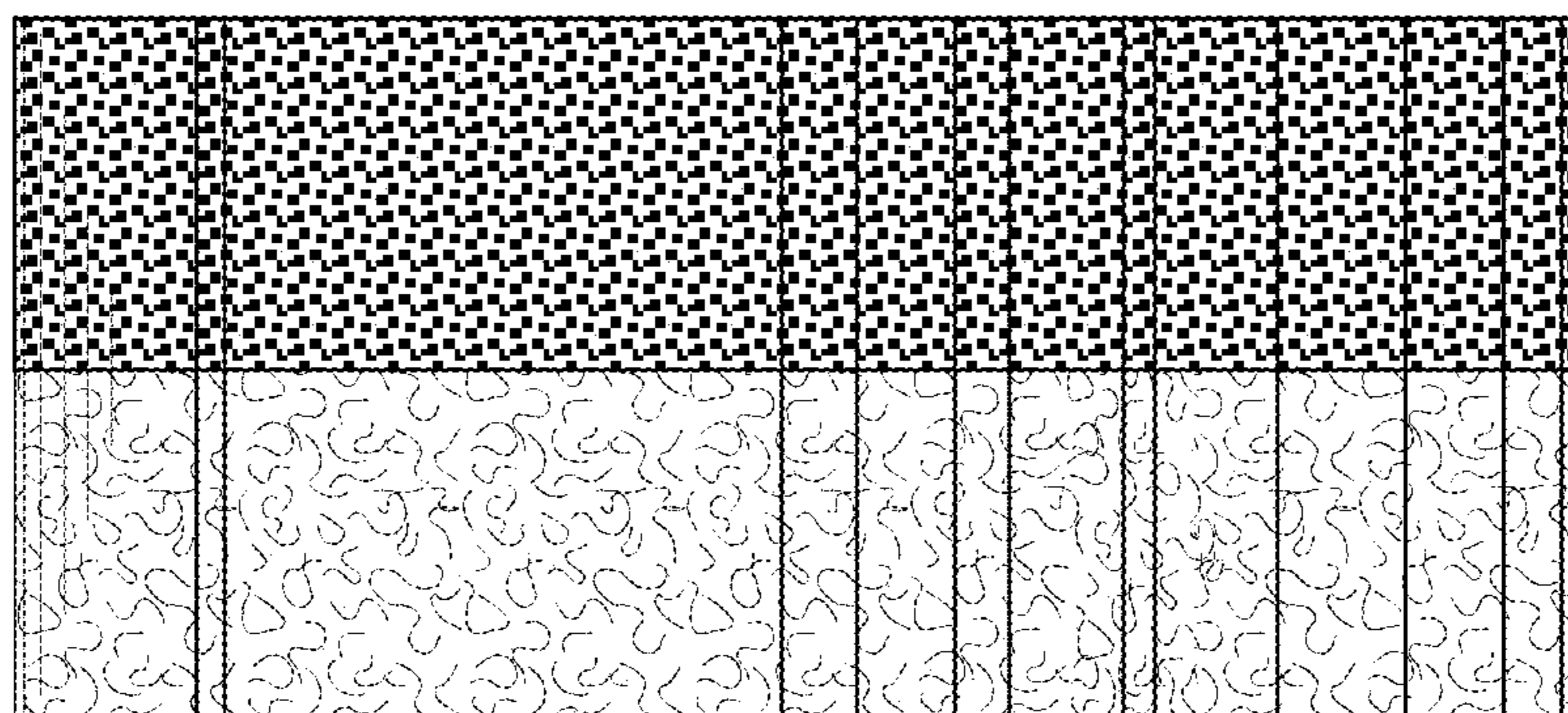

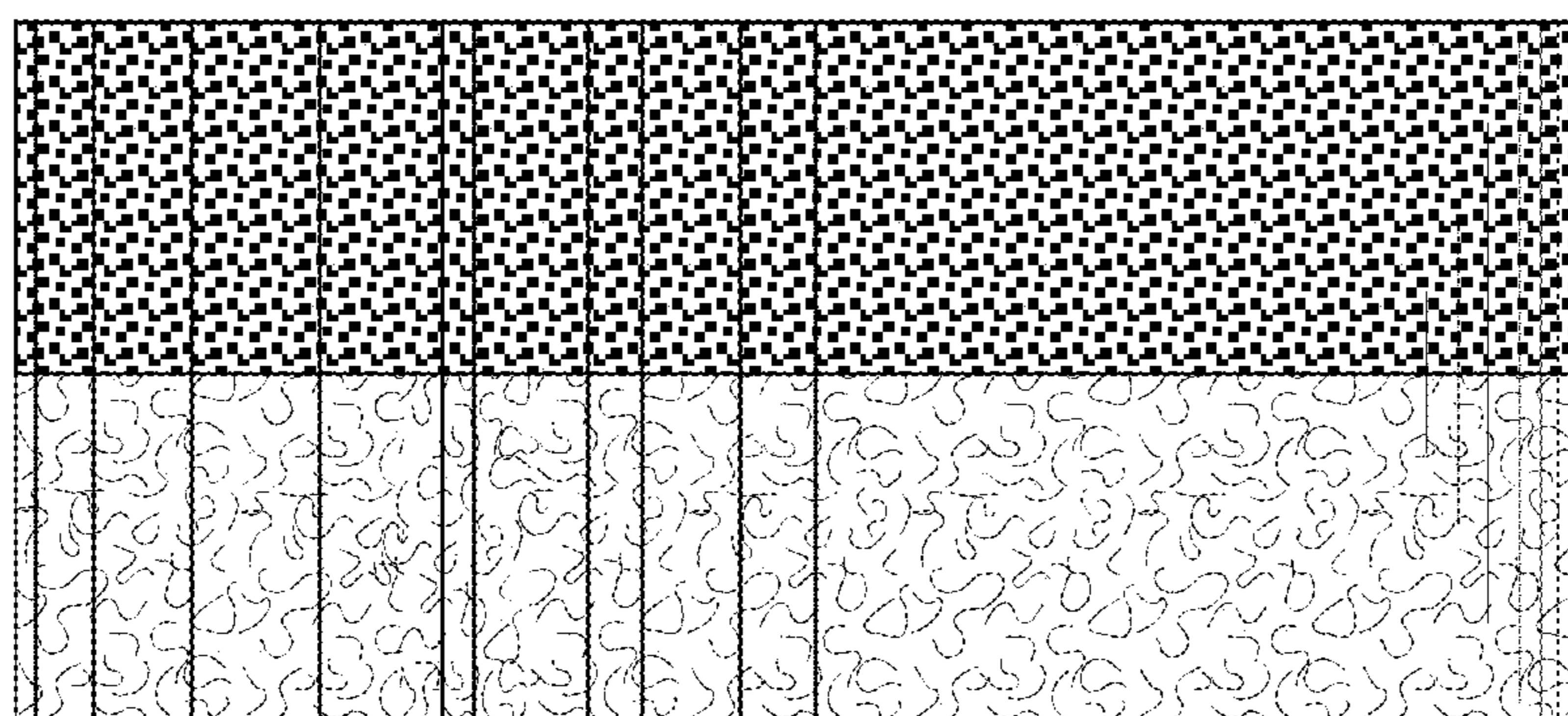

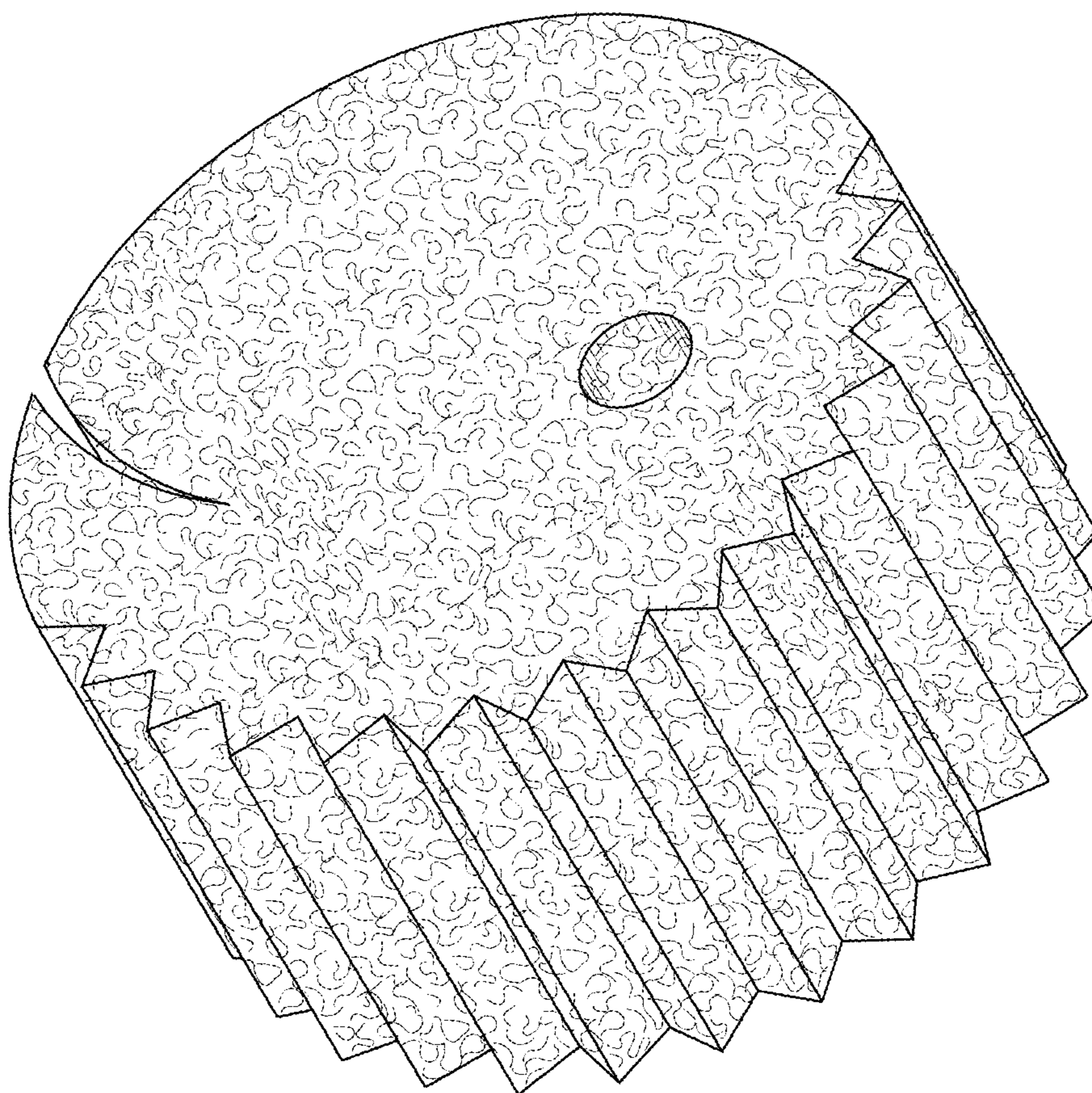

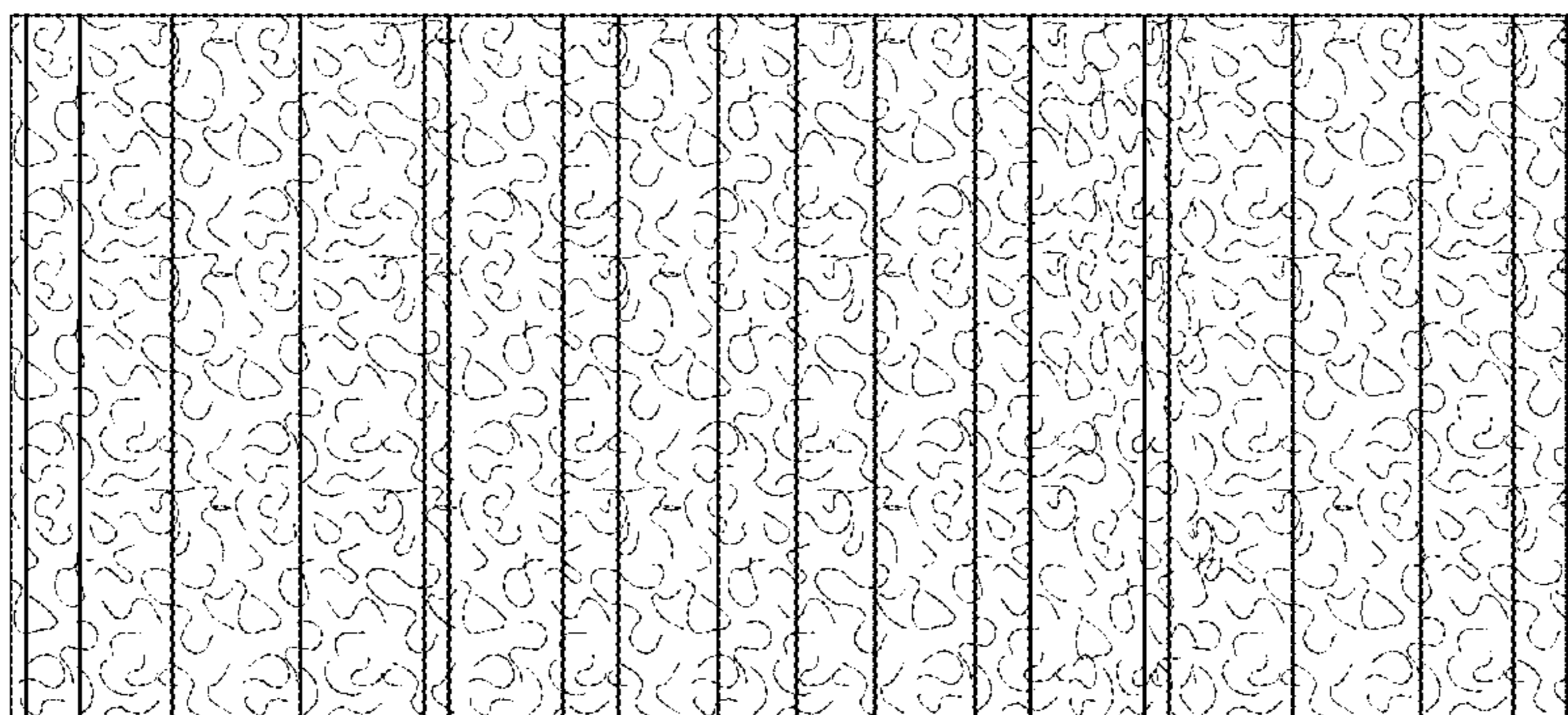

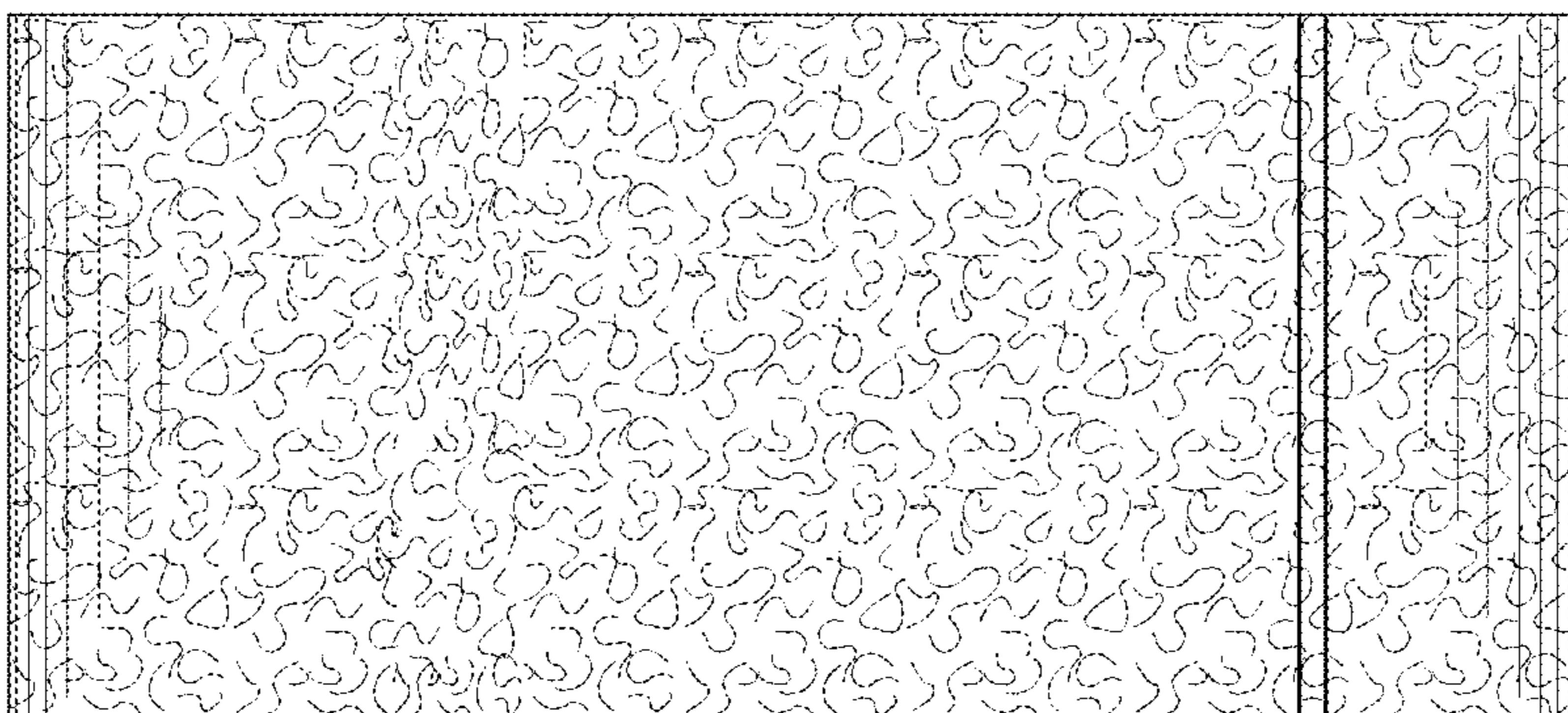

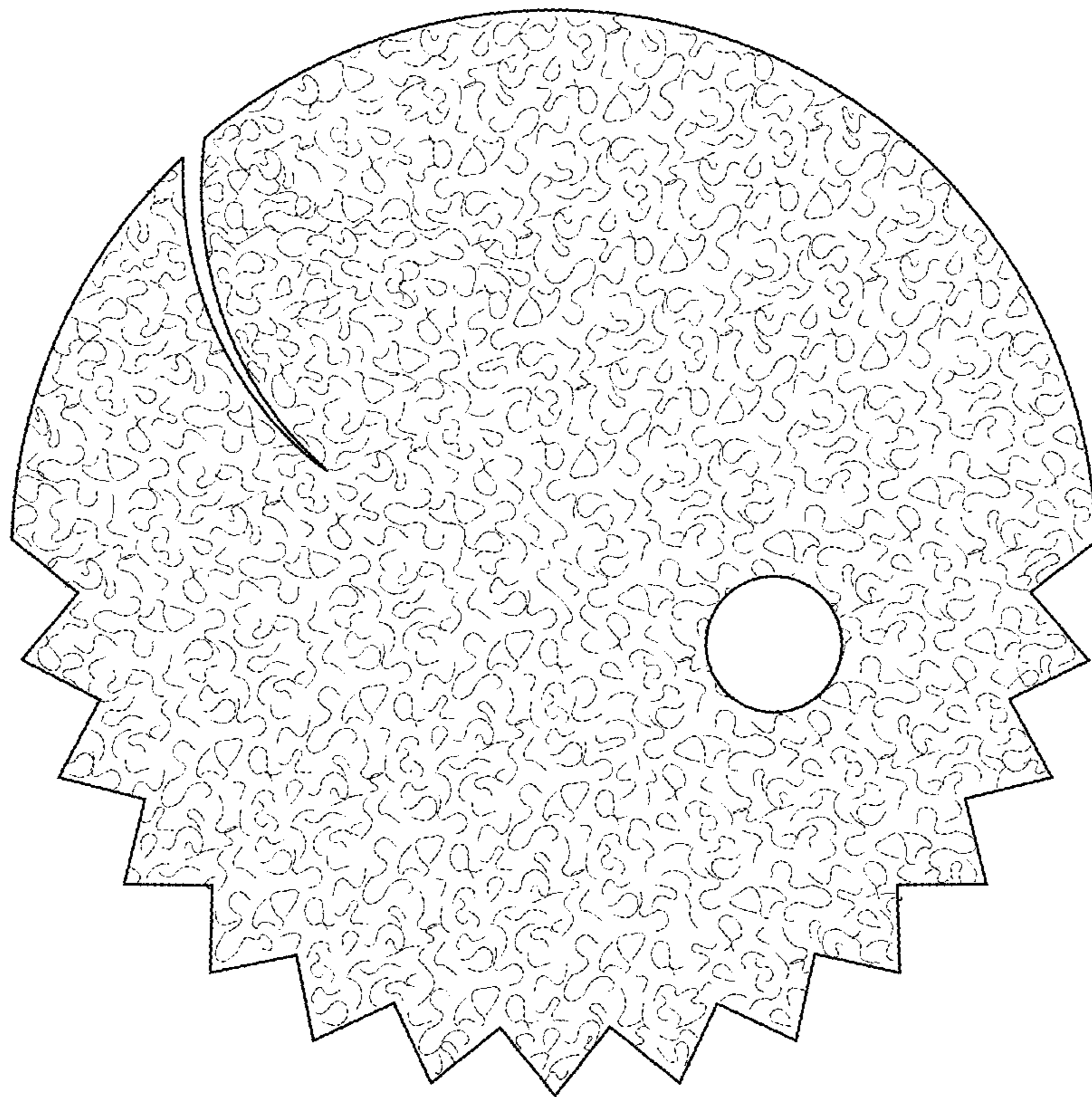

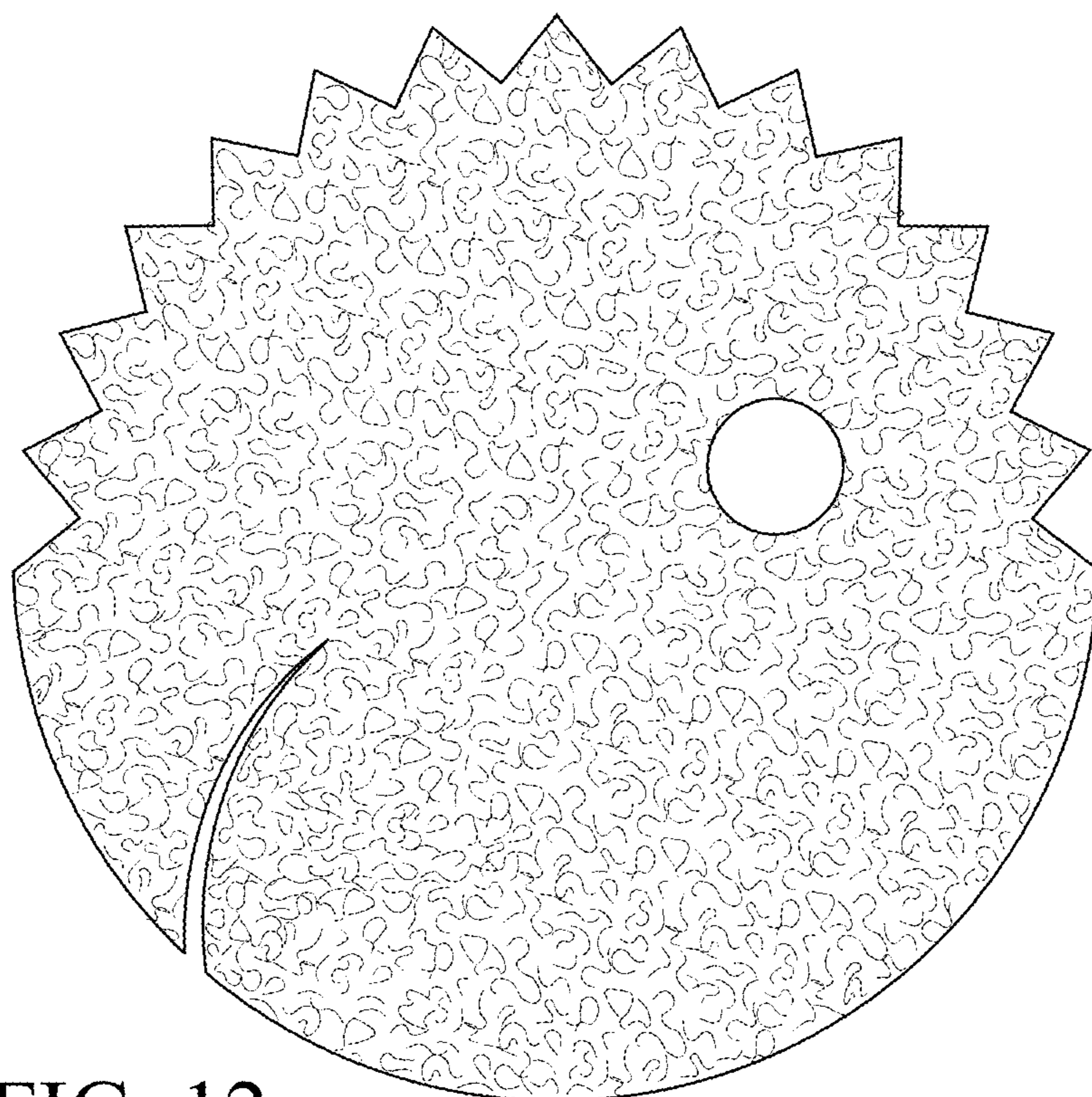

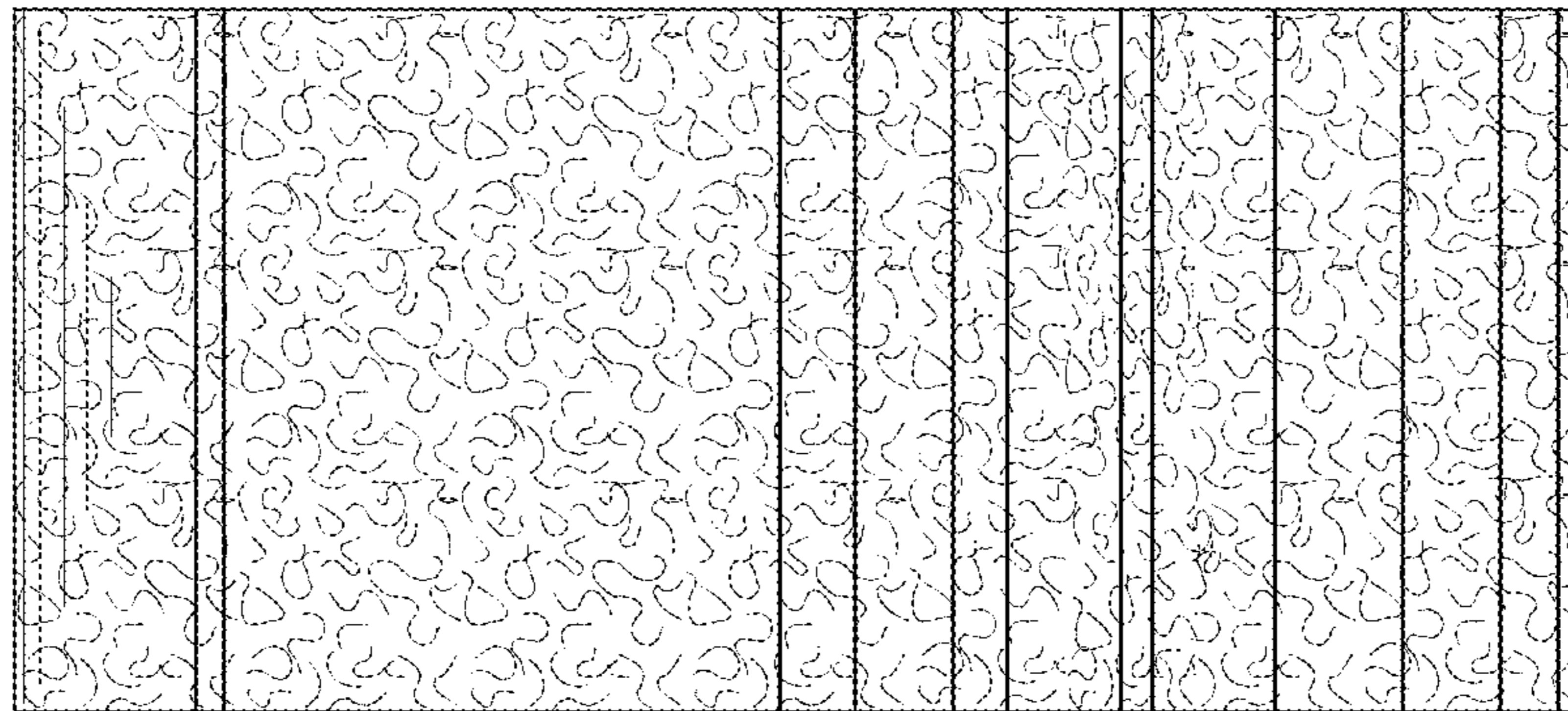

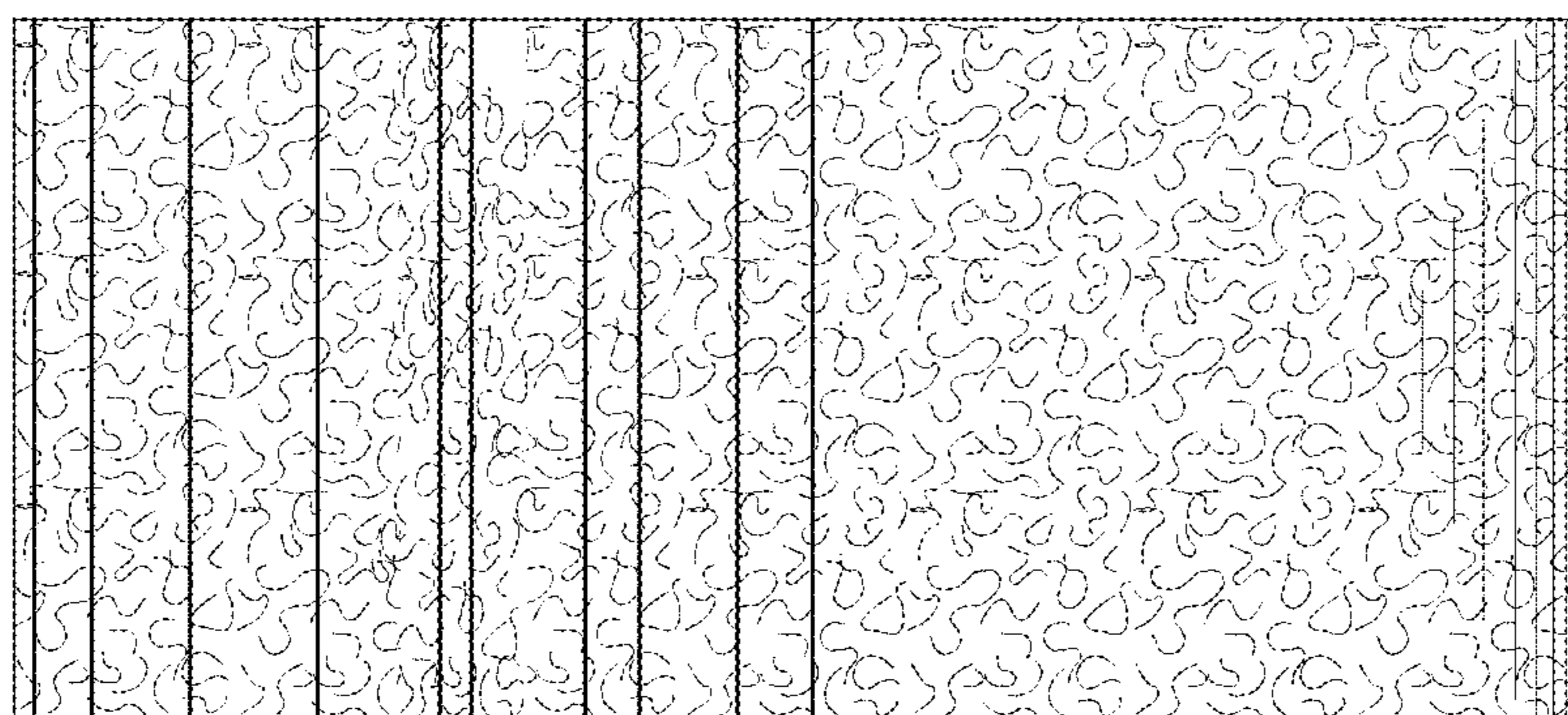
