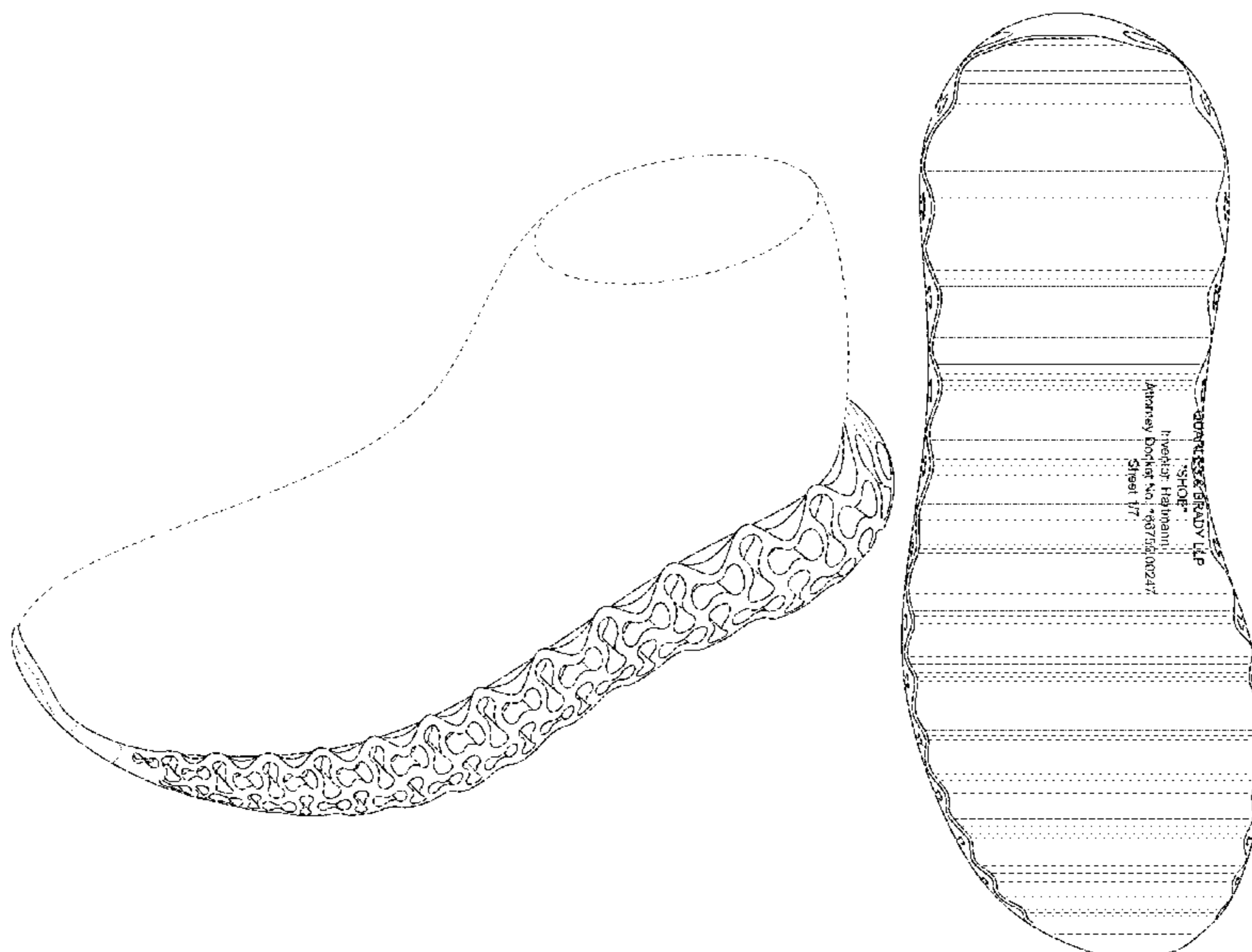
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a top, left, front perspective view of an ornamental design for a shoe;
FIG. 2 is a top, left, rear perspective view of the shoe of FIG. 1;
FIG. 3 is a front elevational view of the shoe of FIG. 1;
FIG. 4 is a rear elevational view of the shoe of FIG. 1;
FIG. 5 is a left side elevational view of the shoe of FIG. 1;

FIG. 7 is a top plan view of the shoe of FIG. 1; and,
FIG. 8 is a bottom plan view of the shoe of FIG. 1.

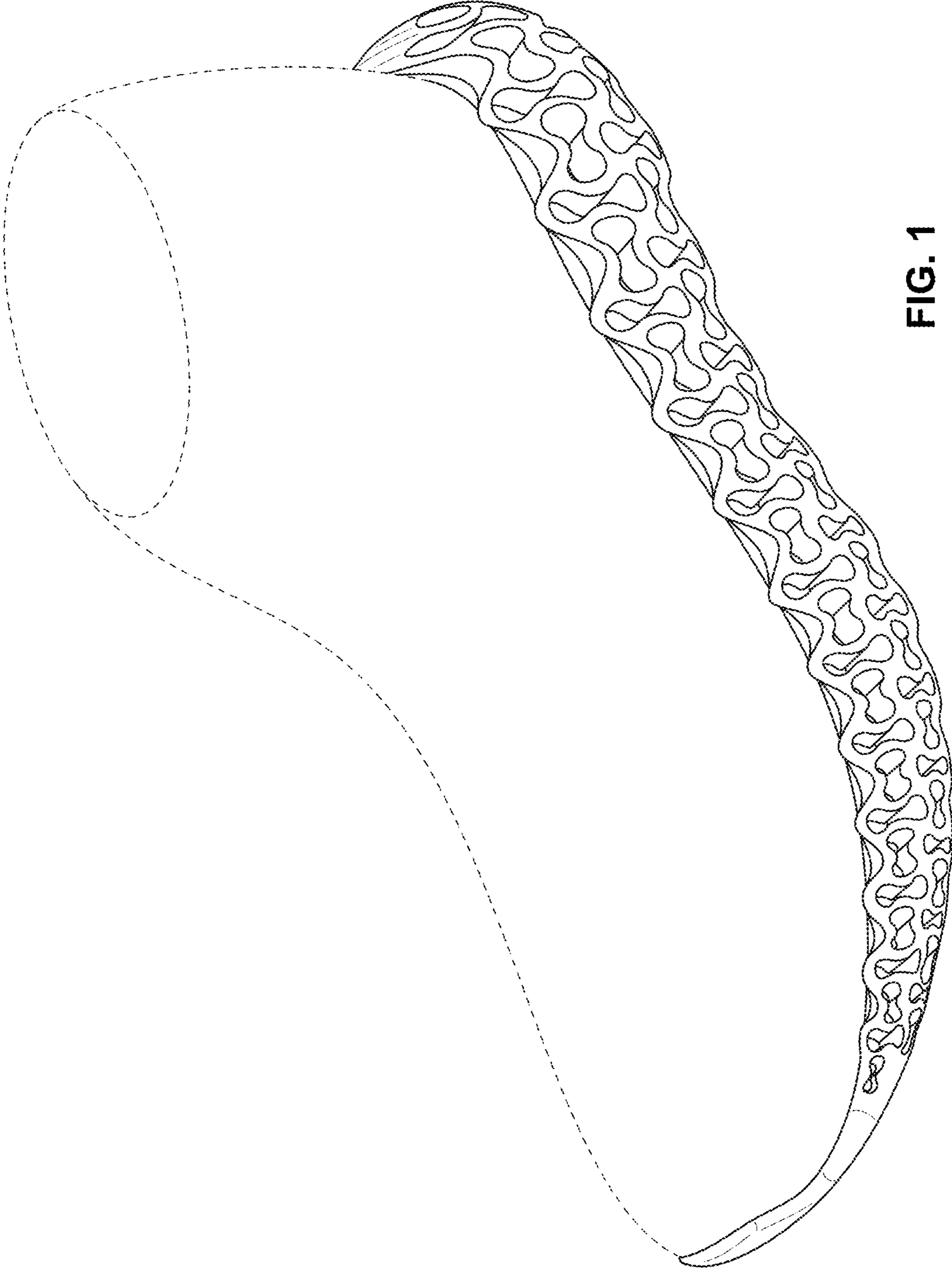

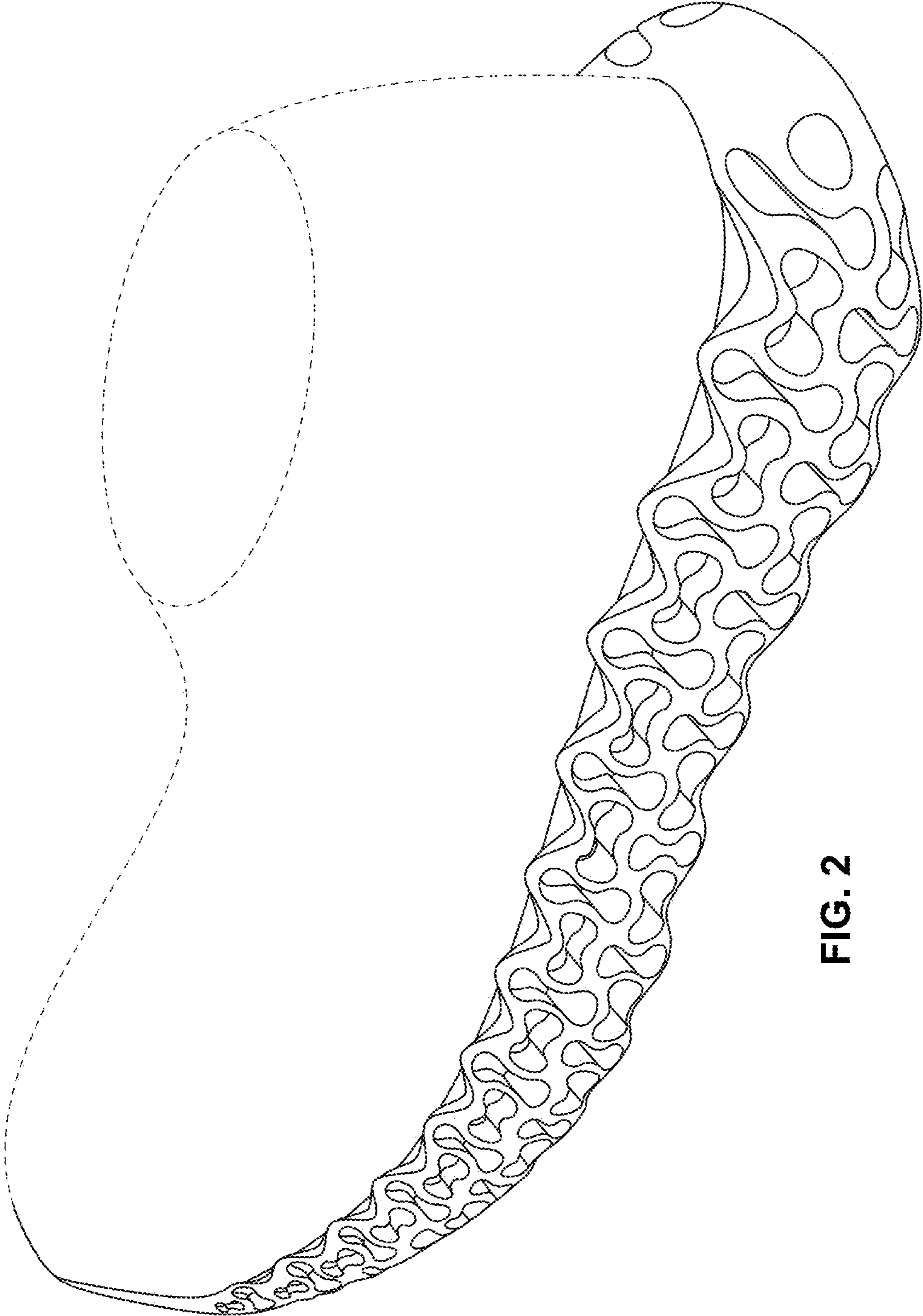

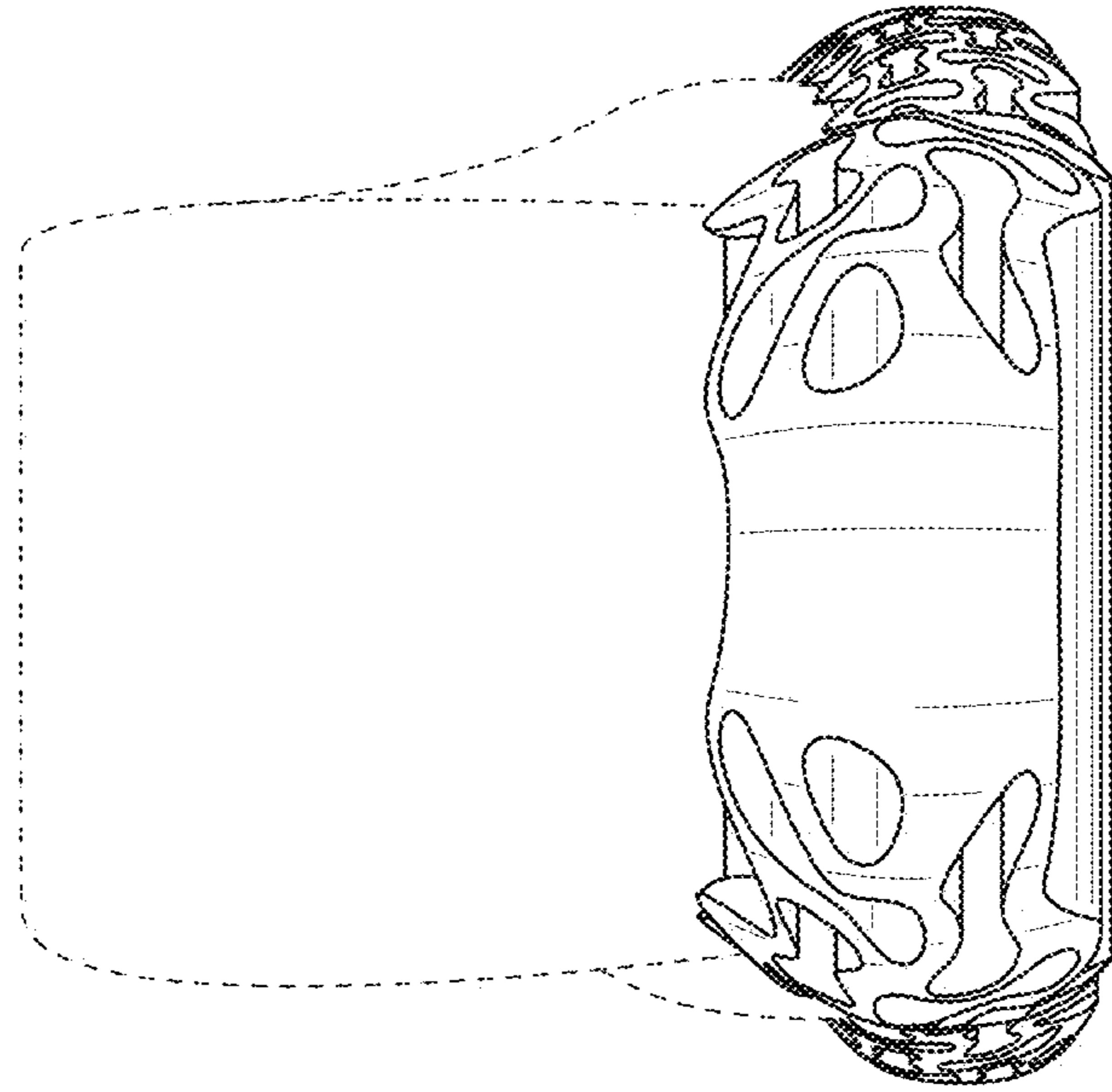

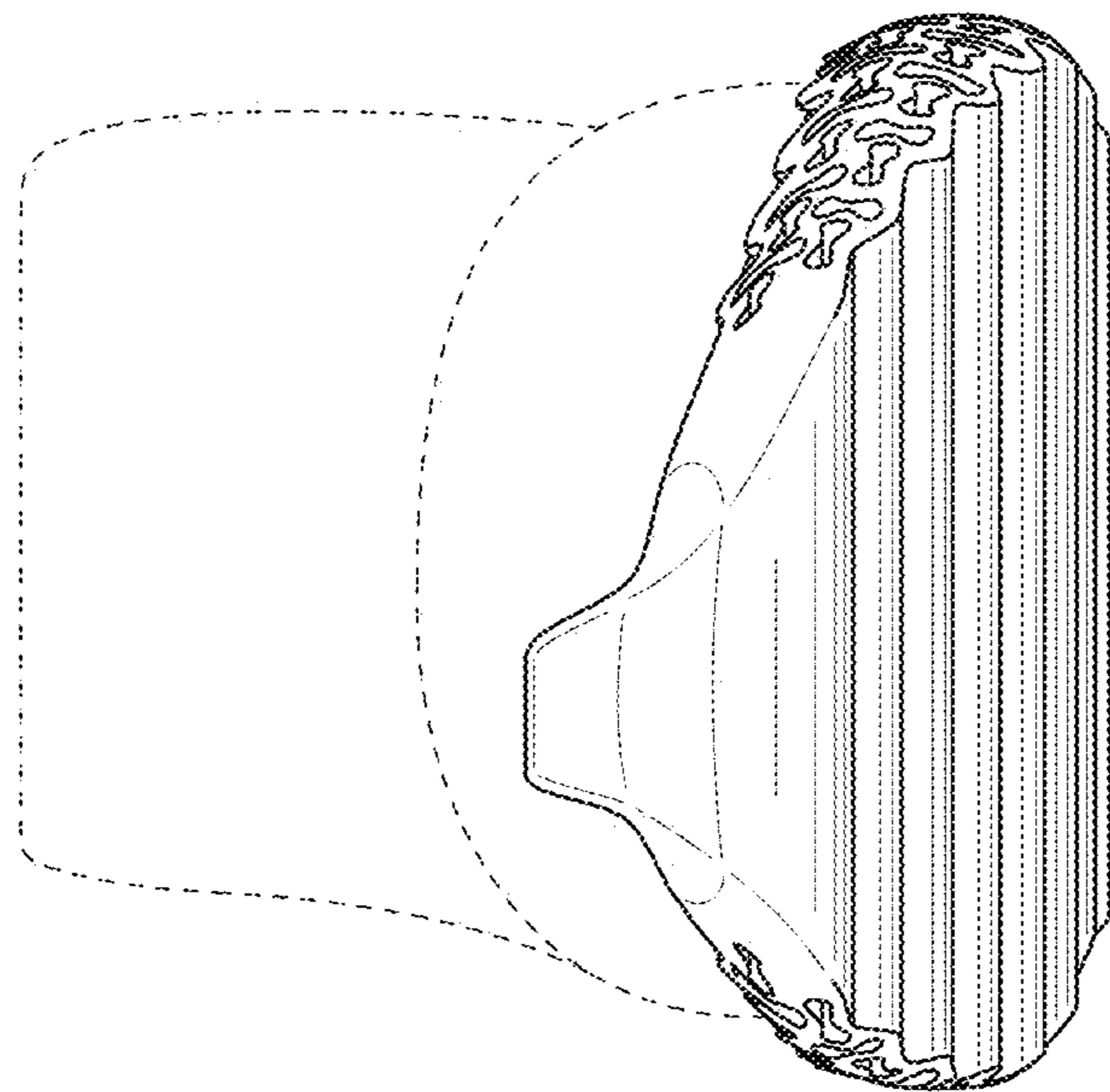

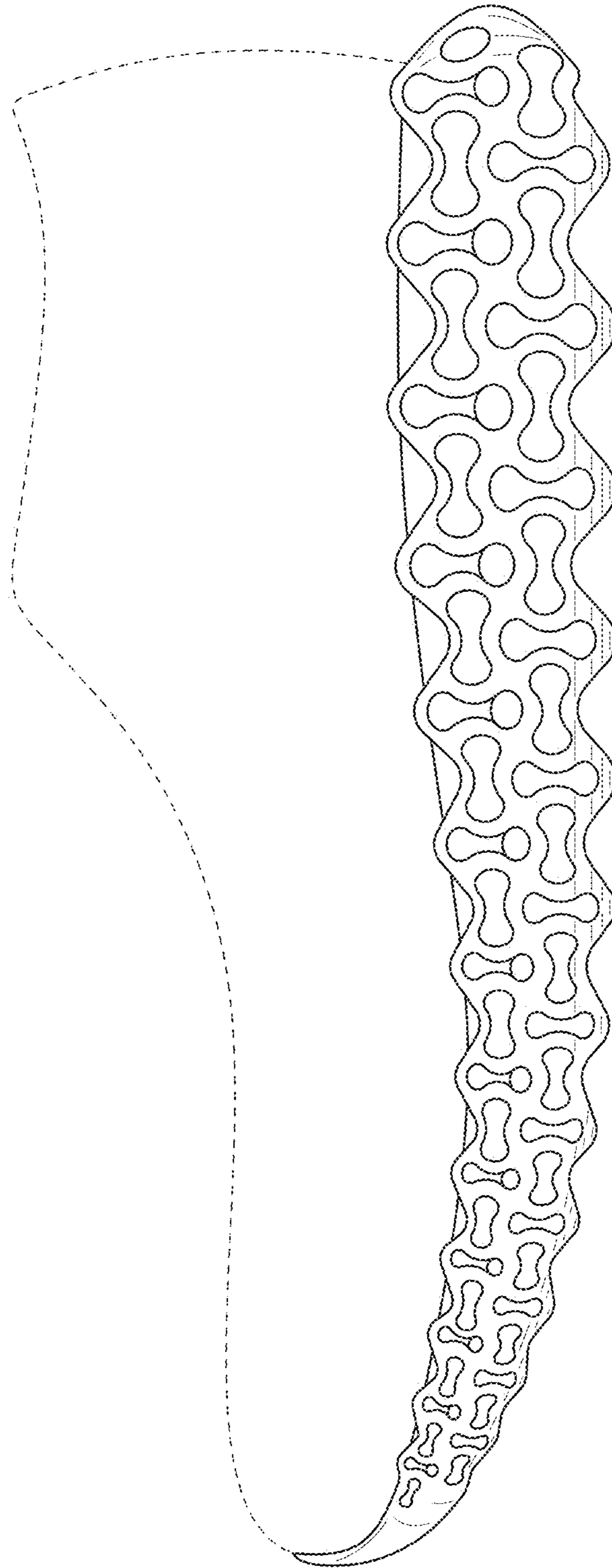

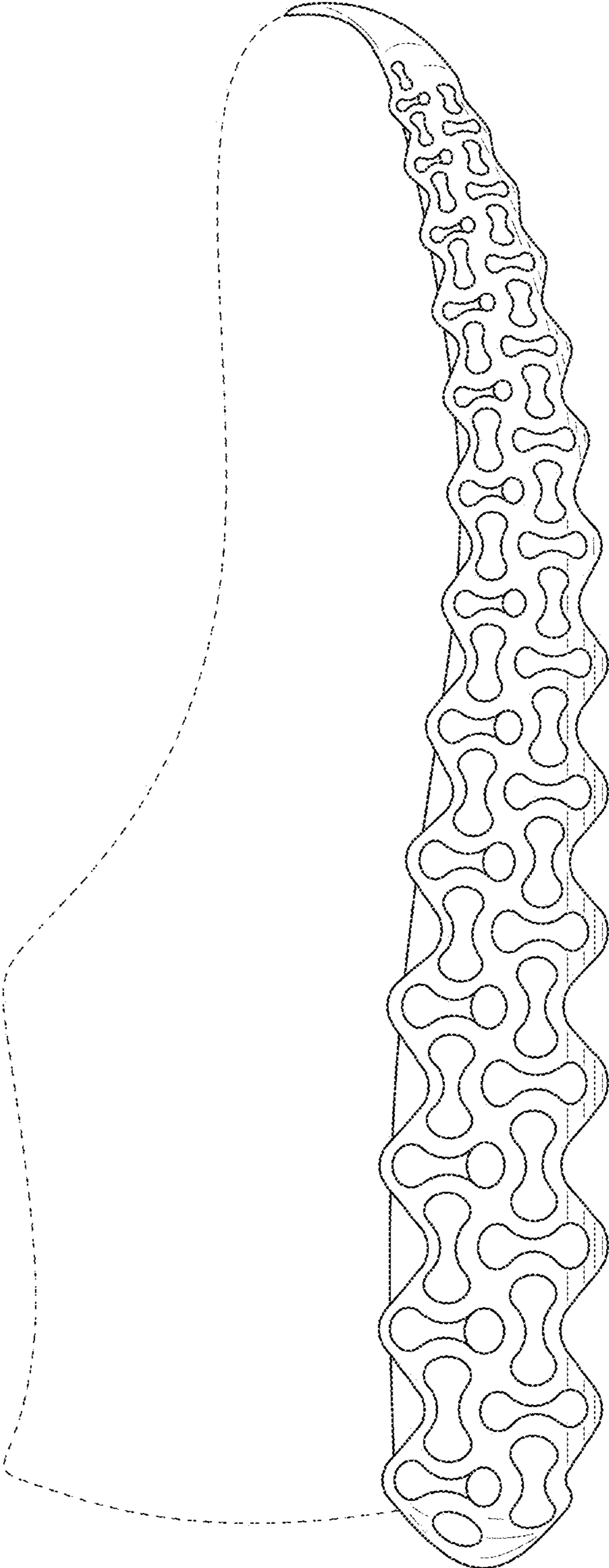

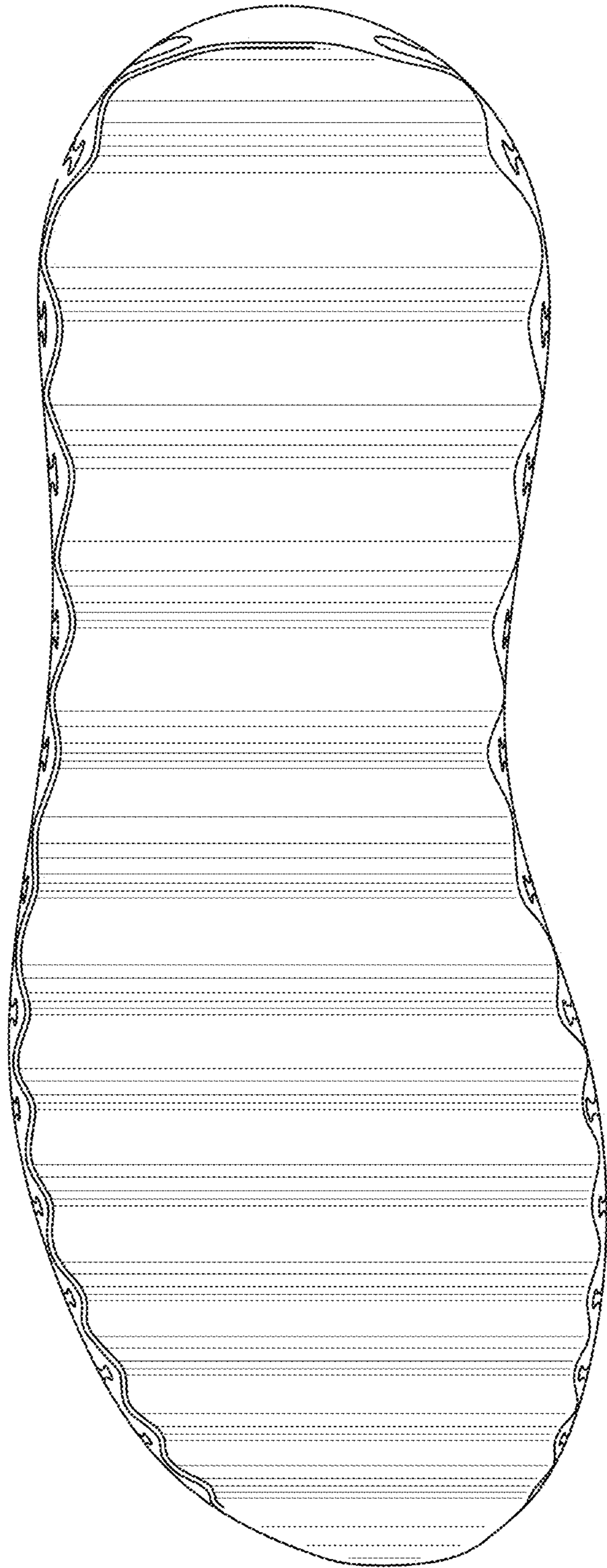
