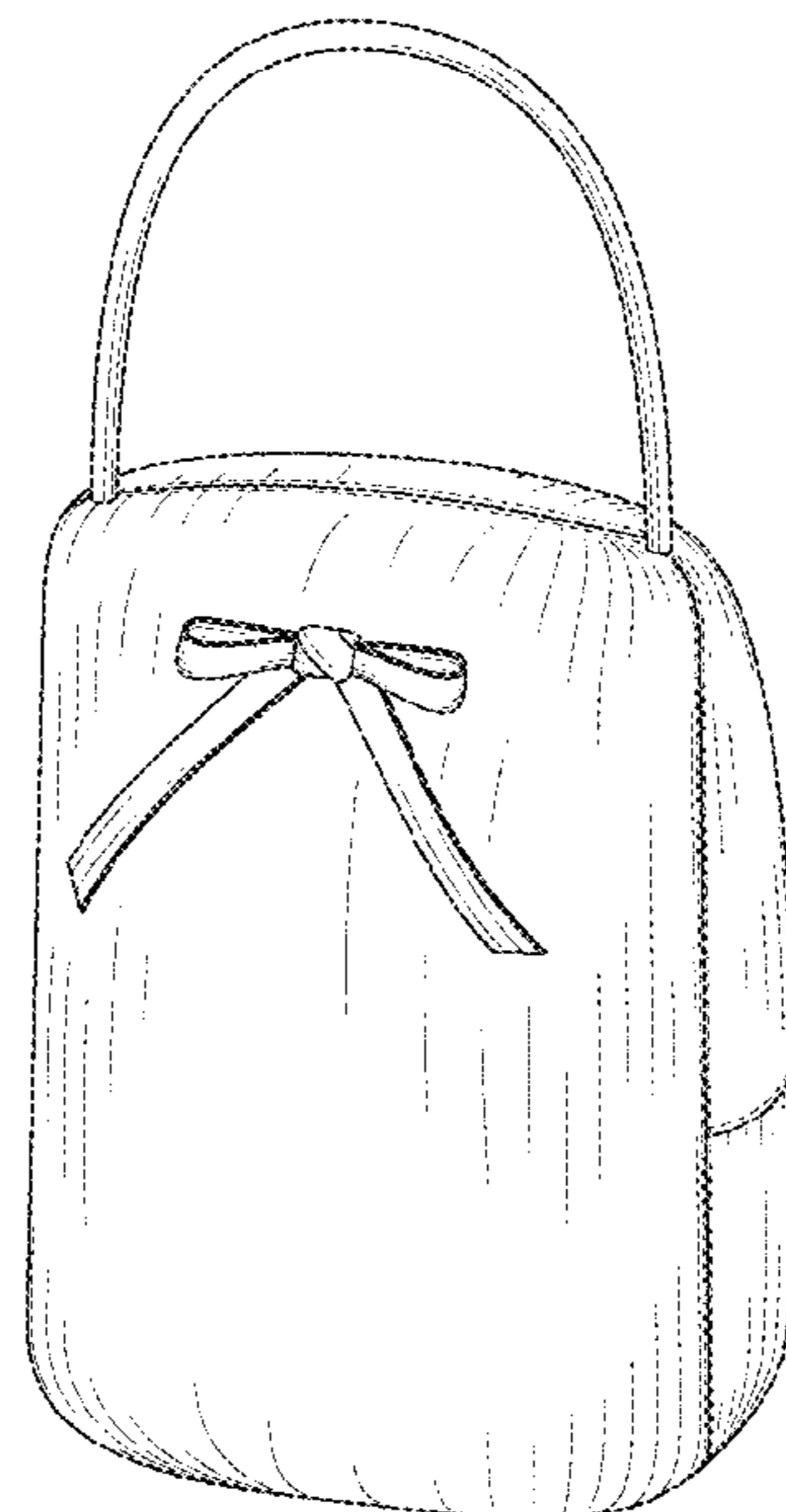
(57) **CLAIM**

I claim the ornamental design for a boot weight, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the boot weight; FIG. 2 is a front side elevational view of the boot weight; FIG. 3 is a rear side elevational view of the boot weight; FIG. 4 is a right side elevational view of the boot weight; FIG. 5 is a left side elevational view of the boot weight; FIG. 6 is a top plan view of the boot weight; and, FIG. 7 is a bottom plan view of the boot weight. The dashed lines in the figures represent stitching and form part of the claimed design.

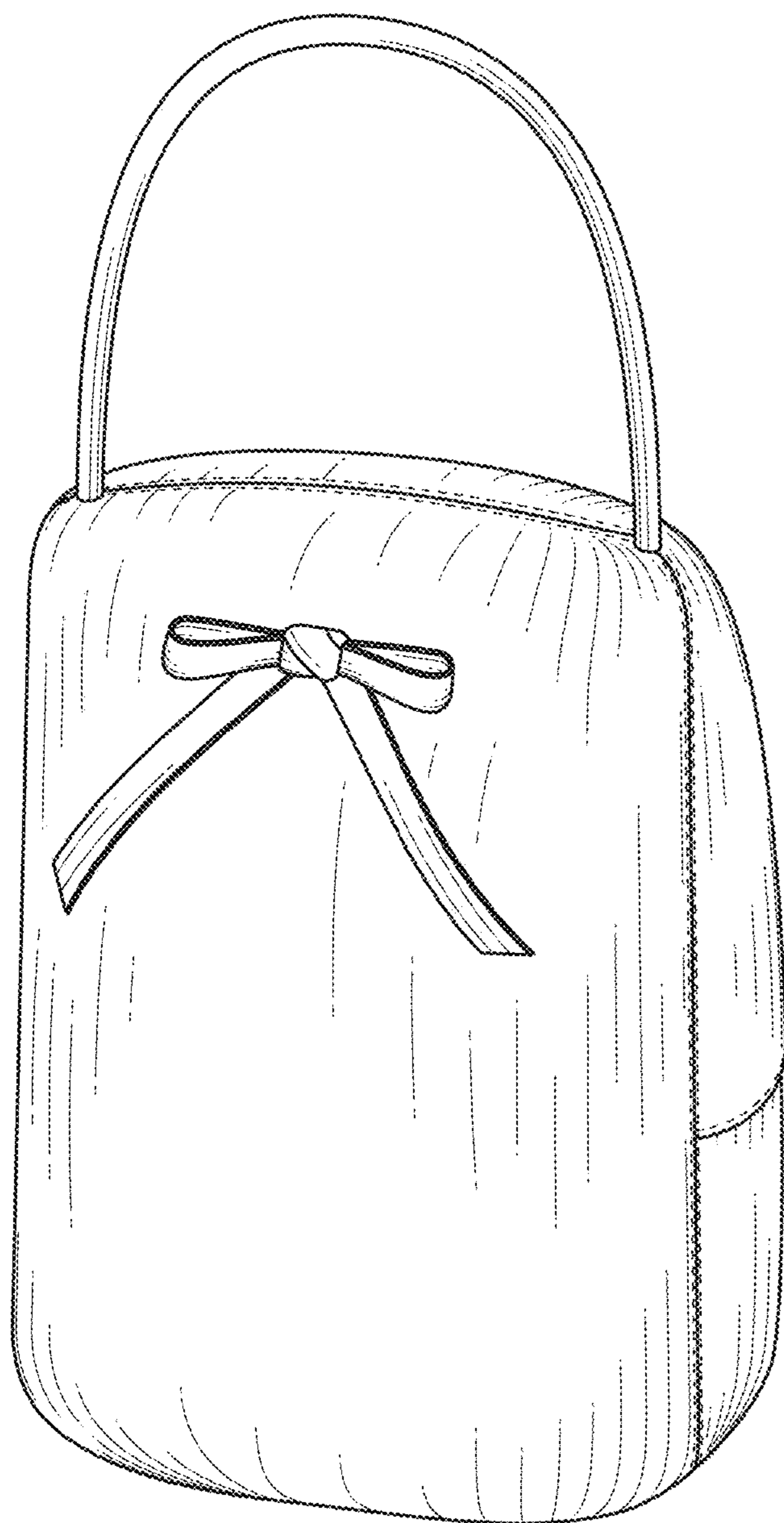

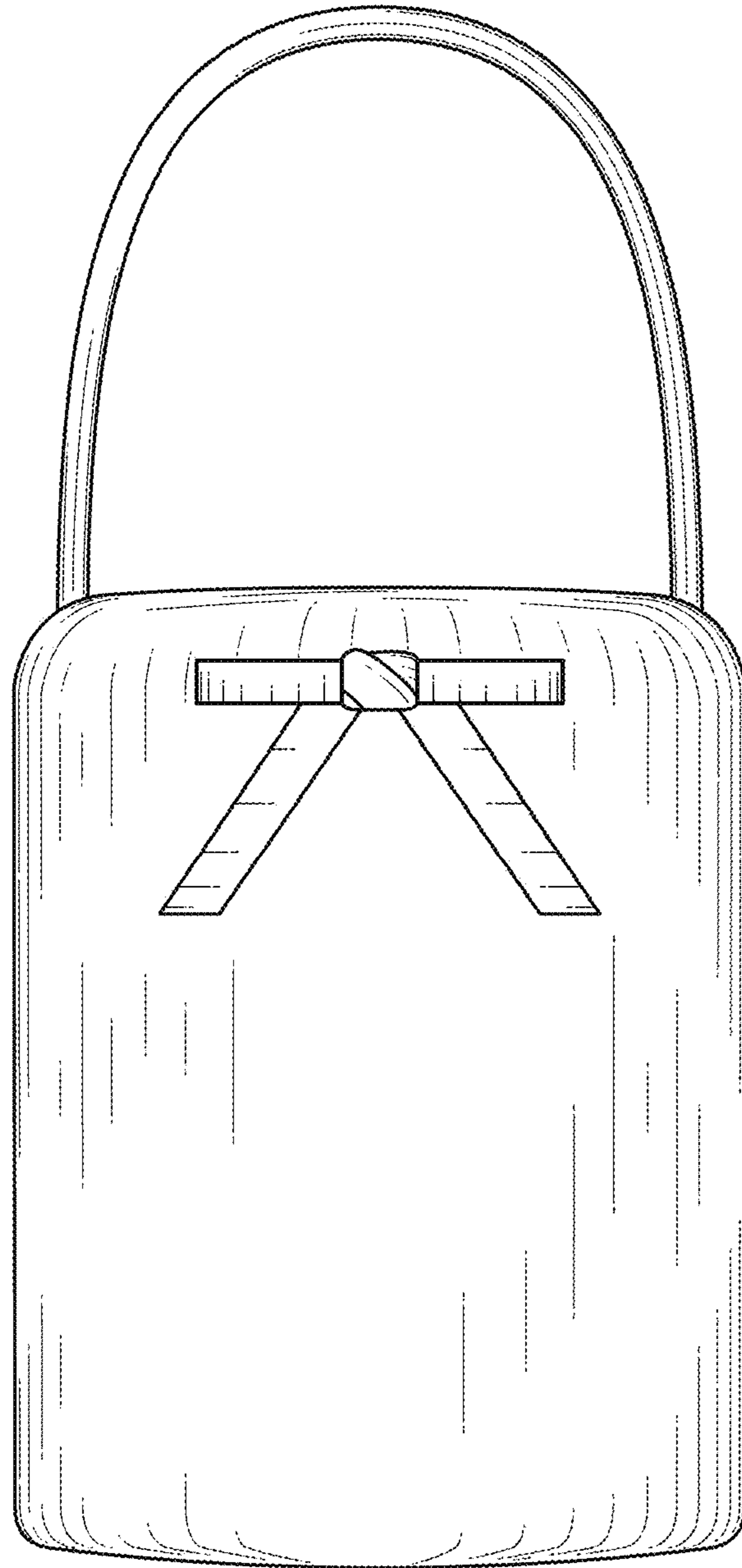

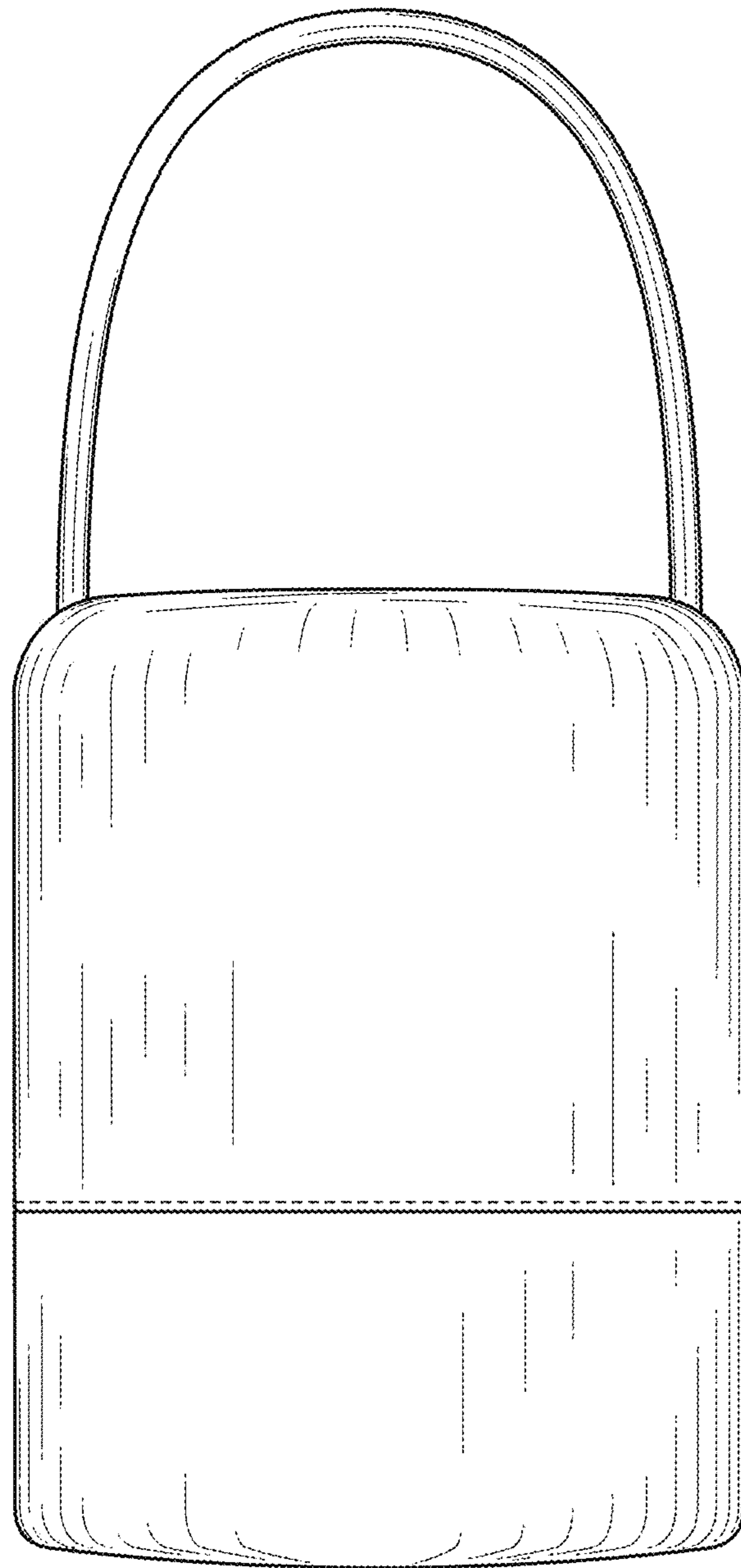

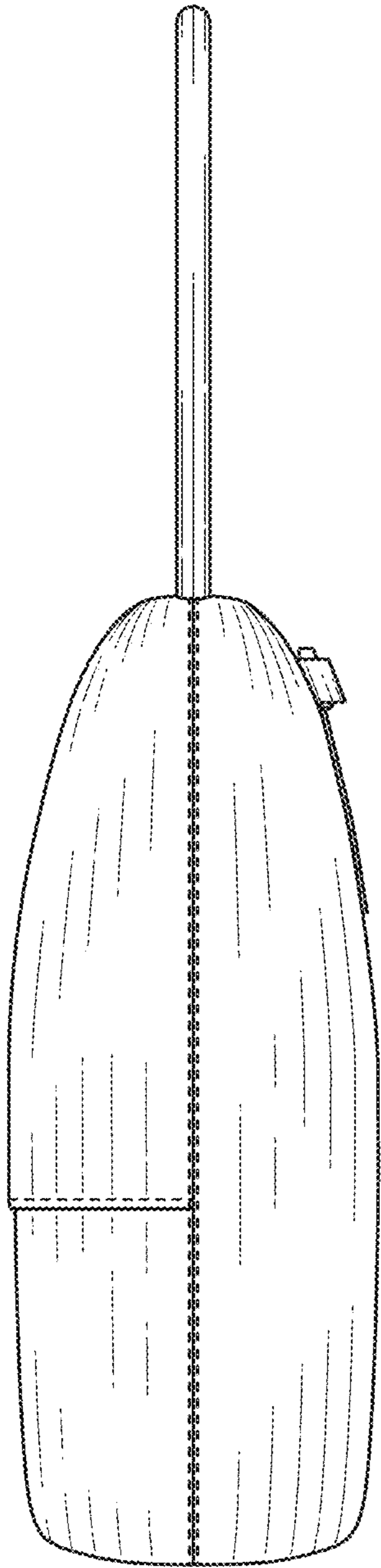

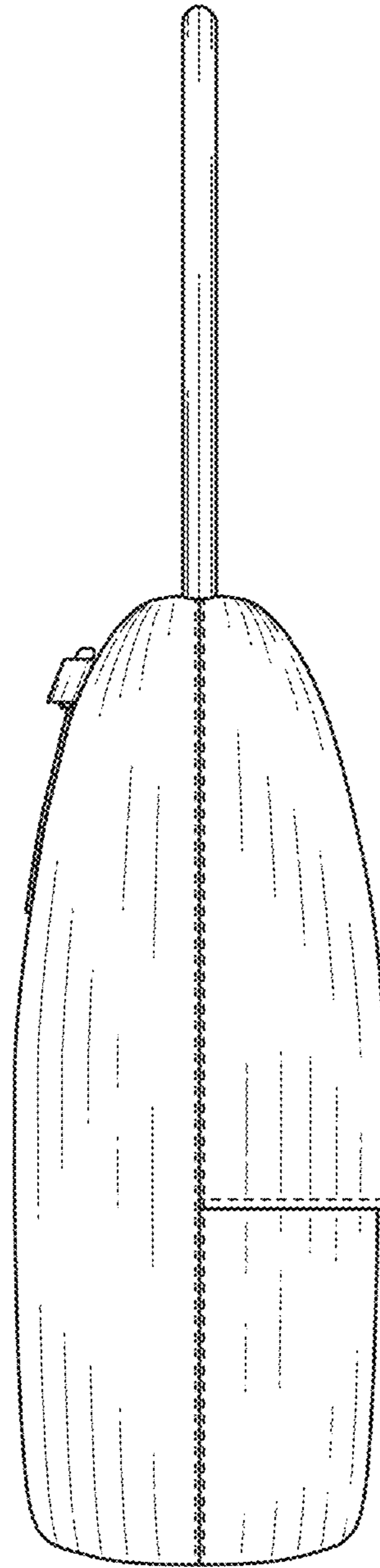

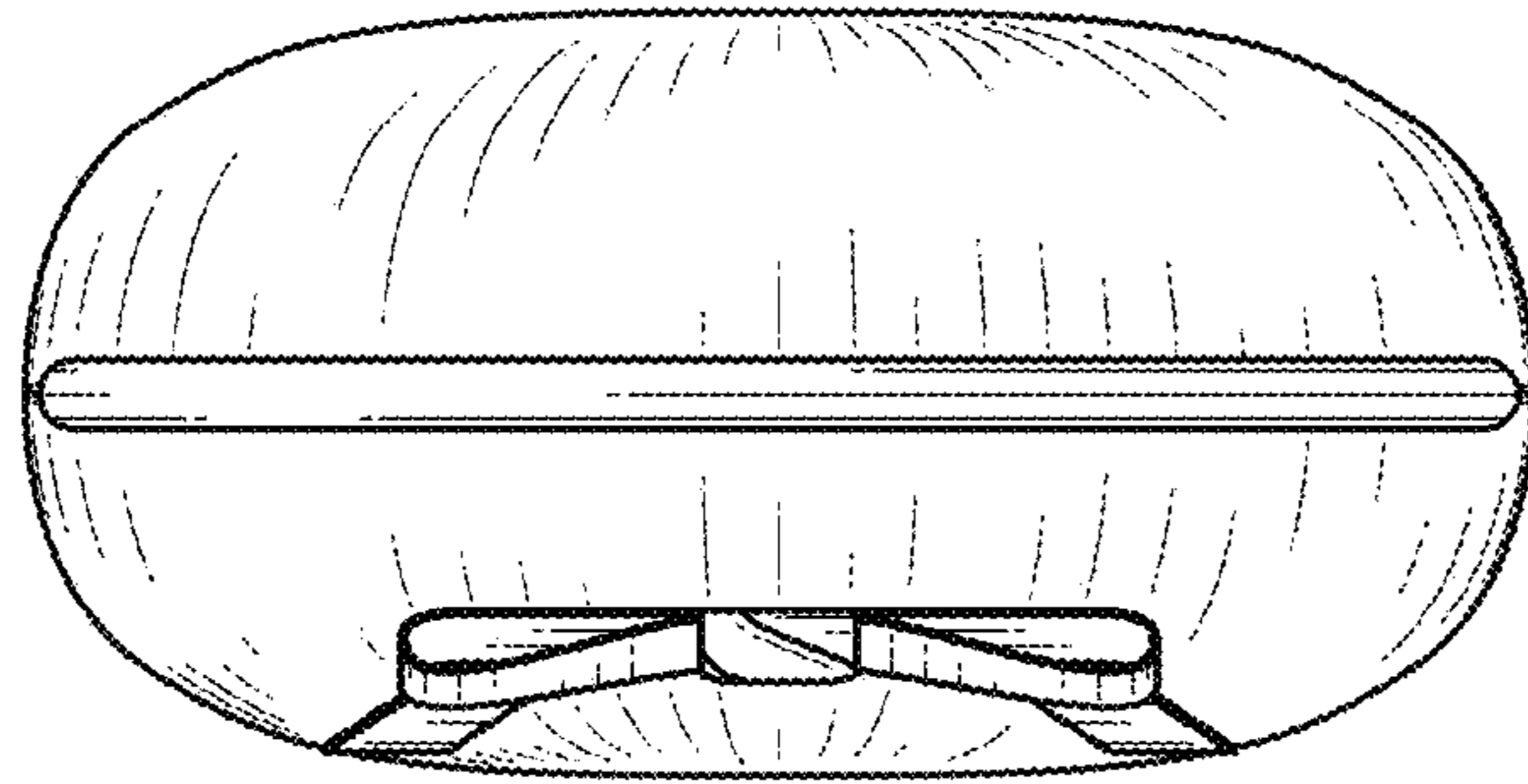

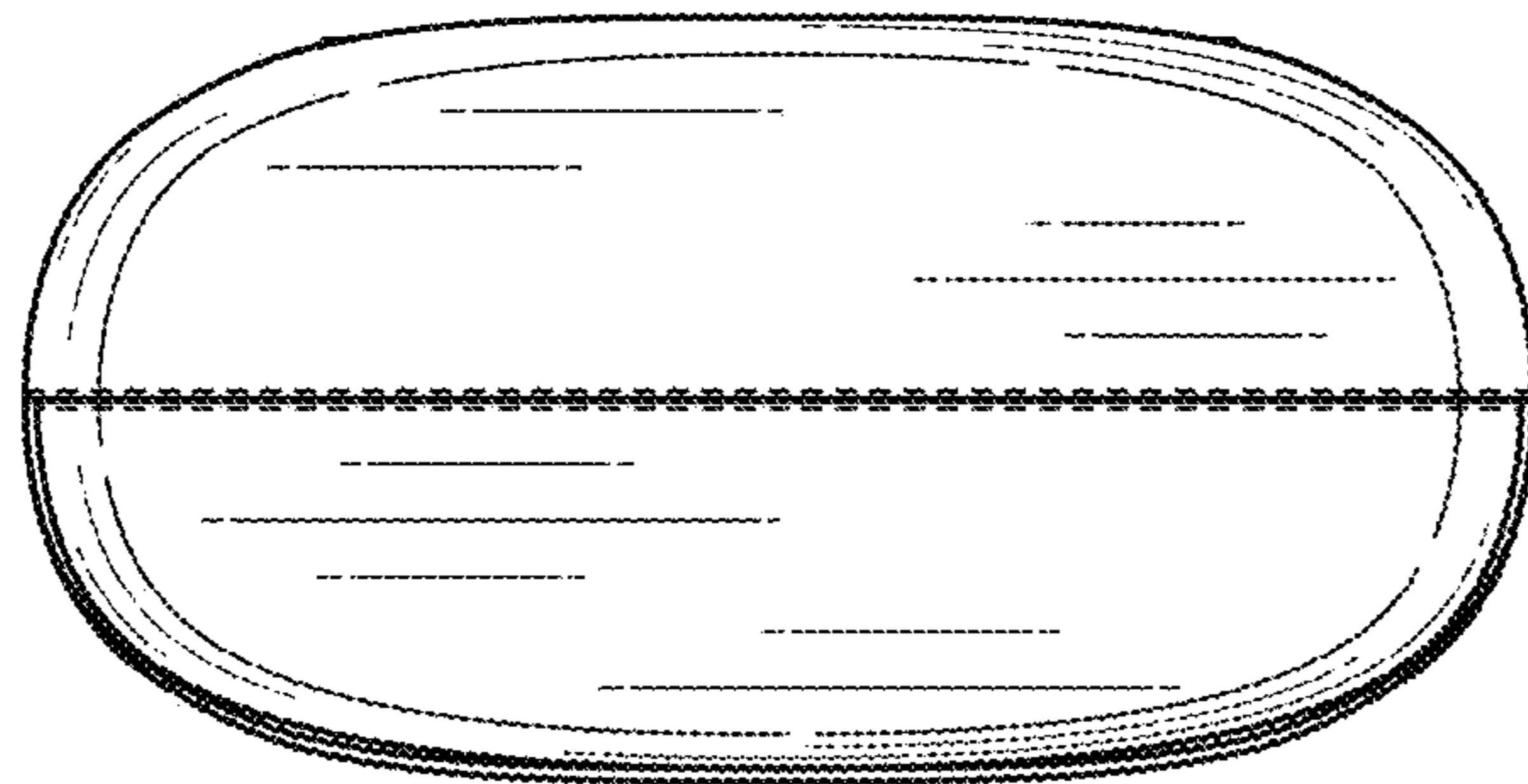
