DESCRIPTION

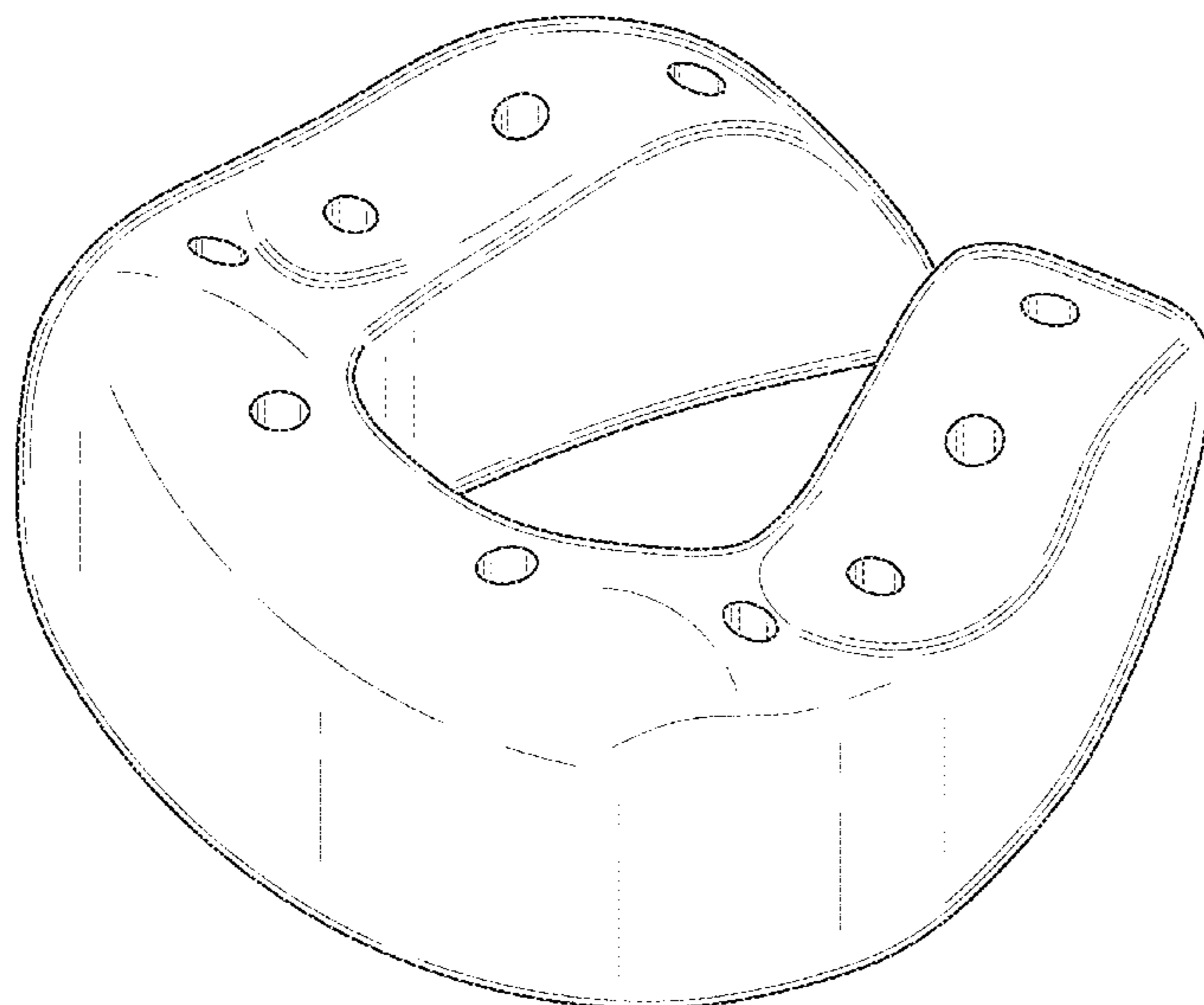
FIG. 1 is a top rear perspective view of a neck pillow according to our new design;

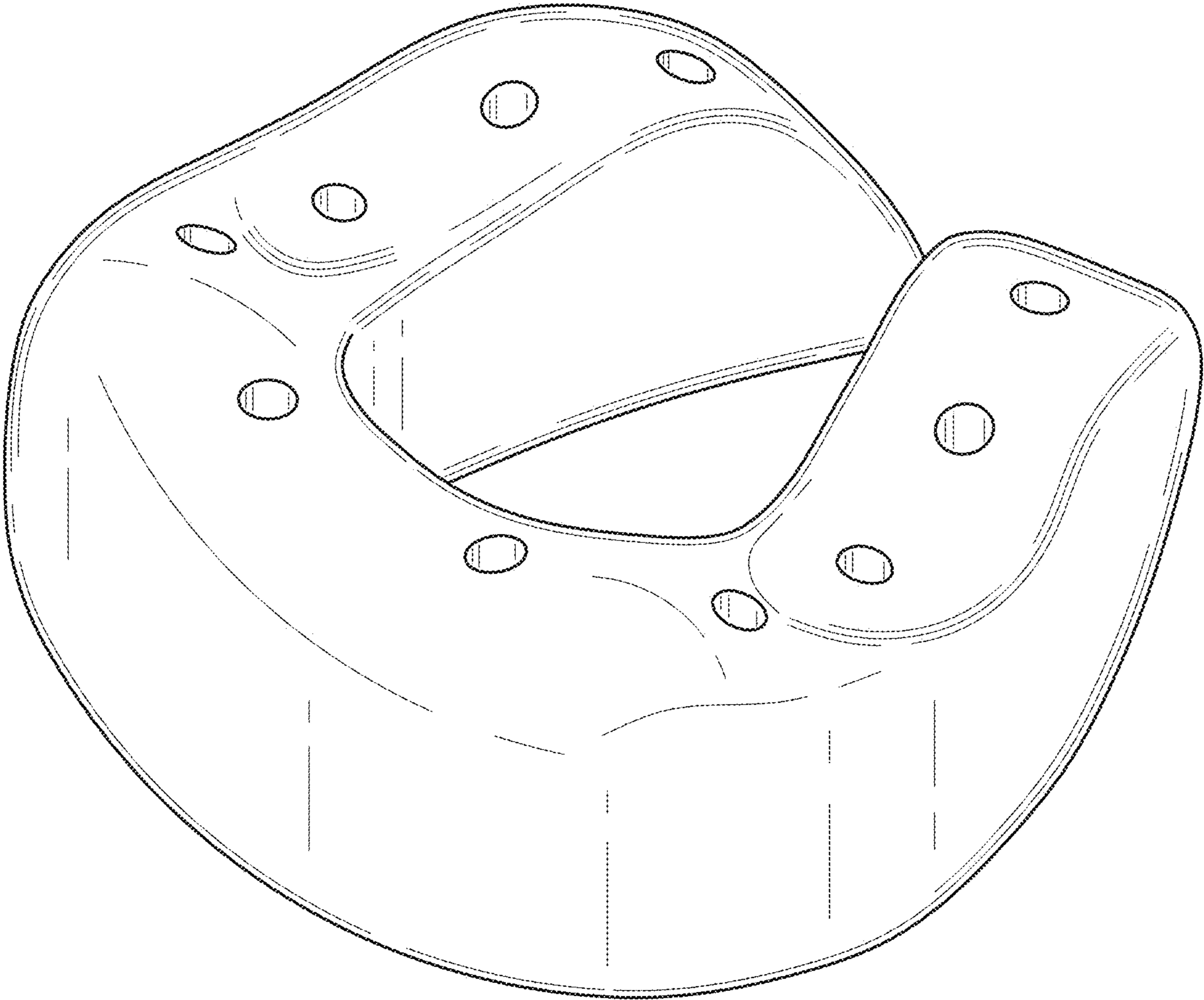

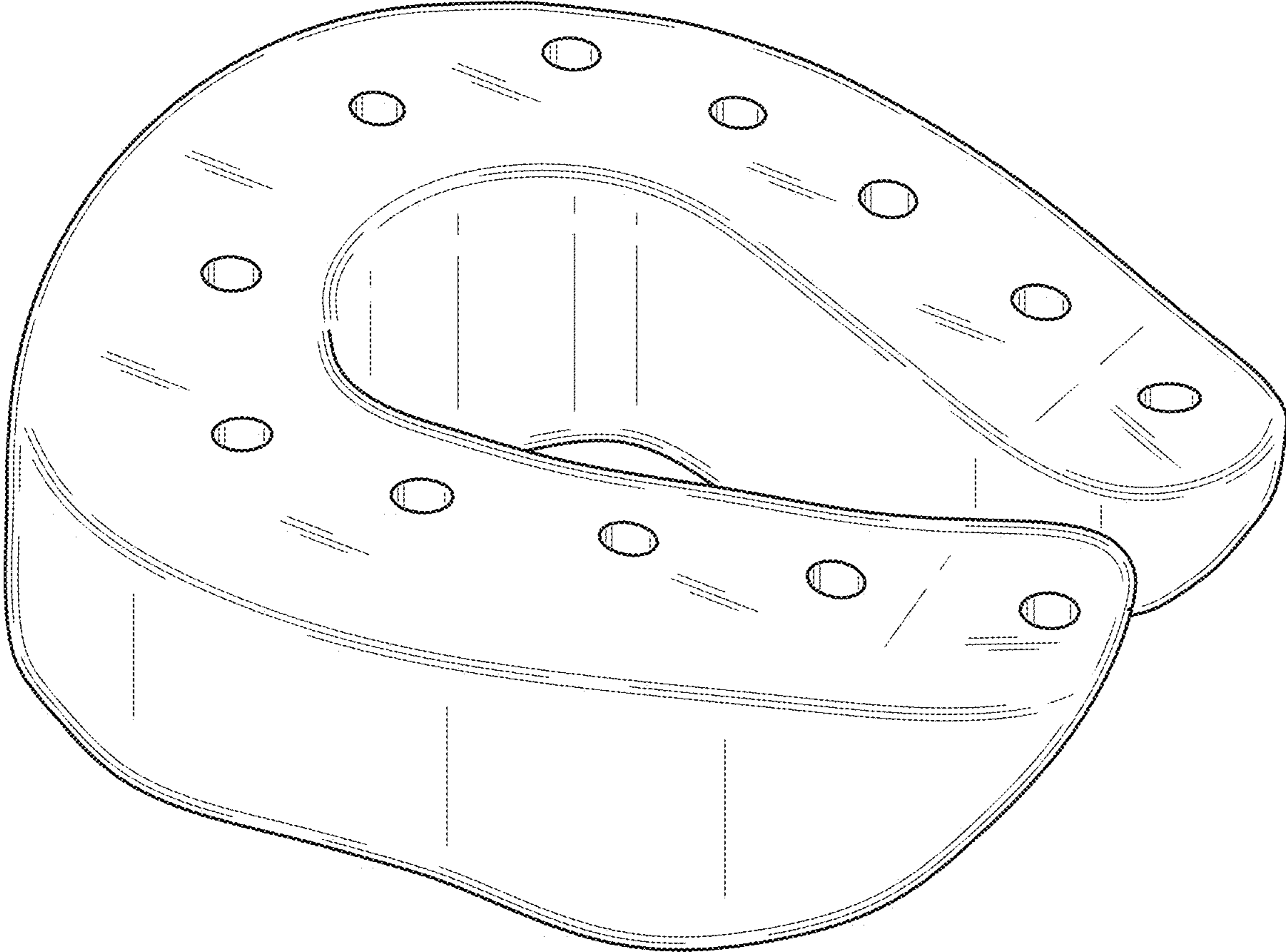

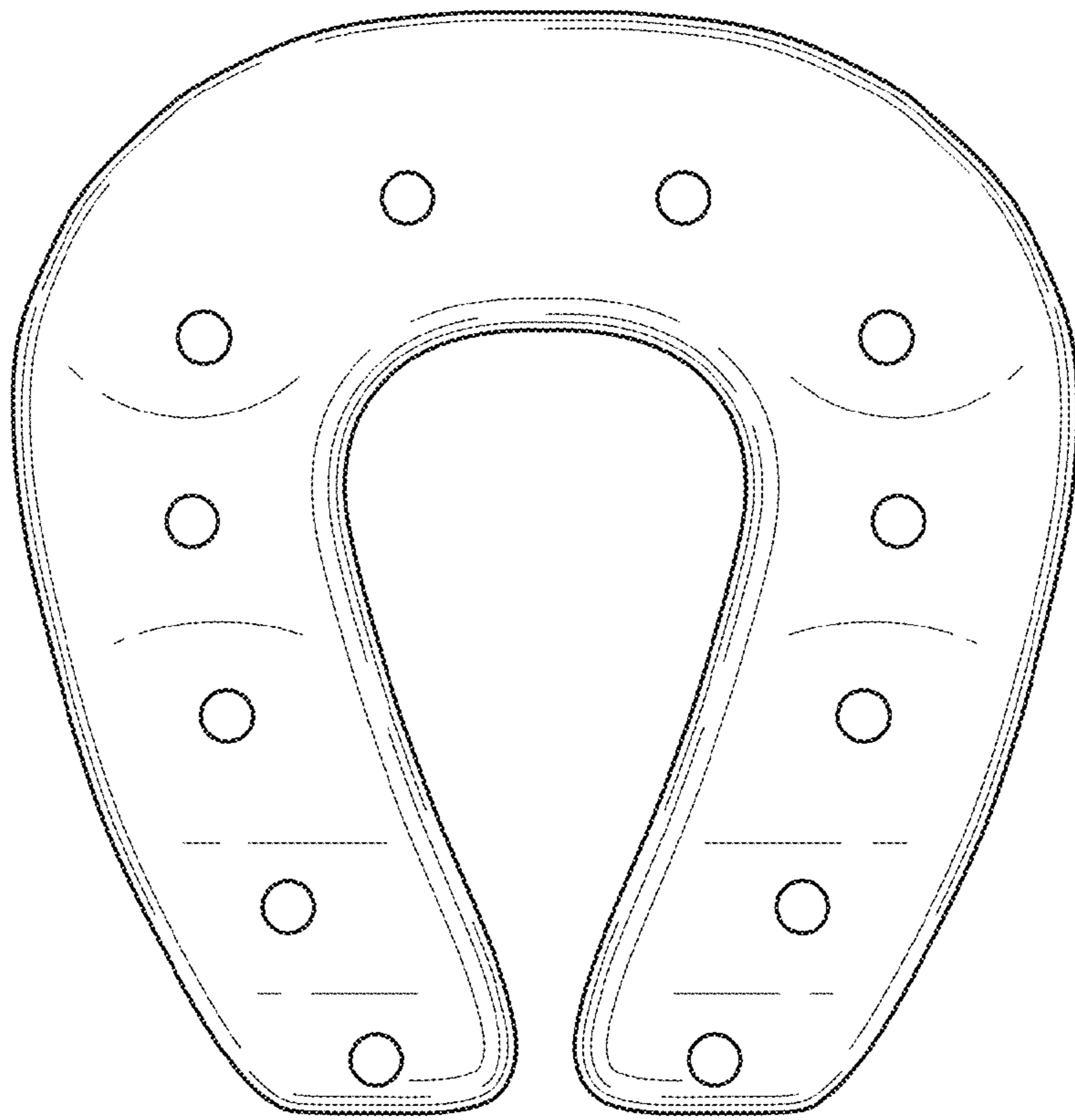

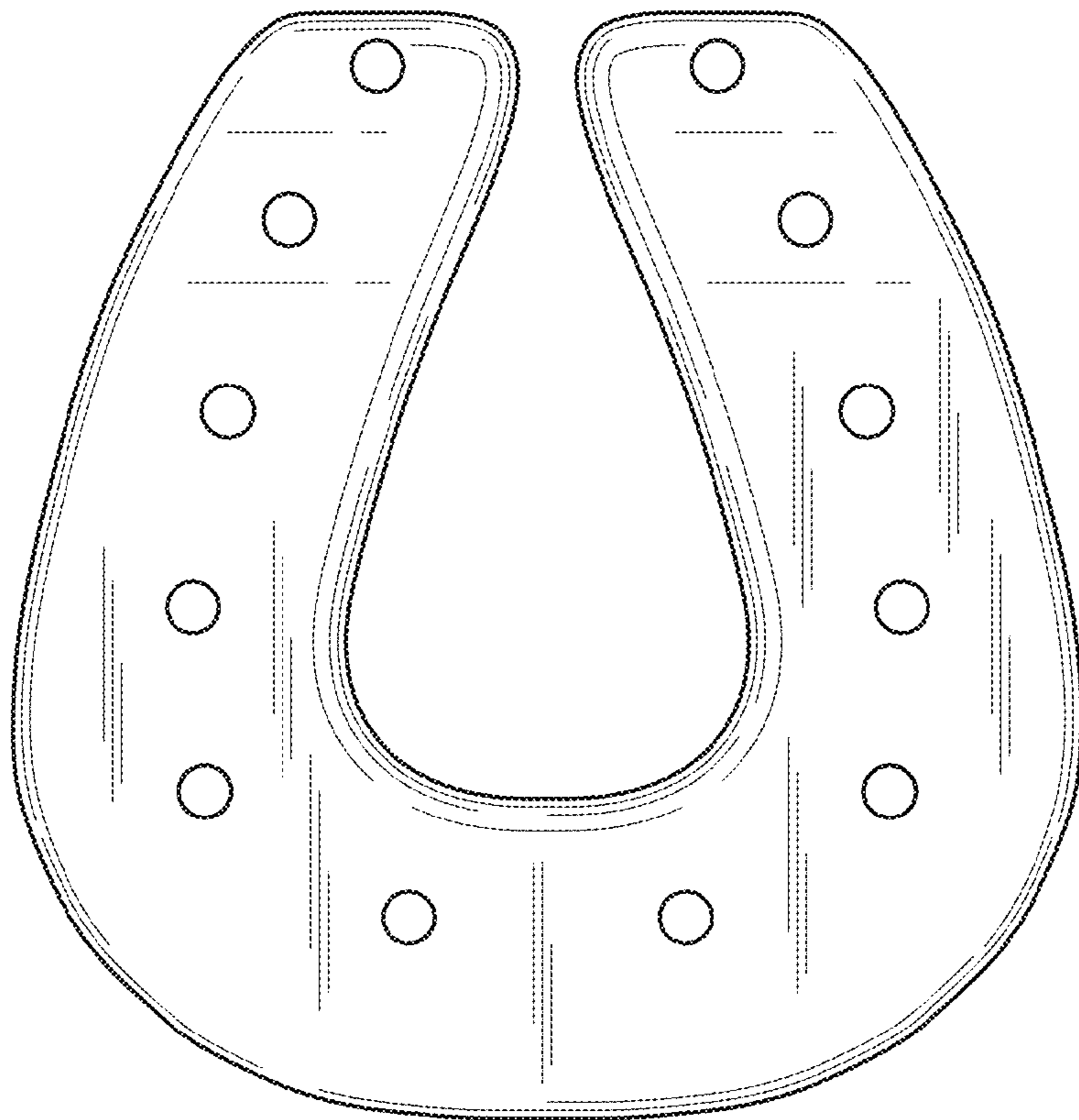

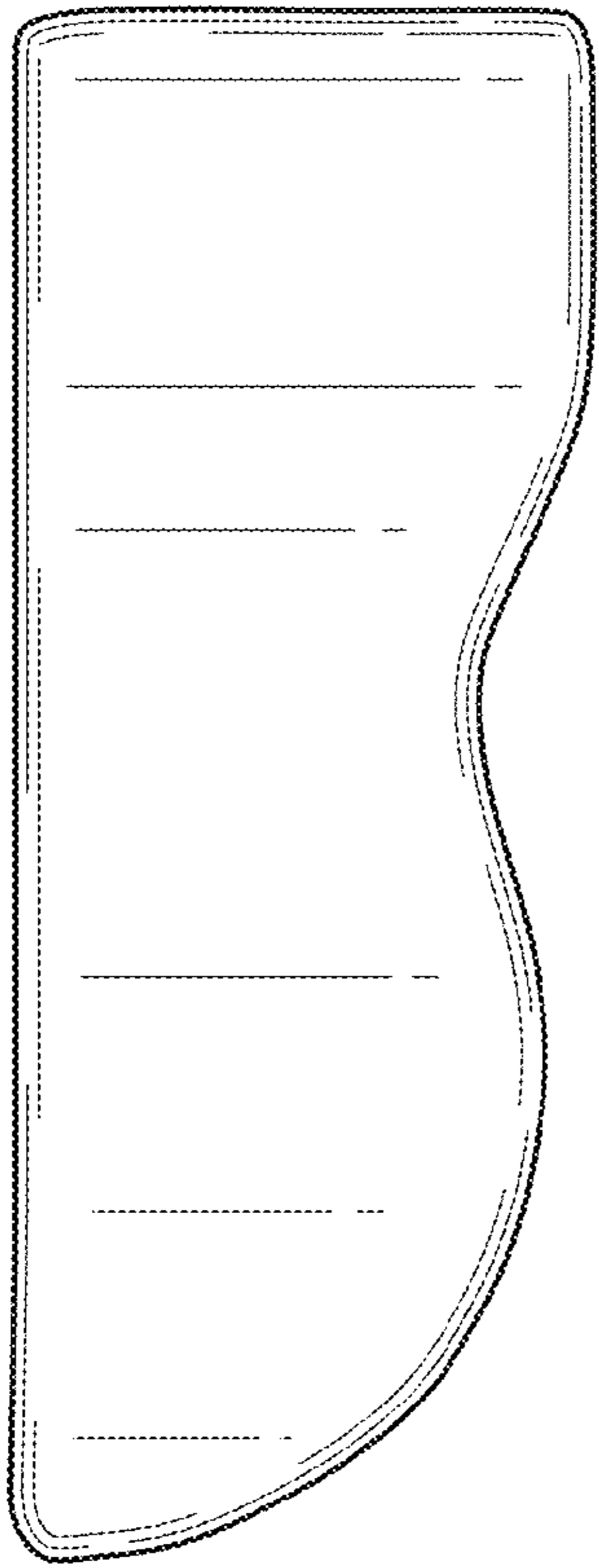

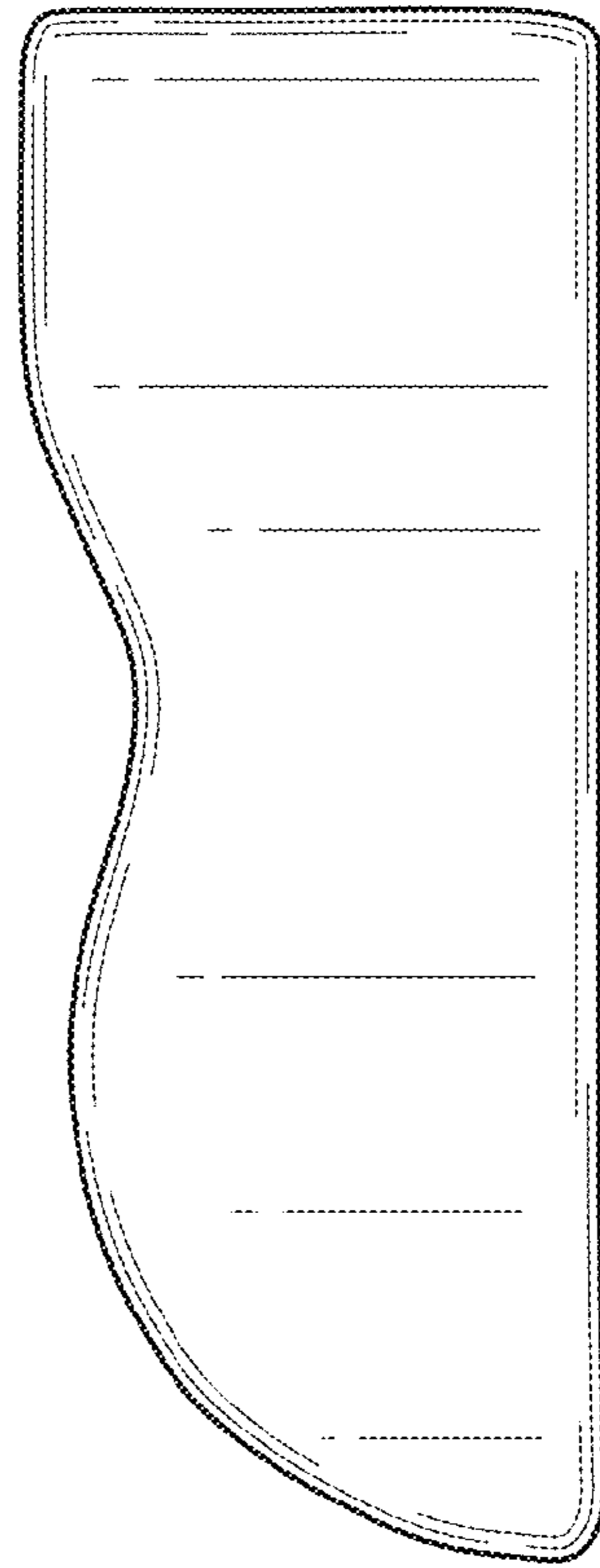

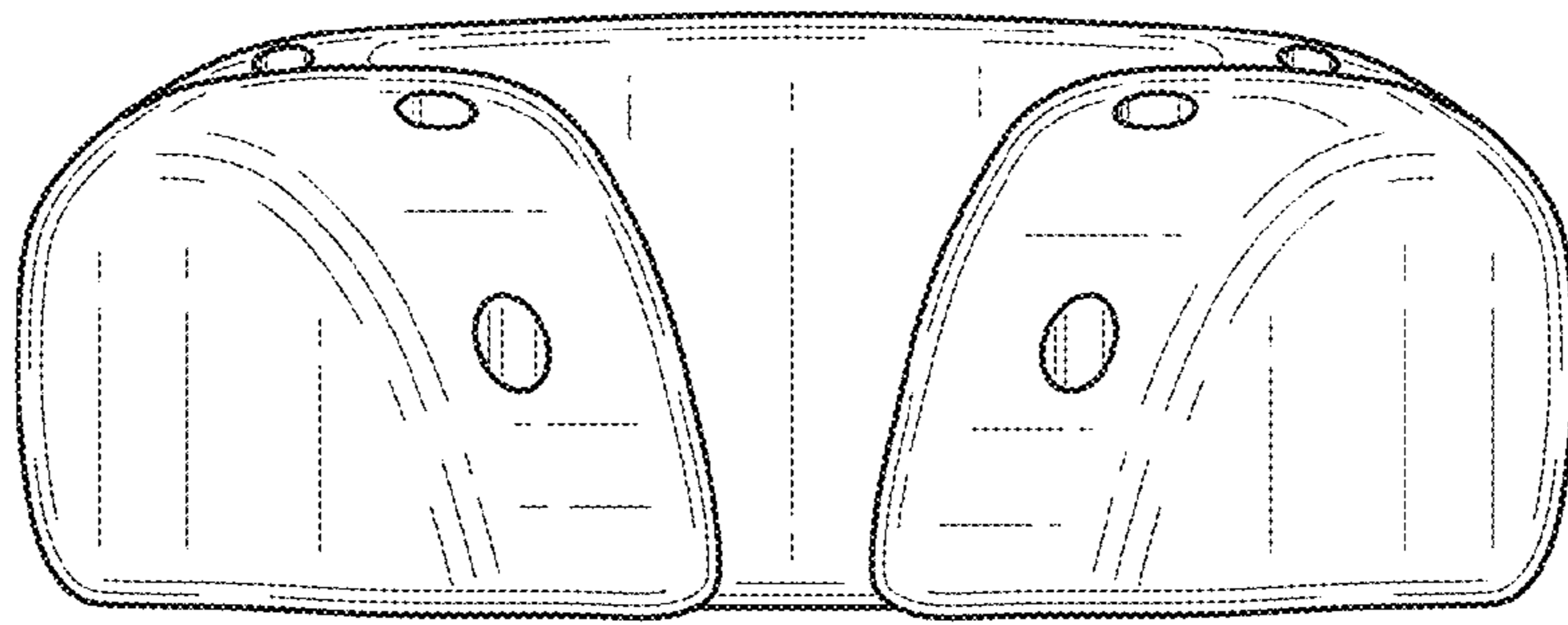

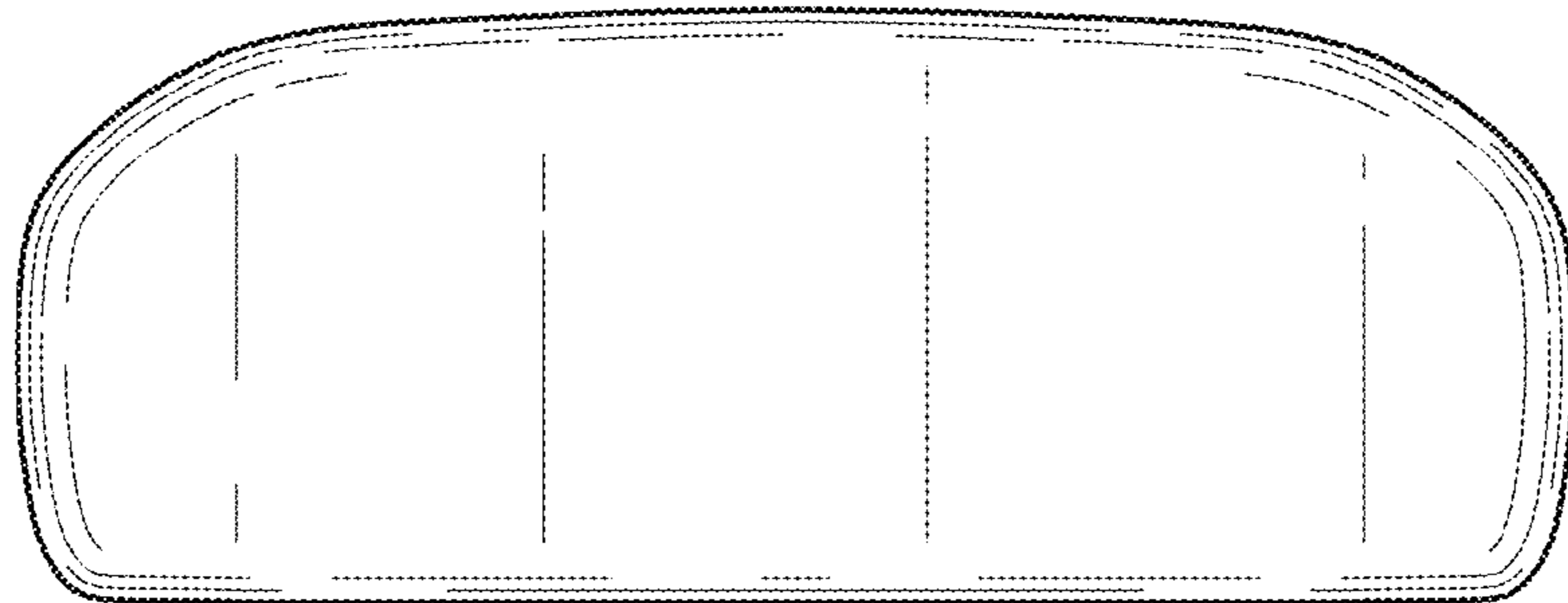
