The ornamental design for a wearable pillow, as shown and described.

DESCRIPTION

FIG. 10 is a left side view of the design as shown in FIG. 7;

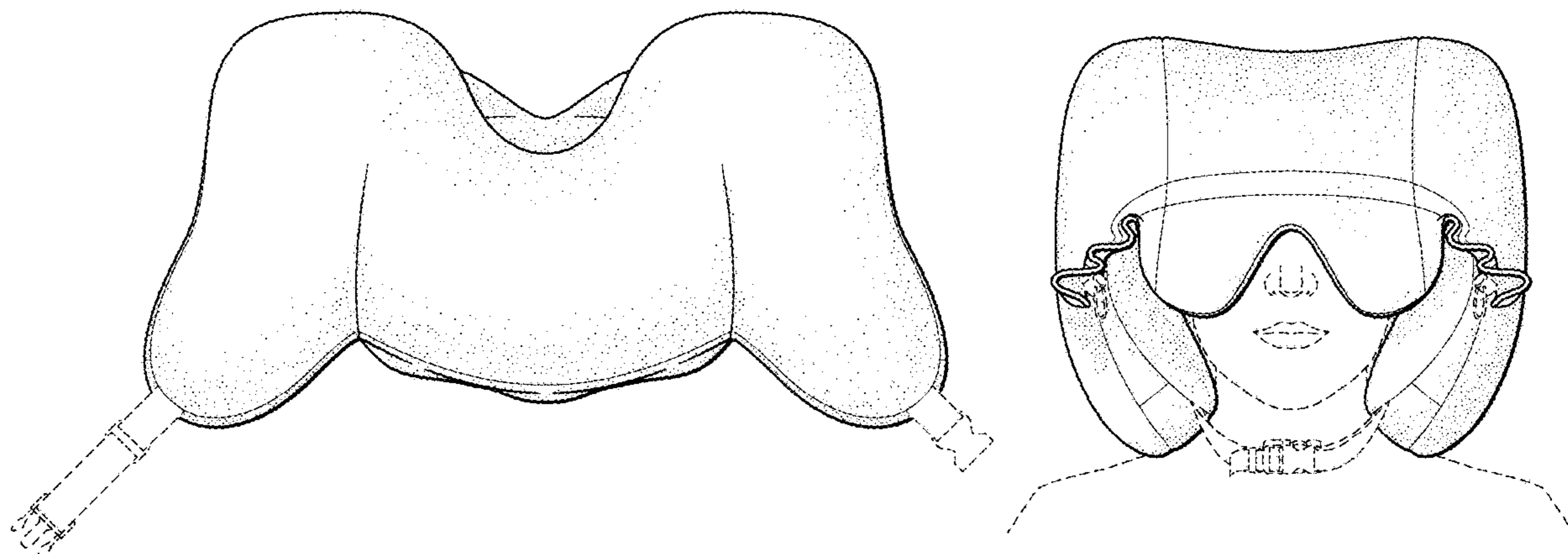
FIG. 11 is a top view of the design as shown in FIG. 7;

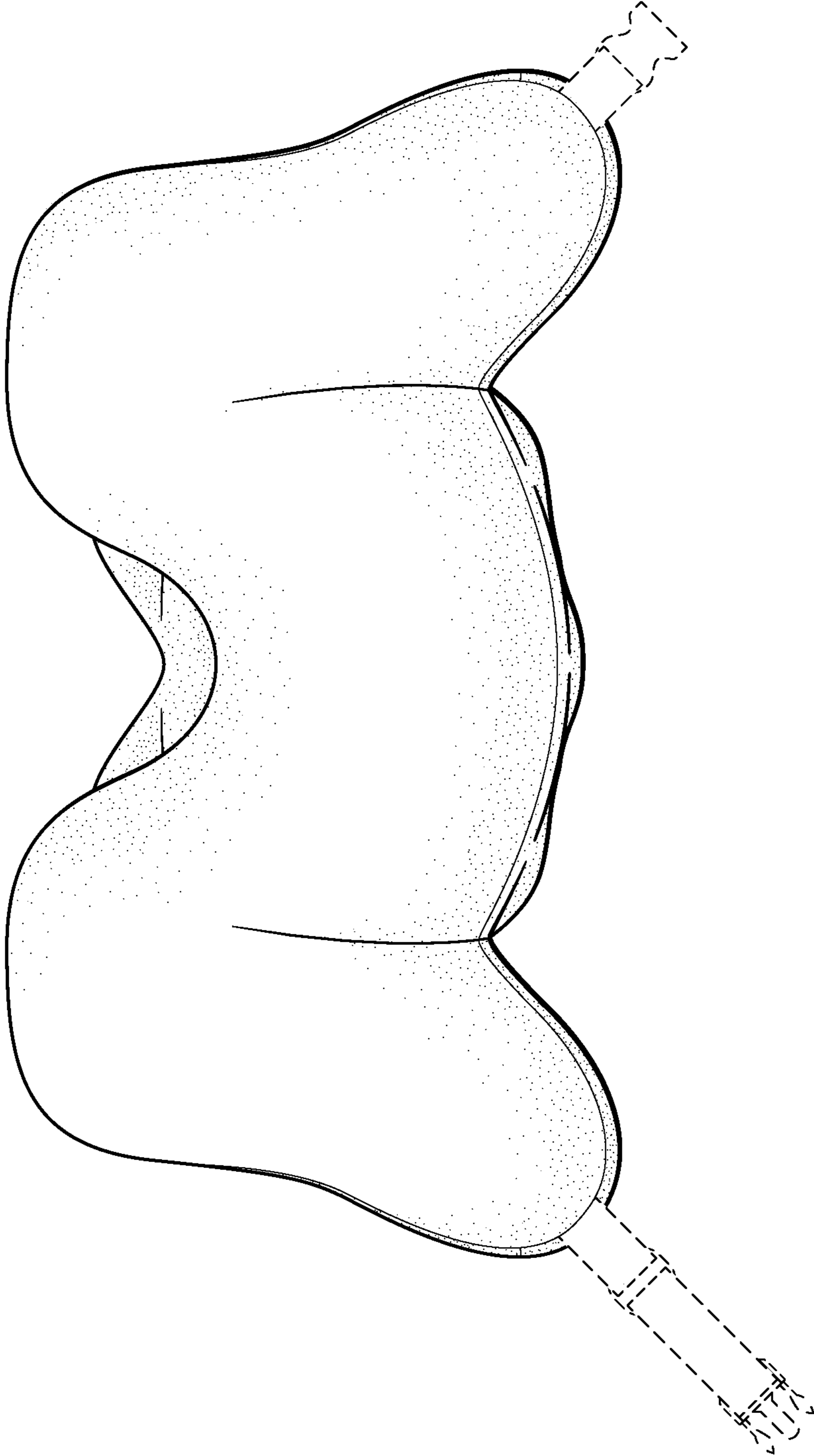

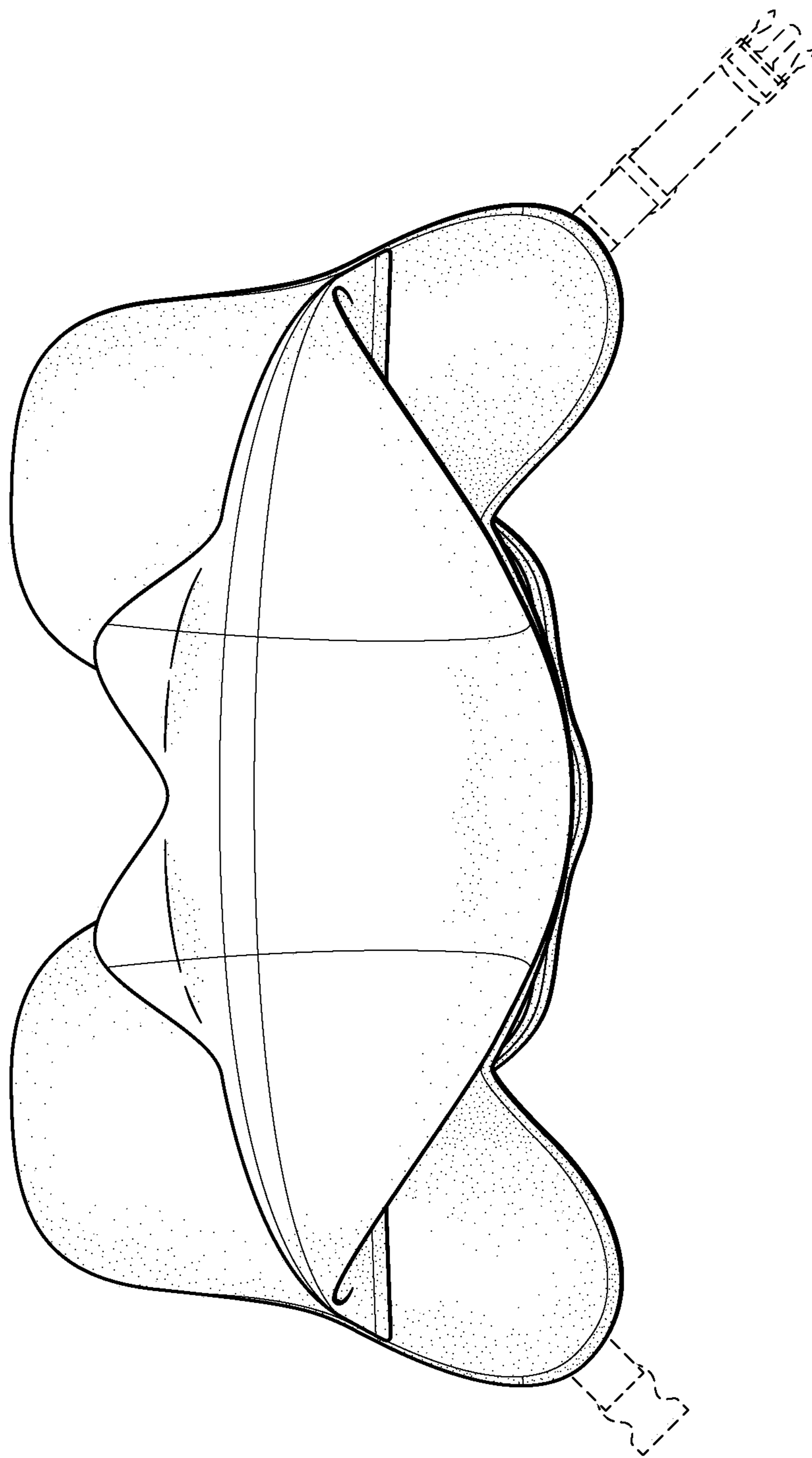

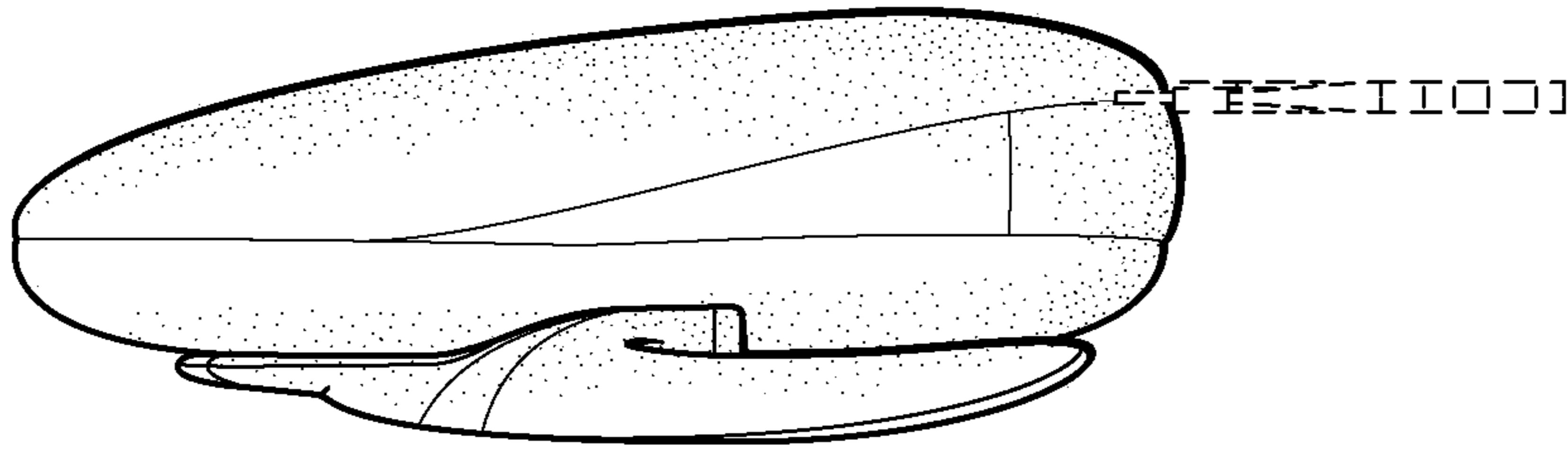

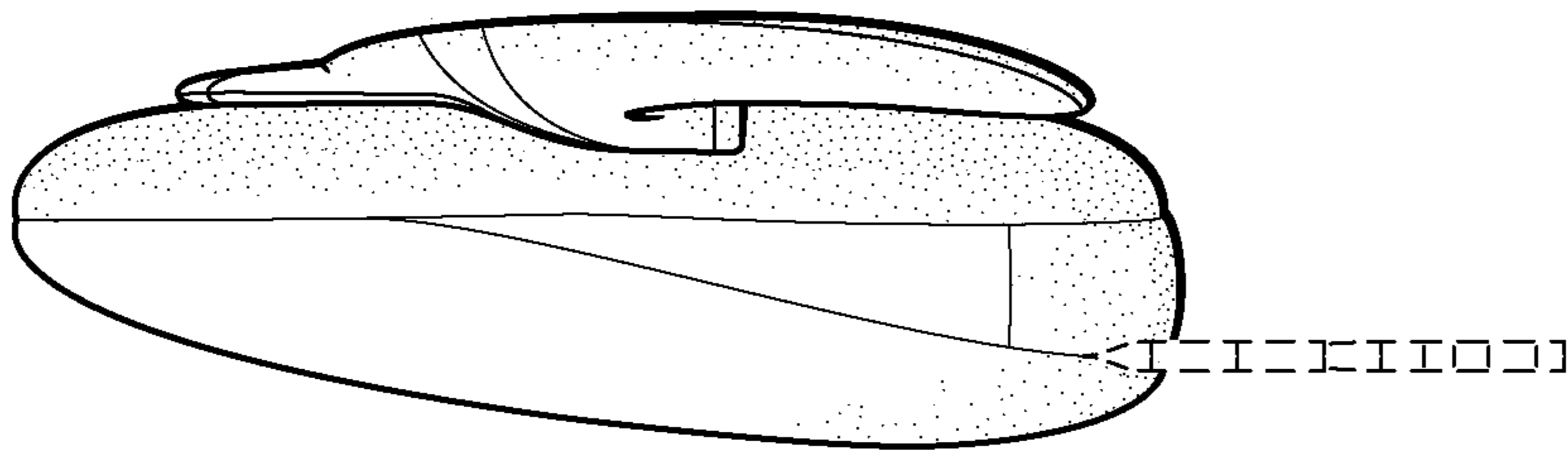

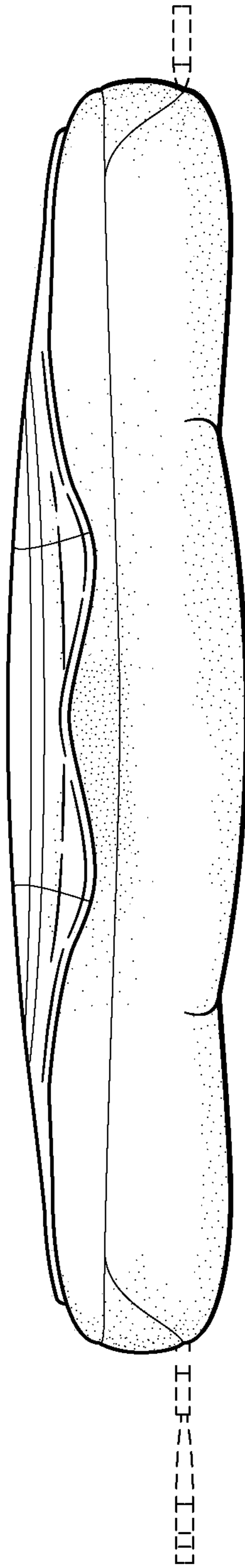

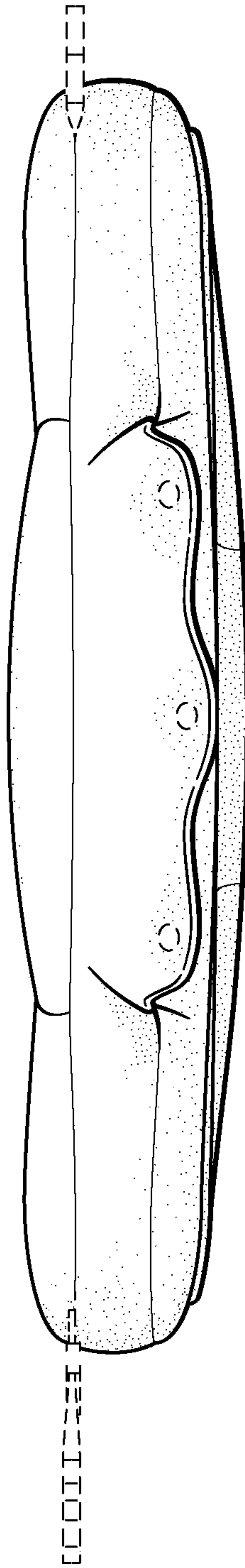

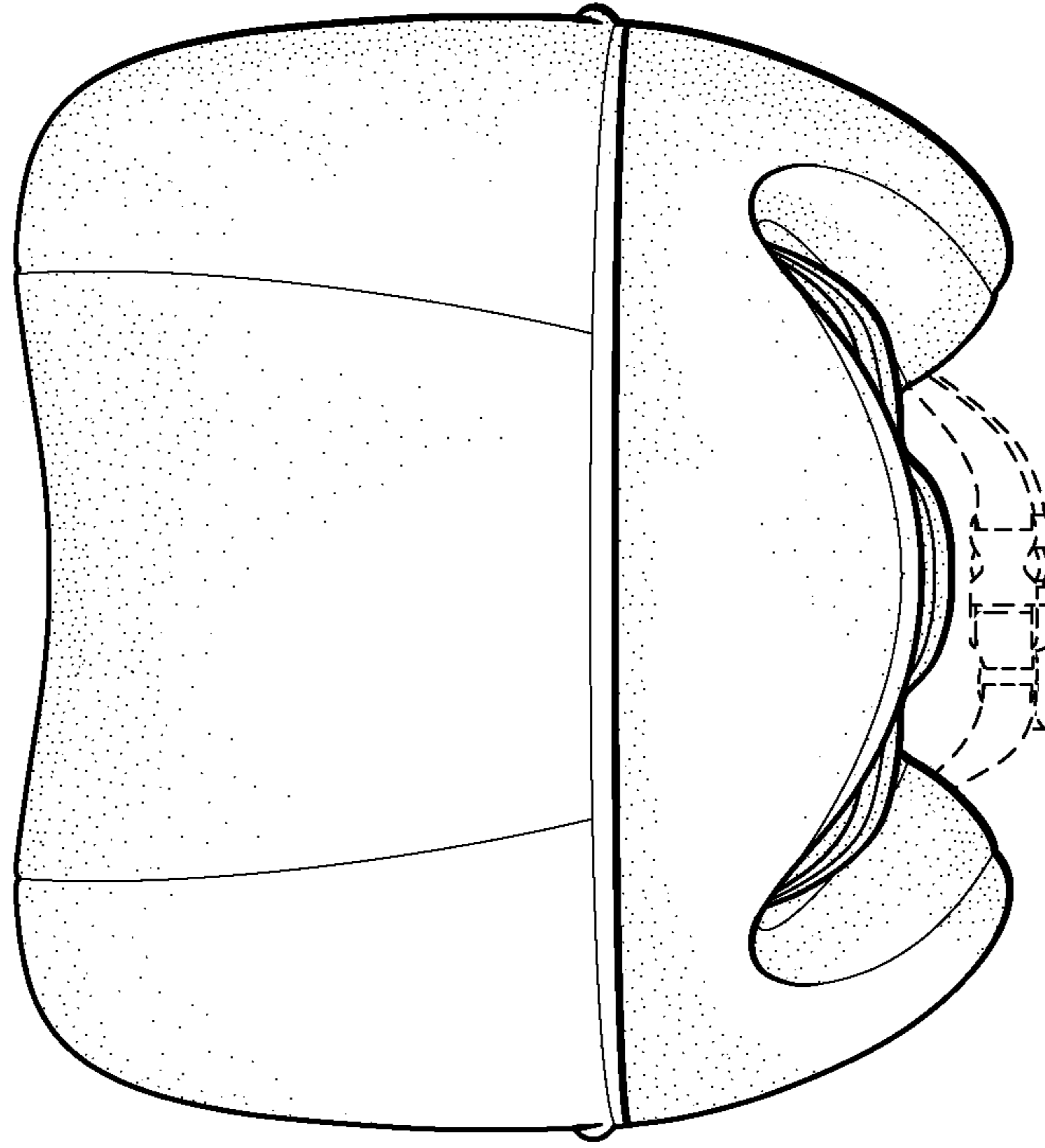

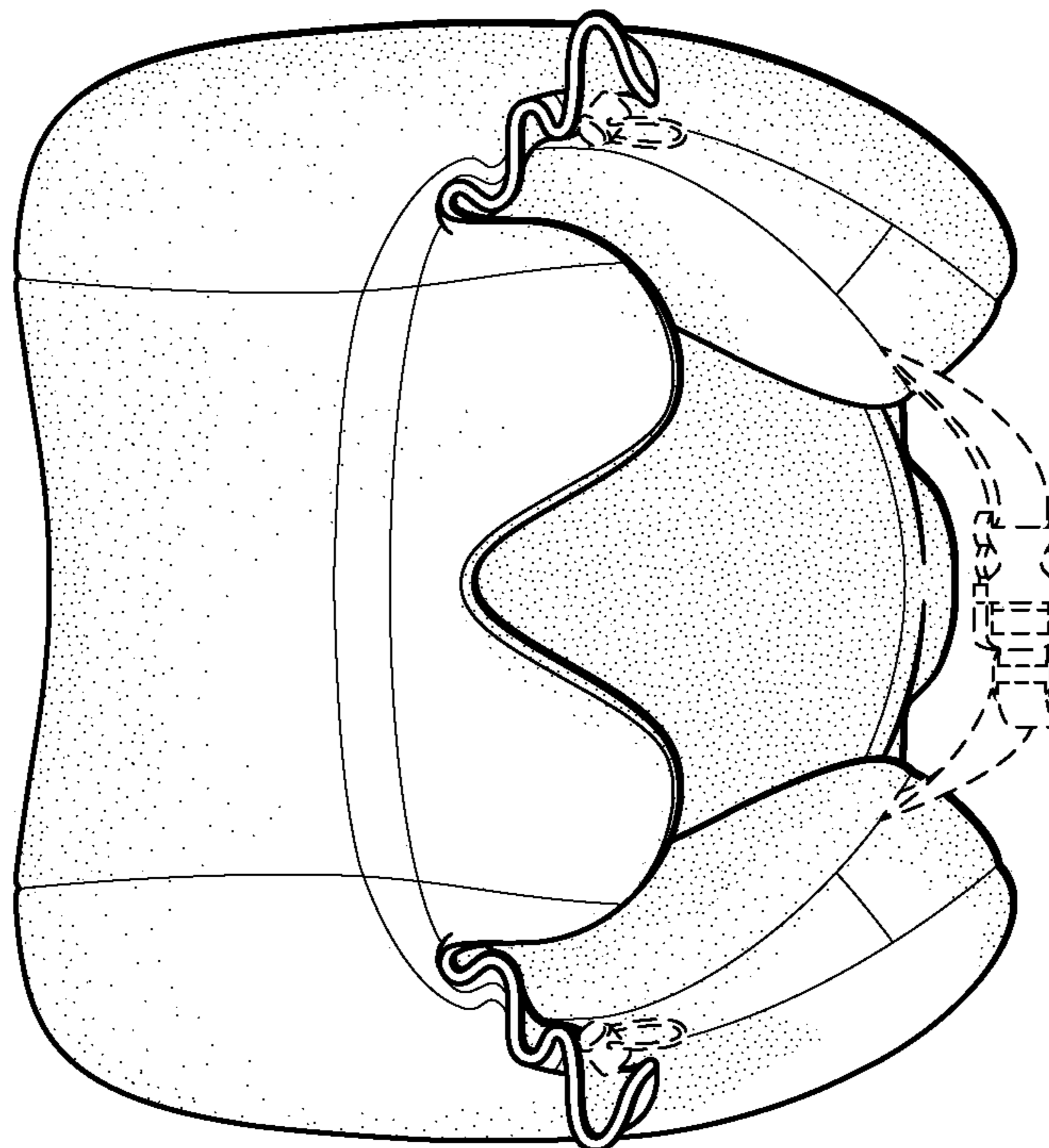

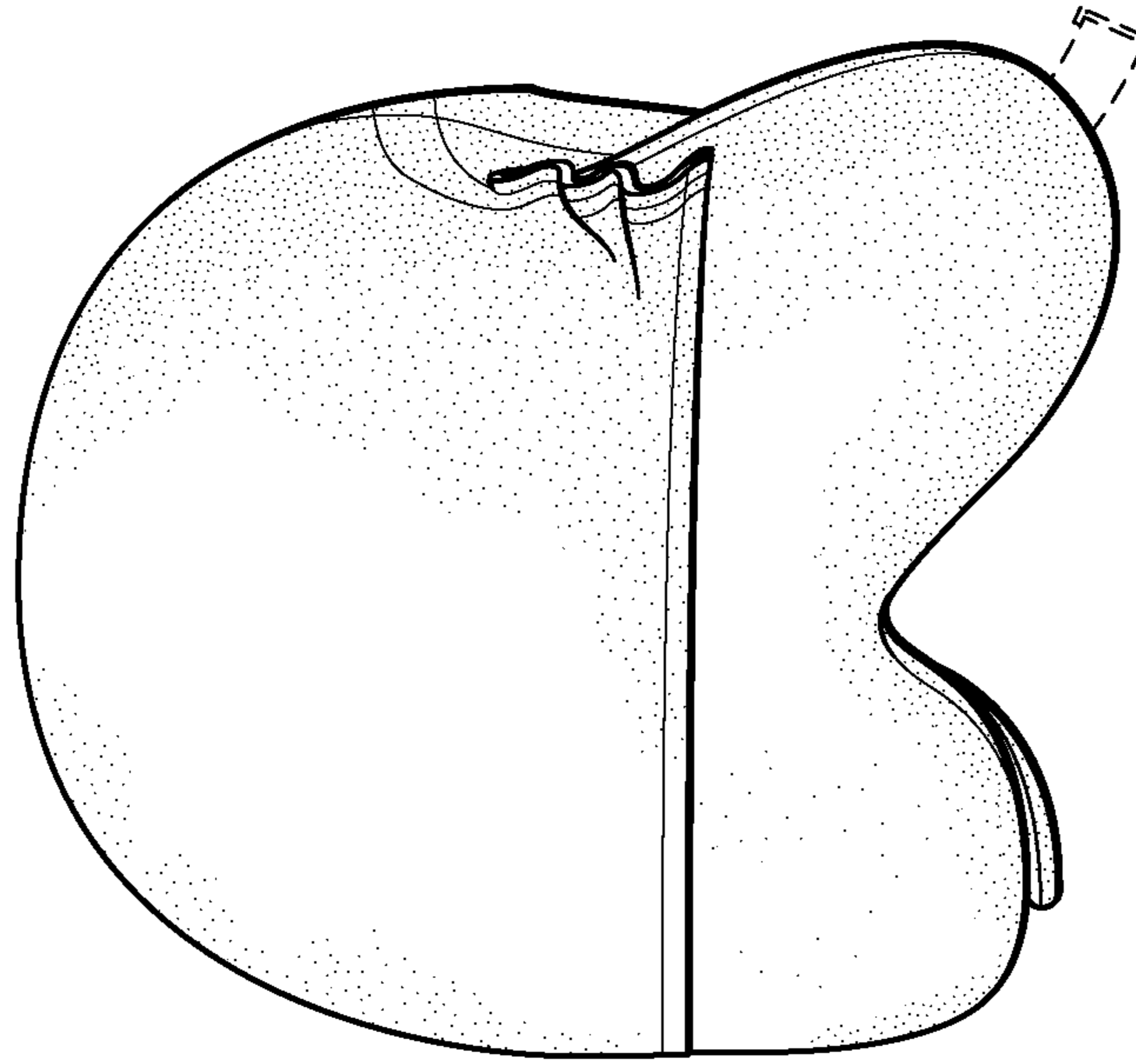

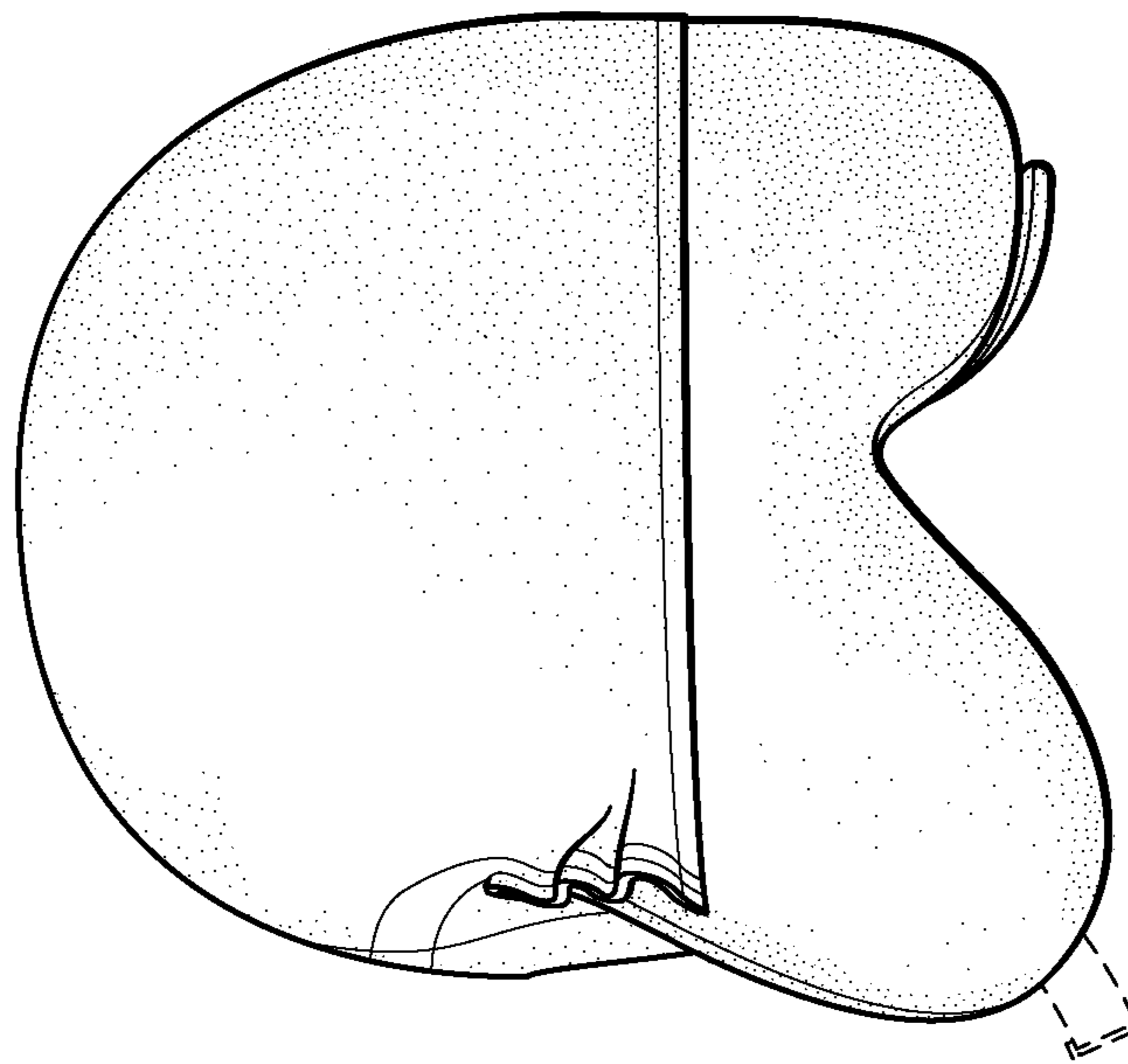

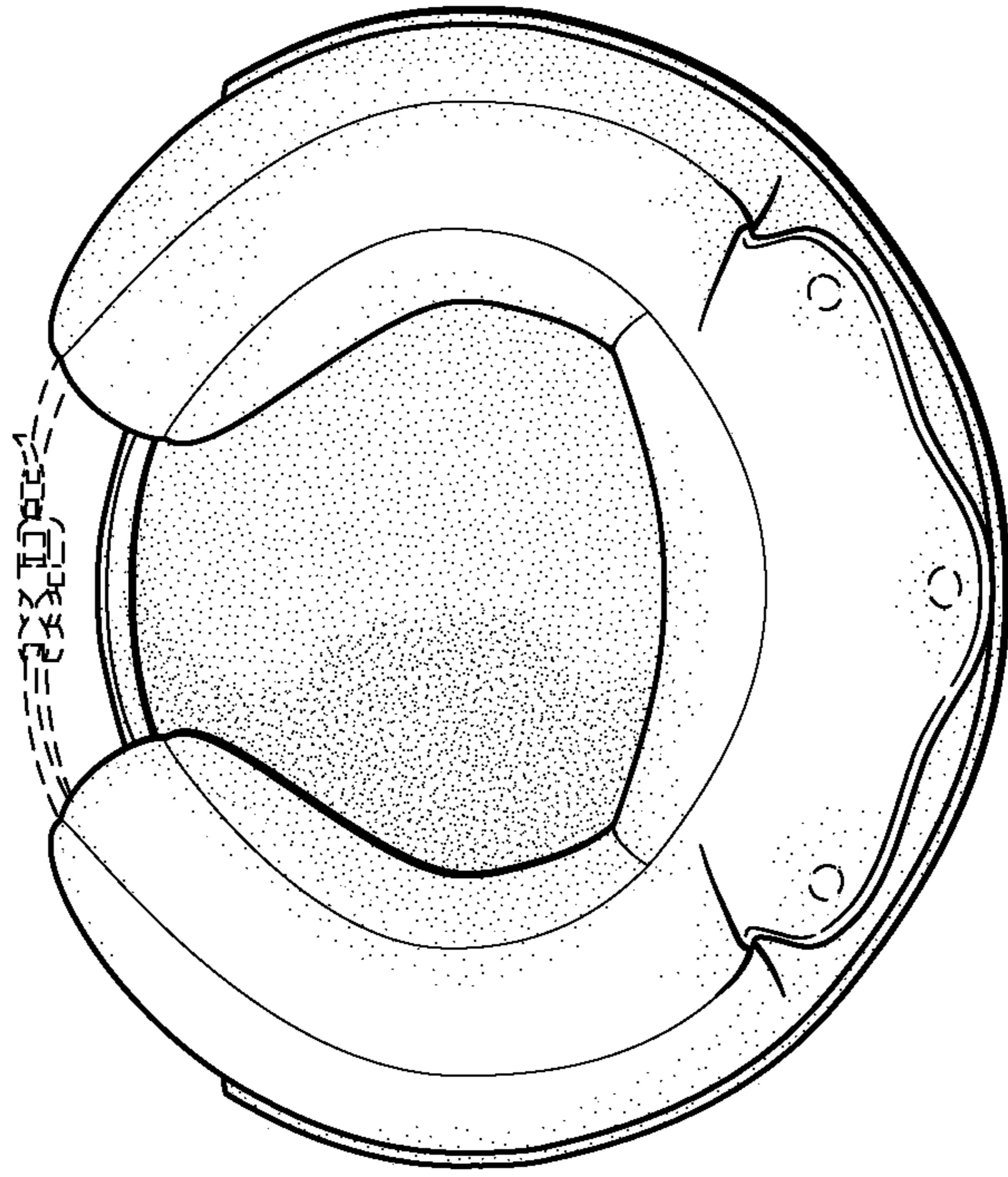

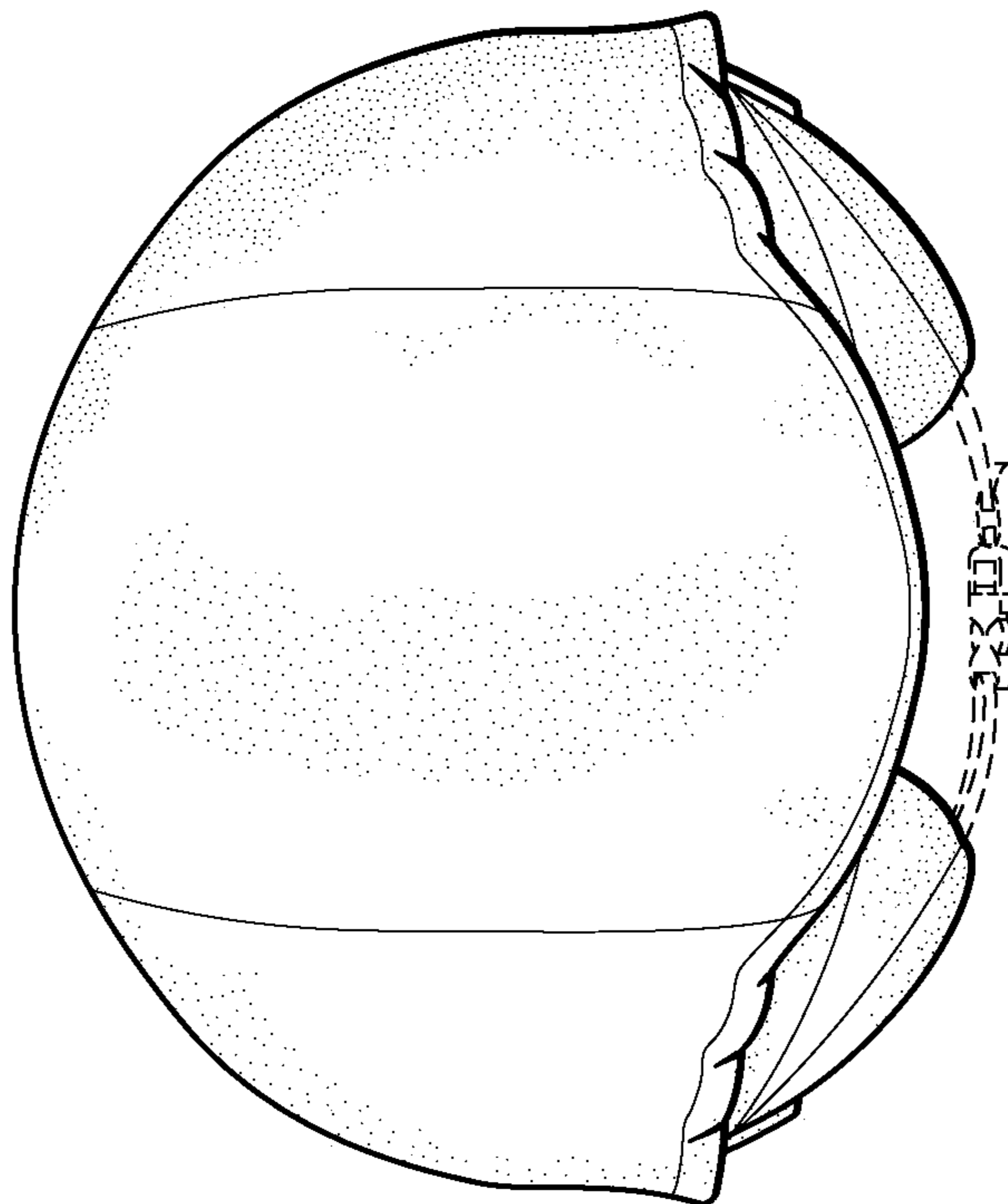

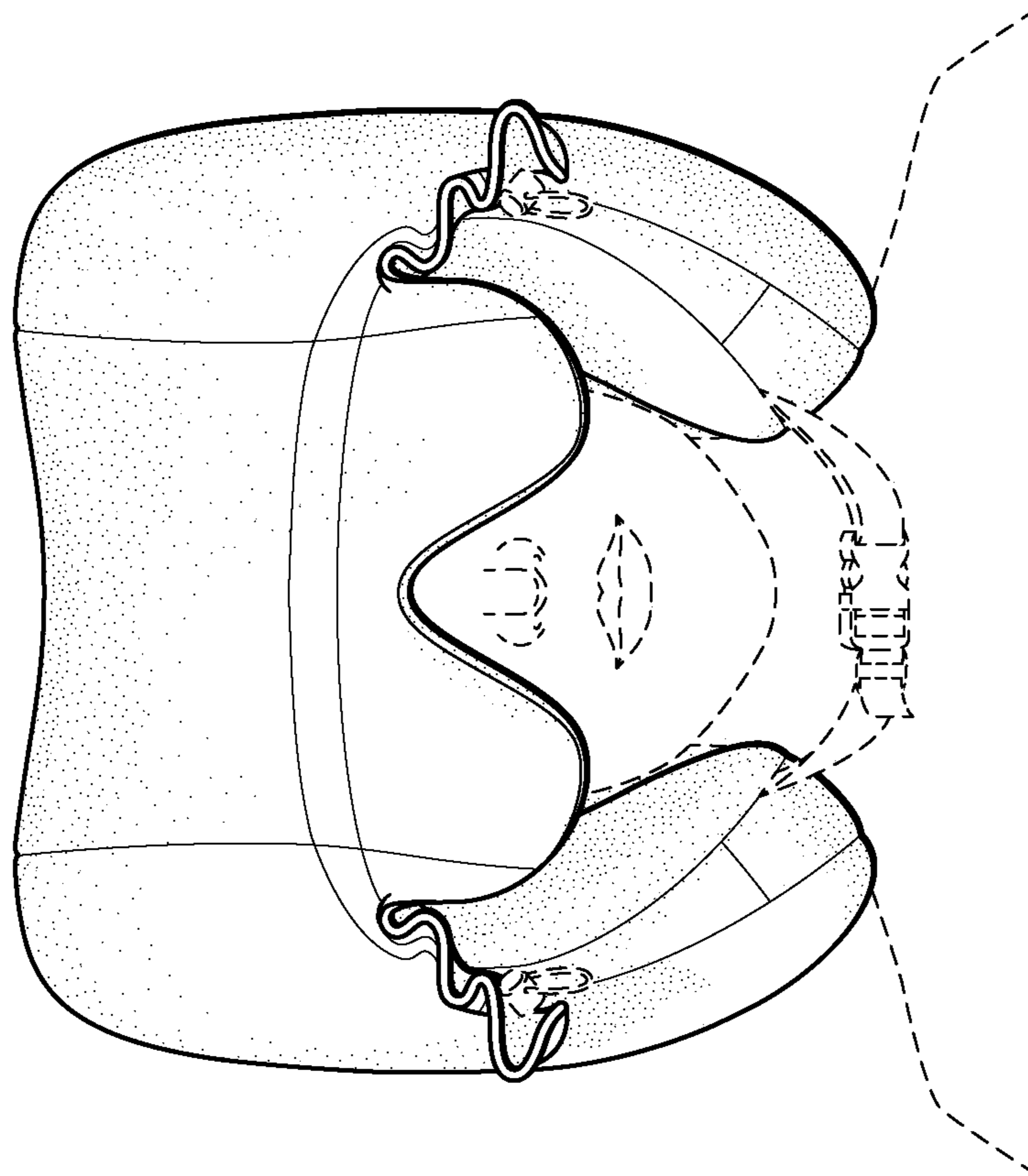
