The ornamental design for a container for food packages, as shown and described.

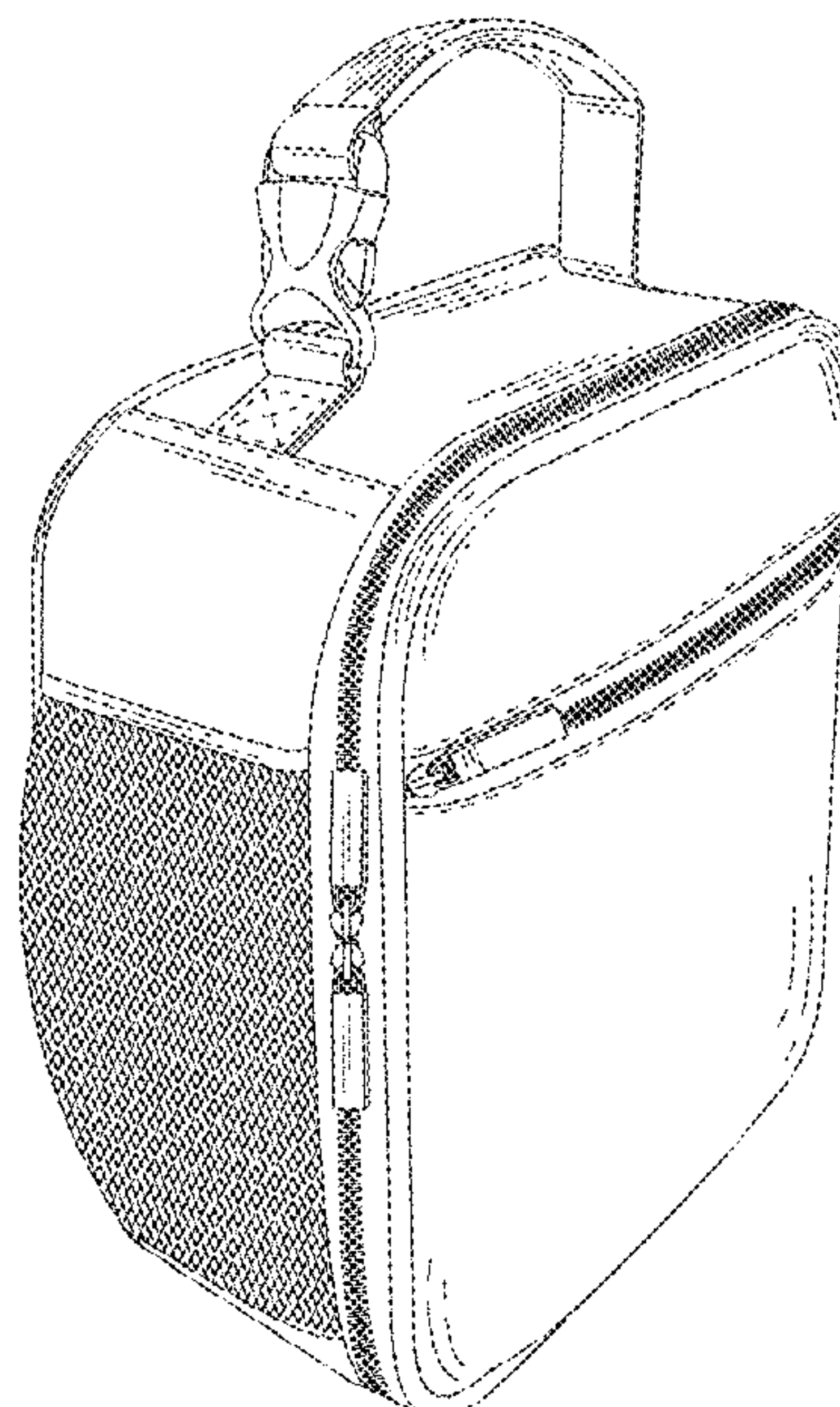
DESCRIPTION

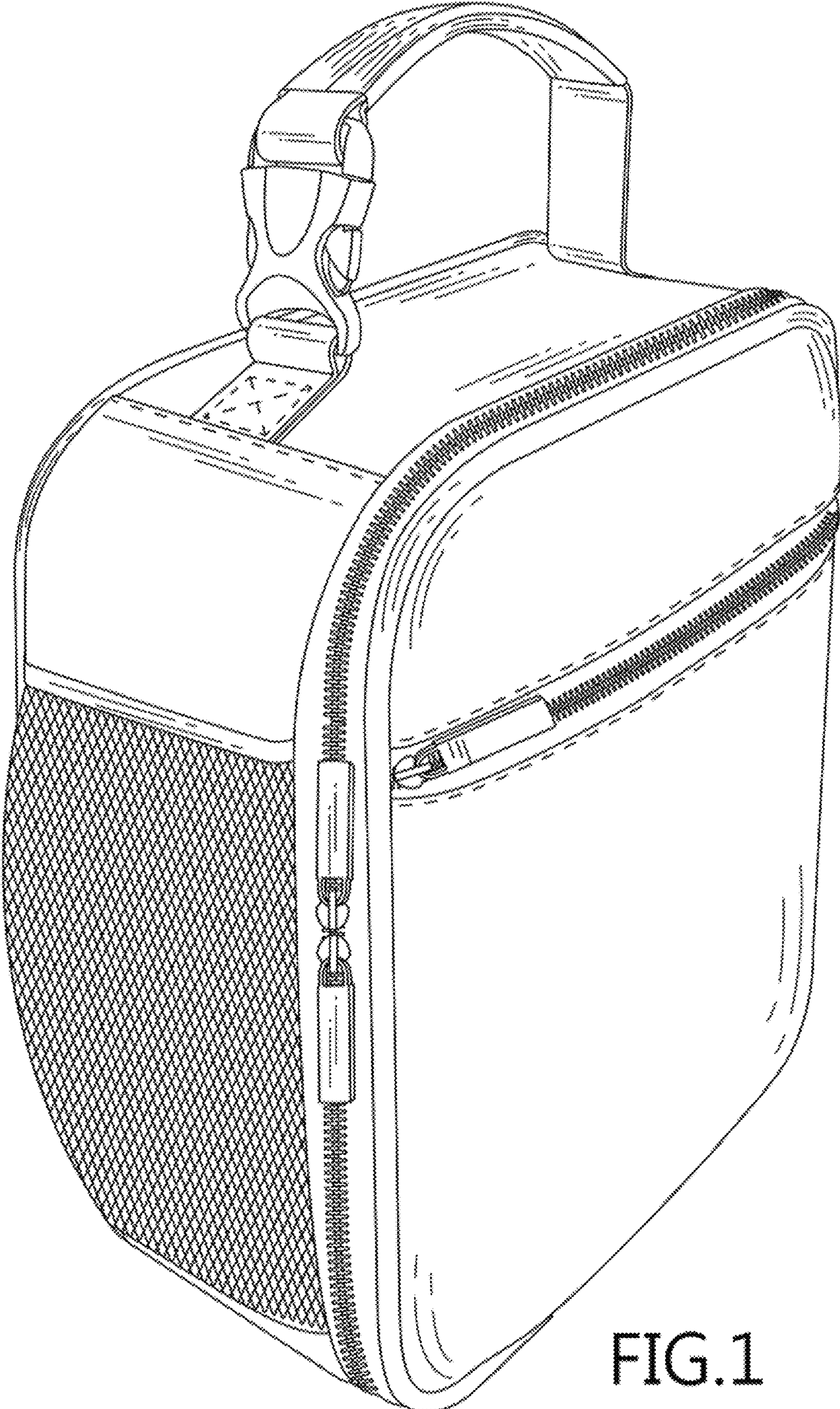

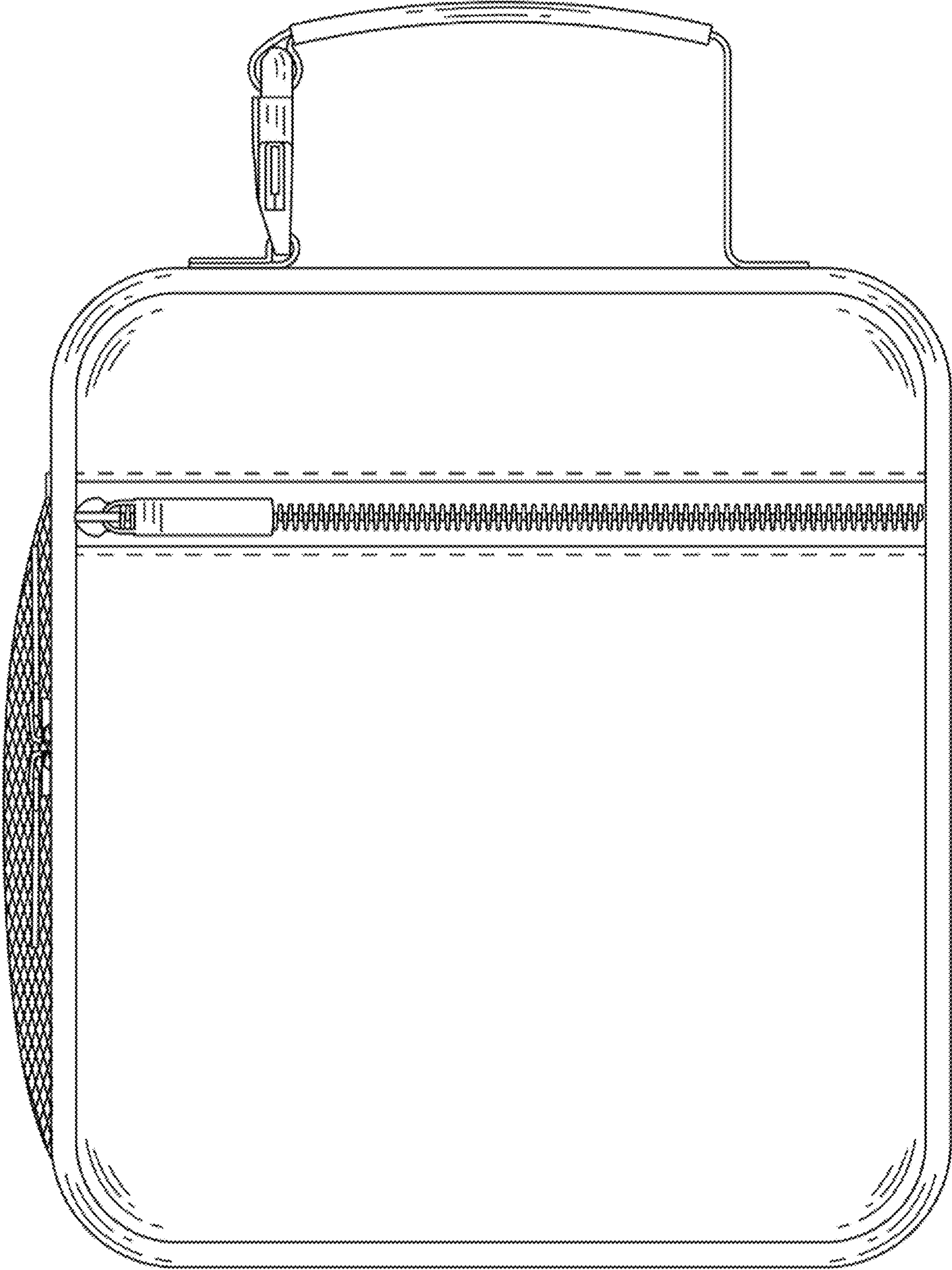

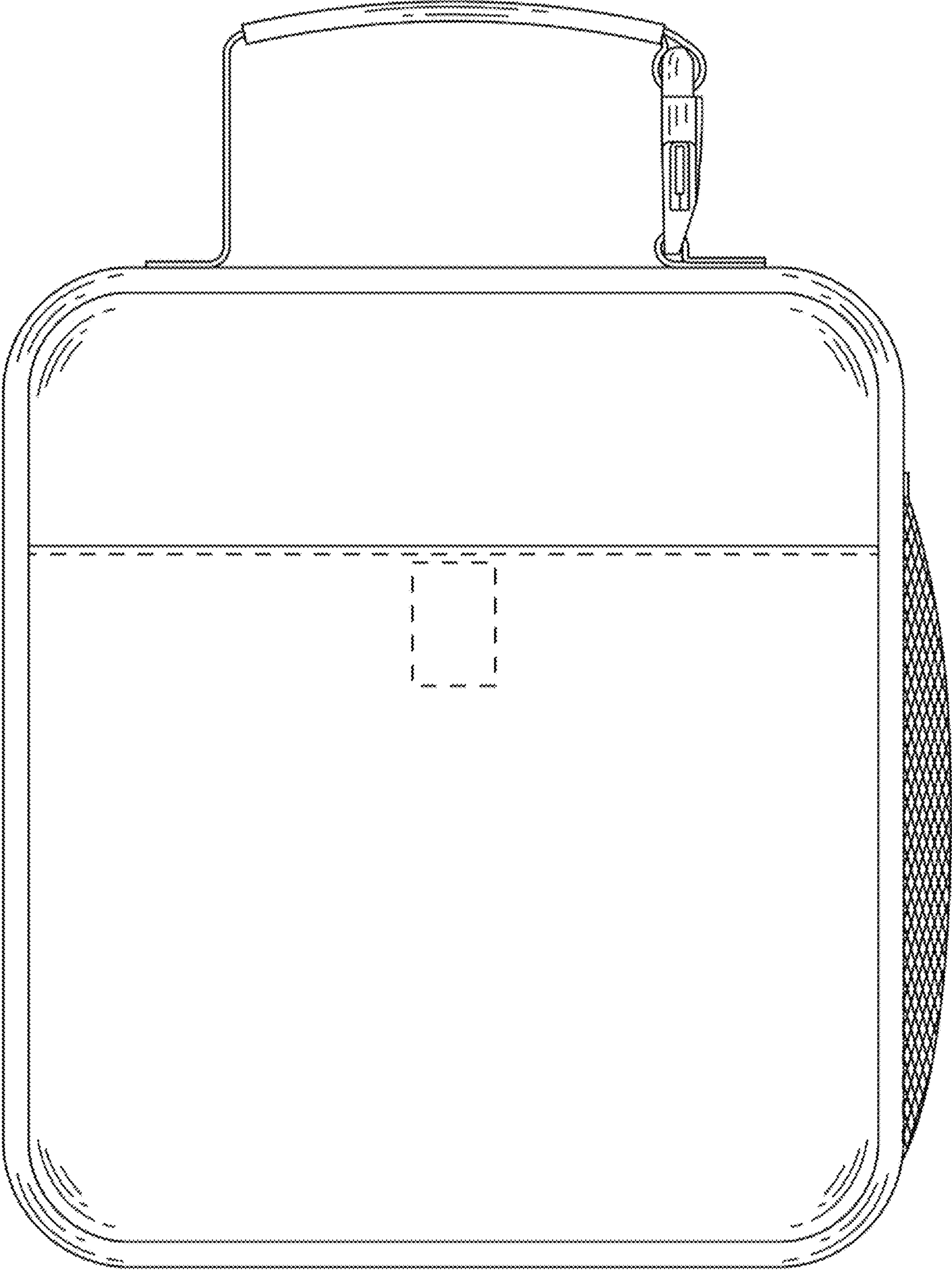

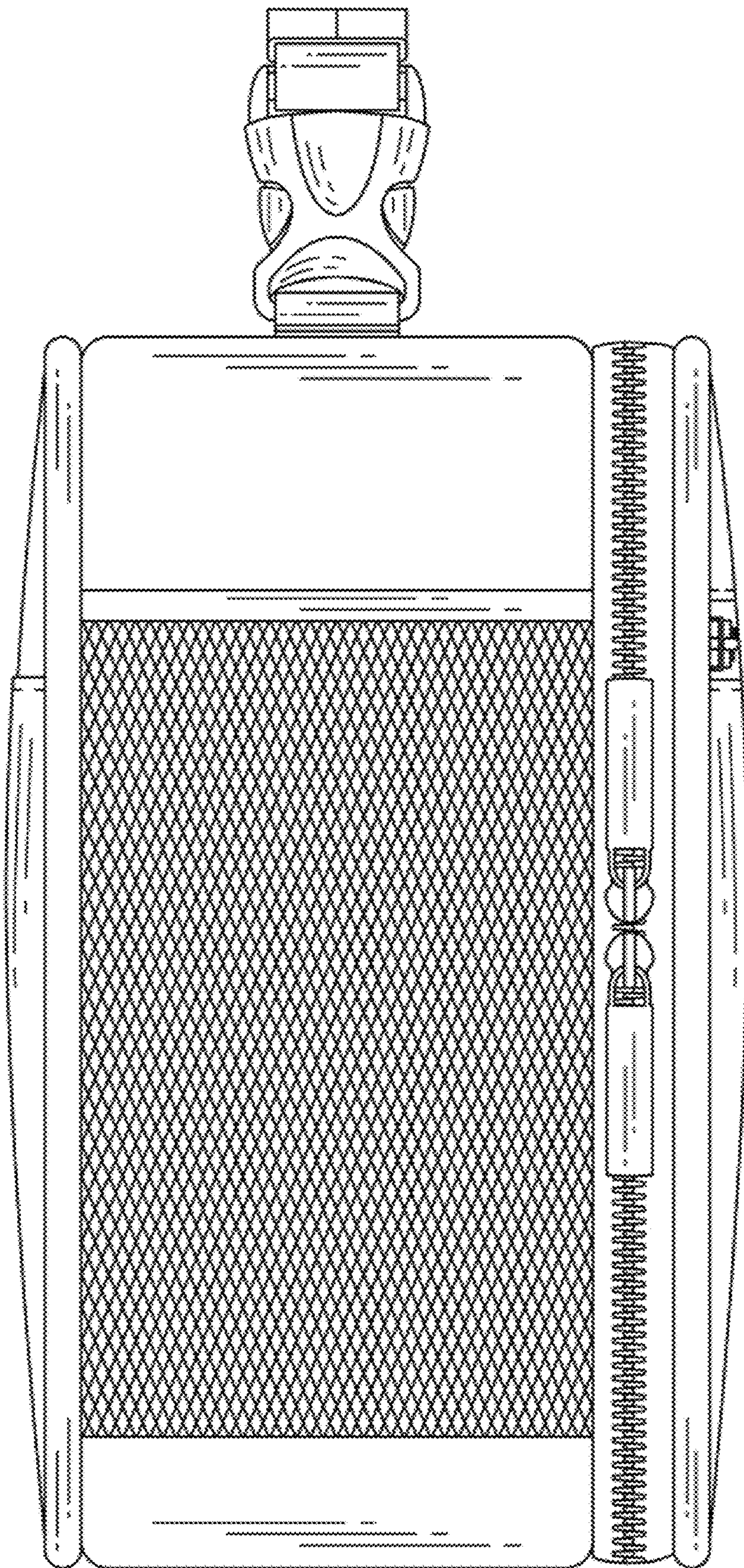

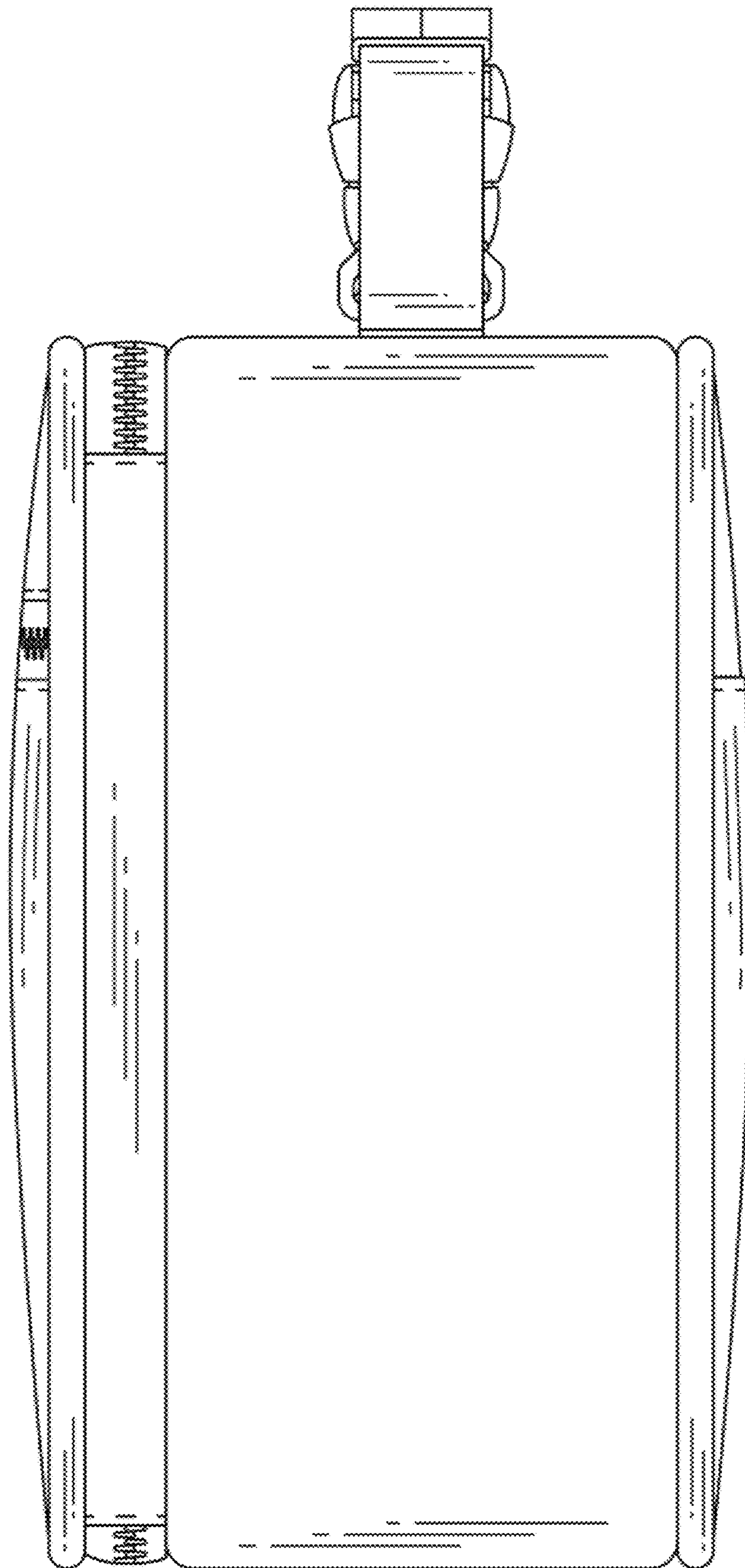

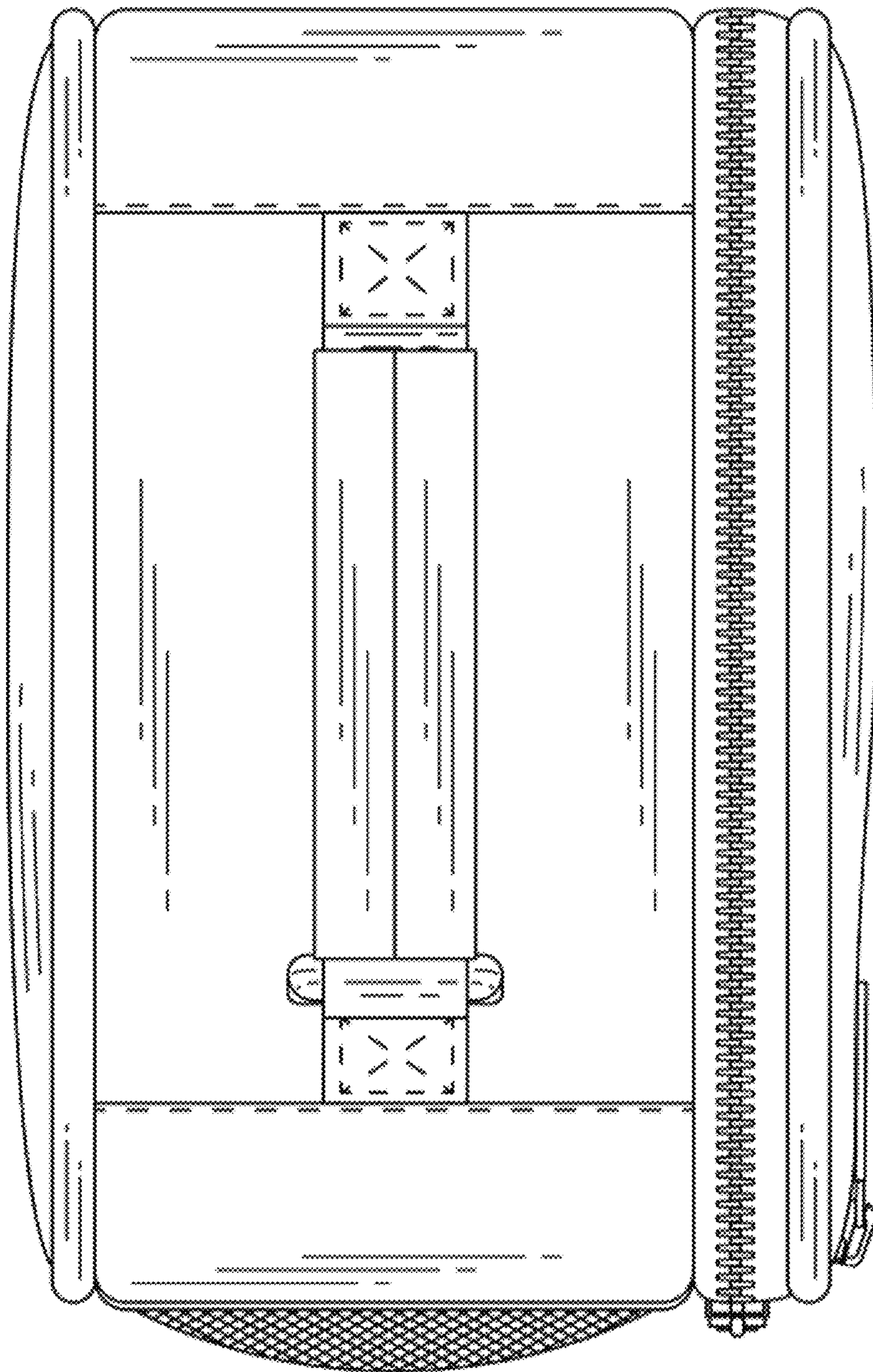

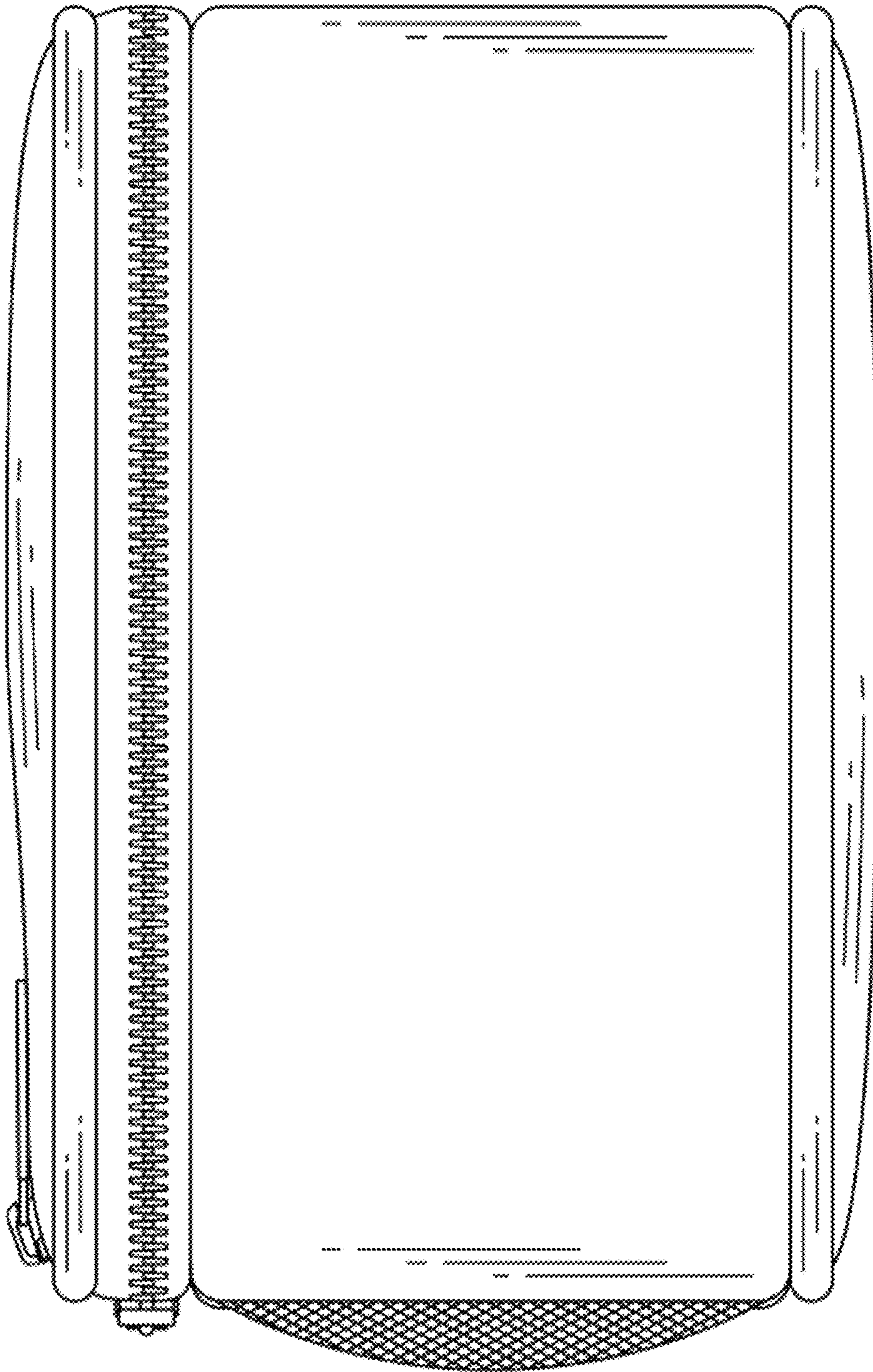
