FIG. 18 is a back view thereof; and

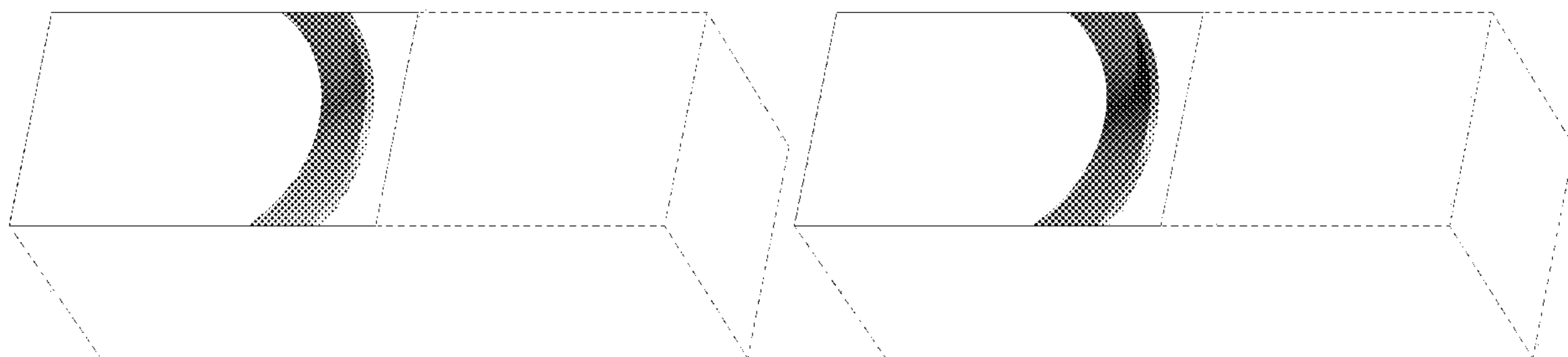
FIG. 19 is a left side view thereof;

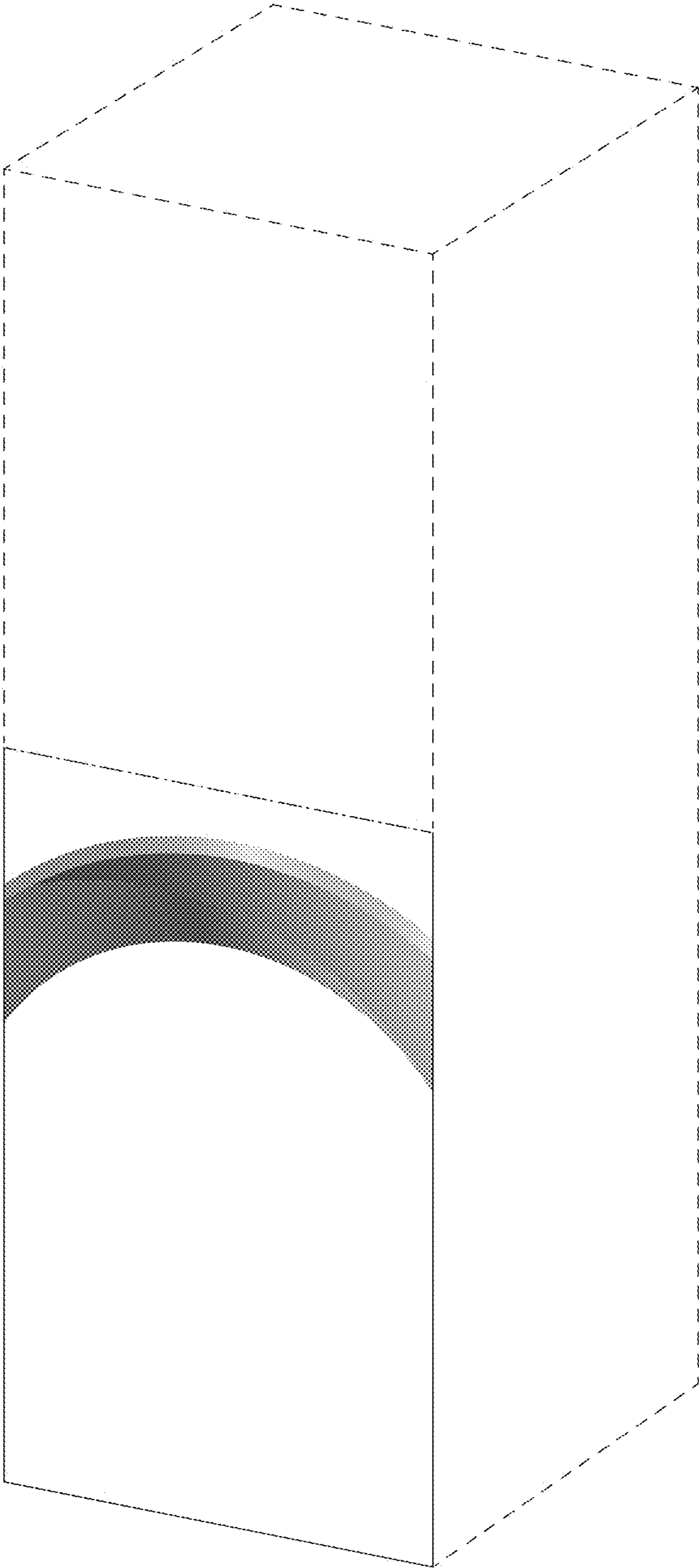

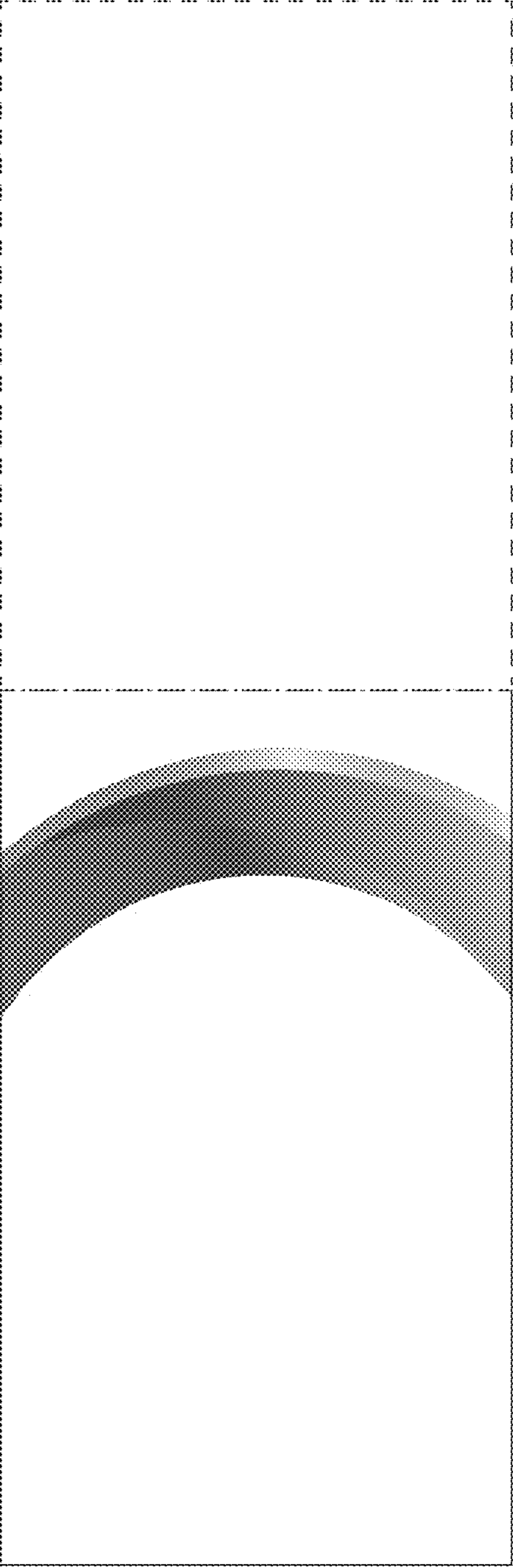

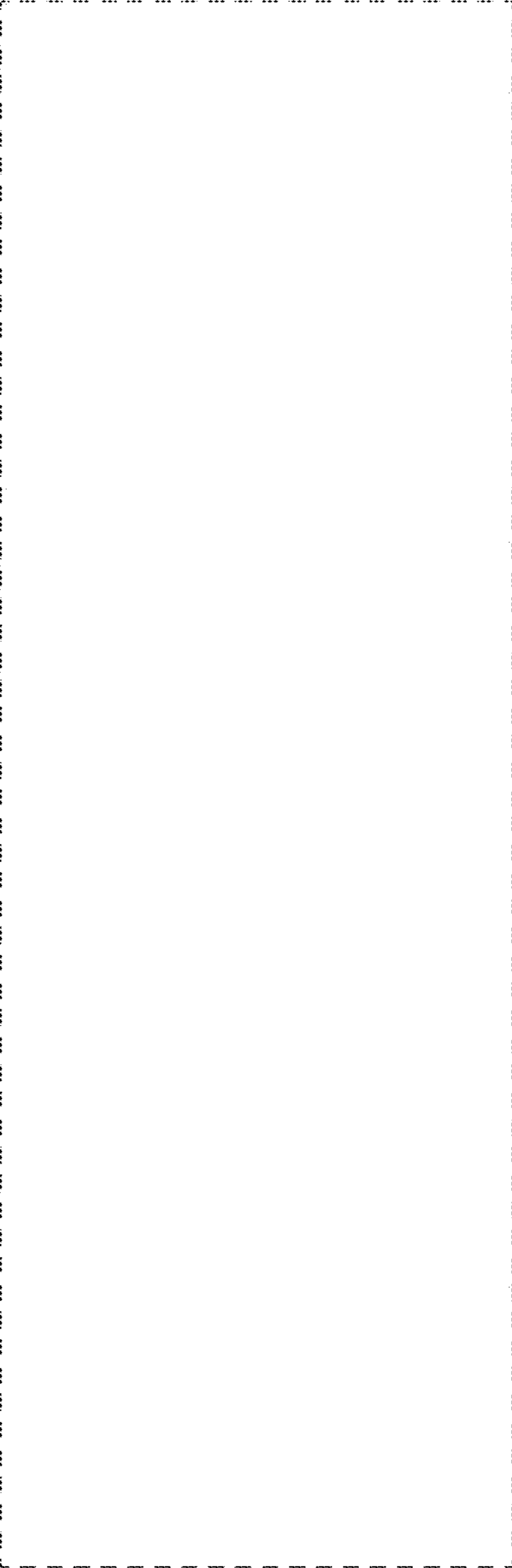

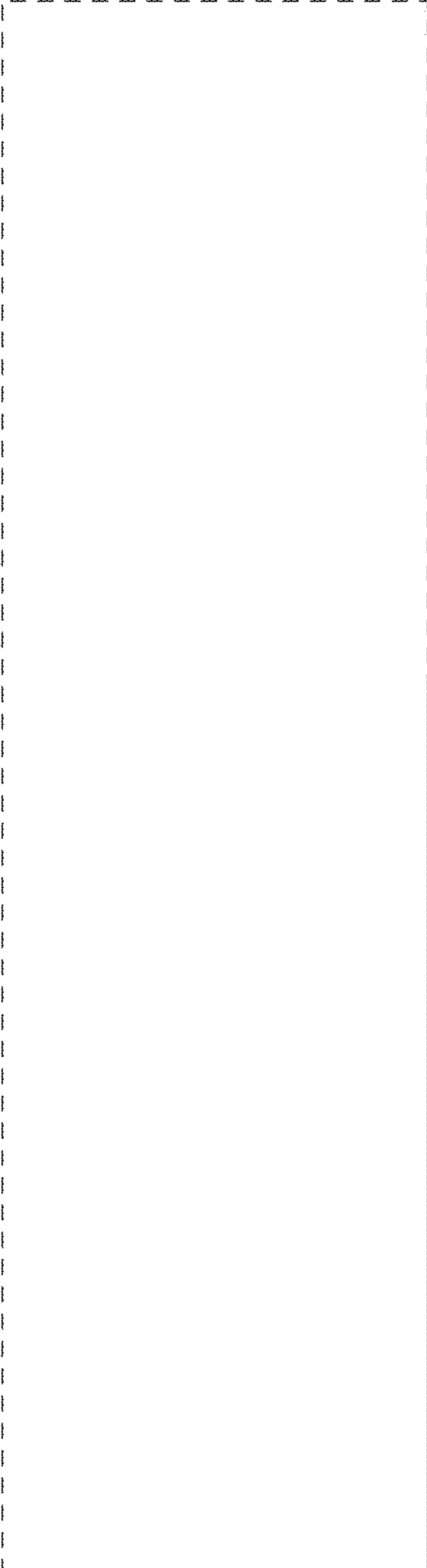

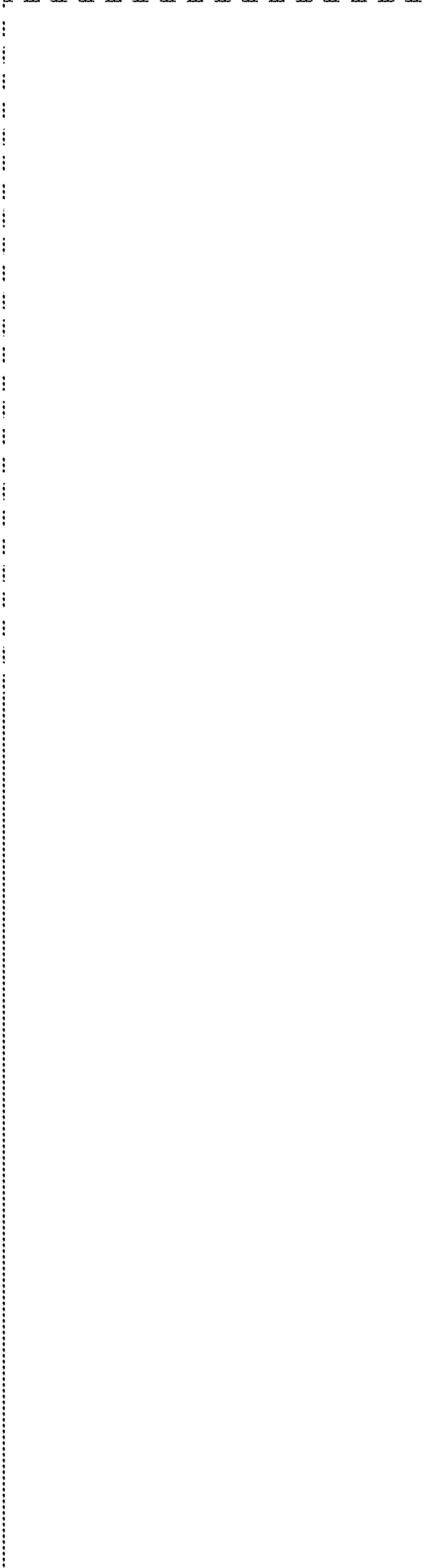

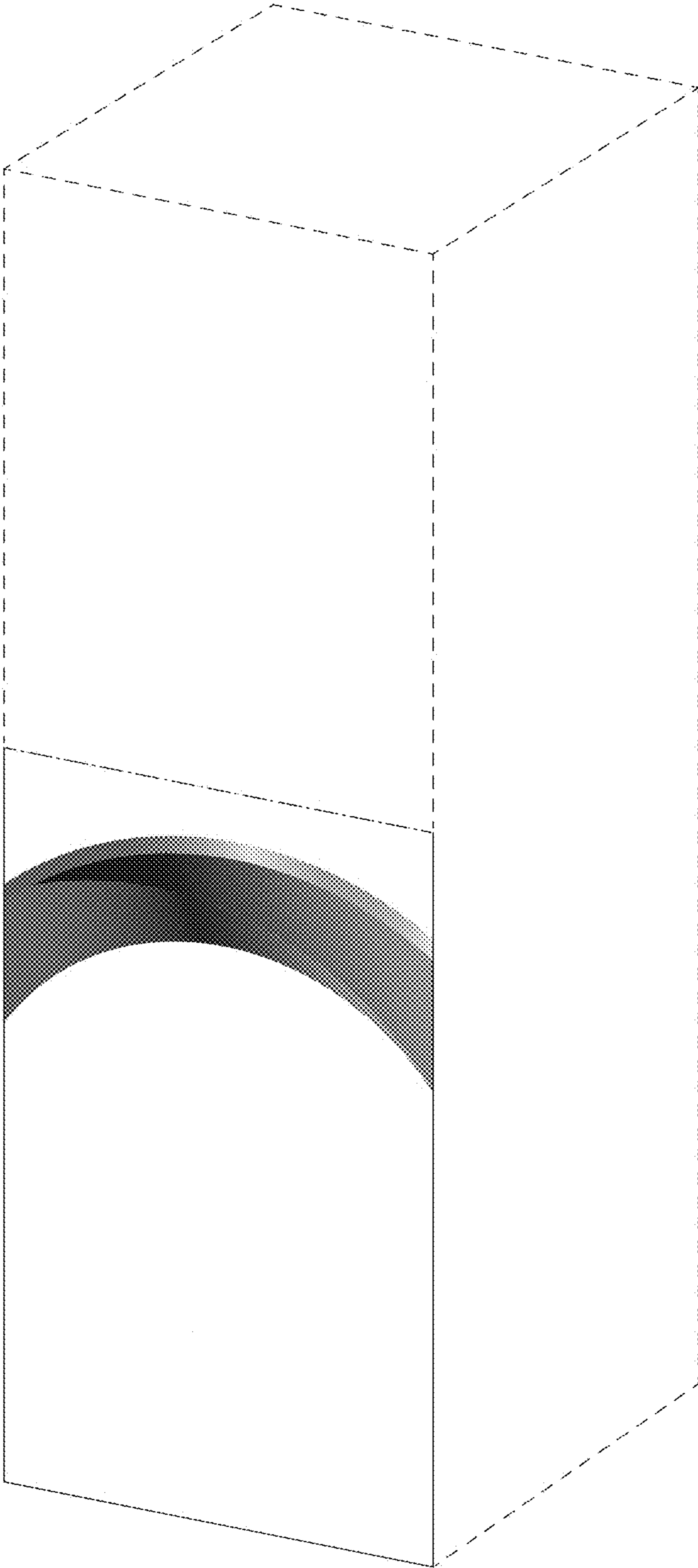

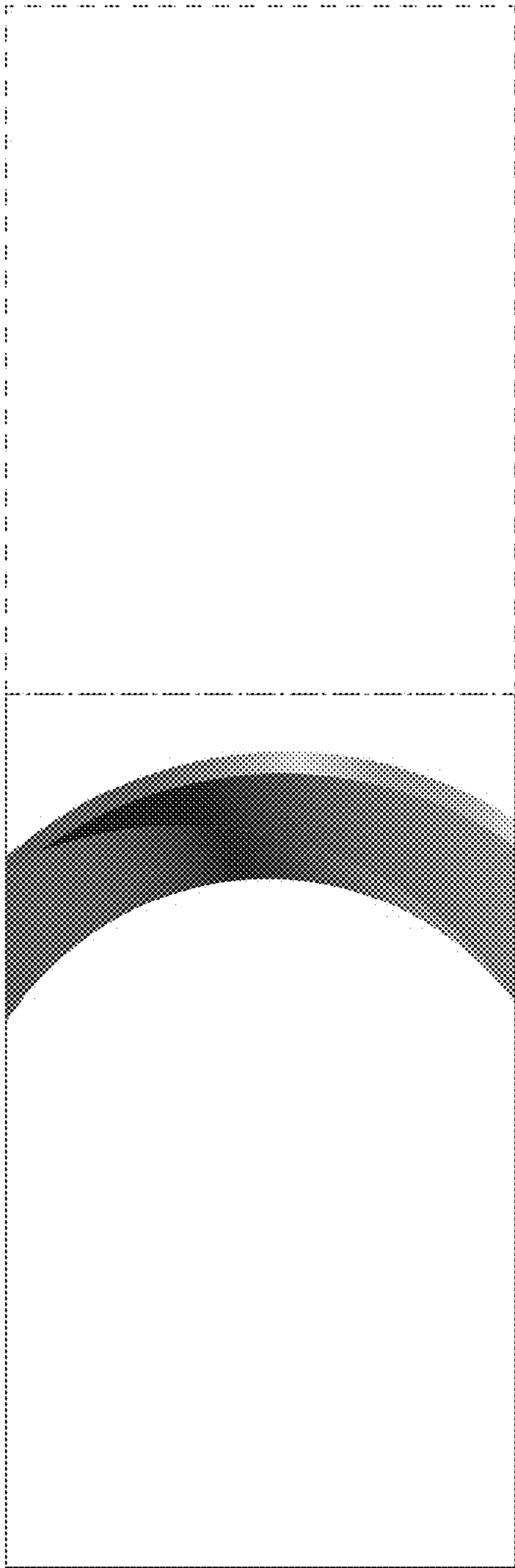

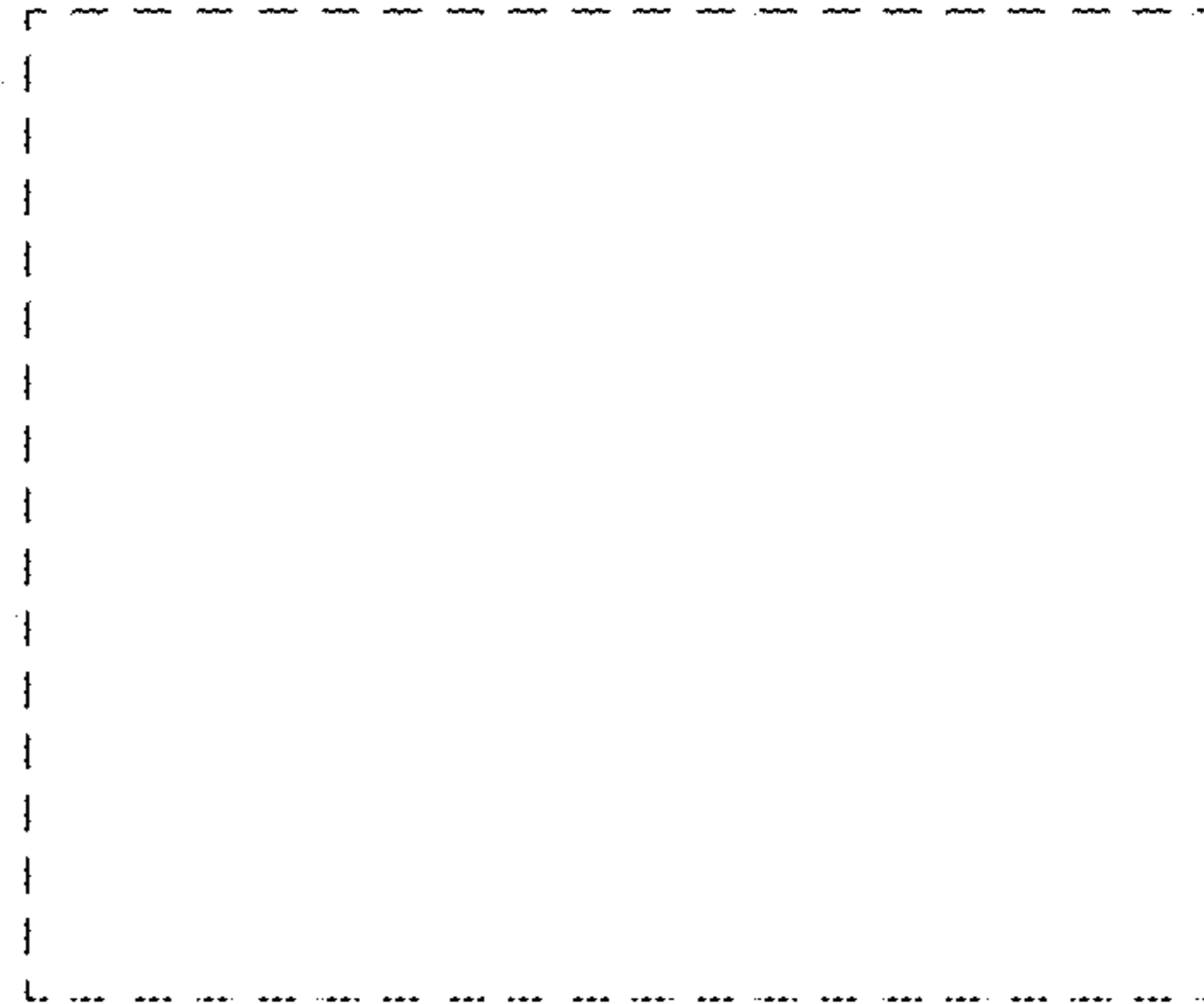

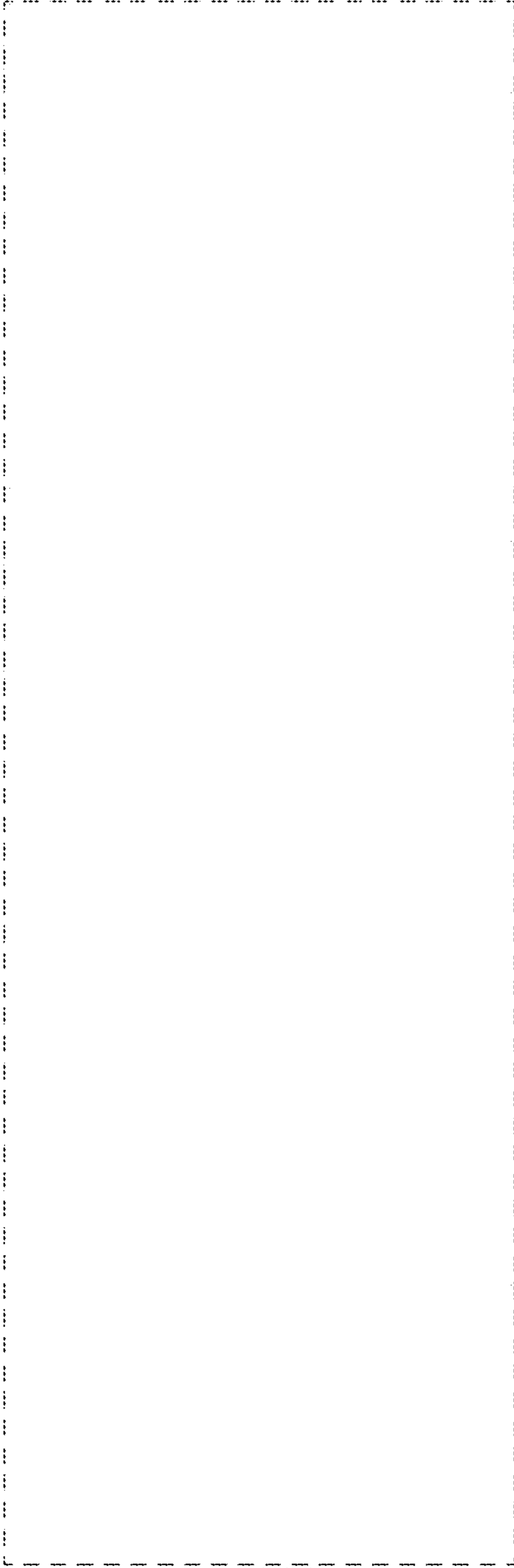

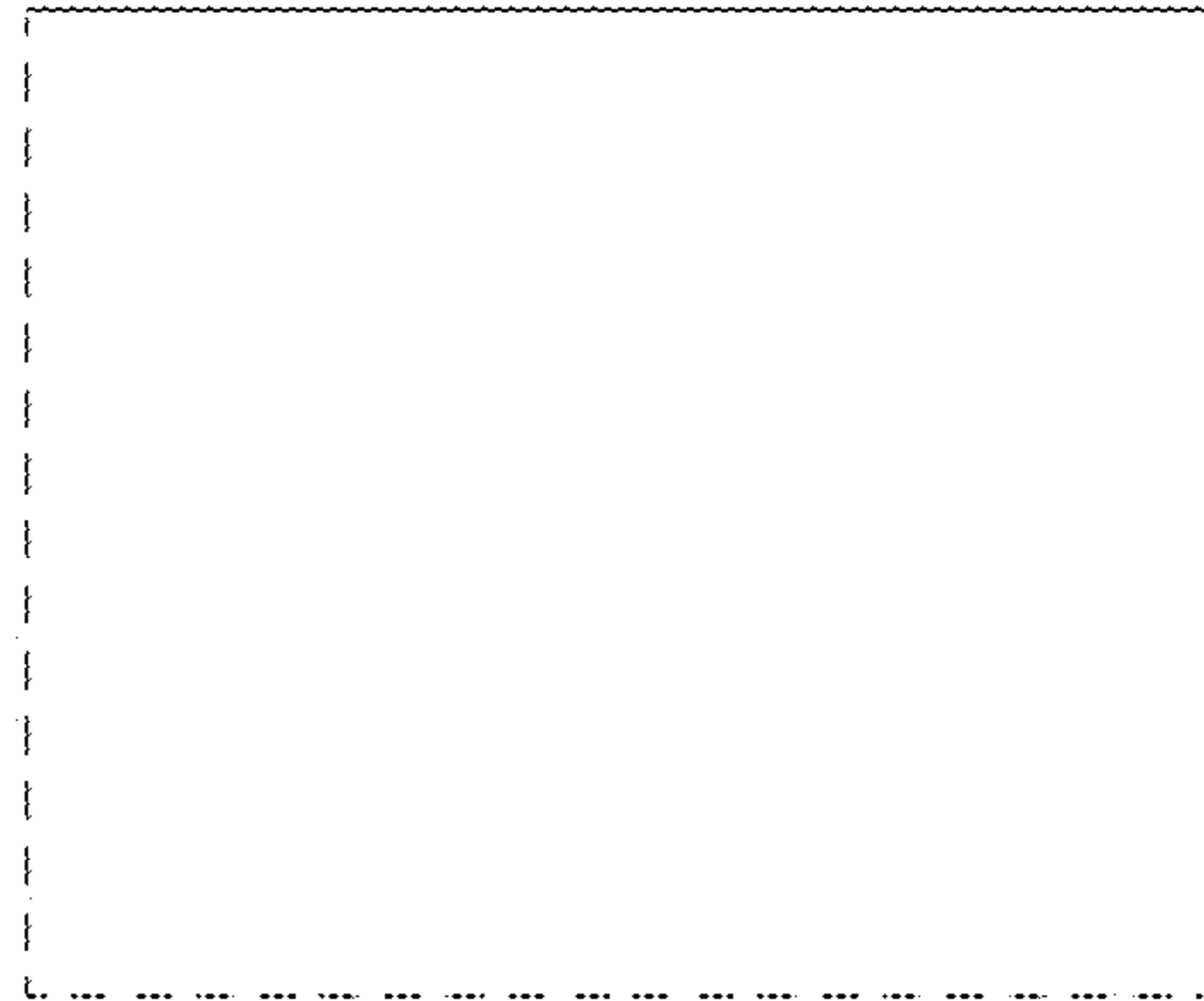

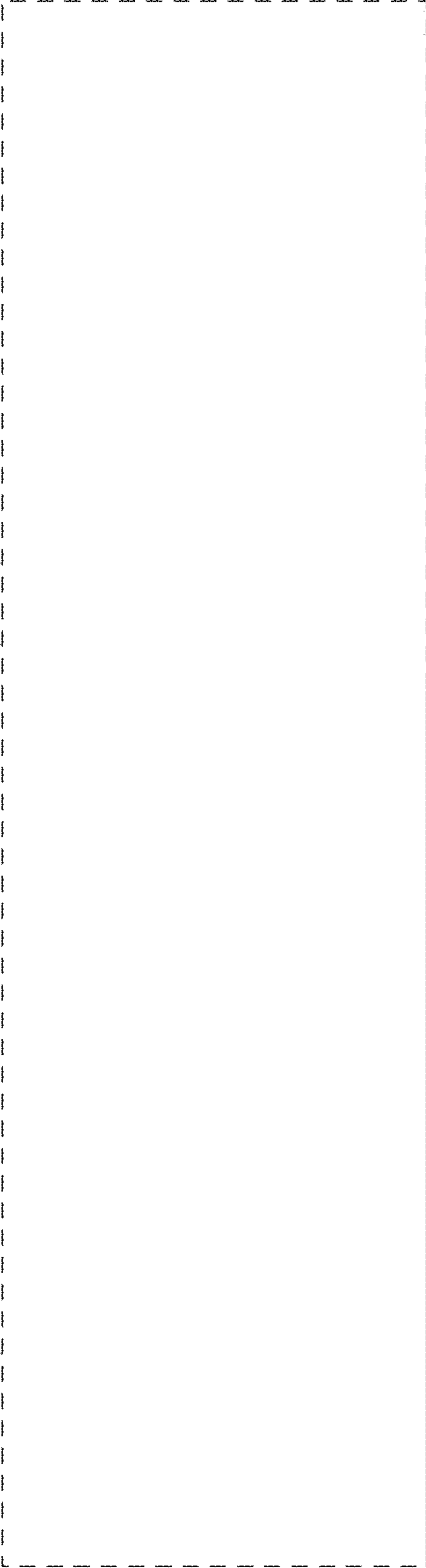

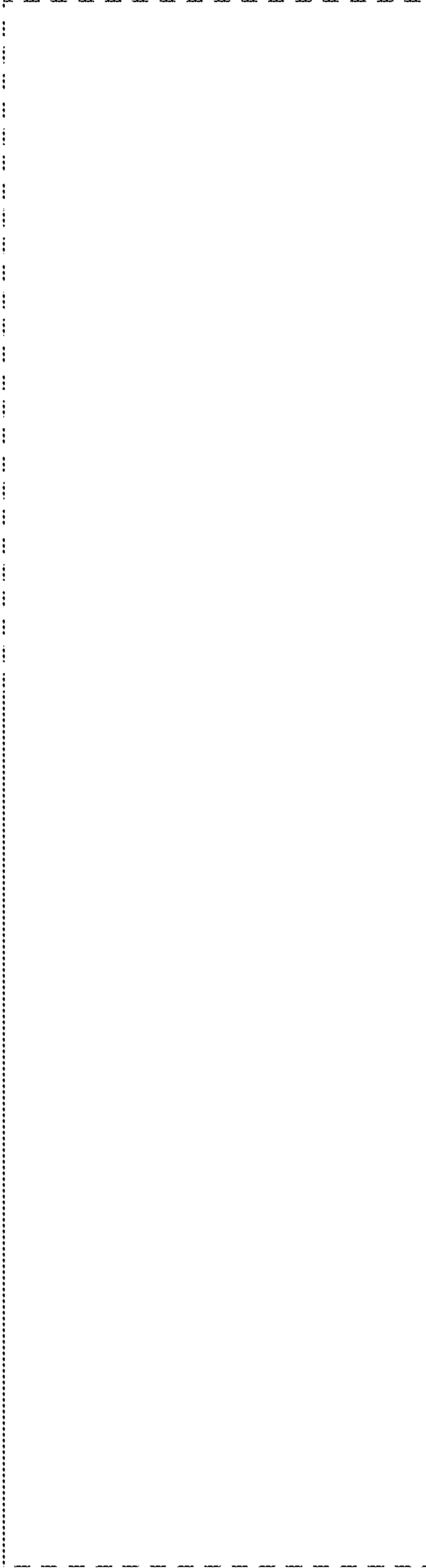

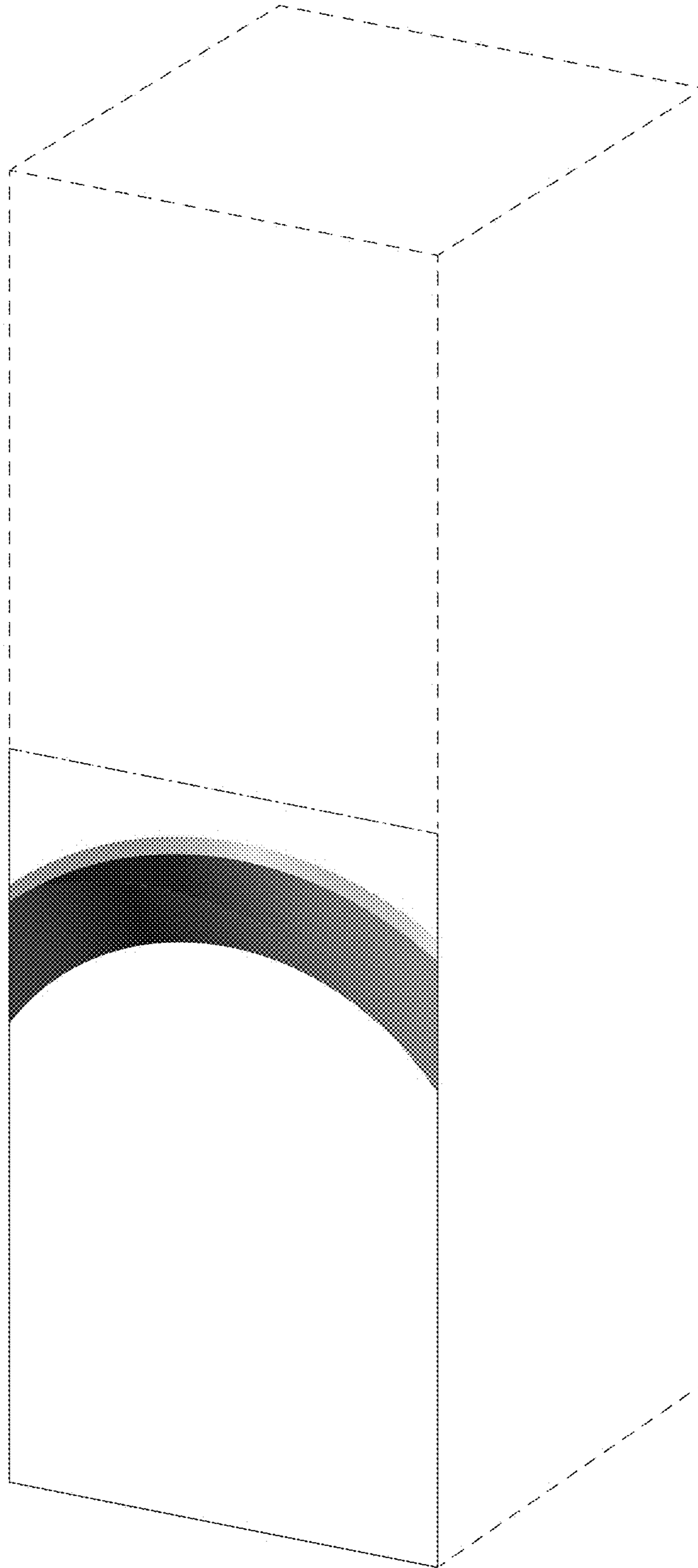

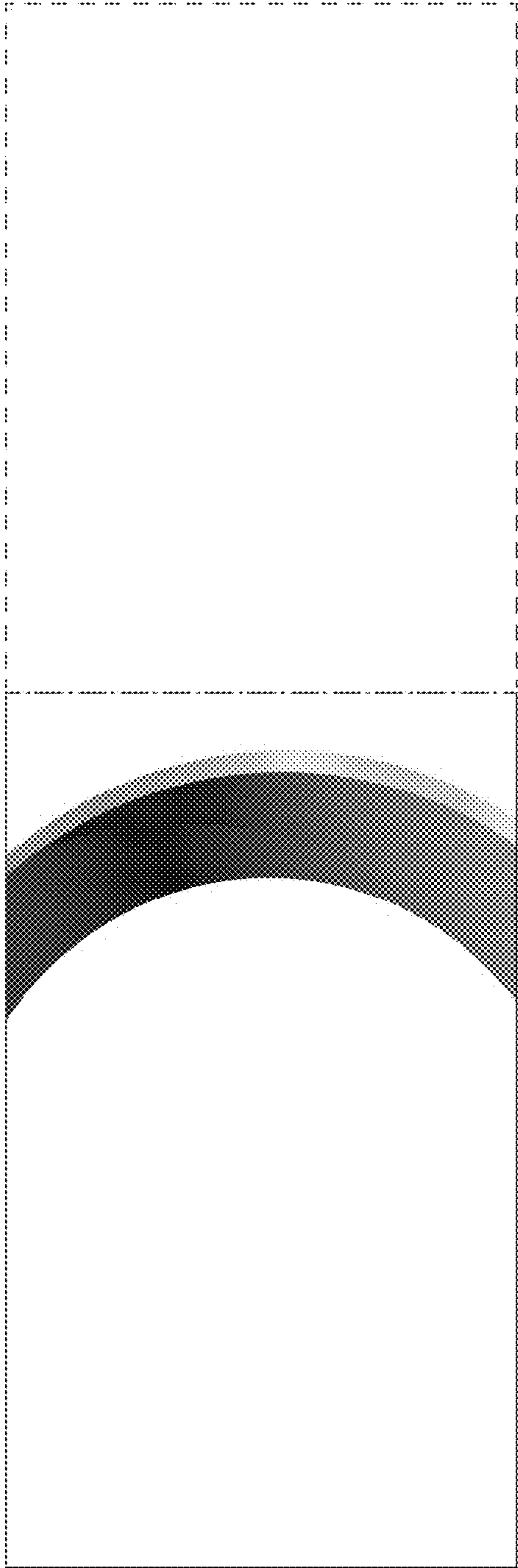

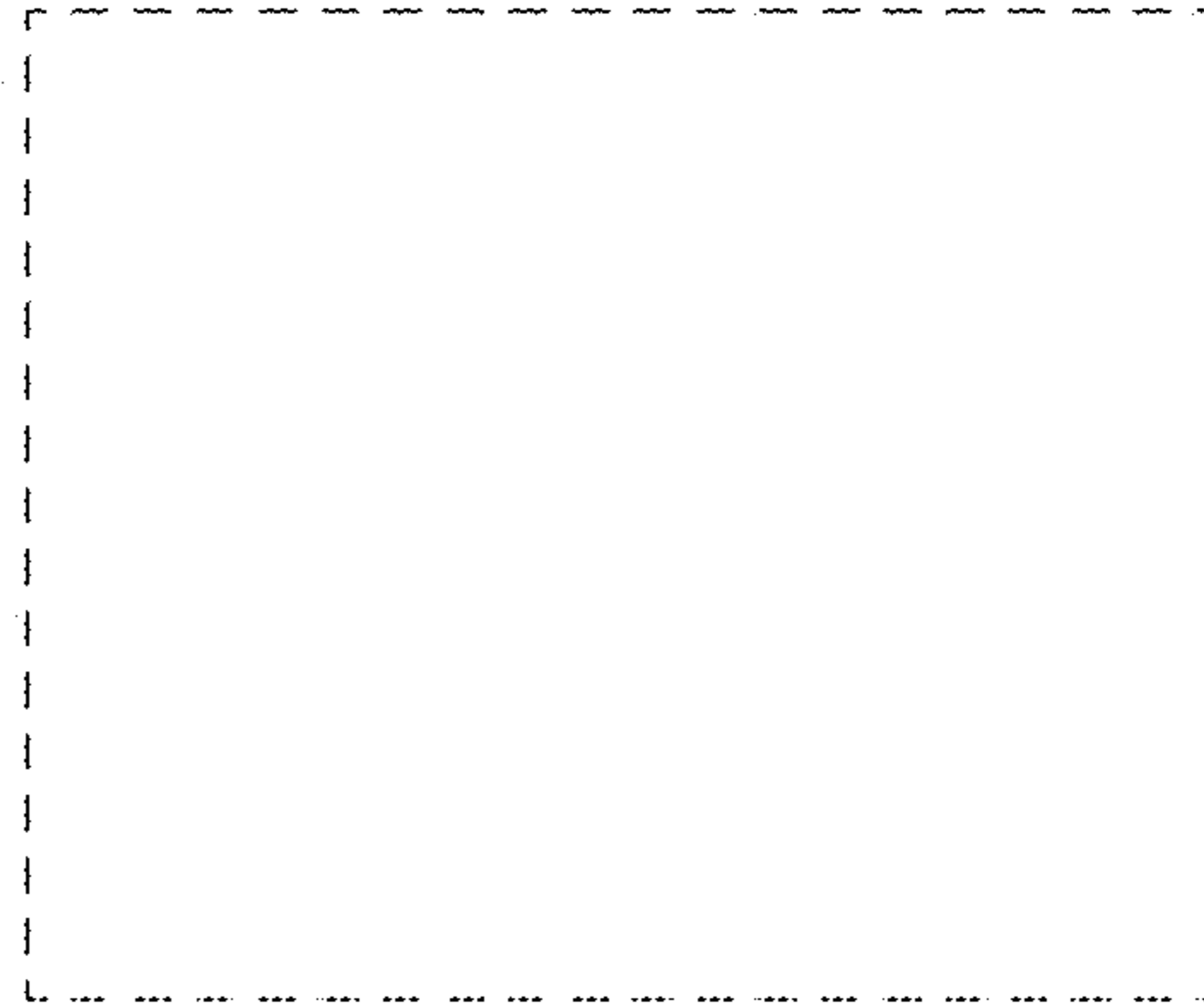

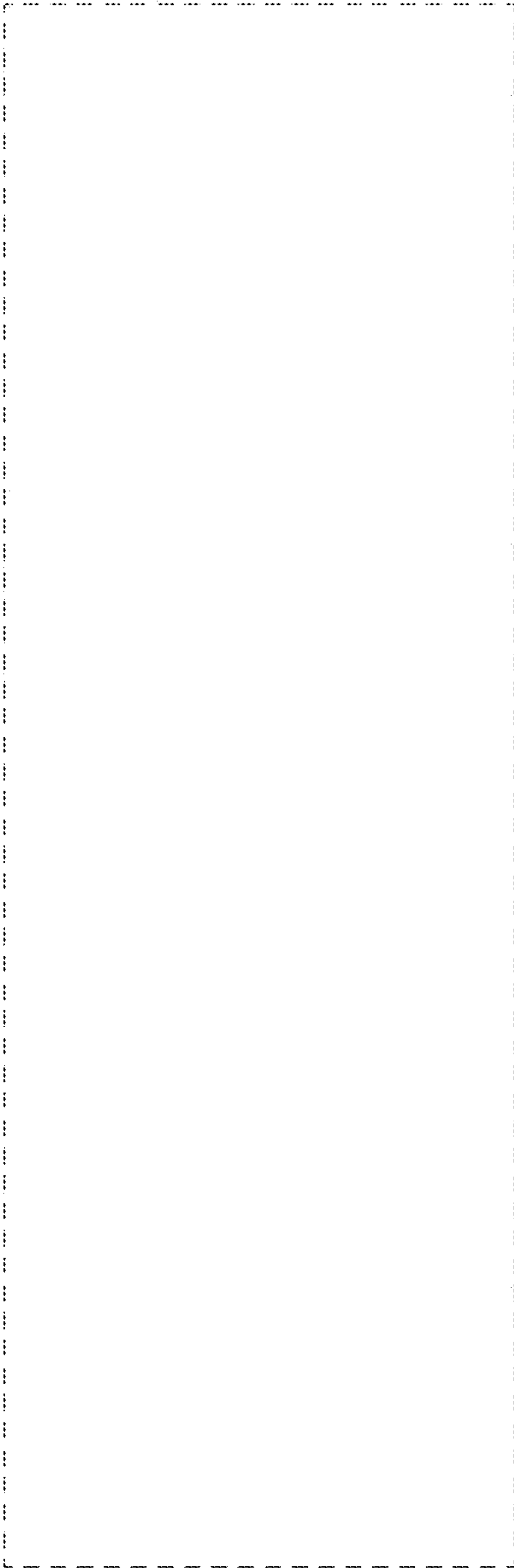

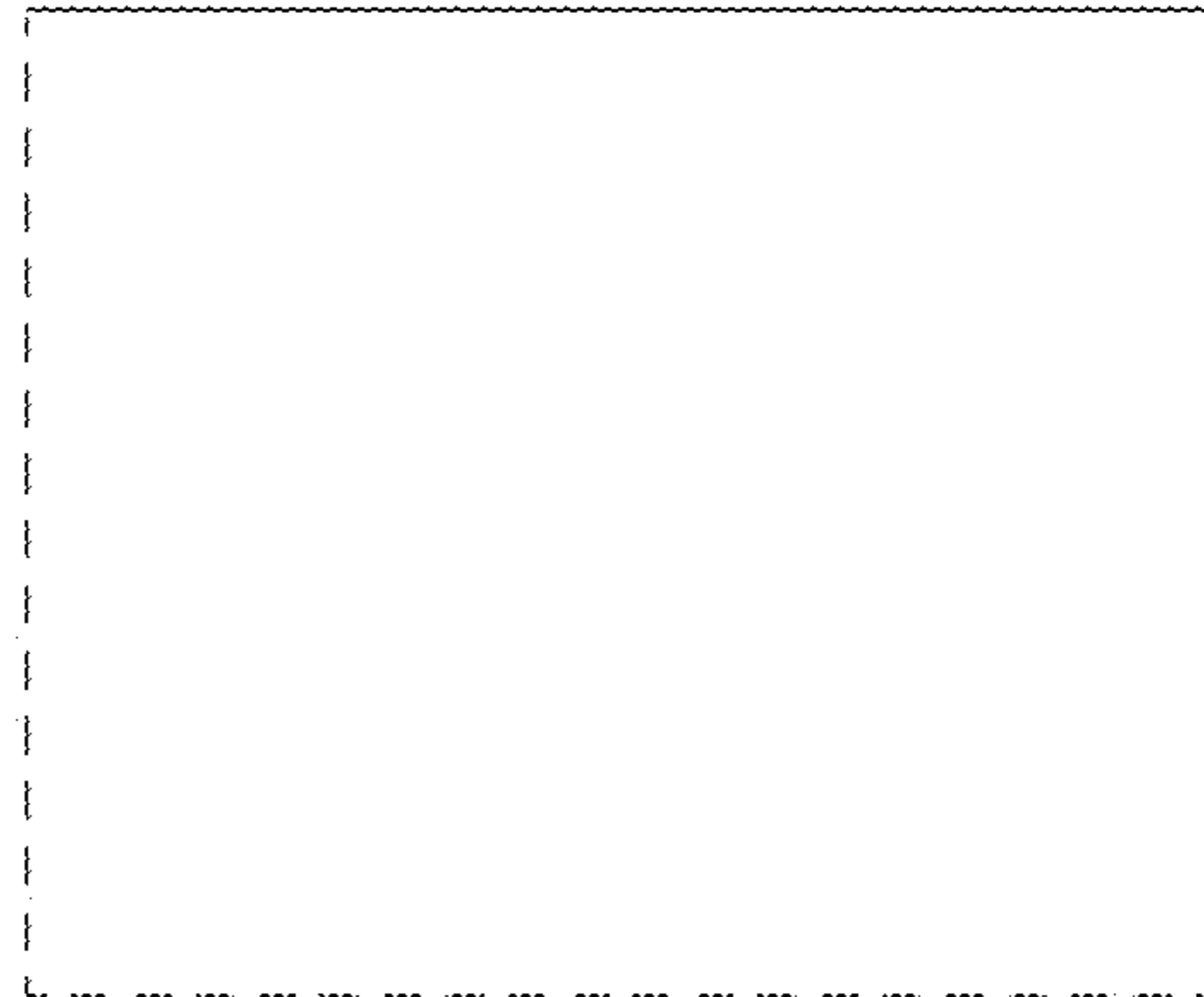

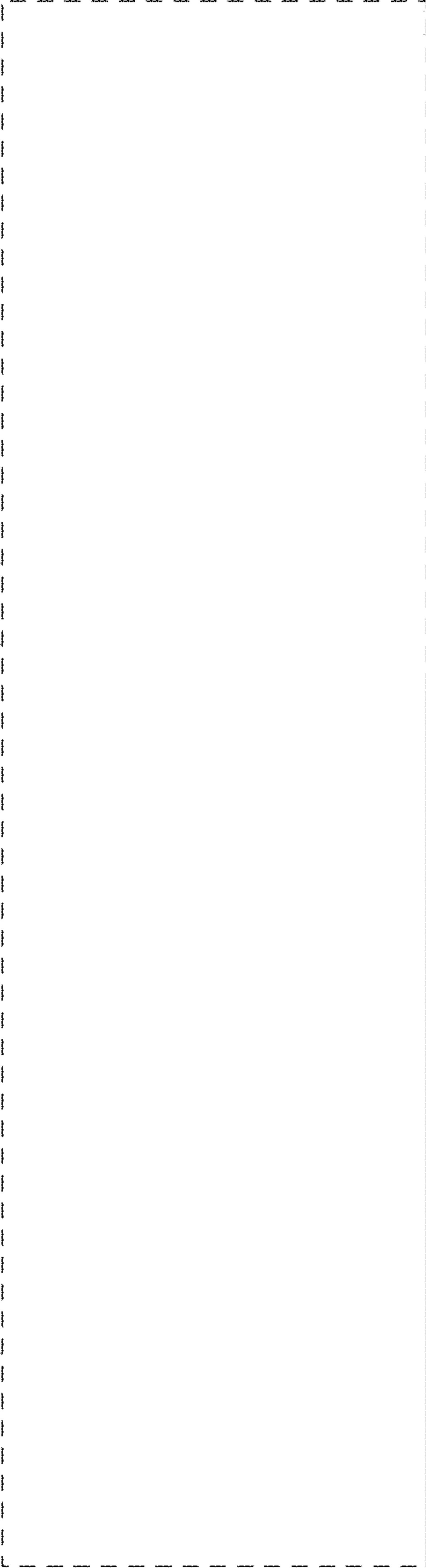

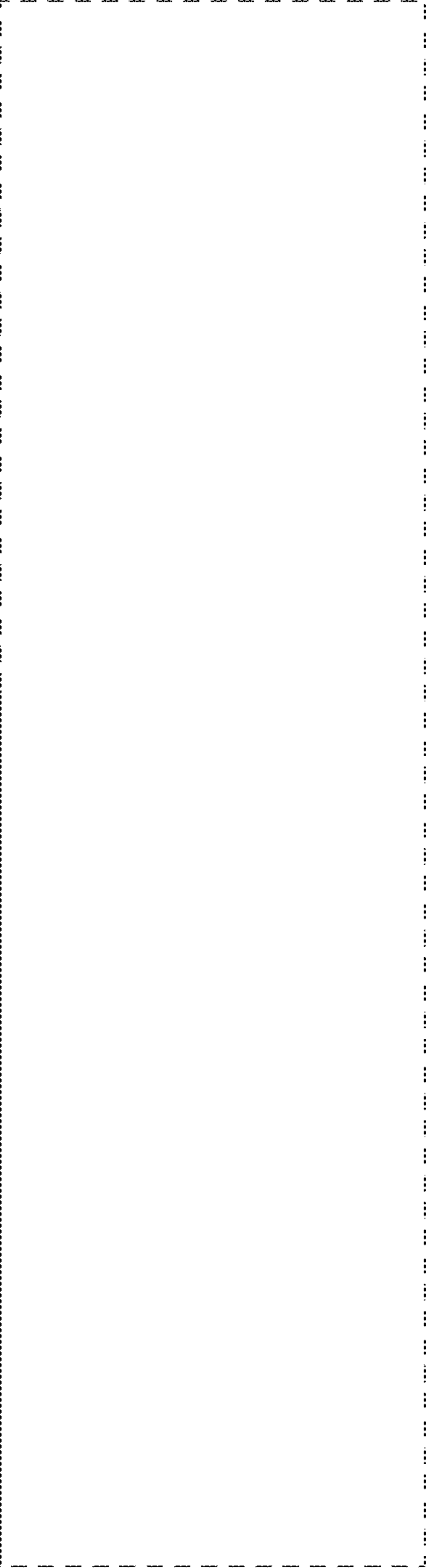
