(57) **CLAIM**

The ornamental design for a globe for a signal warning and displaying lamp, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a globe for a signal warning and displaying lamp of my new design, the rear elevational view being a mirror image of the front elevational view;

FIG. 2 is a right side elevational view thereof, the left side elevational view being a mirror image of the right side elevational view;

FIG. 3 is a top plan view thereof;

FIG. 4 is a bottom plan view thereof;

FIG. 5 is a perspective view taken from the front, top and left side thereof;

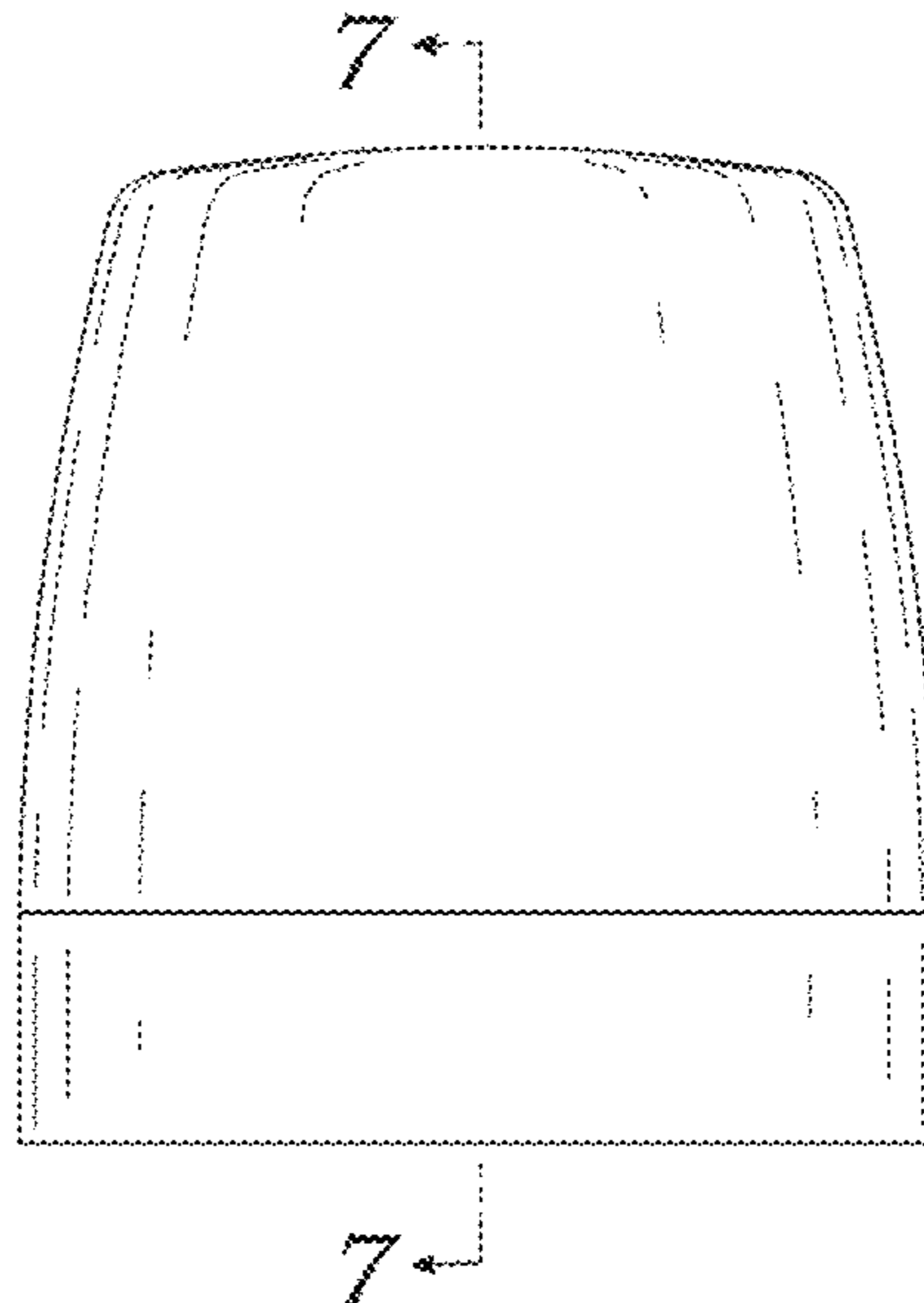
FIG. 6 is a perspective view taken from the rear, bottom and right side thereof;

FIG. 7 is a cross-sectional view taken along the lines 7-7 in FIG. 1; and,

FIG. 8 is a reference illustration of the globe with the translucent portion indicated by inclined lines.

The surface is lined for contour only, and no claim is made to a particular texture. No claim is made to portions not shown in the drawings.

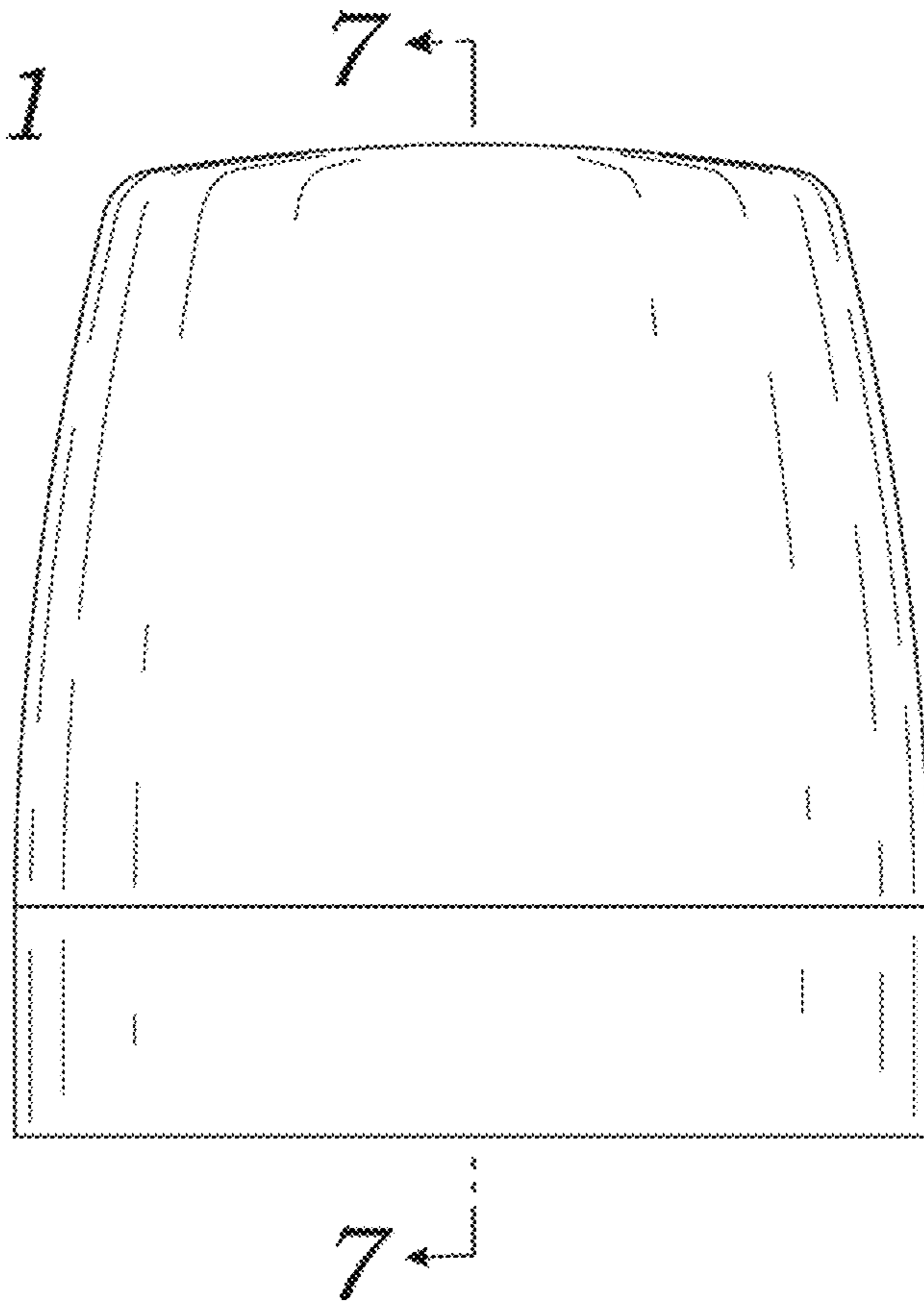

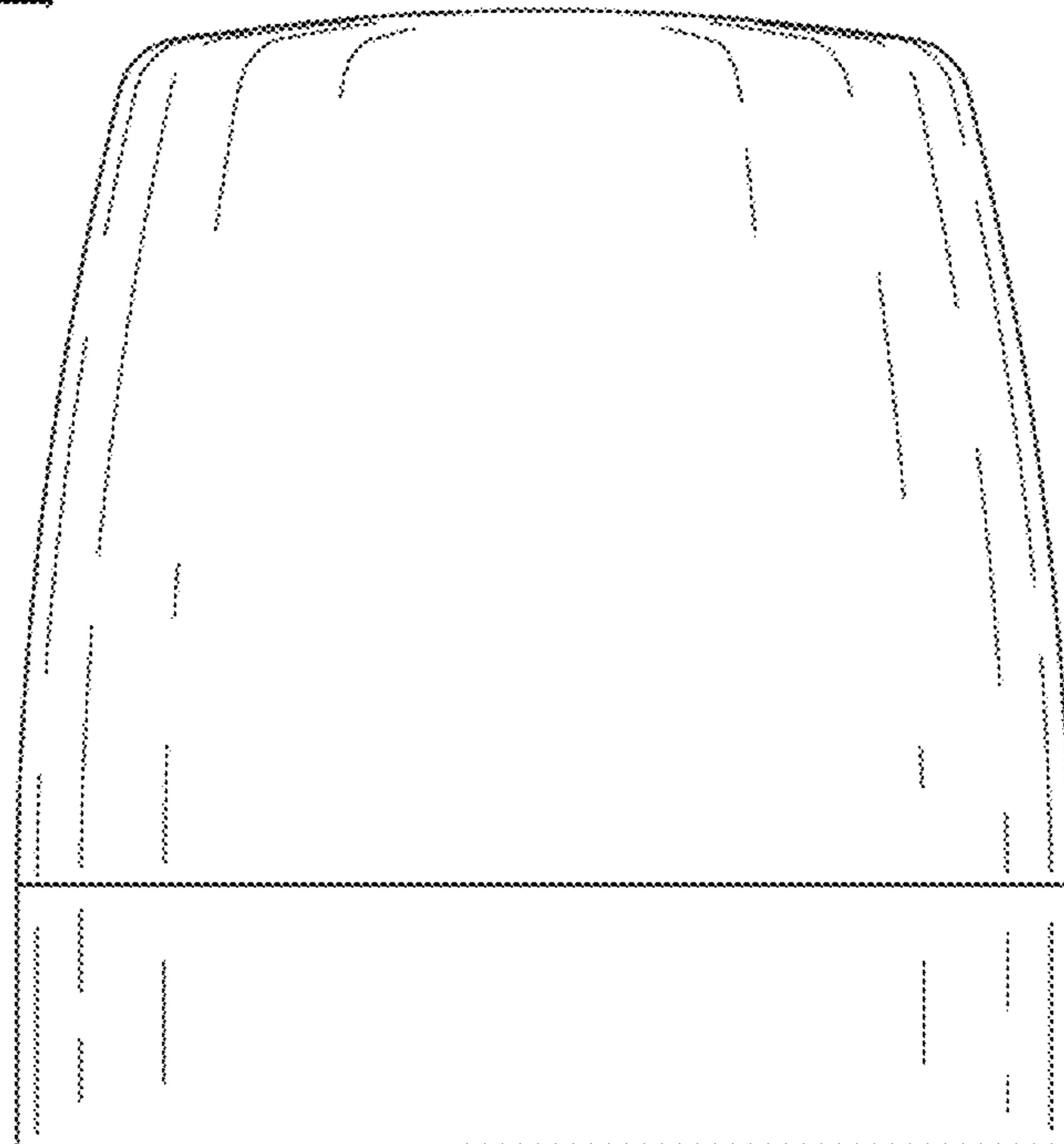

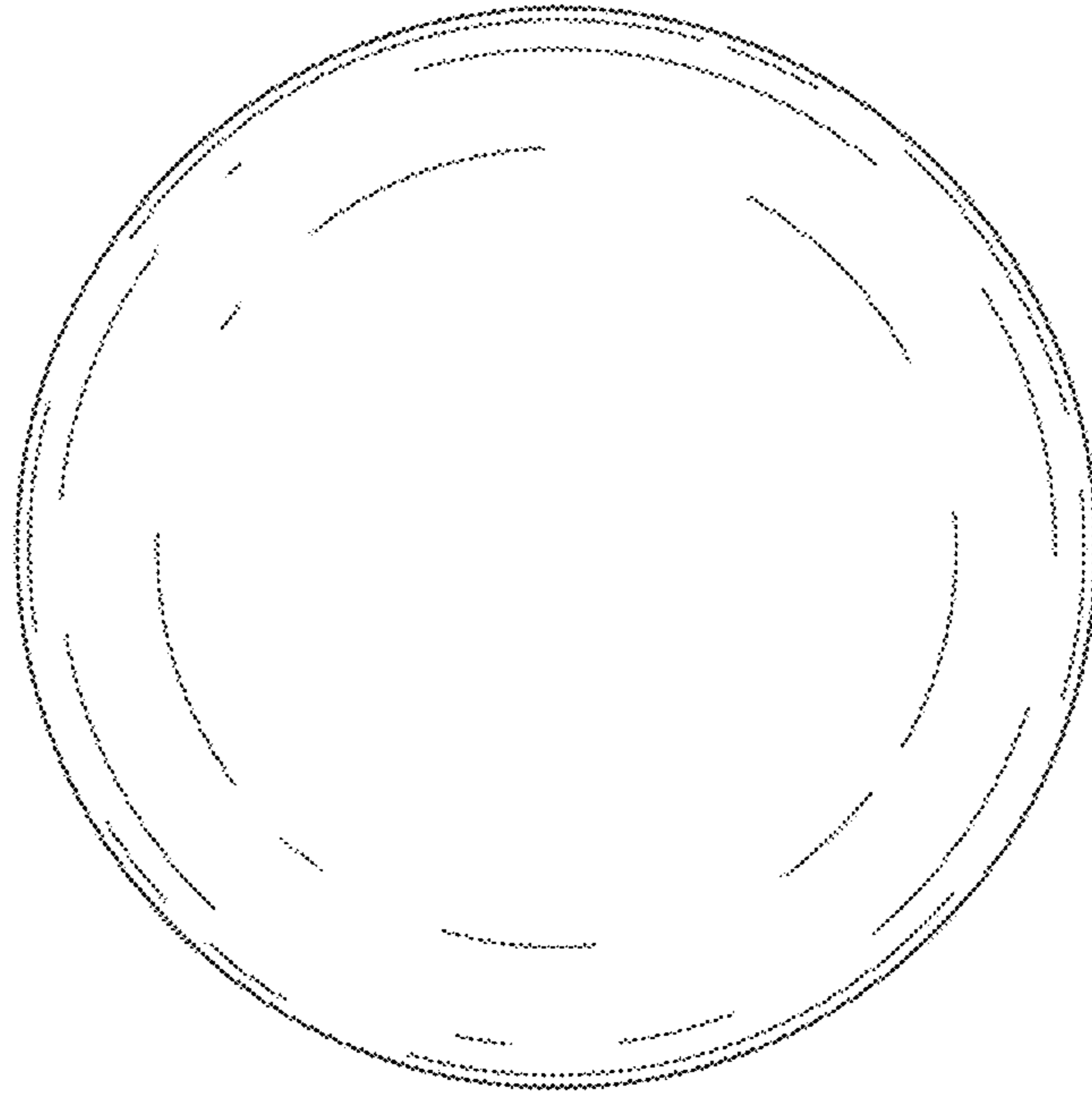

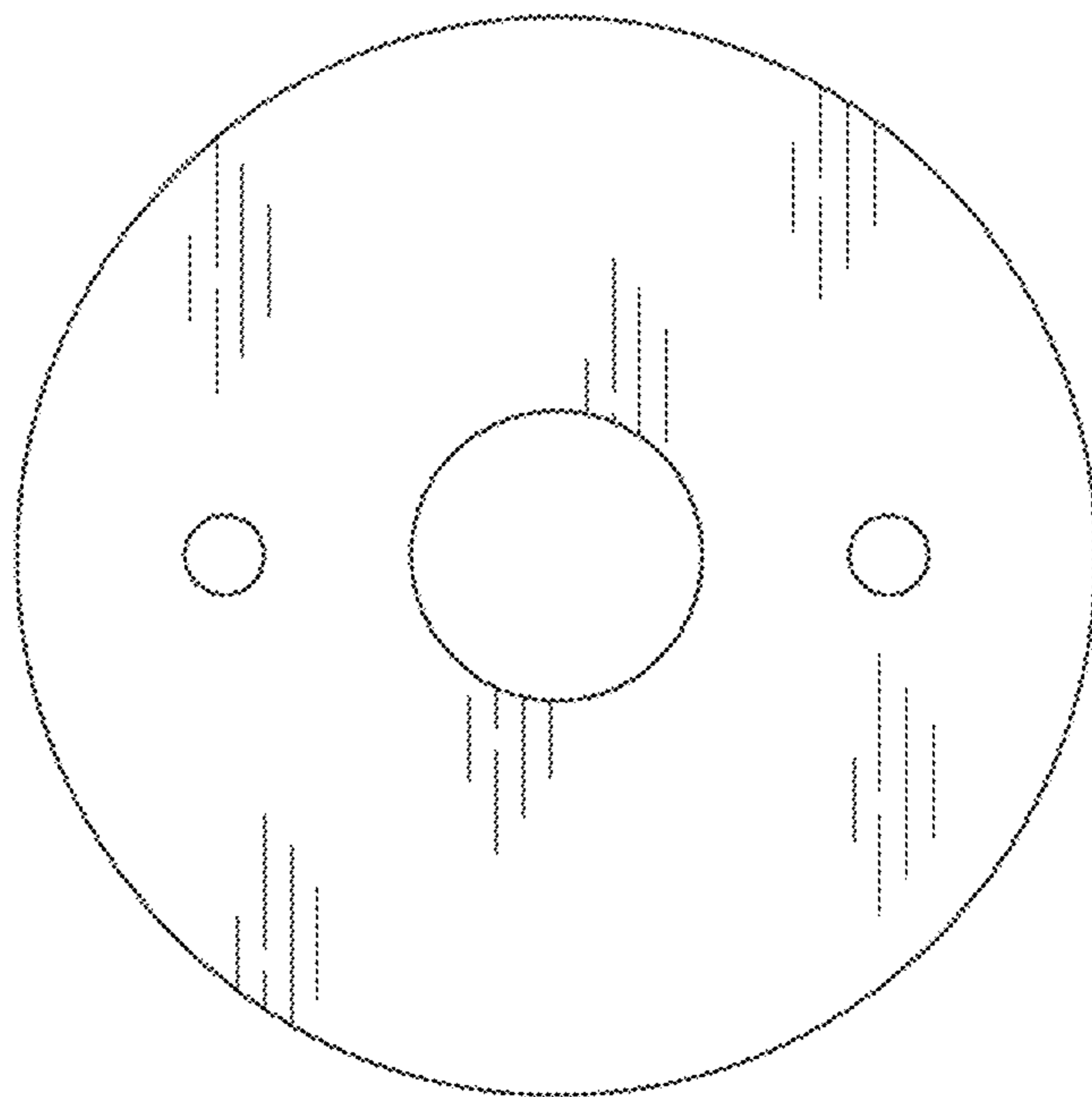

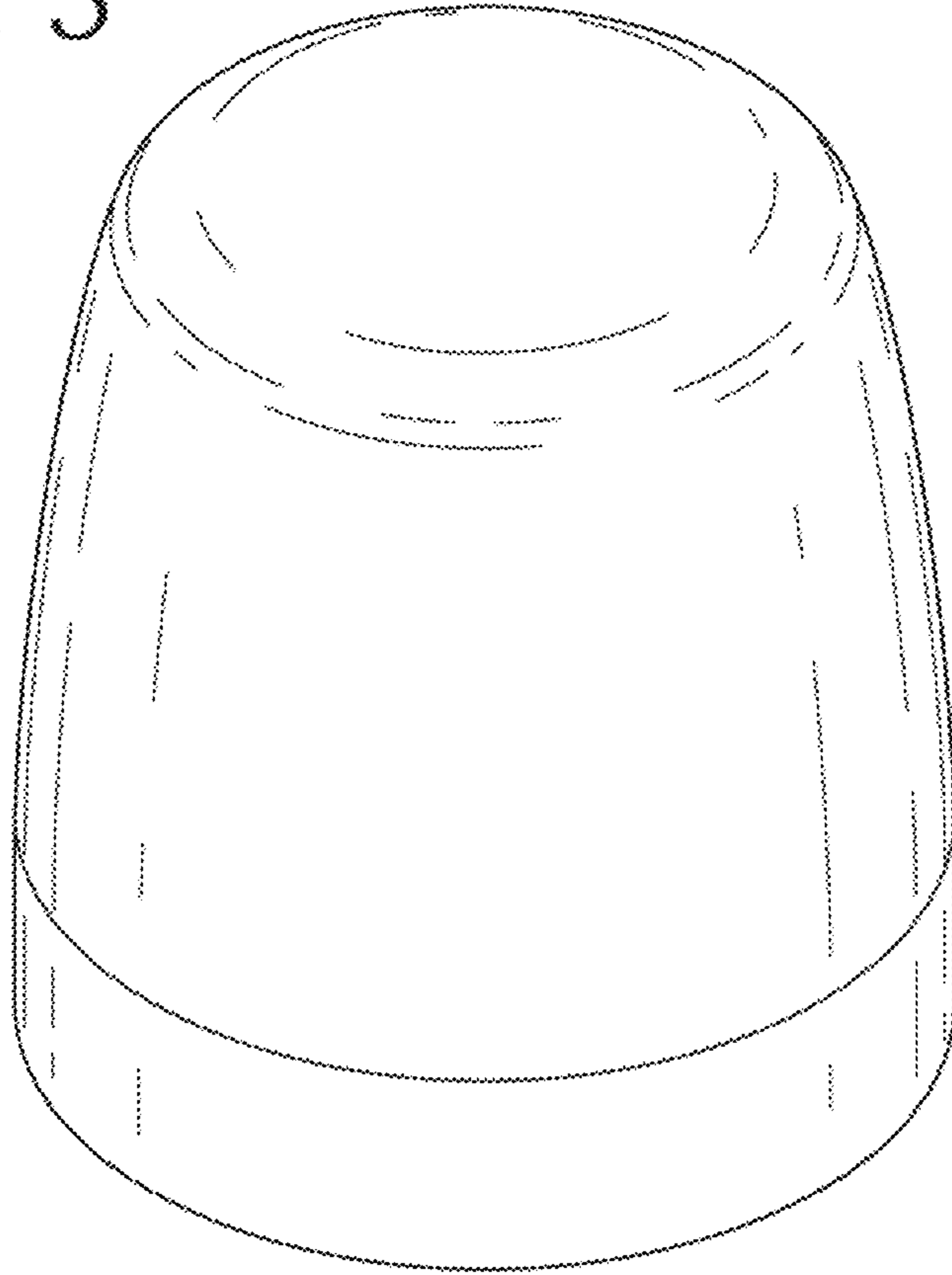

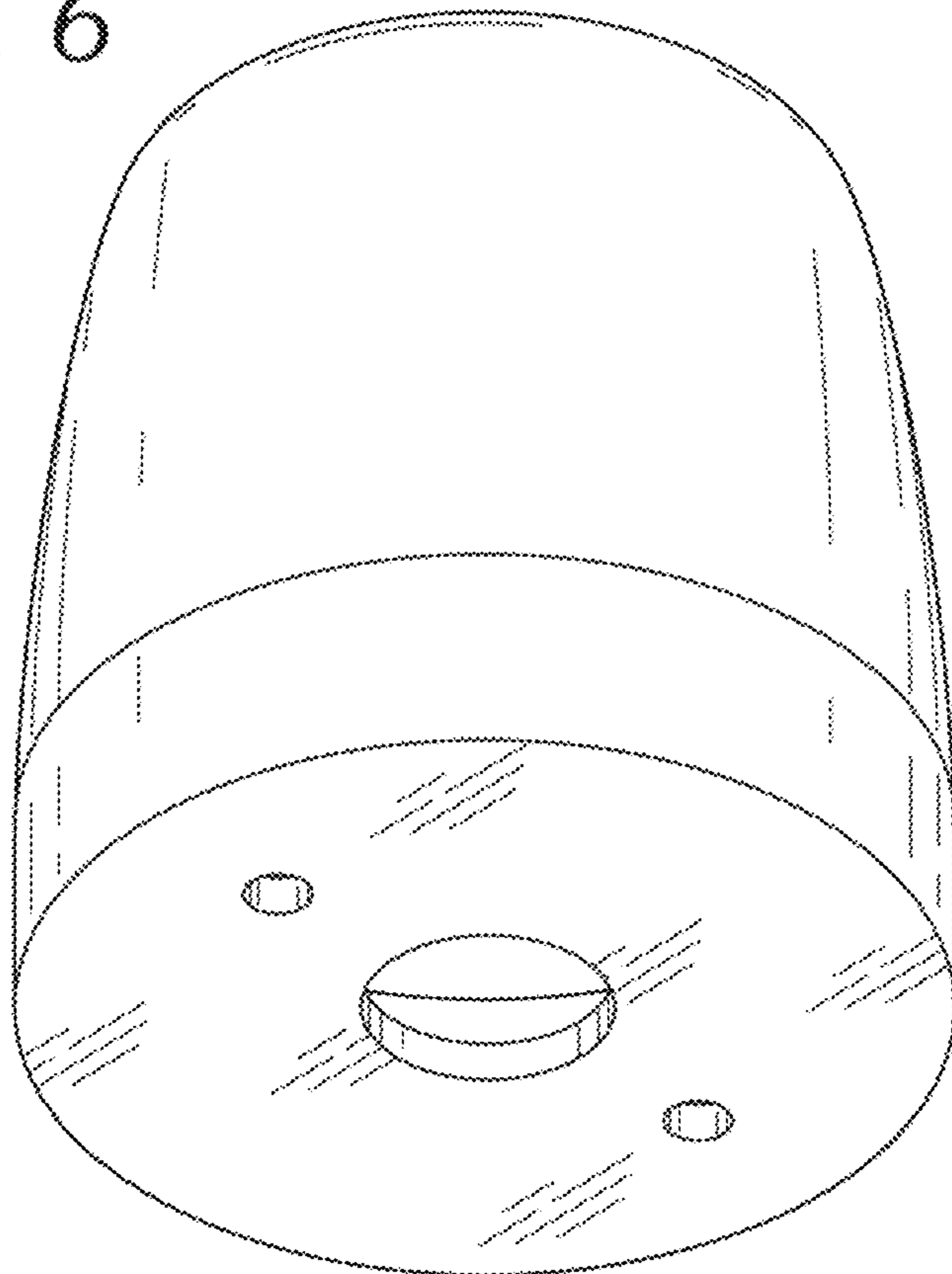

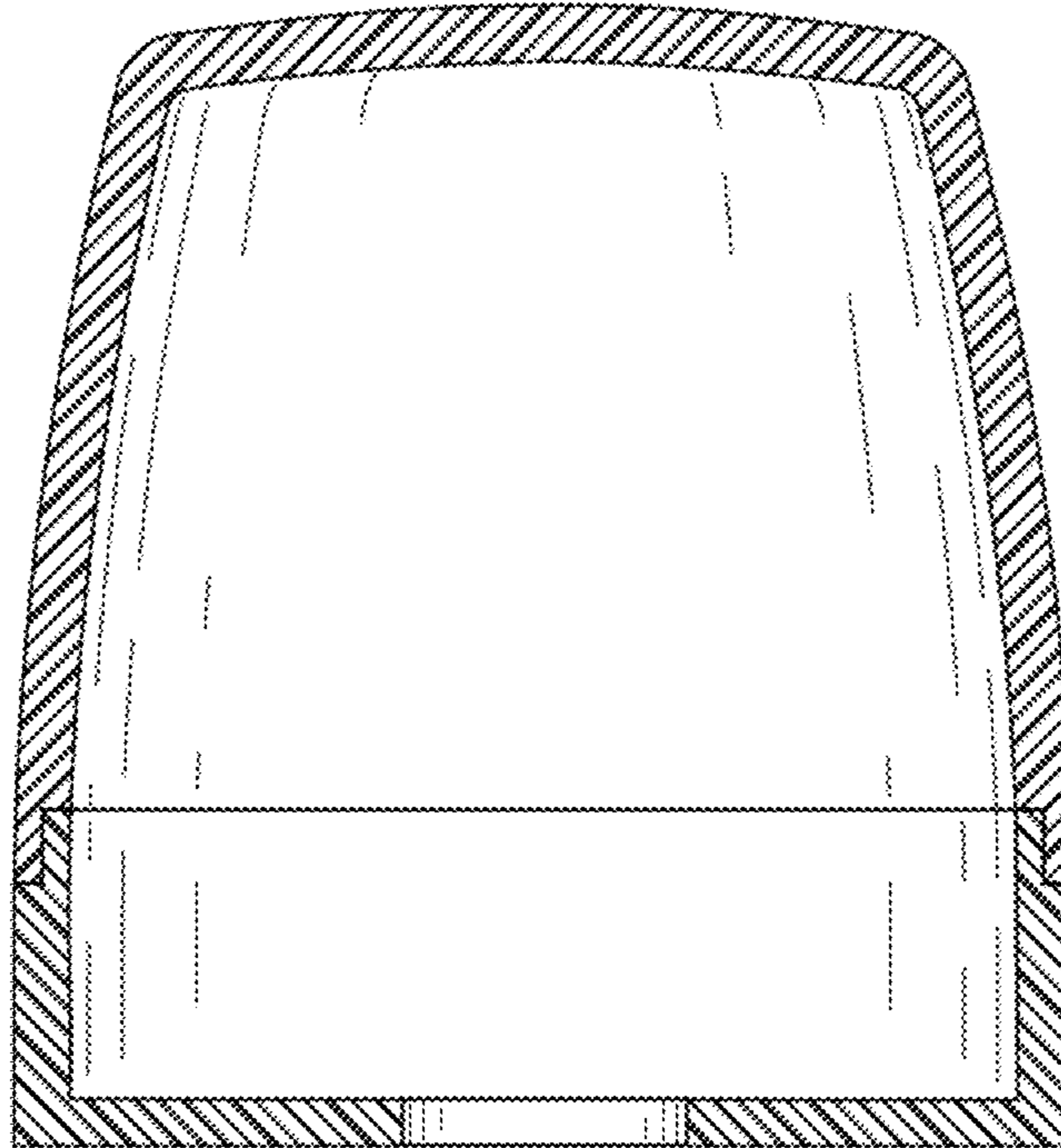
