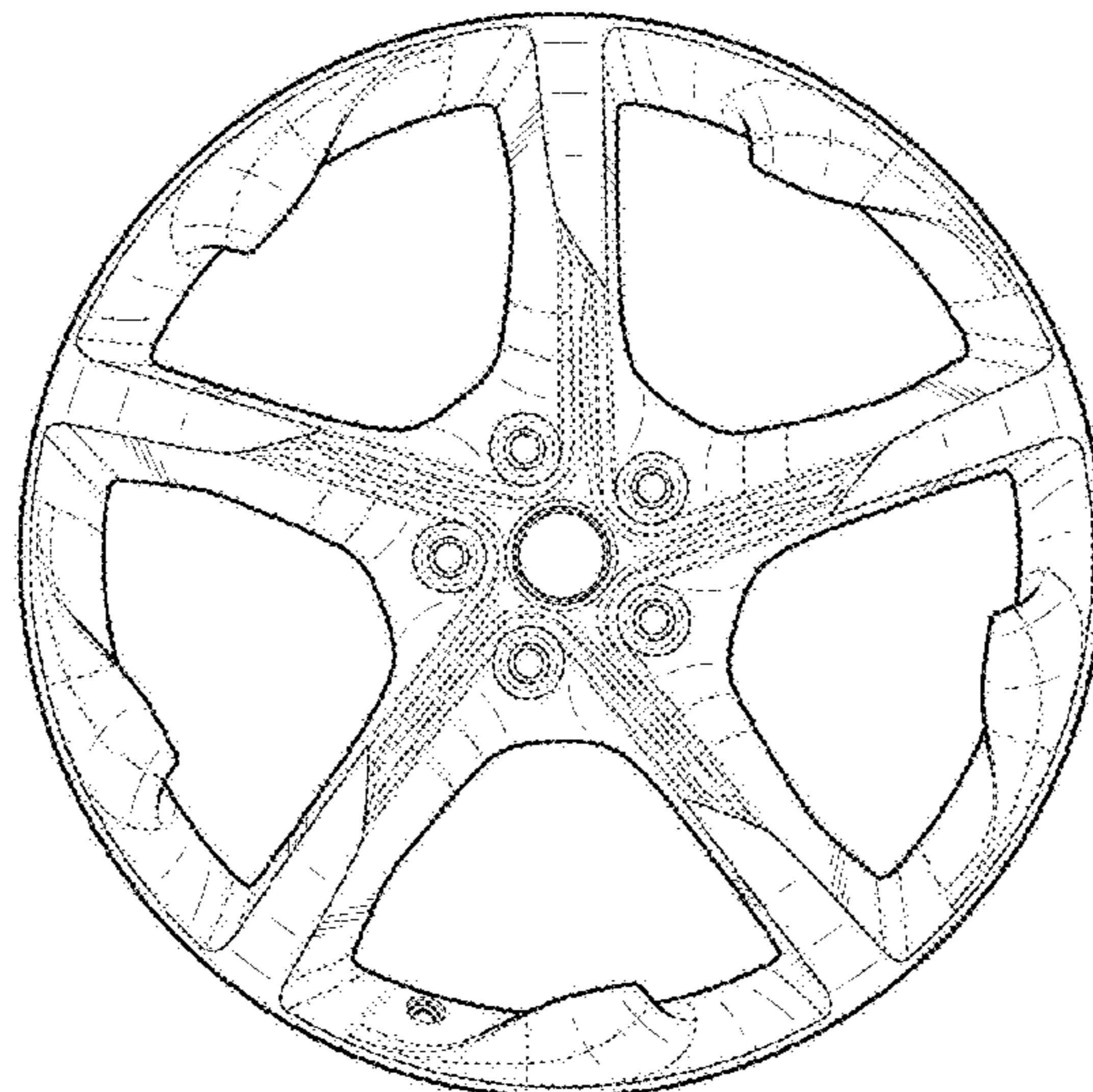
DESCRIPTION

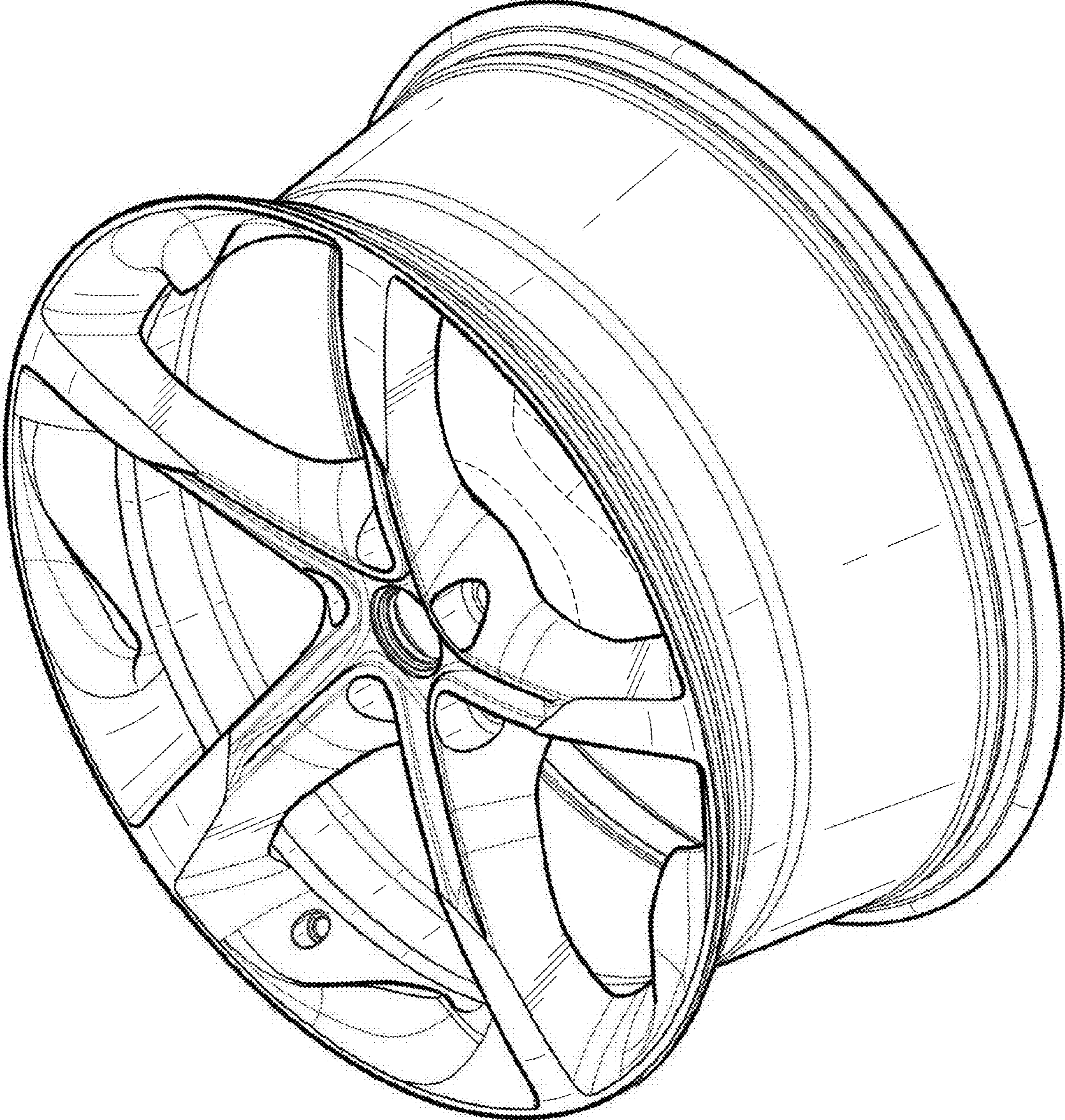

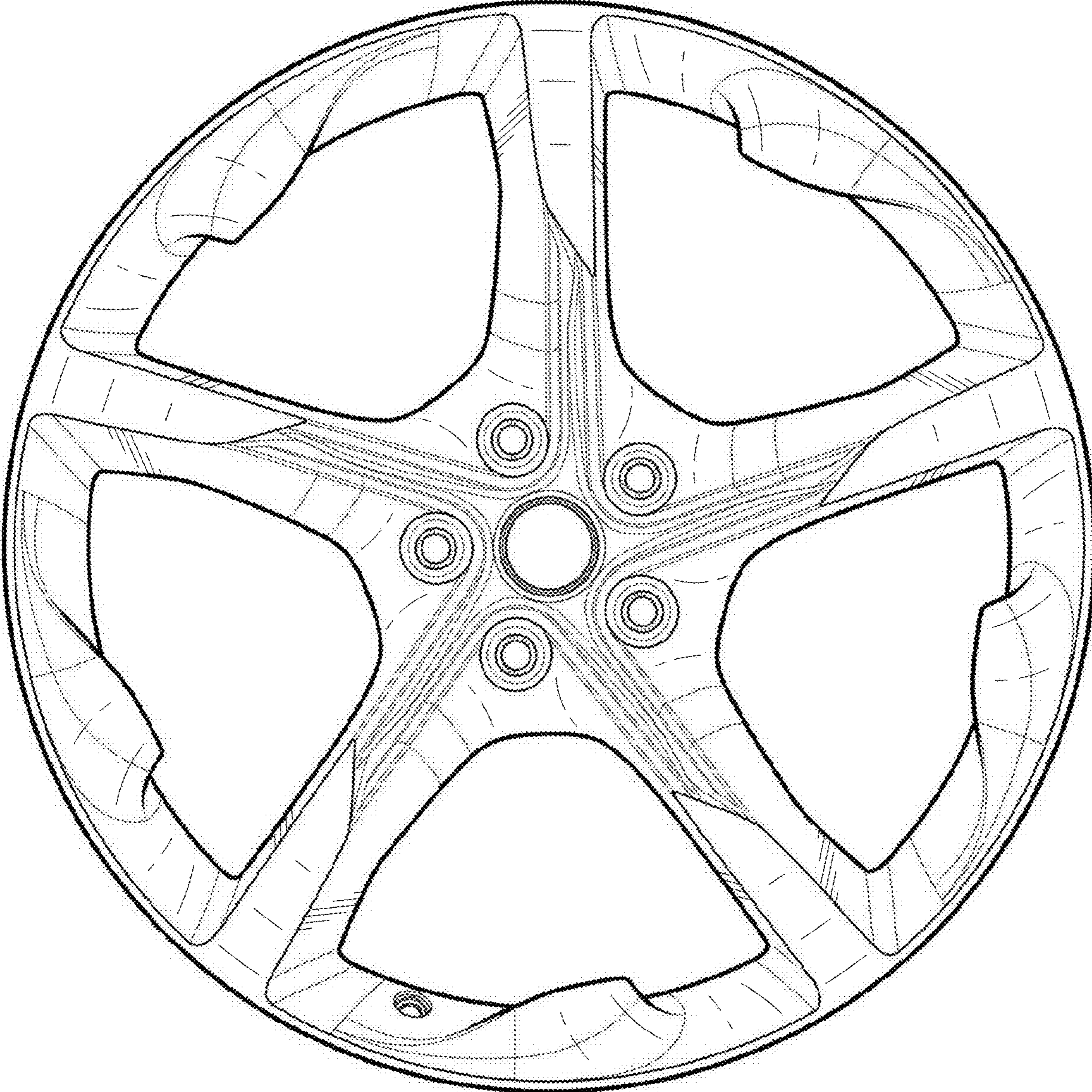

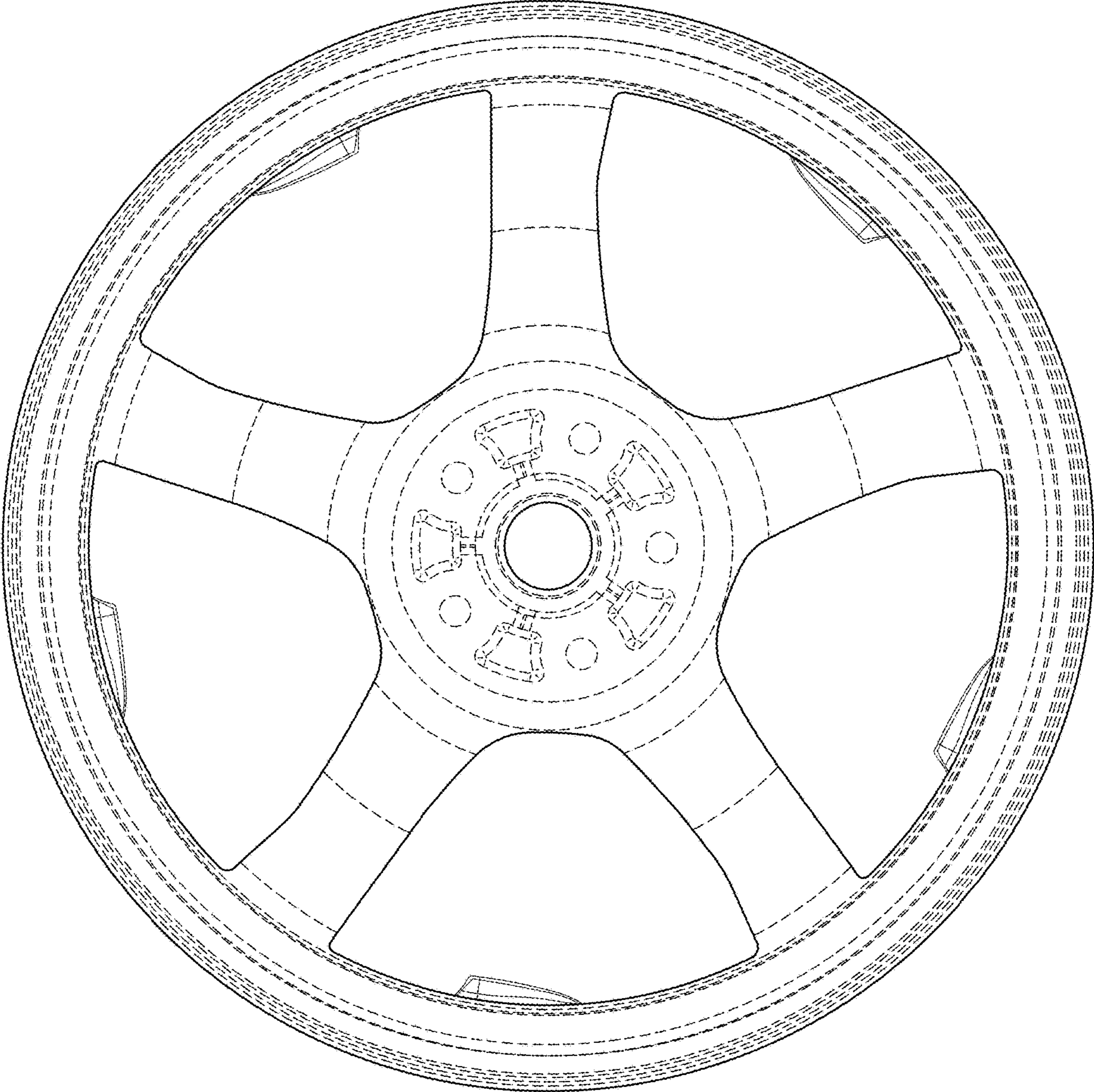

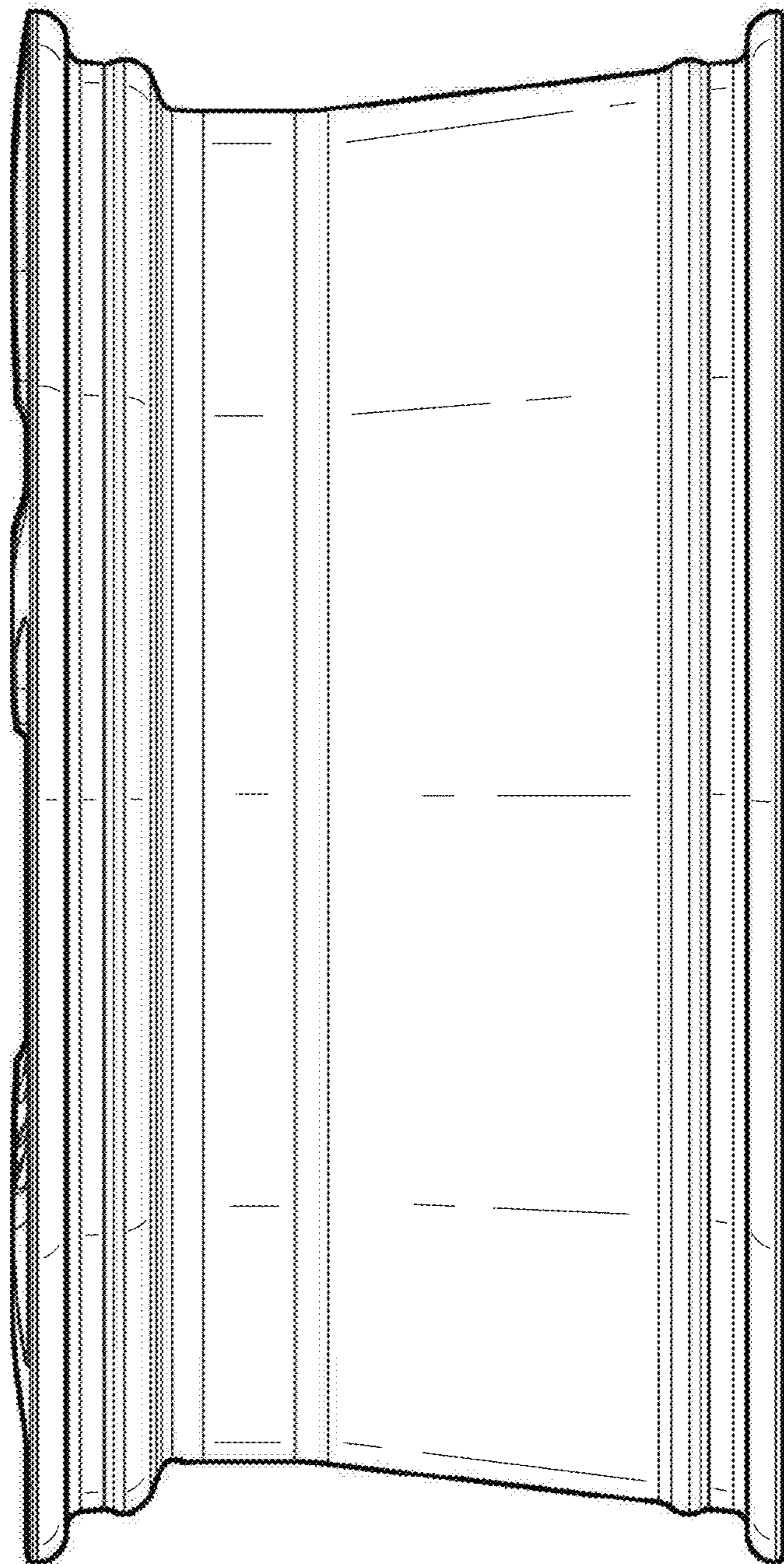

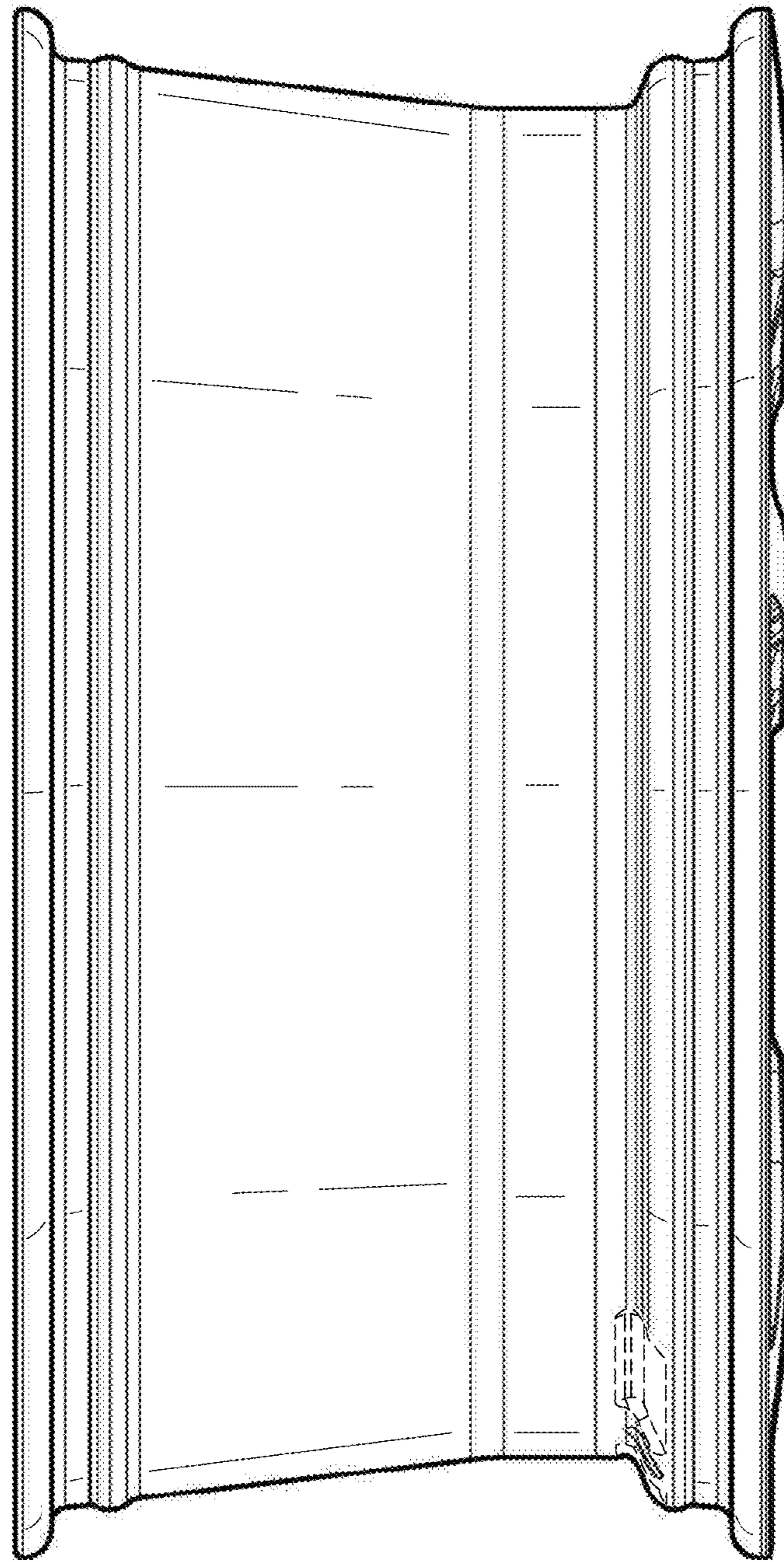

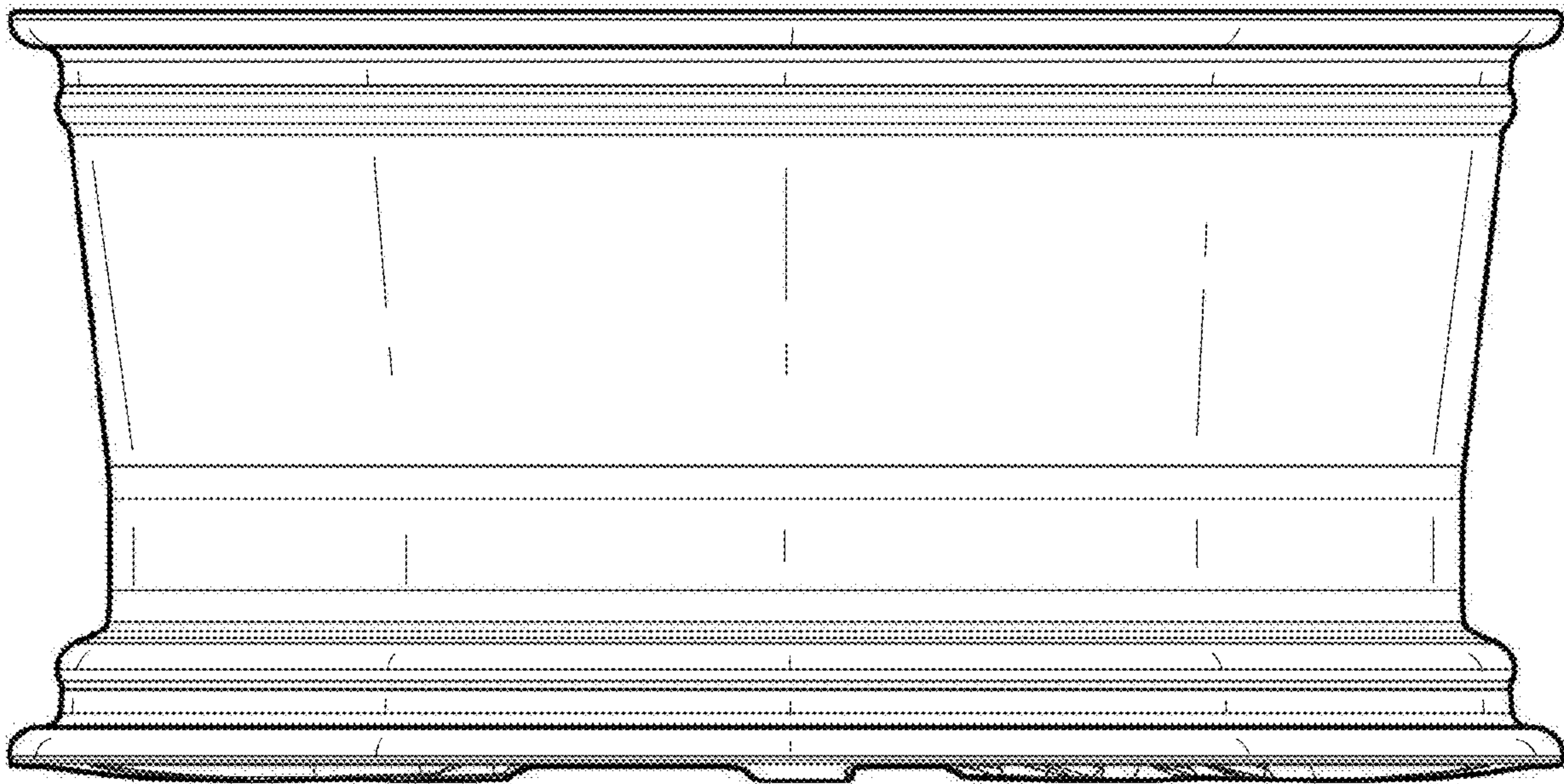

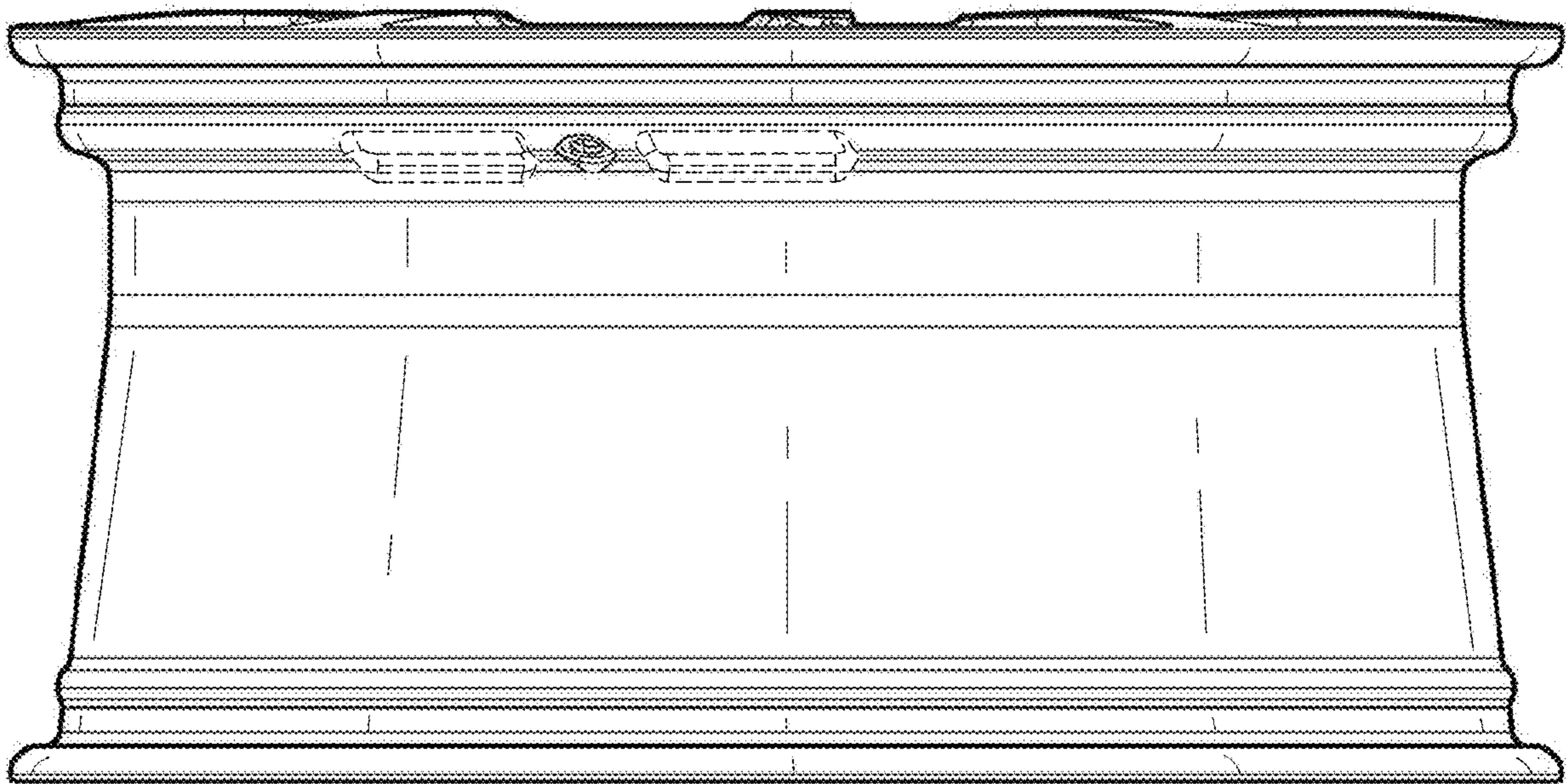

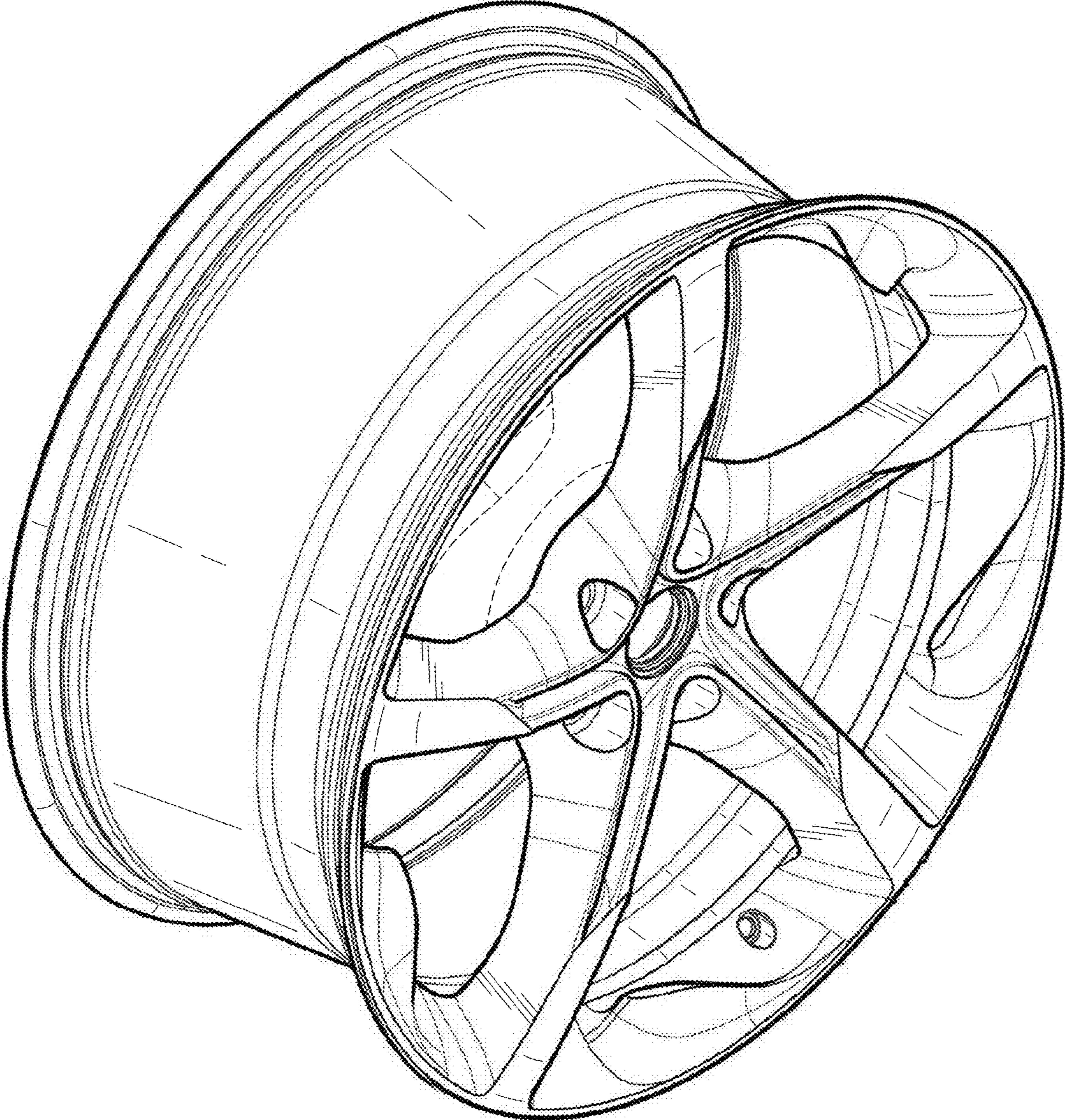

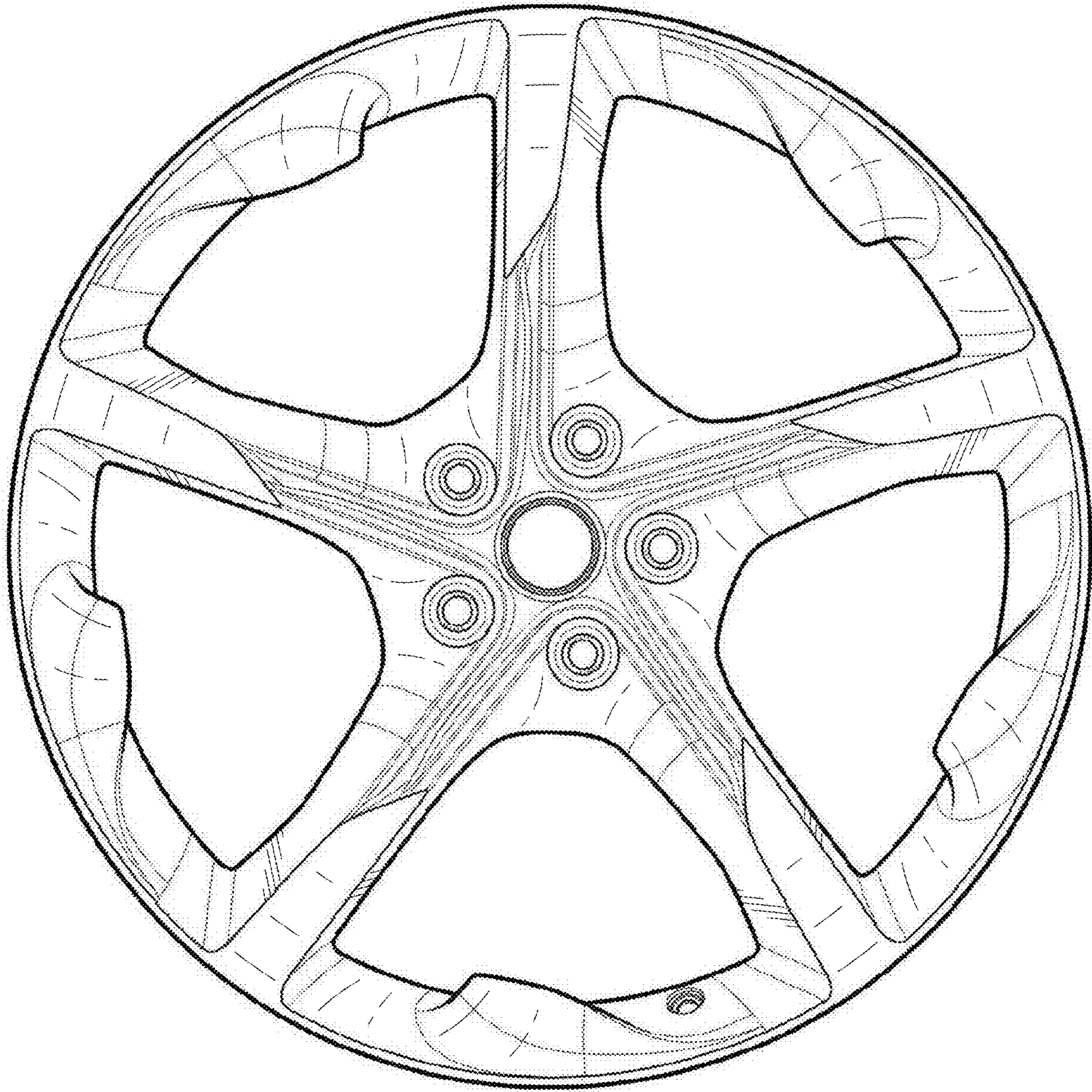

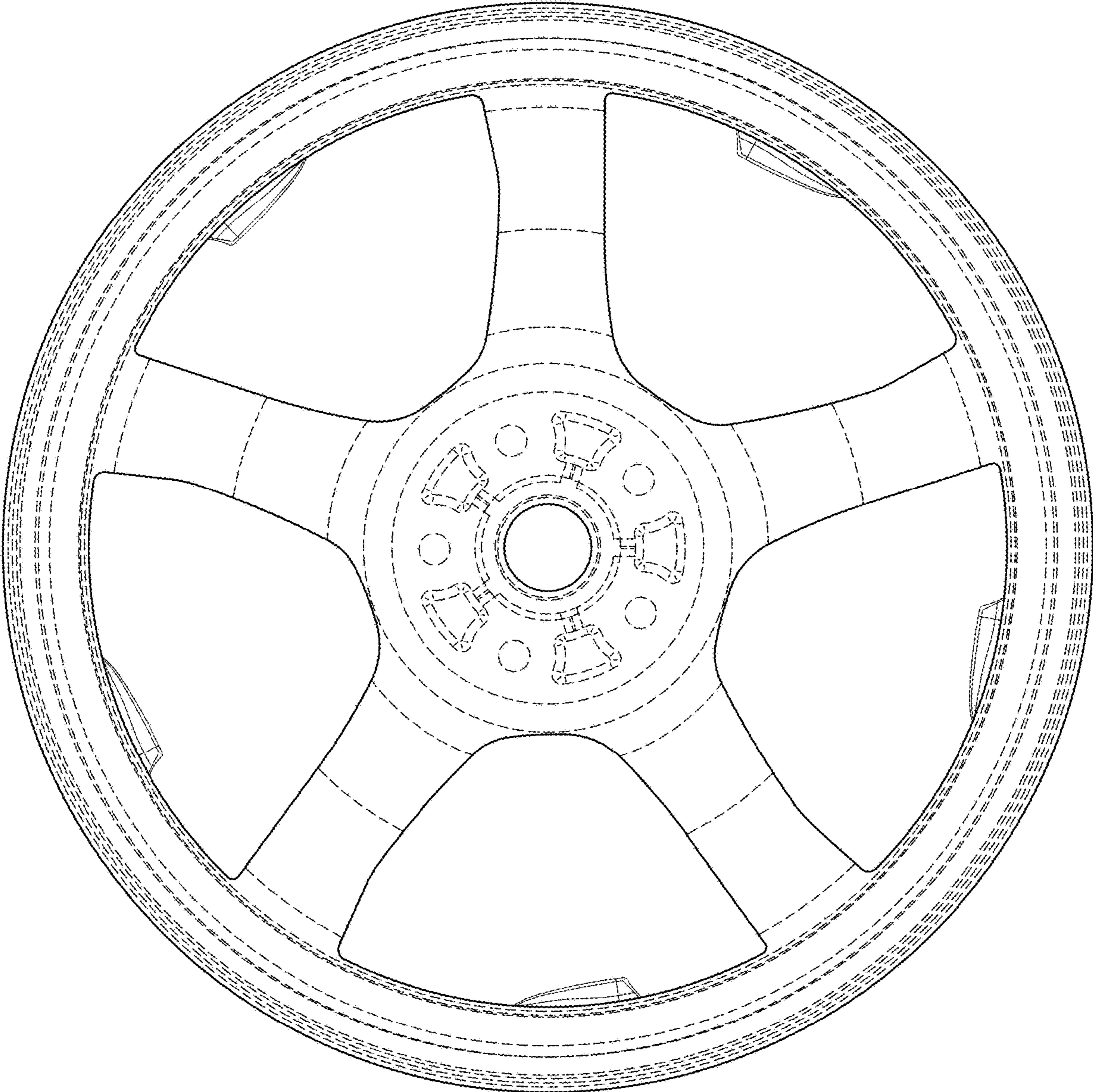

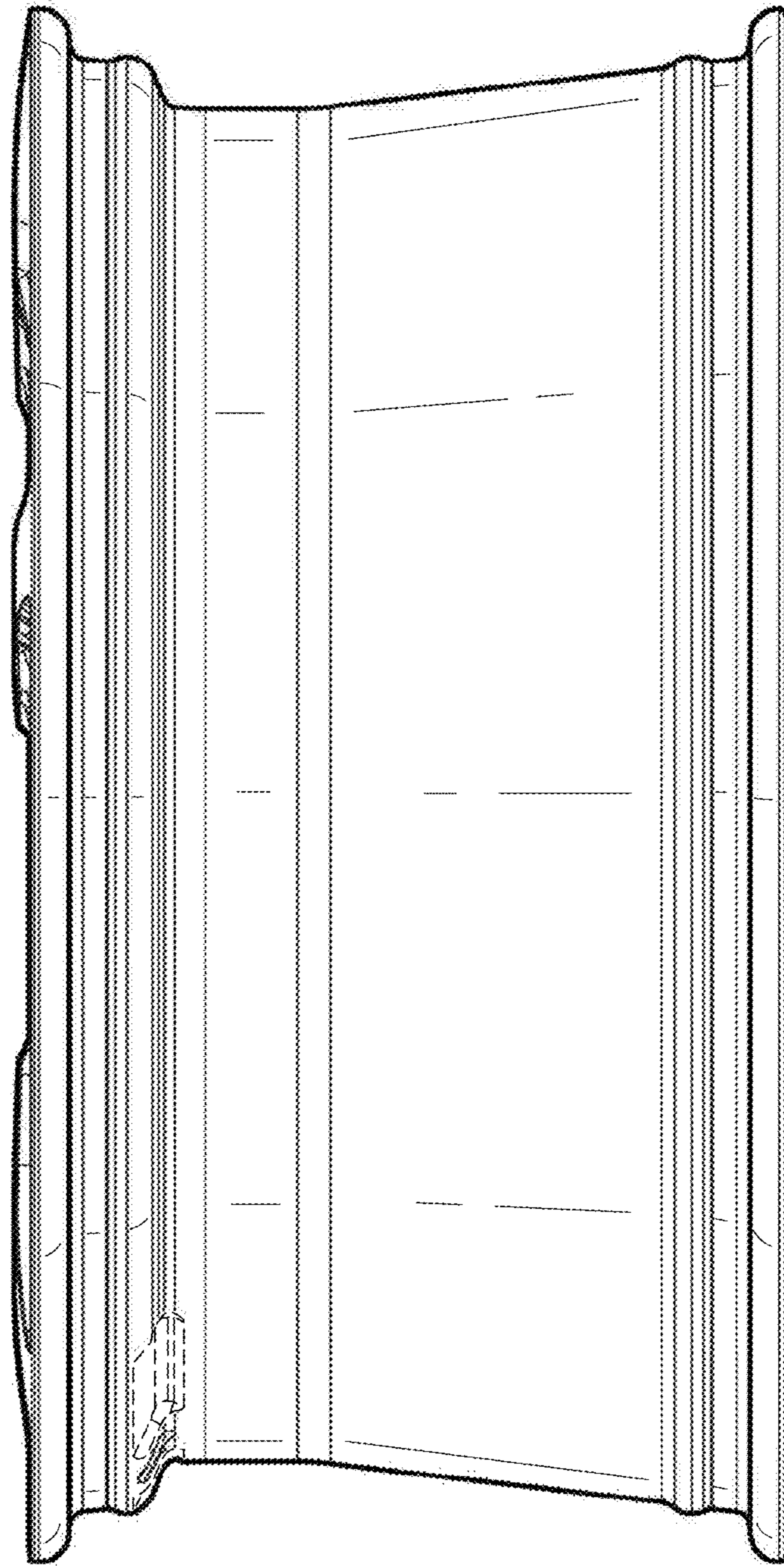

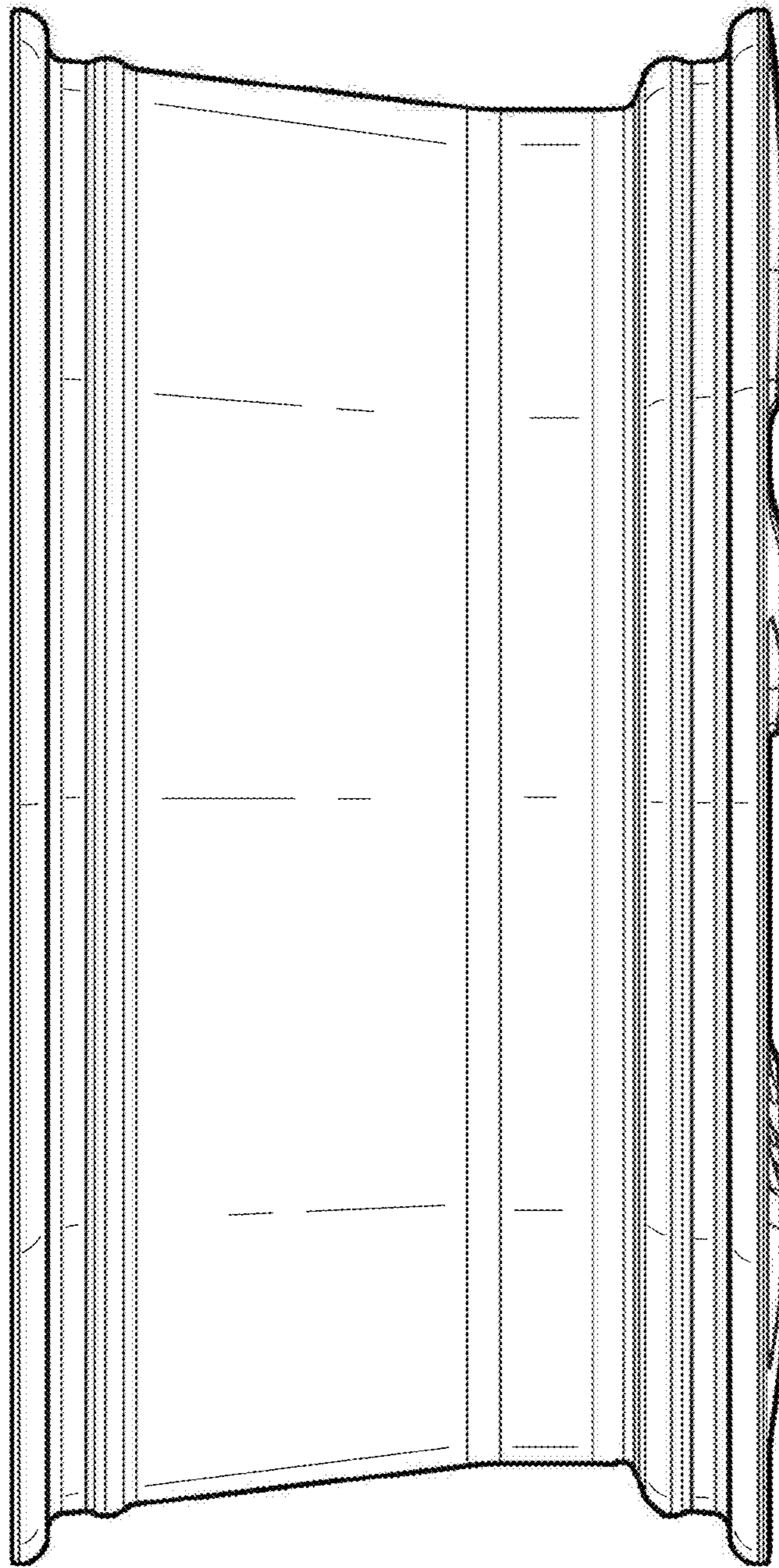

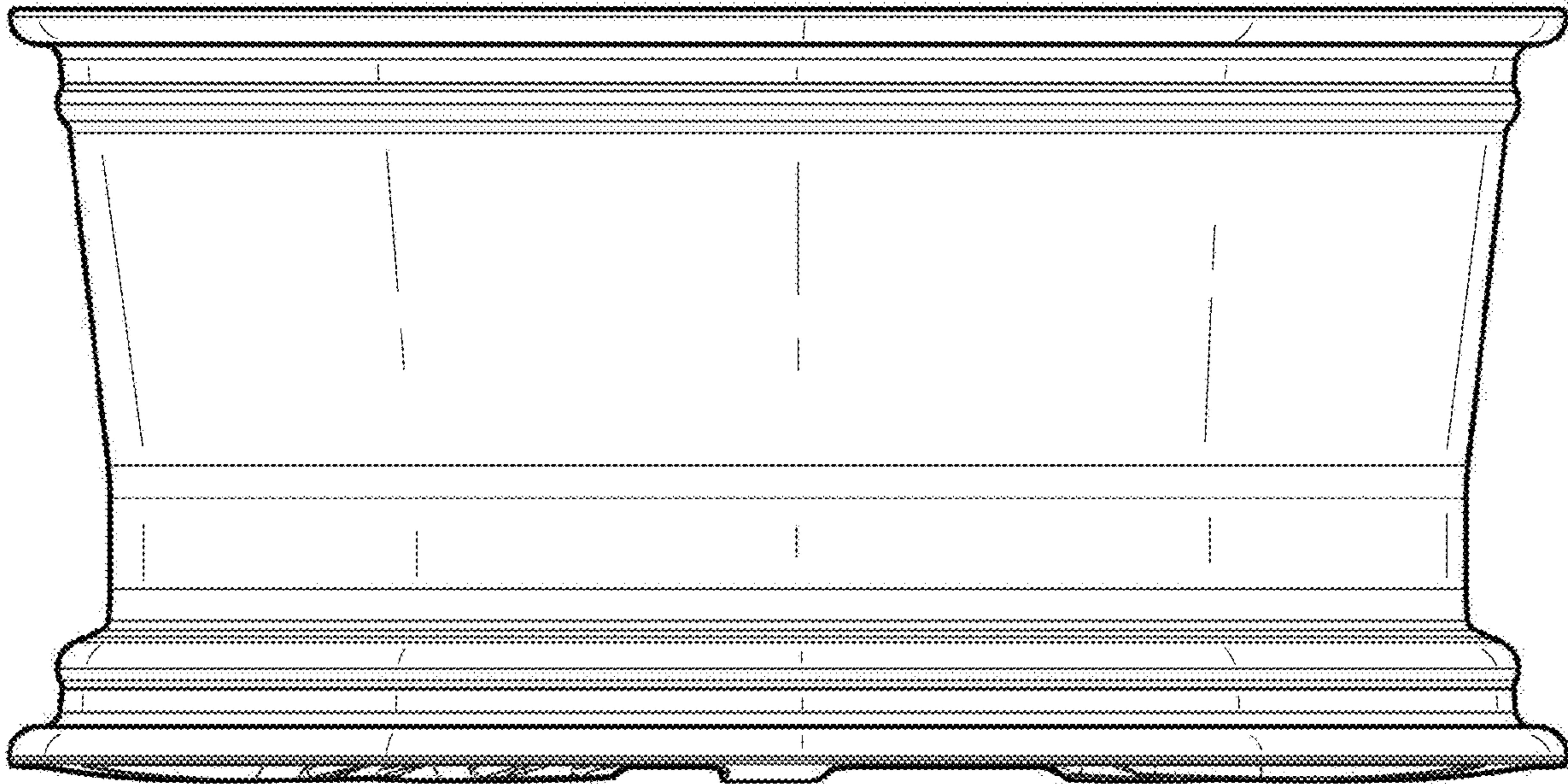

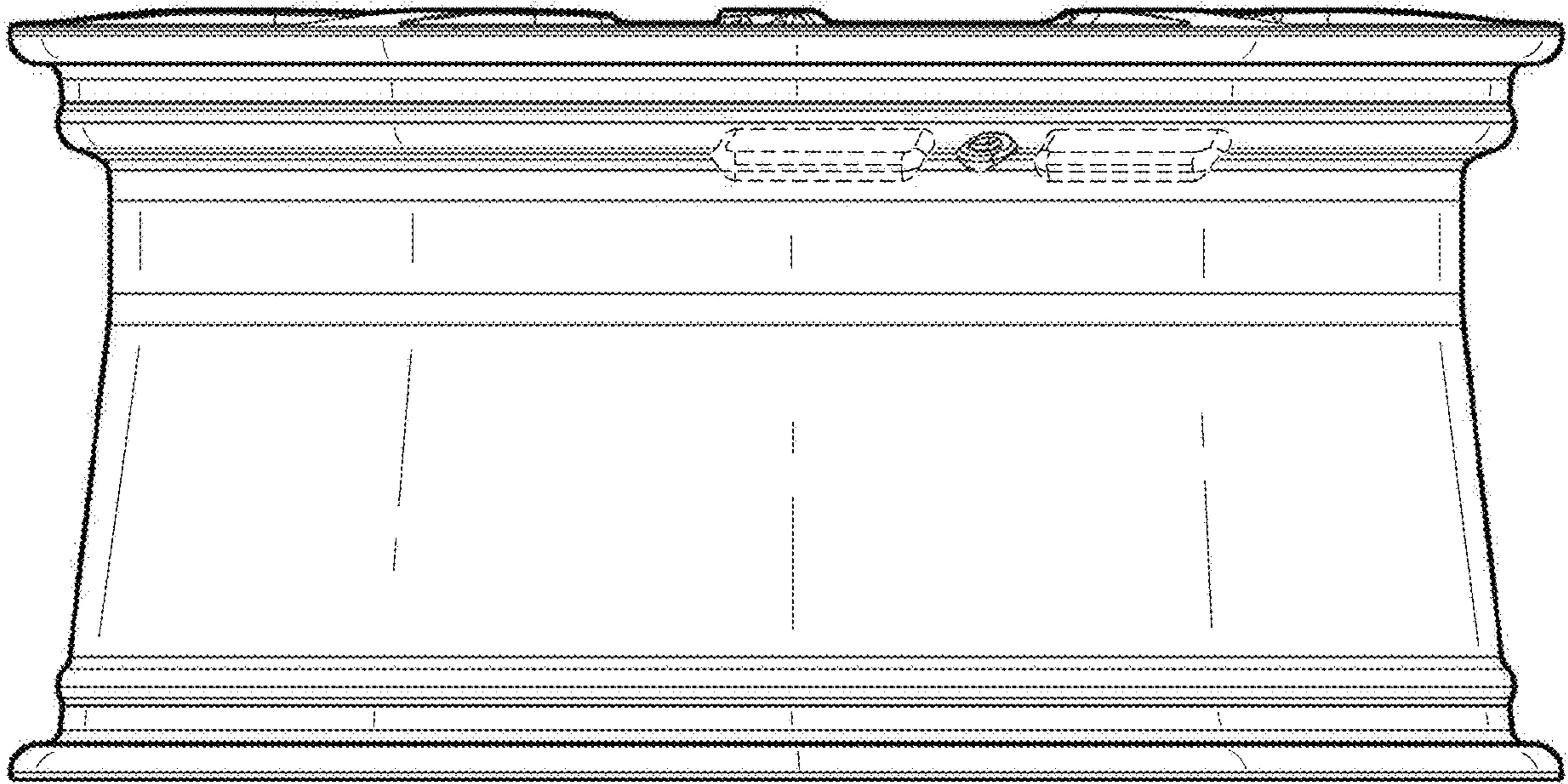
