DESCRIPTION

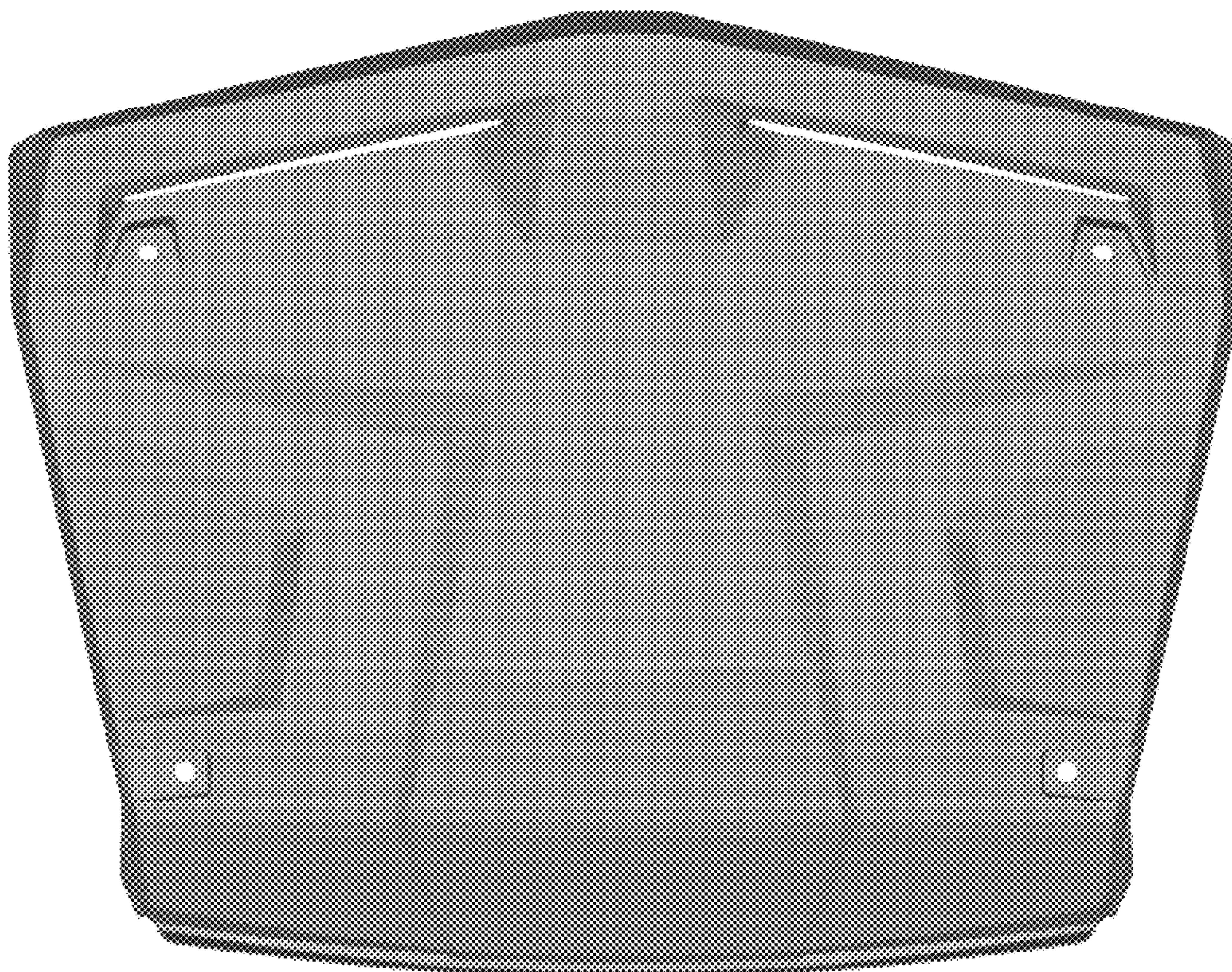

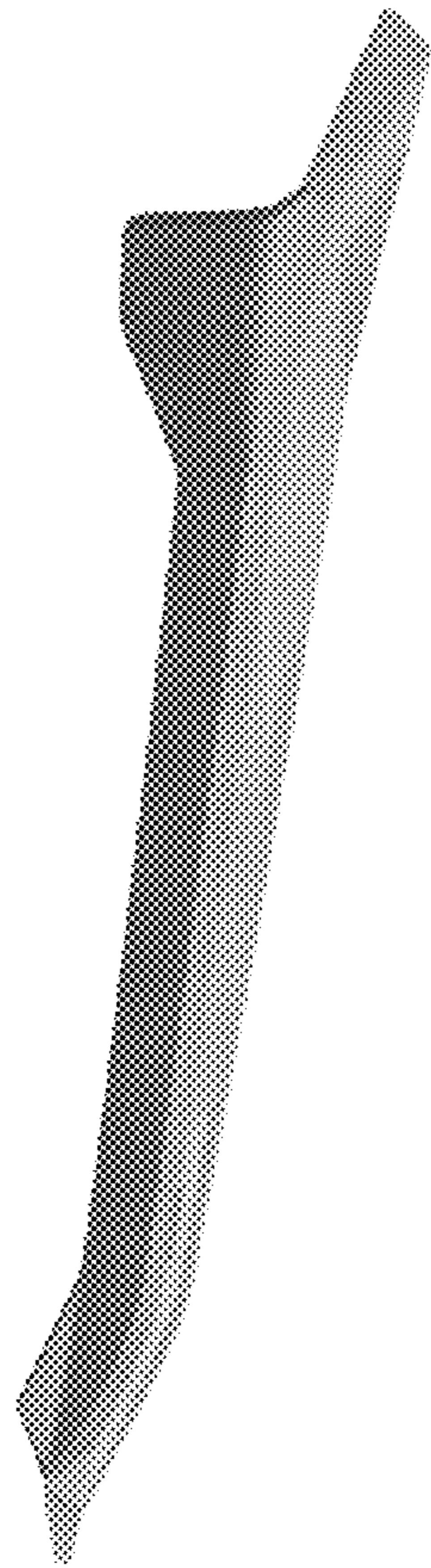

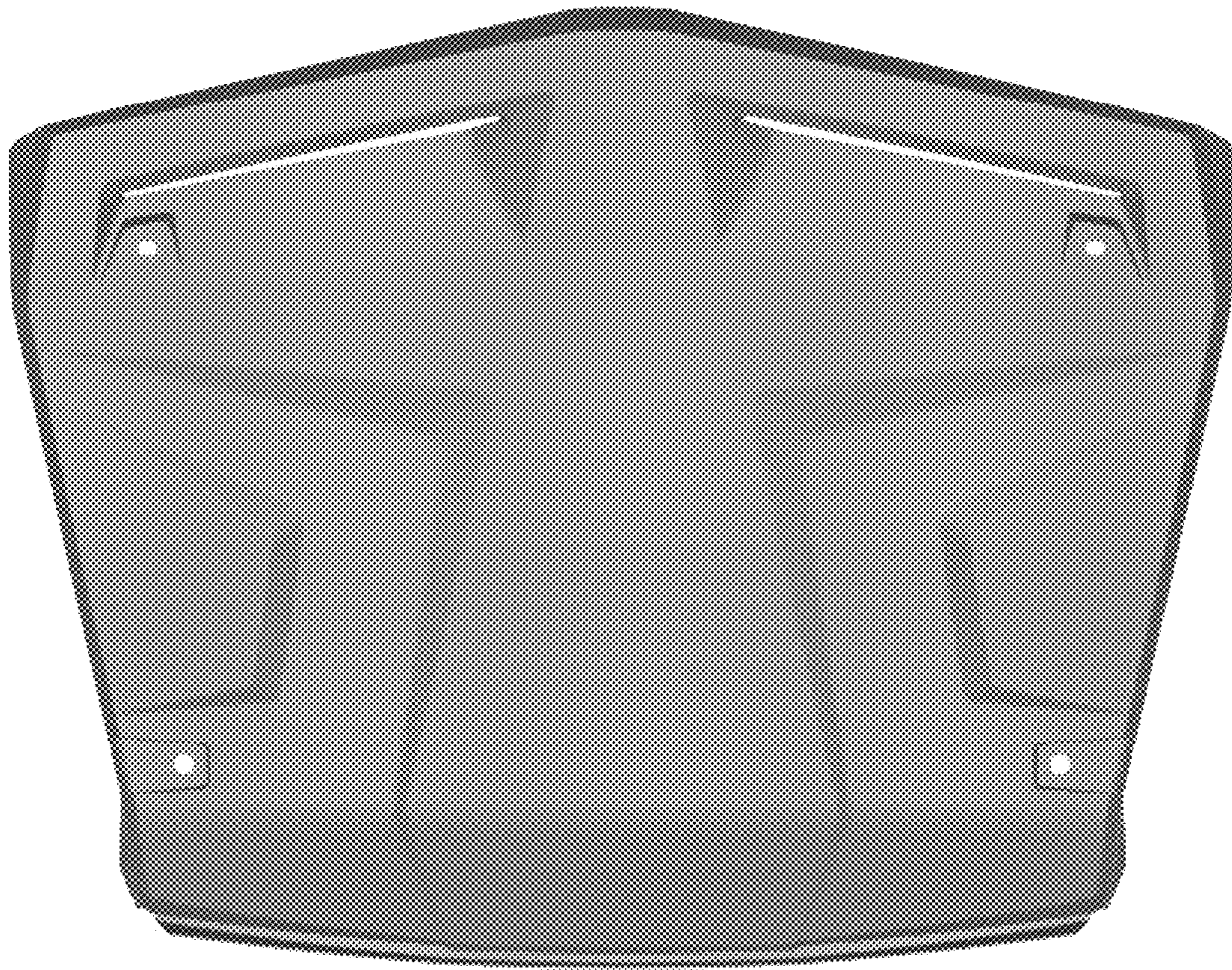

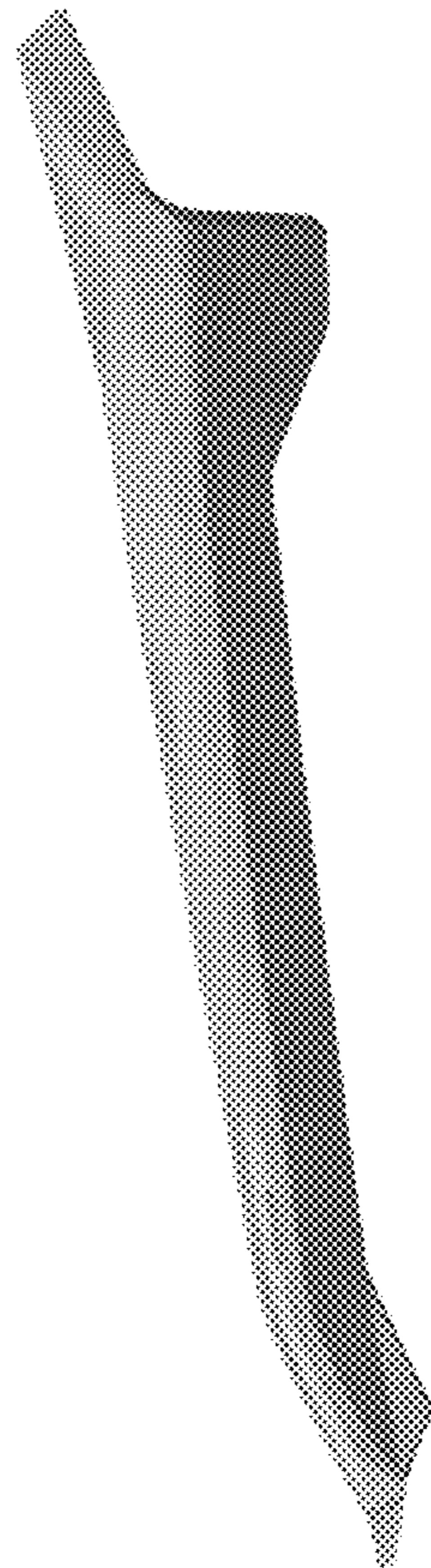

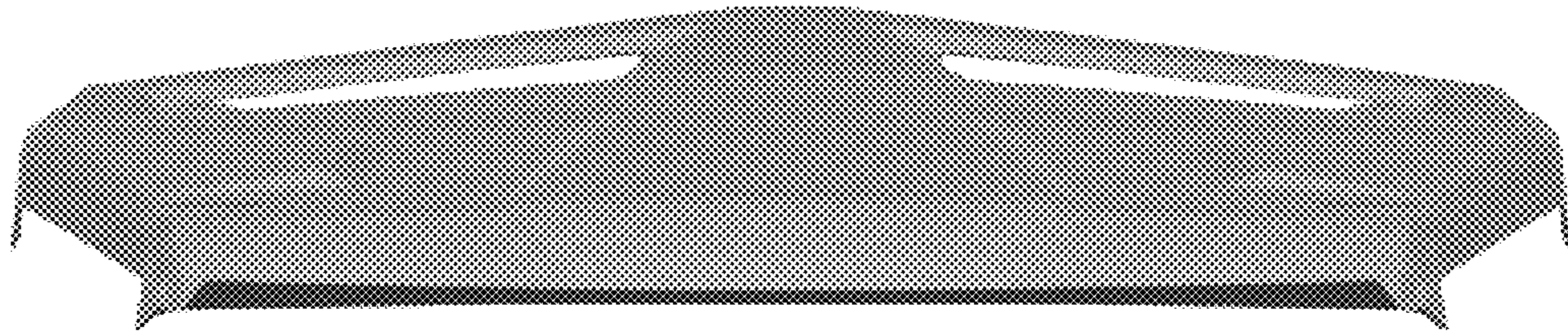

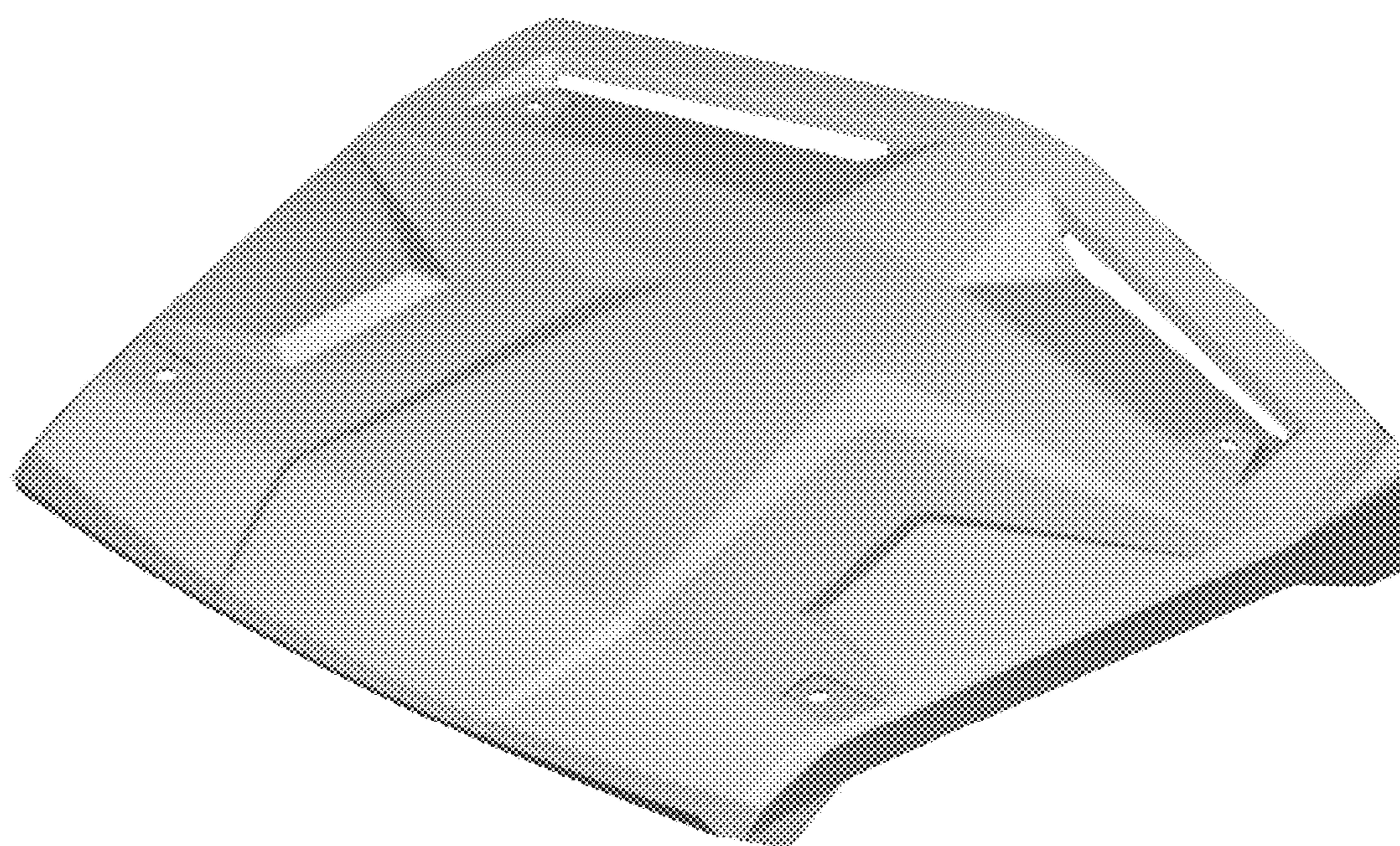

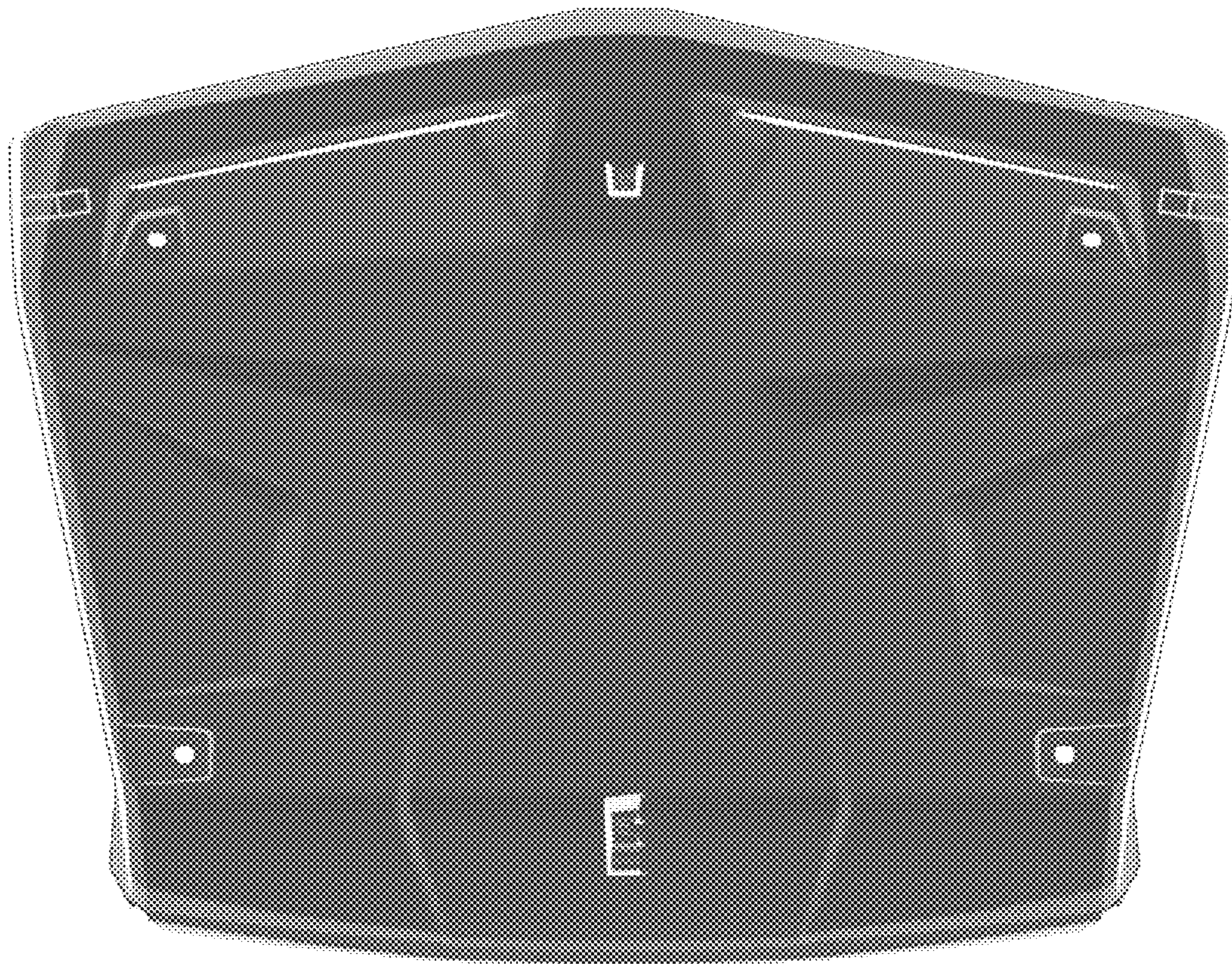

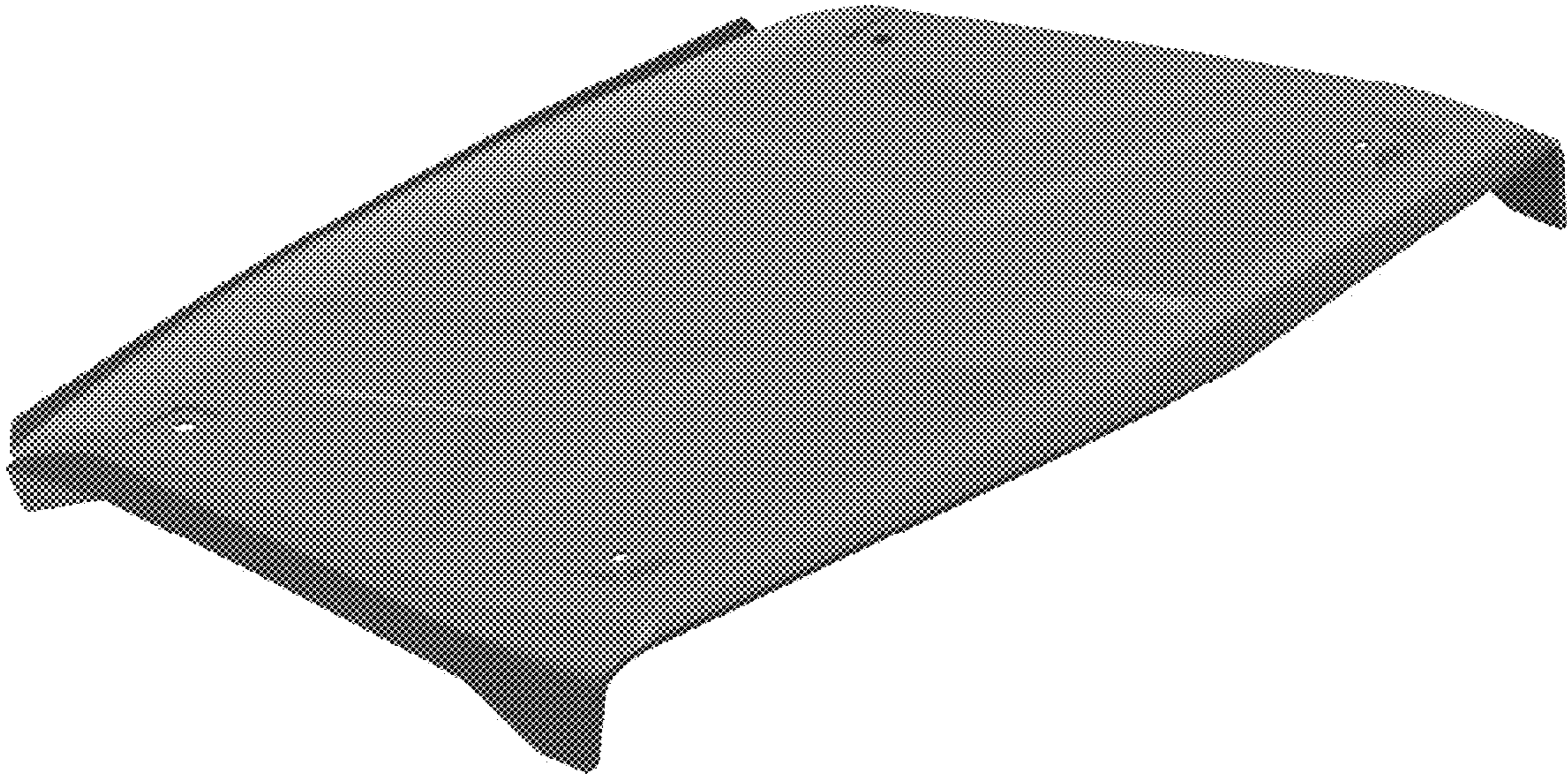
