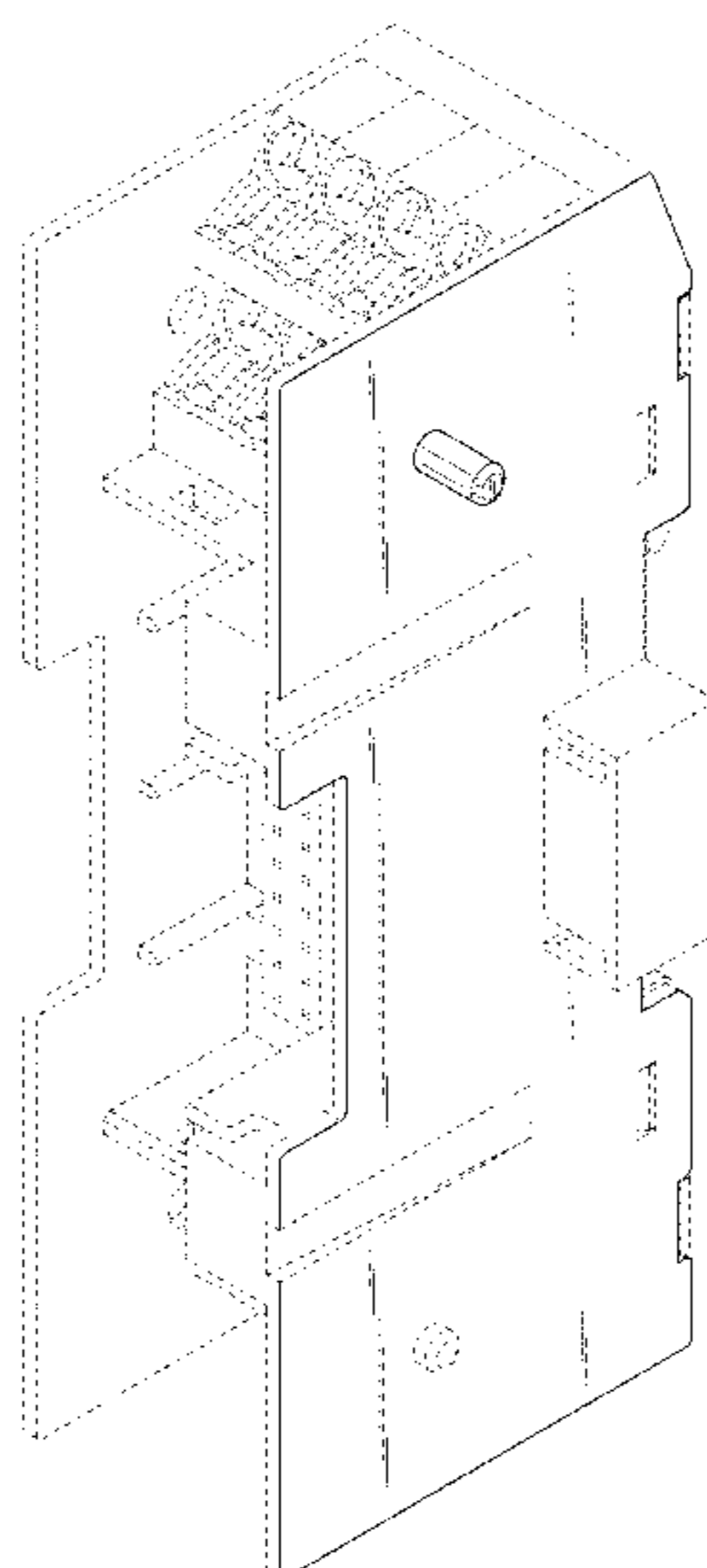
The ornamental design for a terminal block, as shown and described.

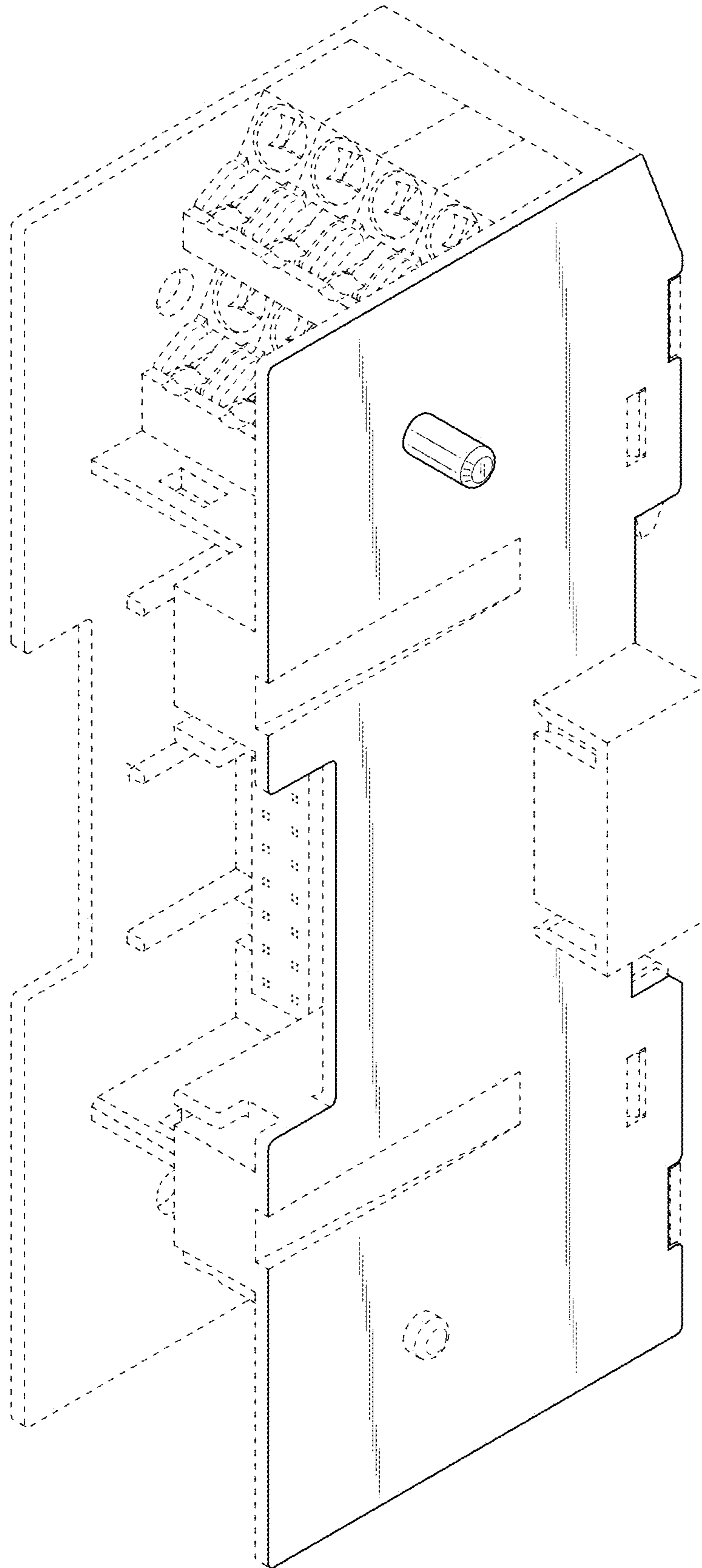

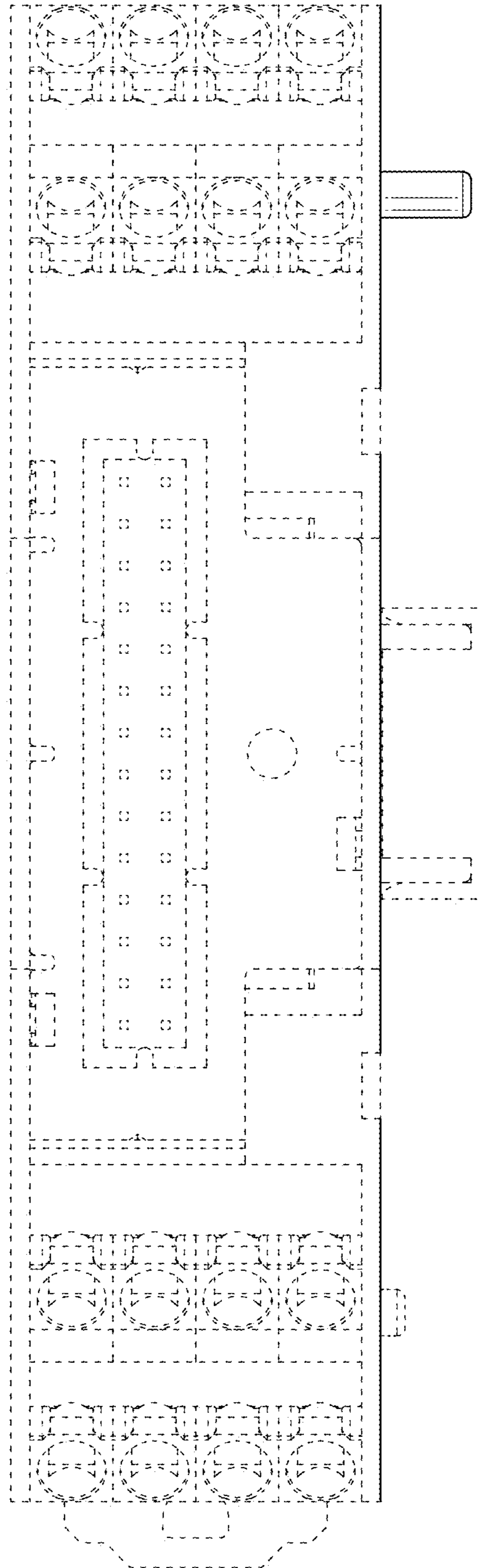

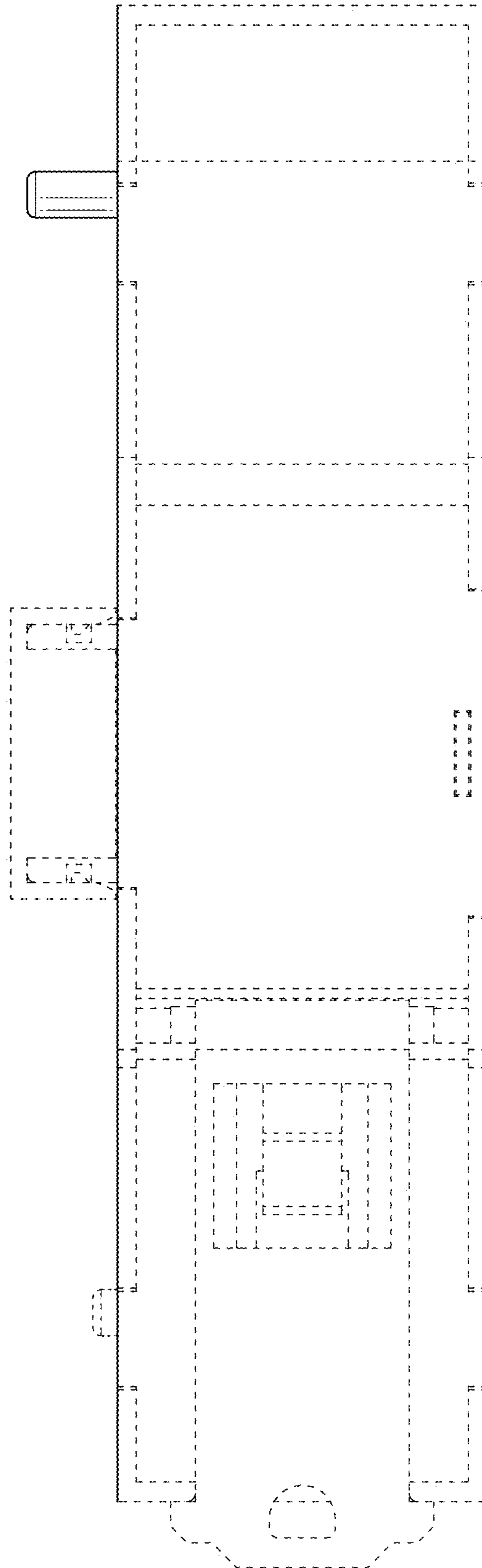

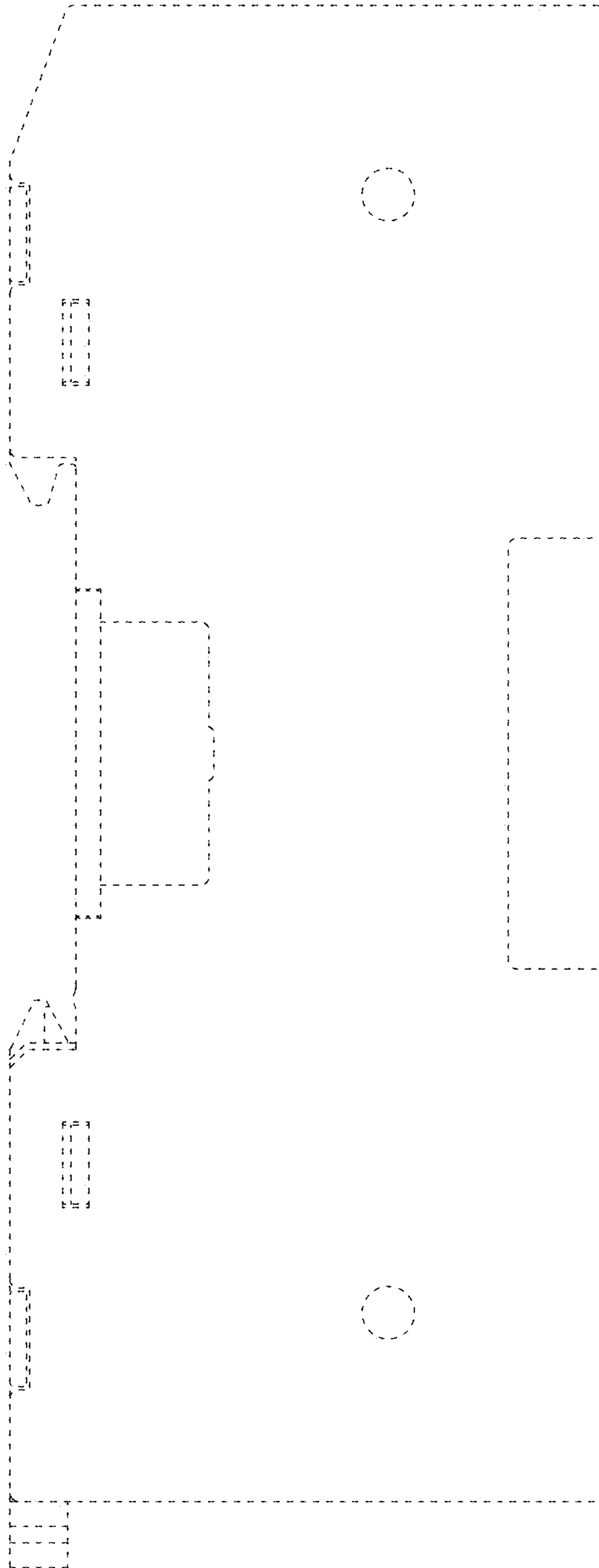

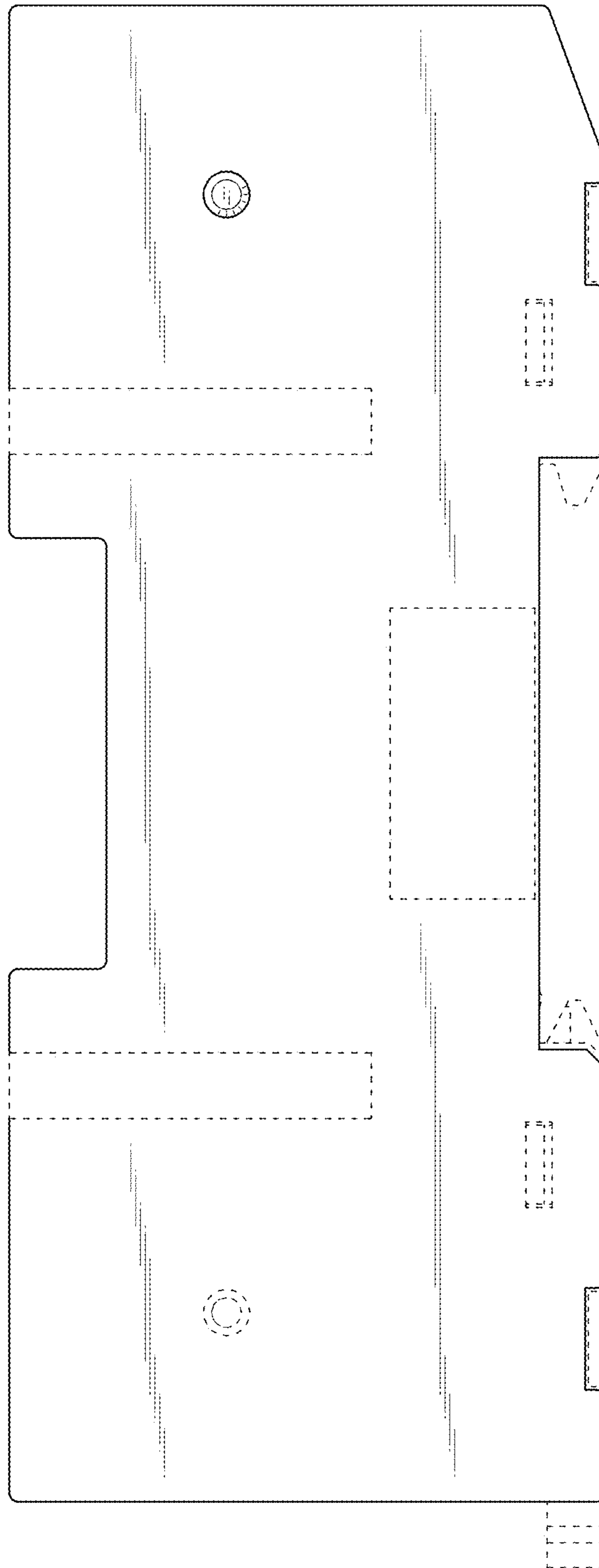

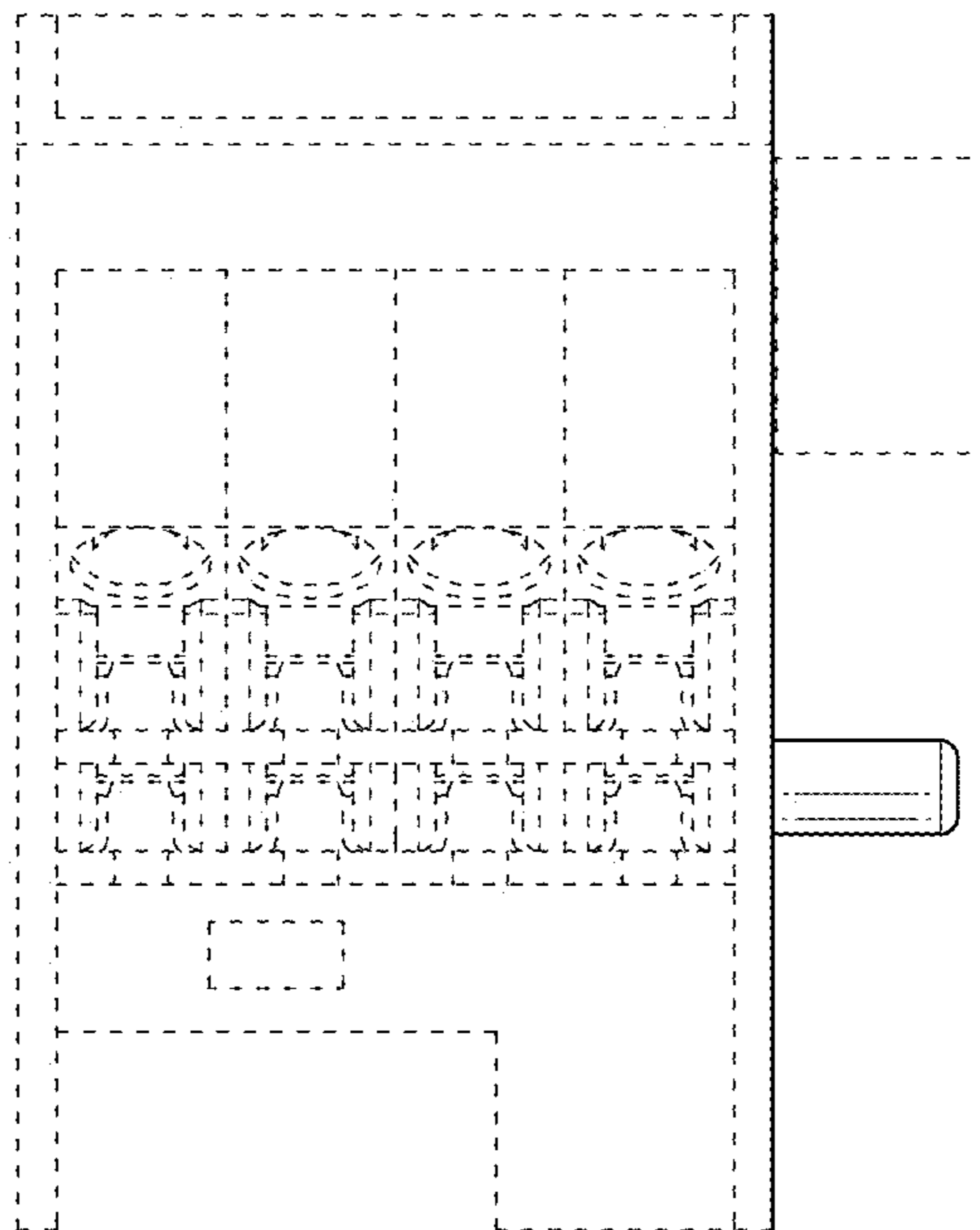
