(57) **CLAIM**

The ornamental design for a display device with a graphical user interface presenting an invoice tracker, as shown and described.

DESCRIPTION

FIG. 1 is a front view of a first image in a sequence for a display device with a graphical user interface presenting an invoice tracker; and,

FIG. 2 is a second image thereof.

The appearance of the transitional image sequentially transitions between the images shown in FIGS. 1-2. The process or period in which one image transitions to another image forms no part of the claimed design.

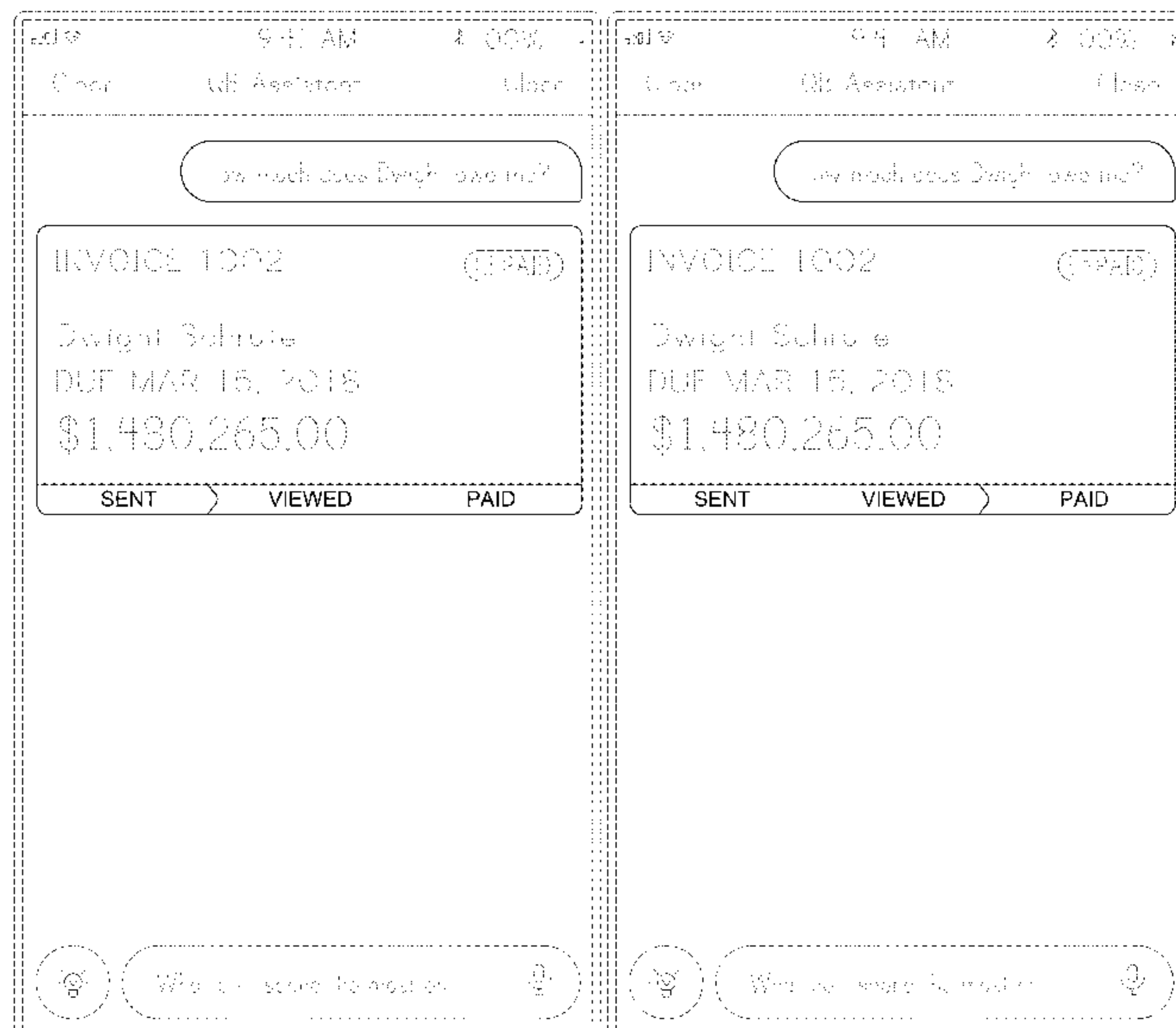

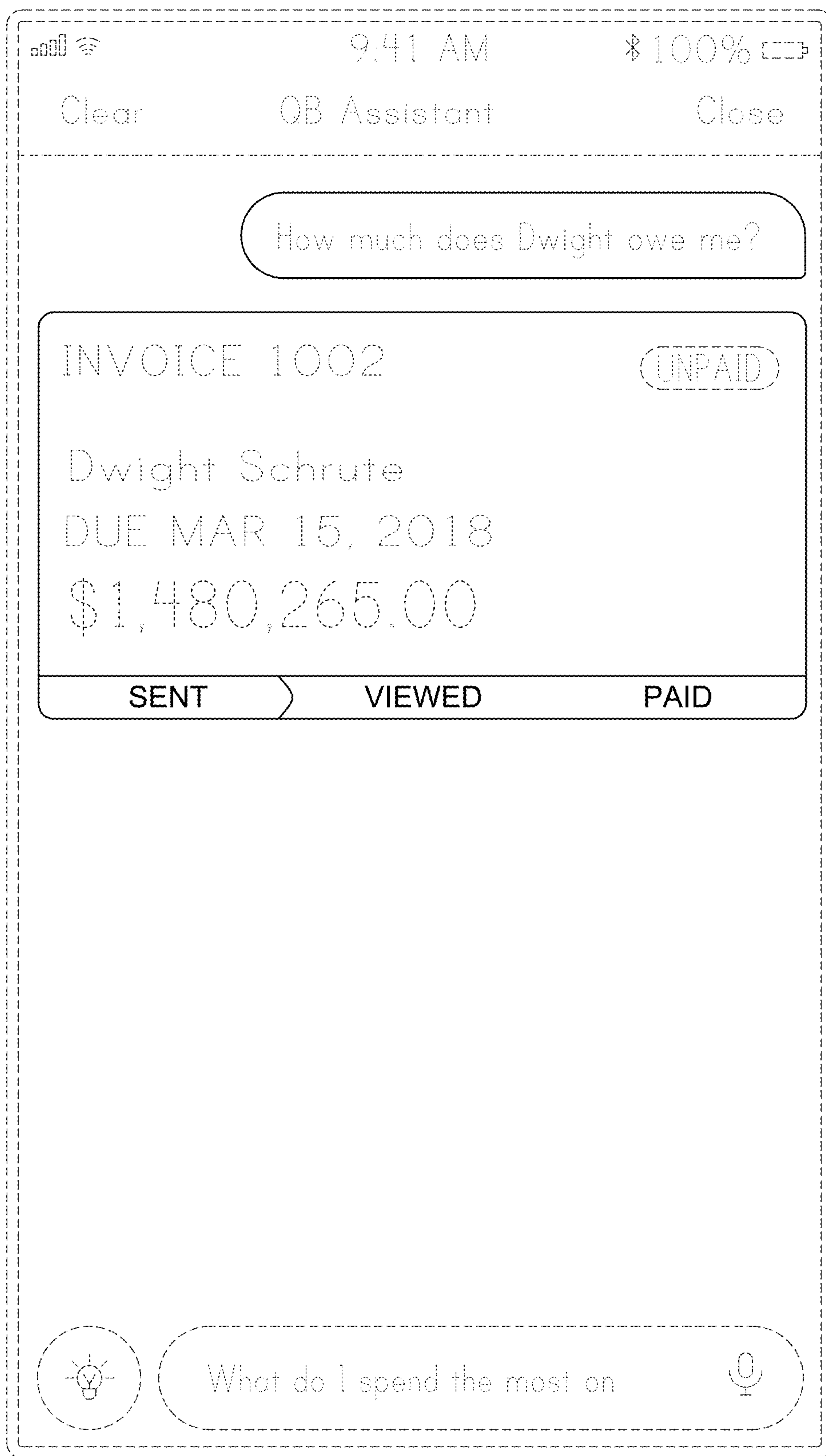

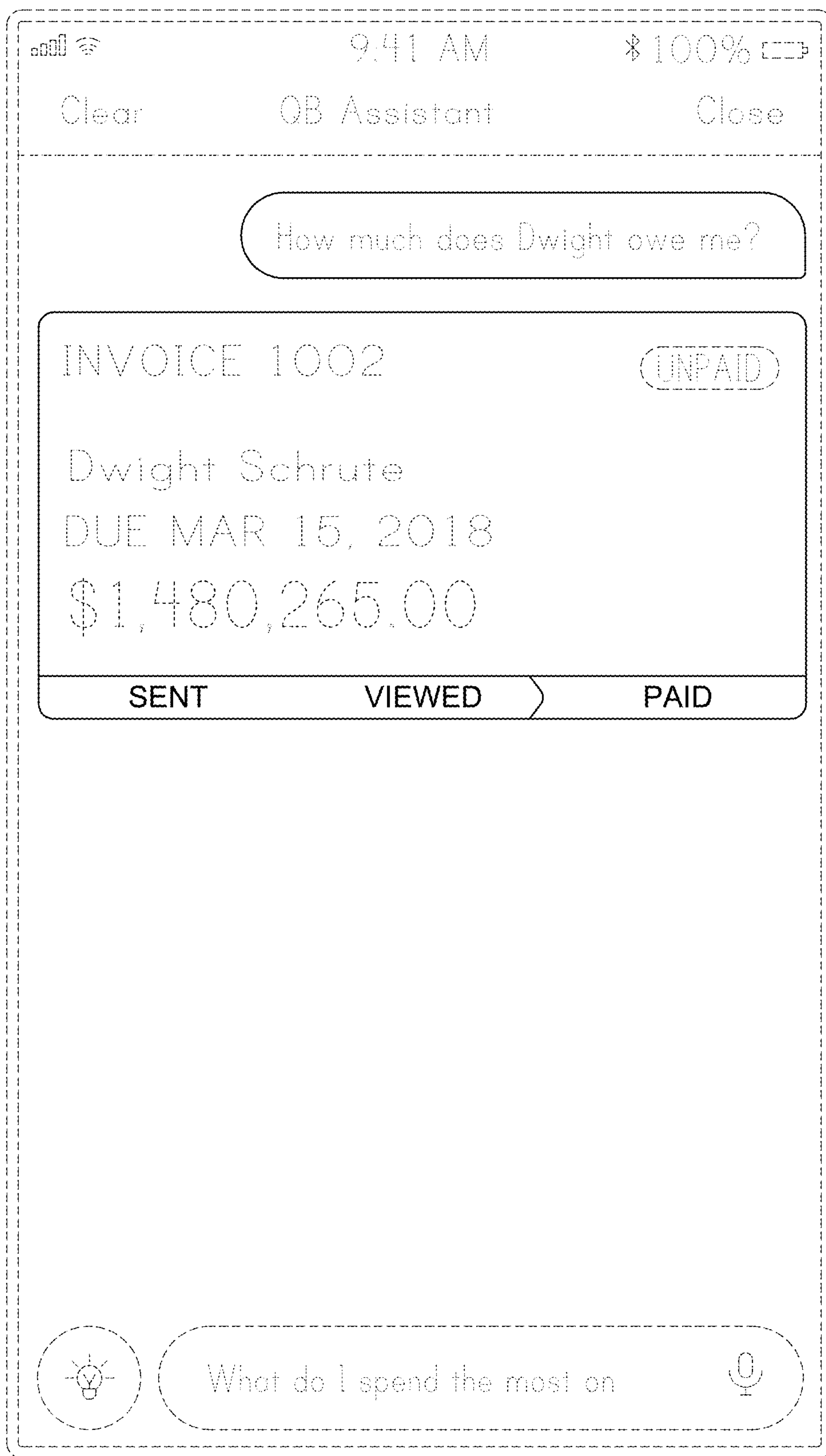
