The ornamental design for a display screen or portion thereof having a graphical user interface for scoring one or more individuals, as shown and described.

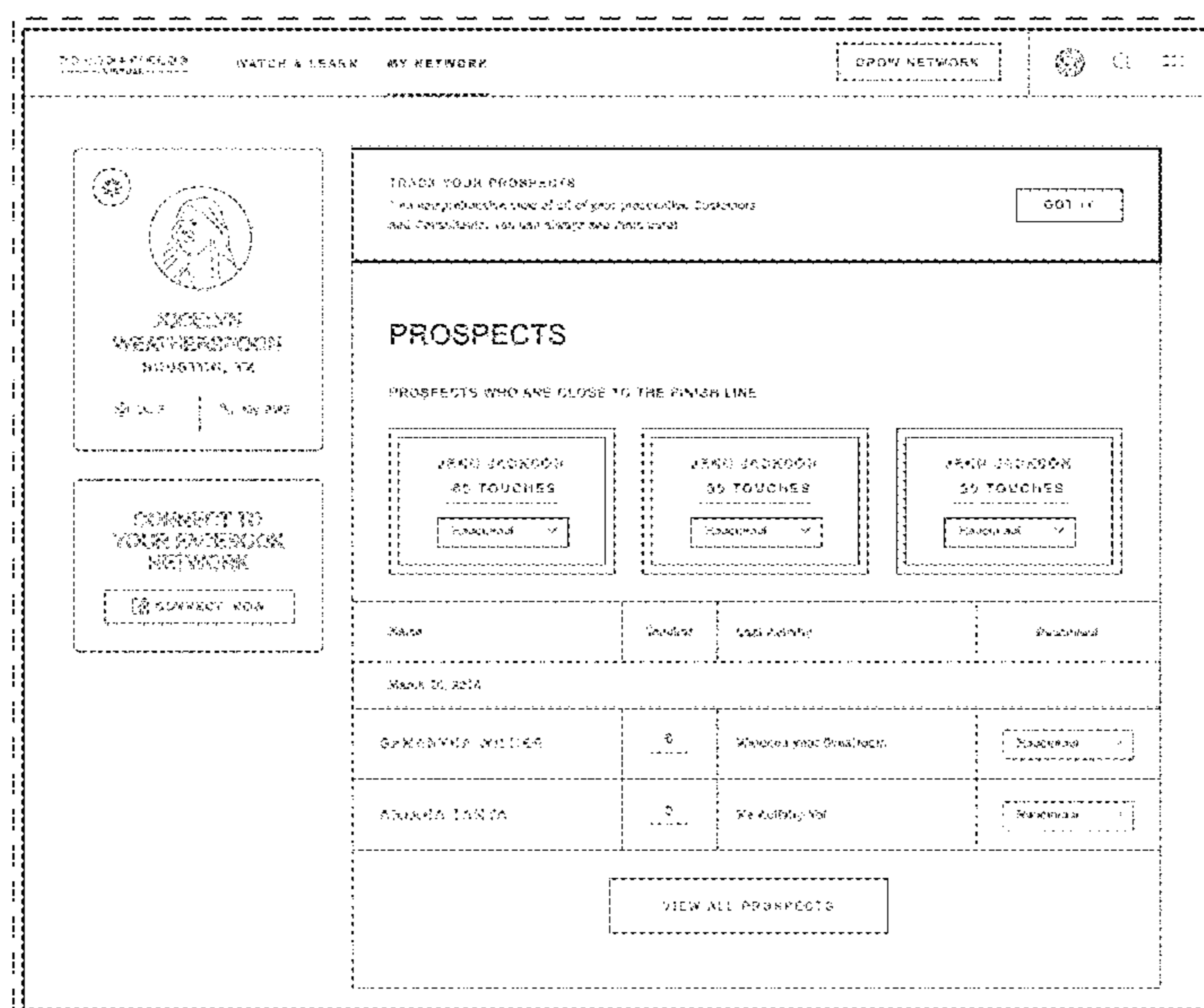
DESCRIPTION
