(57) **CLAIM**

The ornamental design for machine tool for drilling deep holes, as shown and described.

DESCRIPTION

FIG. 1 is a top view of a machine tool for drilling deep holes; FIG. 2 is a perspective view of a fourth side and of a first side thereof; FIG. 3 is a front view of the fourth side thereof; FIG. 4 is a front view of the first side thereof; FIG. 5 is a perspective view of a second side and a third side thereof; FIG. 6 is a front view of the second side thereof; and, FIG. 7 is a front view of the third side thereof. The broken lines in the drawings illustrate portions of the machine tool for drilling deep holes that form no part of the claimed design.

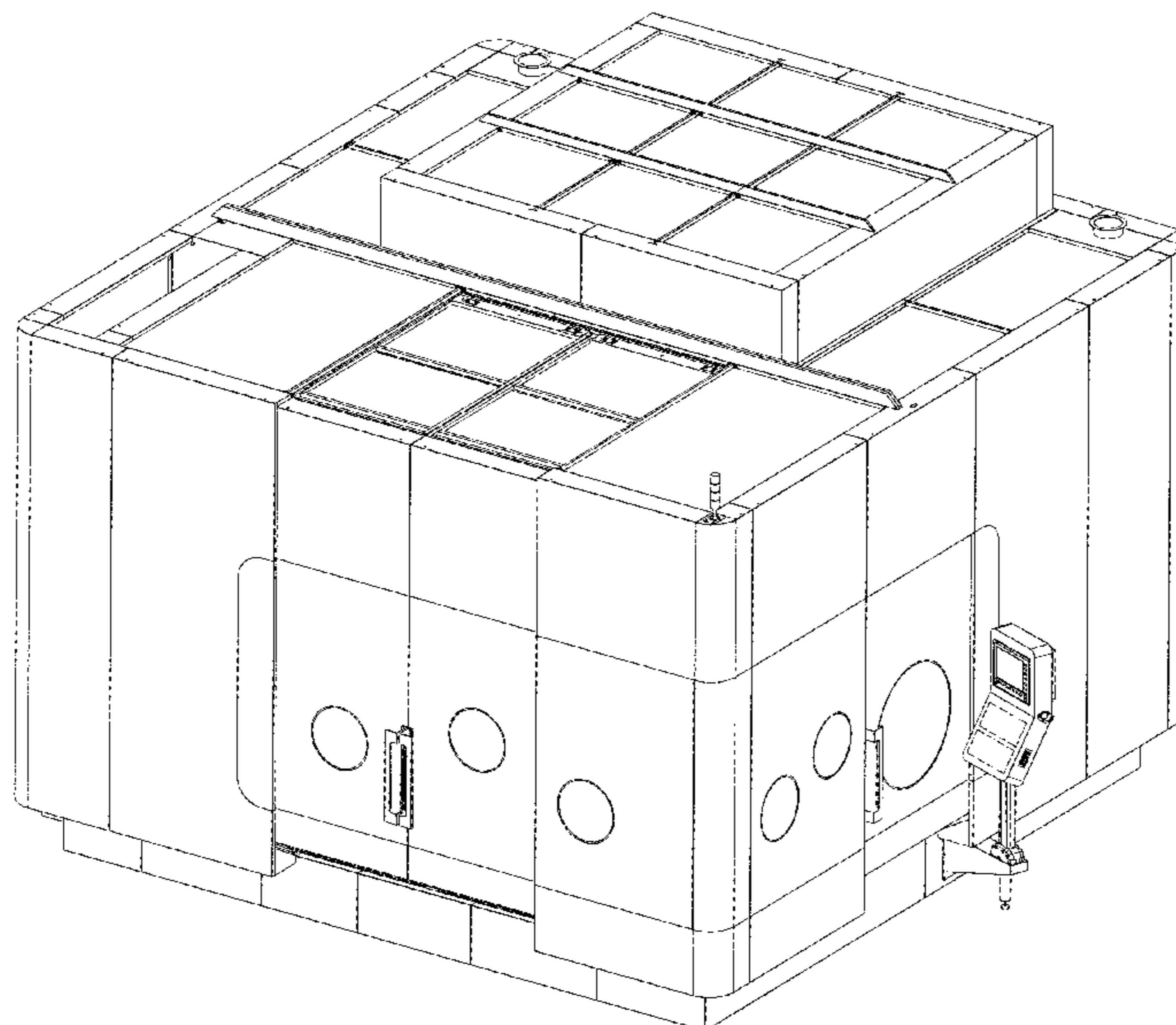

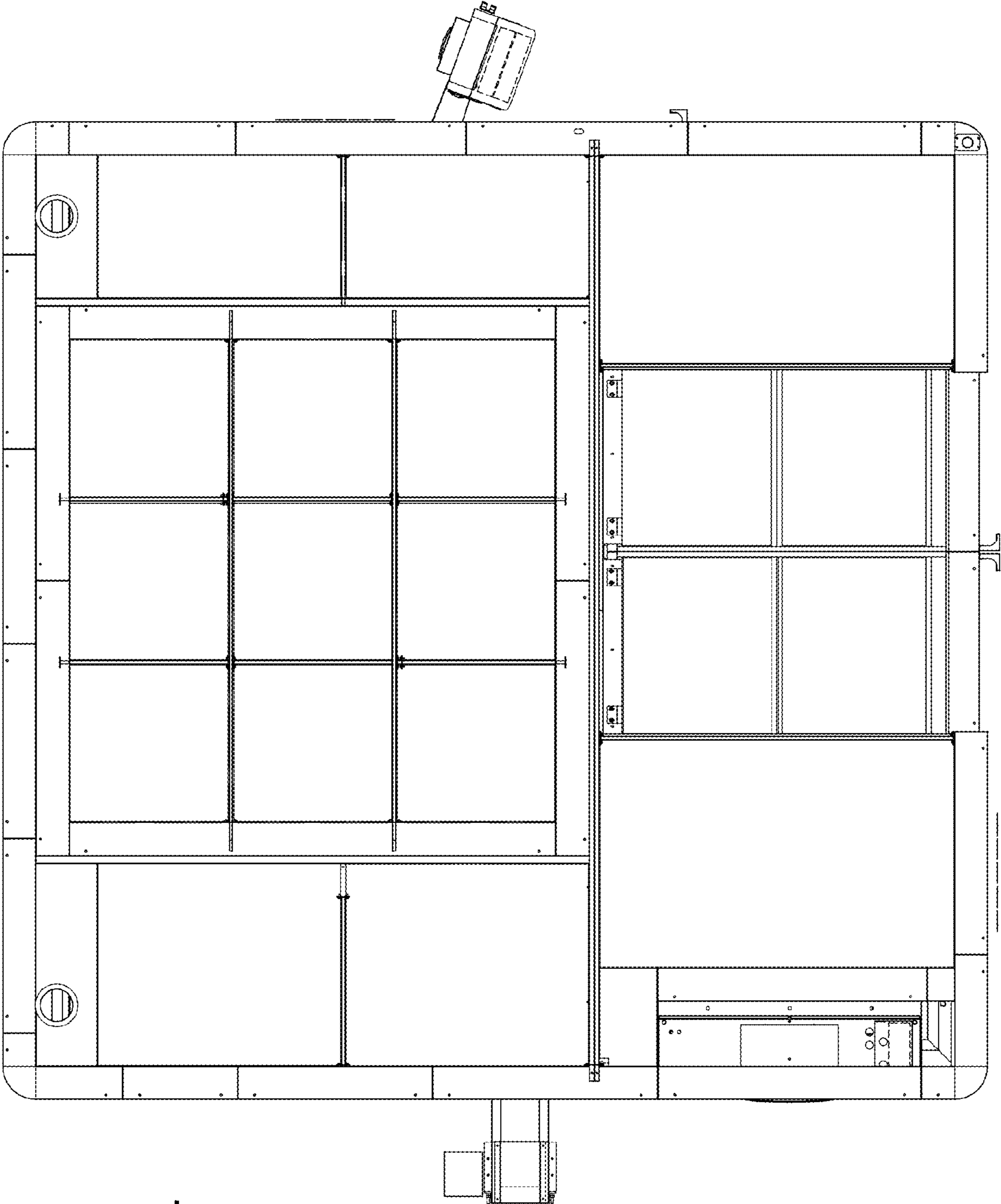

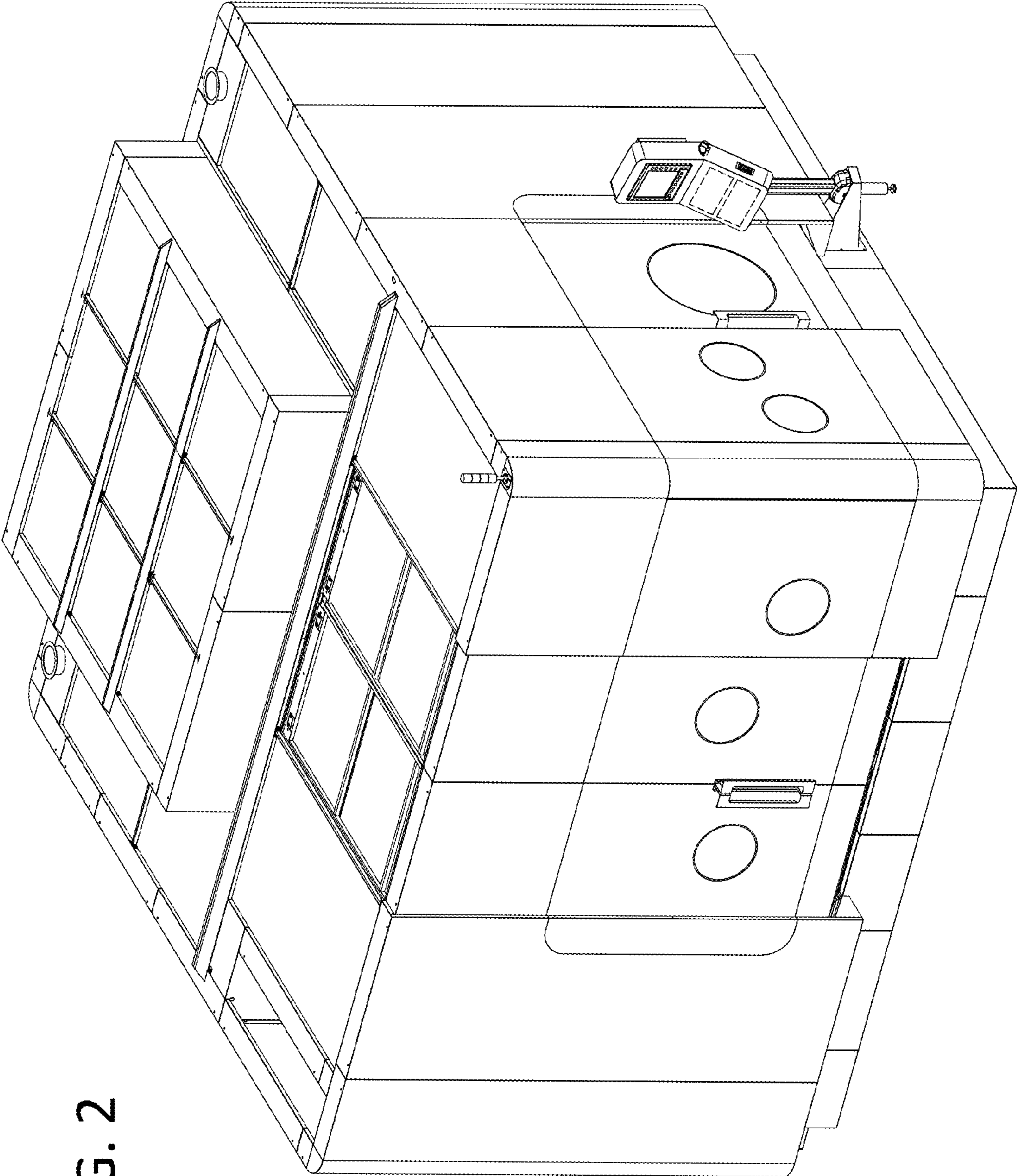

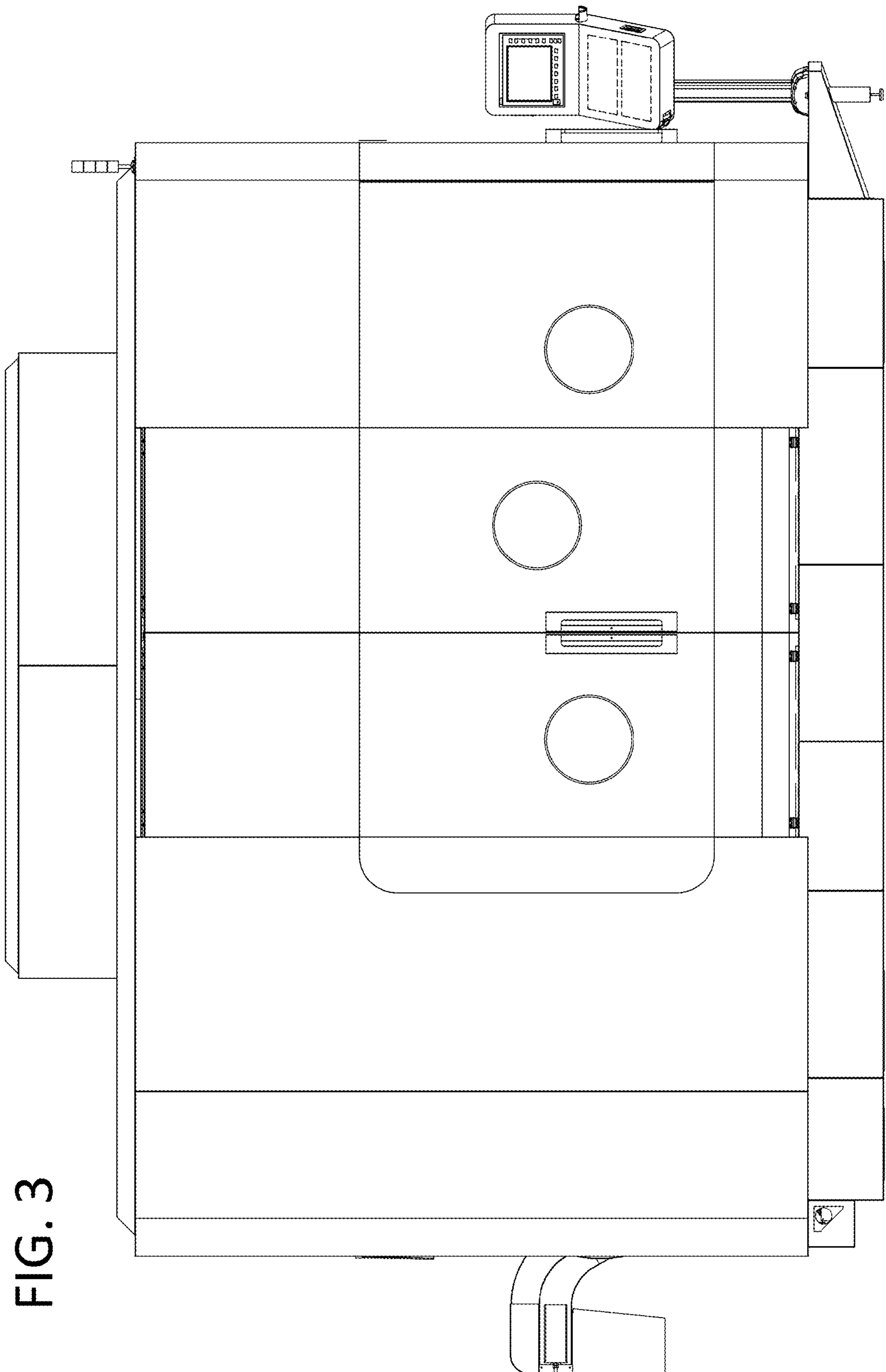
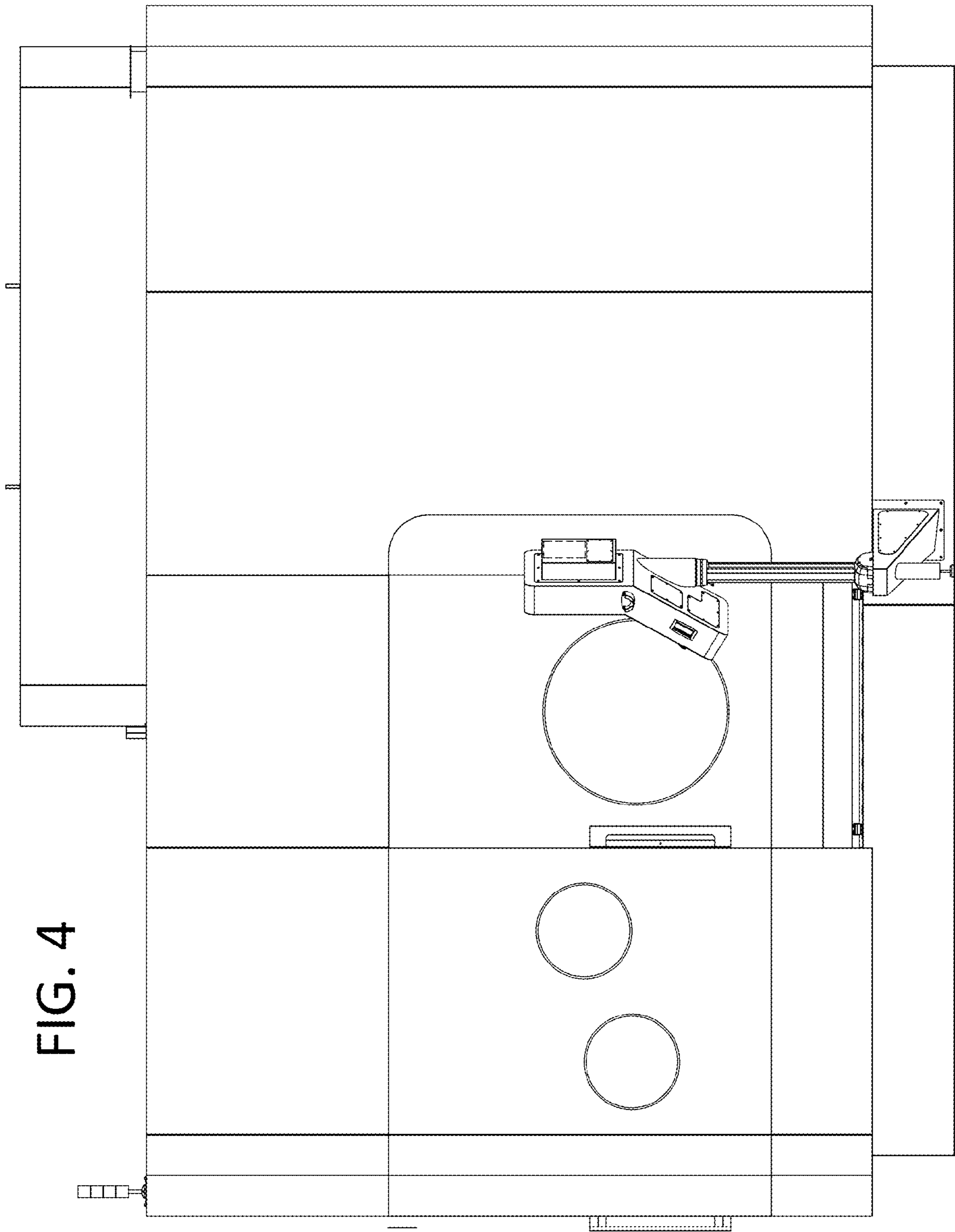

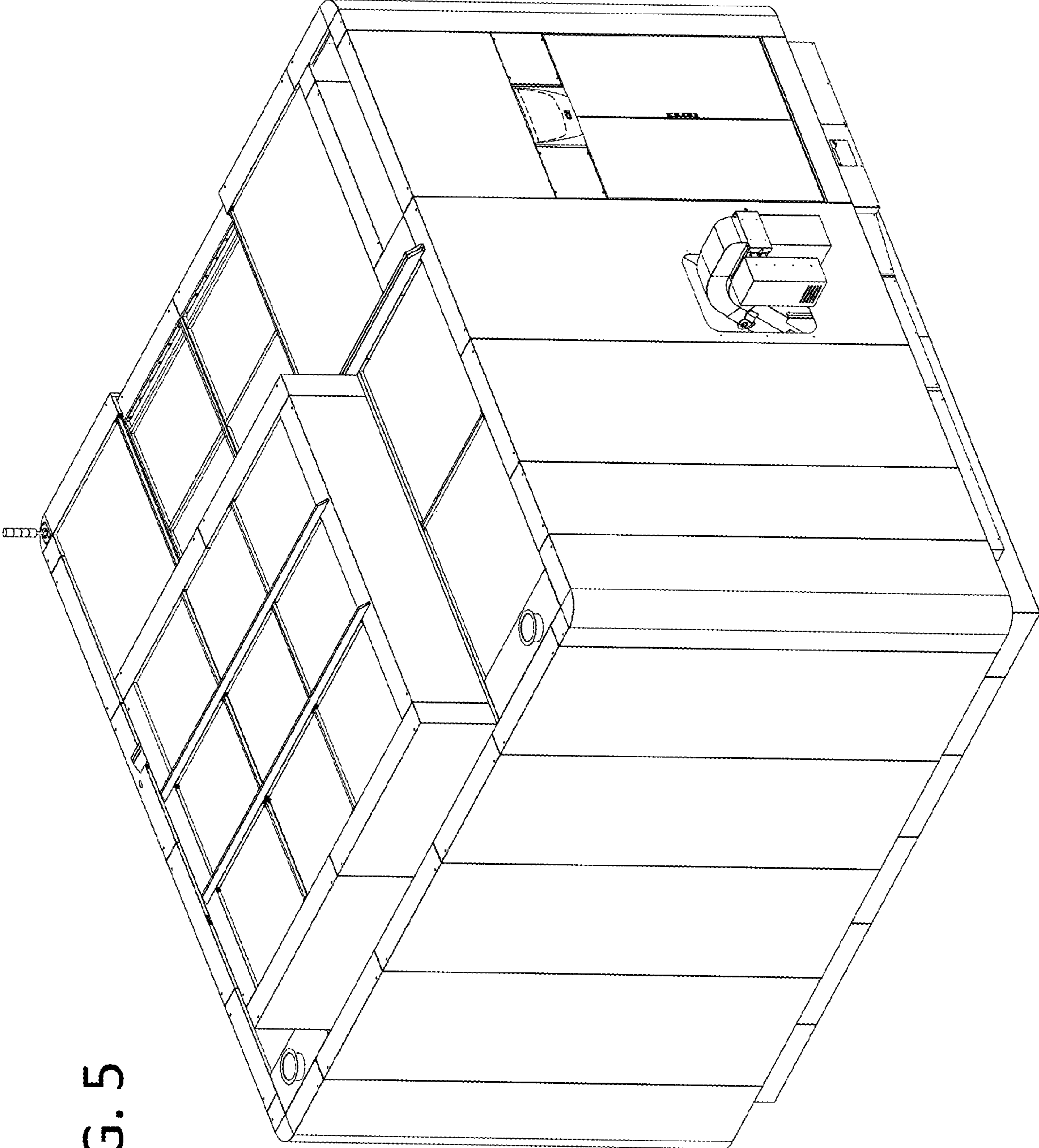

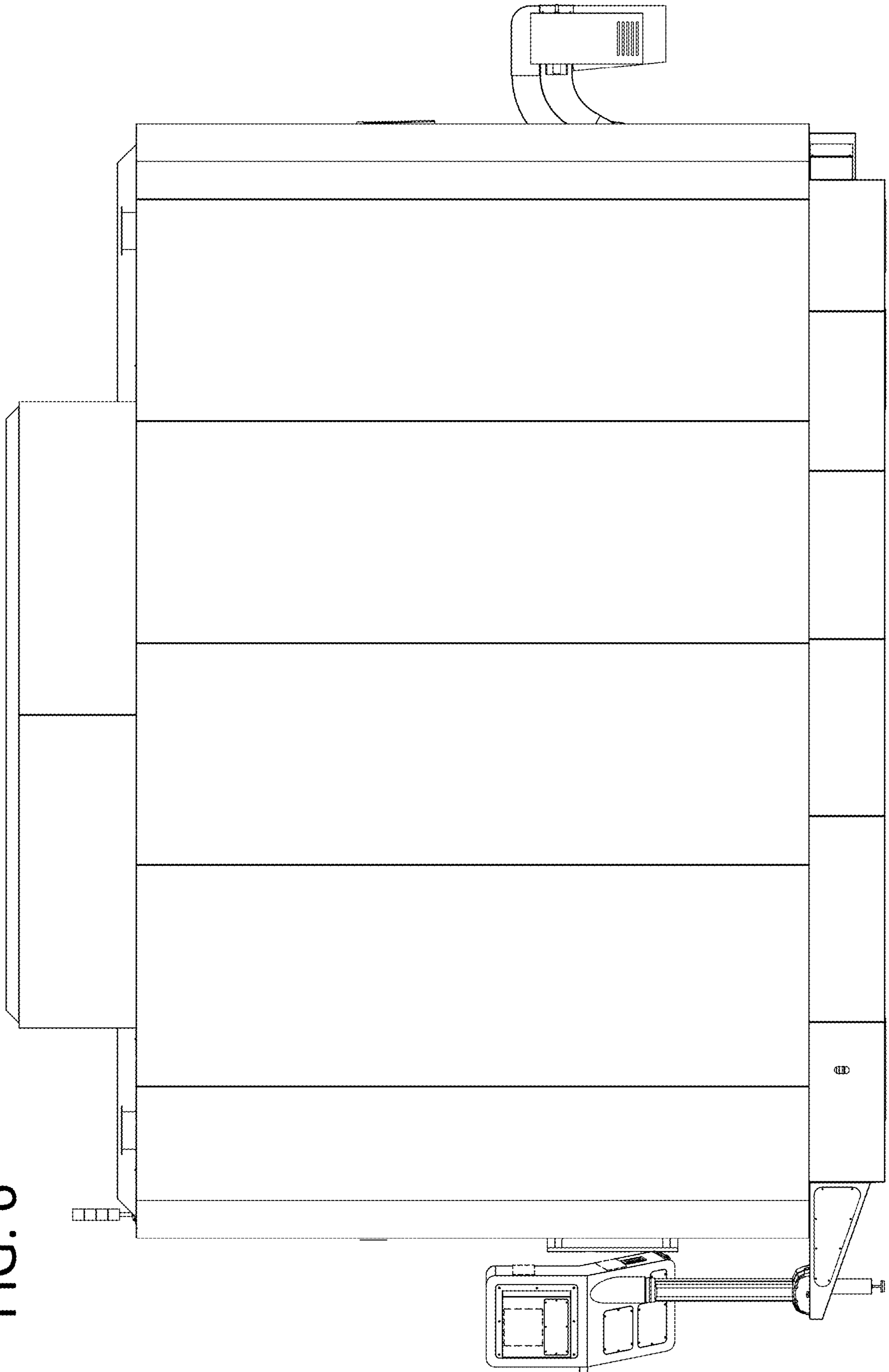
