(57) **CLAIM**

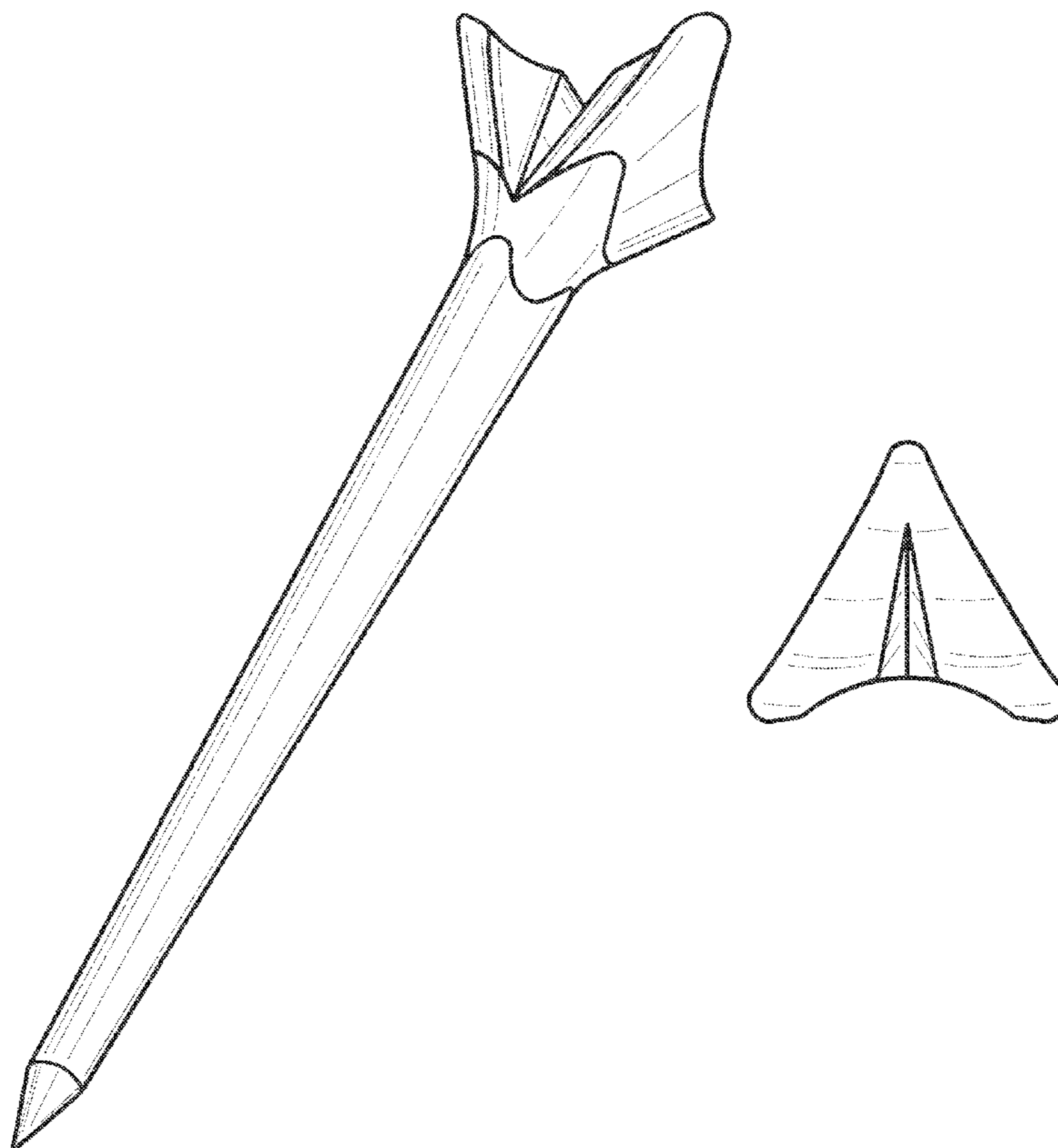
The ornamental design for a golf tee, as shown and described.

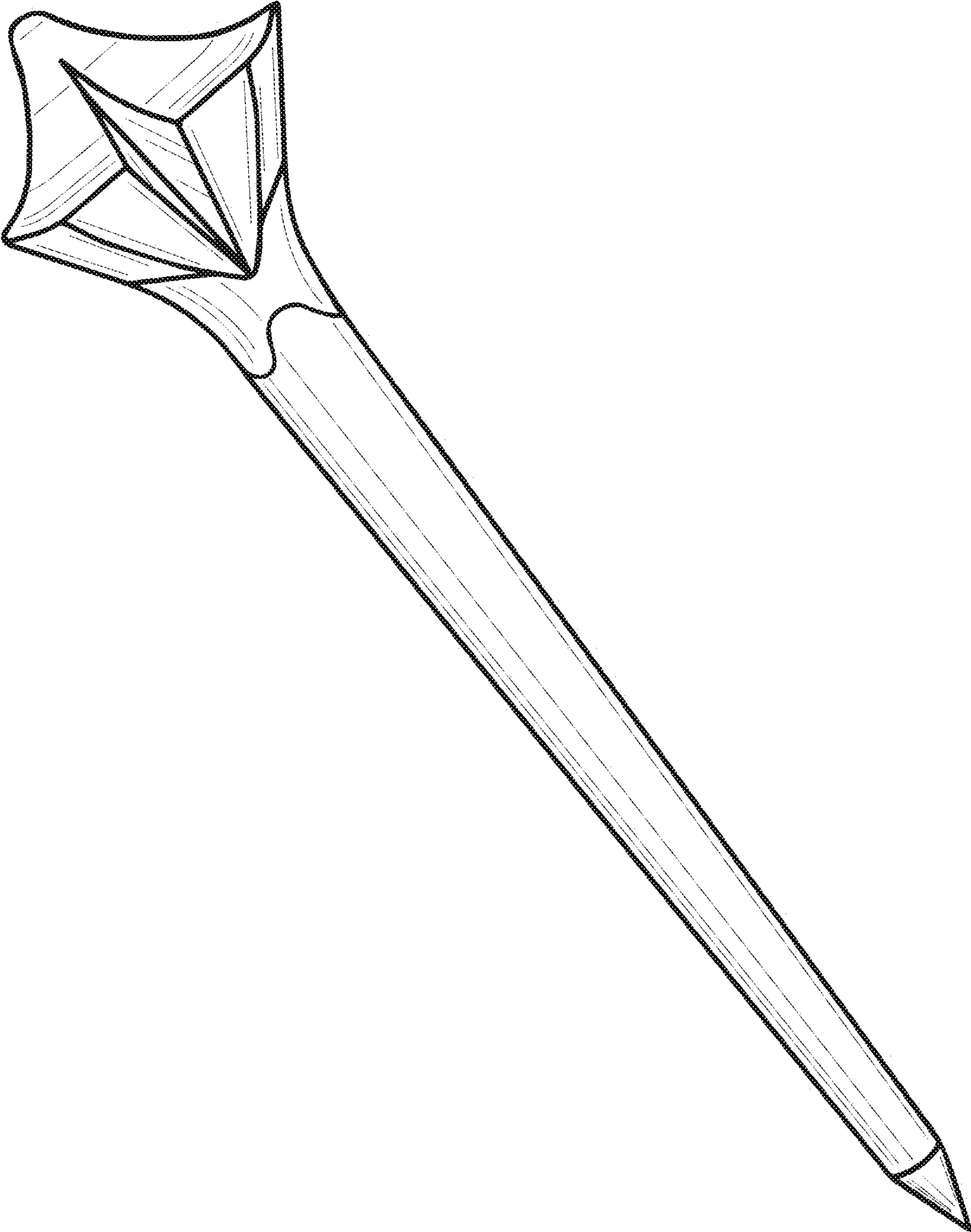

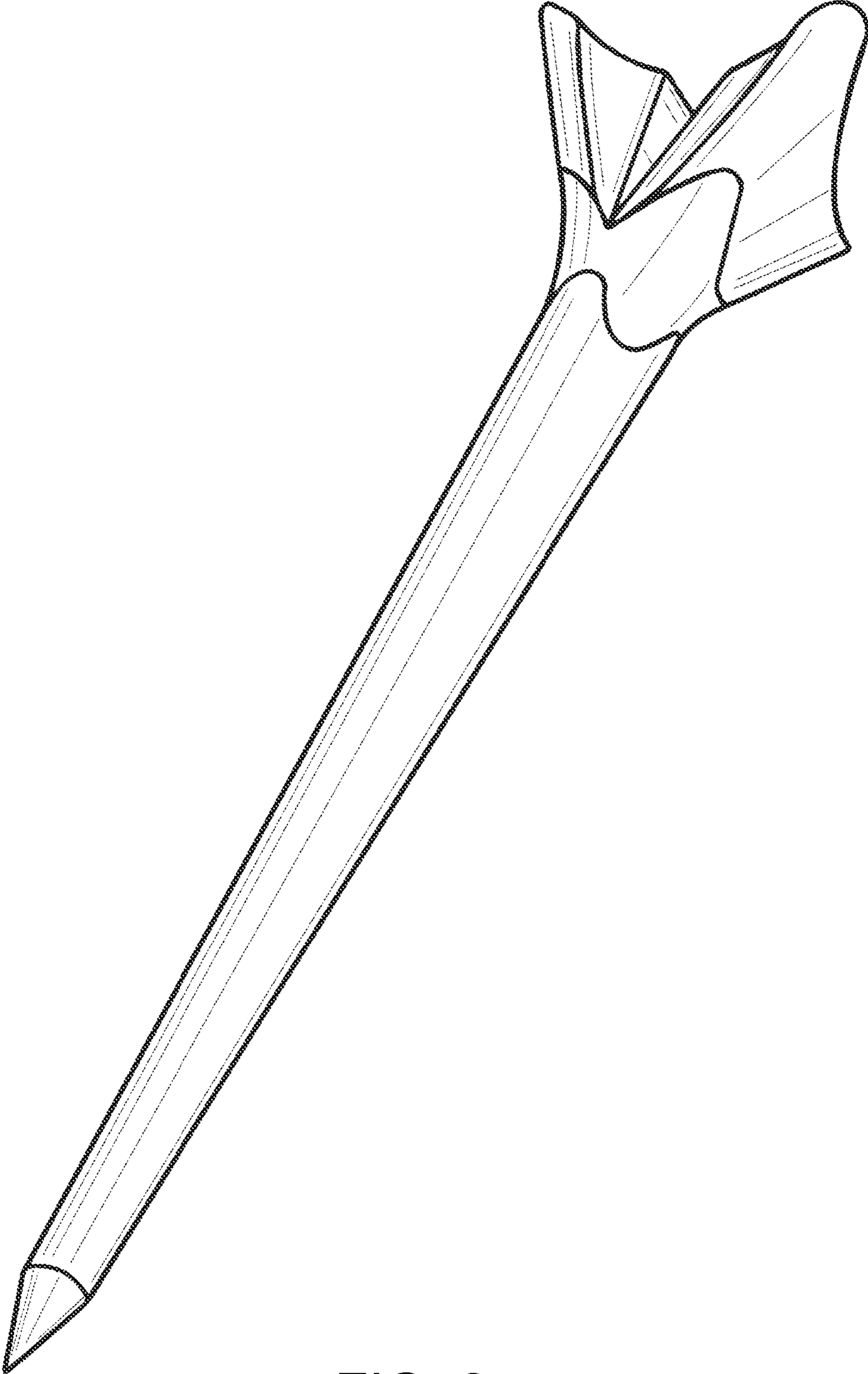

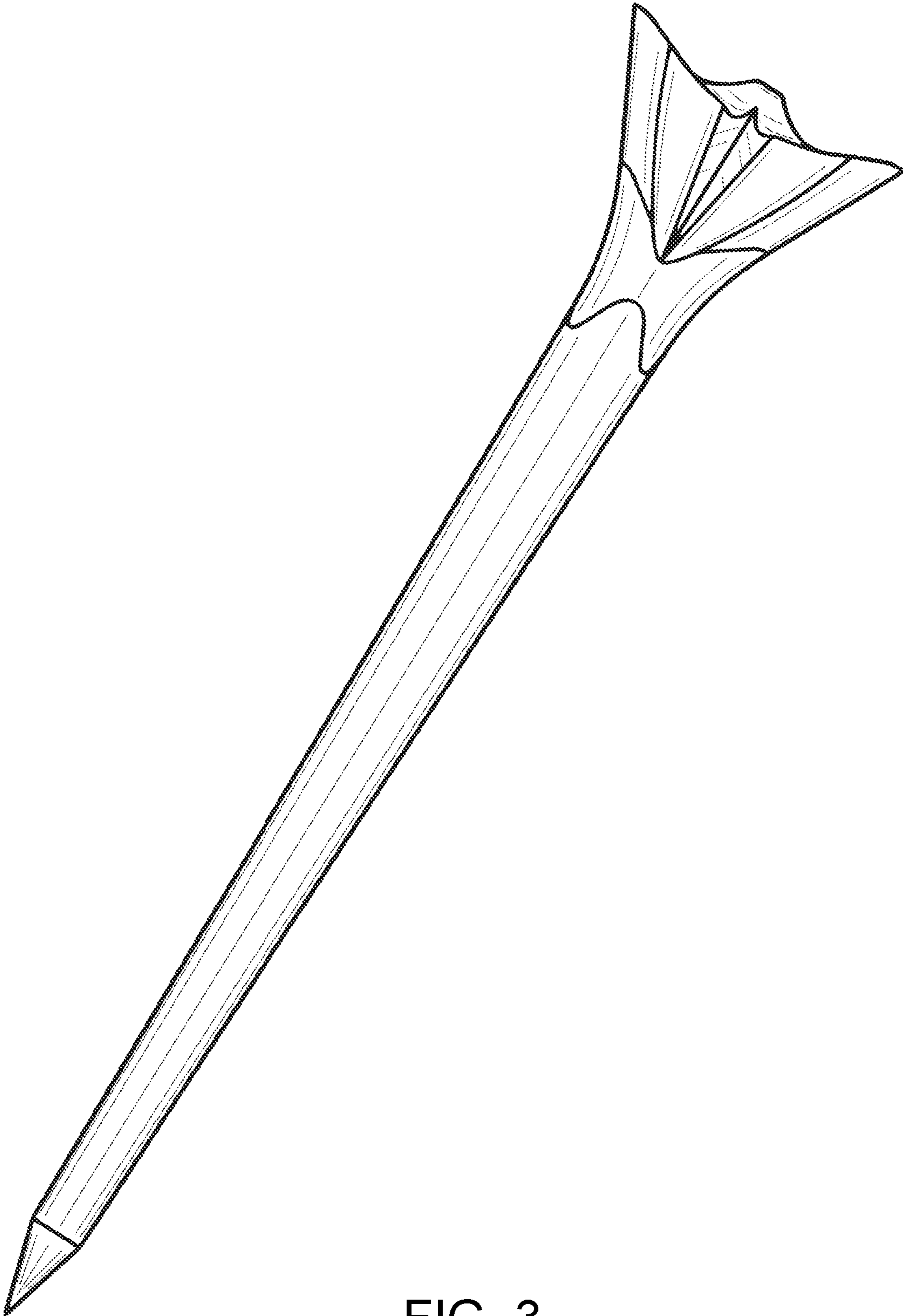

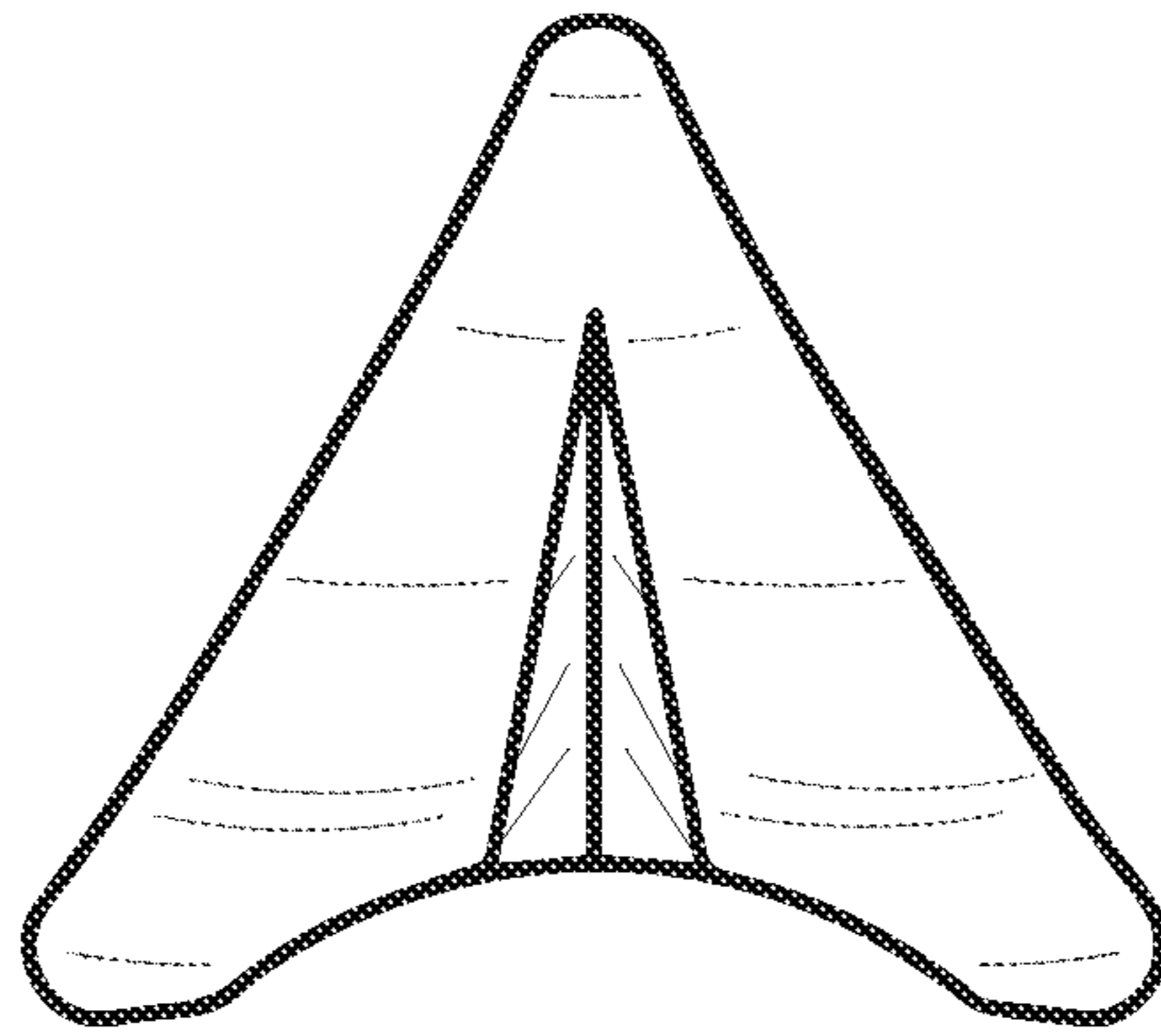

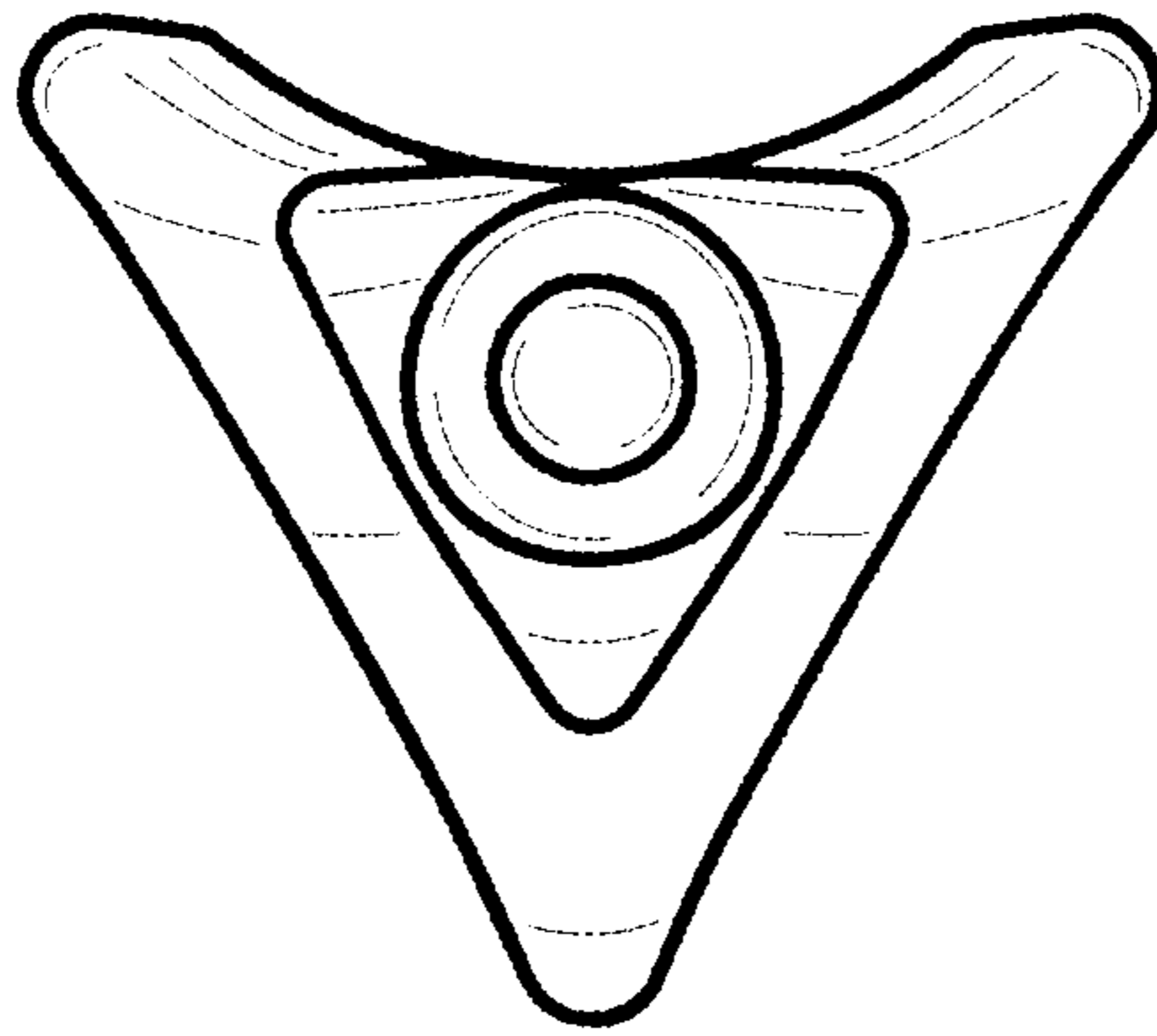

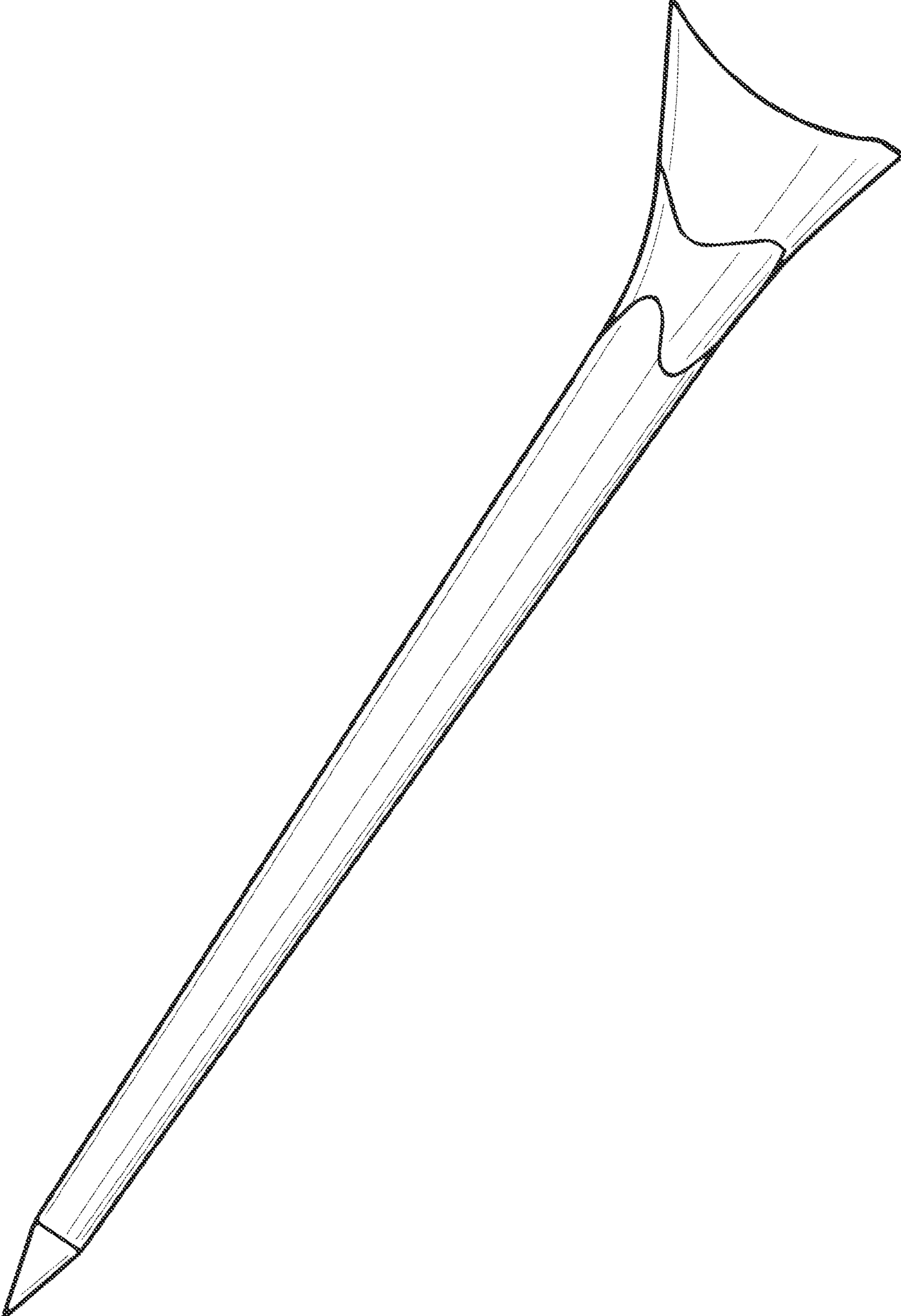

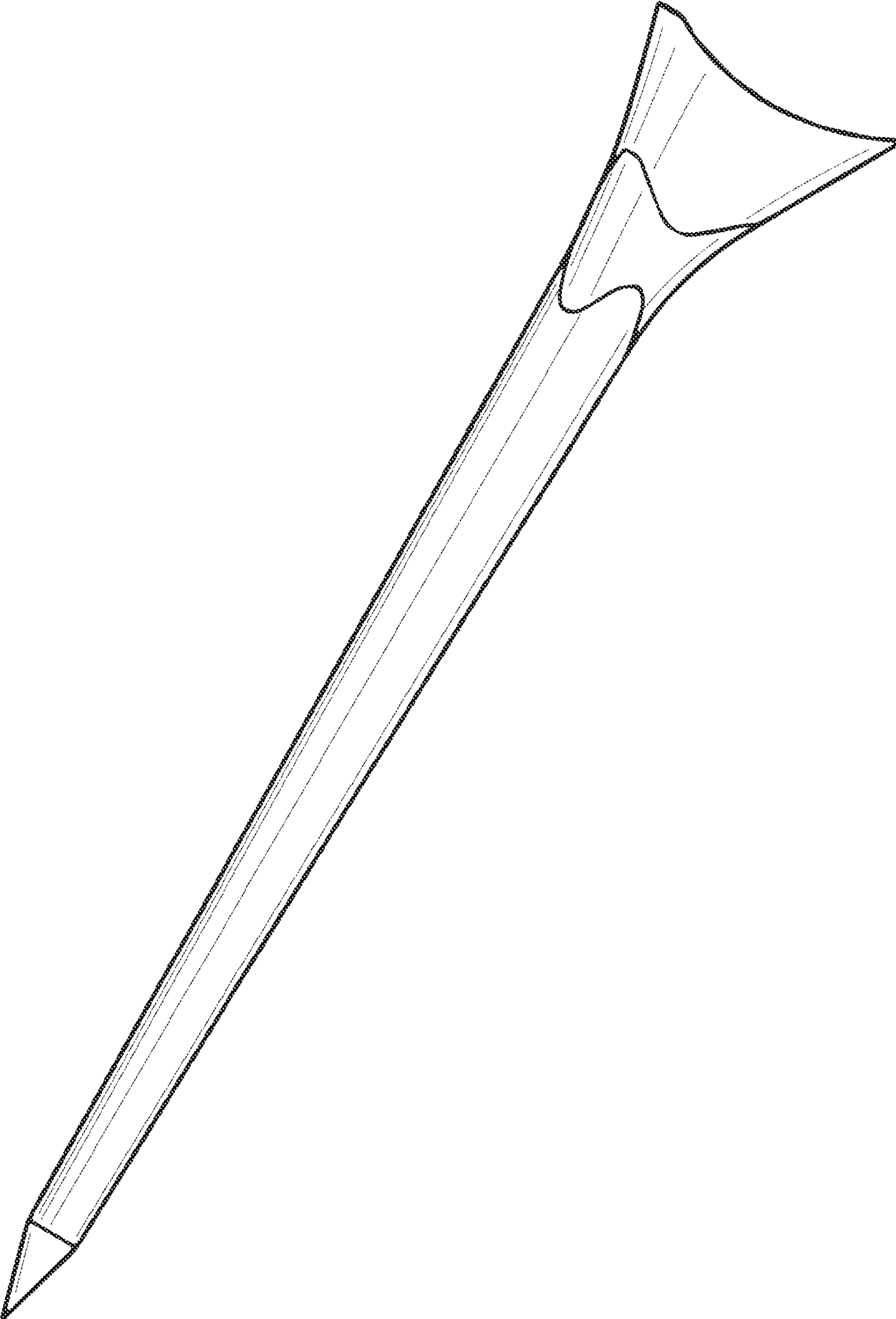
