(57) **CLAIM**

The ornamental design for a sanitary napkin with blotting marking, as shown and described.

DESCRIPTION

FIG. 1 shows a perspective view of a sanitary napkin with blotting marking.

FIG. 2 shows a top plan view of the sanitary napkin blotting marking.

FIG. 3 shows a bottom plan view of the sanitary napkin with blotting marking.

FIG. 4 shows a right side elevation view of the sanitary napkin with blotting marking.

FIG. 5 shows a left side elevation view of the sanitary napkin with blotting marking.

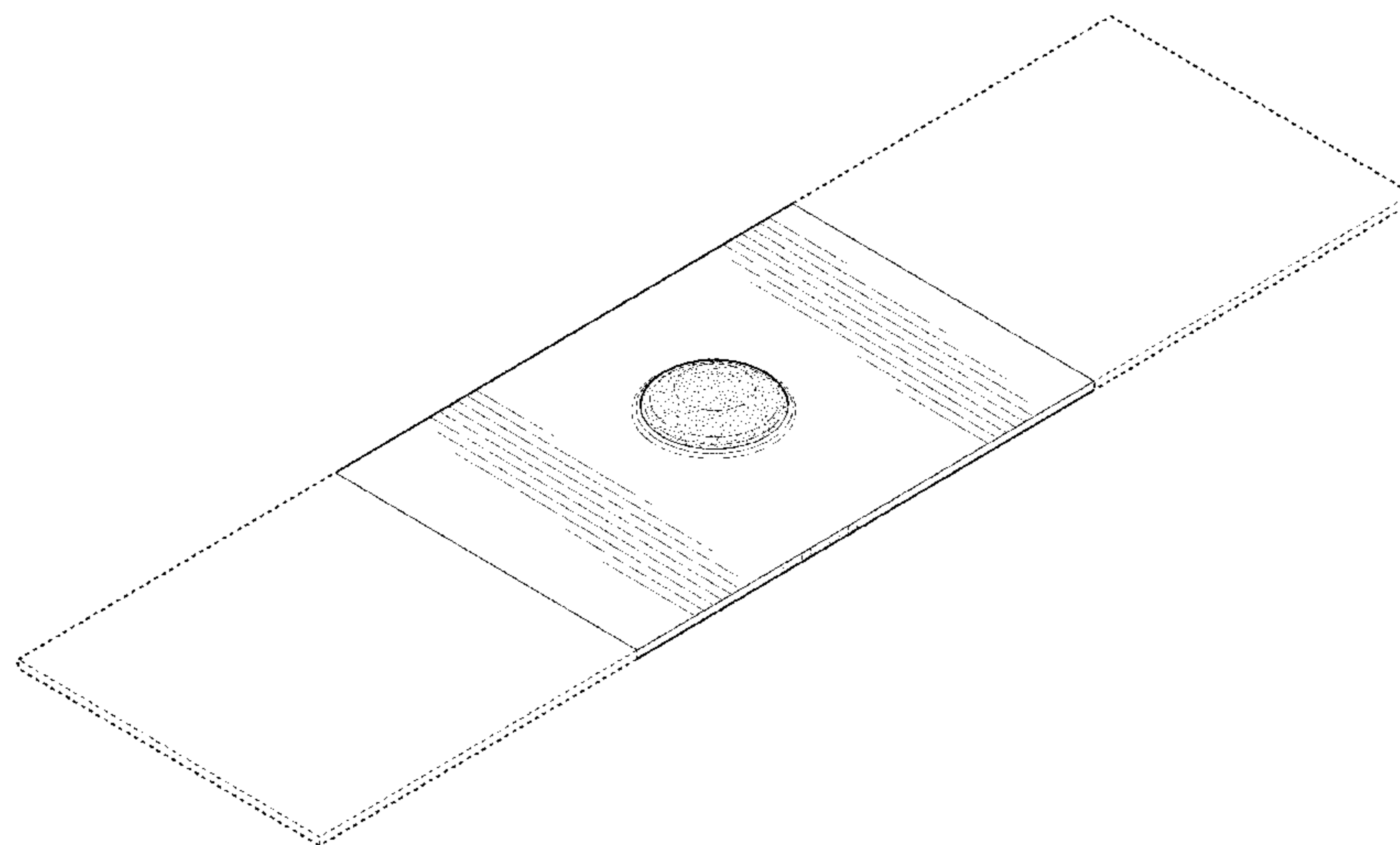
FIG. 6 shows a front elevation view of the sanitary napkin with blotting marking; and,

FIG. 7 shows a rear elevation view of the sanitary napkin with blotting marking.

The shade lines in the Figures show contour and not surface ornamentation.

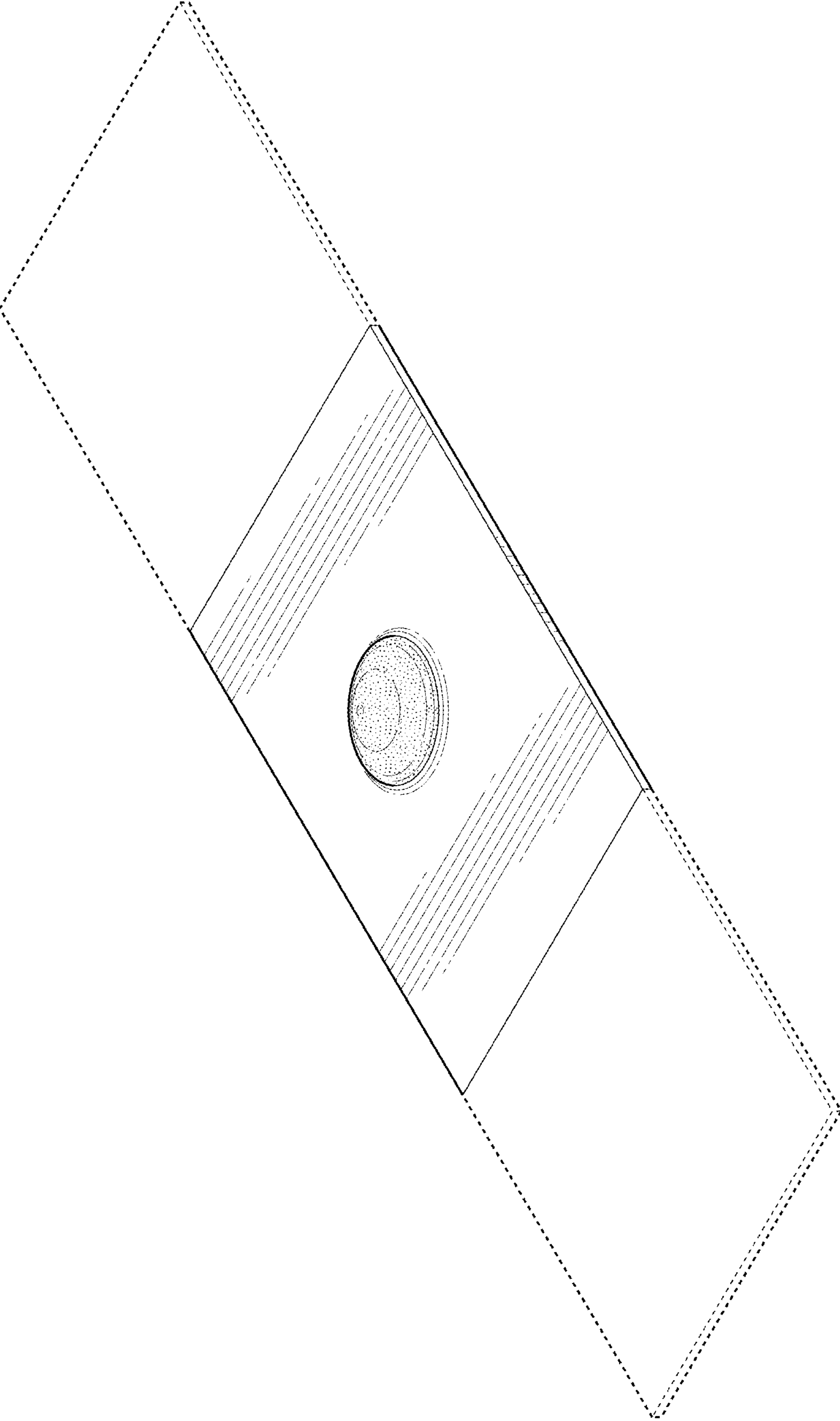

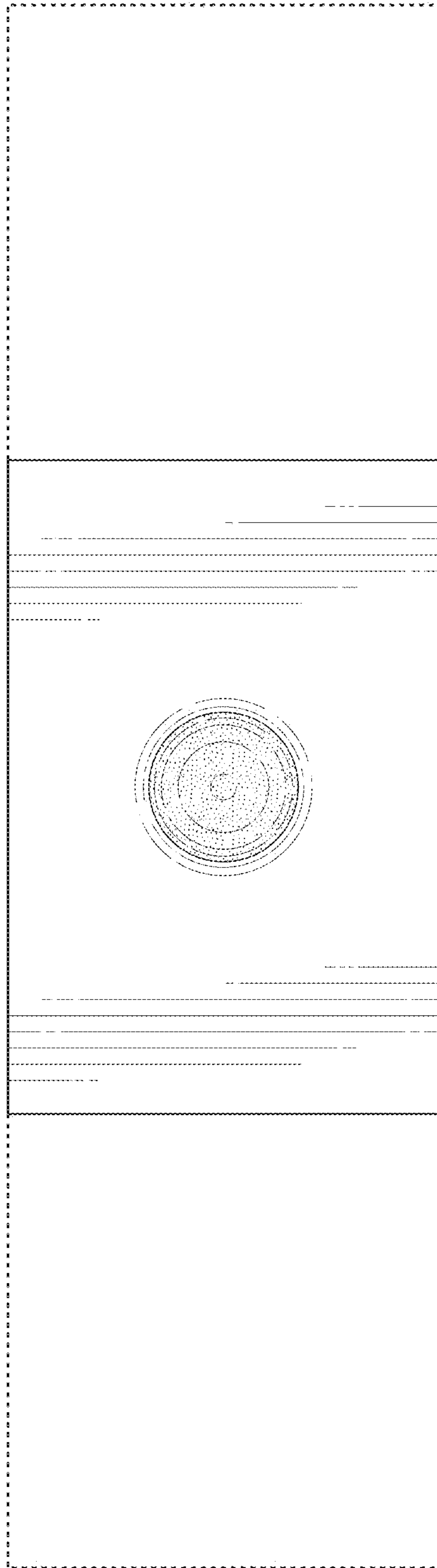

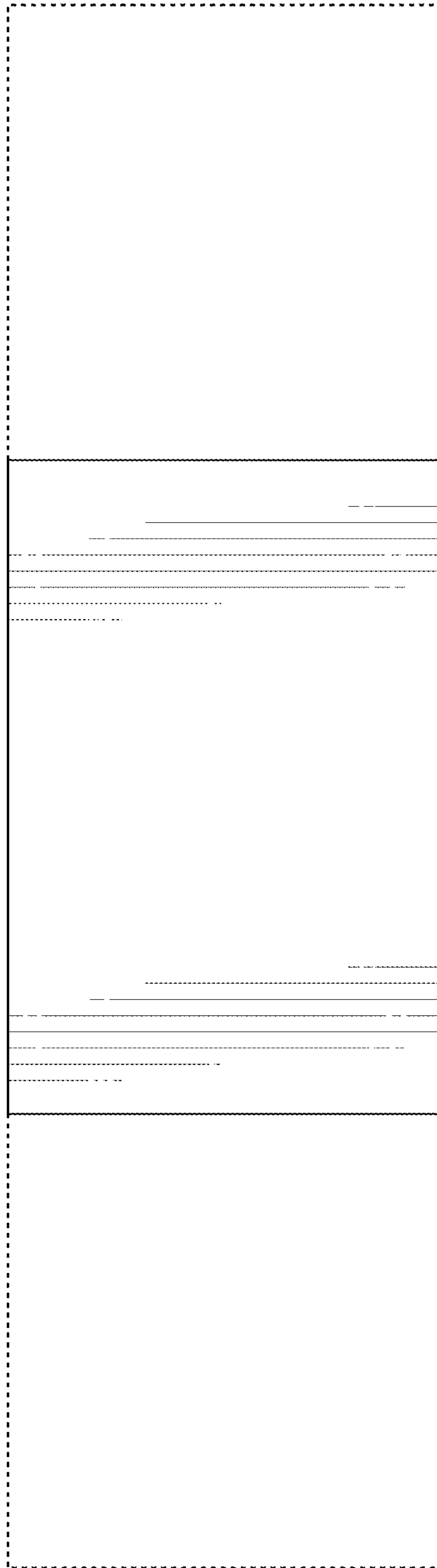

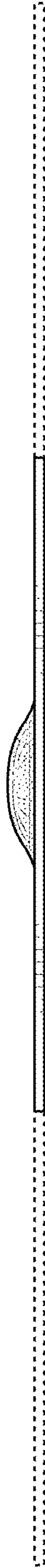

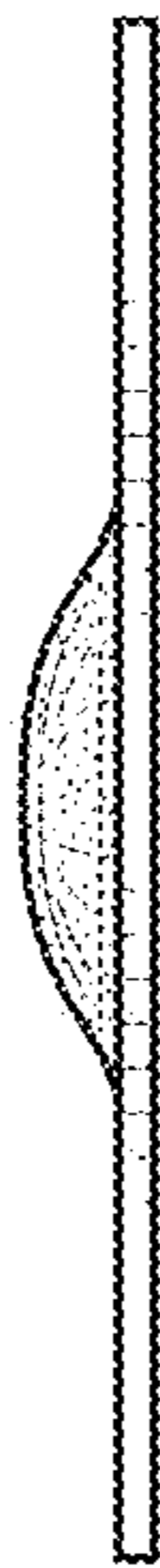
