The ornamental design for a chandelier, as shown and described.

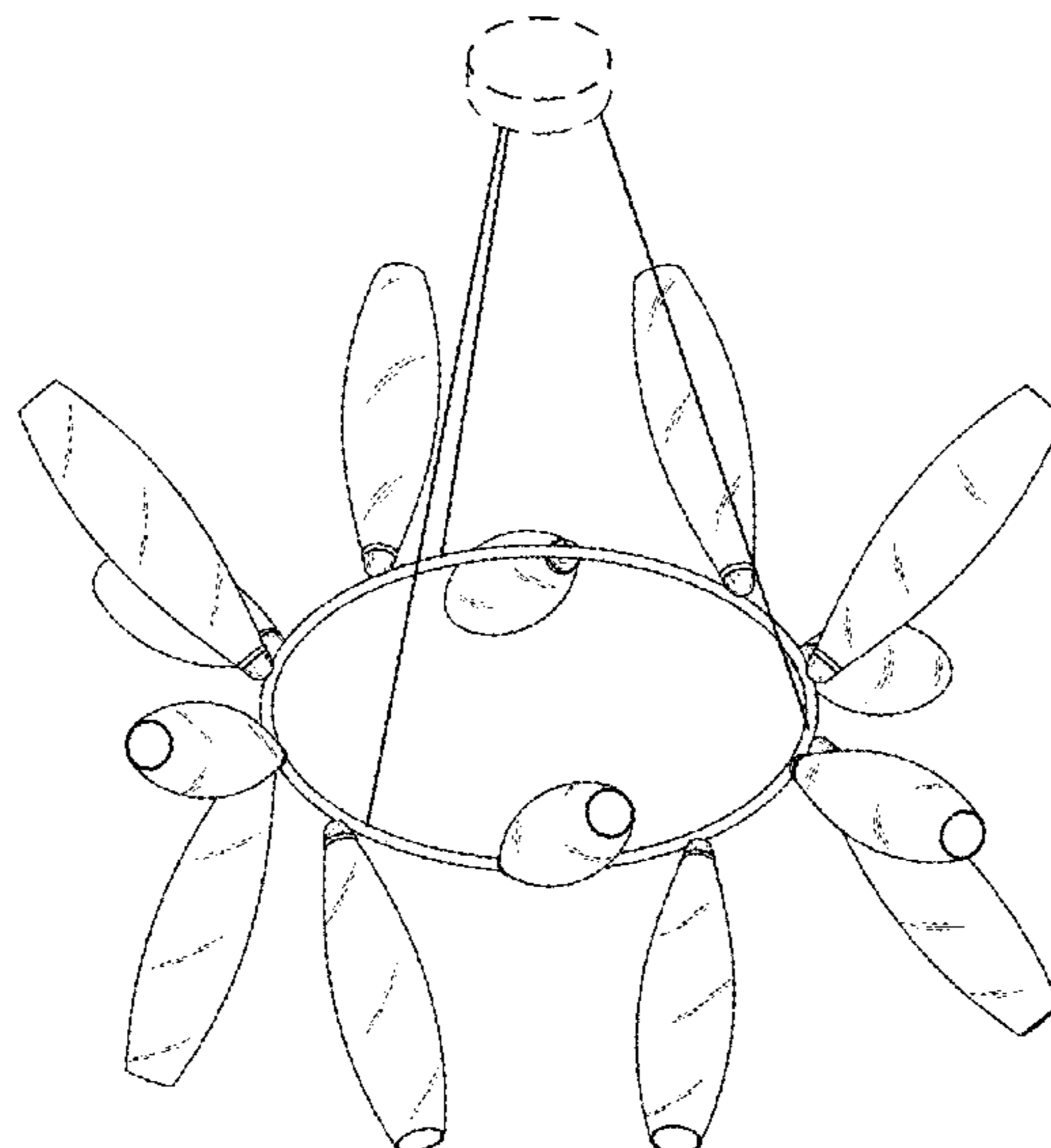
DESCRIPTION

1. Chandelier

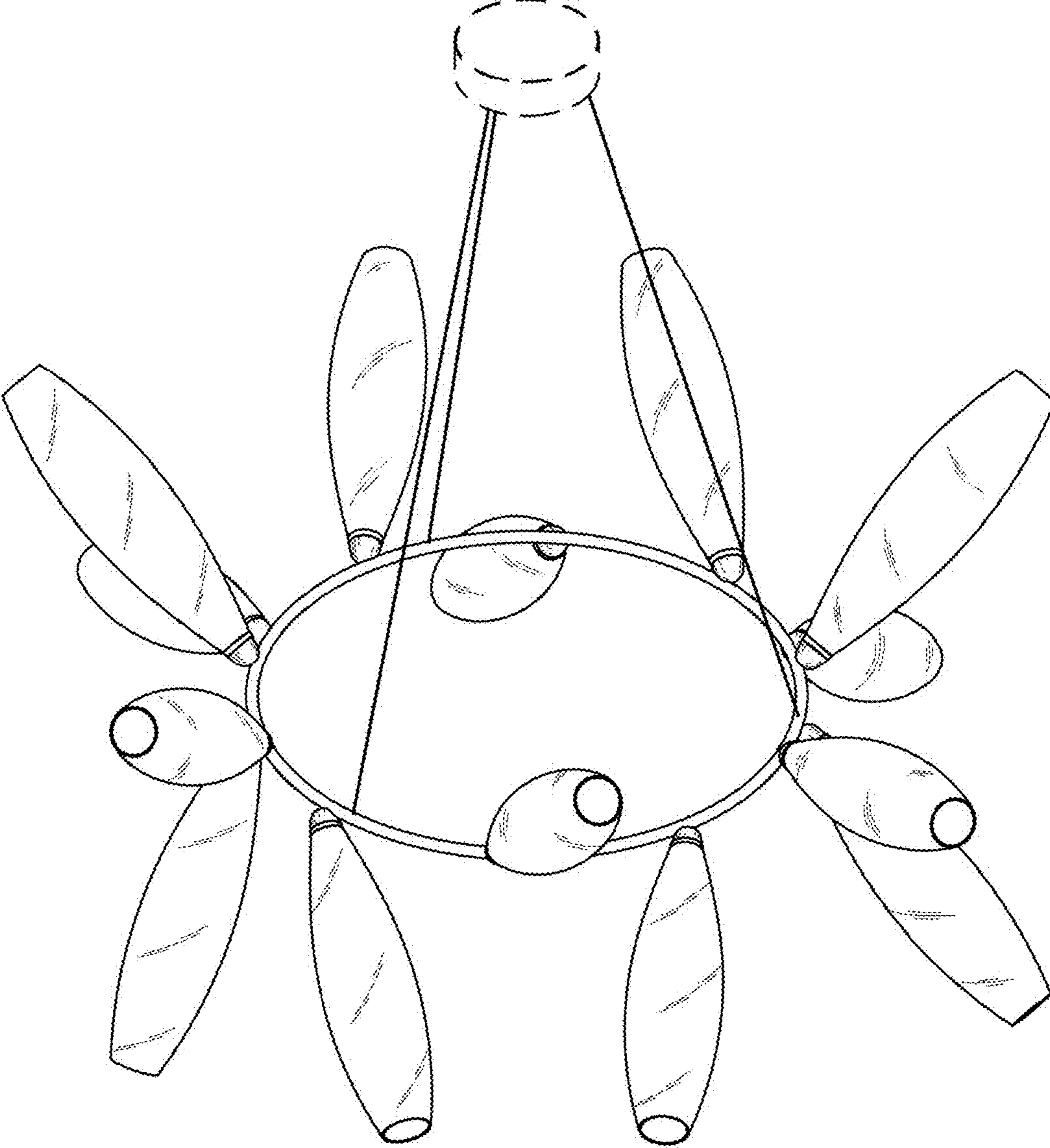

The broken lines shown in the drawings illustrate environmental subject matter and form no part of the claimed design.

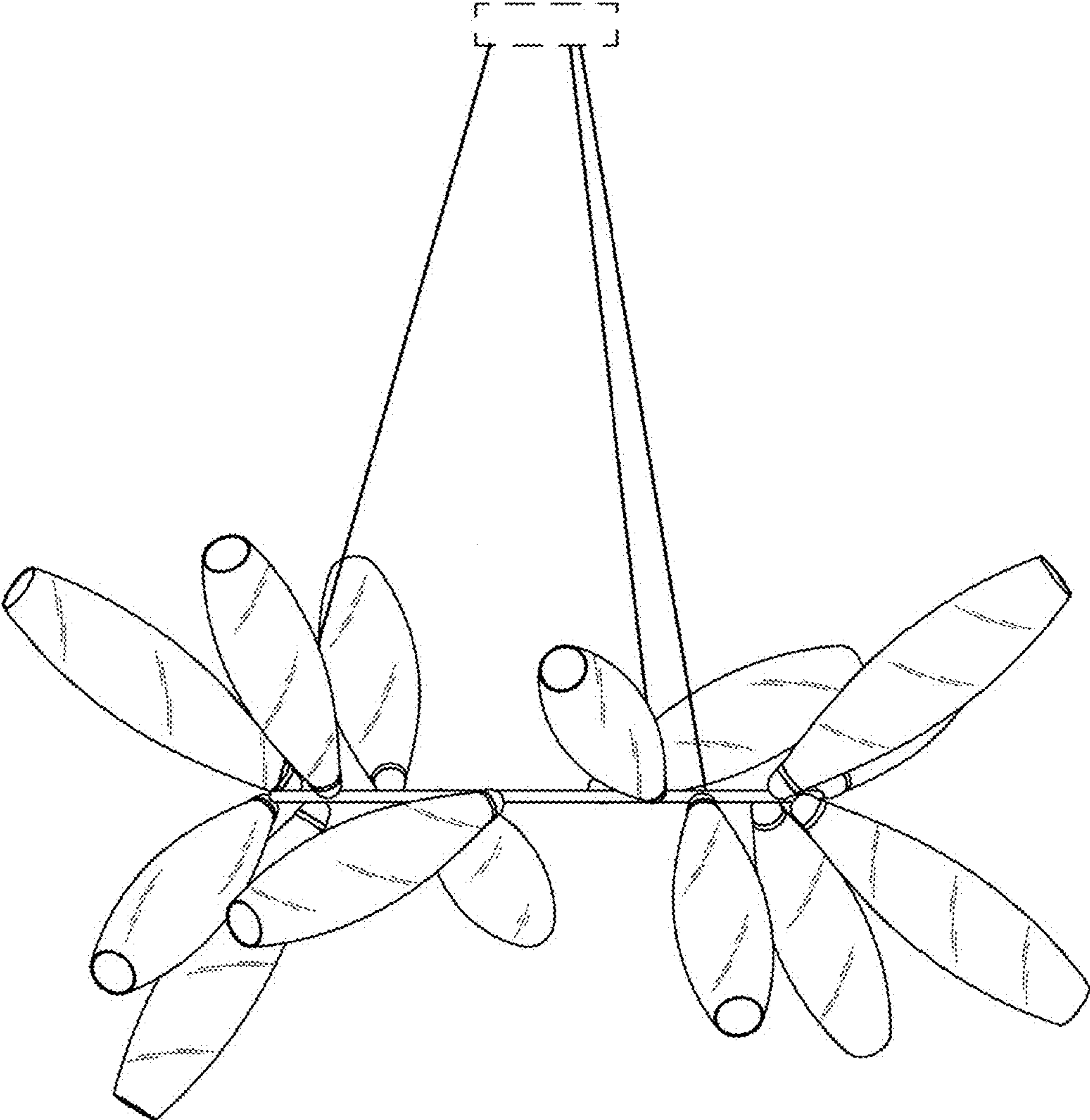

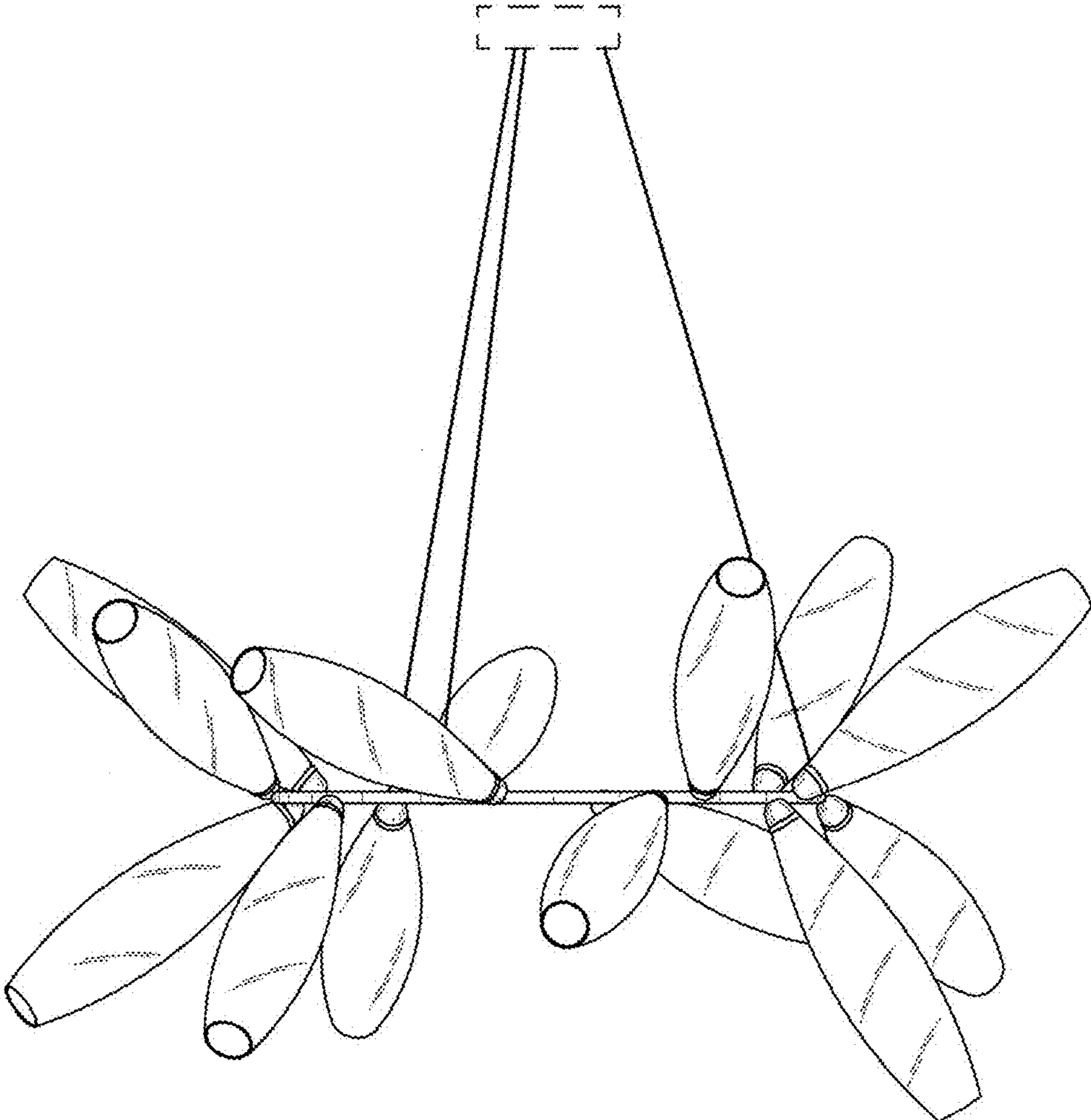

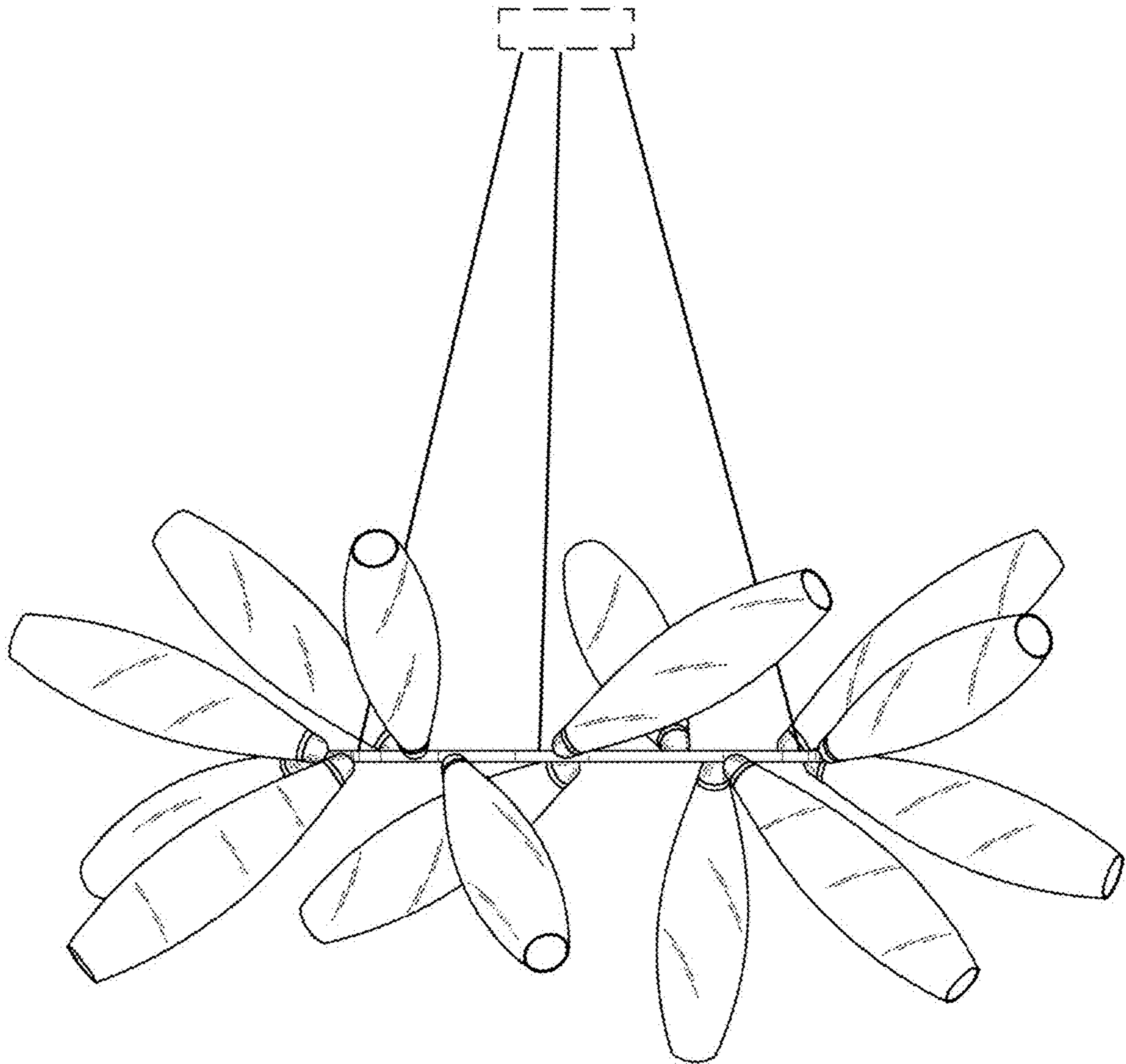

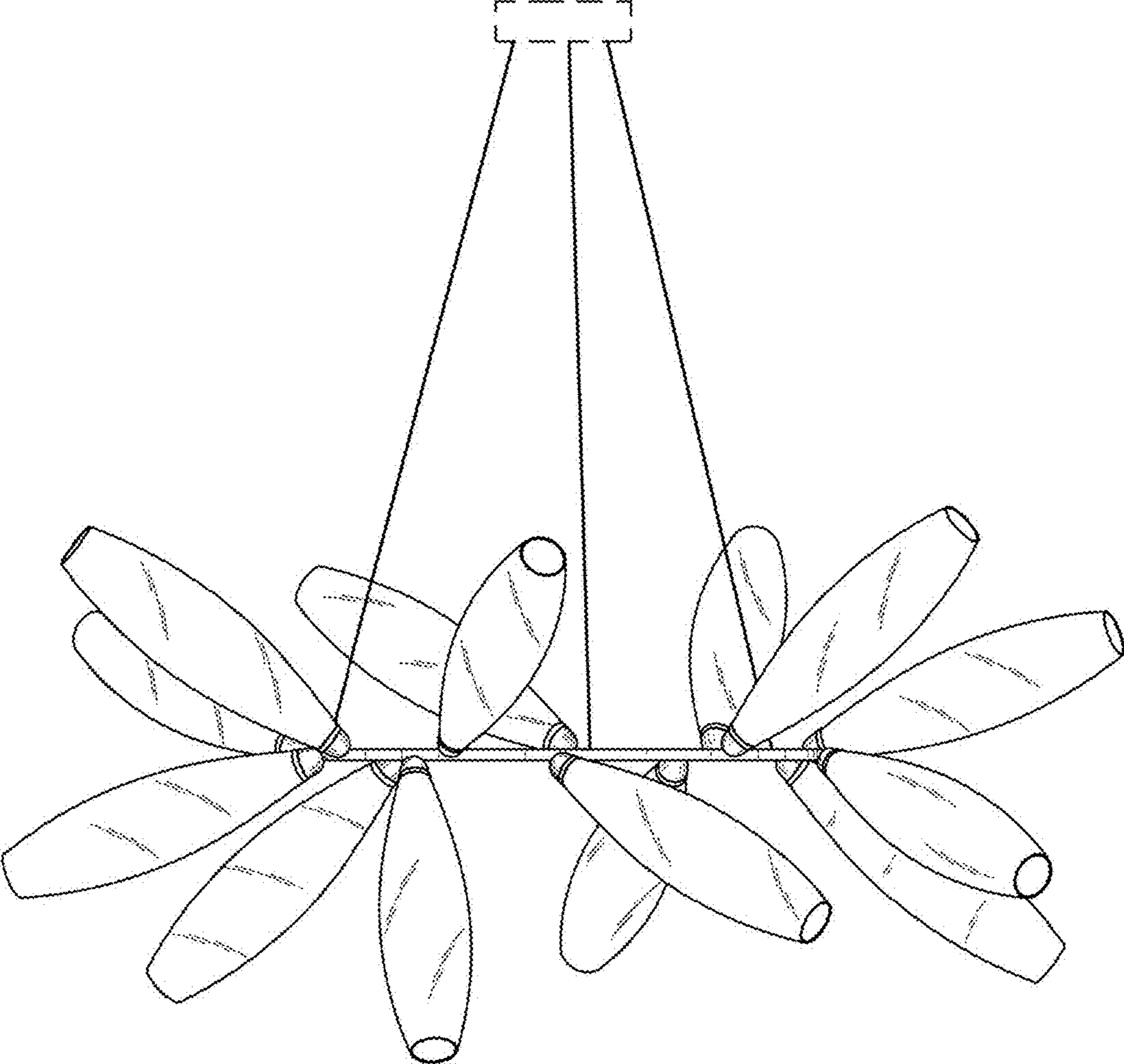

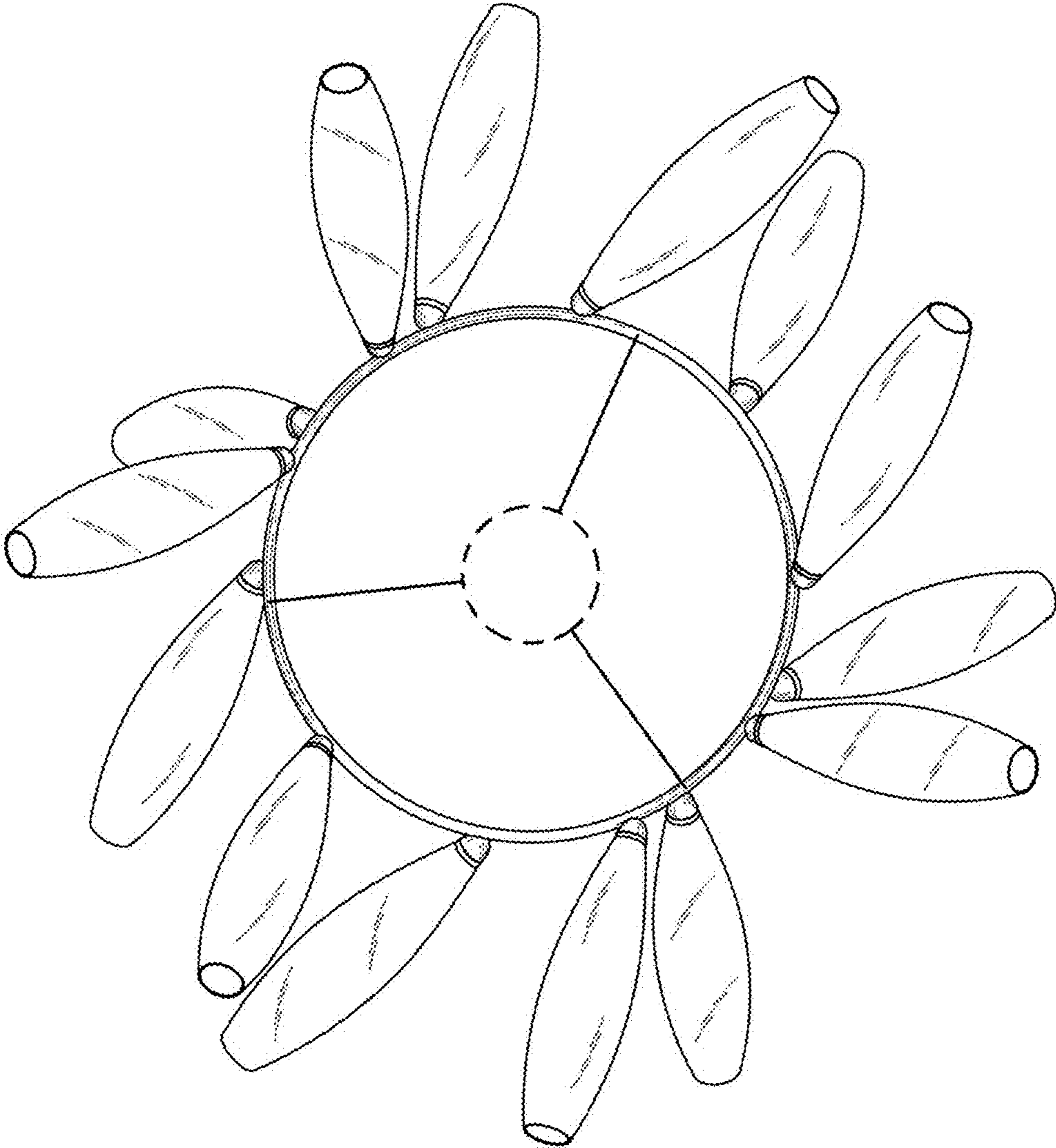
