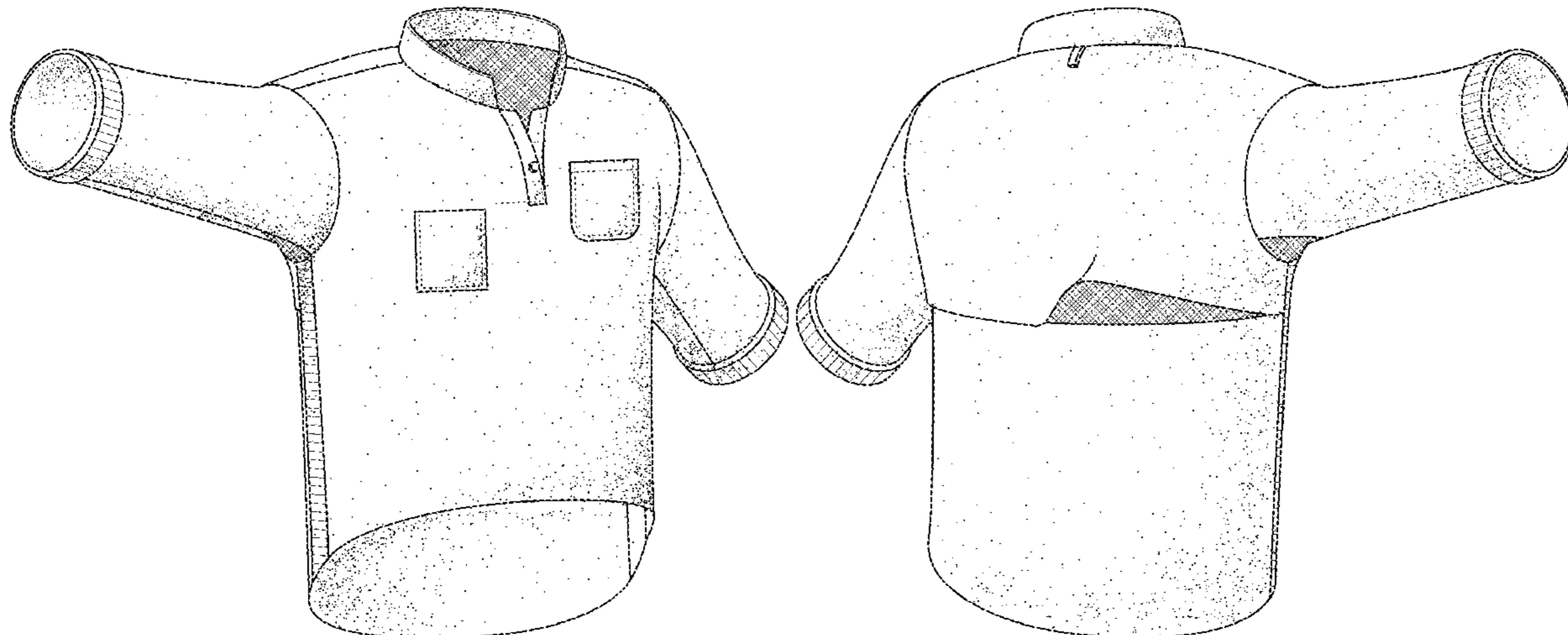
(57) **CLAIM**

The ornamental design for a chef's shirt, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of the chef's shirt showing the claimed design;

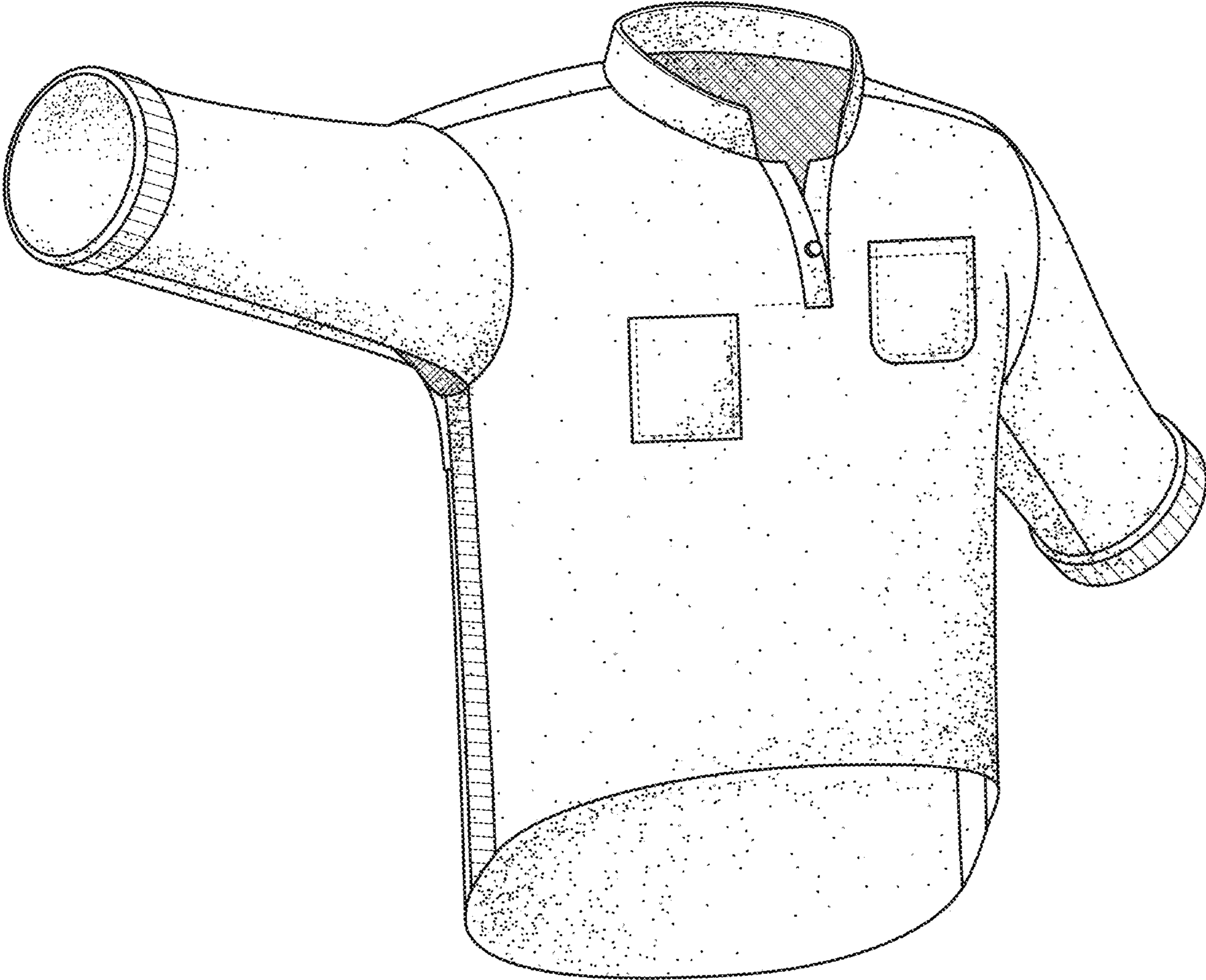

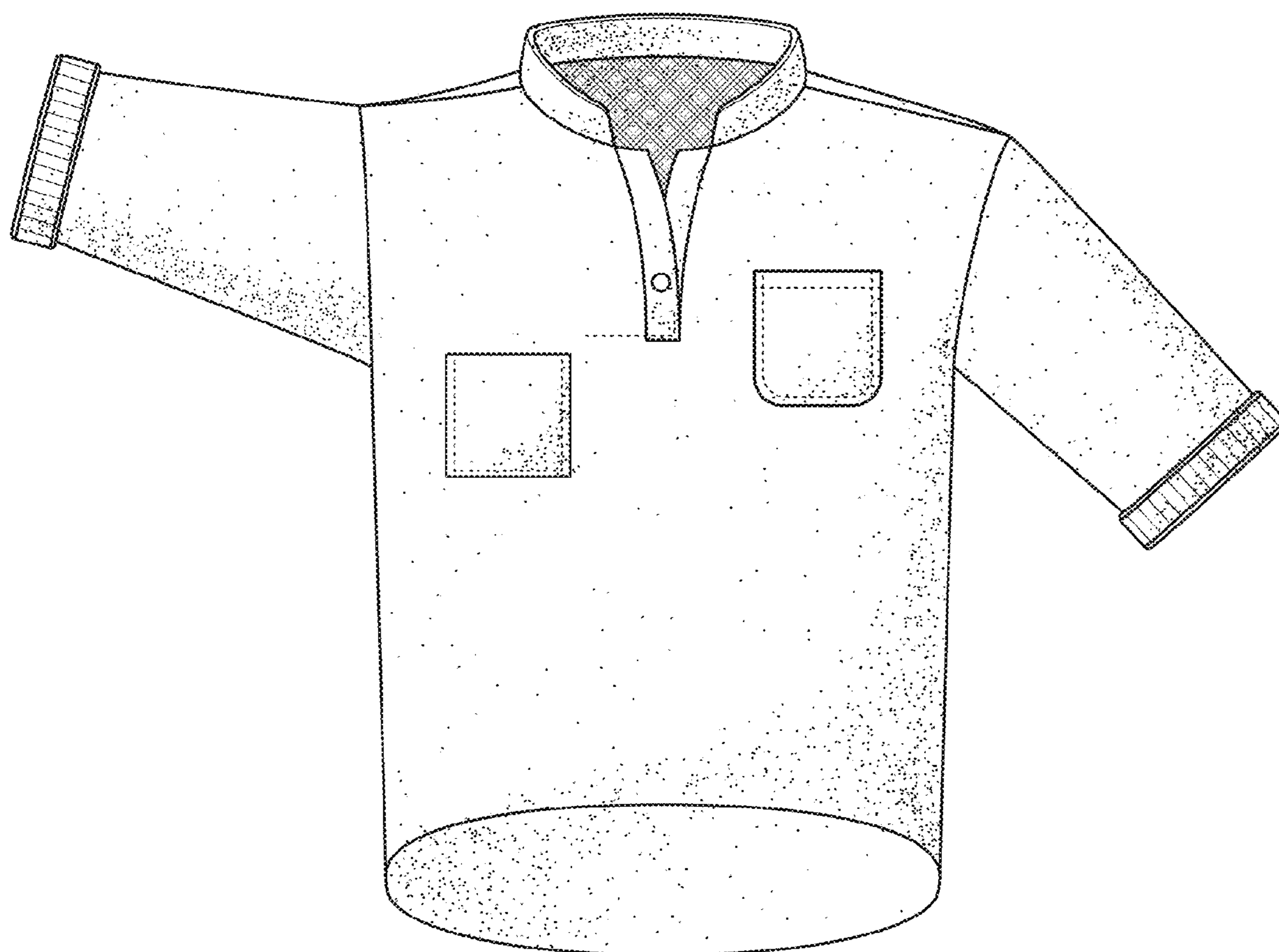

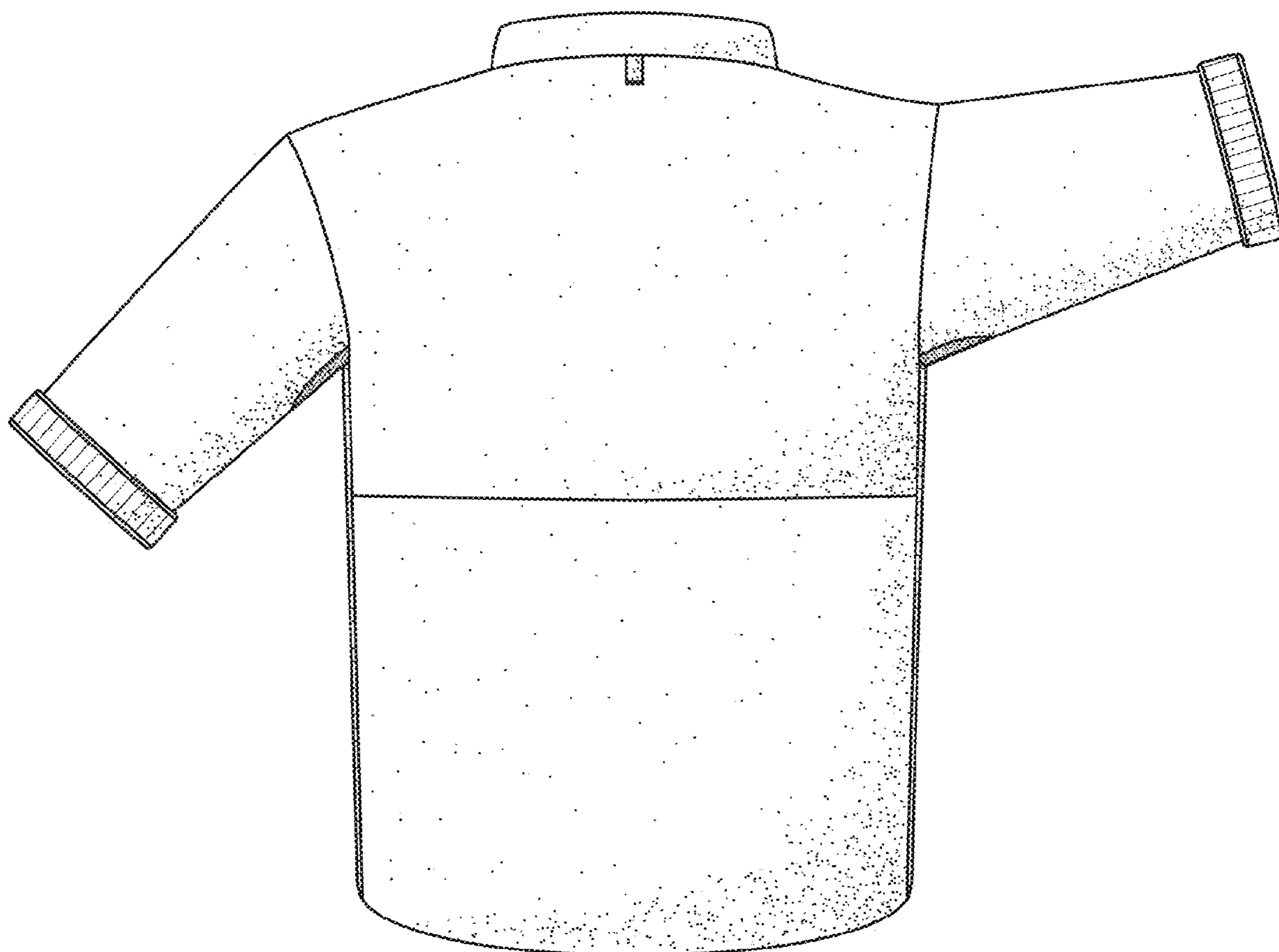

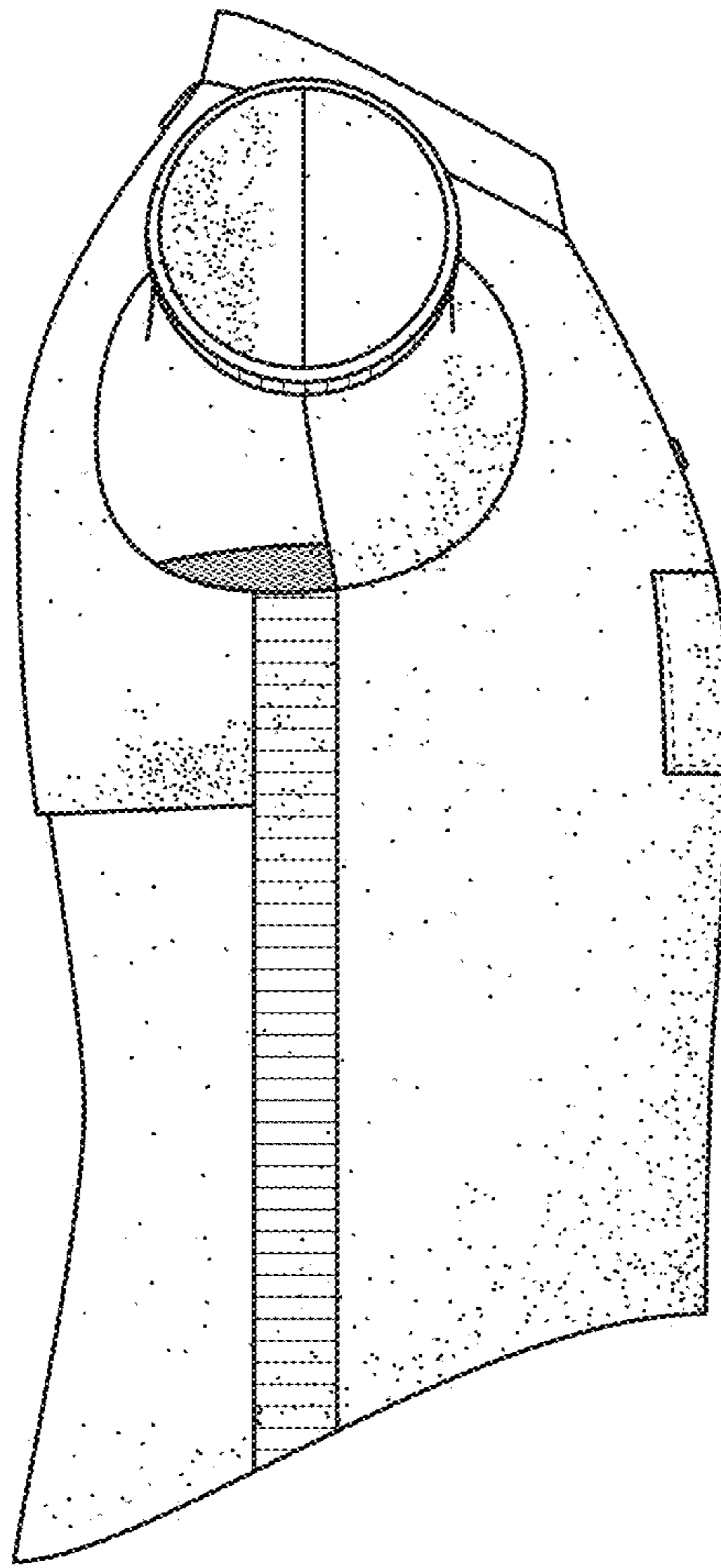

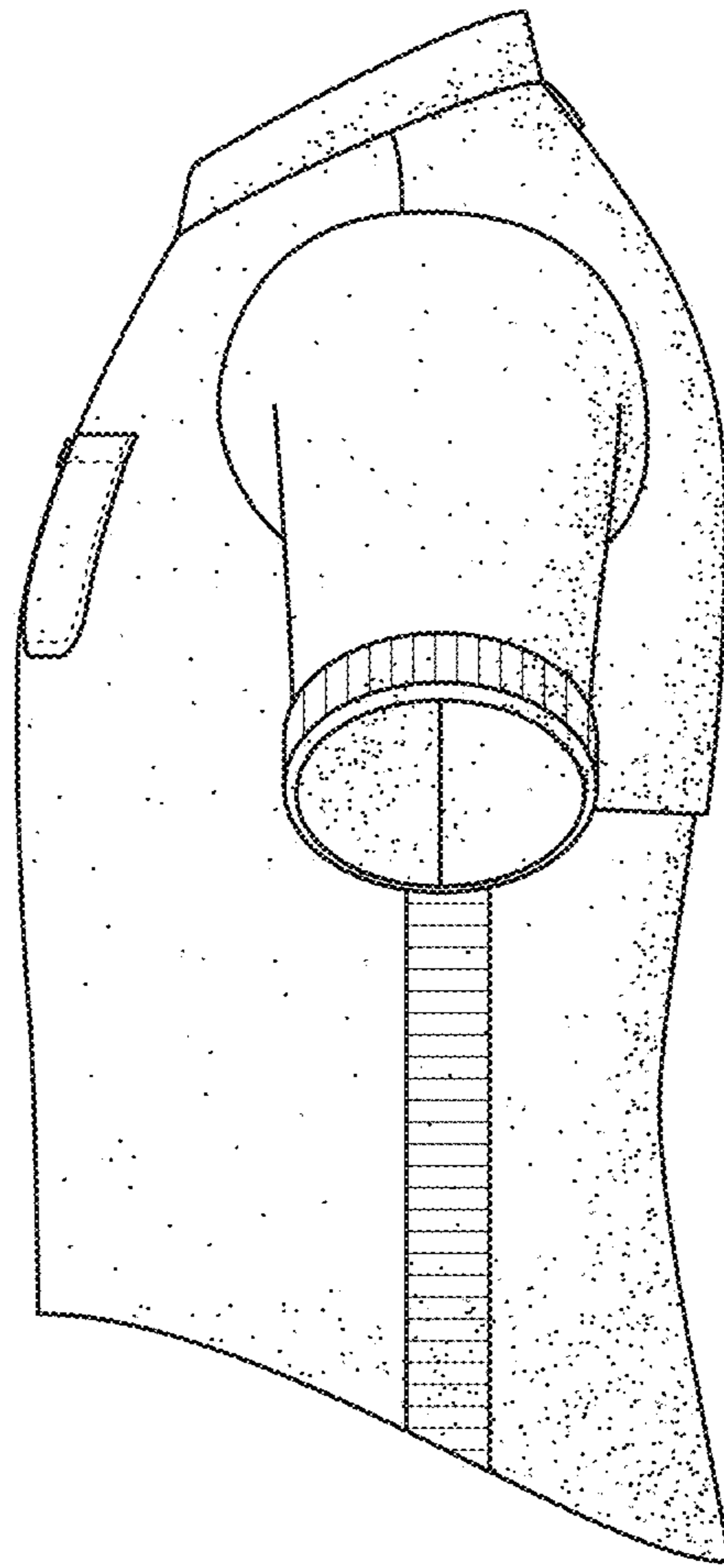

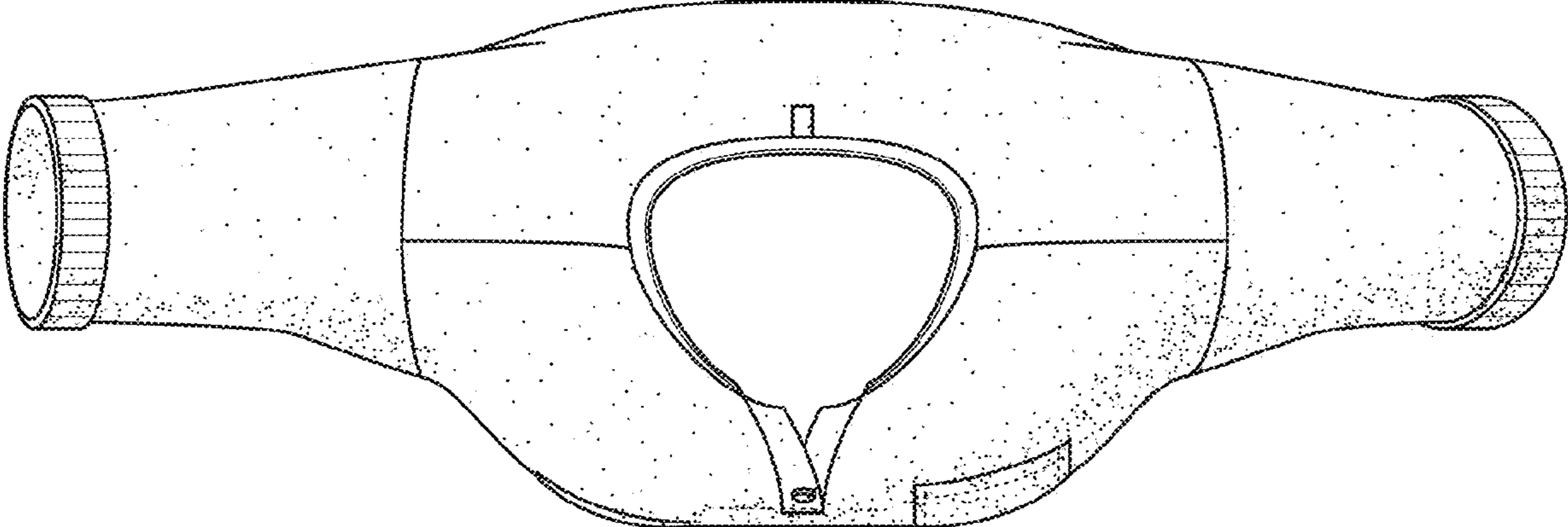

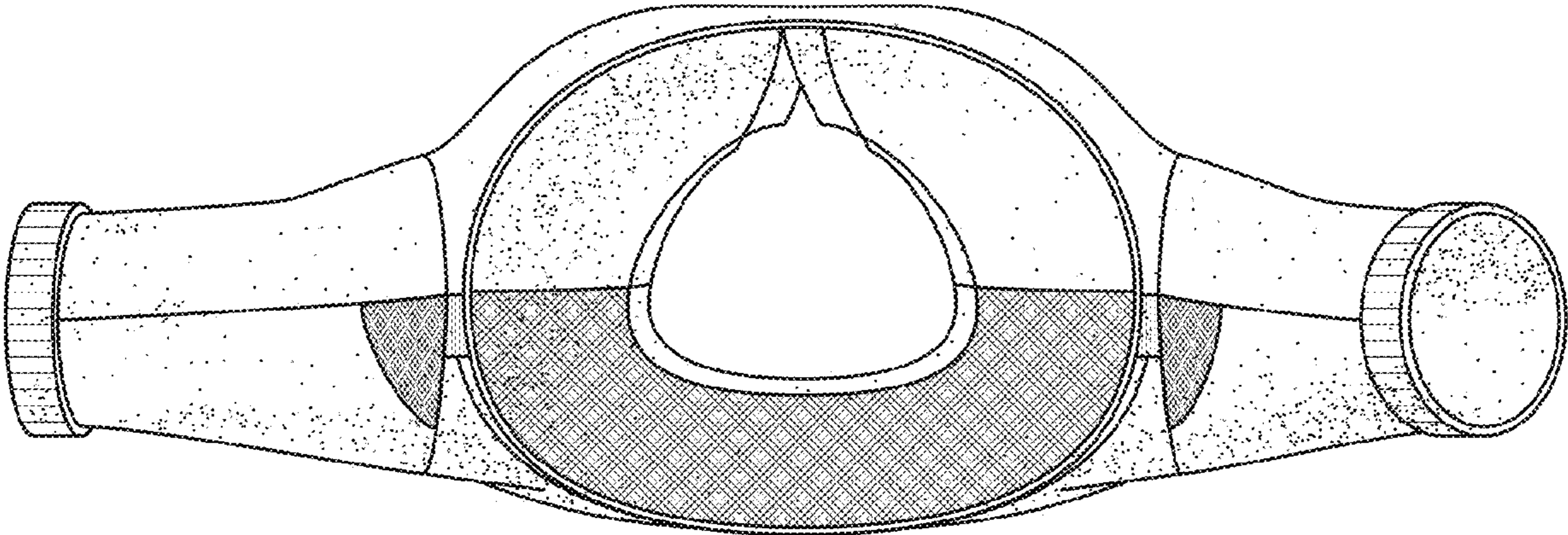

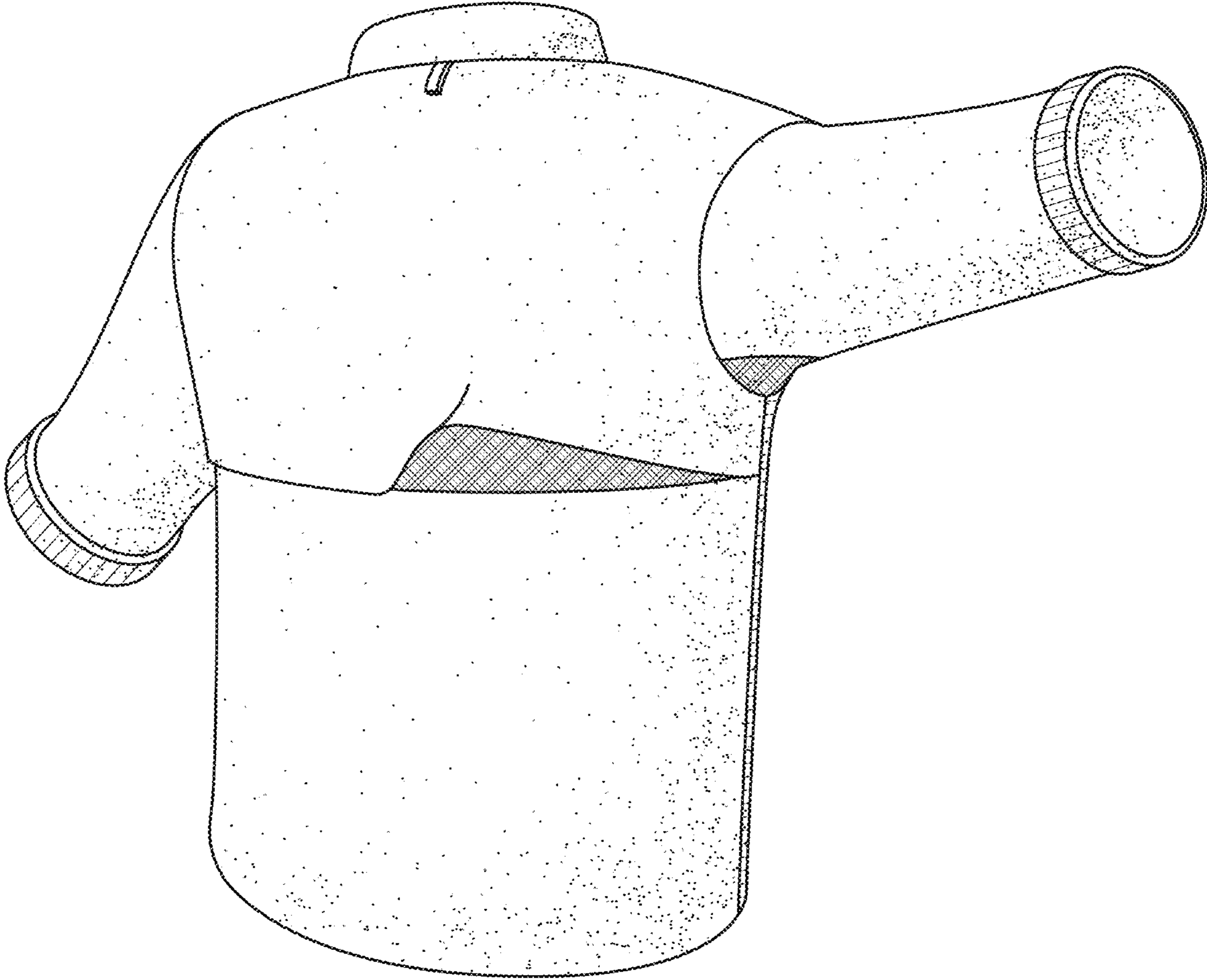

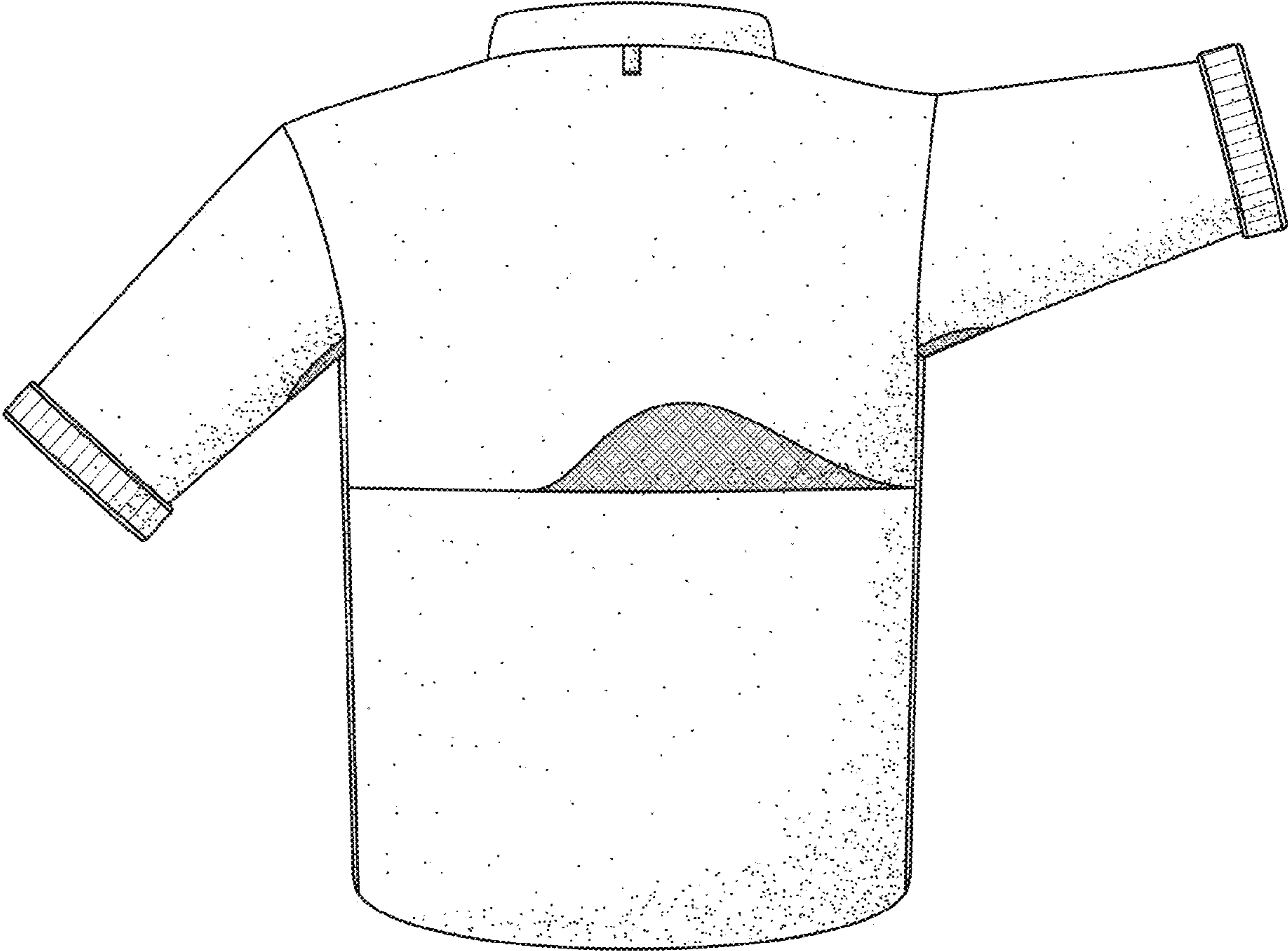
