DESCRIPTION

FIG. 1 is a perspective view of a golf shoe, showing our new design;
FIG. 2 is another perspective view thereof;
FIG. 3 is a top plan view thereof;
FIG. 4 is a bottom plan view thereof;
FIG. 5 is a side elevation view thereof;
FIG. 6 is an opposite side elevation view thereof;
FIG. 7 is a front view thereof; and,
FIG. 8 is a rear view thereof.
The broken lines in the figures show portions of the golf shoe that form no part of the claimed design.

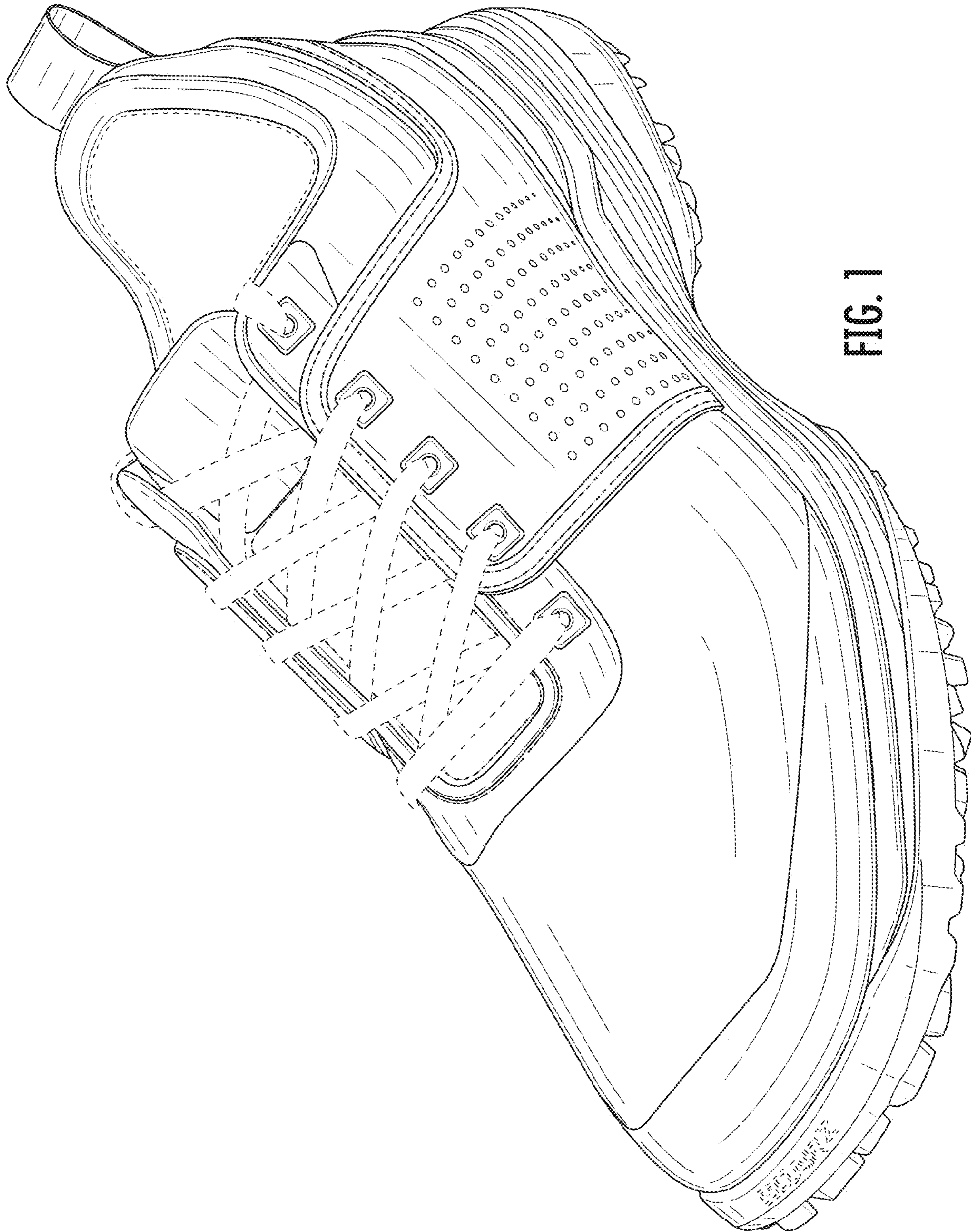

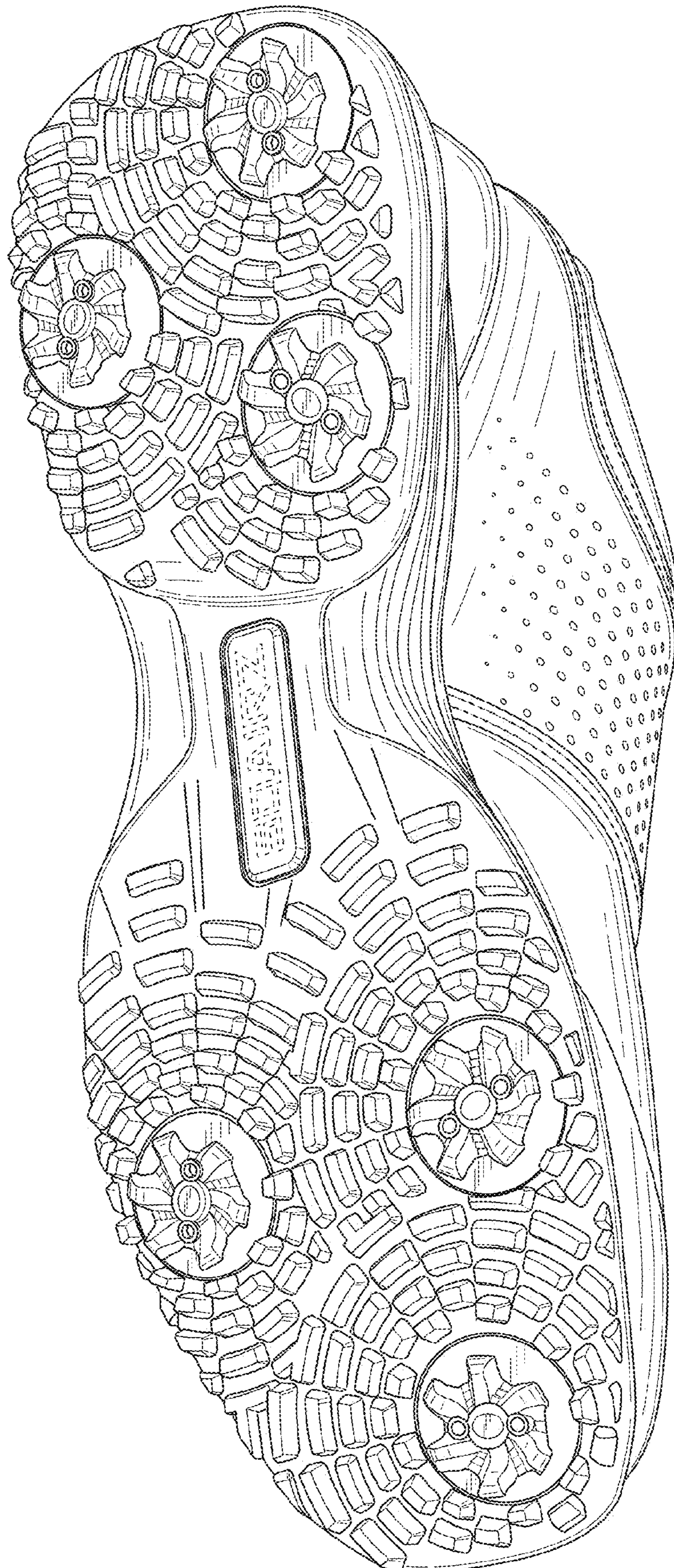

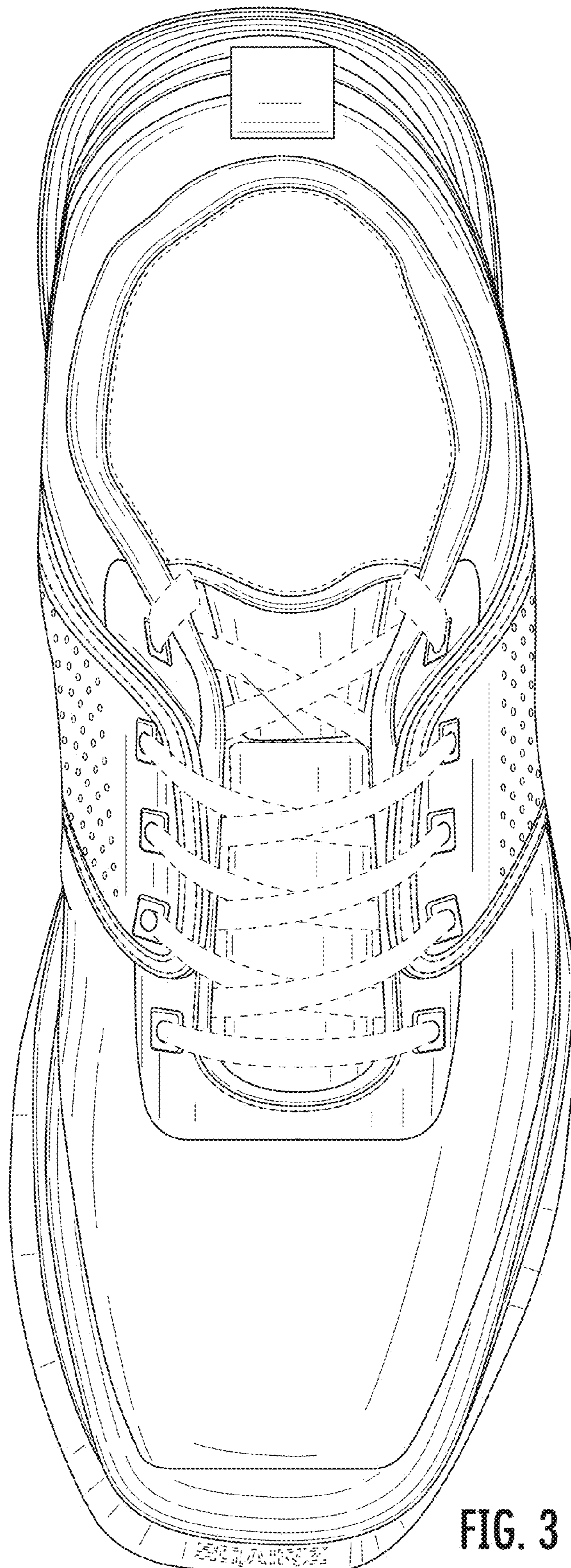

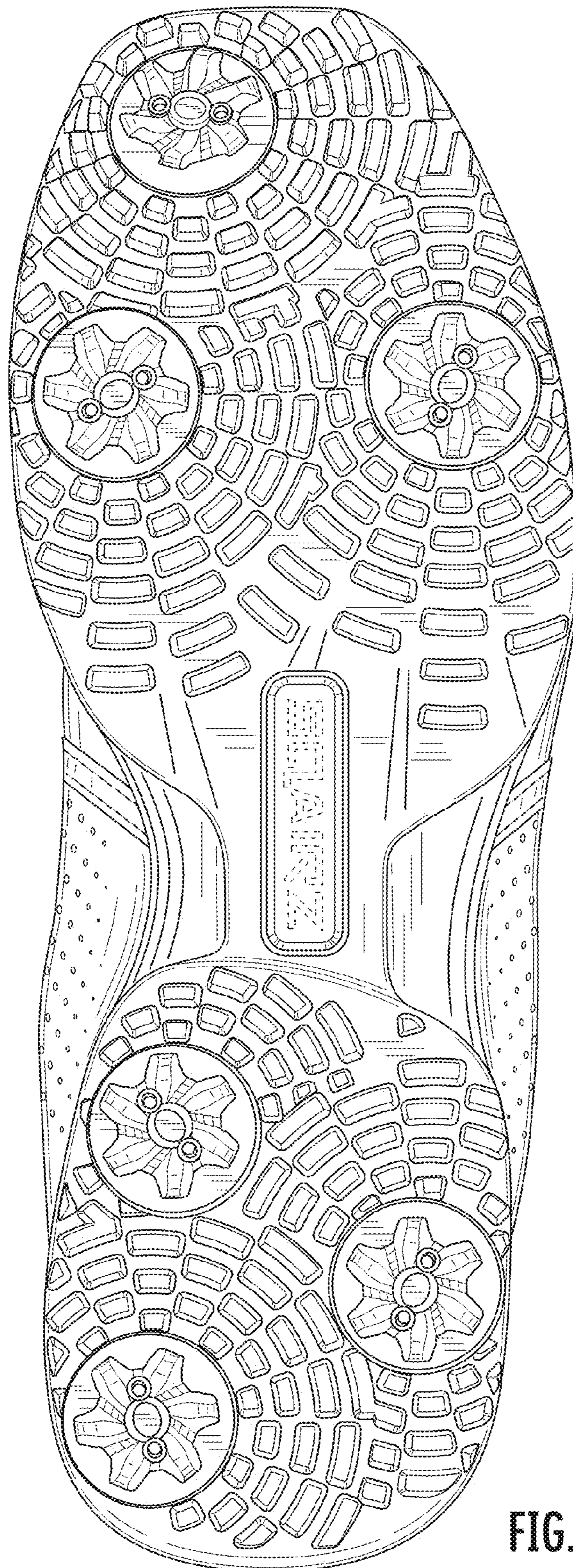

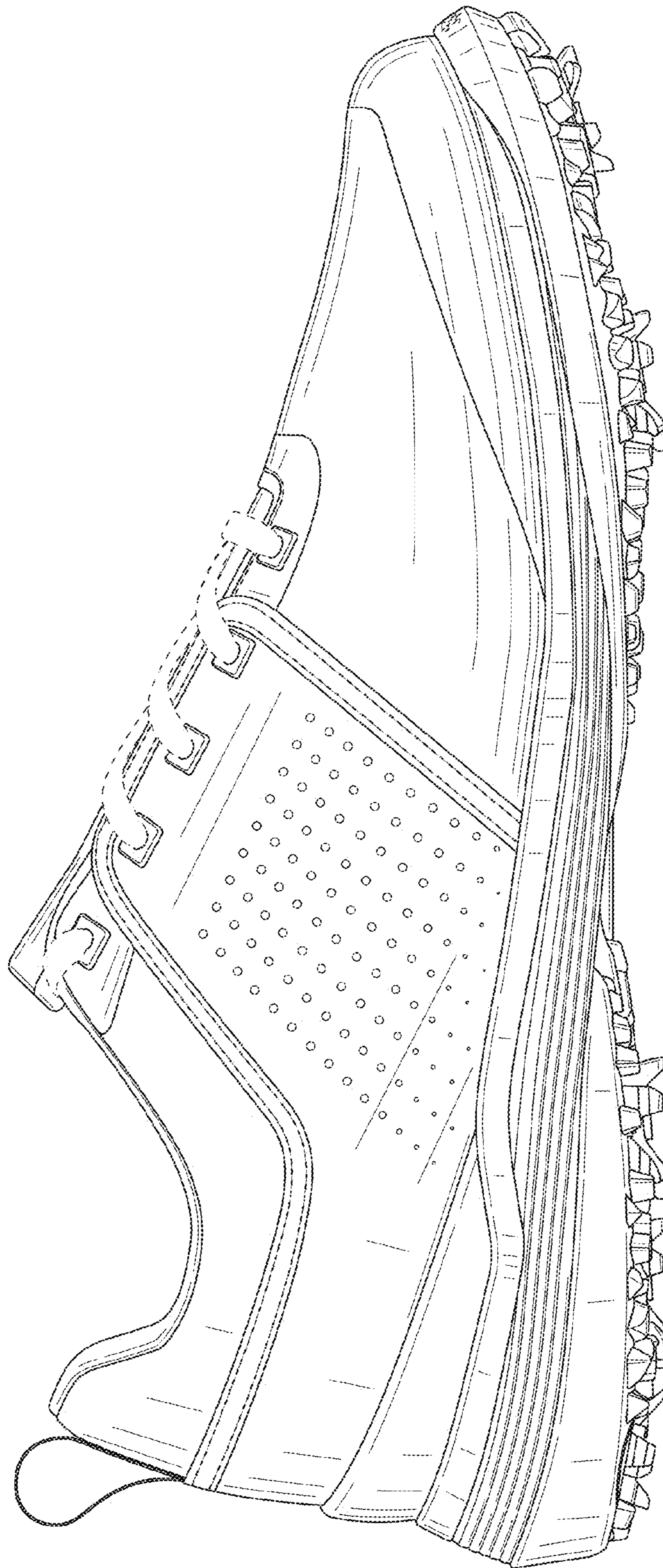

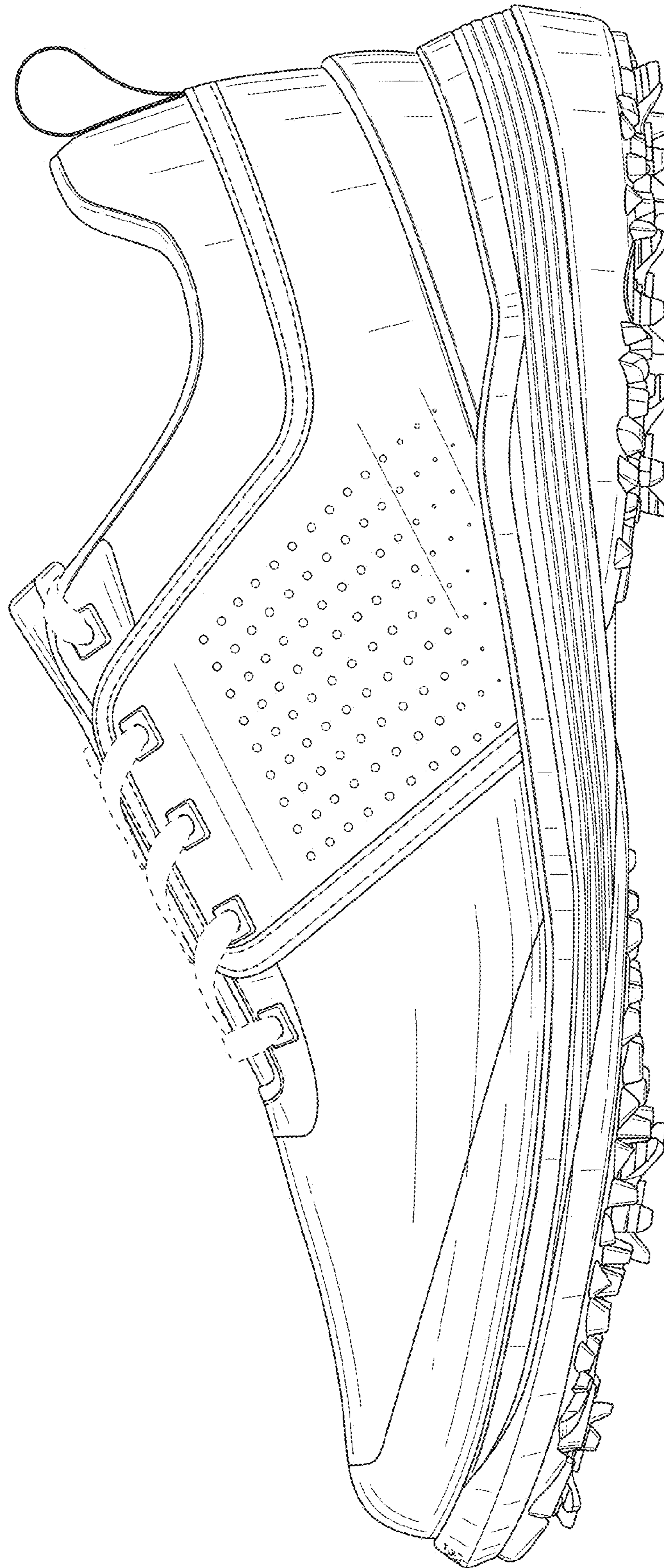

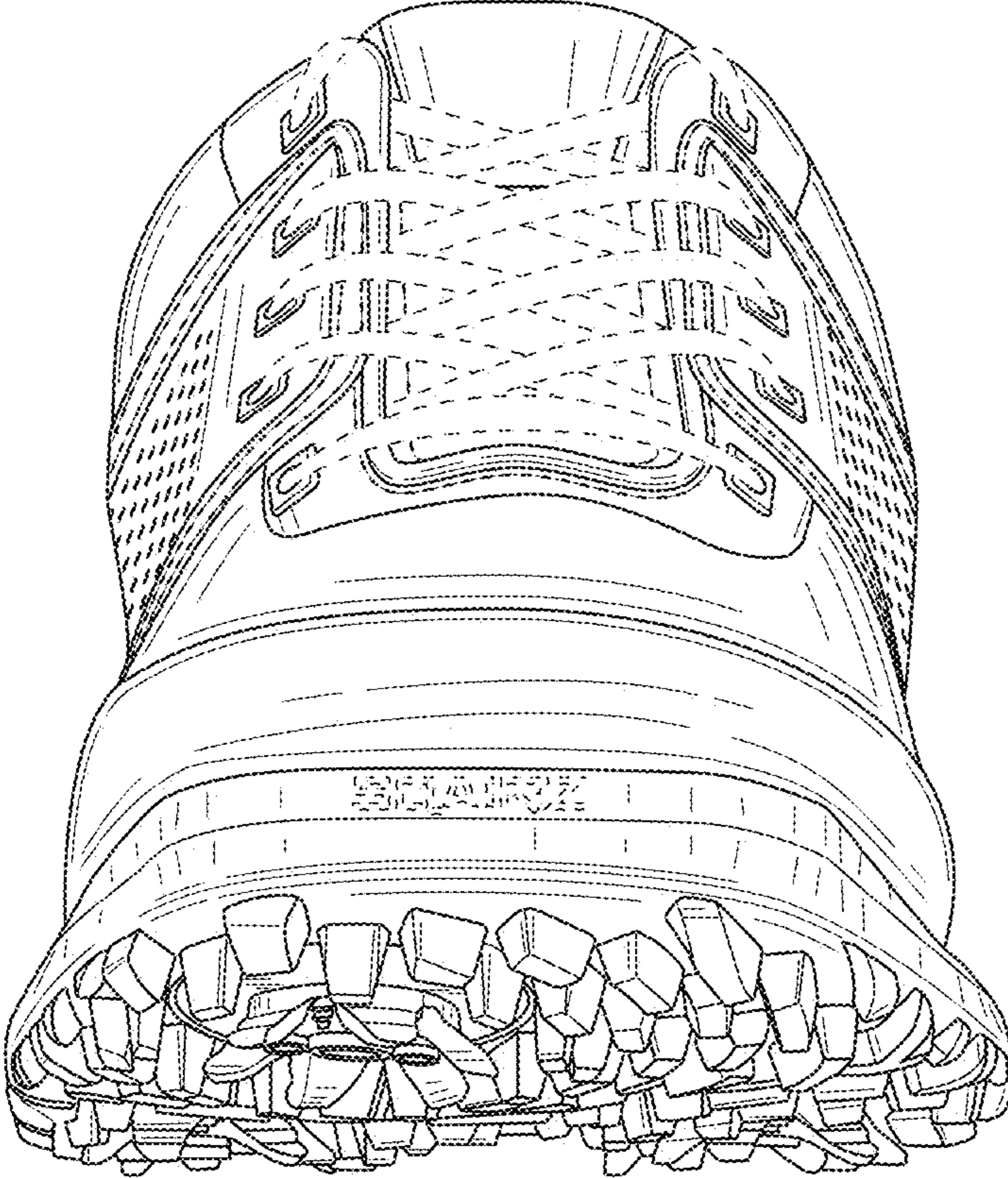

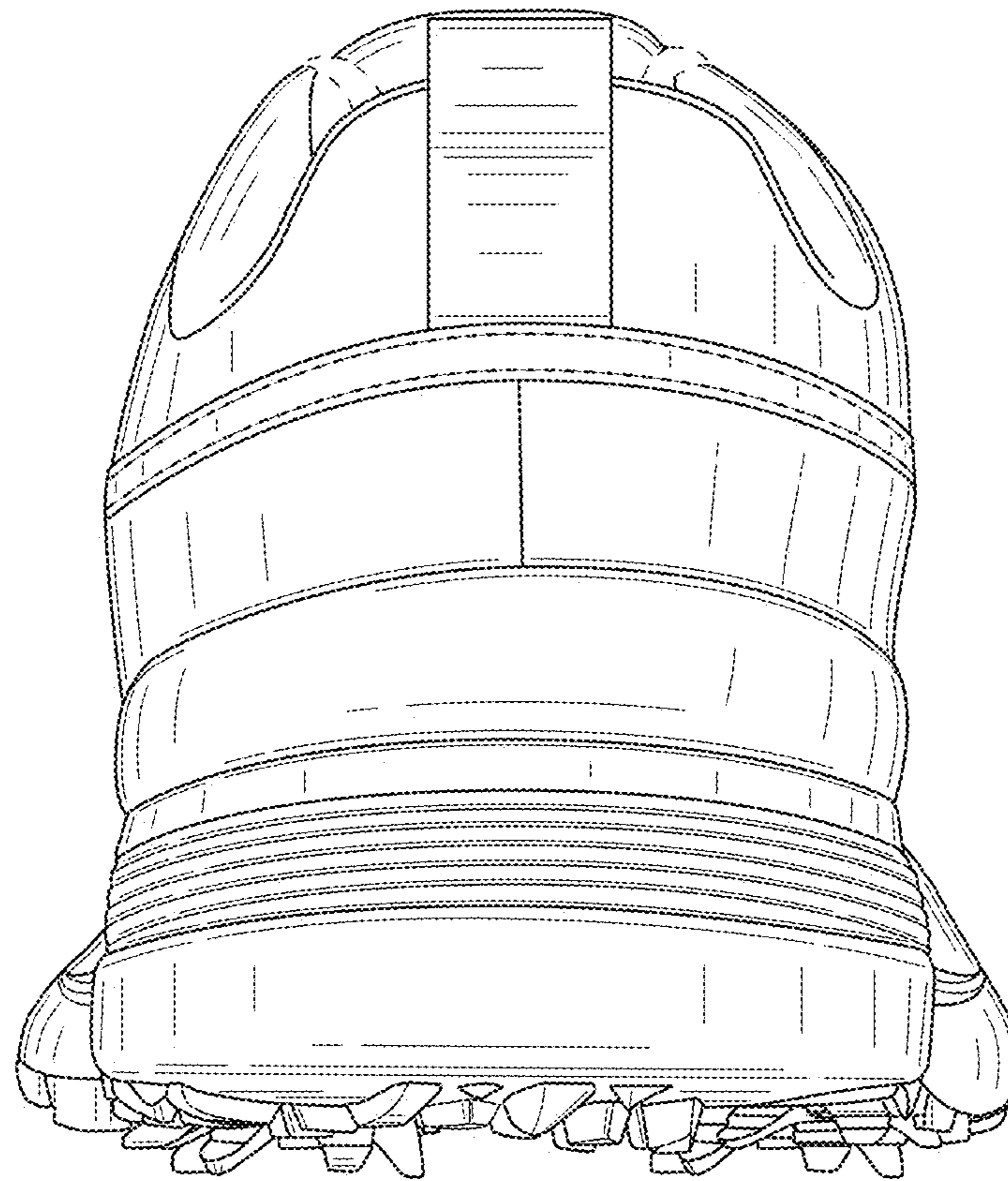
