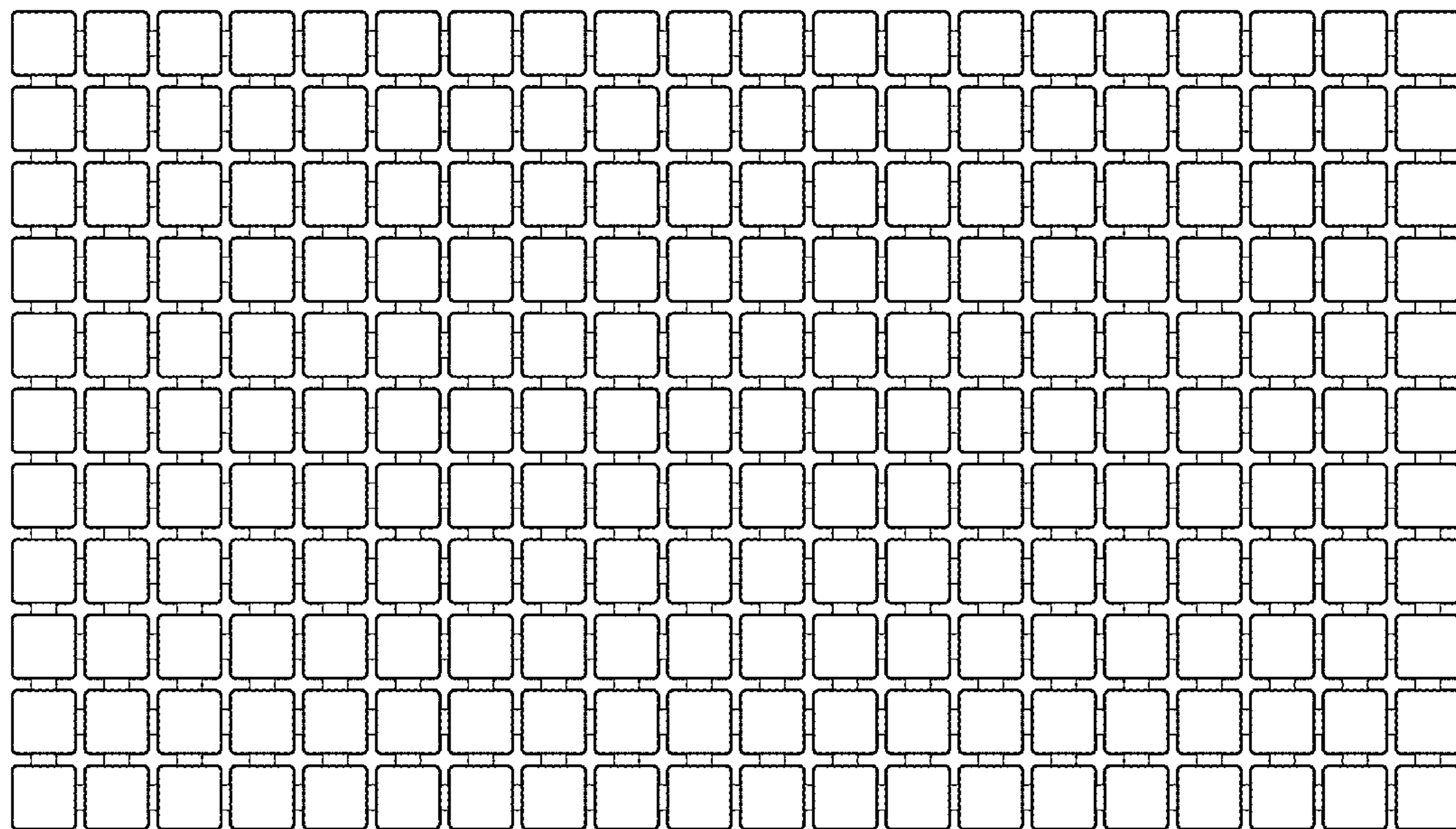
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front elevational view of a mosaic anti slip mat showing my new design;

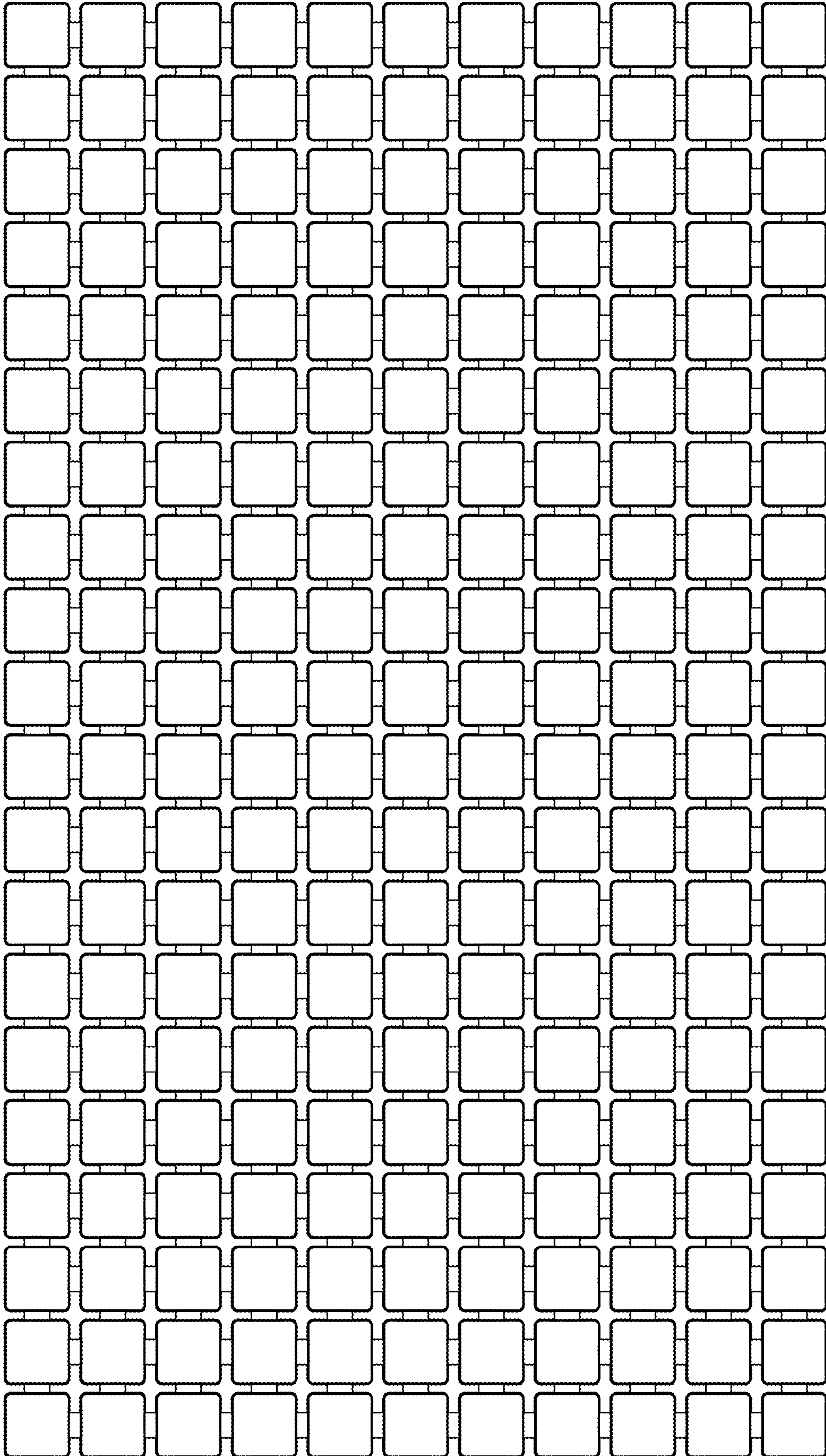

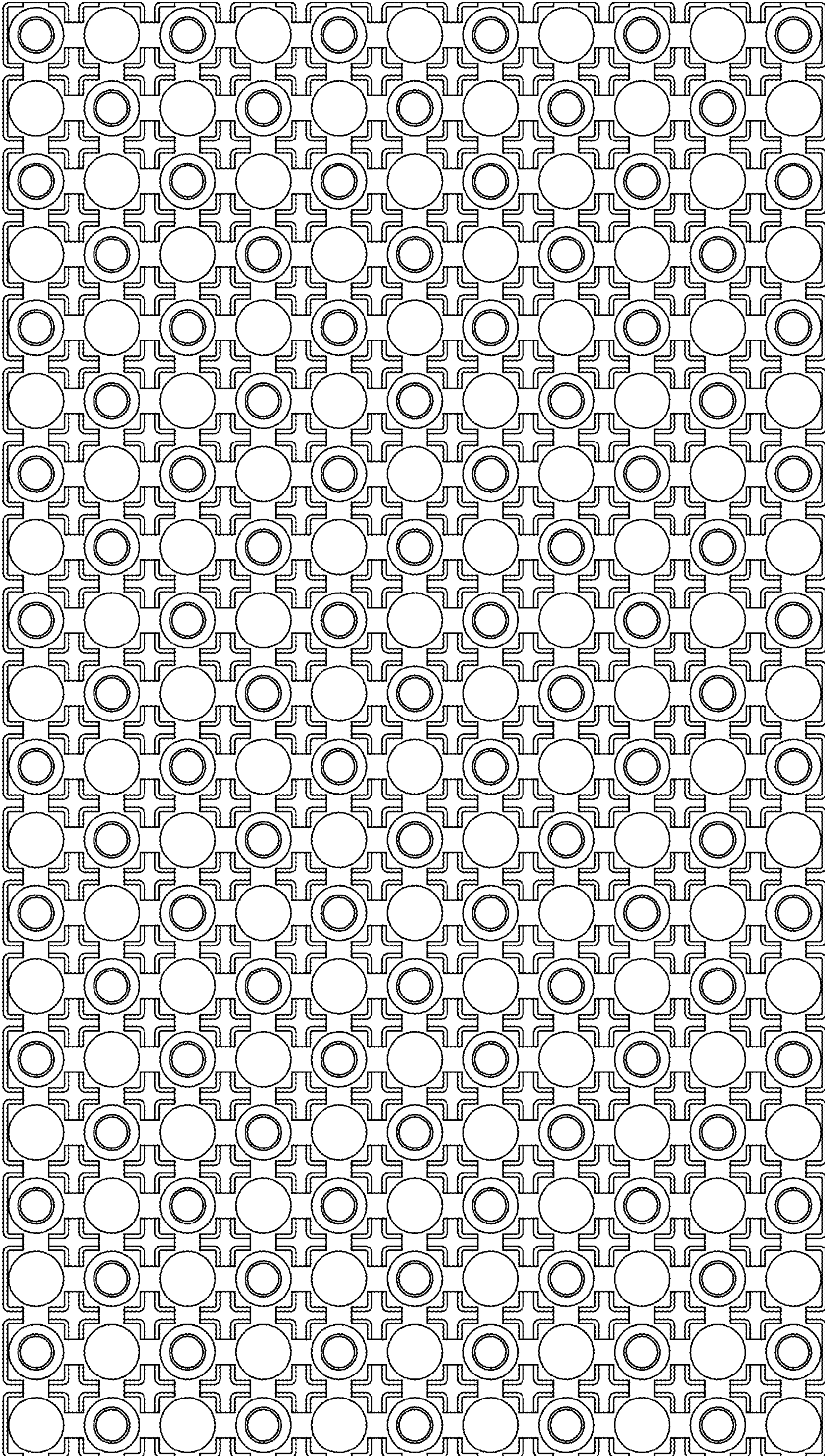

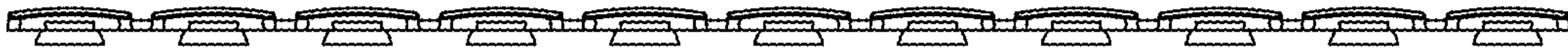

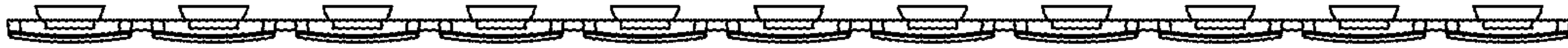

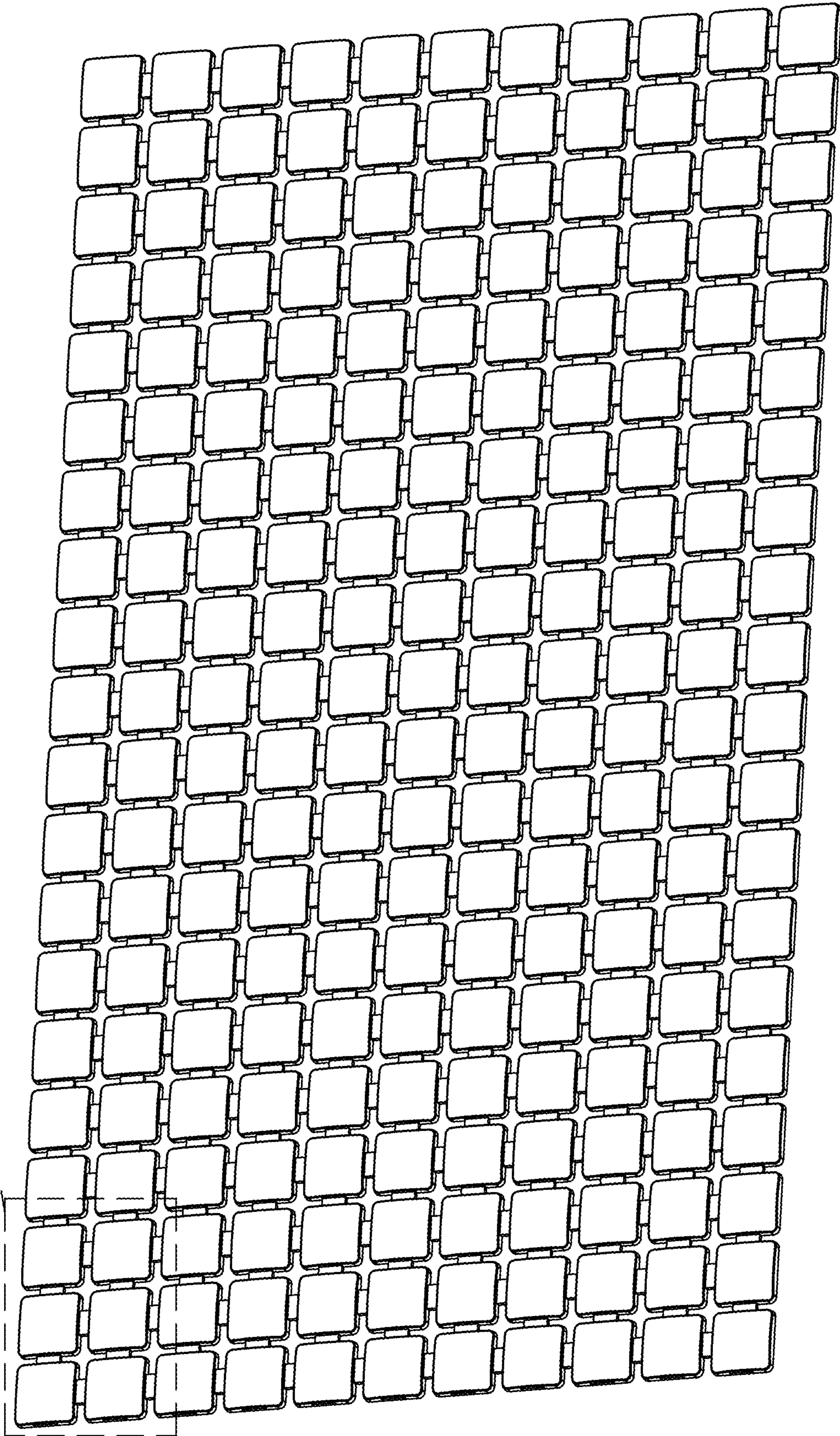

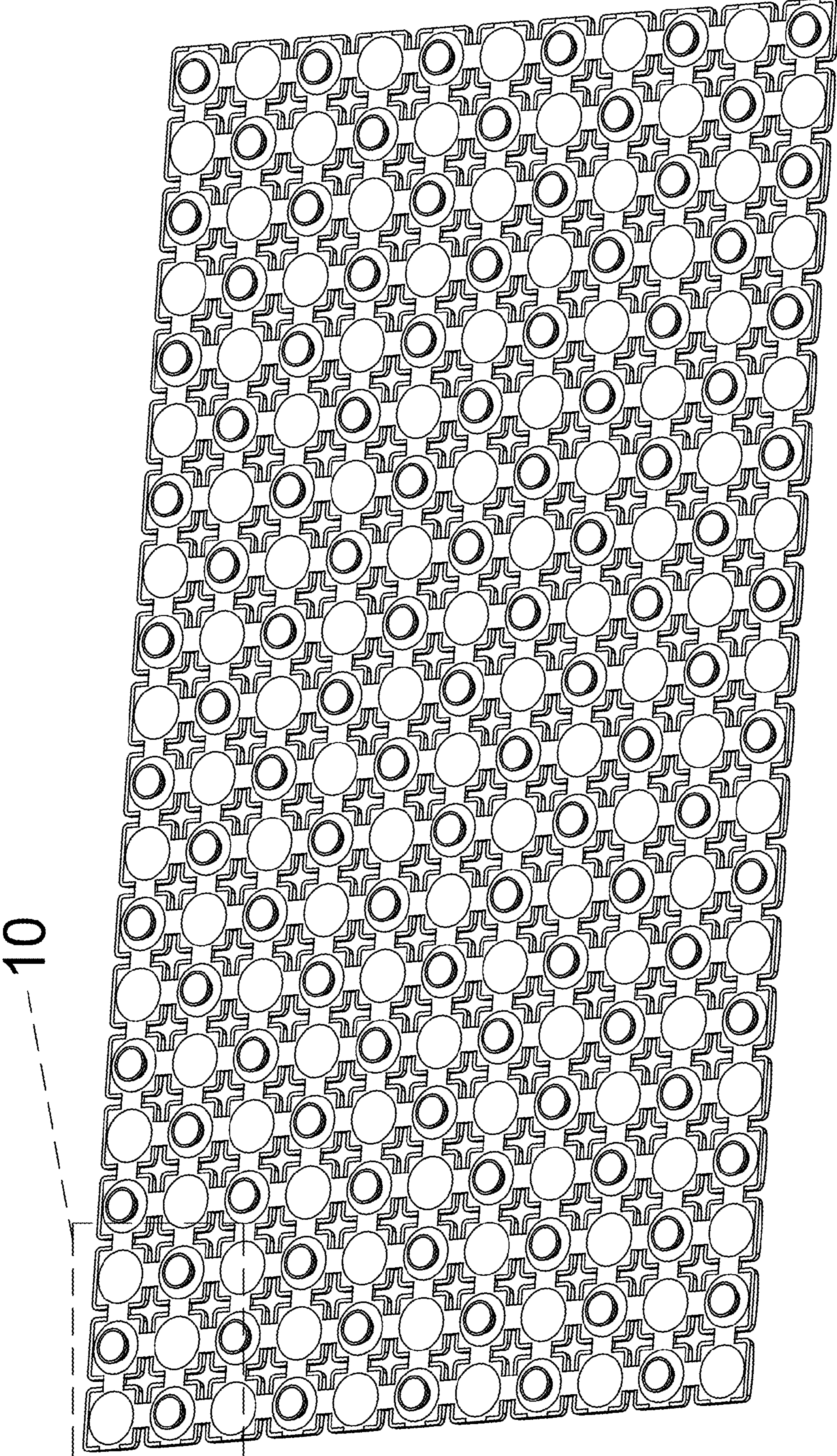

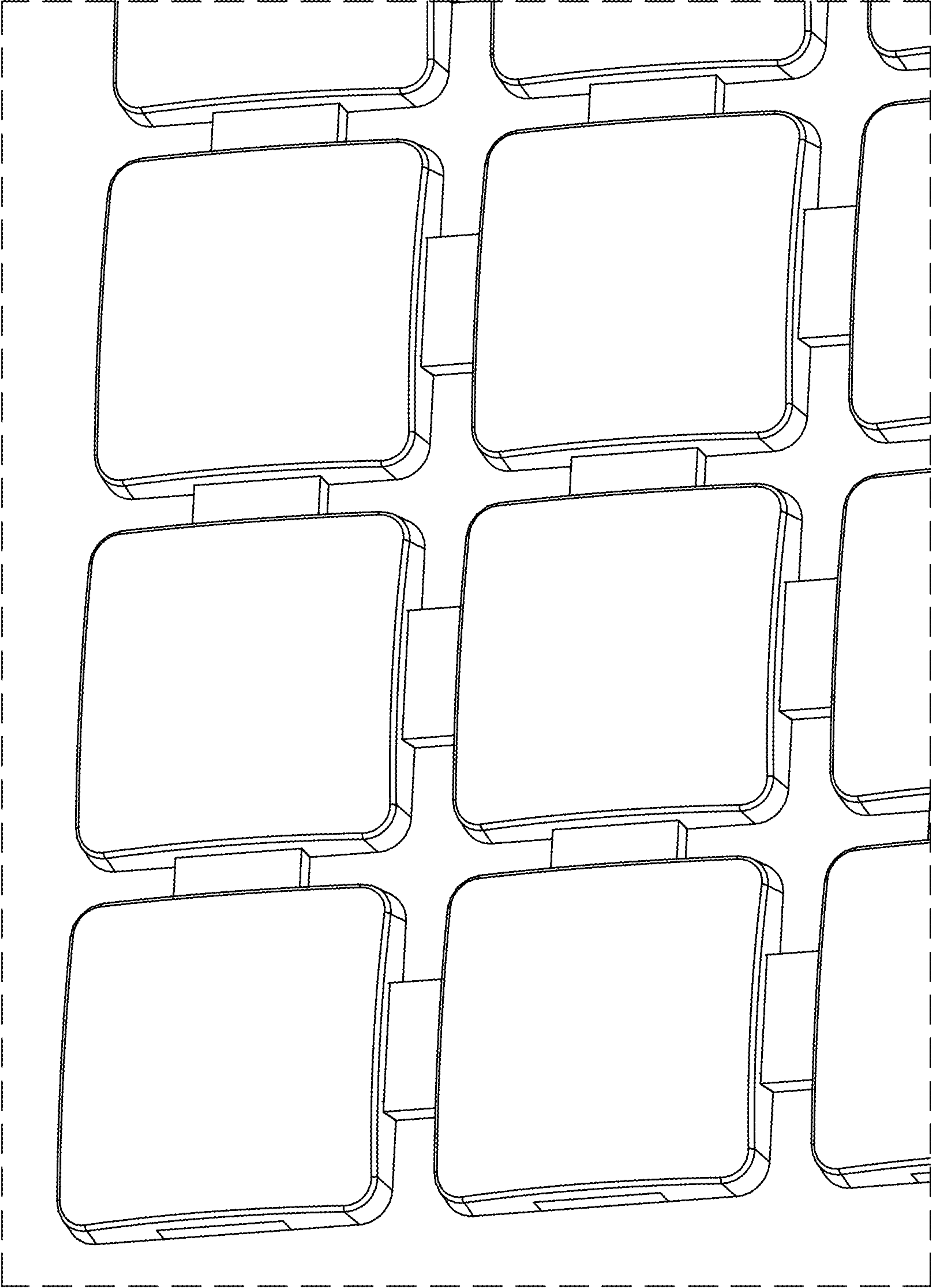

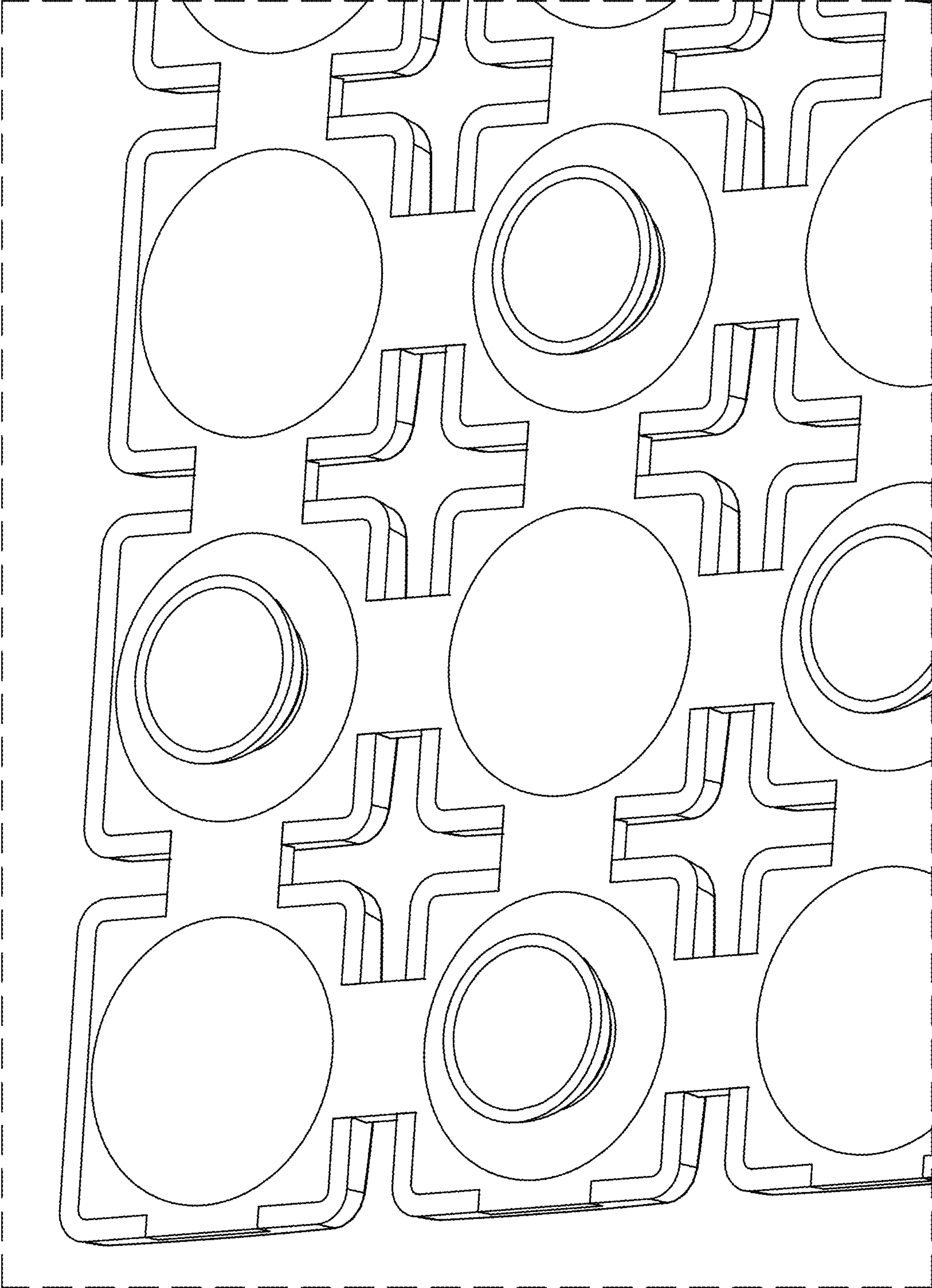
