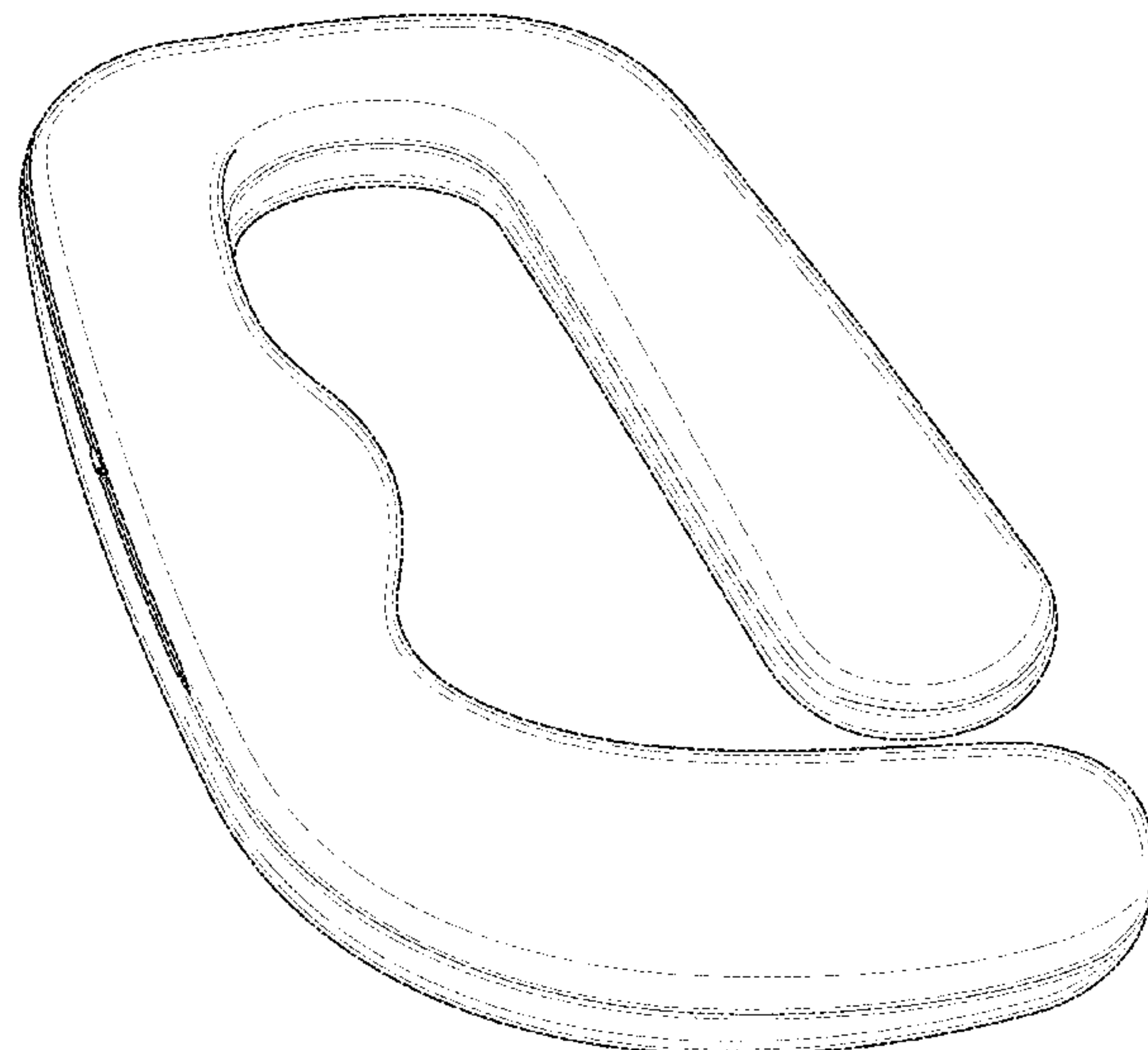
The ornamental design for a pillow, as shown and described.

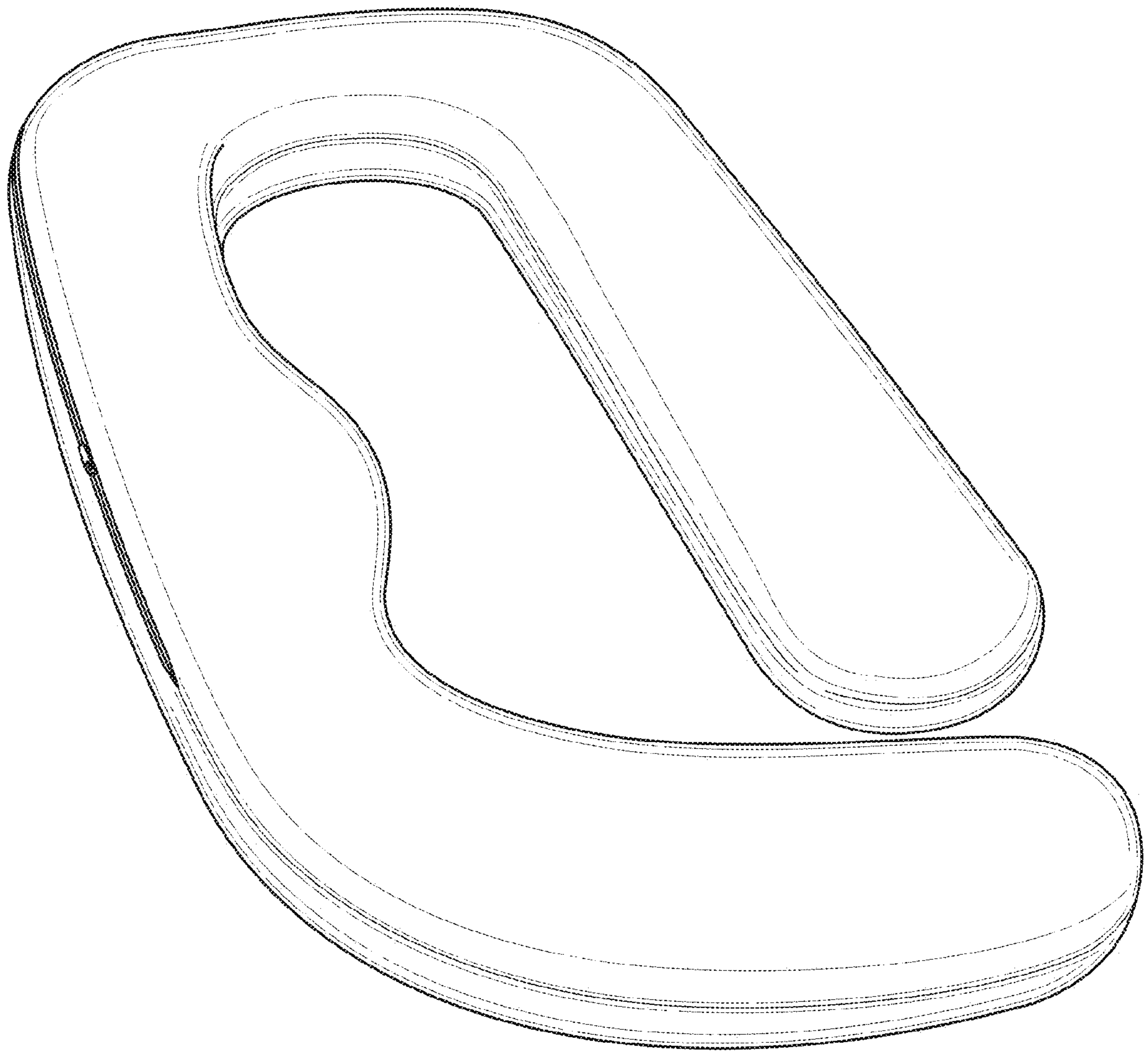

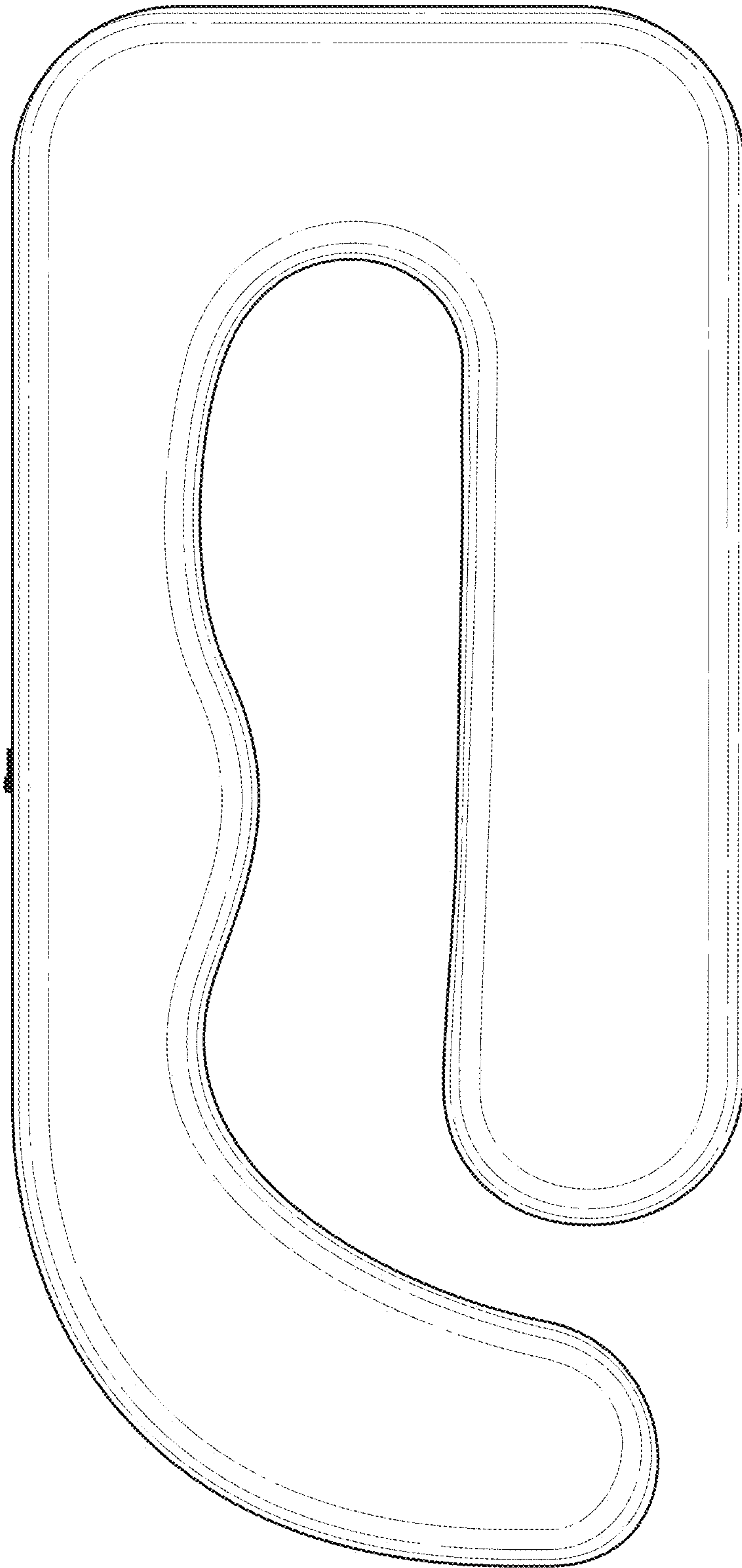

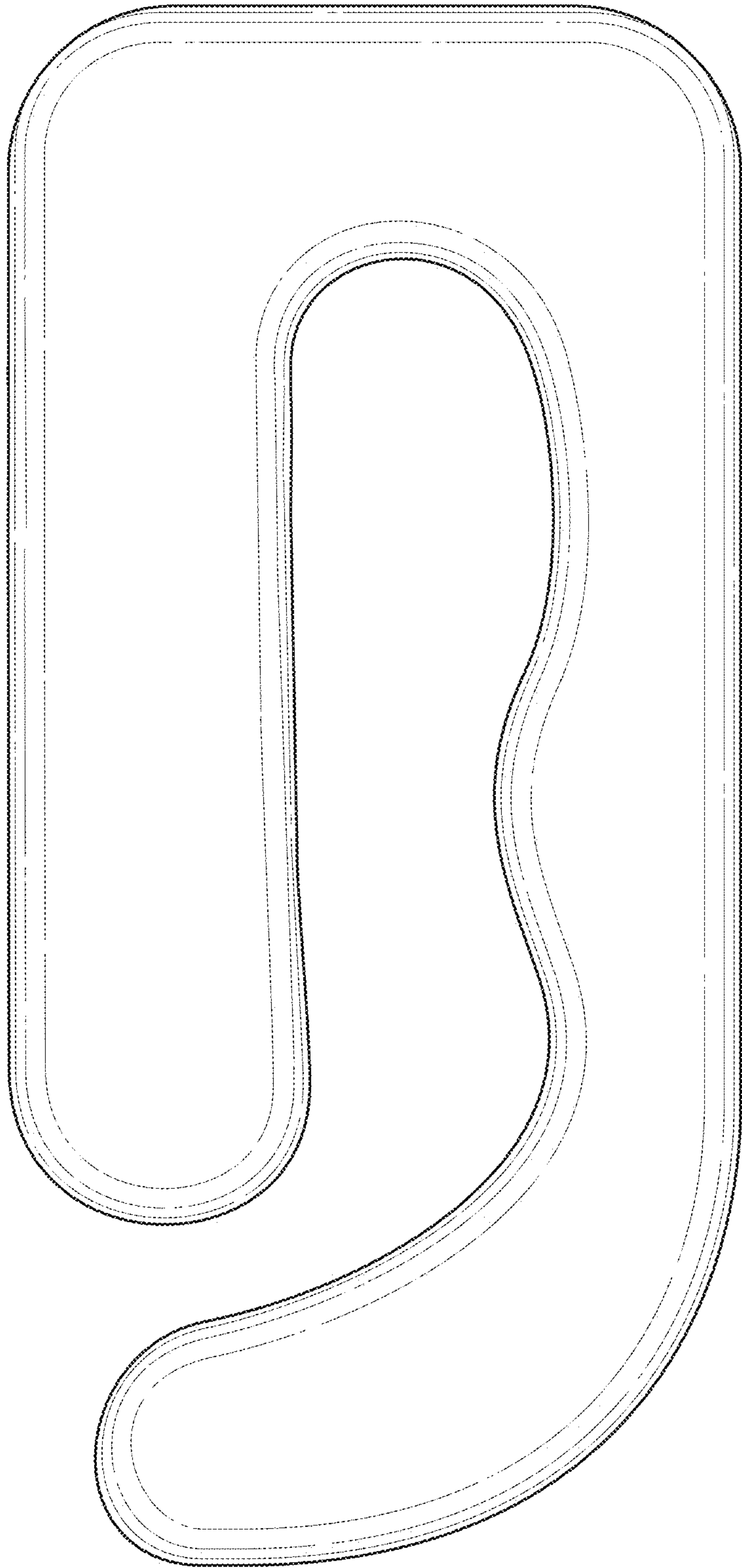

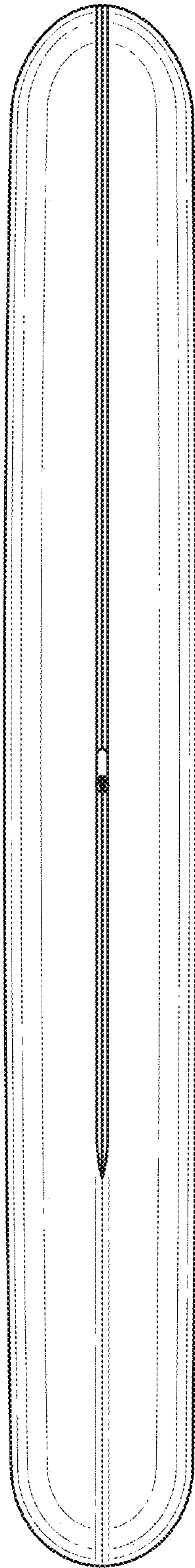

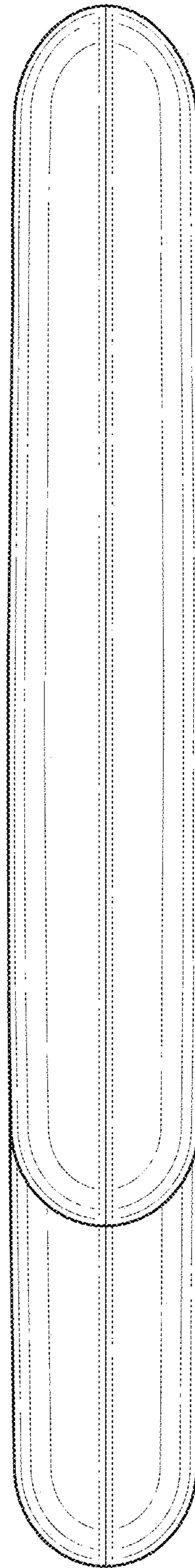

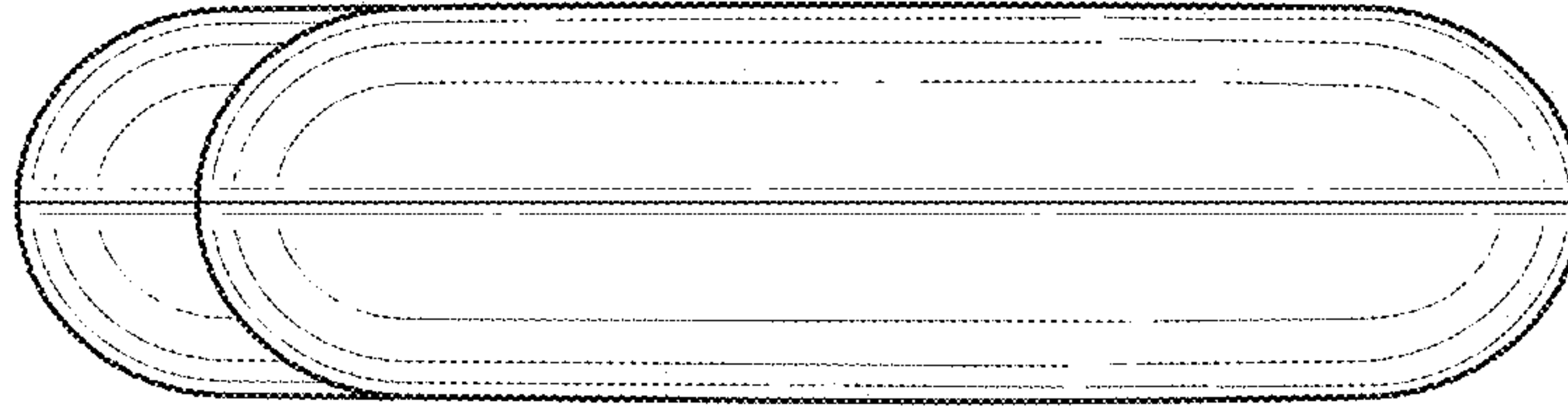

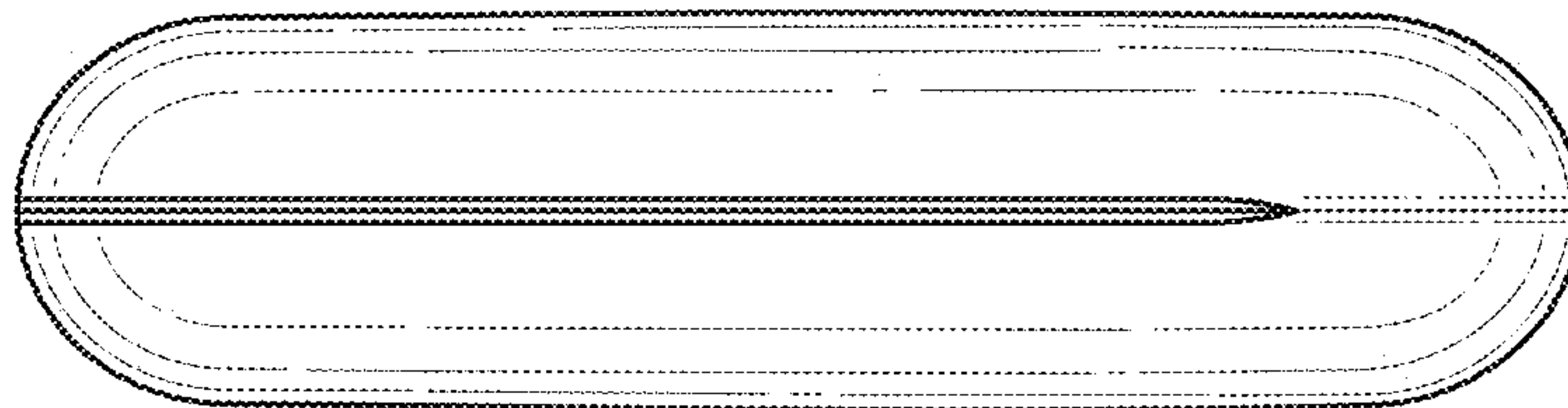
