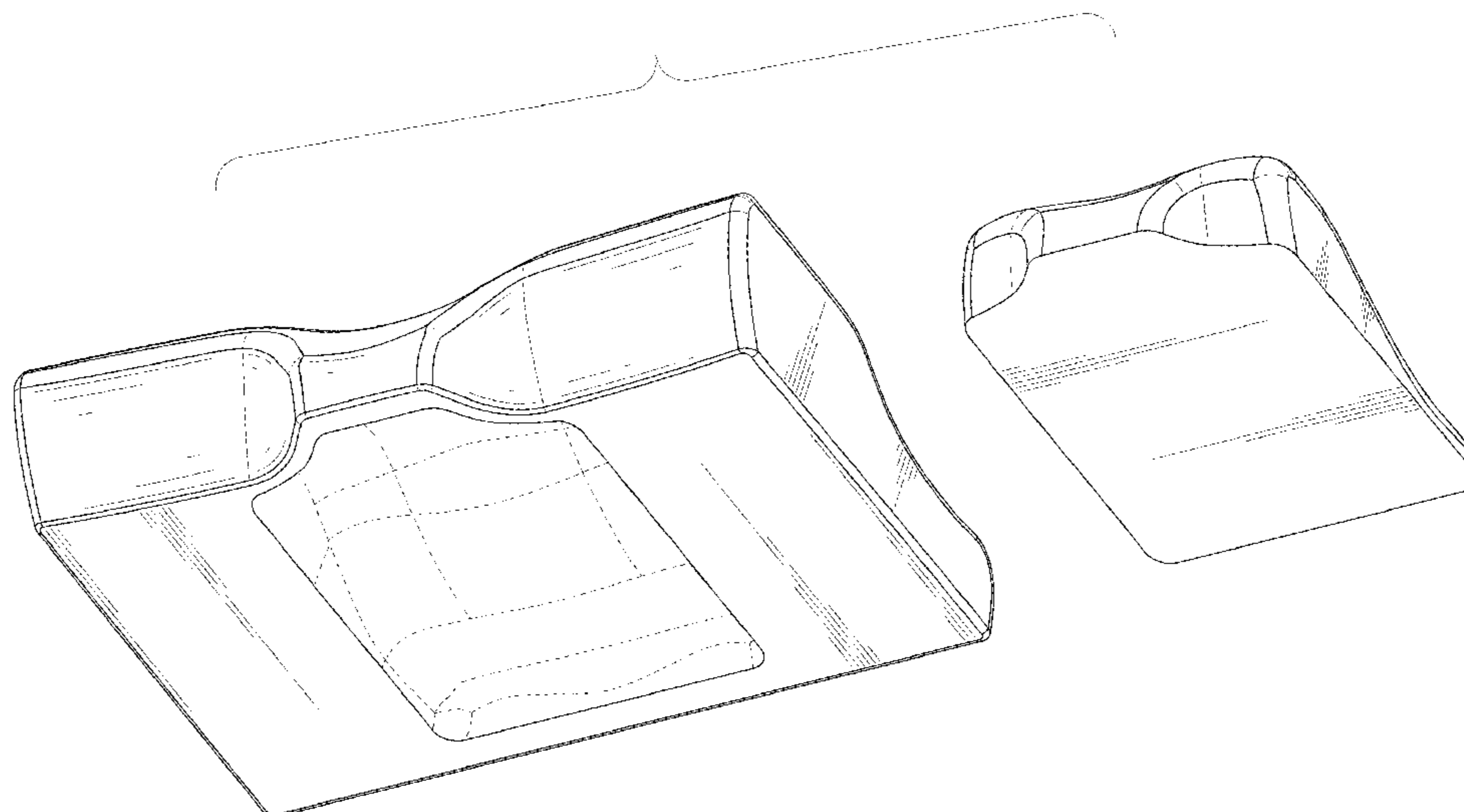
(57) **CLAIM**

The ornamental design for a pillow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a first component of a pillow, showing my new design, shown separately for ease of illustration;
FIG. 2 is another perspective view thereof;
FIG. 3 is a front elevational view thereof;
FIG. 4 is a rear elevational view thereof;
FIG. 5 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 6 is a top plan view thereof;
FIG. 7 is a bottom plan view thereof;
FIG. 8 is a perspective view of a second component of the pillow, shown separately for ease of illustration;
FIG. 9 is another perspective view thereof;
FIG. 10 is a front elevational view thereof;
FIG. 11 is a rear elevational view thereof;
FIG. 12 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 13 is a top plan view thereof;
FIG. 14 is a bottom plan view thereof;
FIG. 15 is an exploded perspective view of the pillow; and,
FIG. 16 is a perspective view of the pillow, shown in use with the second component of the pillow received in the first component of the pillow.
The broken lines in the drawings depict portions of the pillow that form no part of the claimed design.

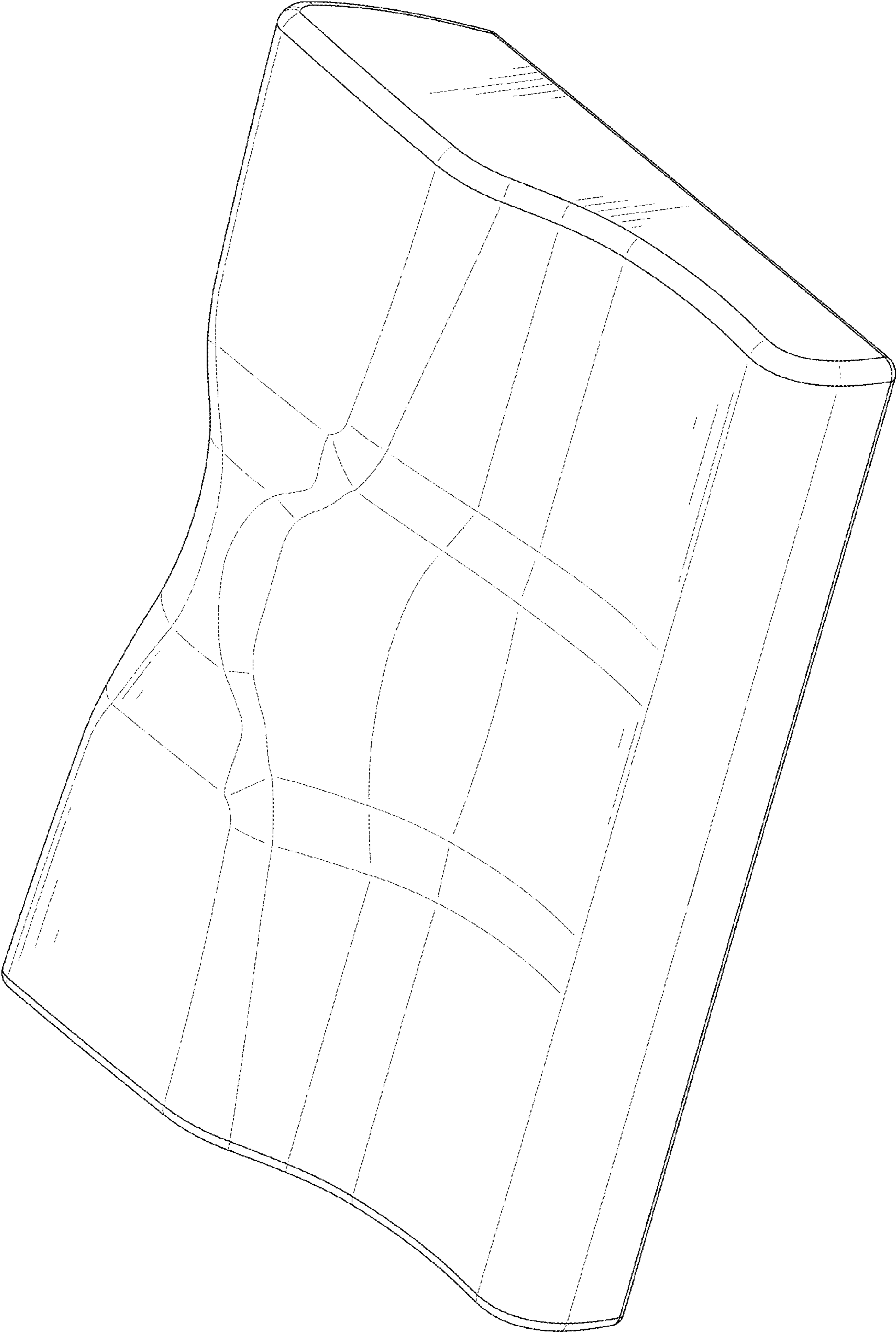

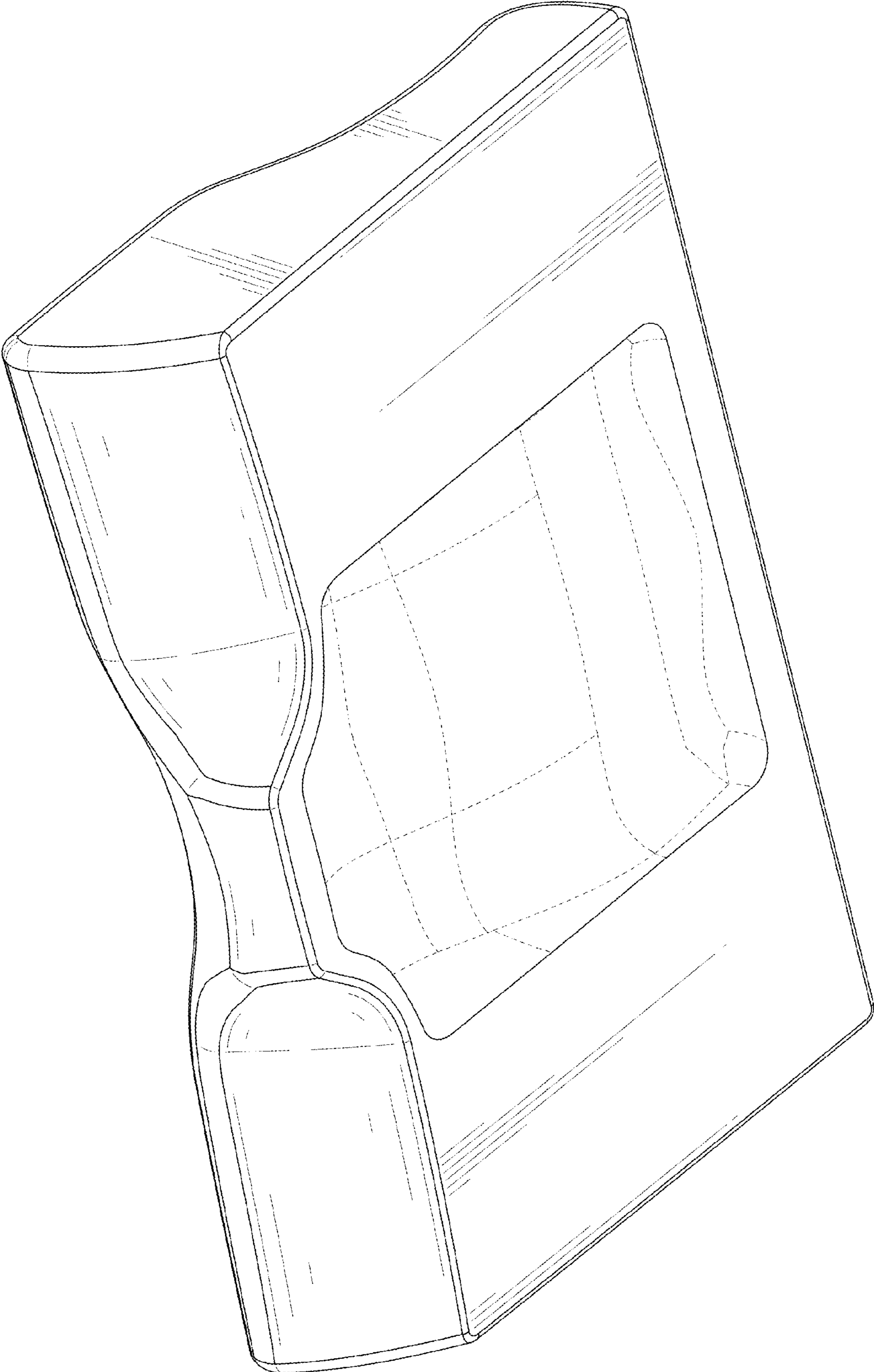

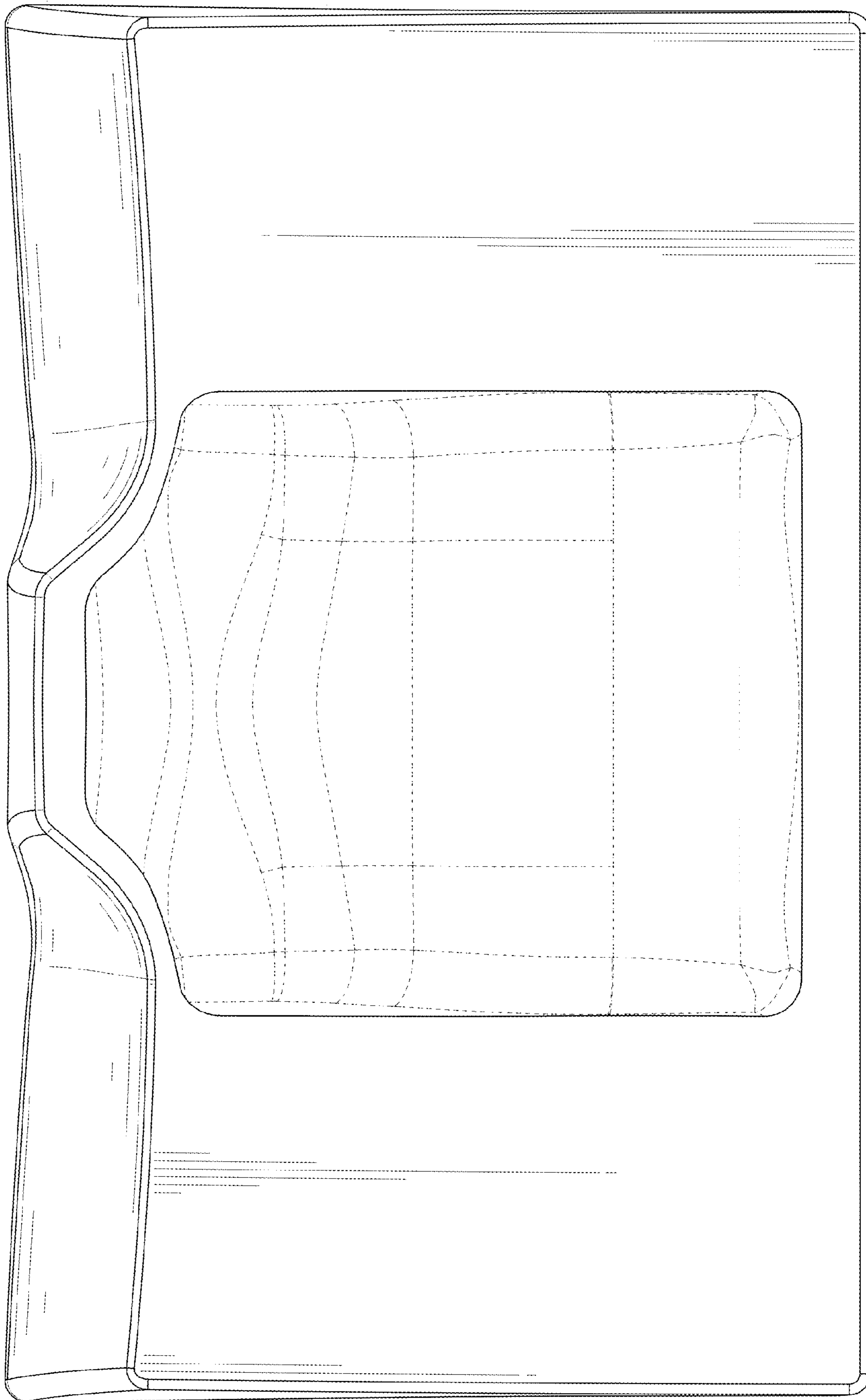

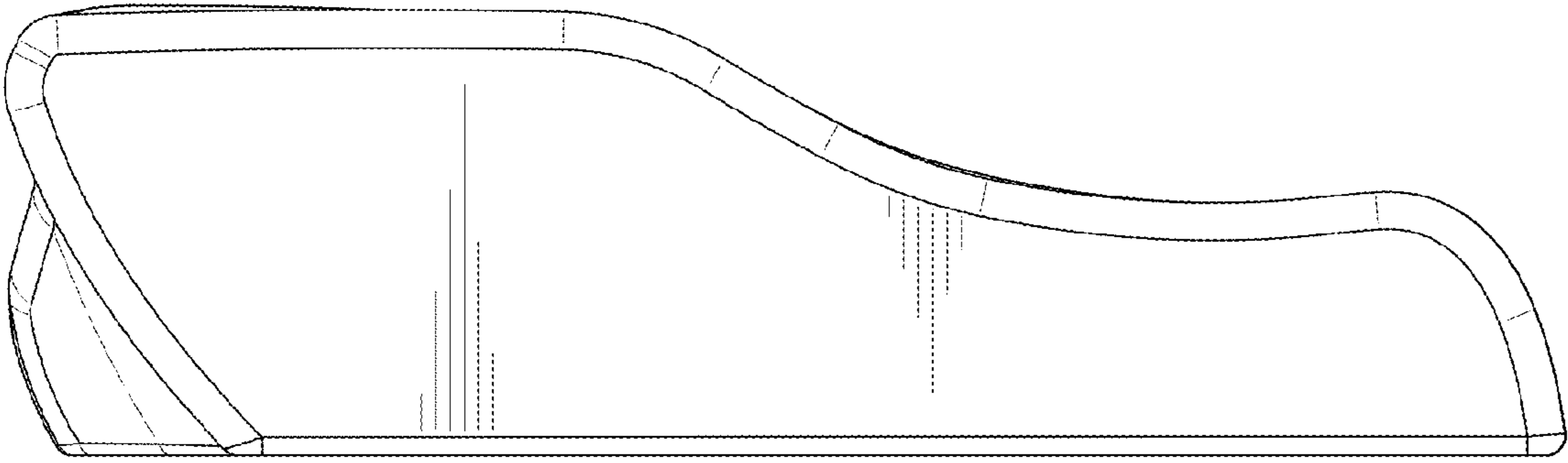

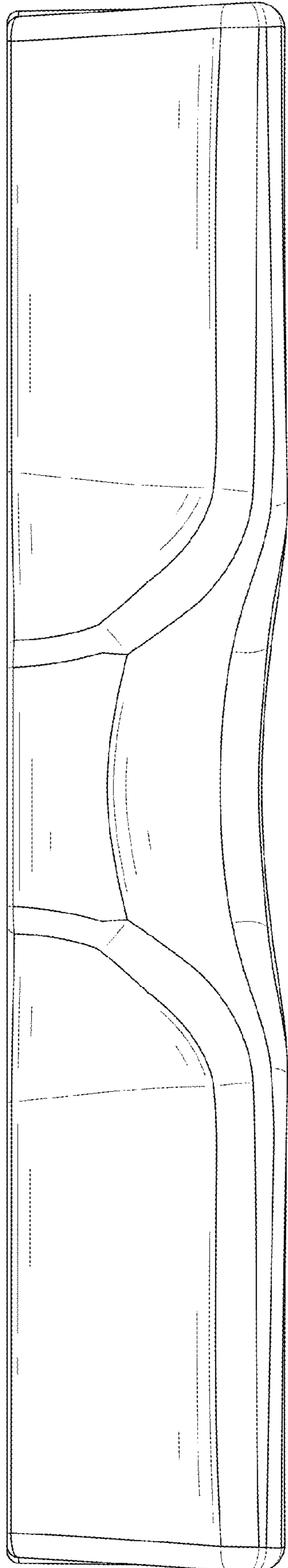

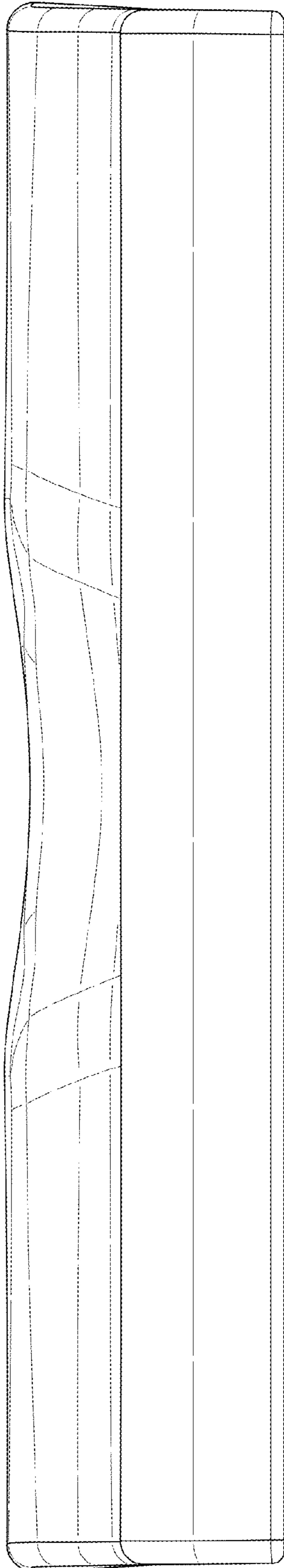

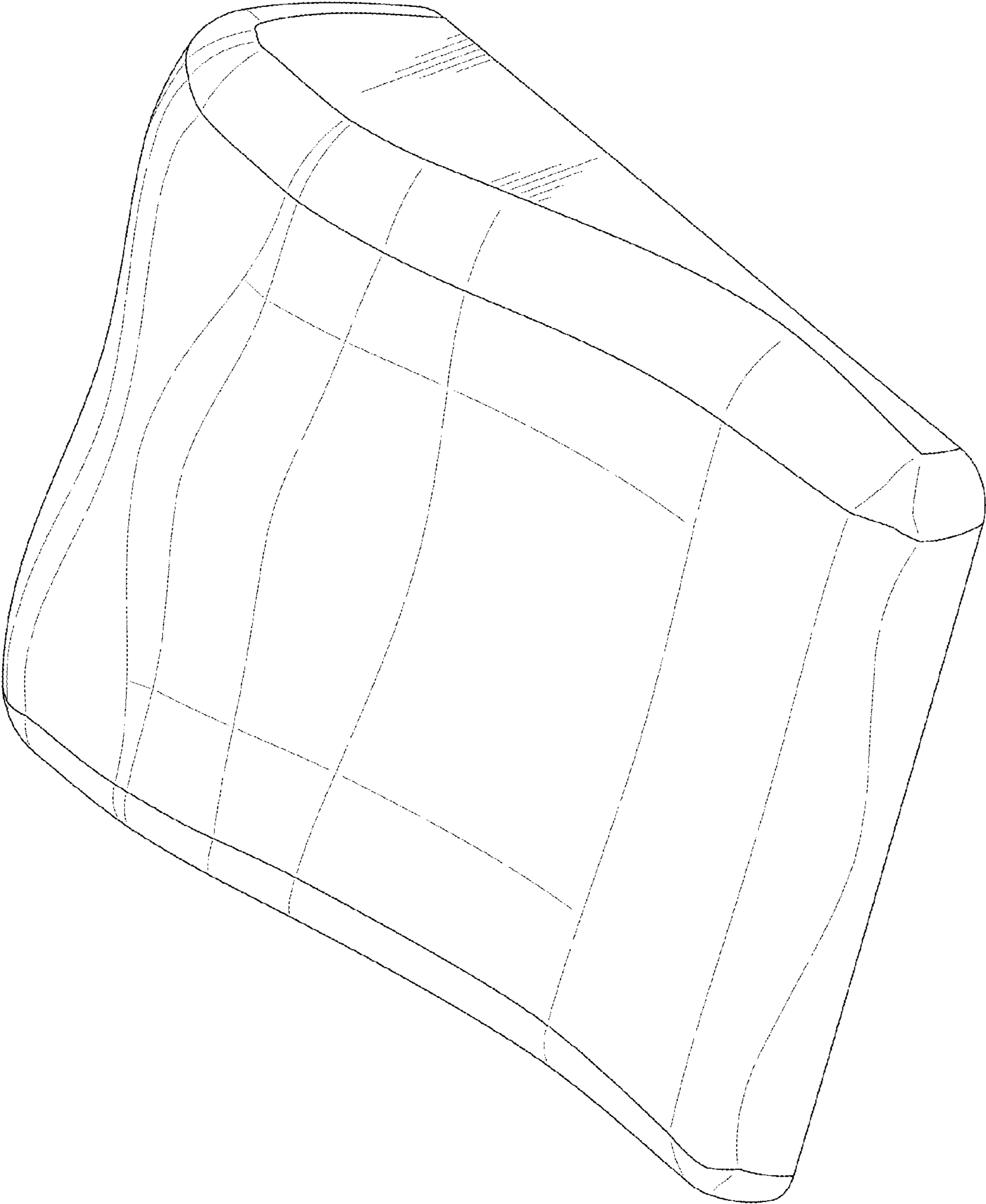

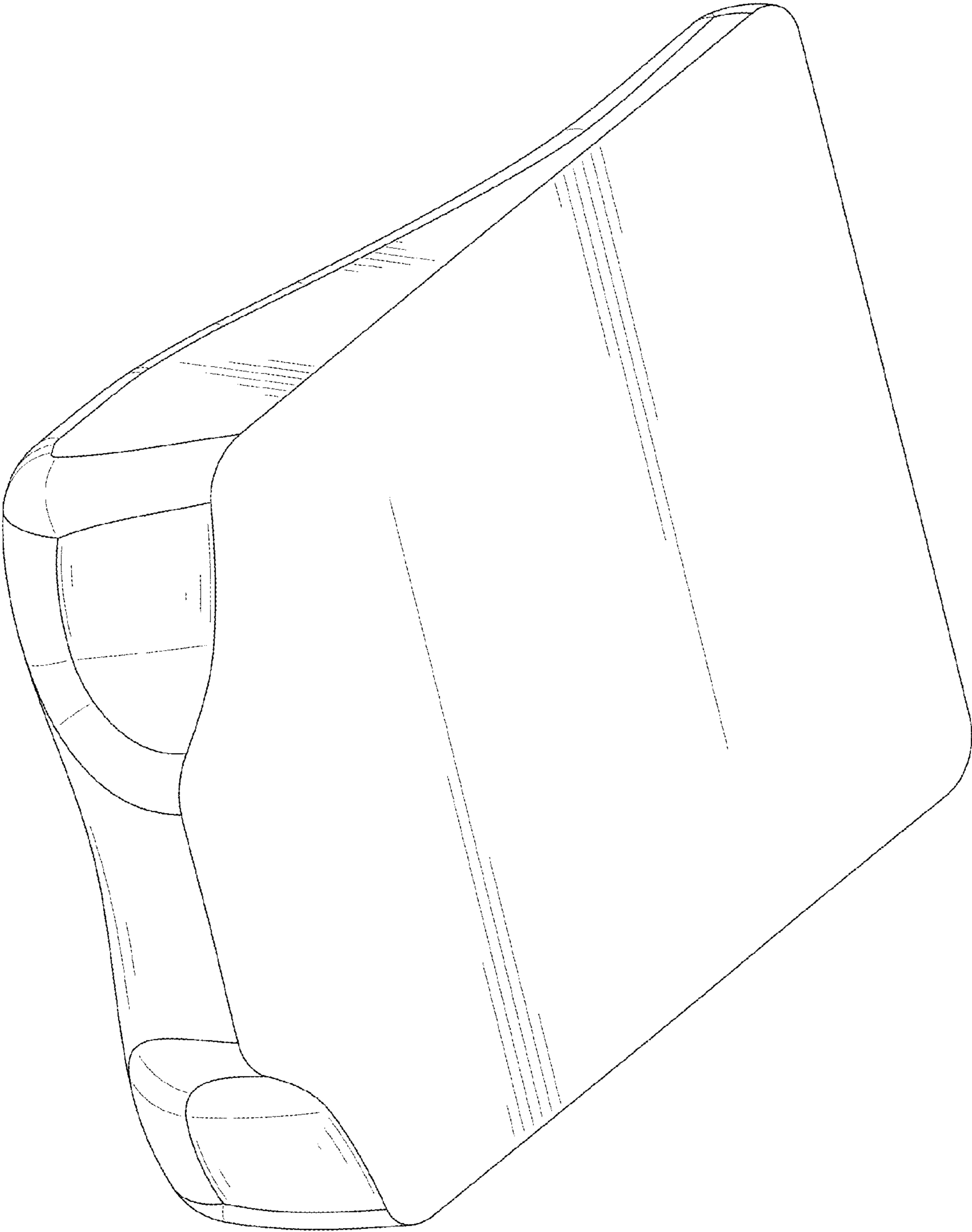

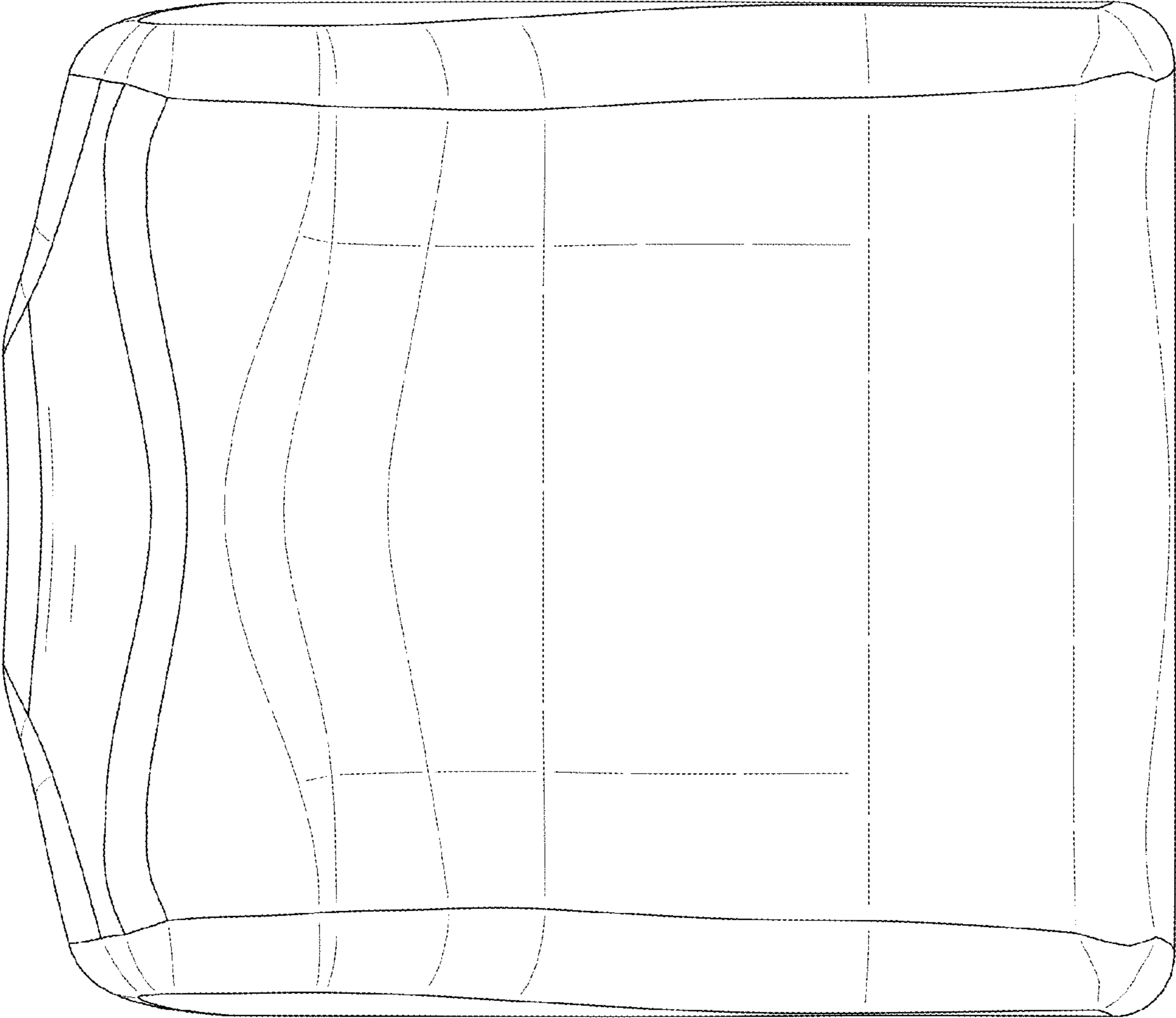

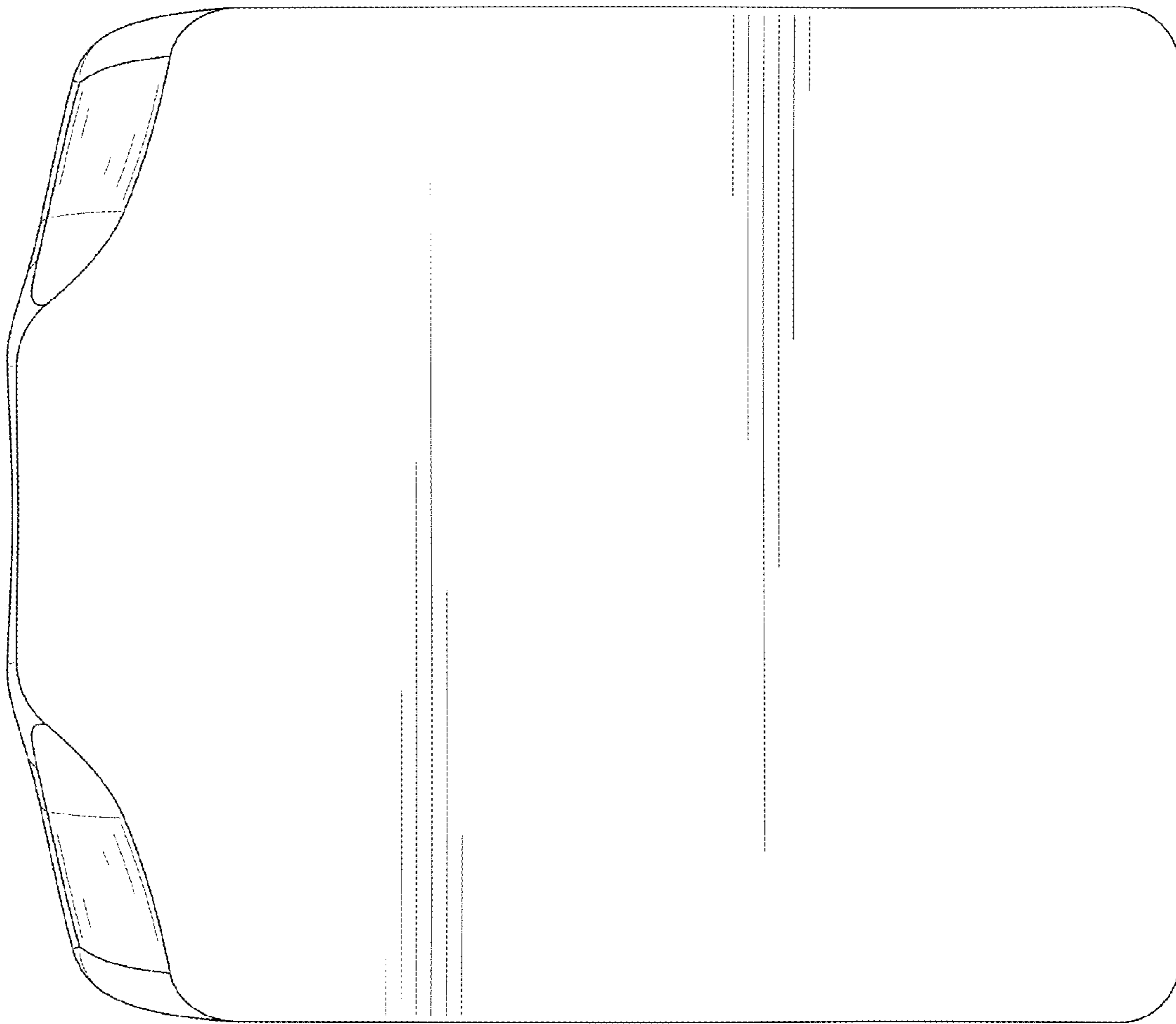

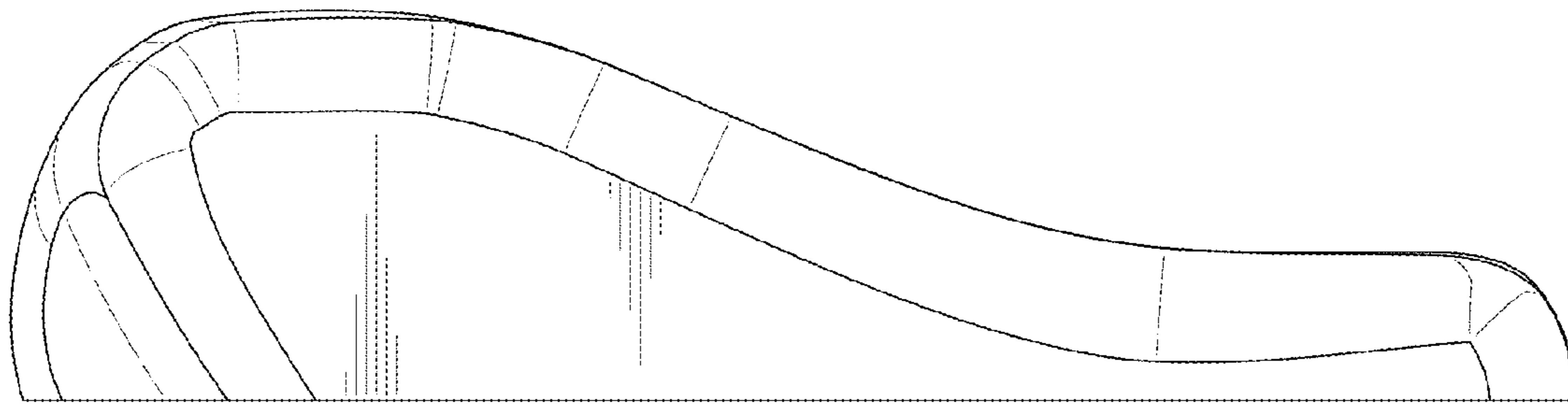

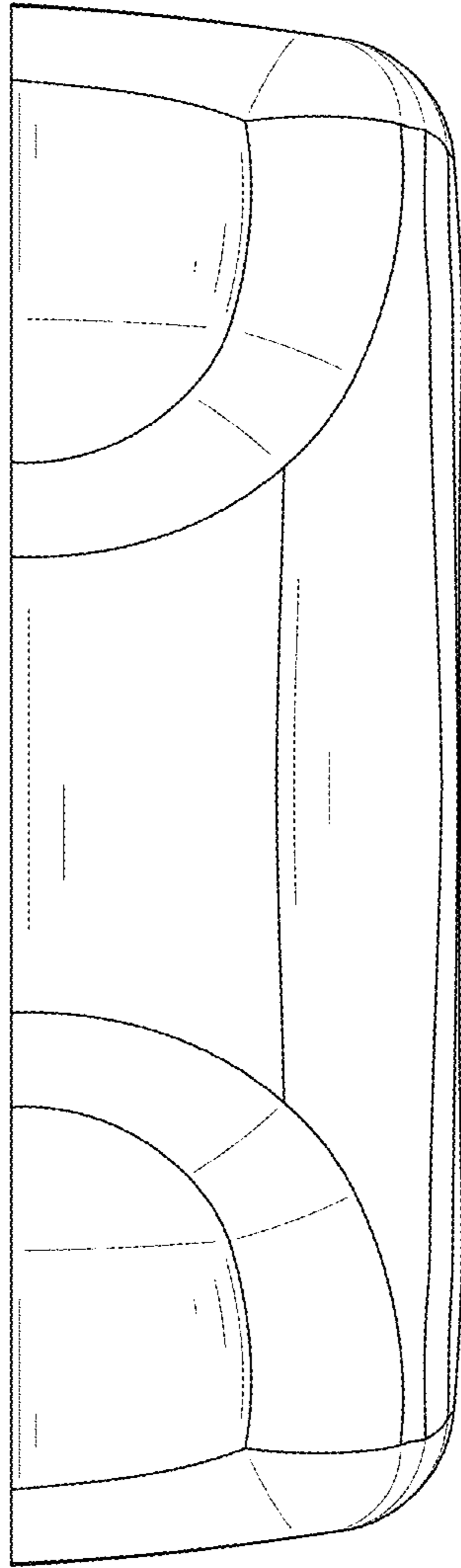

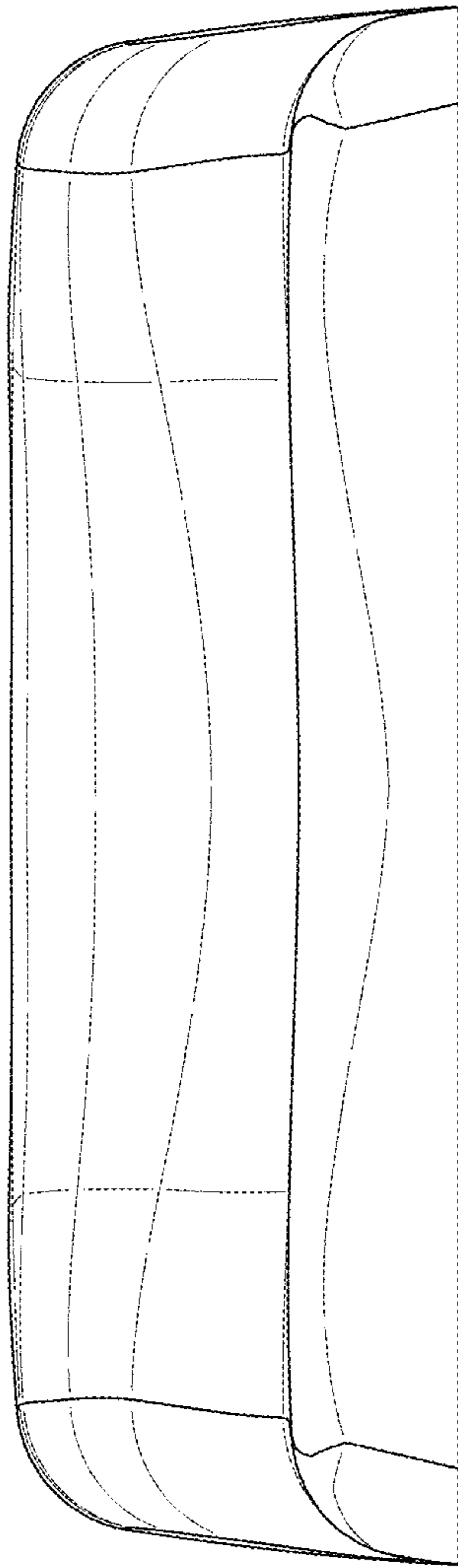

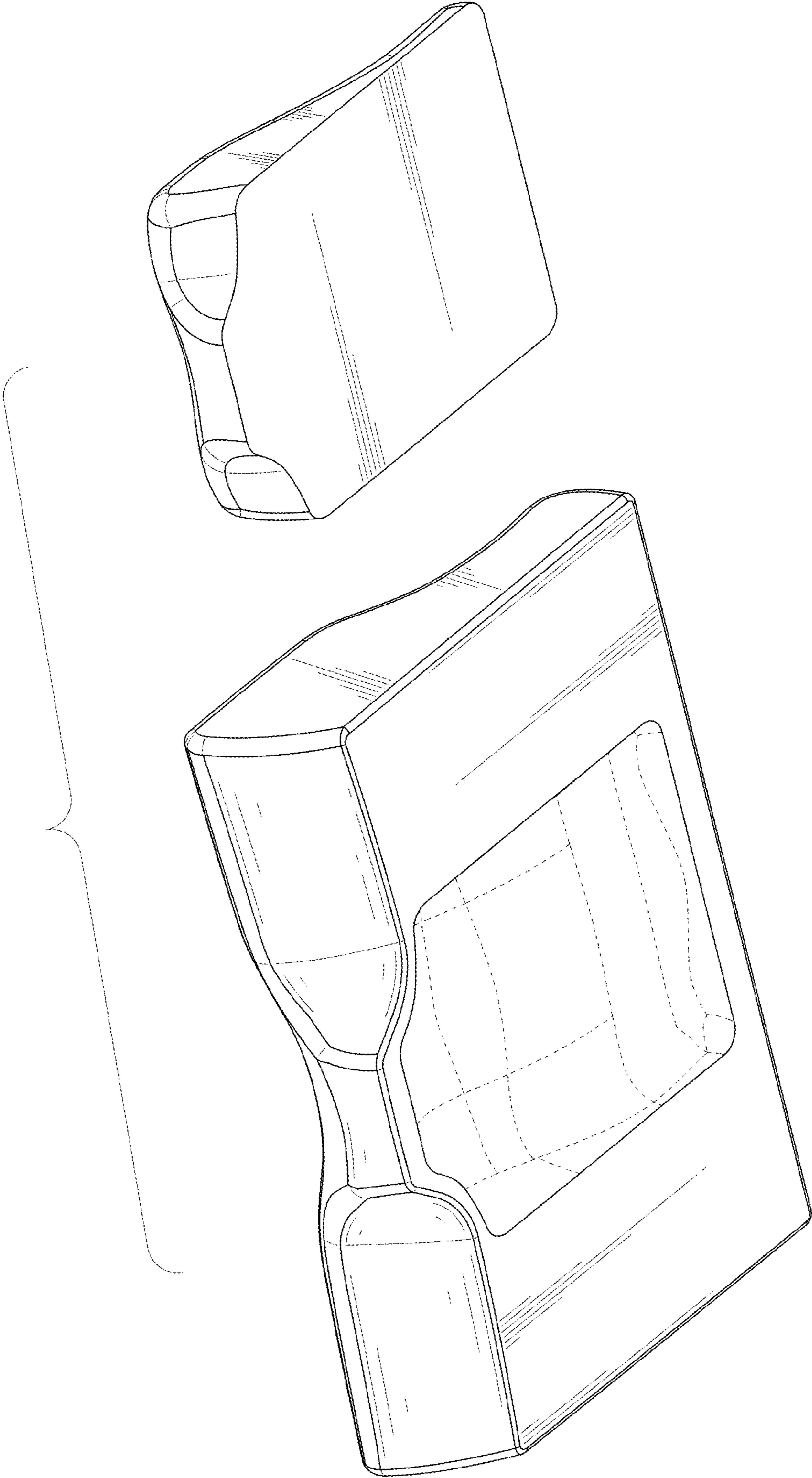

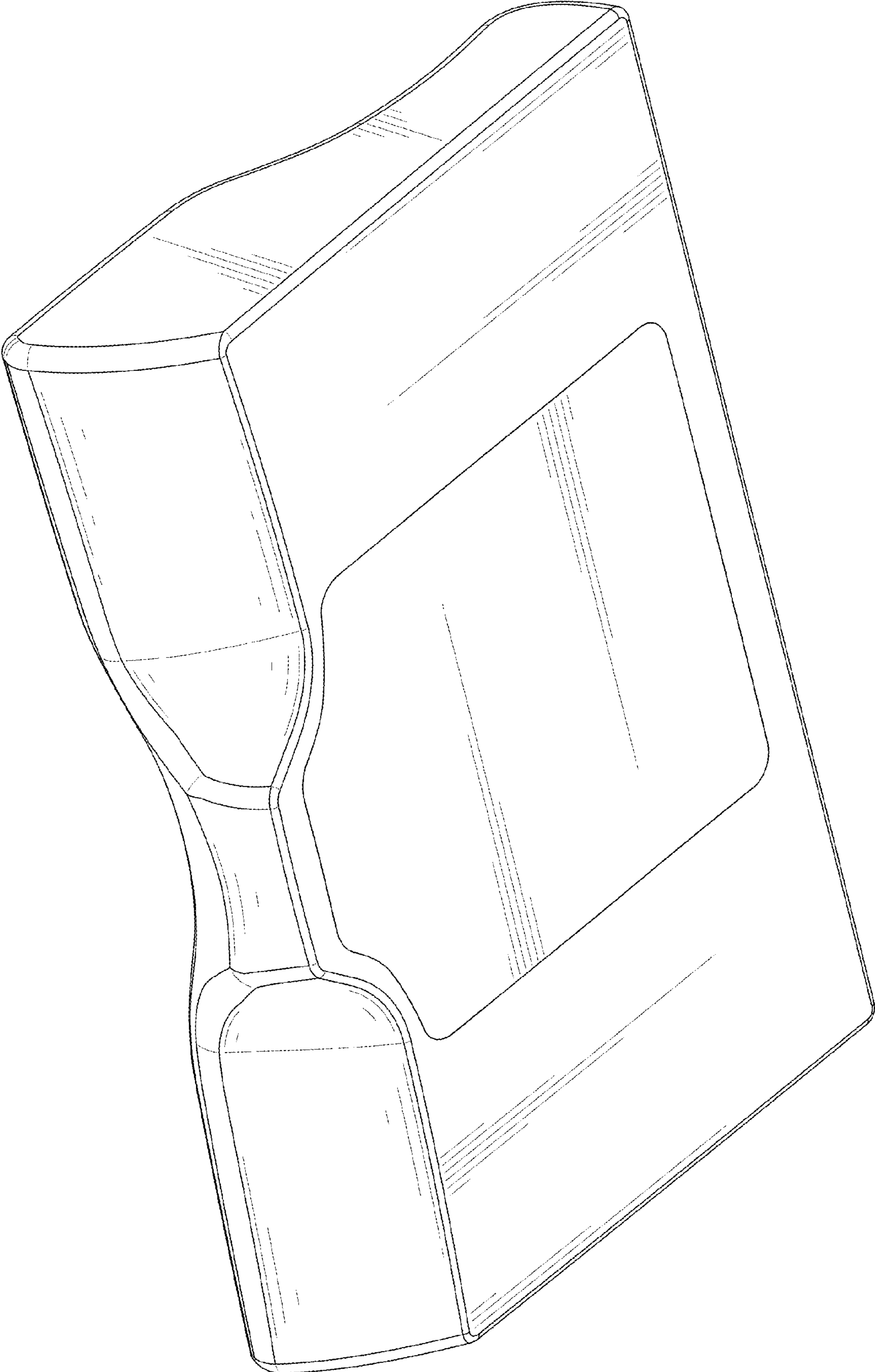
