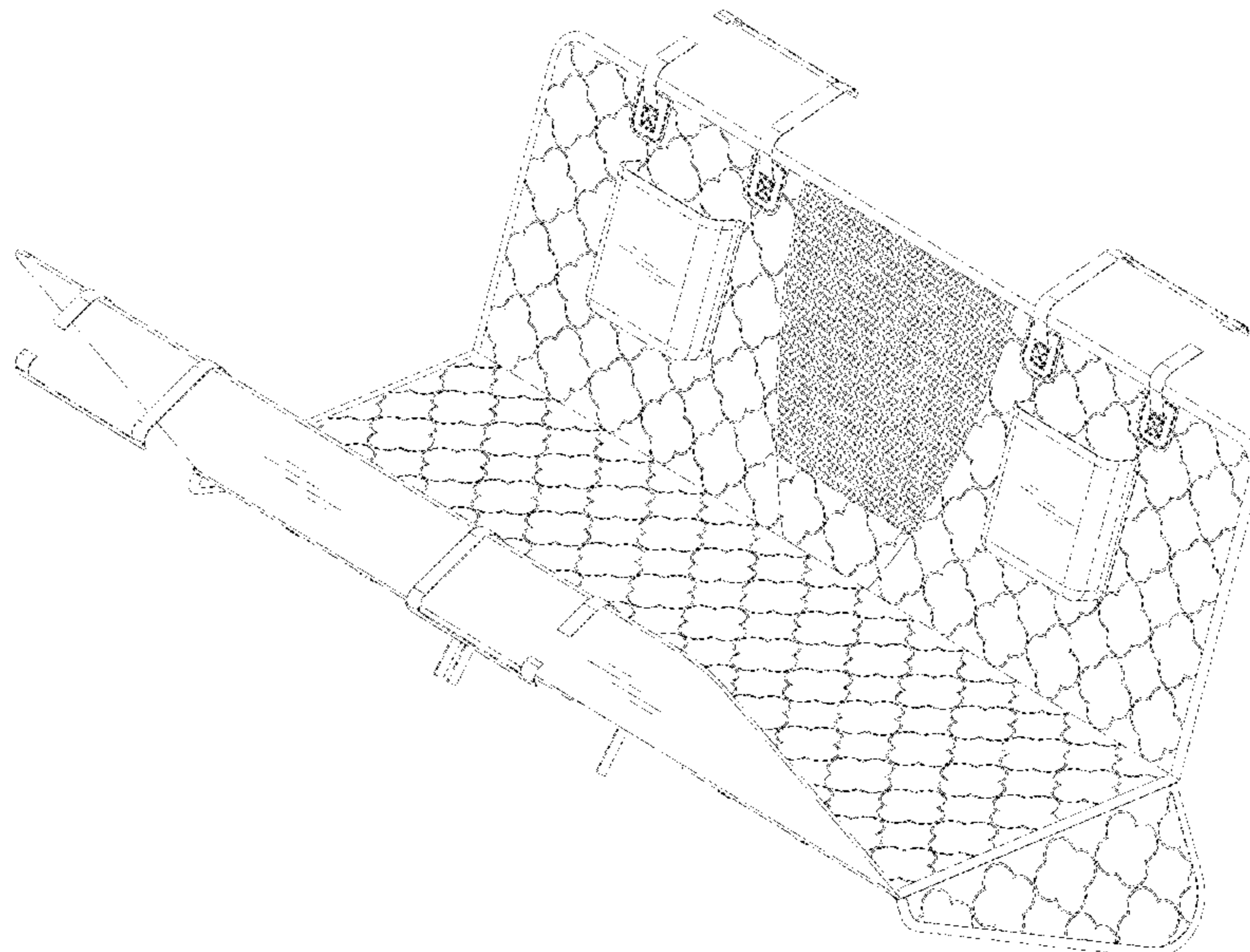
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, right and top view of the dog seat cover for a car showing my new design;

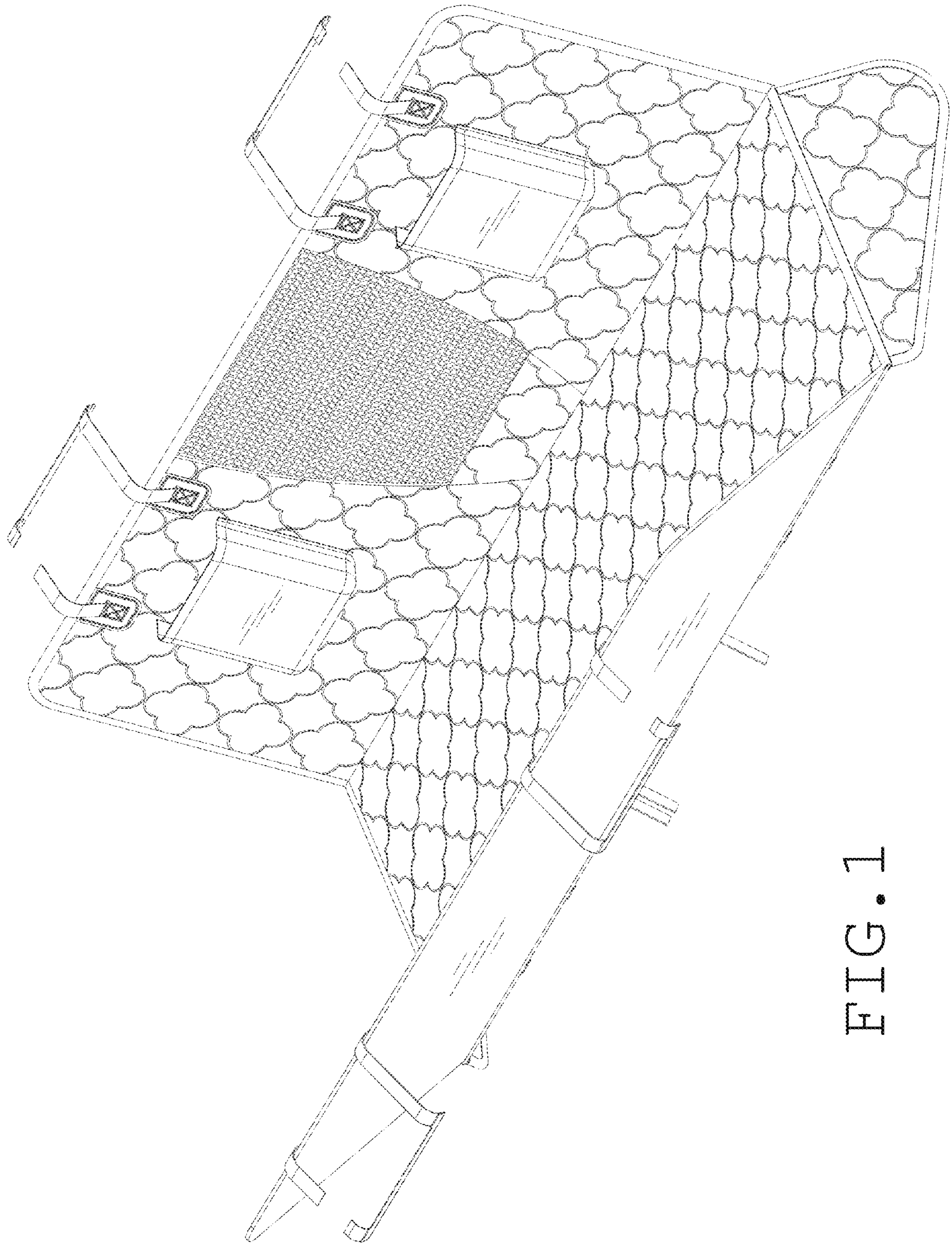

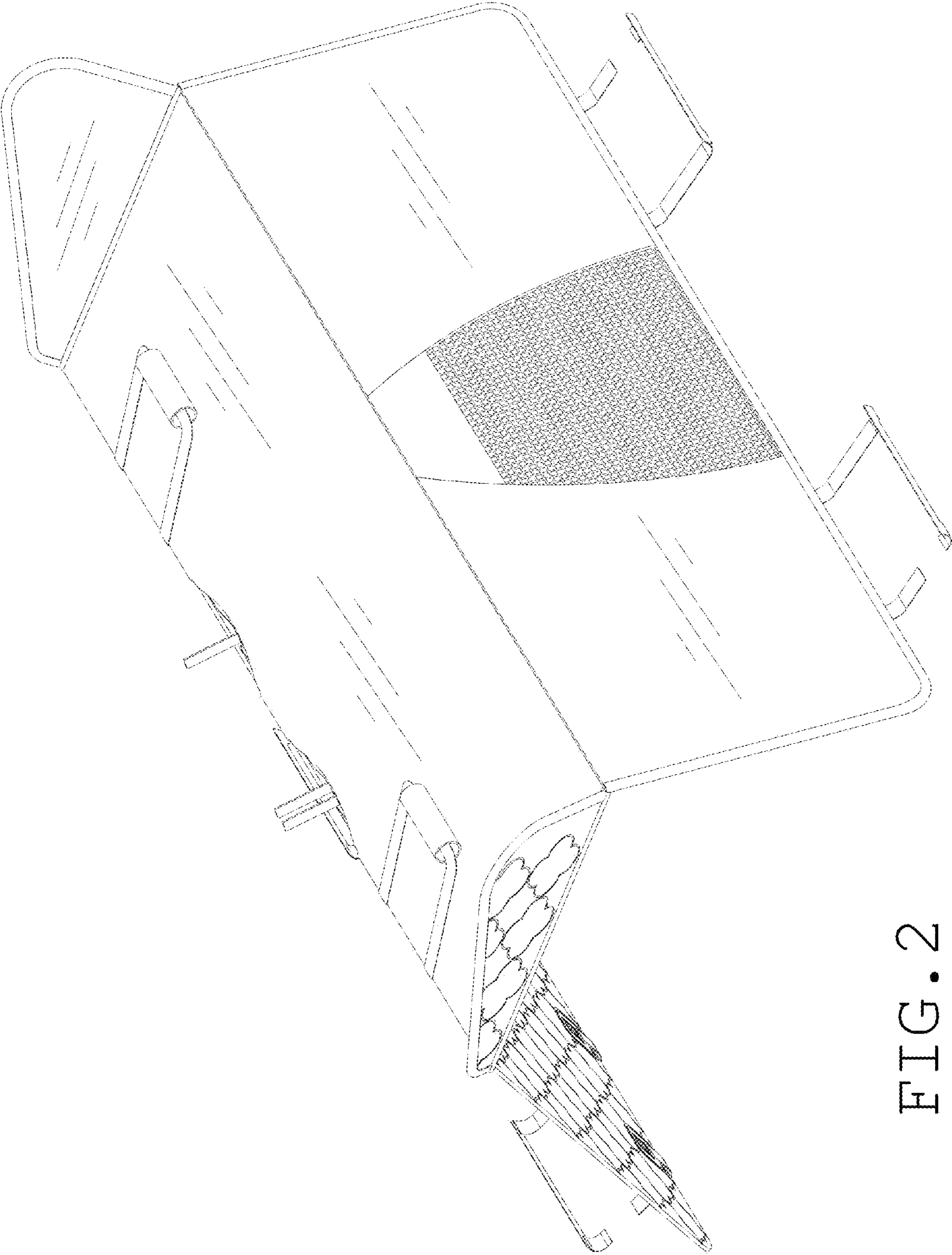

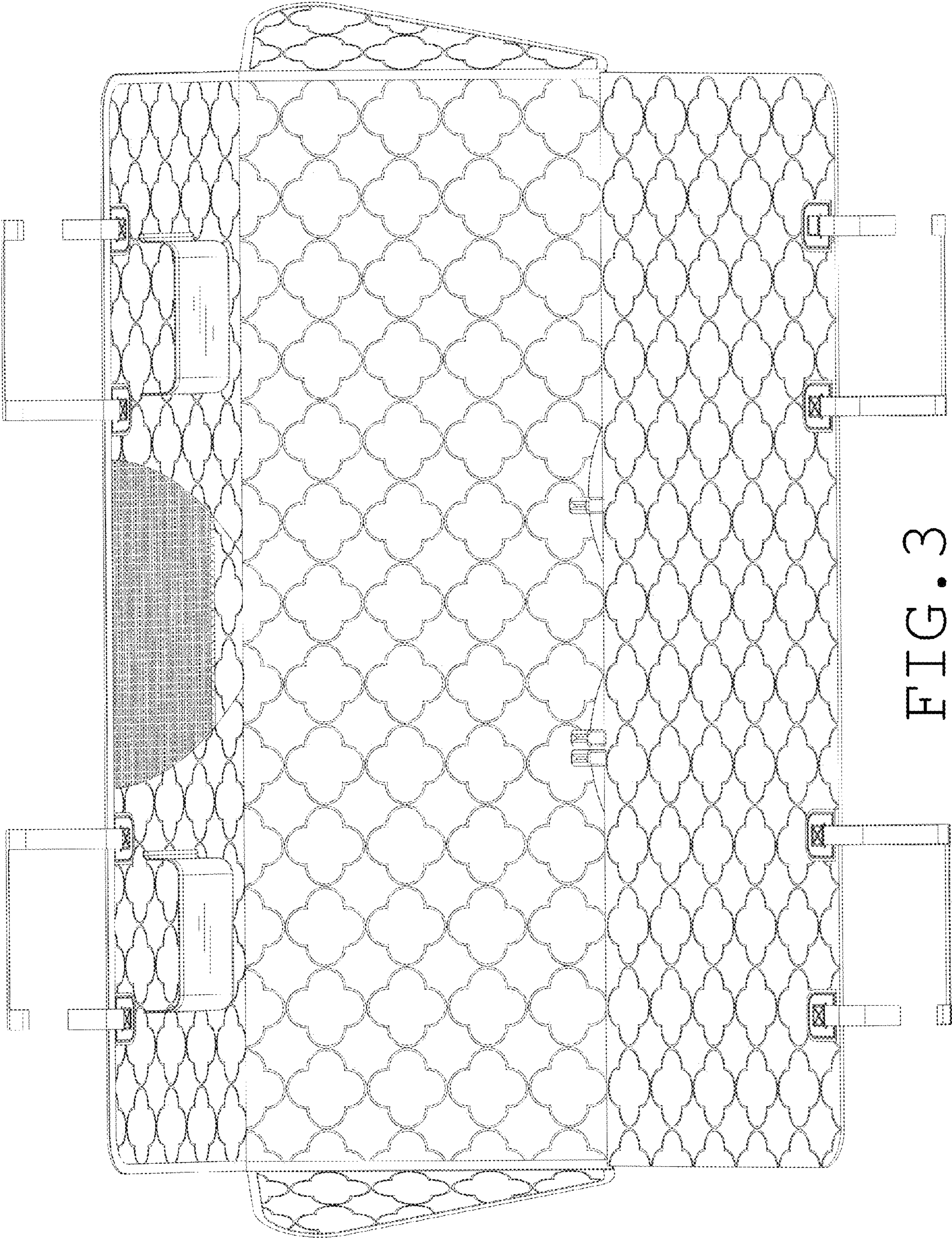

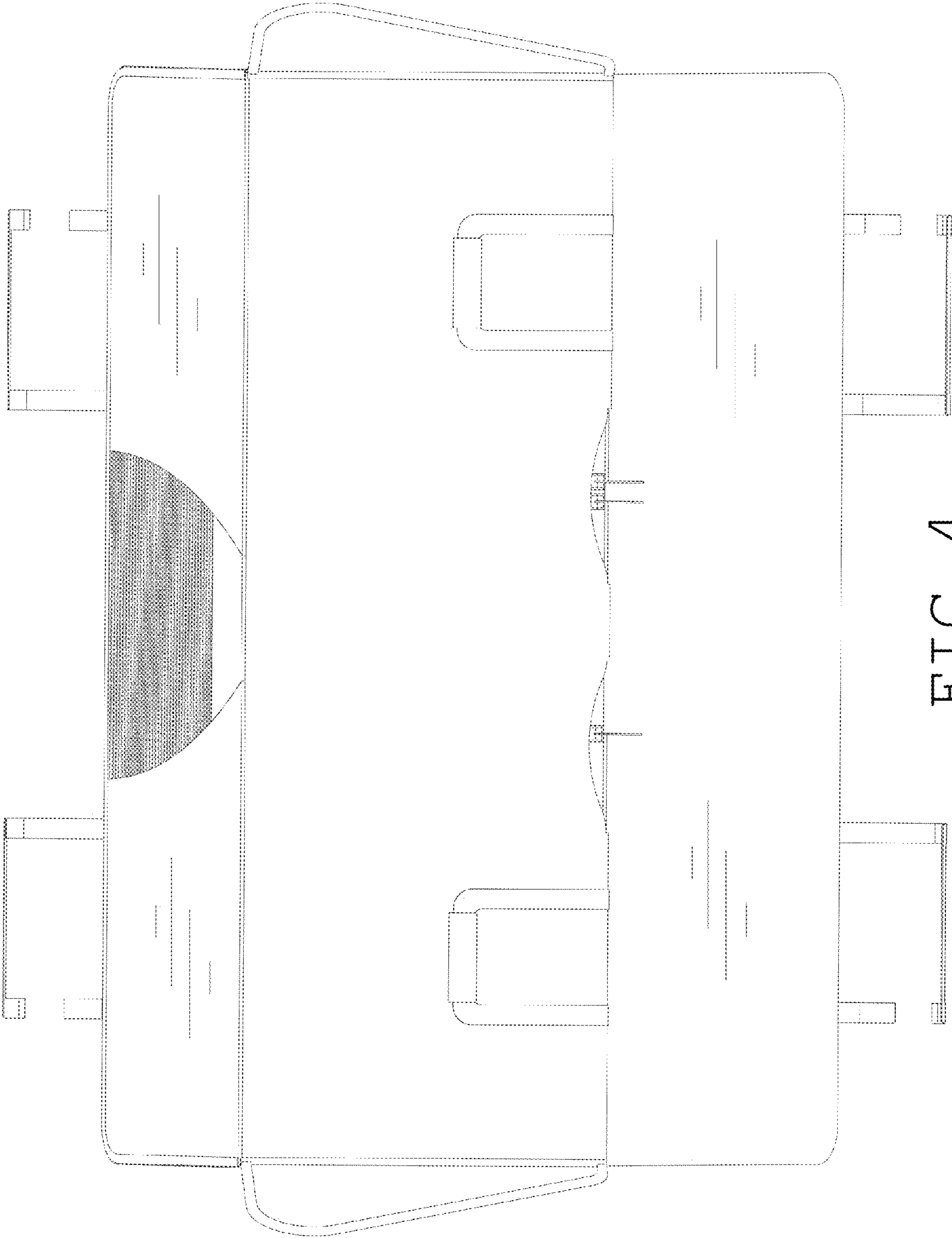

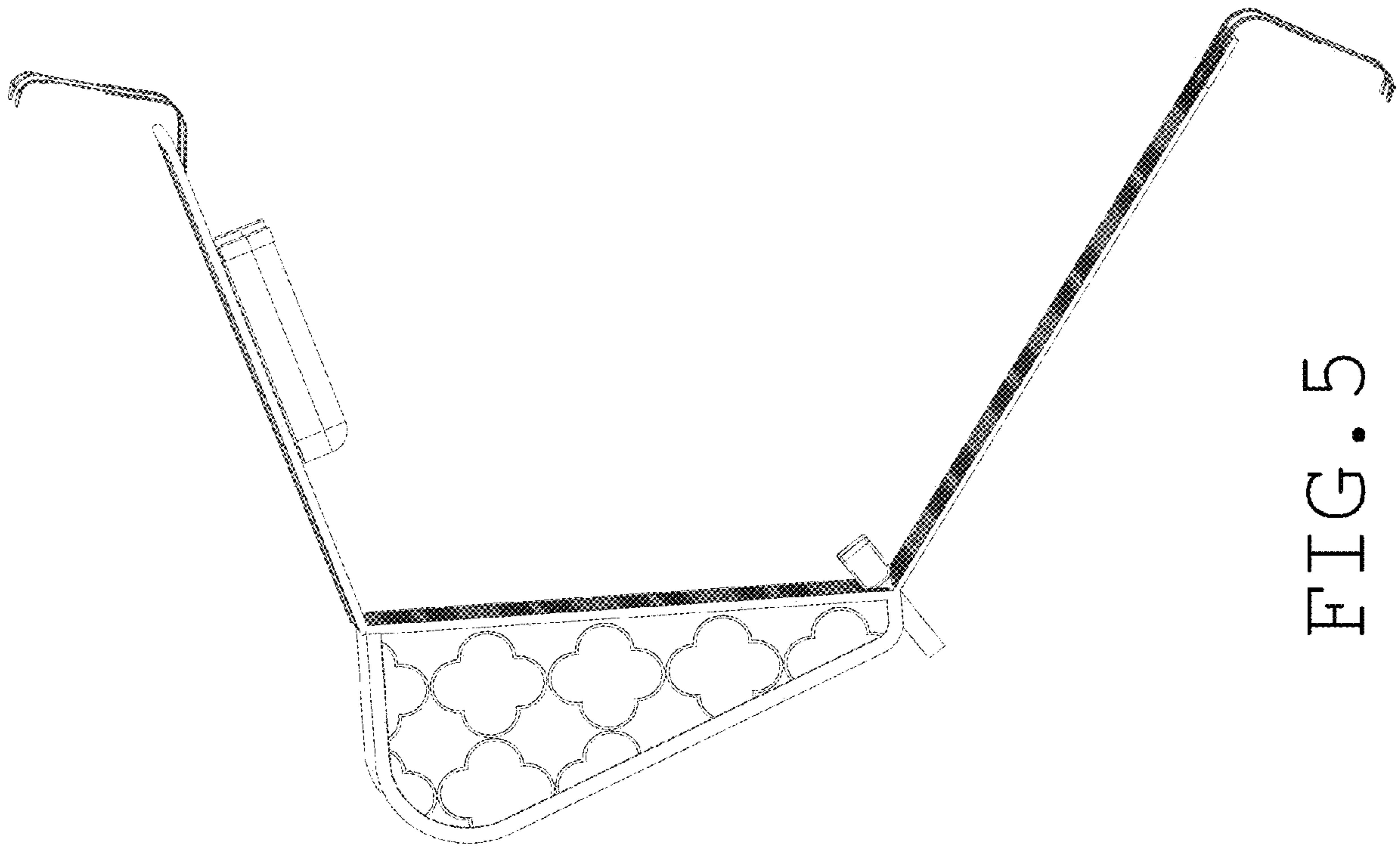

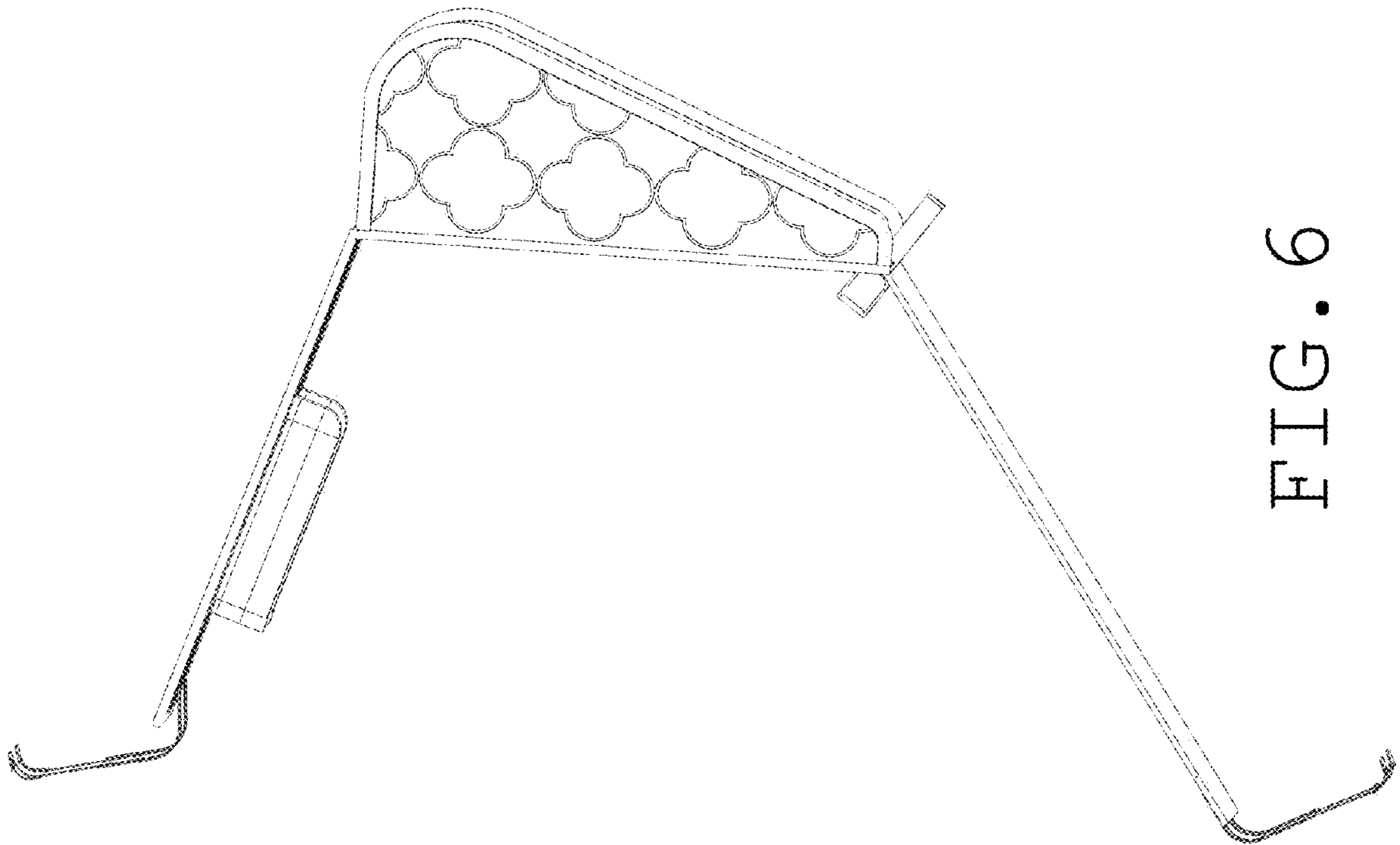

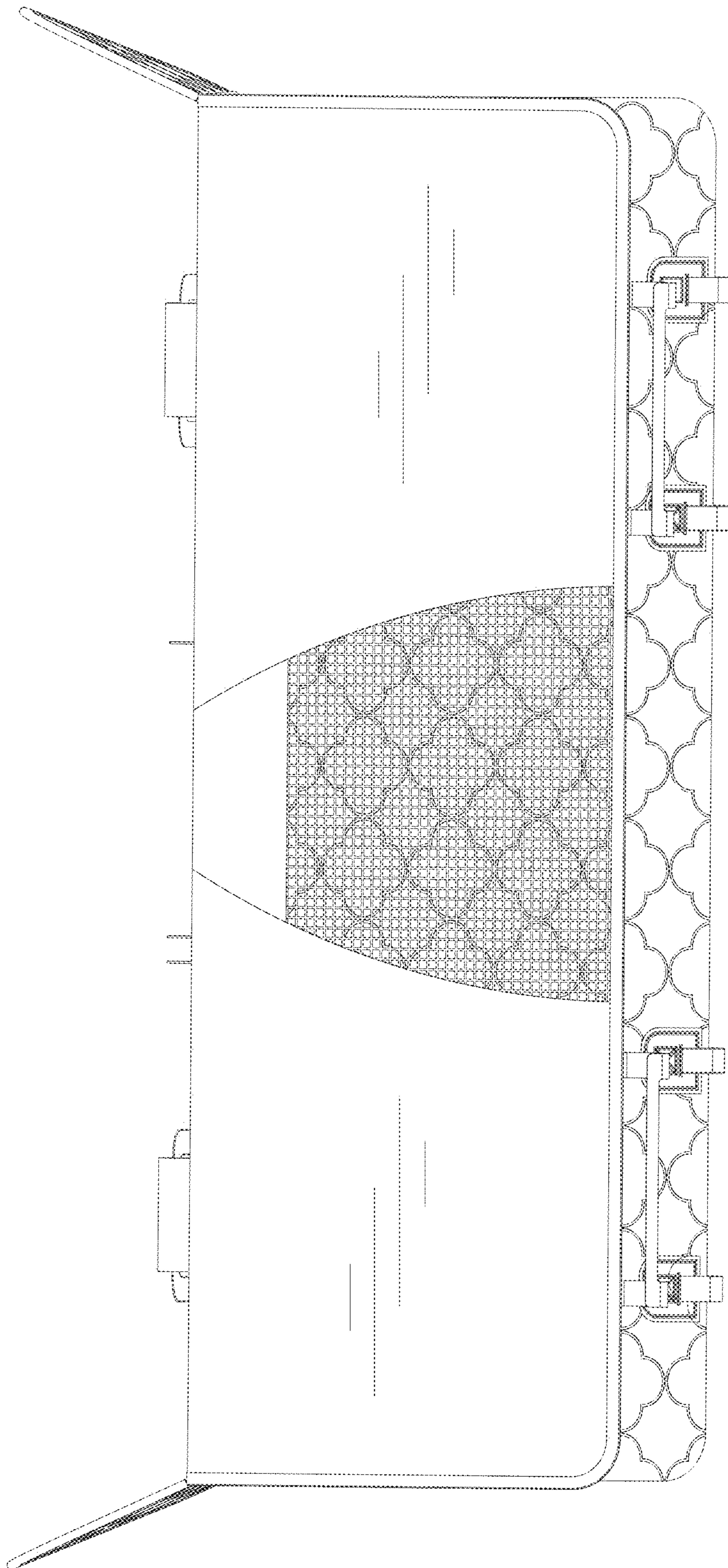

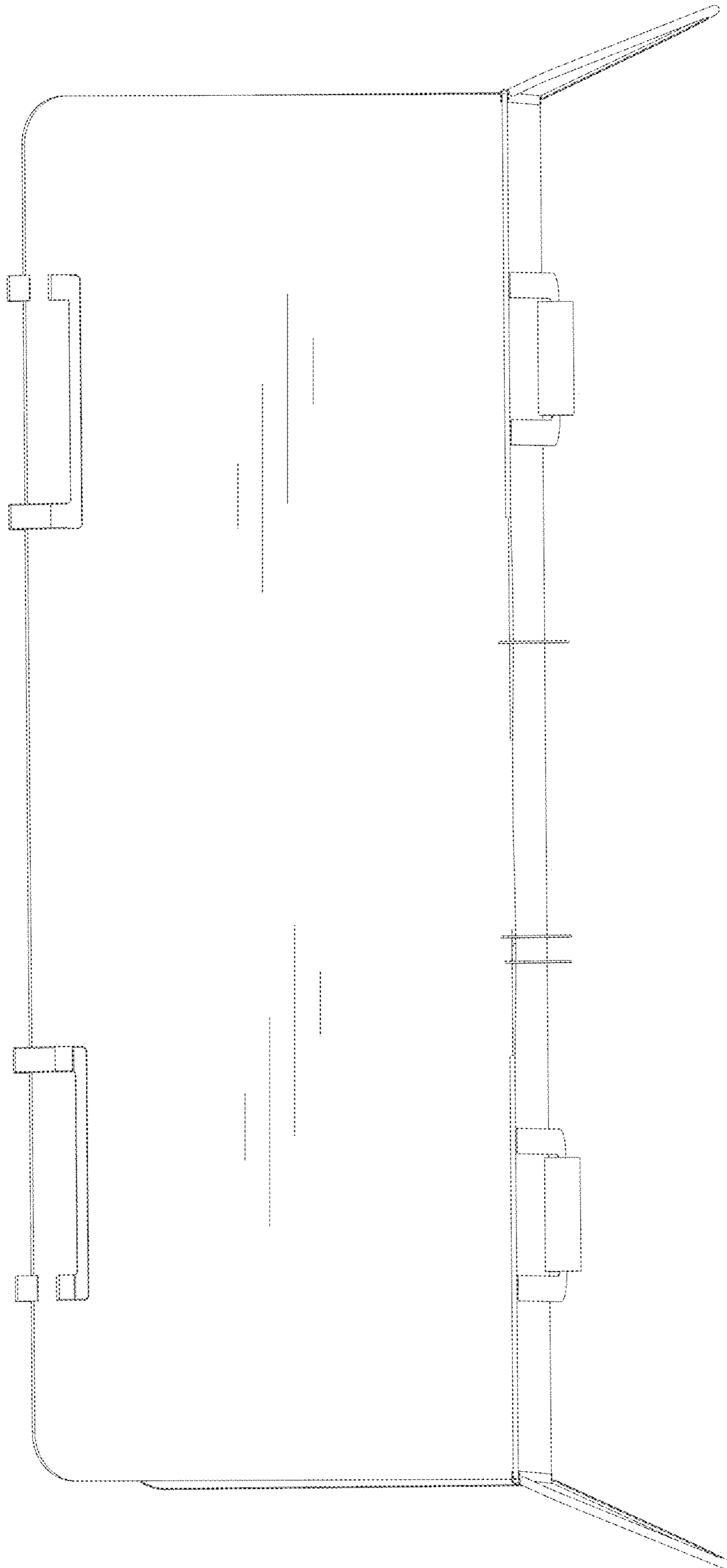
