(57) **CLAIM**

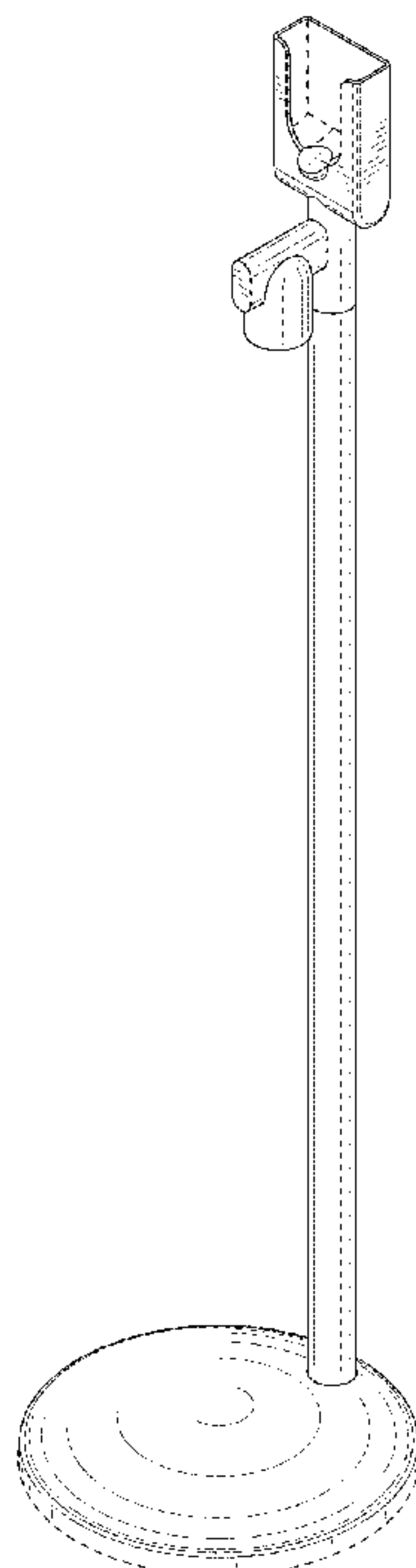
The ornamental design for a stand for a vacuum cleaner, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a stand for a vacuum cleaner showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a side view thereof;
FIG. 5 is a side view of the opposite side of FIG. 4;
FIG. 6 is a top view thereof; and,
FIG. 7 is a bottom view thereof.

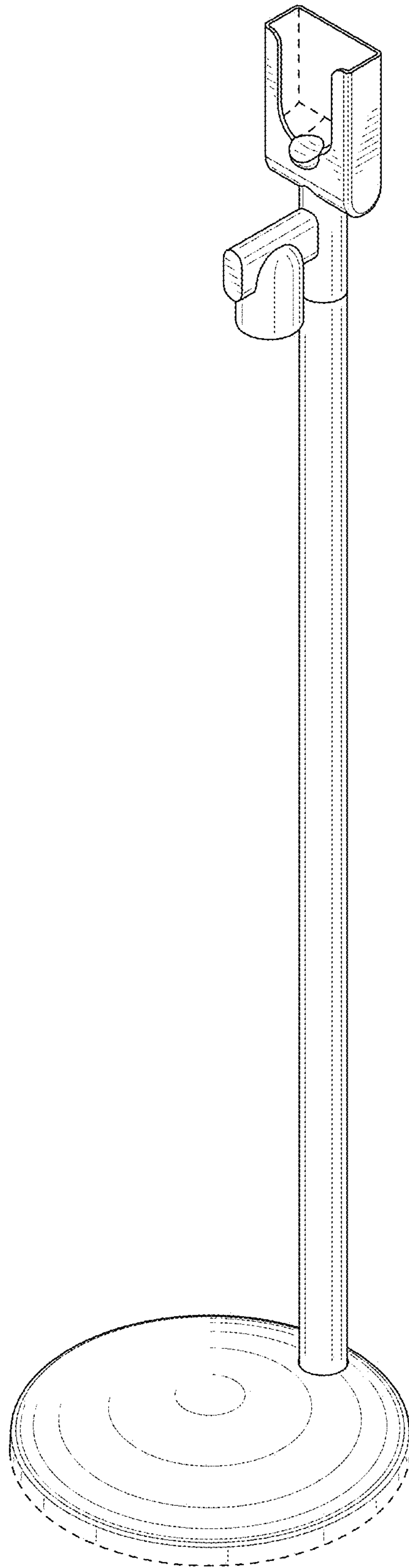

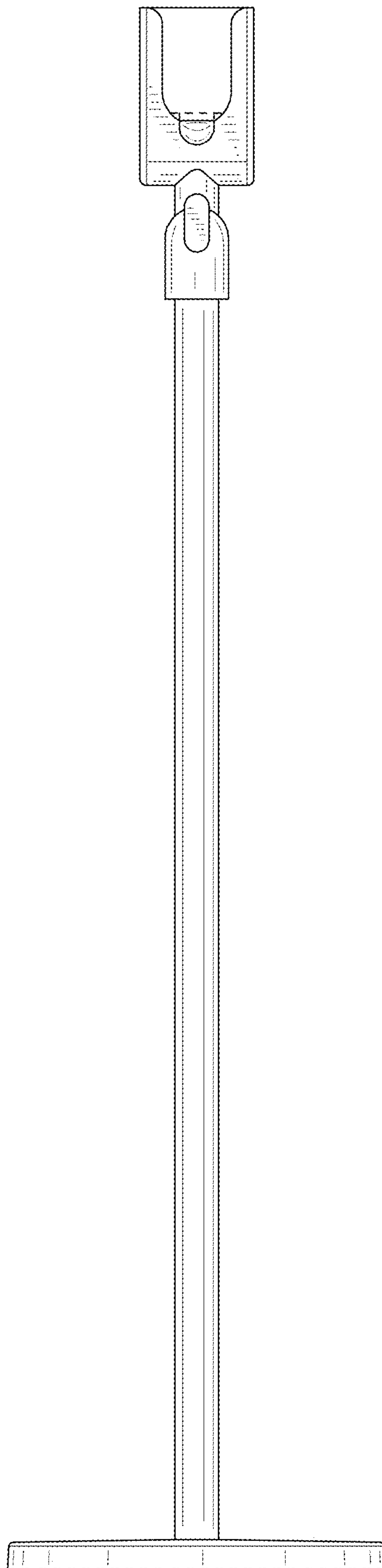

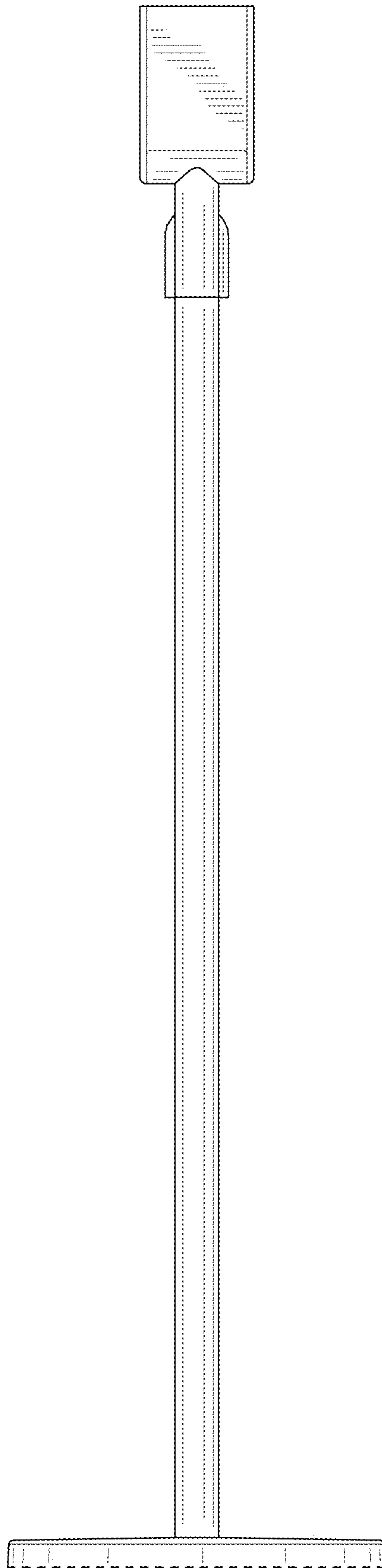

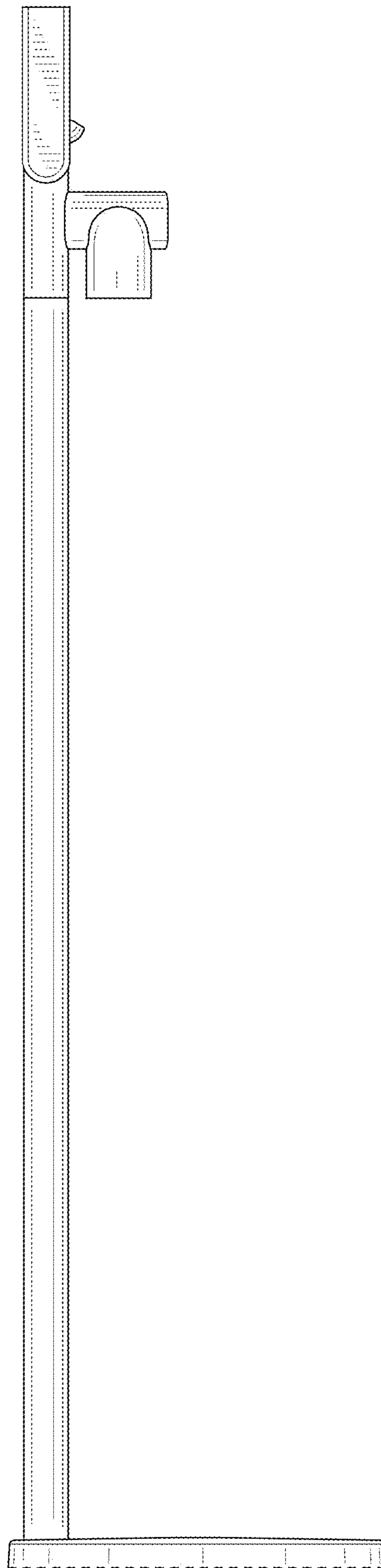

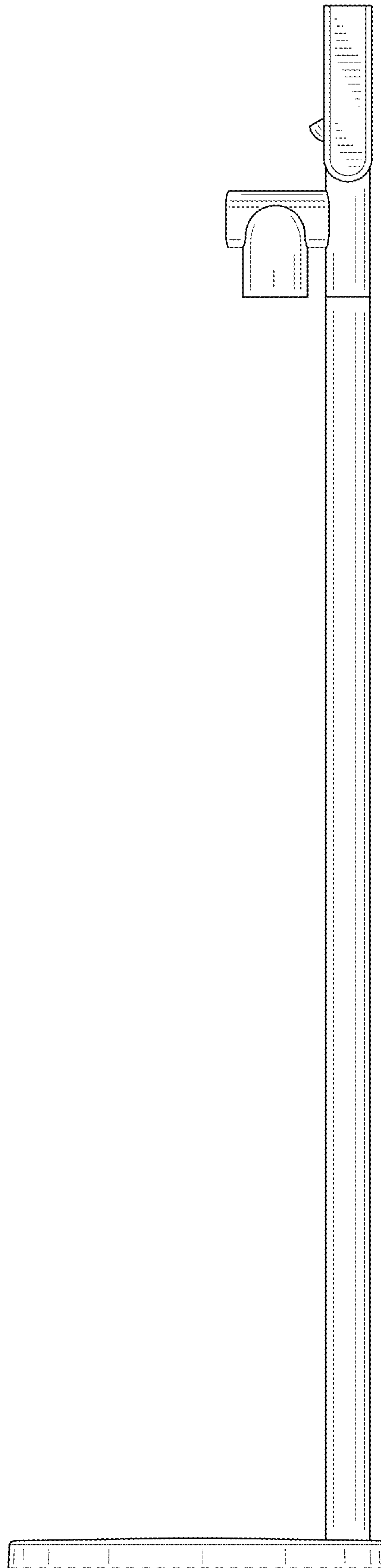

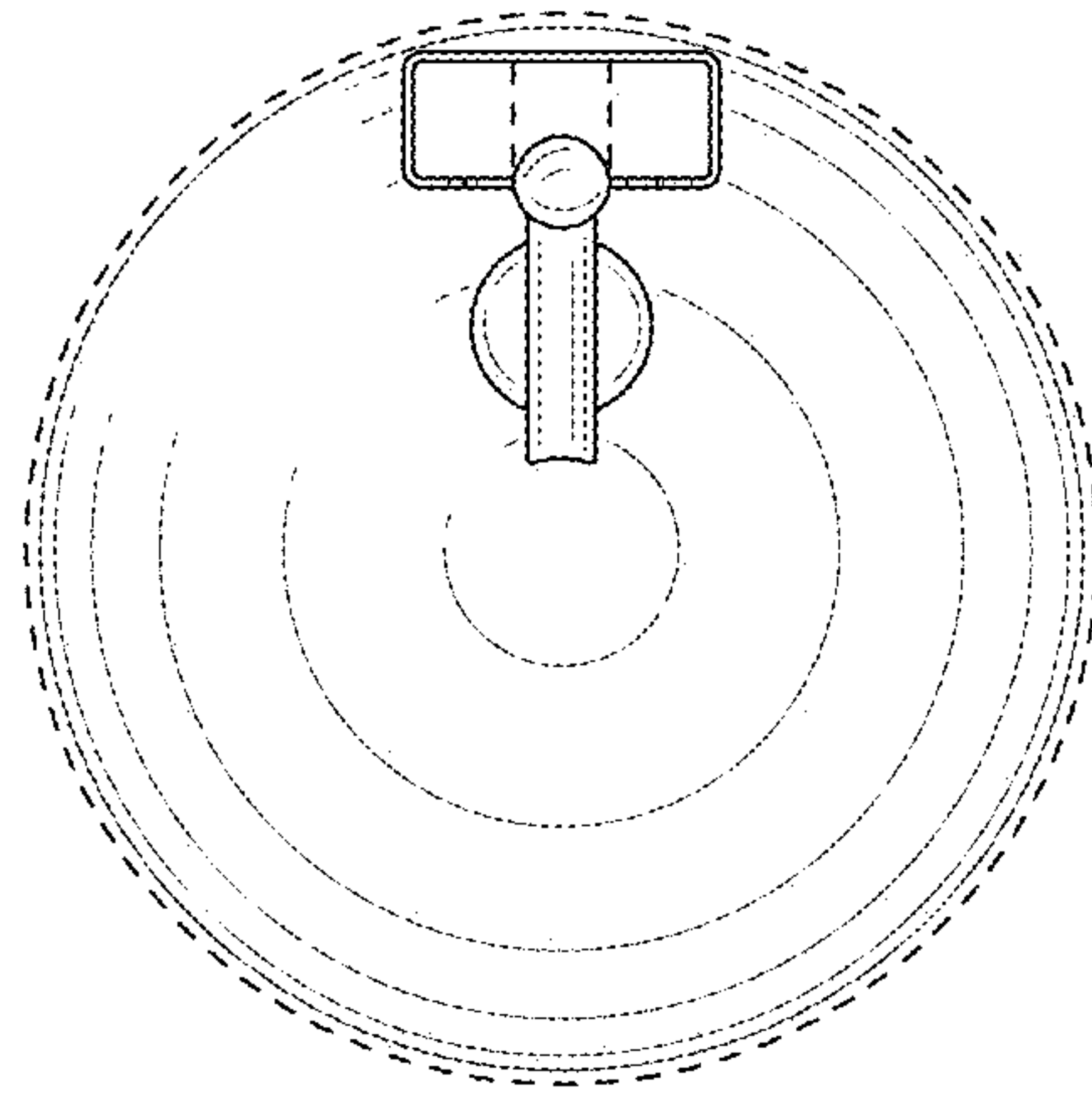

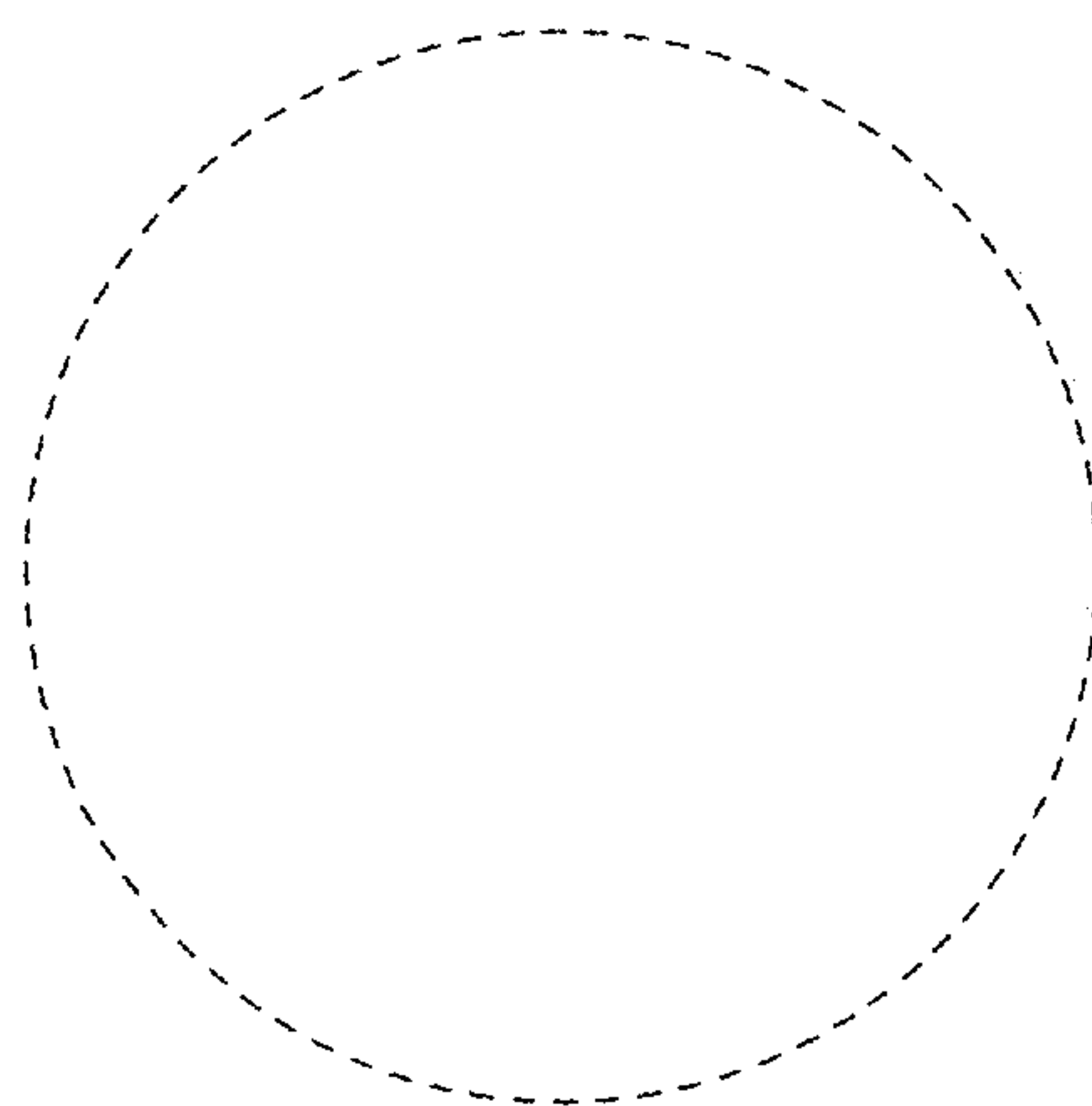
