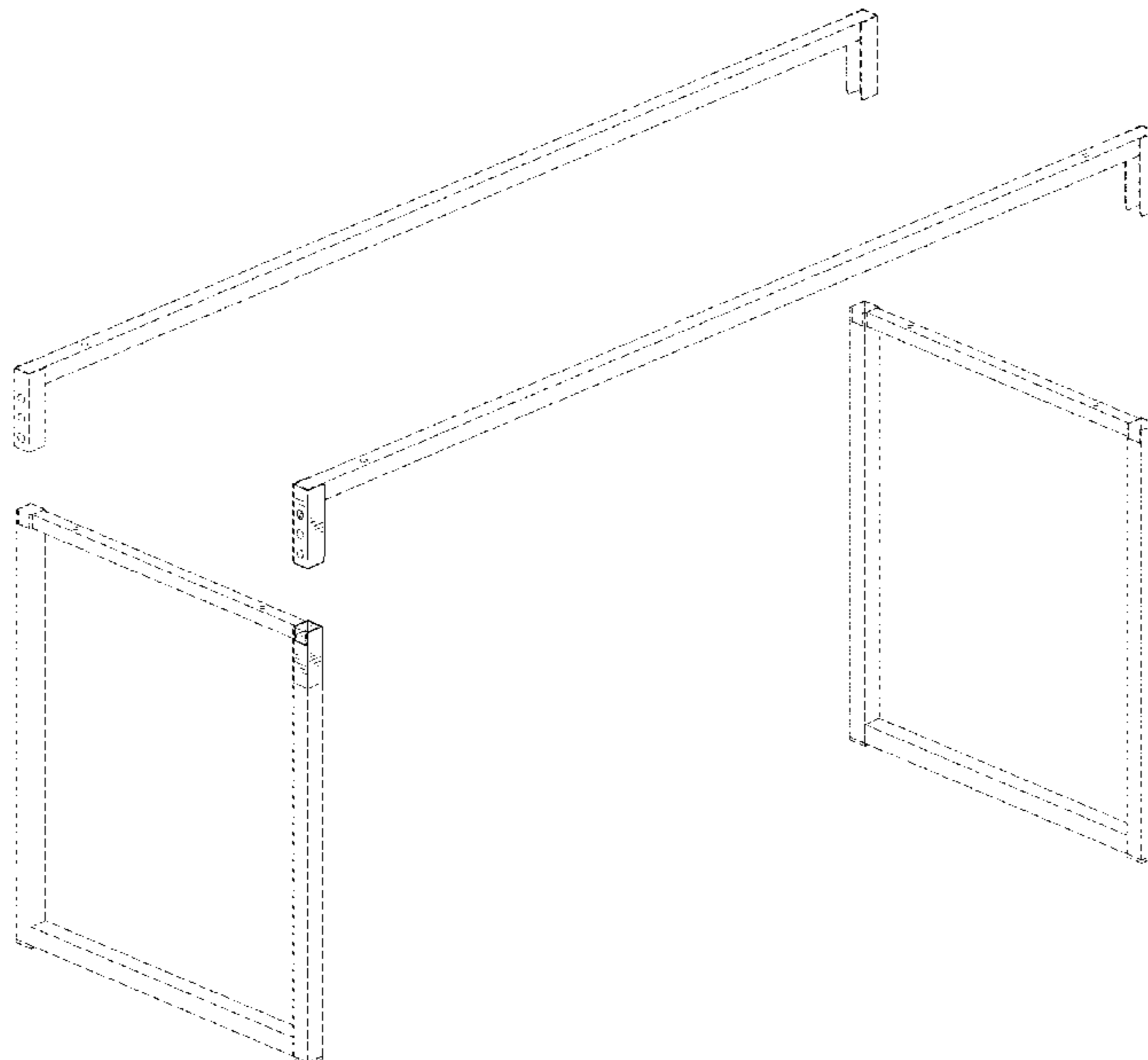
(57) **CLAIM**

The ornamental design for a table frame assembly, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a rod component for a table frame assembly showing my new design, separately for clarity of disclosure;
 FIG. 2 is a front view thereof;

 FIG. 4 is a left side view thereof;

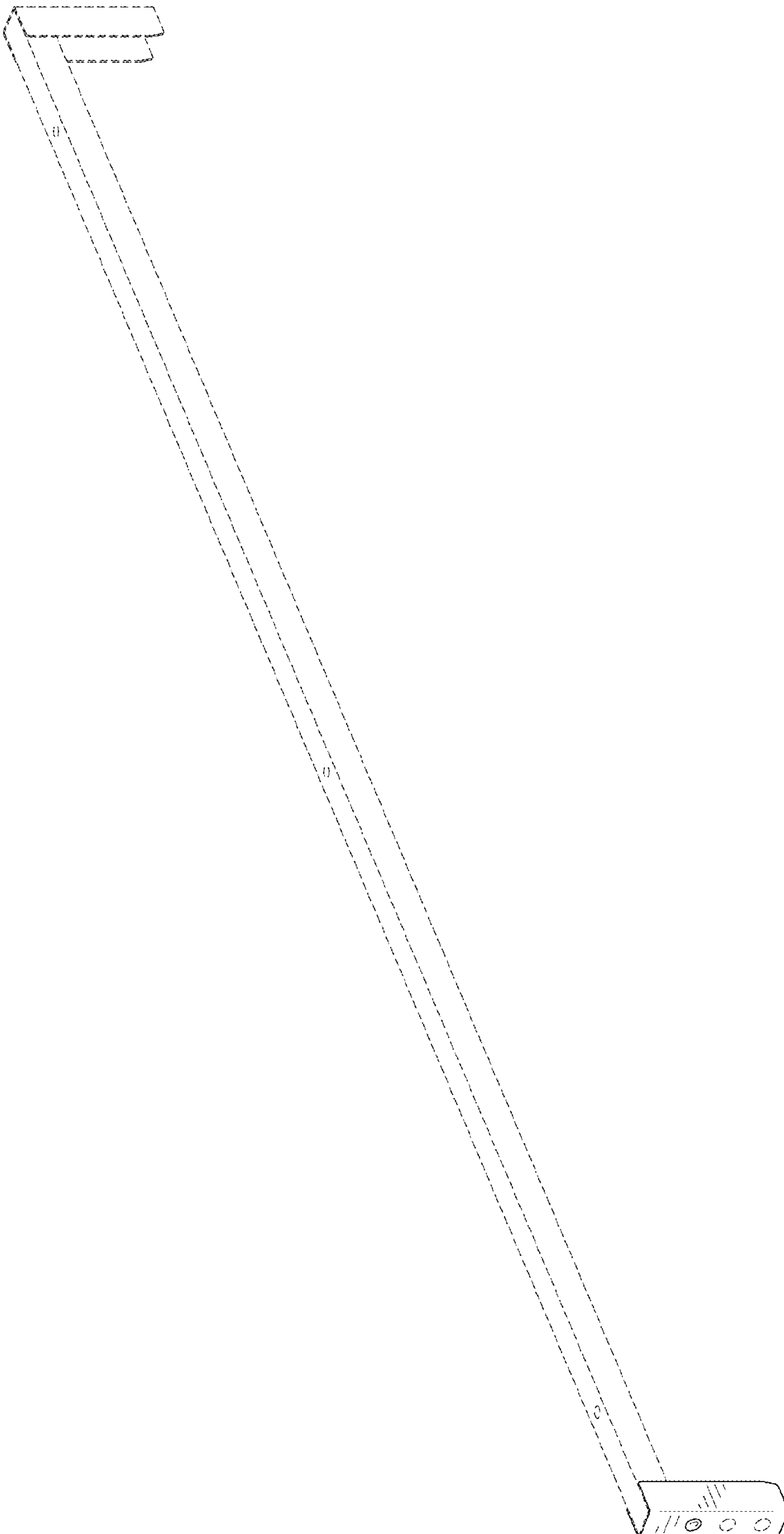

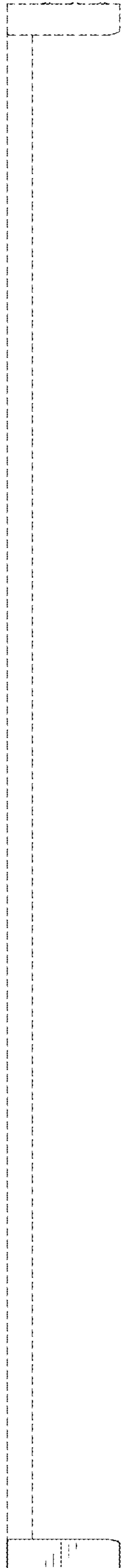

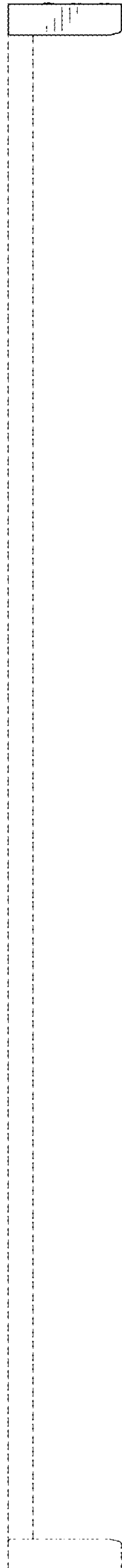

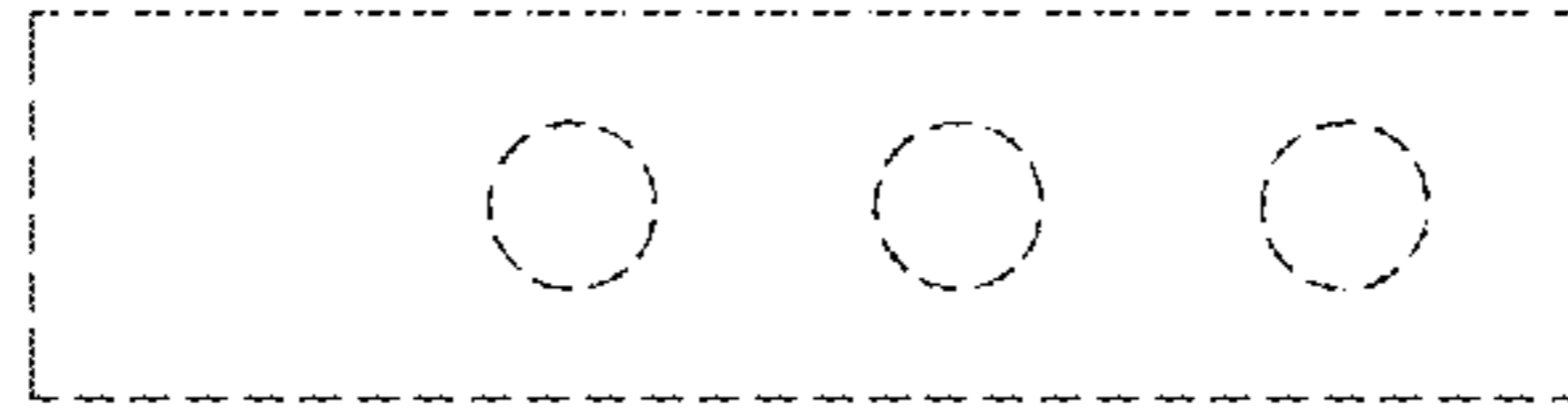

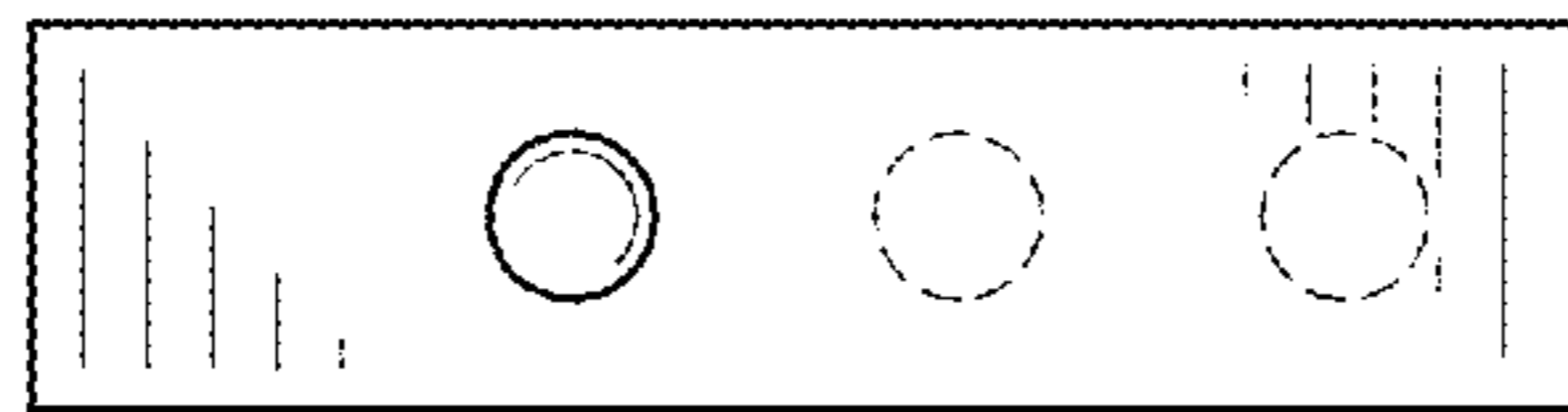

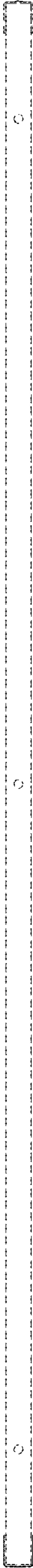

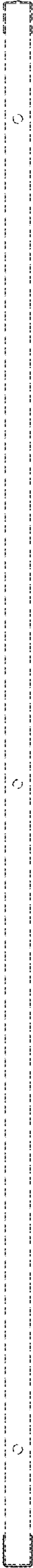

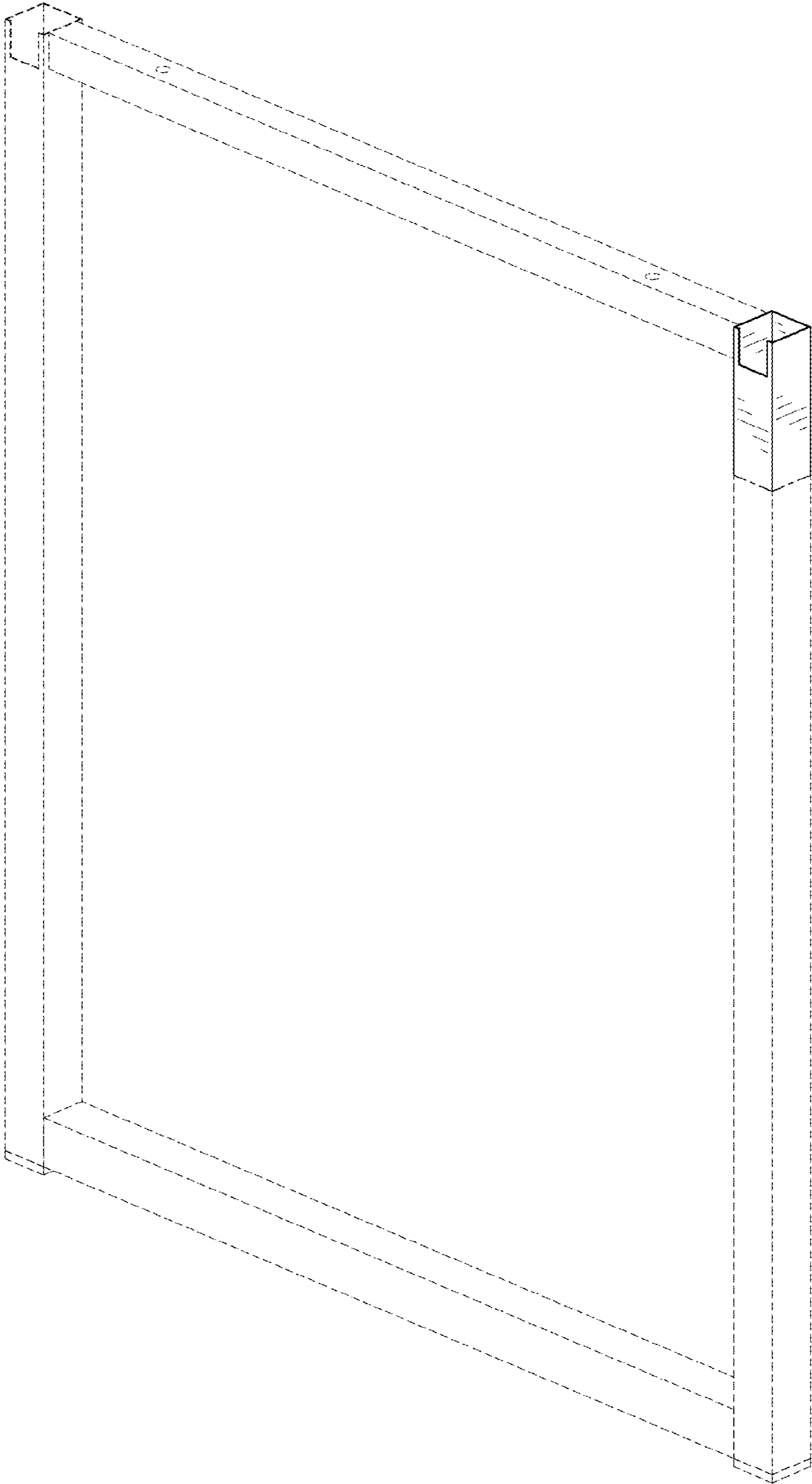

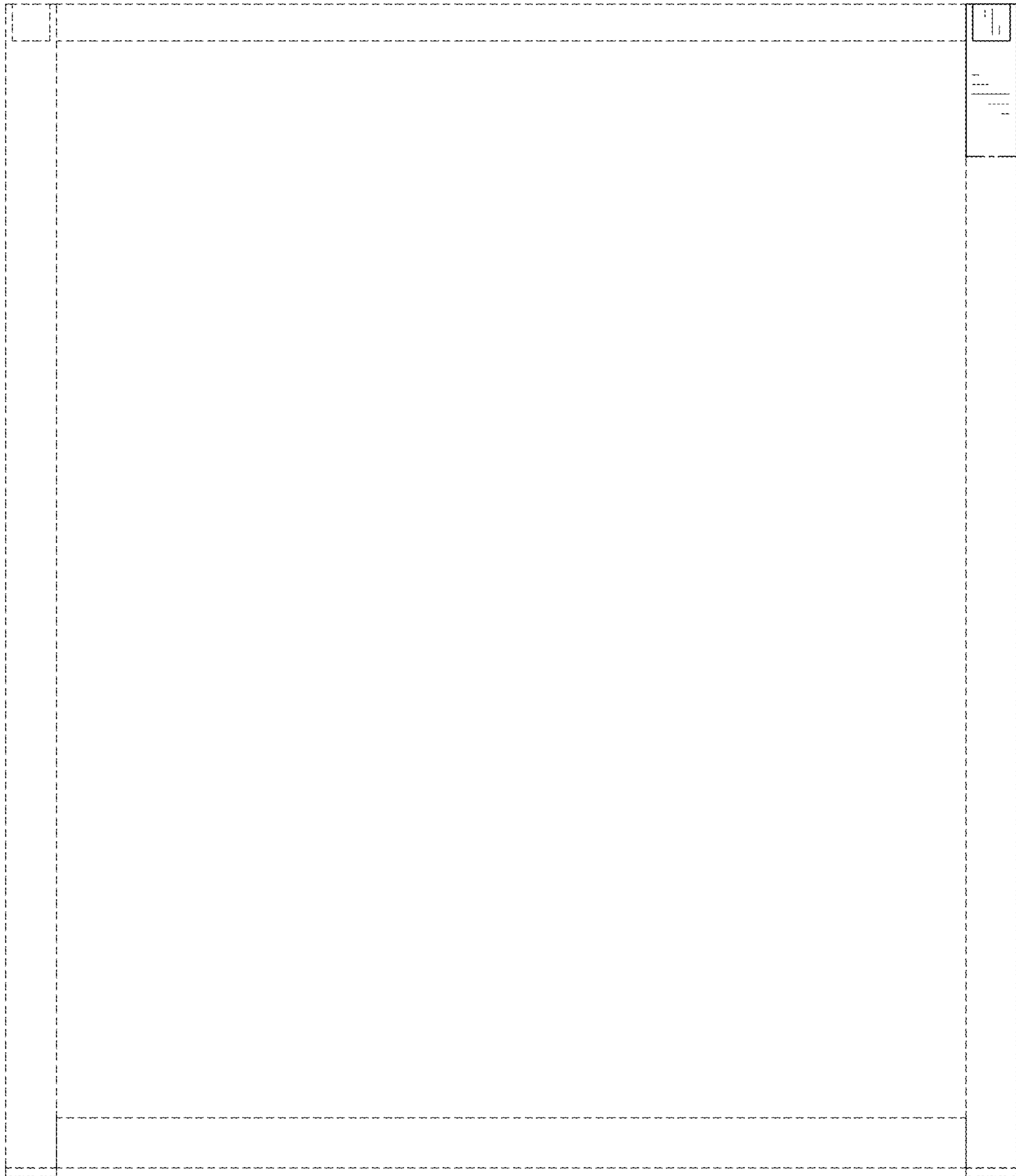

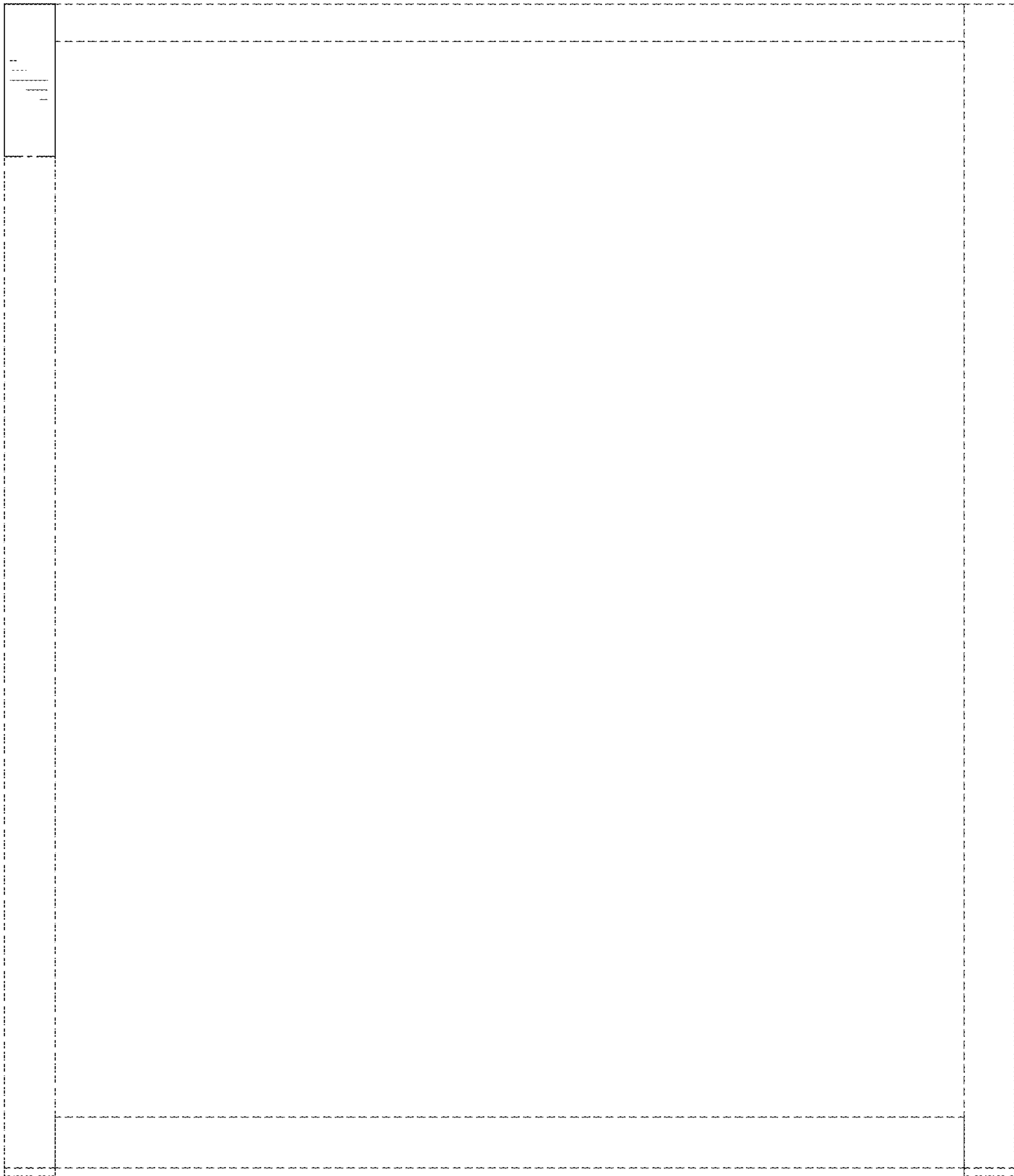

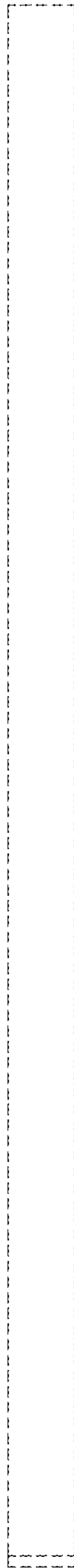

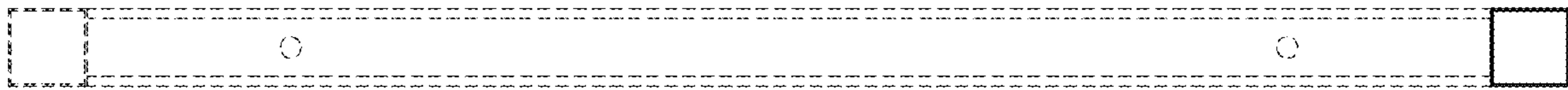

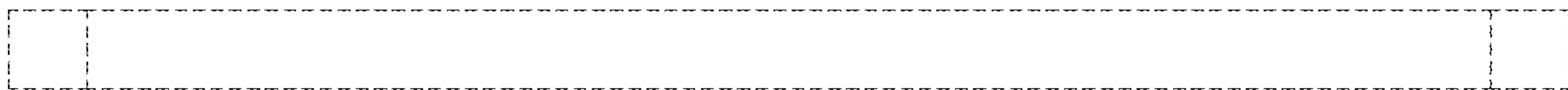

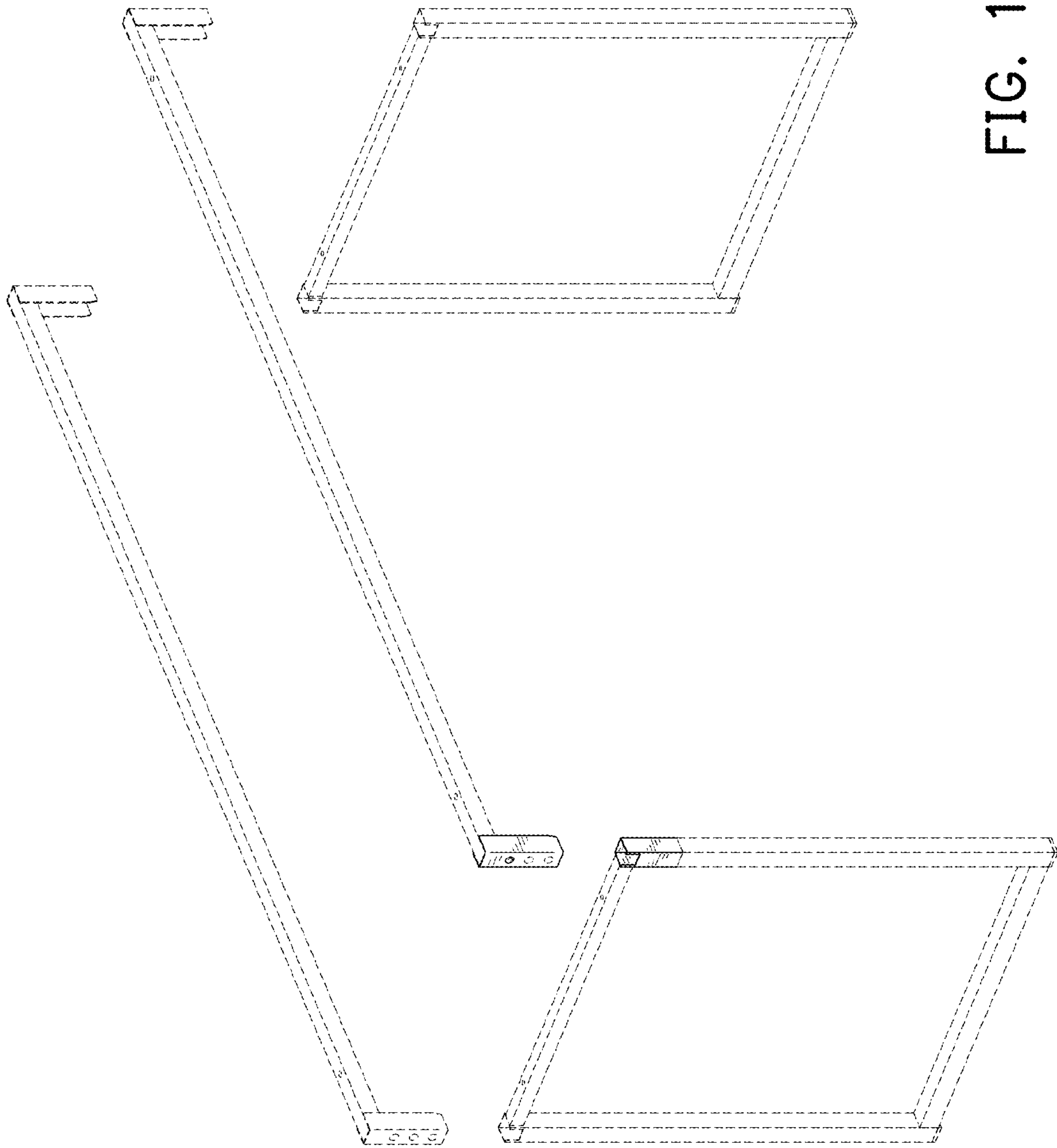

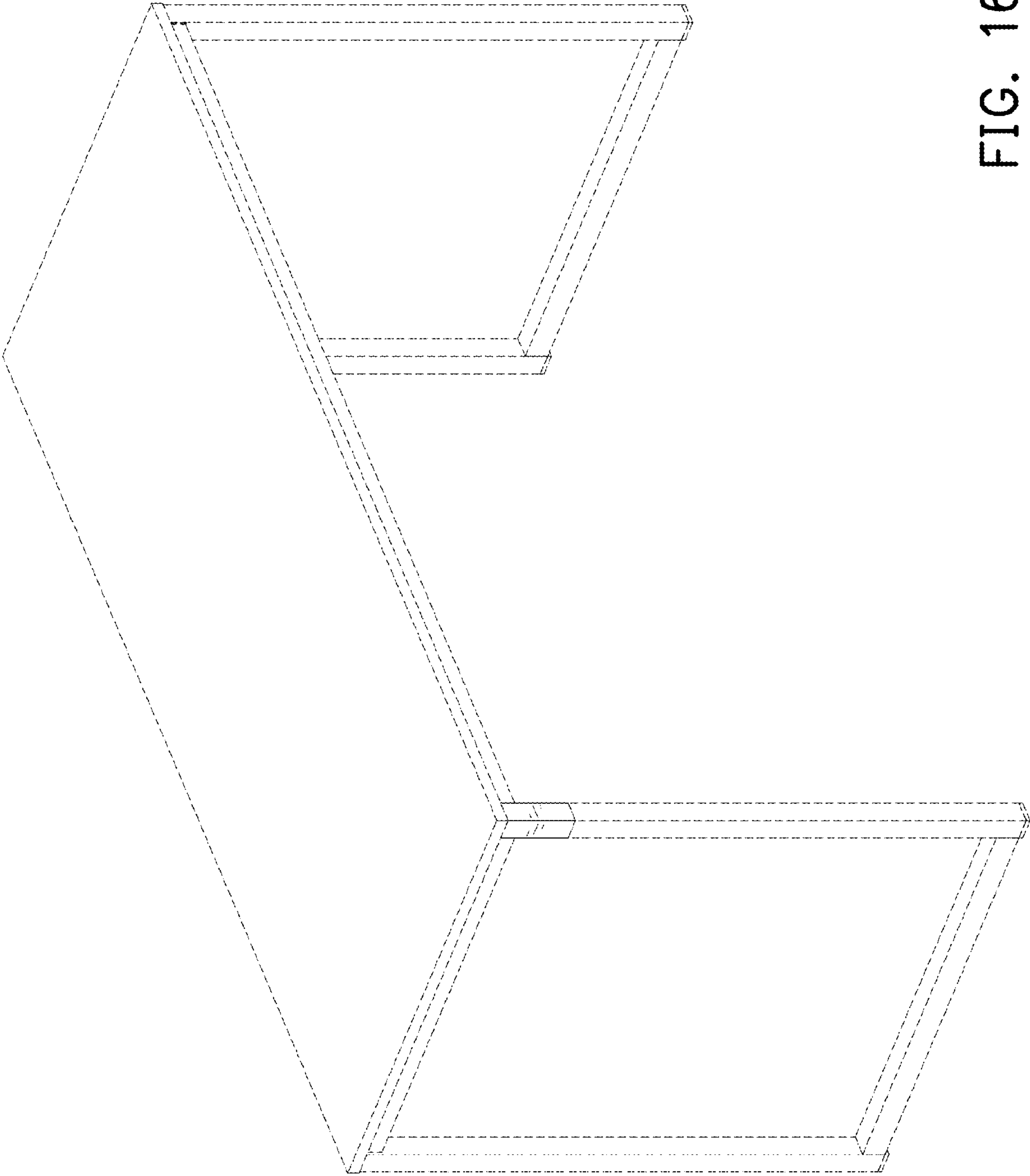
