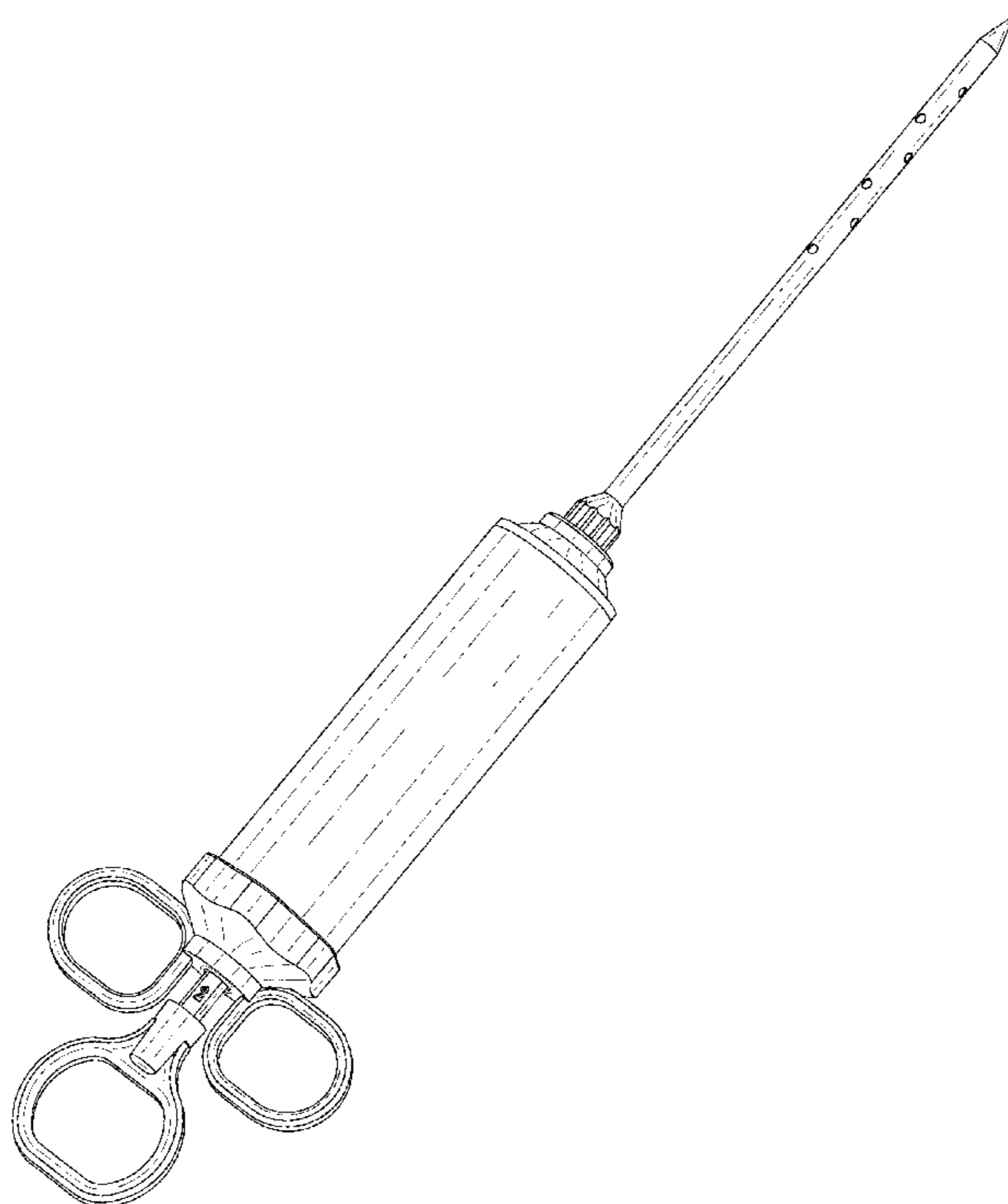
(57) **CLAIM**

The ornamental design for a sauce injector set for food, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a sauce injector set for food showing my new design;
 FIG. 2 is an alternative perspective view of the sauce injector set for food with different alternative needles;
 FIG. 3 is an exploded perspective view of the sauce injector set for food with different alternative needles;
 FIG. 4 is an alternative perspective view of the sauce injector set for food without needle;
 FIG. 5 is a view of the needles of the sauce injector set for food;
 FIG. 6 is a front view thereof;
 FIG. 7 is a left side thereof;
 FIG. 8 is a top view thereof; and,
 FIG. 9 is a bottom view thereof.
 The injector and needles are shown separately for clarity of illustration.

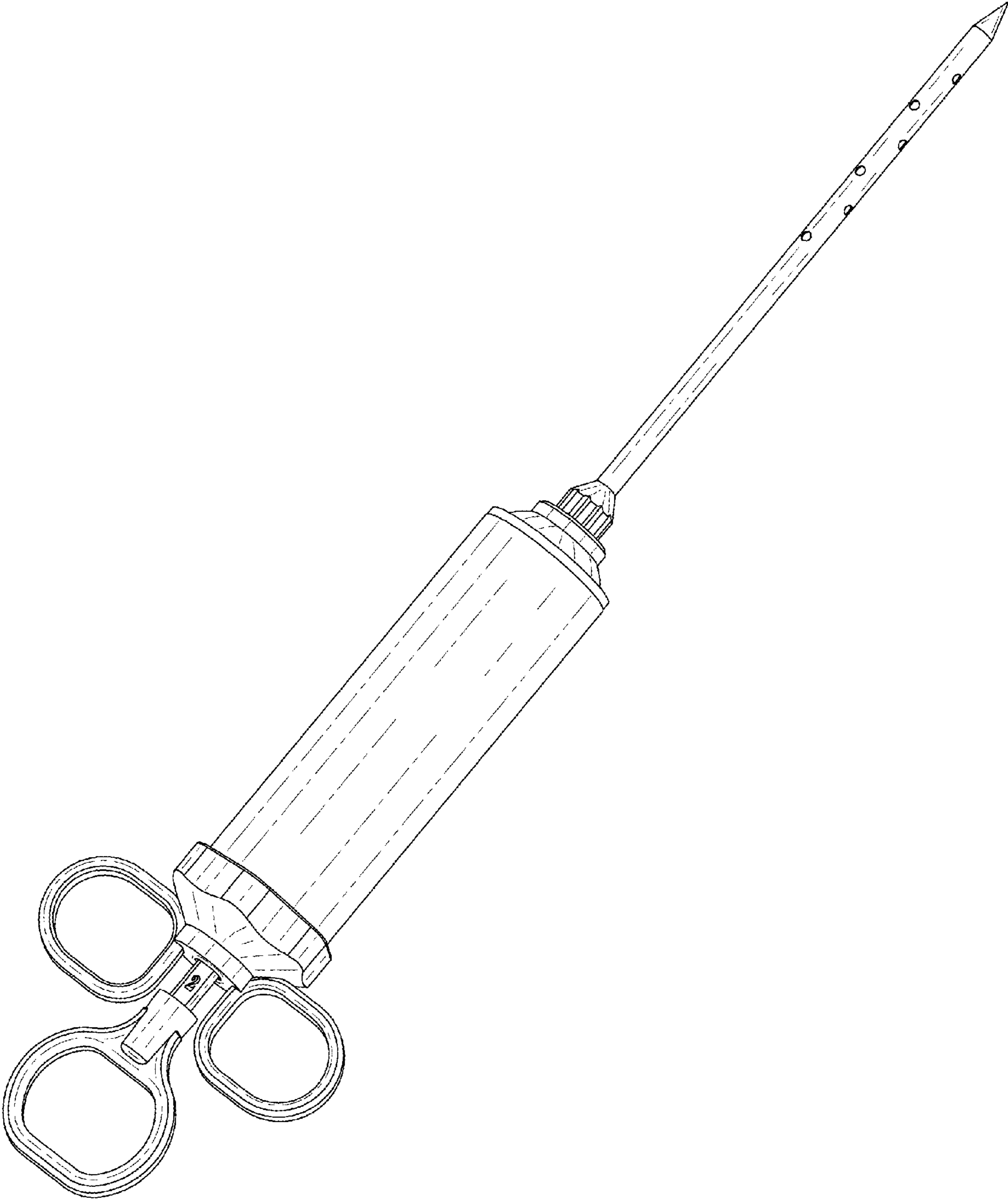
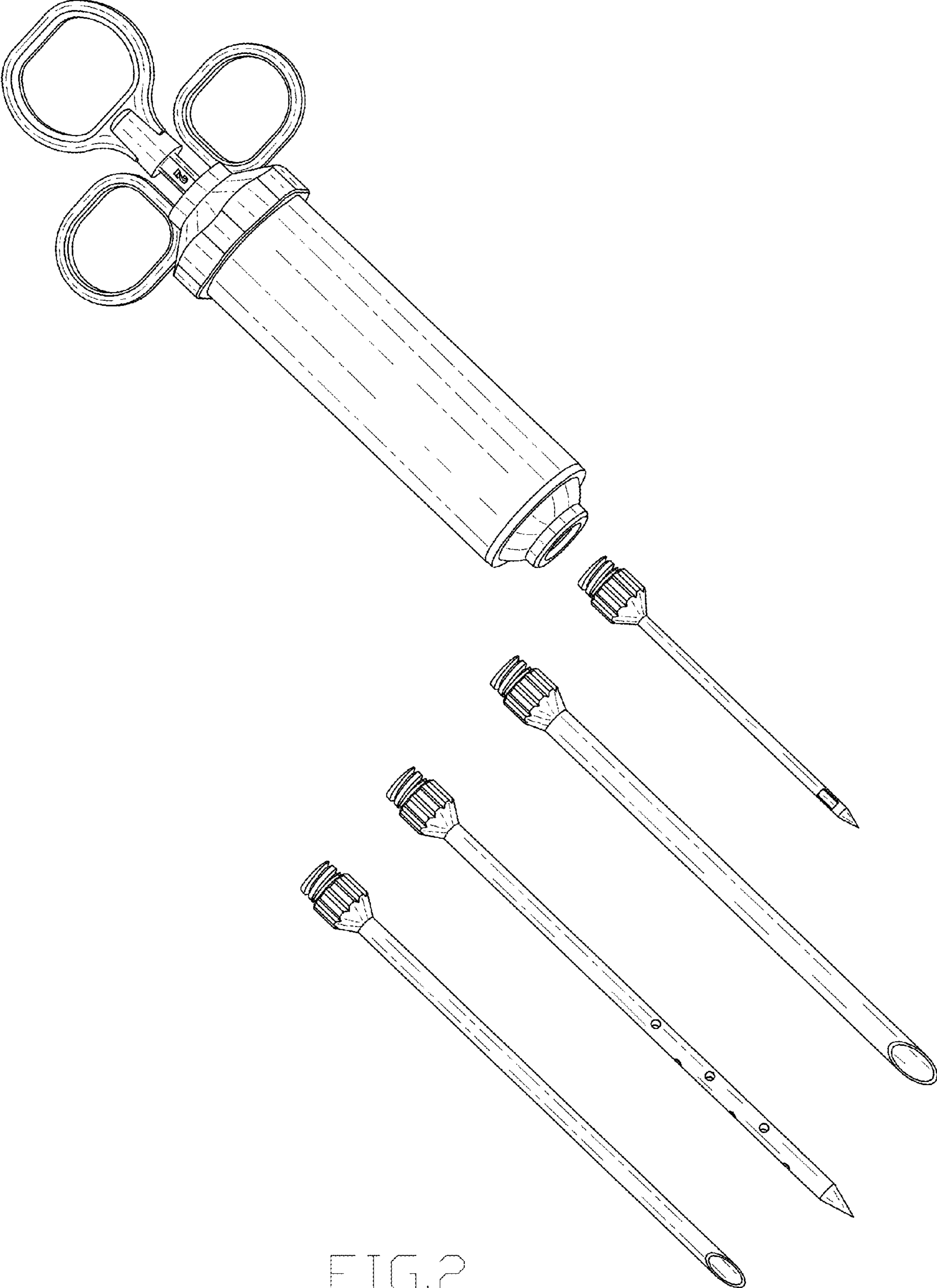

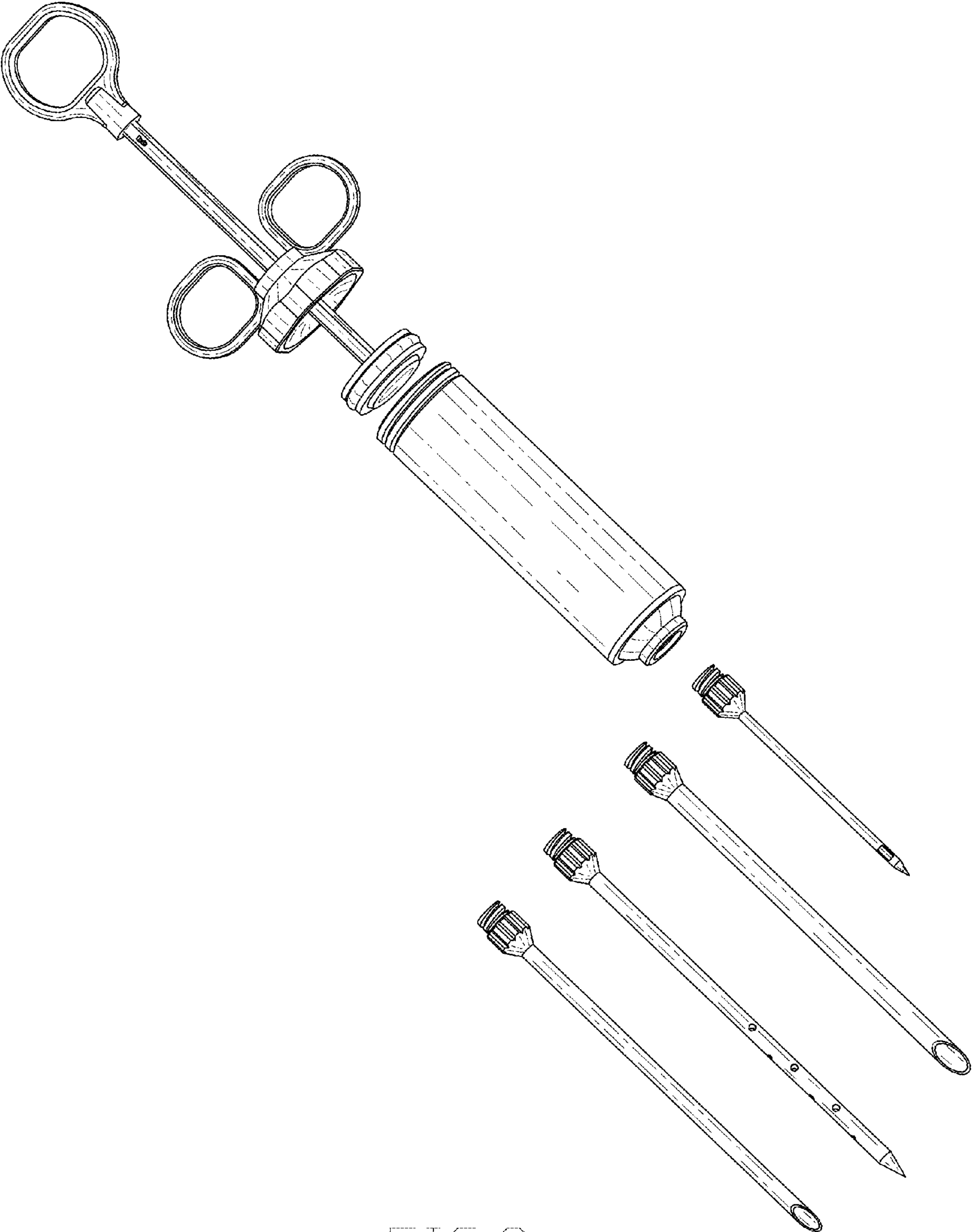

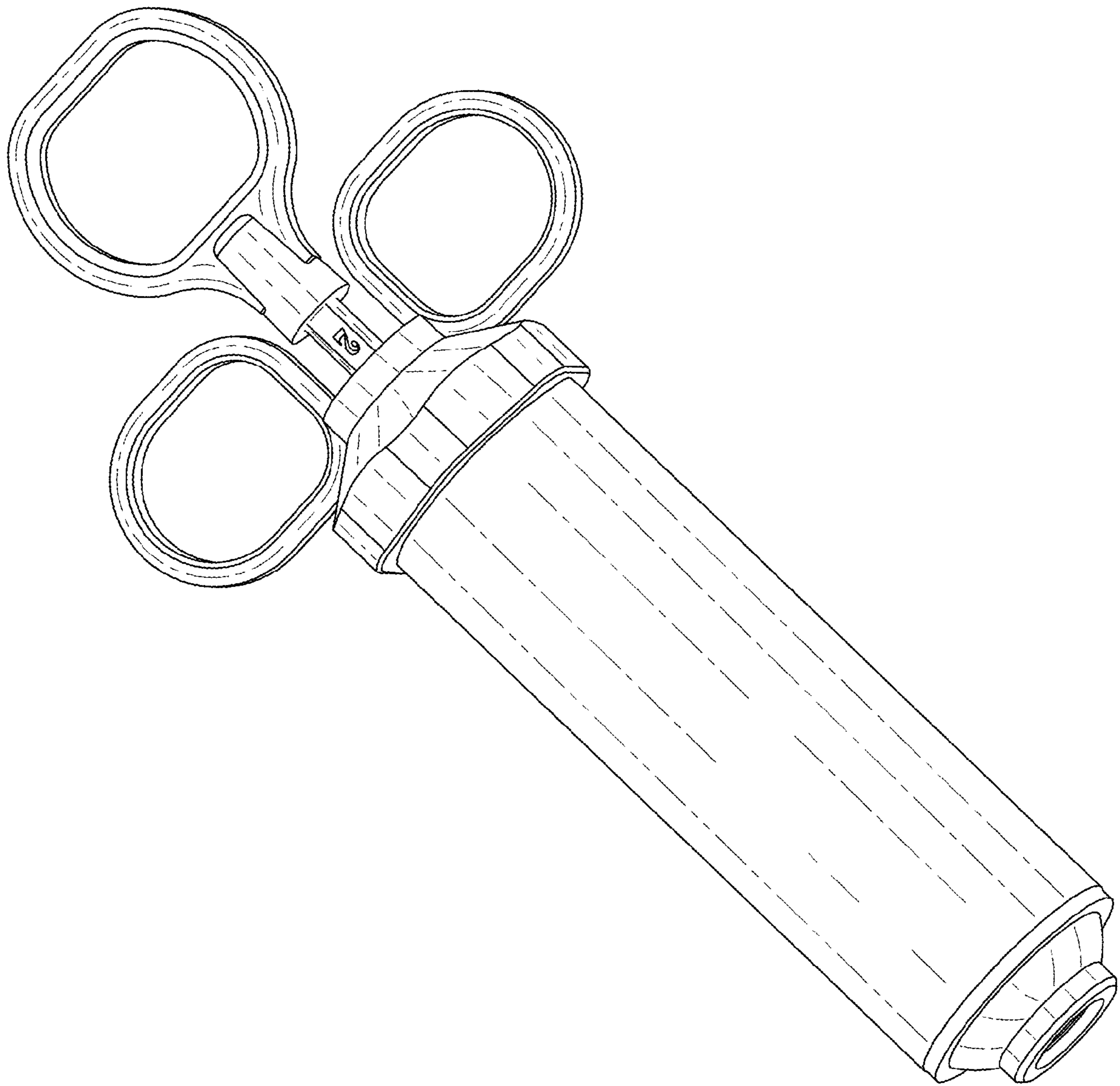

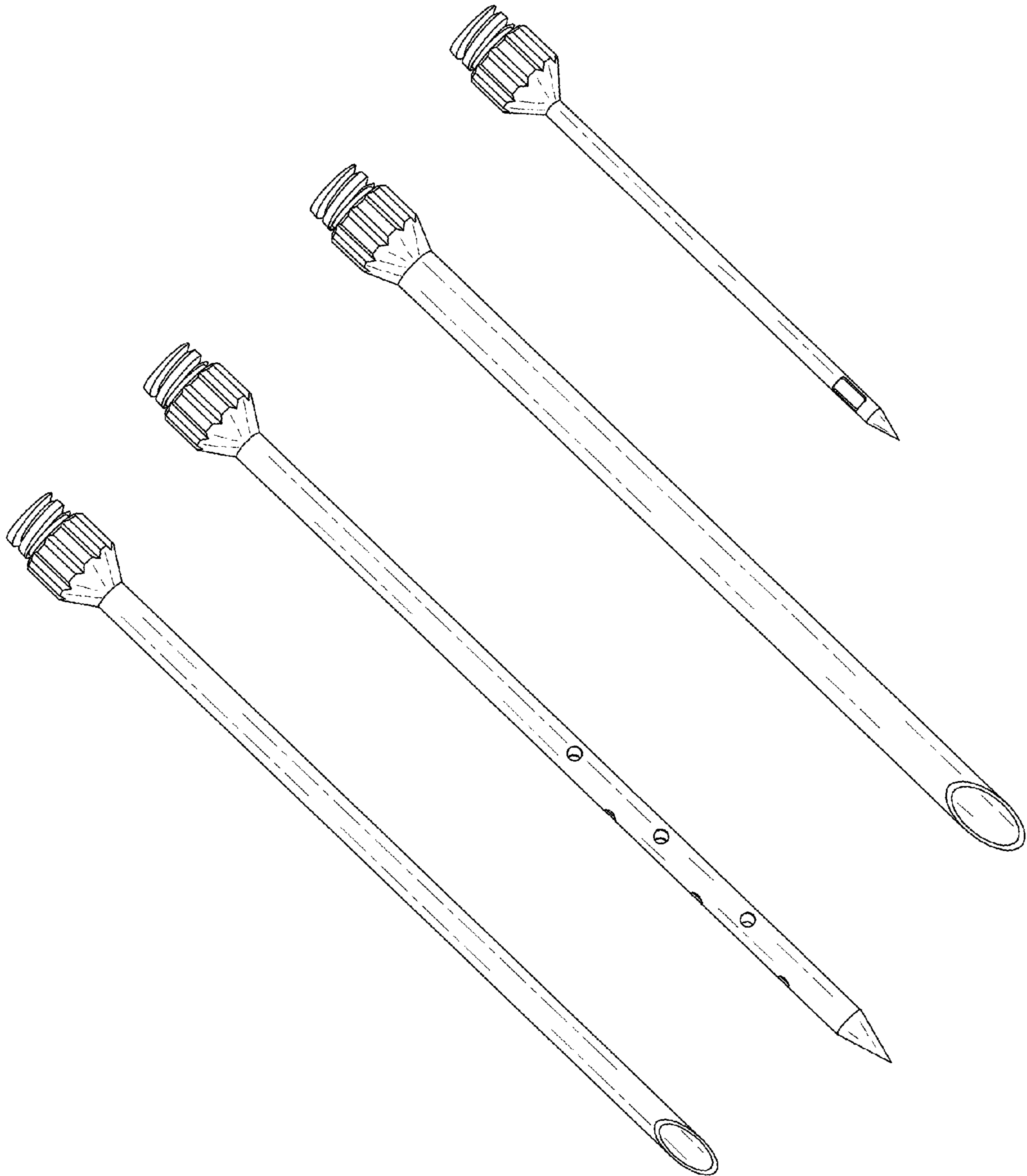

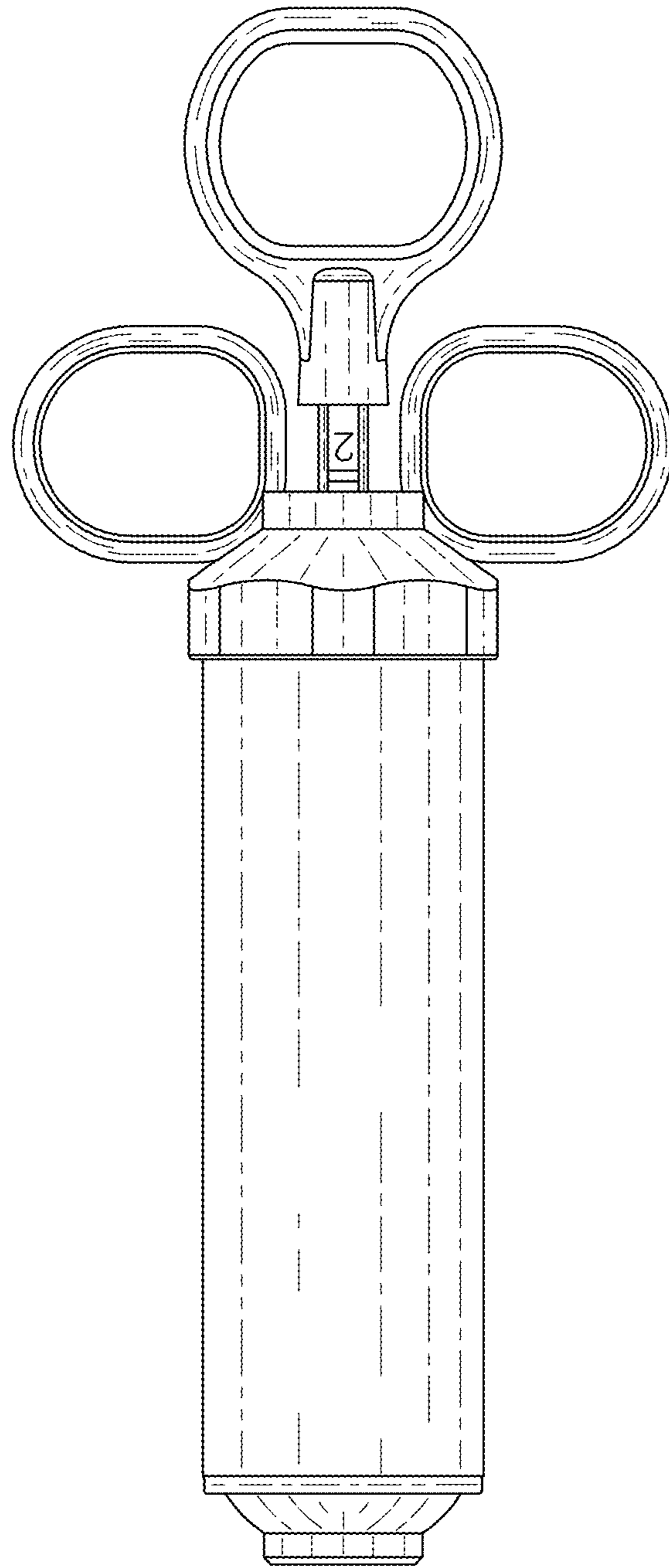

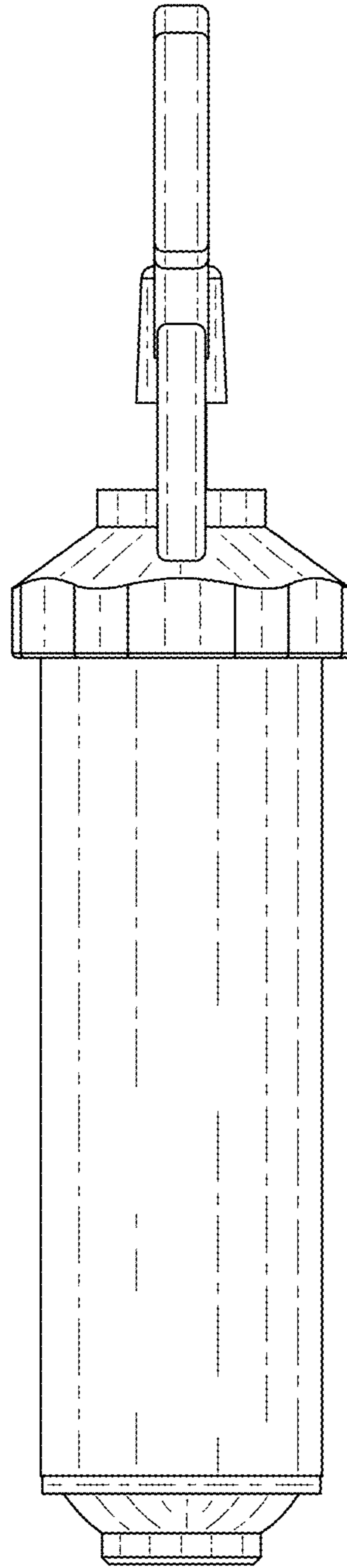

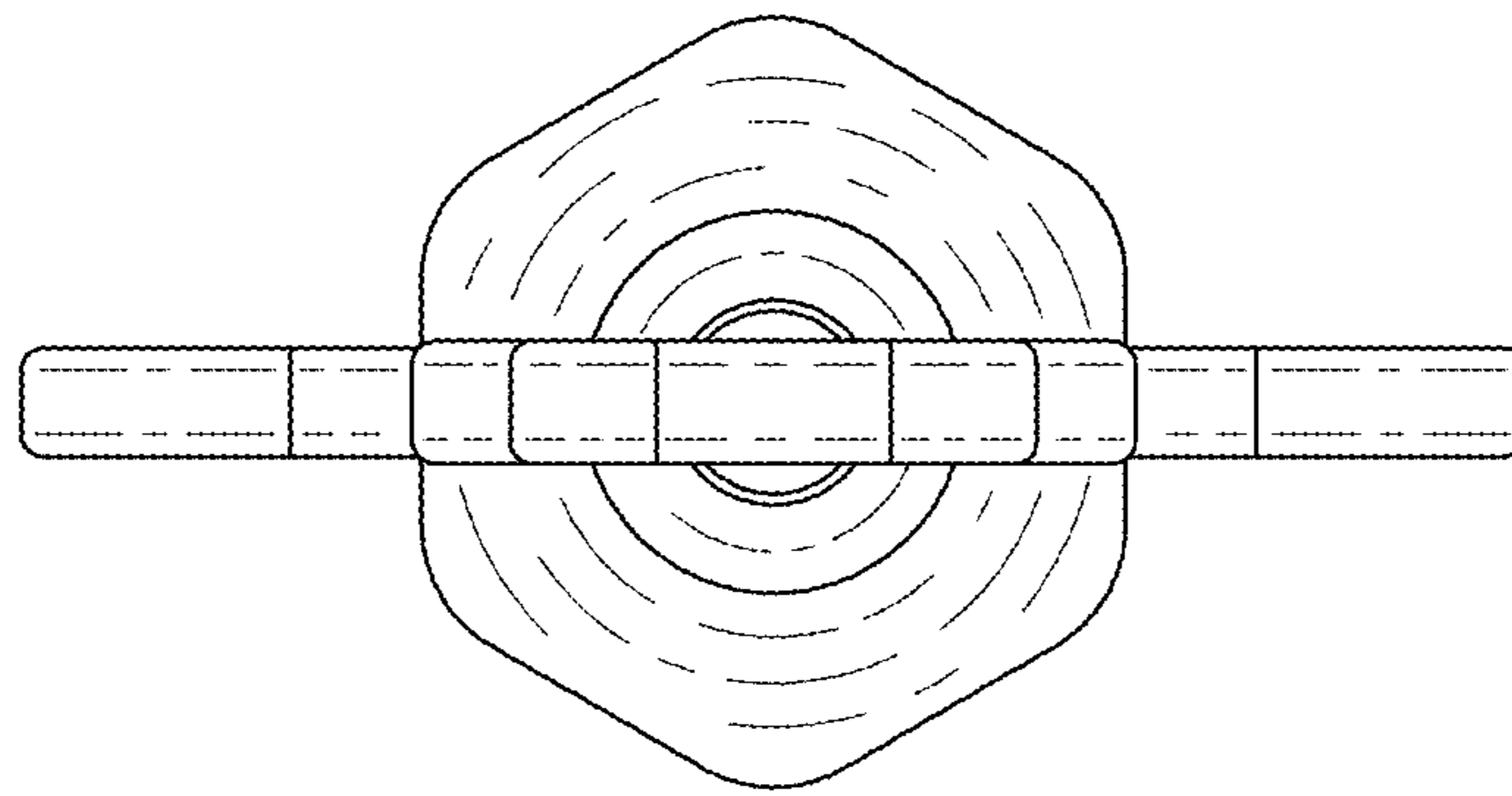

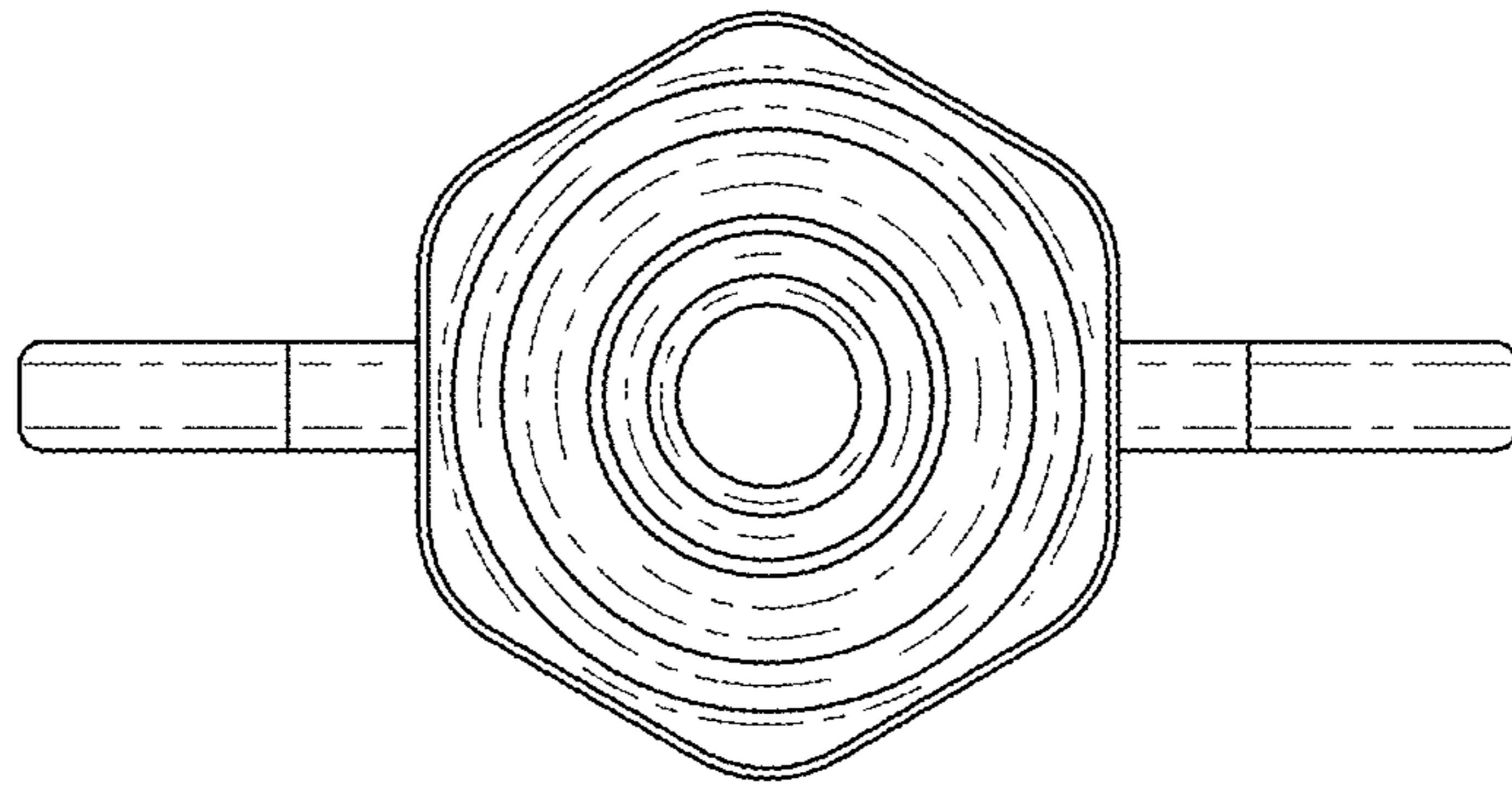
