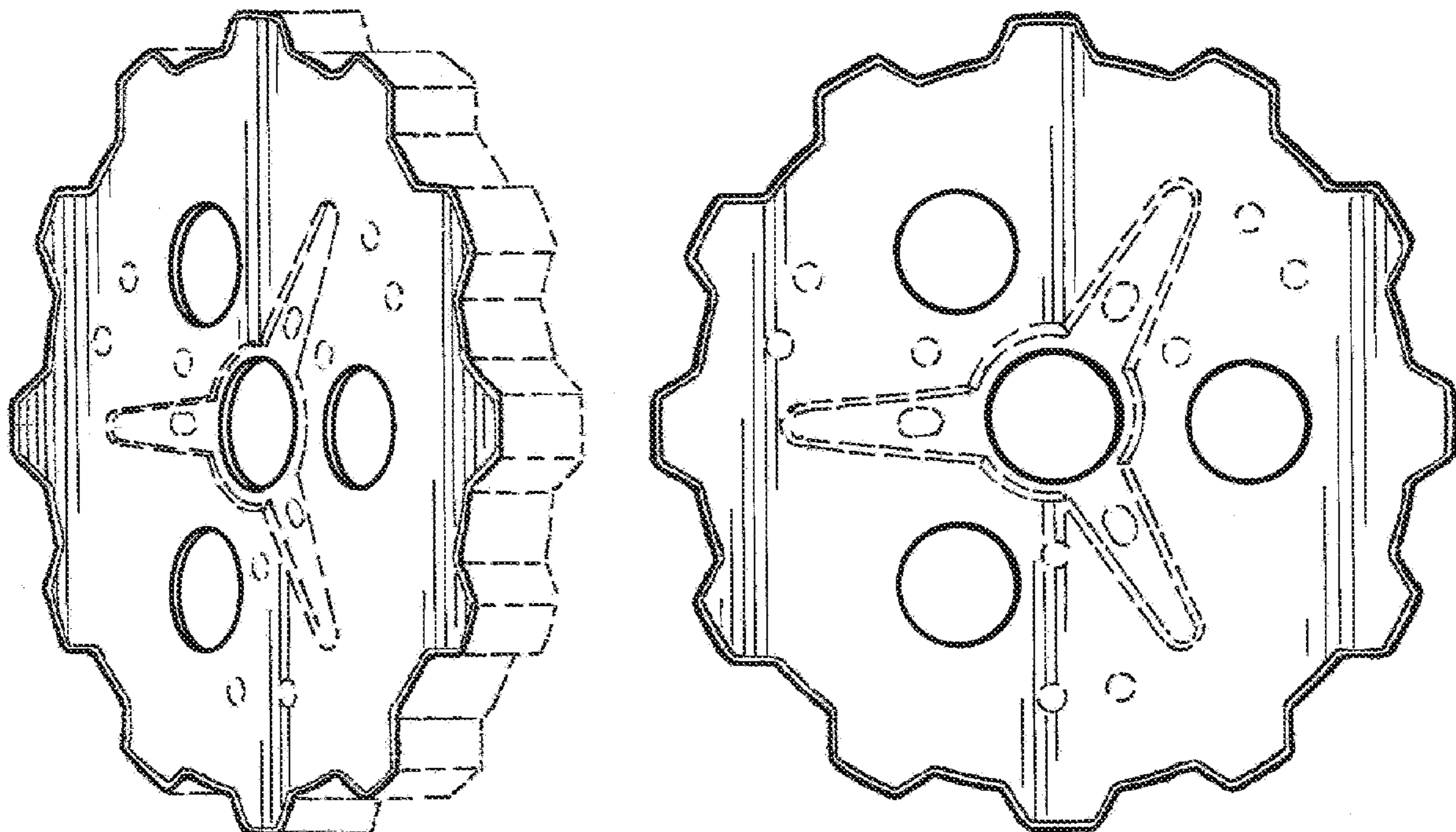
(57) **CLAIM**

I claim the ornamental design for a corrugated drum faceplate, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of the corrugated drum faceplate showing the claimed design; FIG. 2 is a front elevational view thereof; FIG. 3 is a rear elevational view thereof; FIG. 4 is a side profile view thereof; and, FIG. 5 is a sectional view taken along lines 5-5 of FIG. 3. In the drawings, the broken lines are for the purpose of showing environmental structure and form no part of the claimed design.

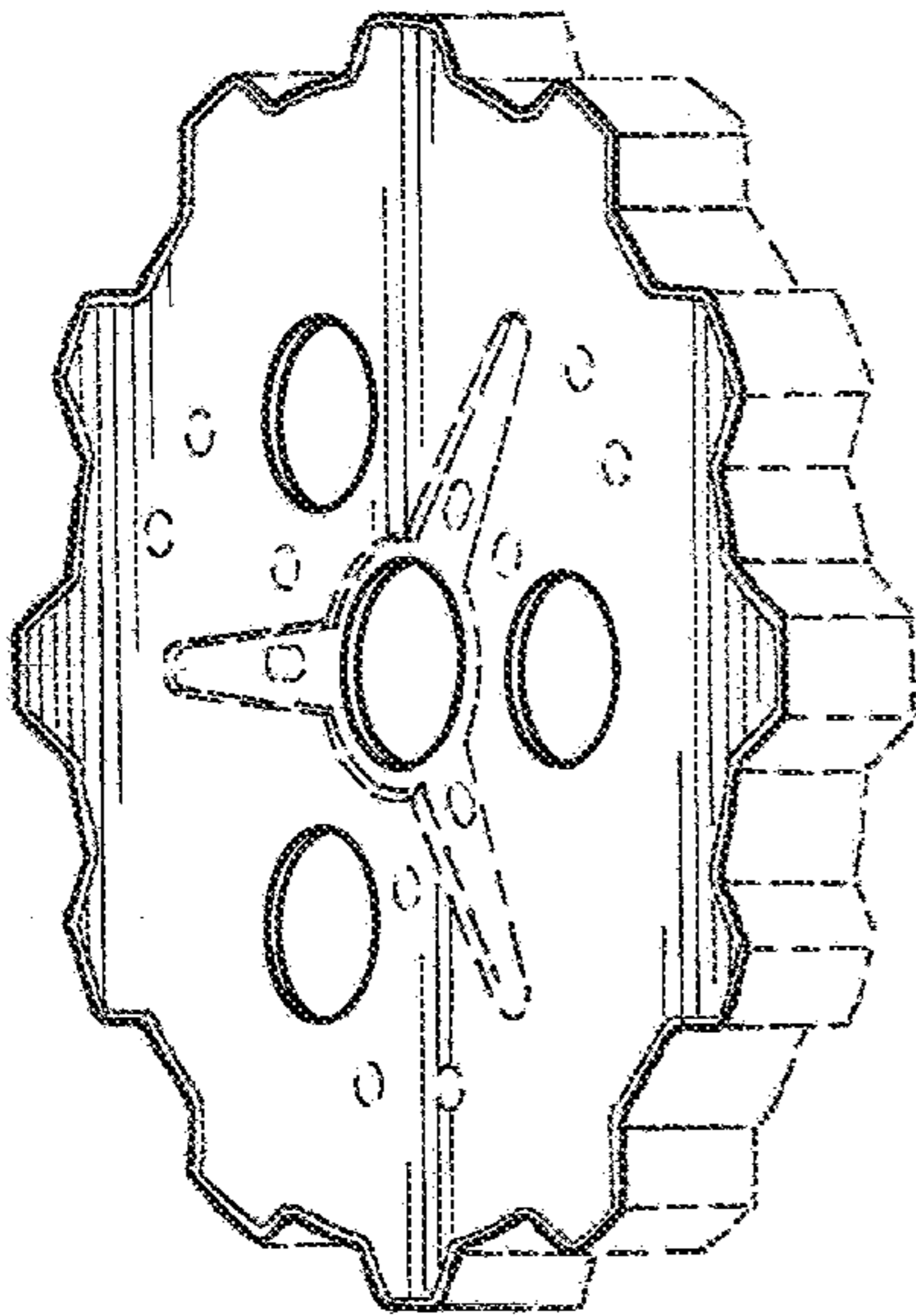

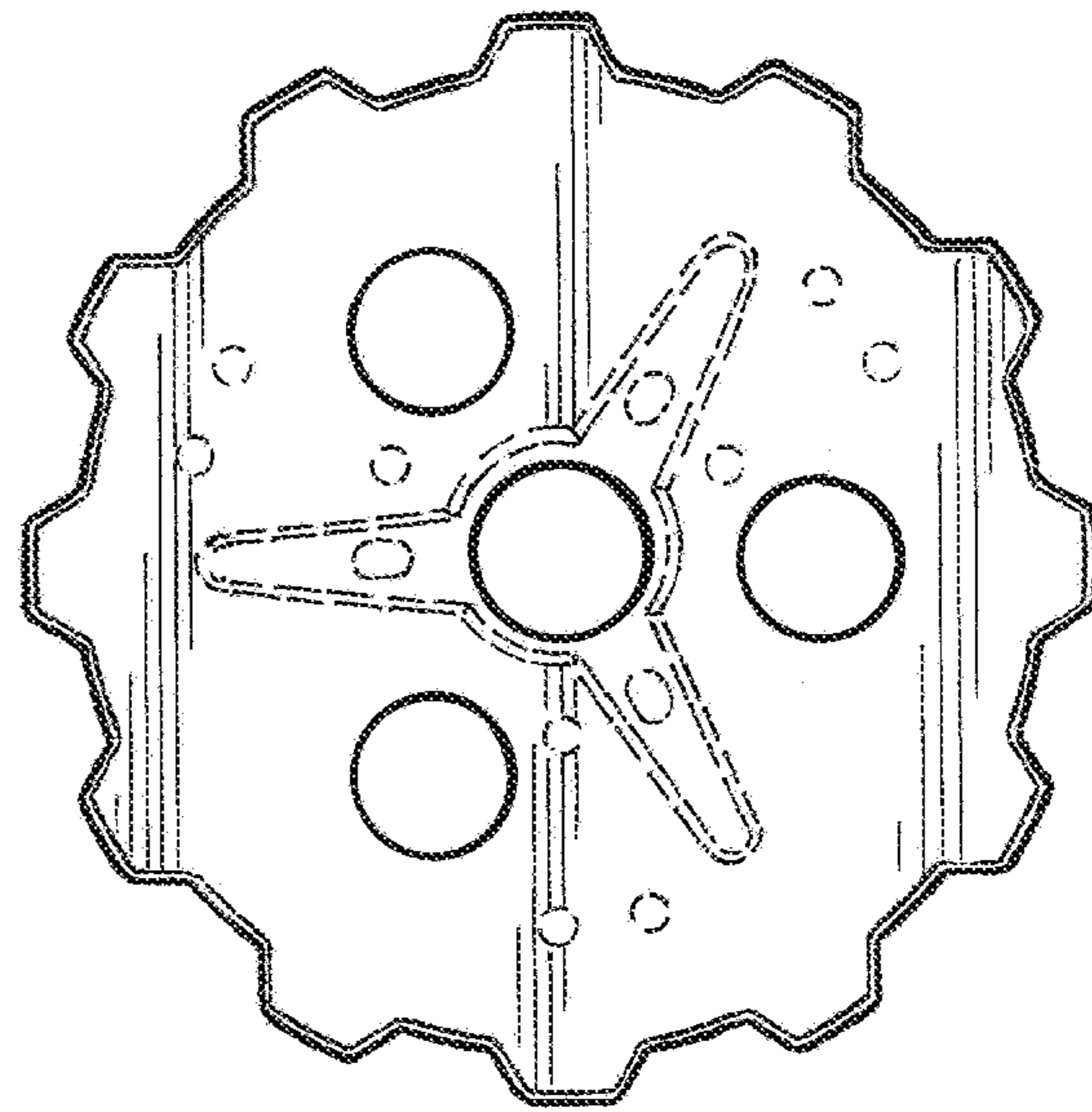

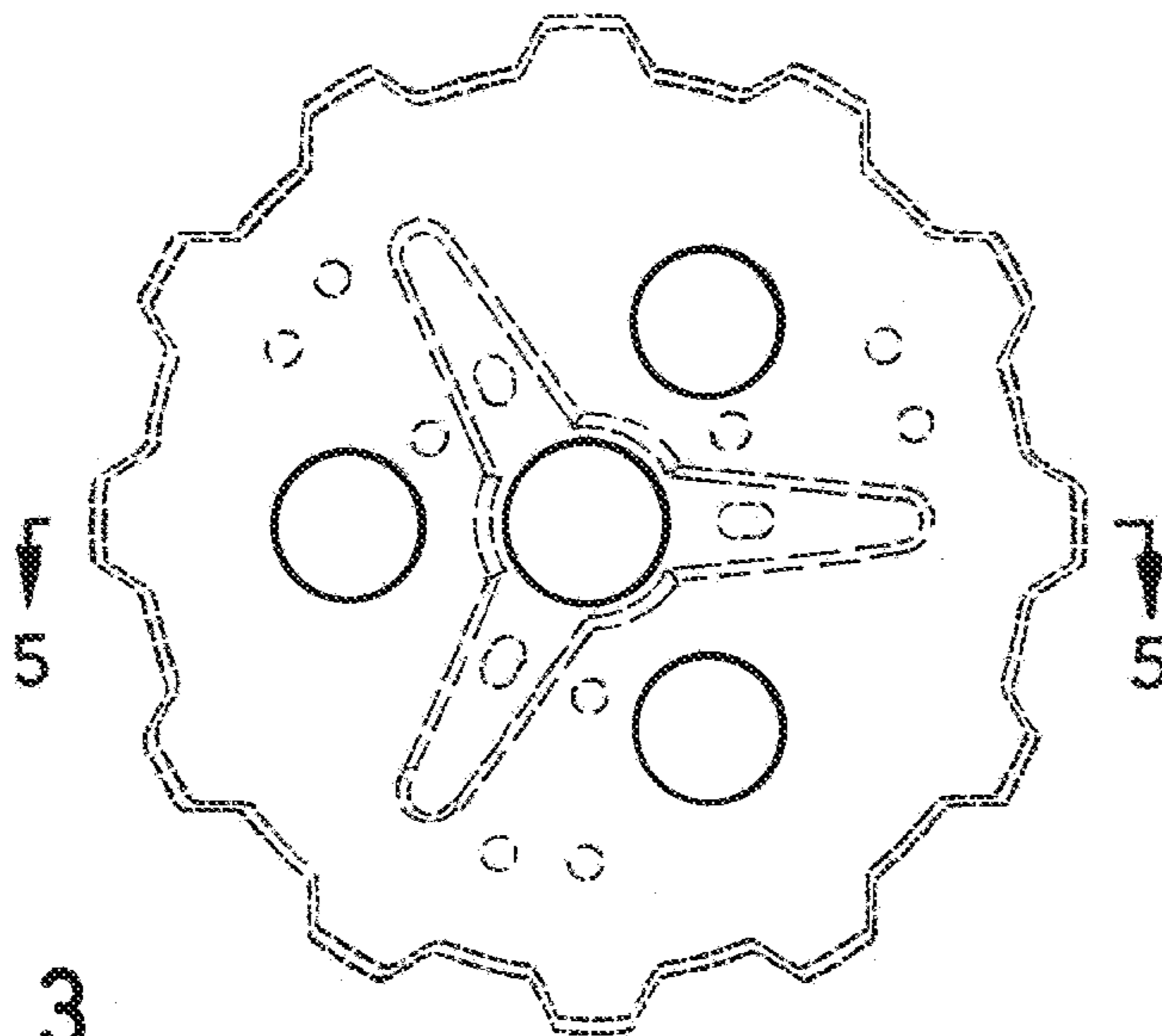

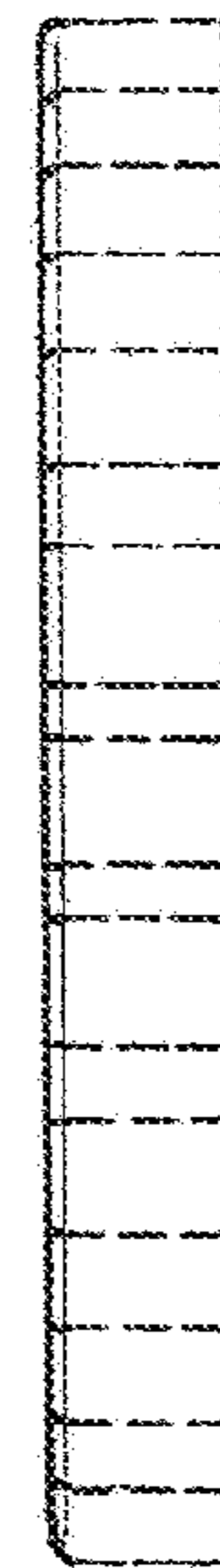

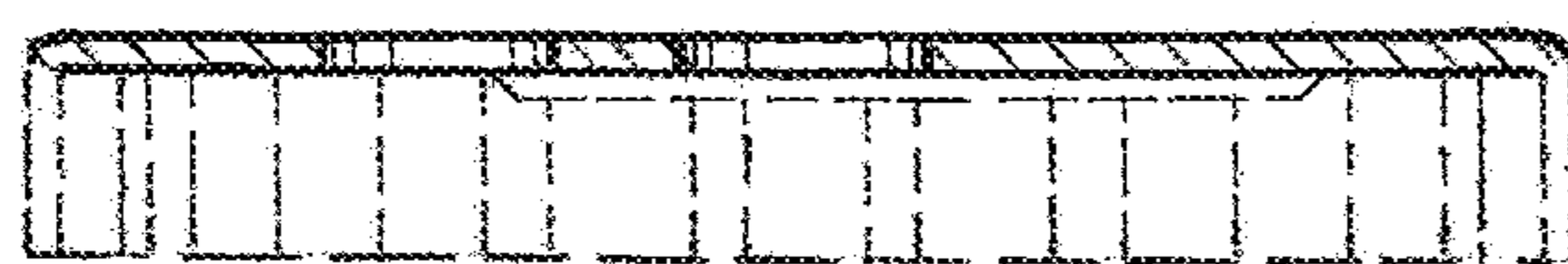
