(57) **CLAIM**

The ornamental design for a packaging and display container, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view taken from the front, top, and left side of a first embodiment of the ornamental design for a packaging and display container.

FIG. 2 is a right side elevation view of the embodiment of FIG. 1.

FIG. 3 is a left side elevation view of the embodiment of FIG. 1.

FIG. 4 is a front elevation view of the embodiment of FIG. 1.

FIG. 5 is a rear elevation view of the embodiment of FIG. 1.

FIG. 6 is a top plan view of the embodiment of FIG. 1.

FIG. 7 is a bottom plan view of the embodiment of FIG. 1.

FIG. 8 is a perspective view taken from the front, top and left side of a second embodiment of the ornamental design for a packaging and display container.

FIG. 9 is a right side elevation view of the embodiment of FIG. 8.

FIG. 10 is a left side elevation view of the embodiment of FIG. 8.

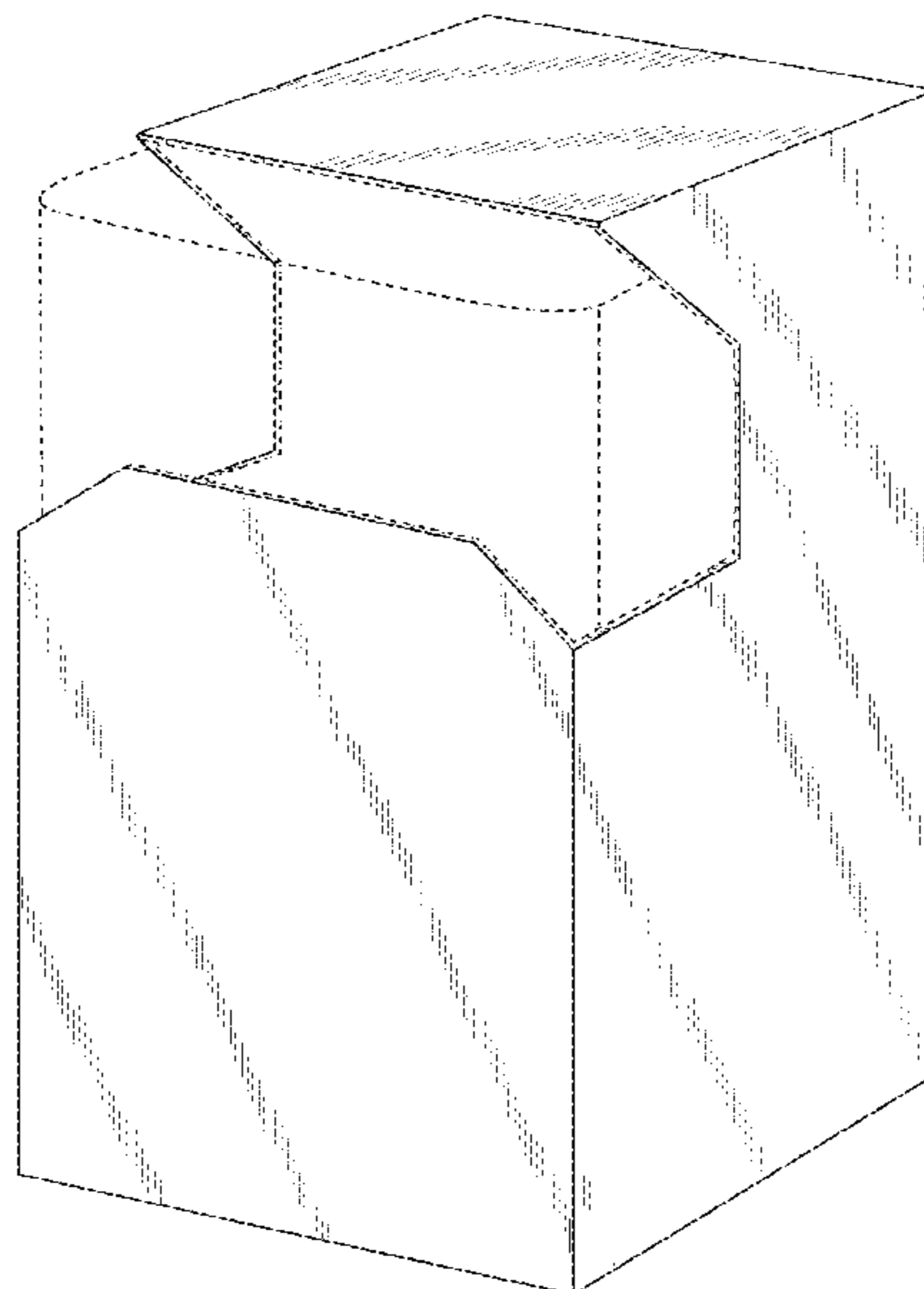
FIG. 11 is a front elevation view of the embodiment of FIG. 8.

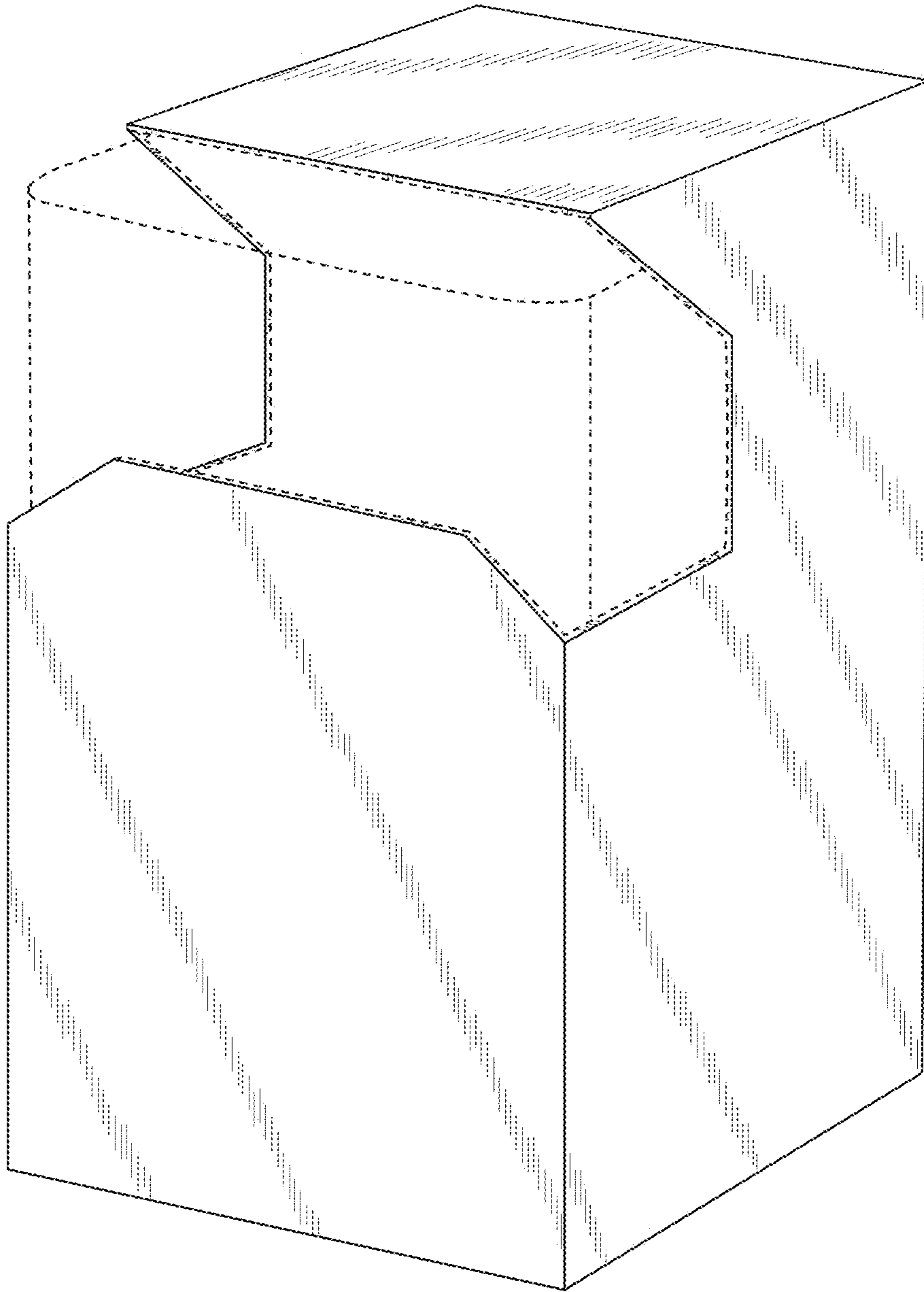

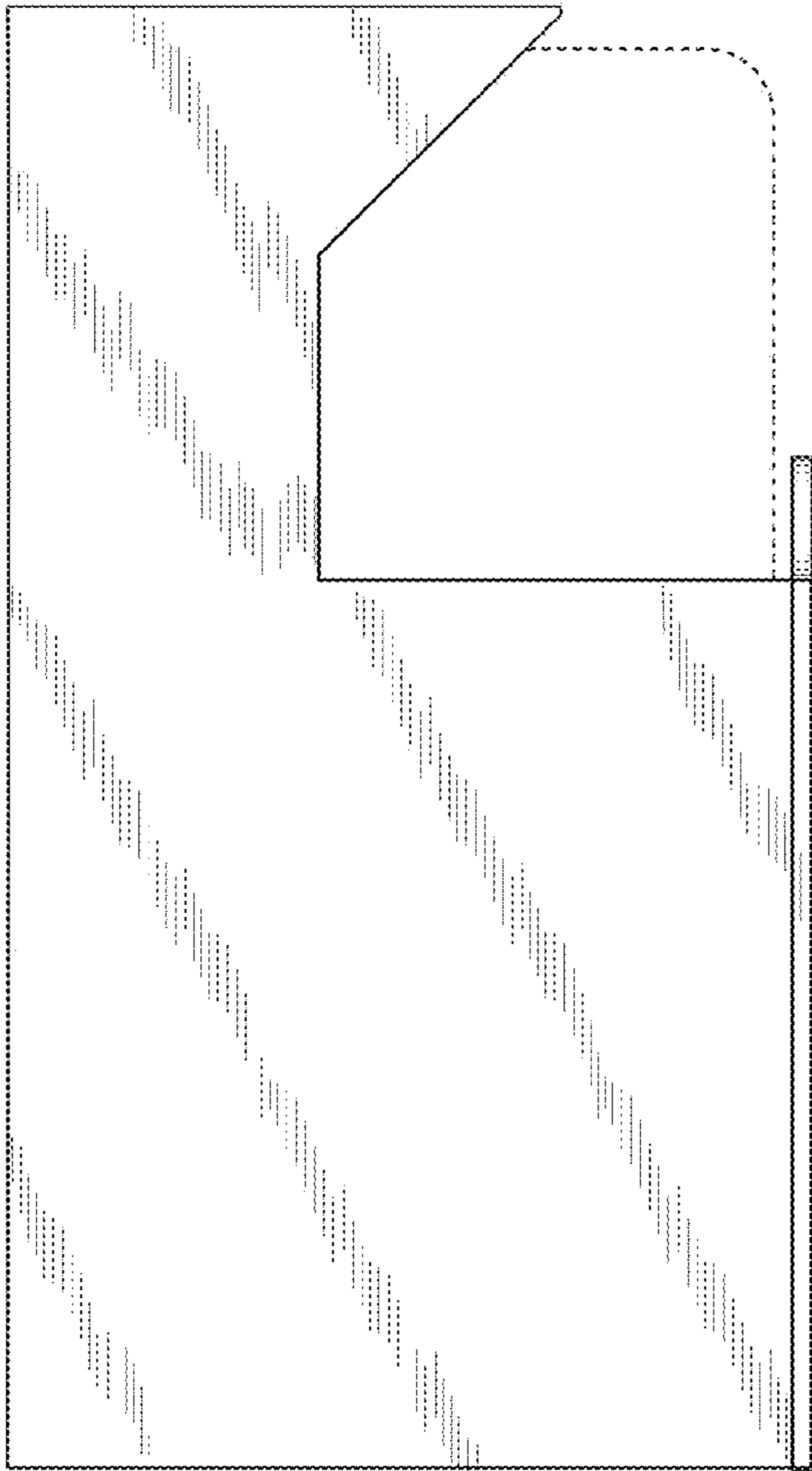

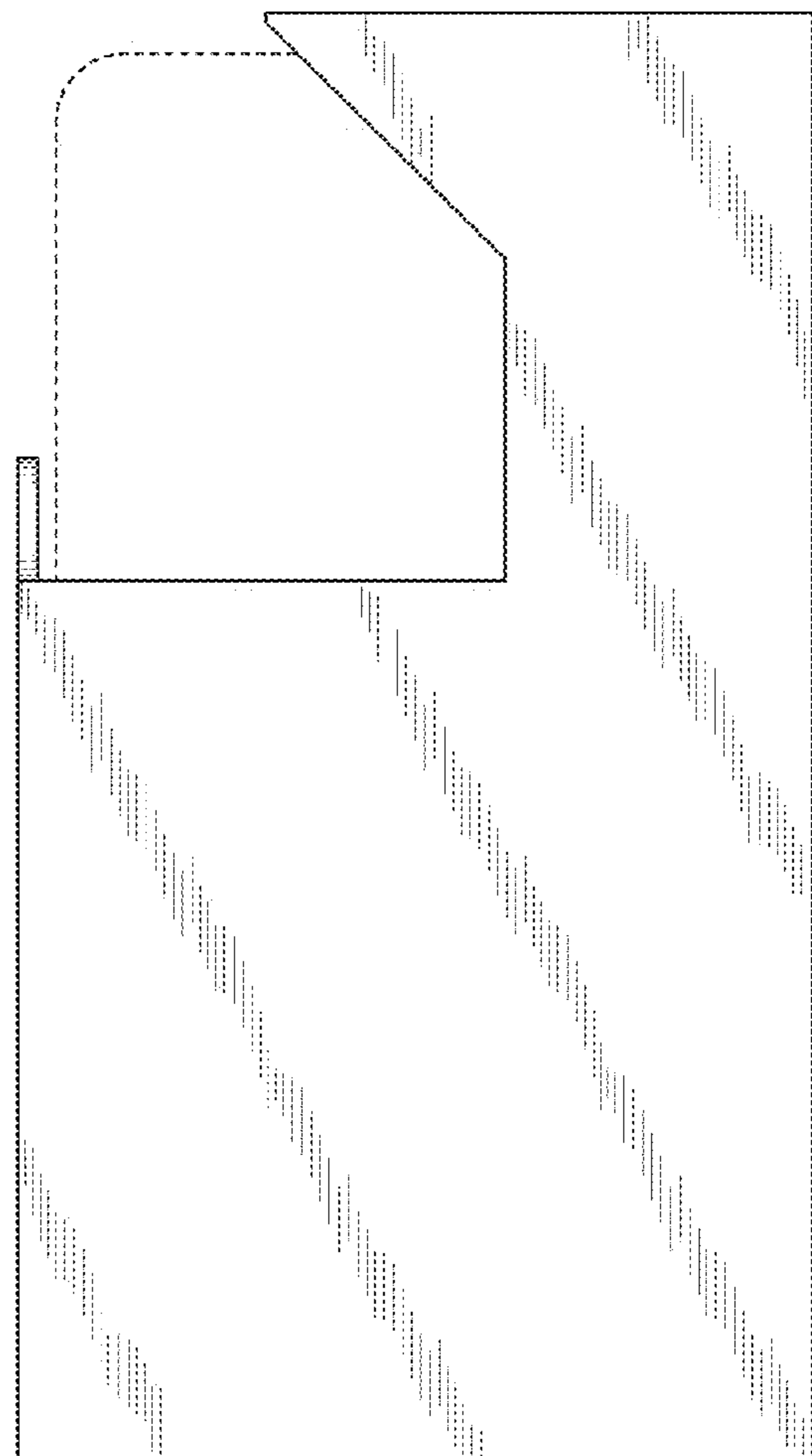

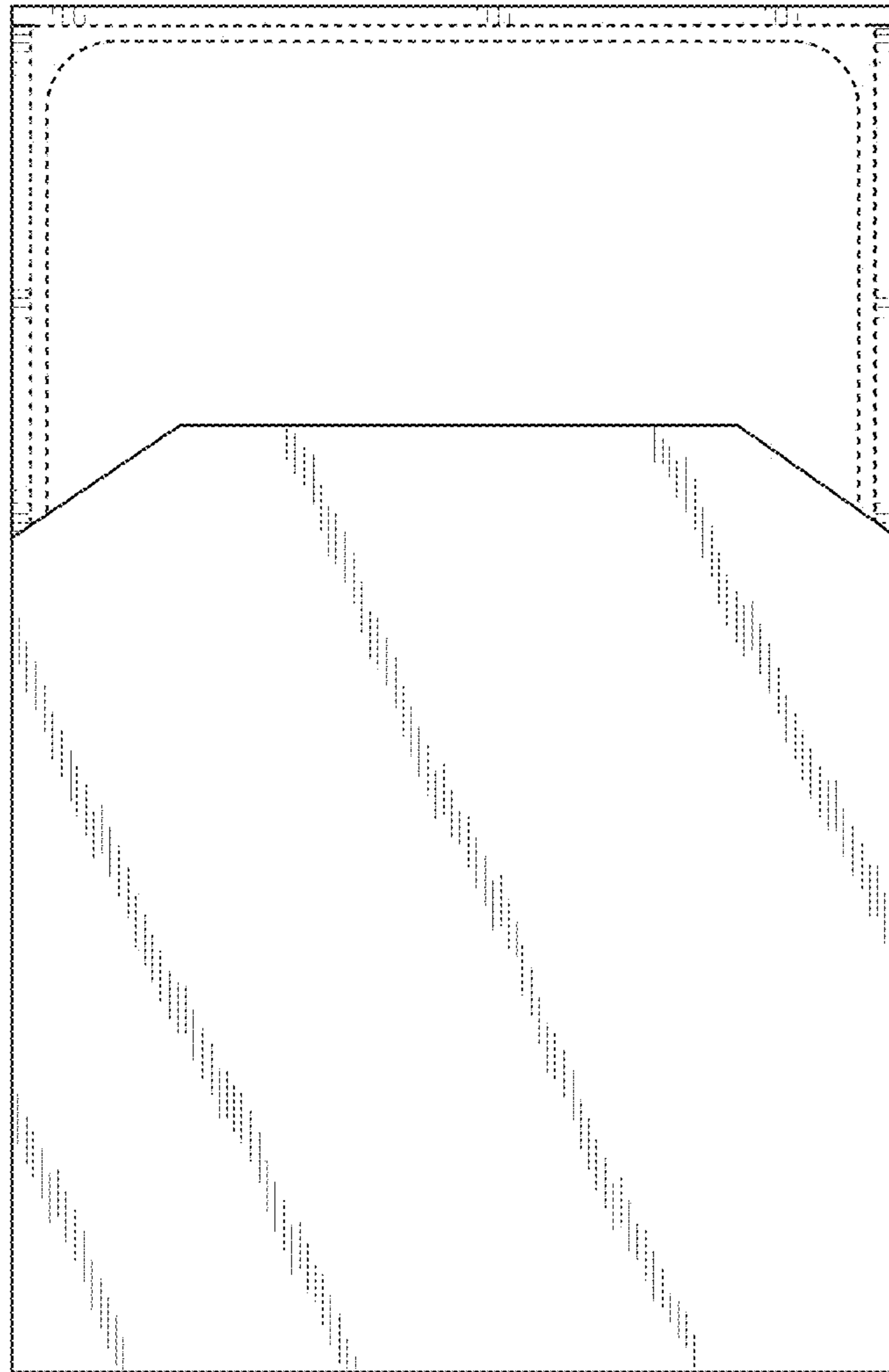

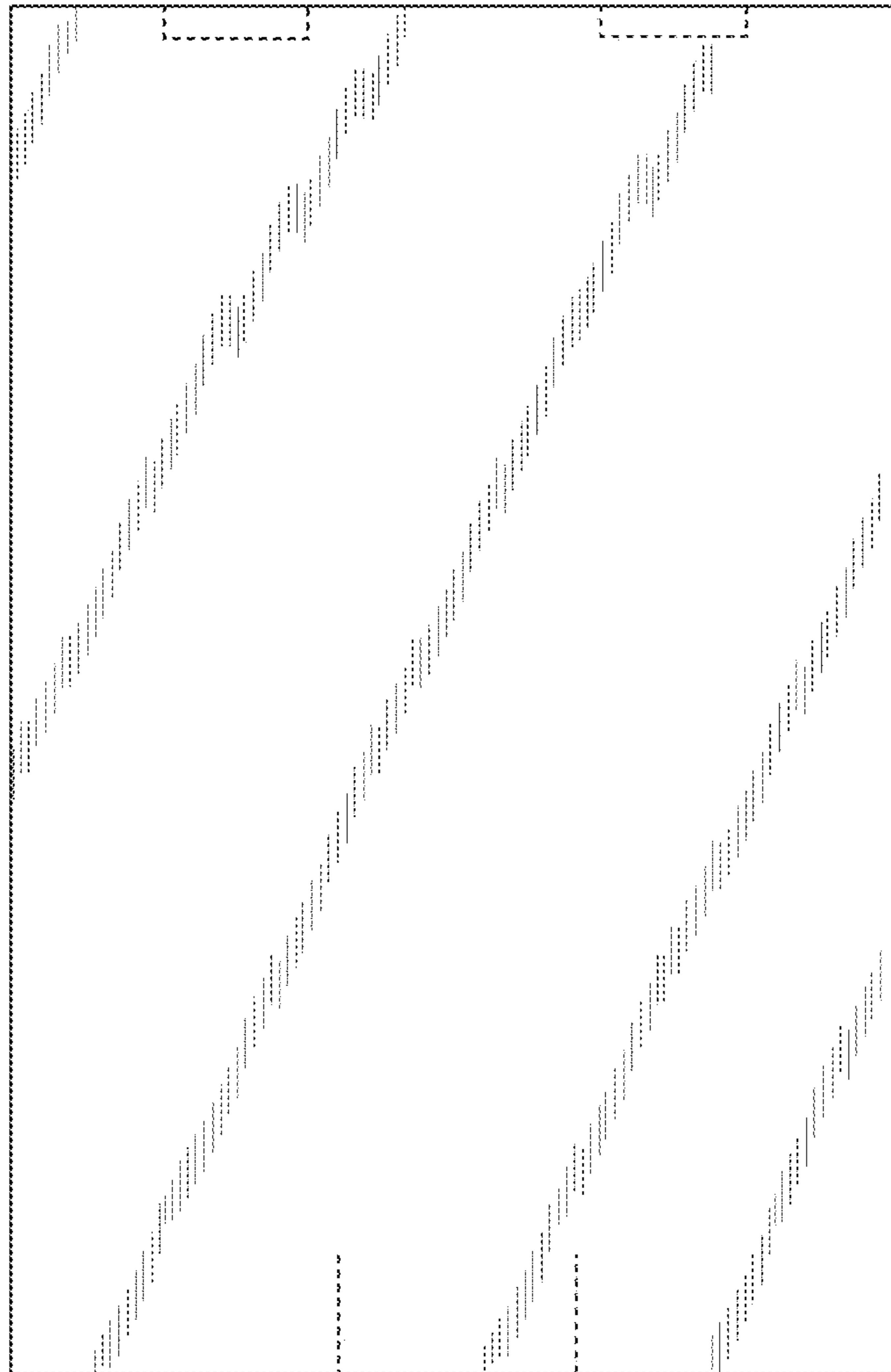

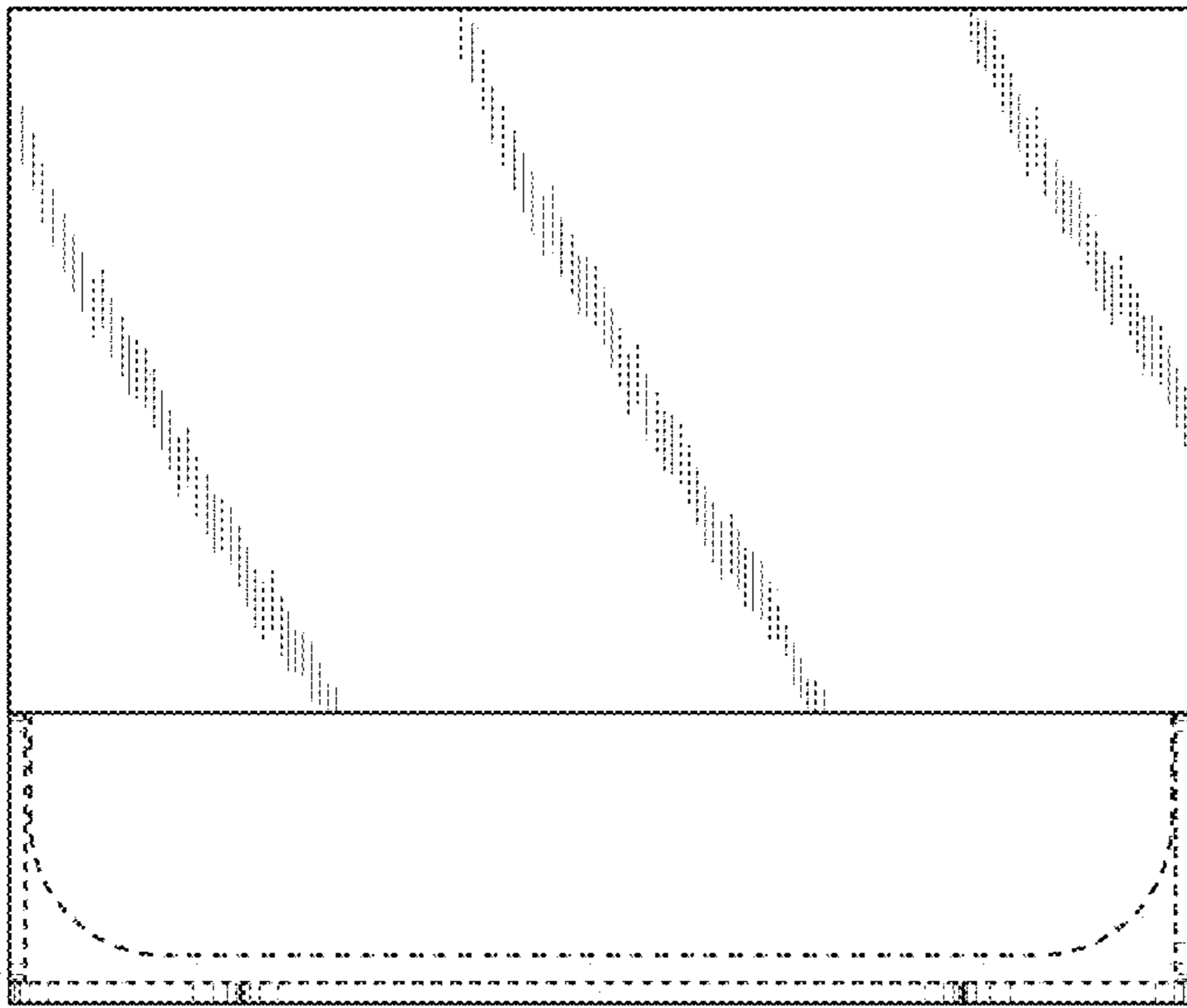

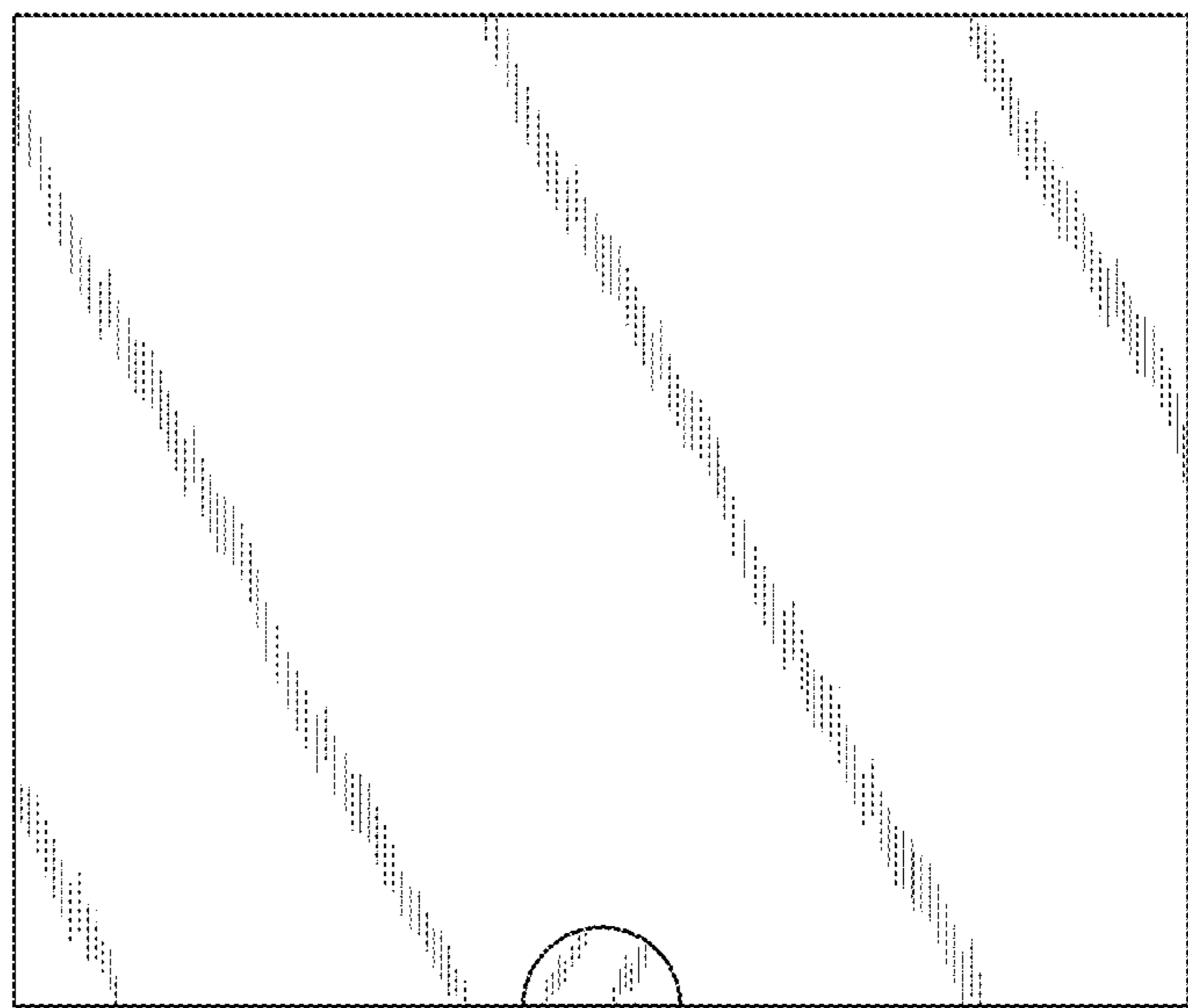

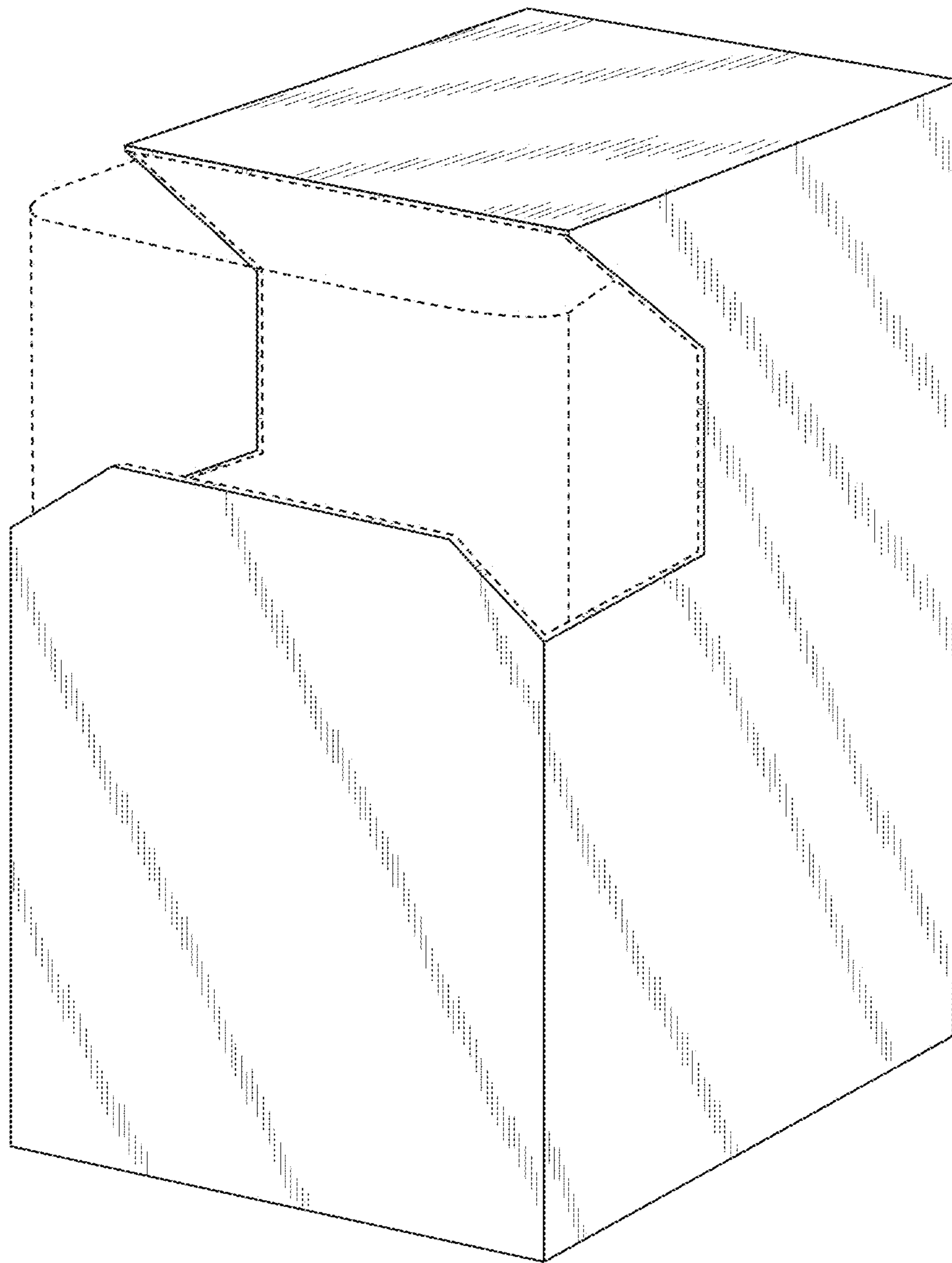

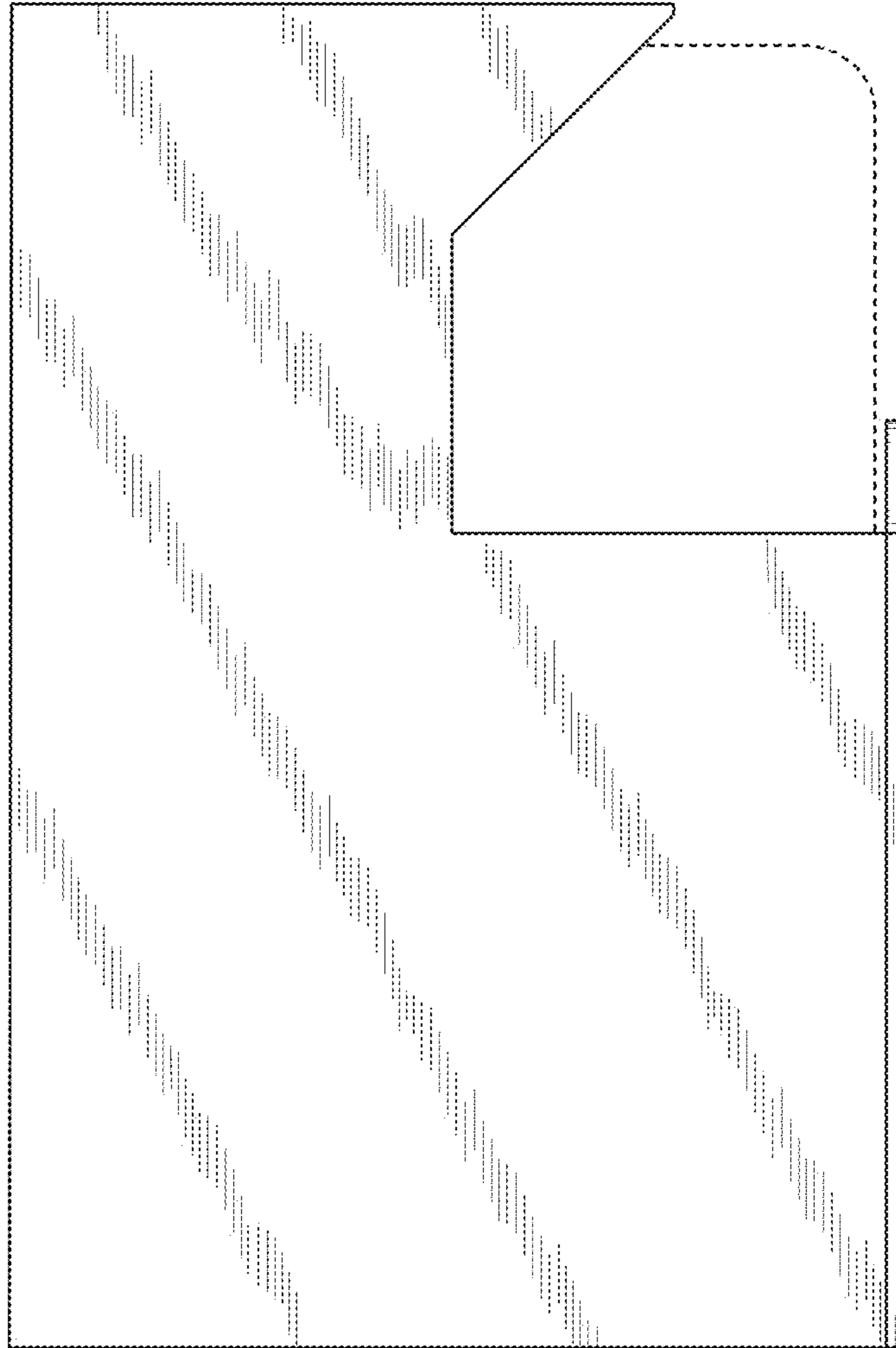

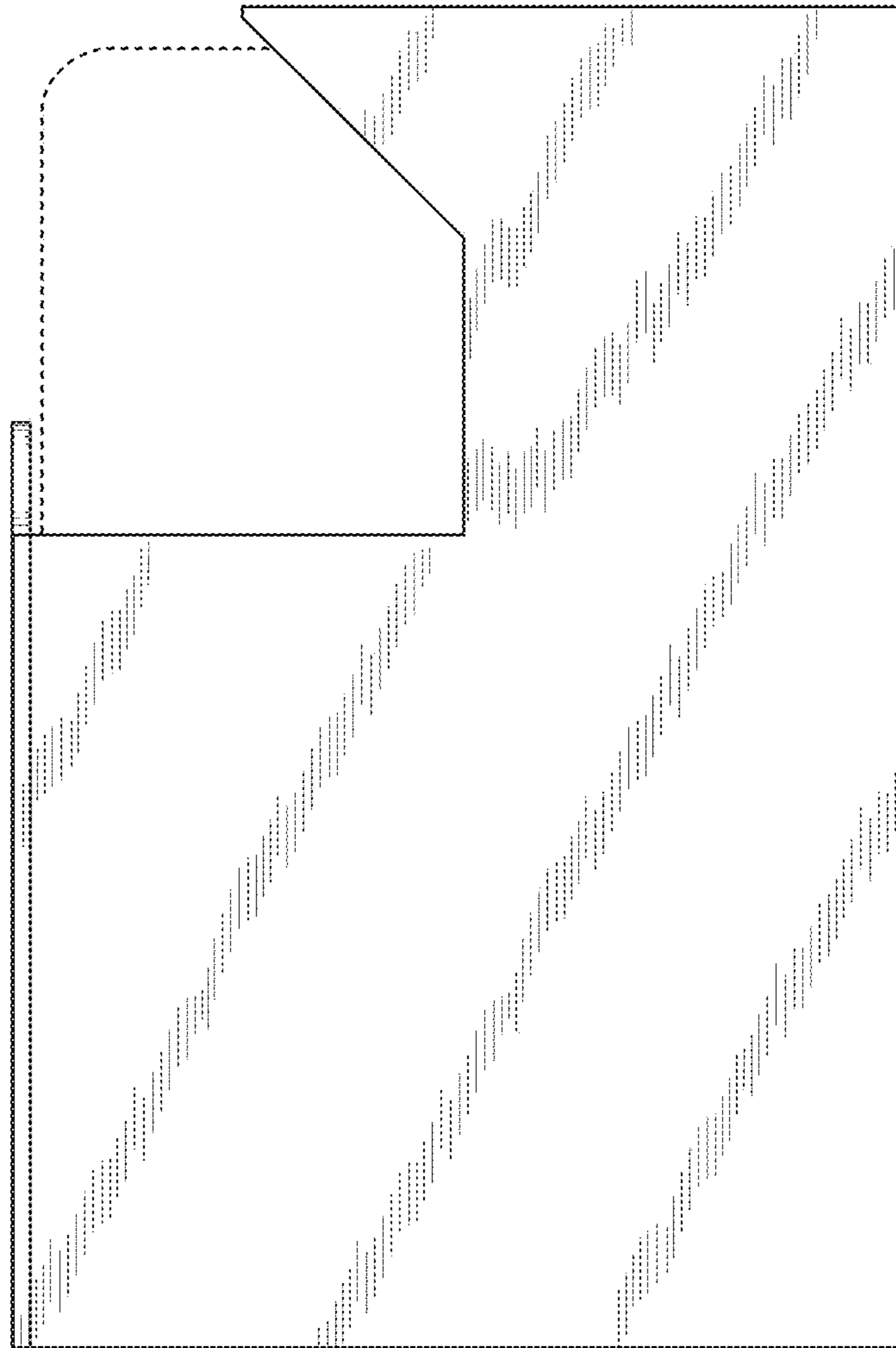

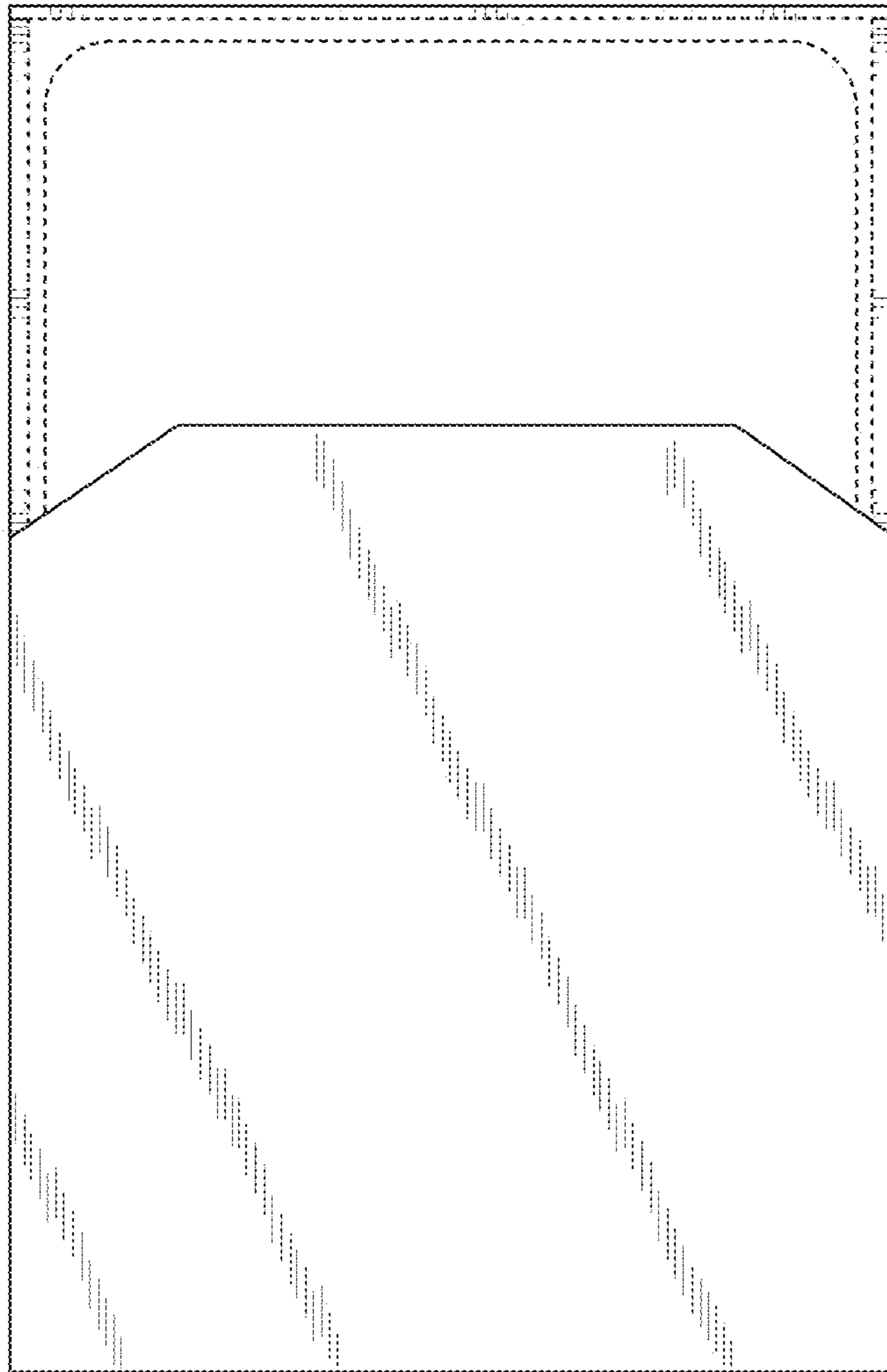

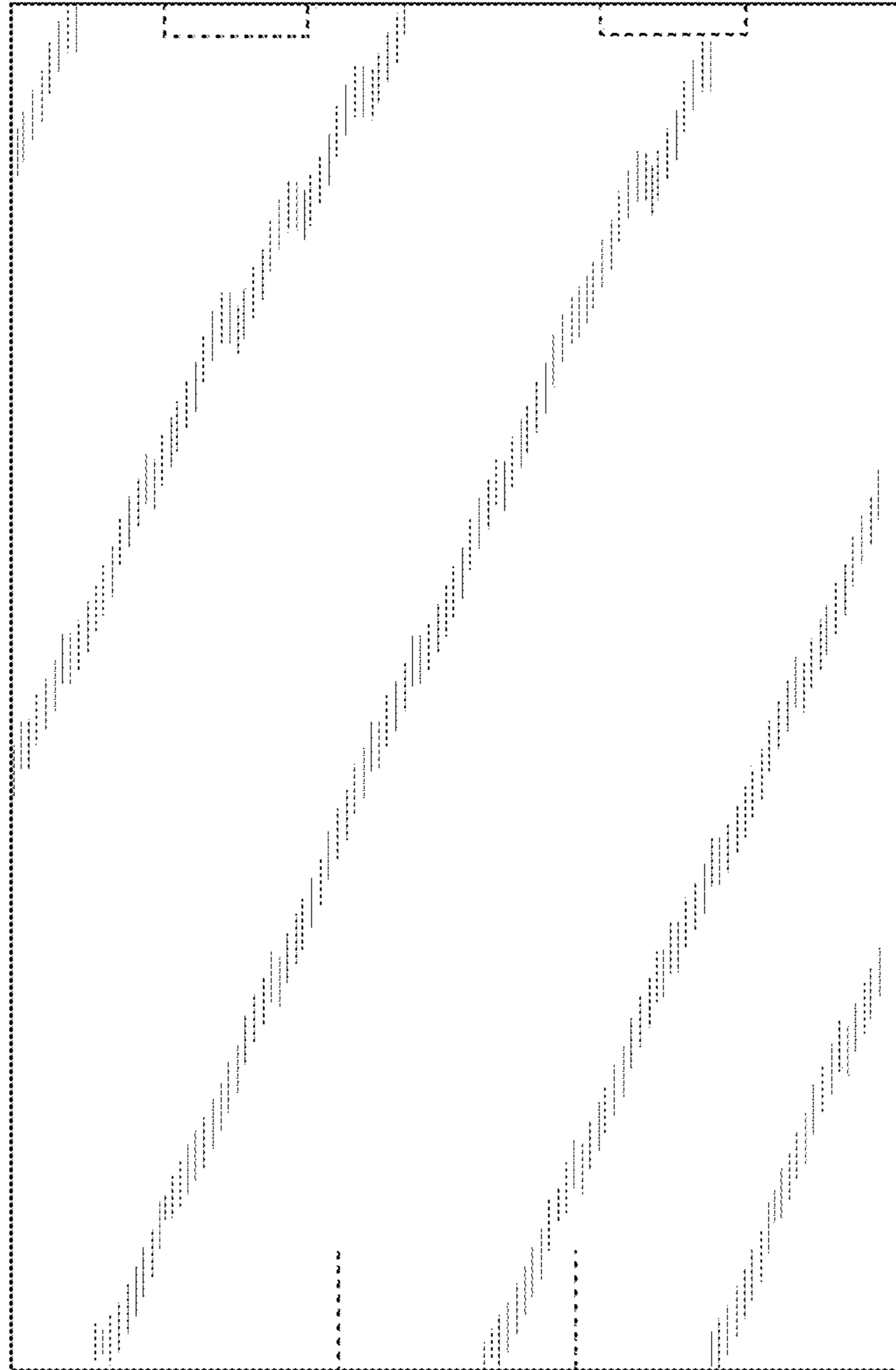

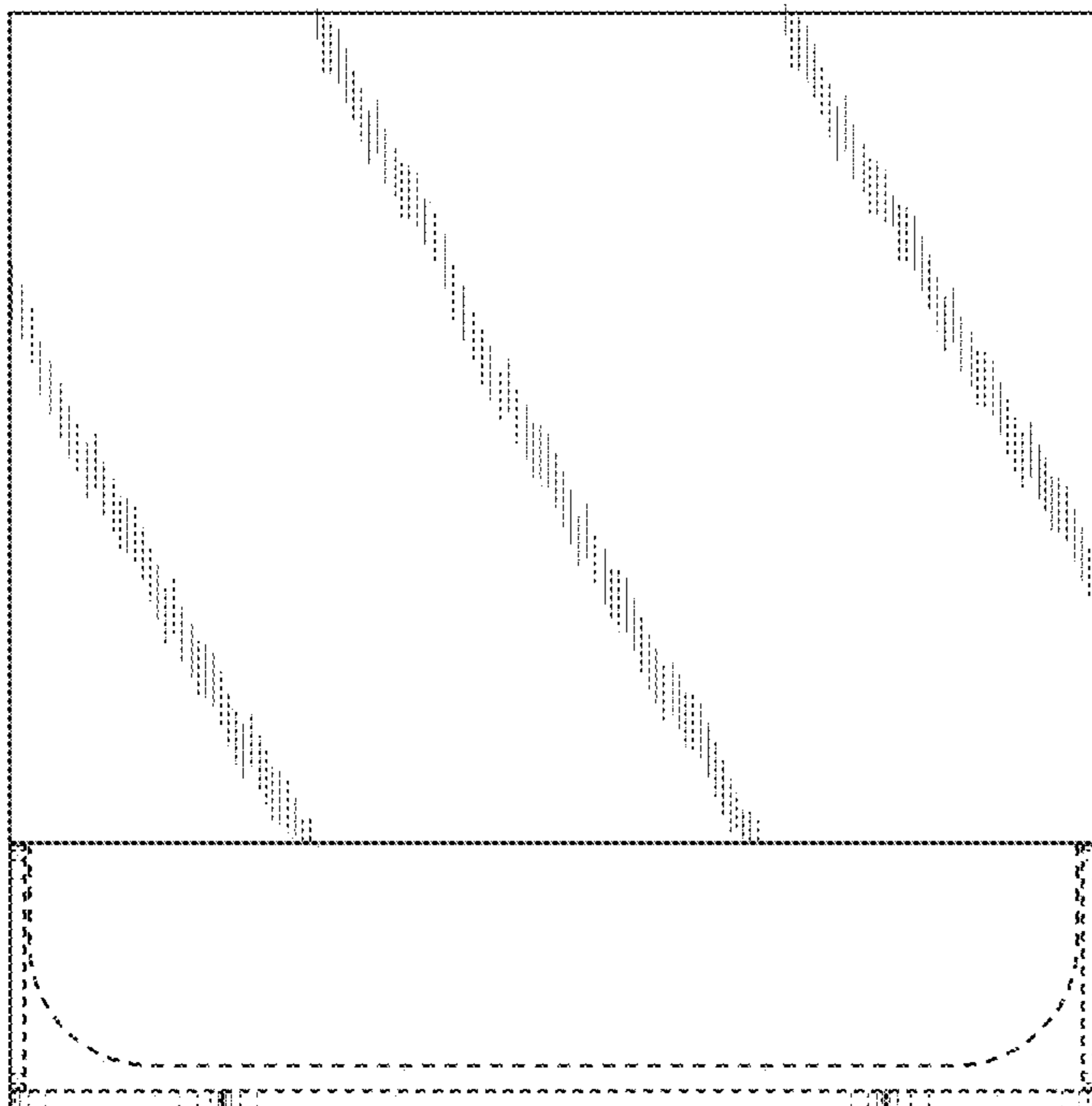

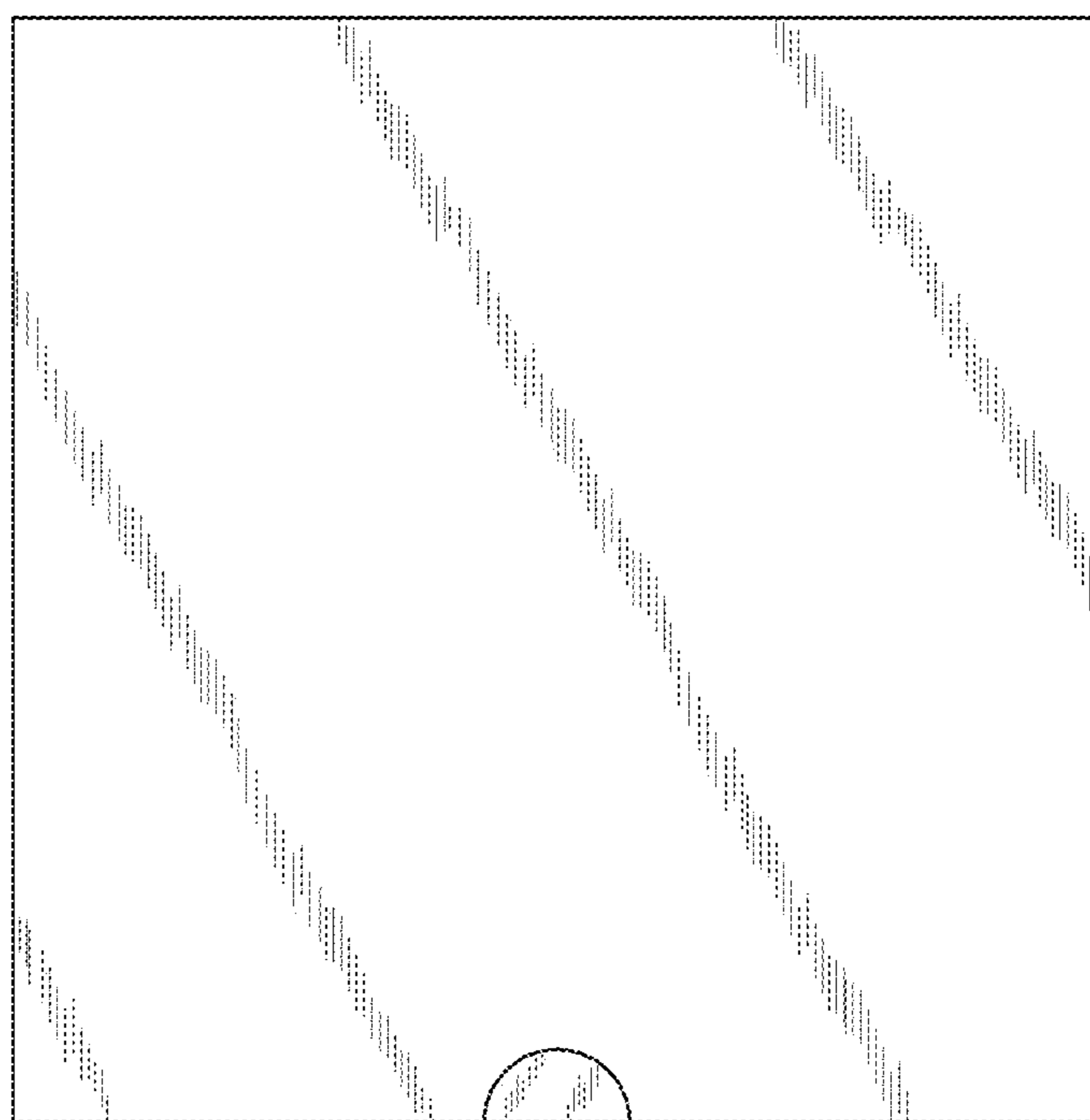
