We claim the ornamental design for a remote control, substantially as shown and described.

DESCRIPTION

FIG. 1 is a front view of a remote control of the present invention;

FIG. 2 is a back view thereof;

FIG. 3 is a left side elevation view of FIG. 1;

FIG. 4 is a right side elevation view of FIG. 1;

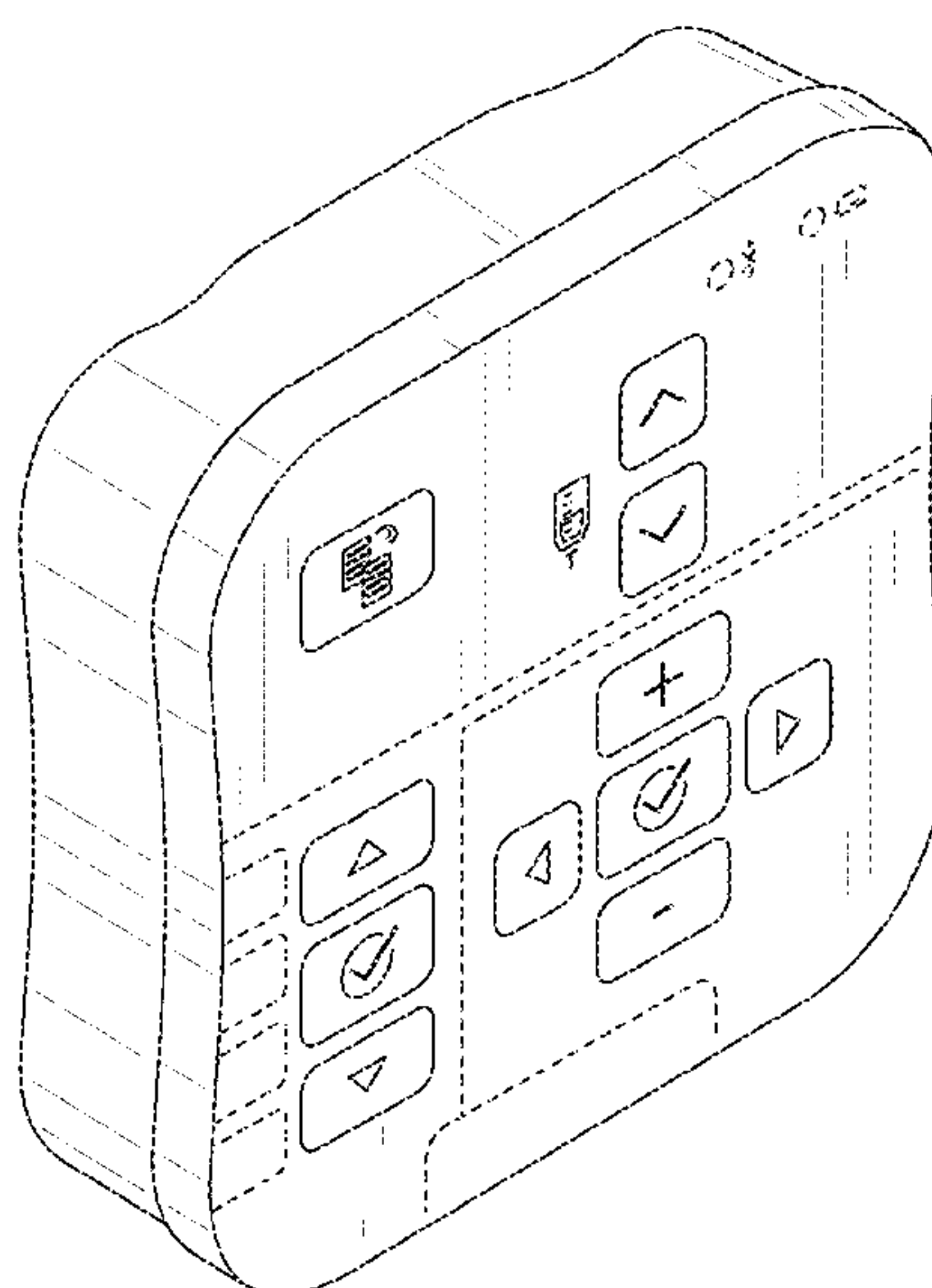
FIG. 5 is a top elevation view of FIG. 1, the bottom elevation view being a mirror image thereof;

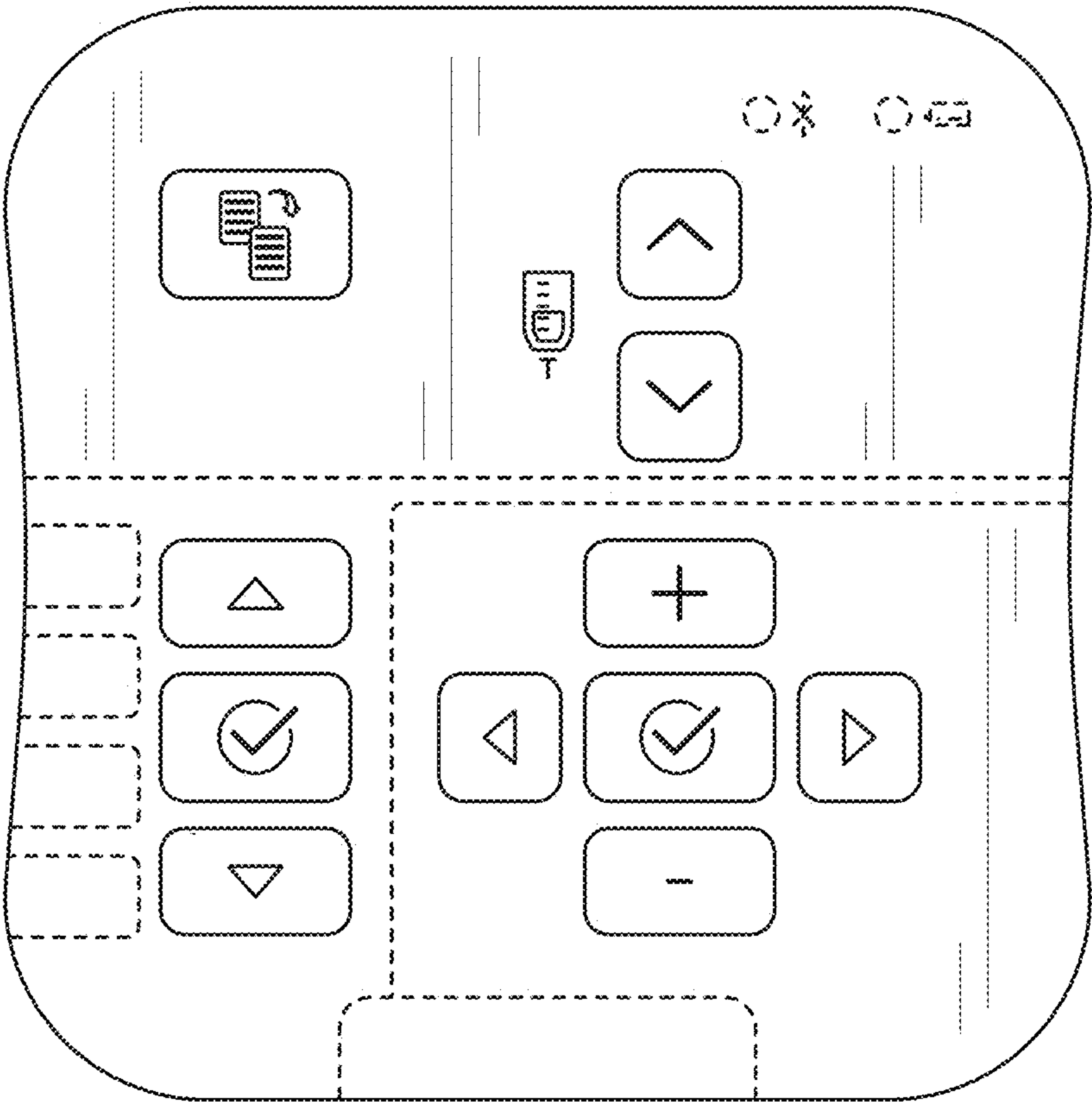

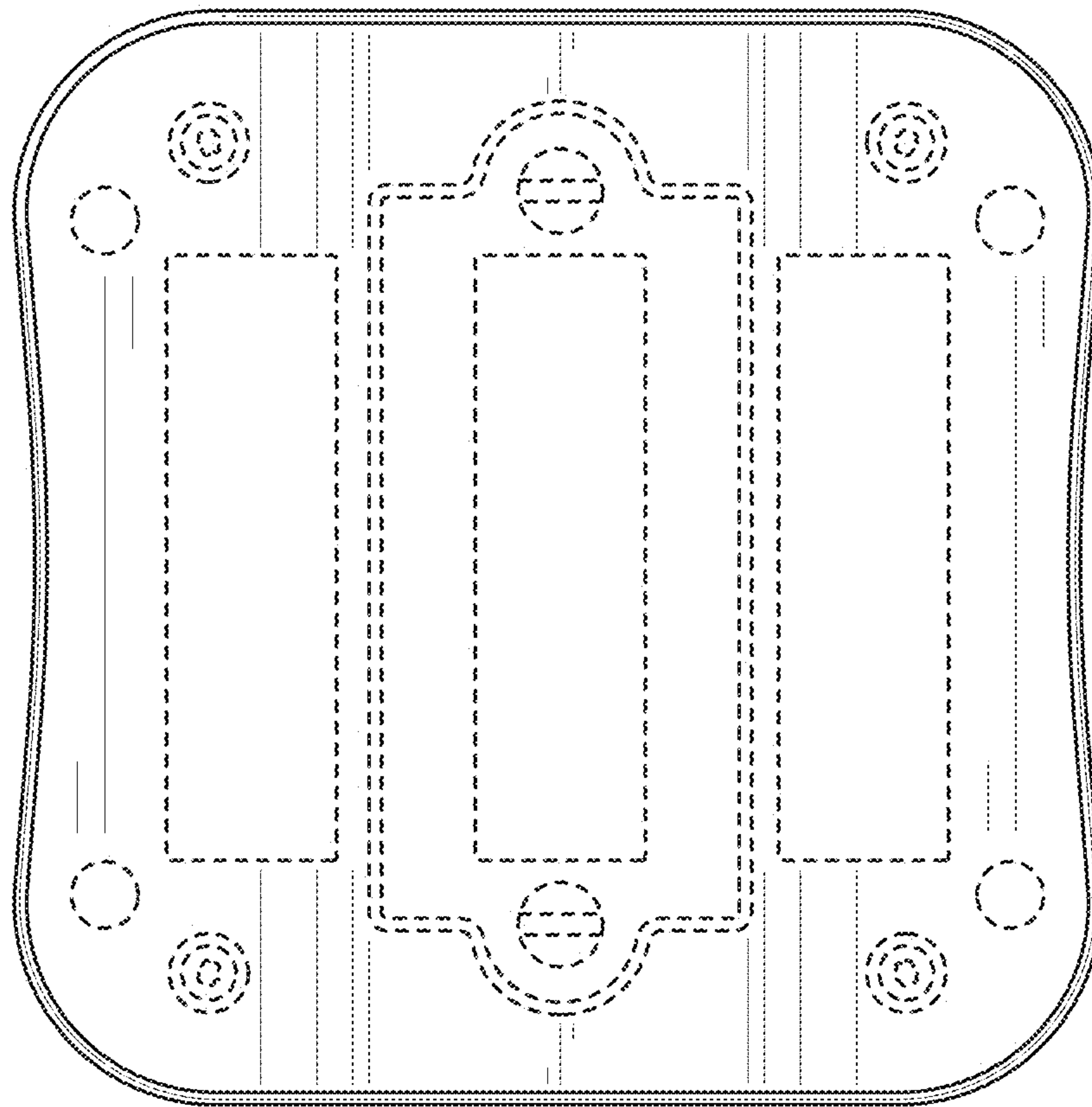

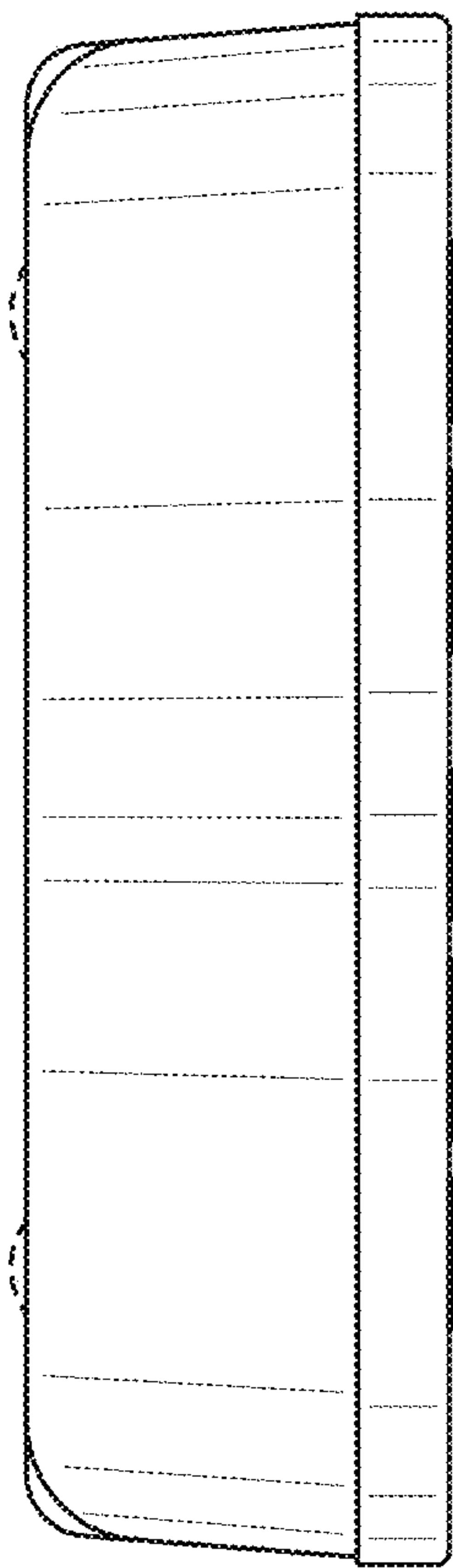

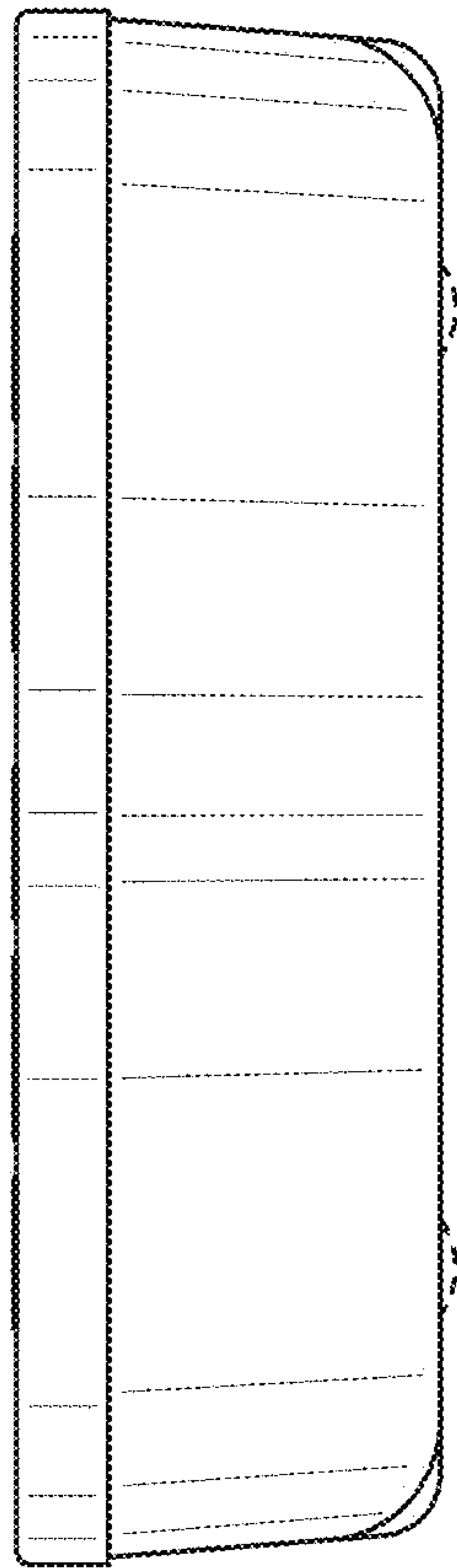

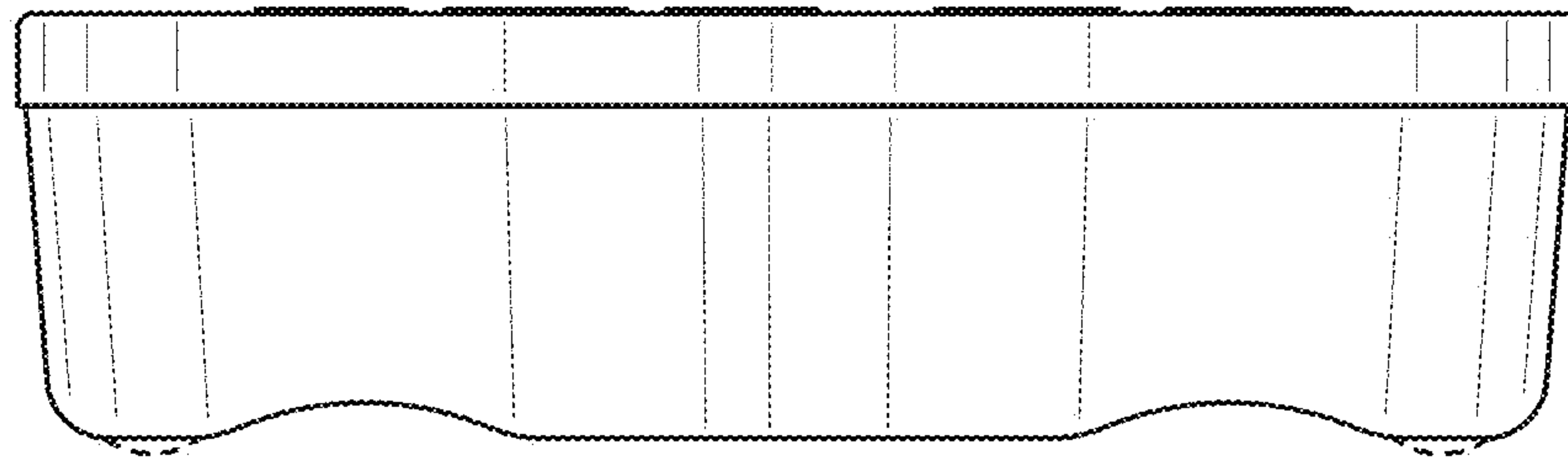

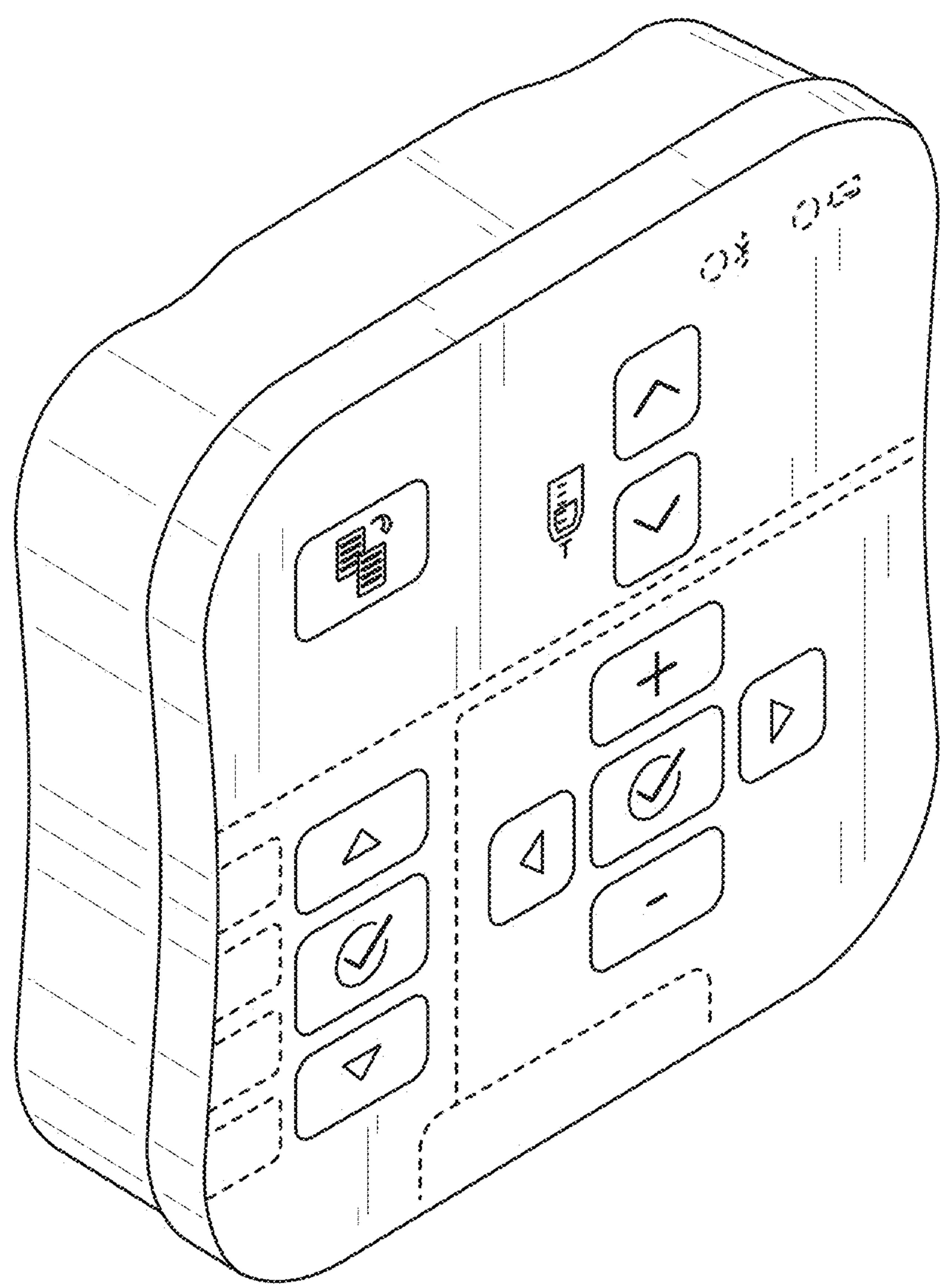

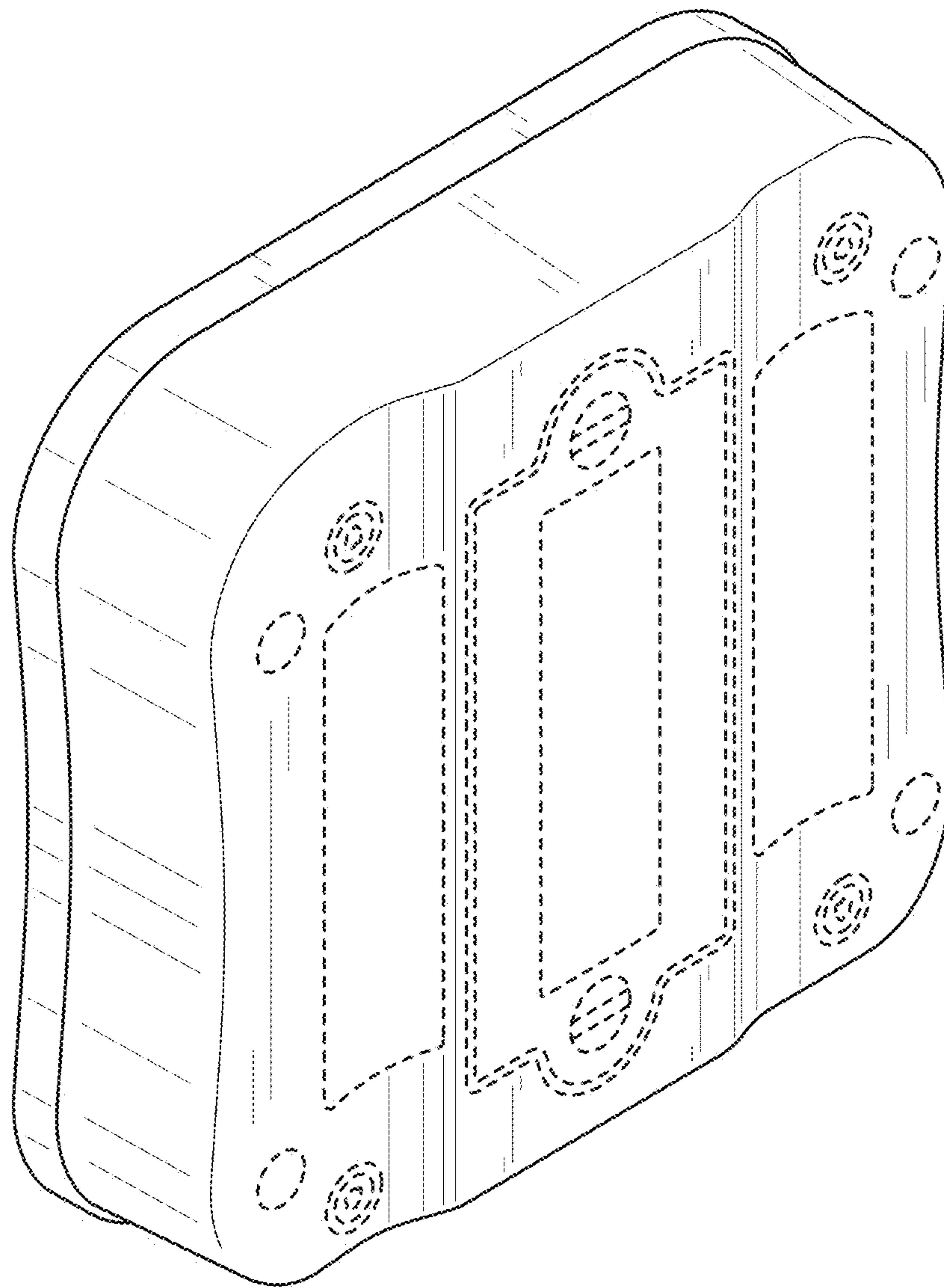
