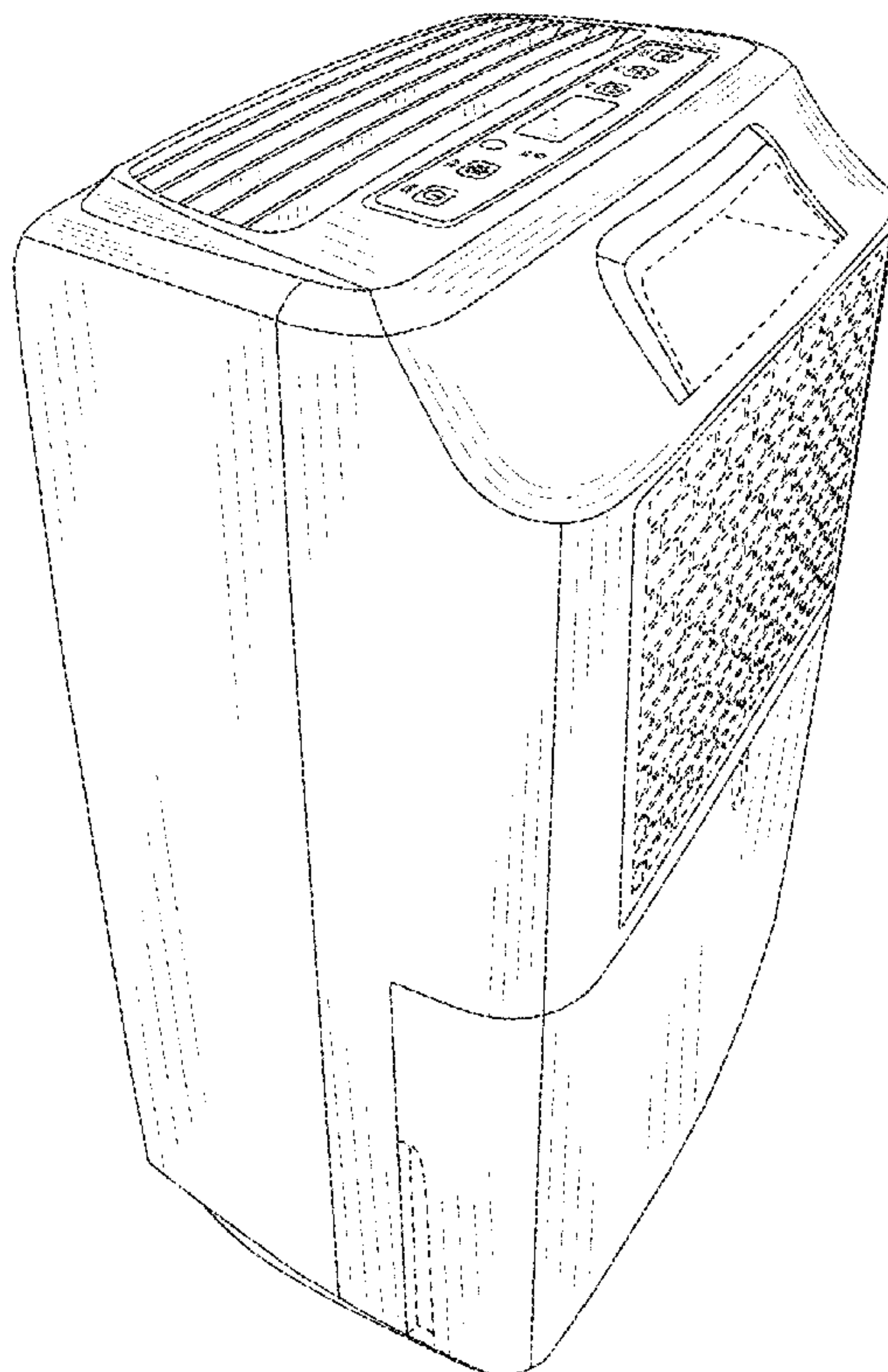
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a front, top and left side perspective view of a dehumidifier showing my new design;

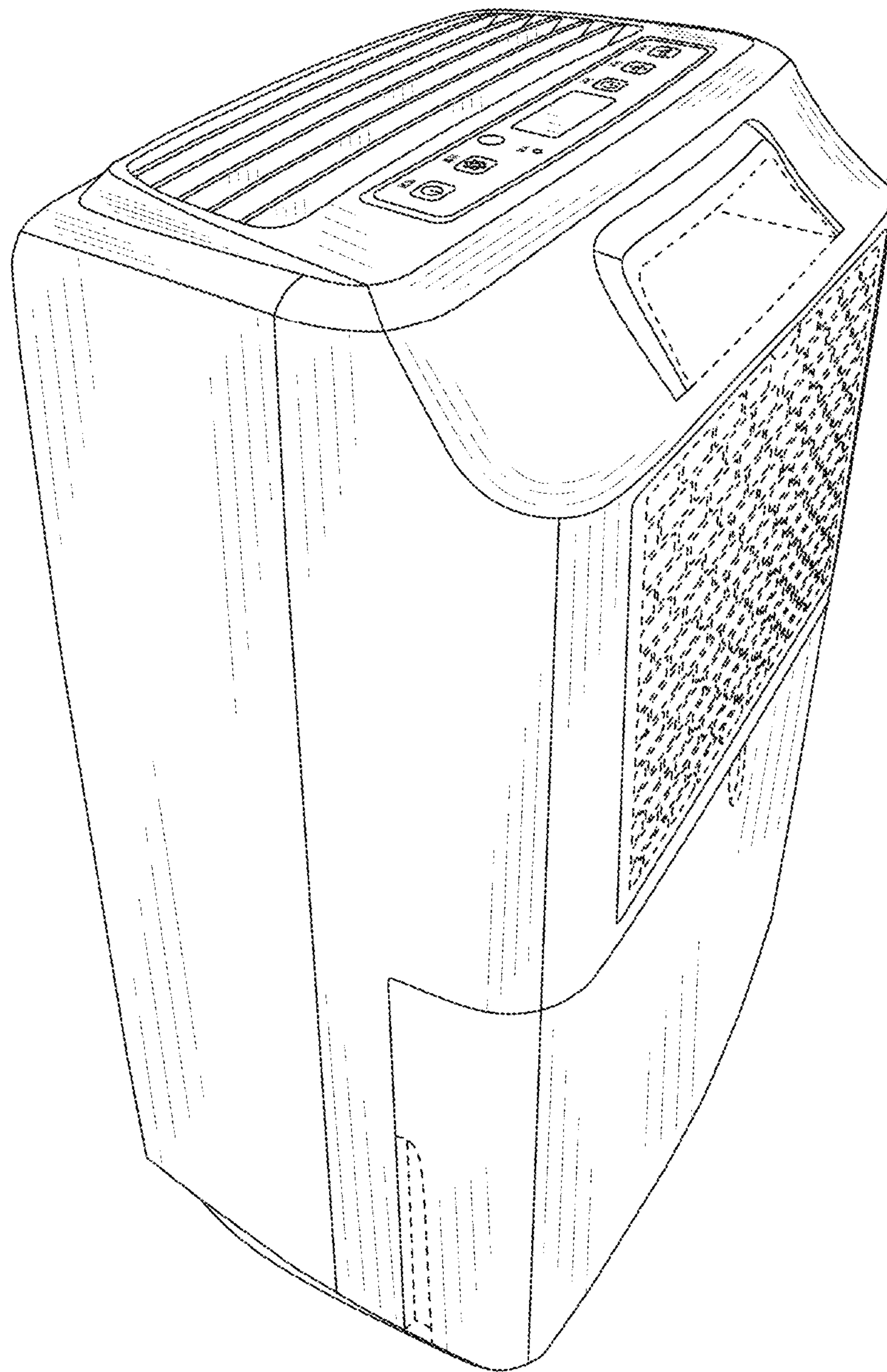

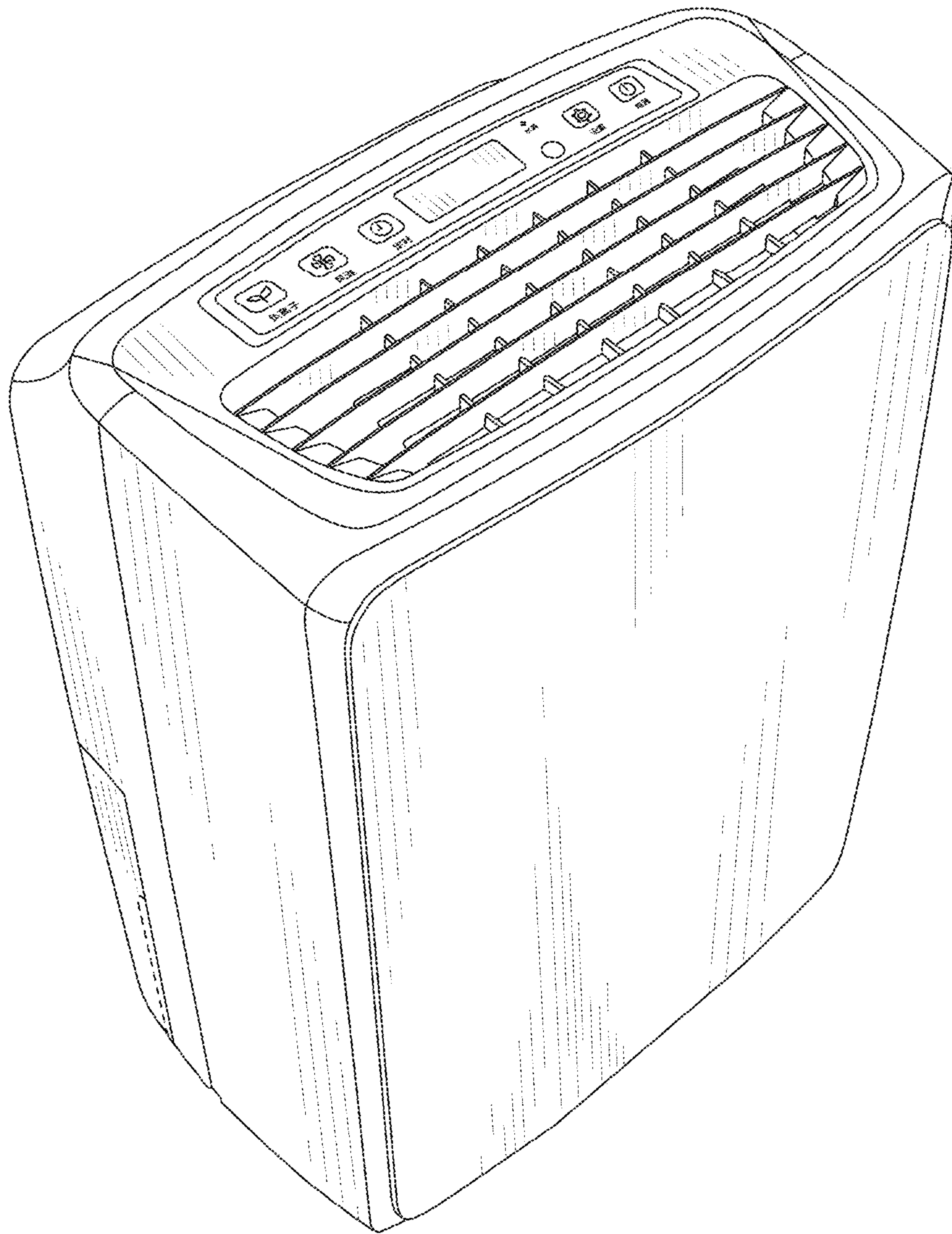

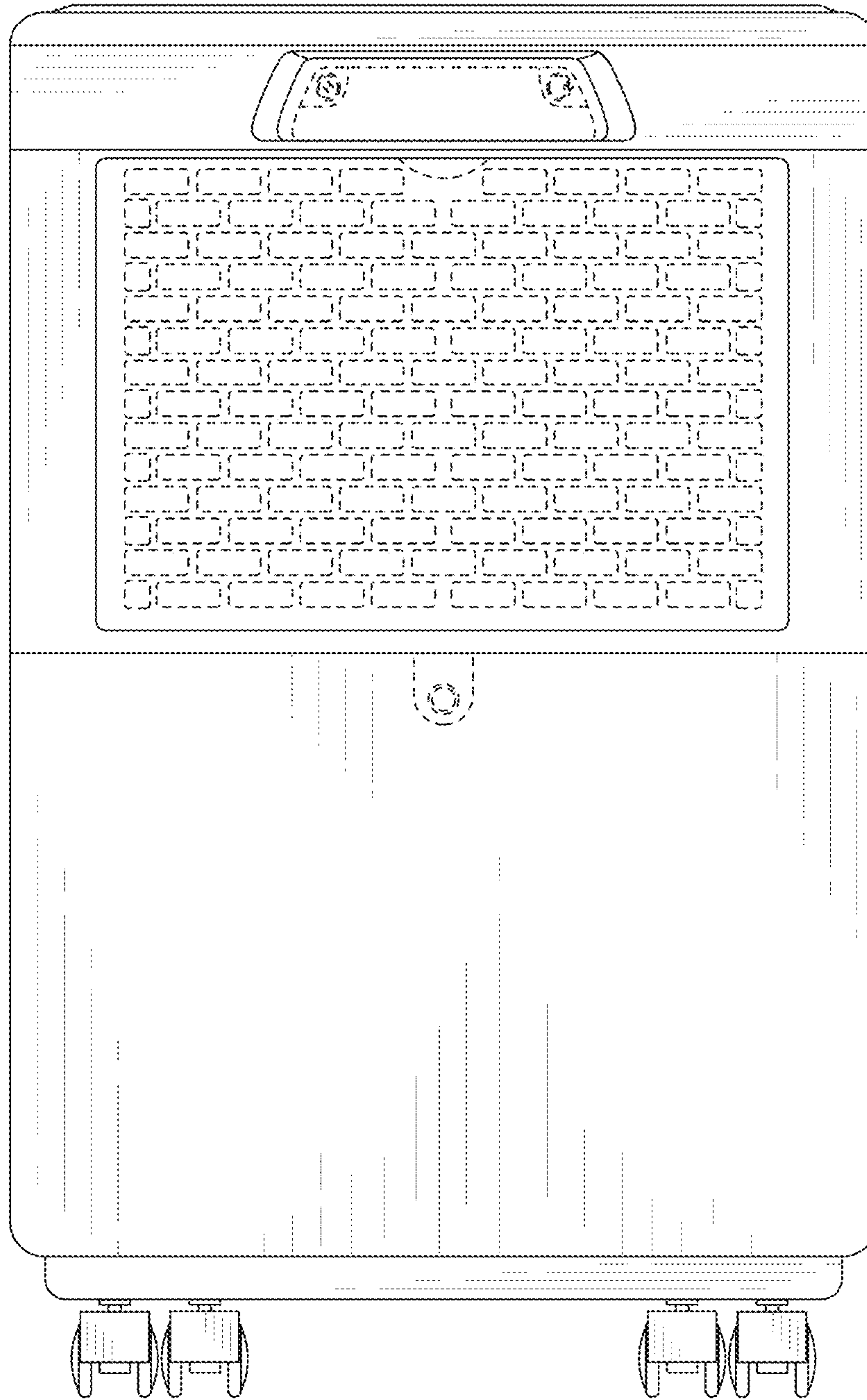

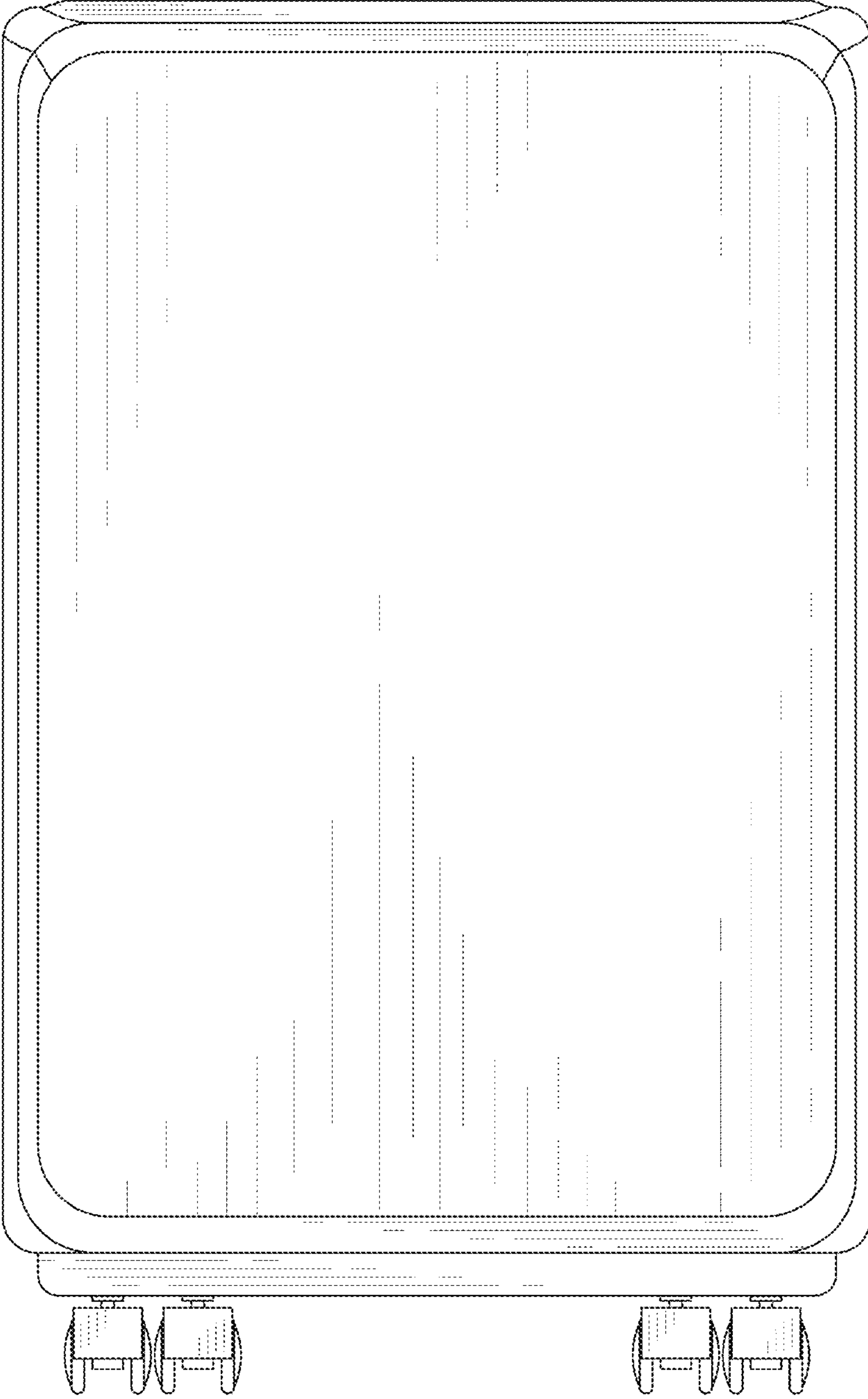

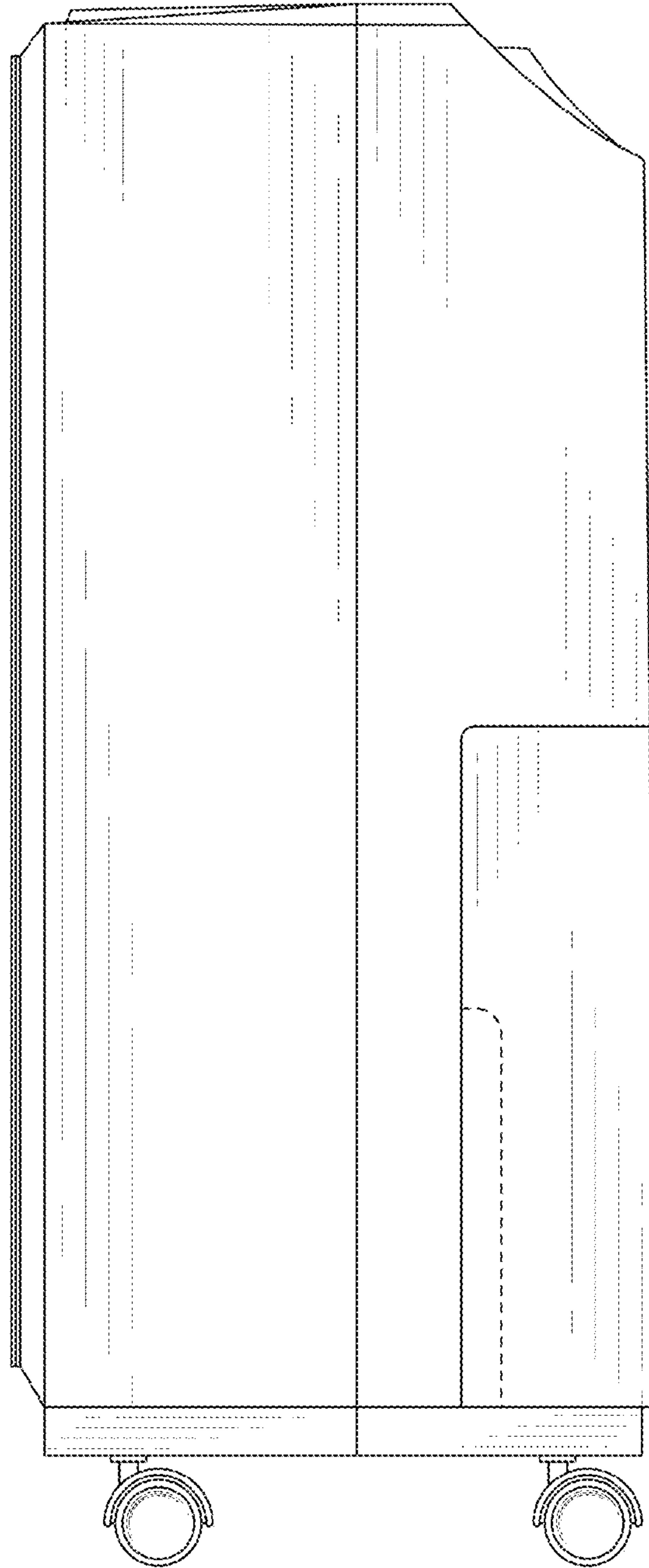

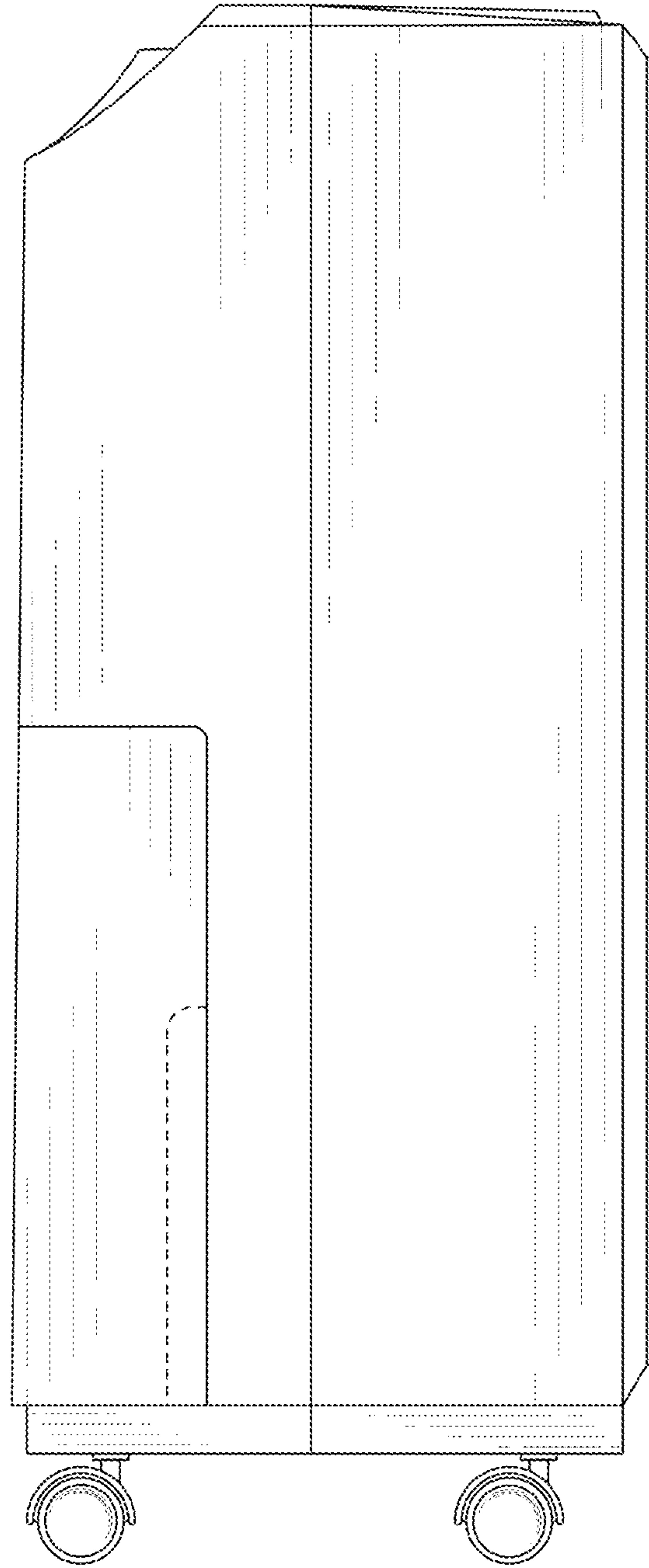

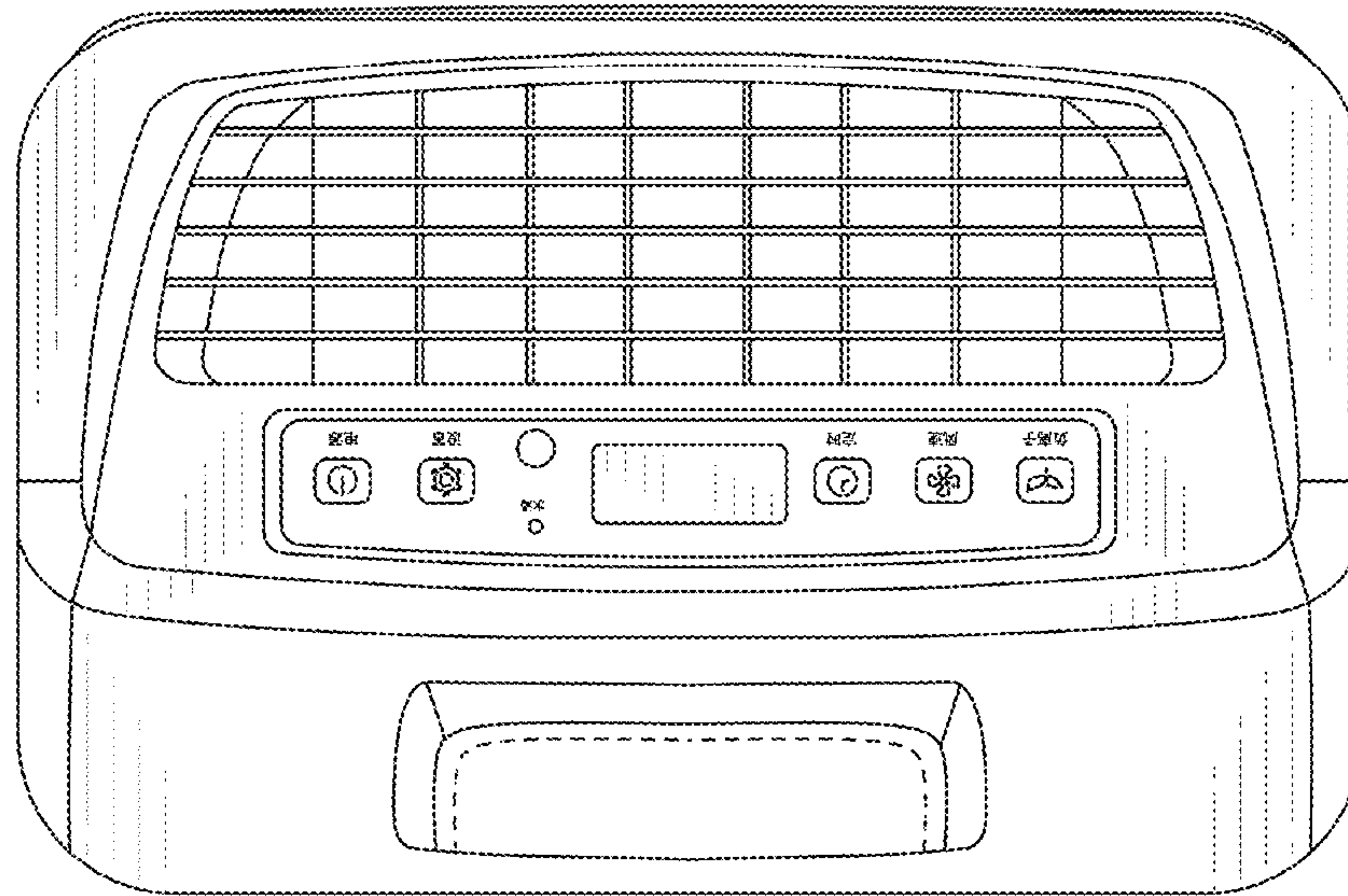

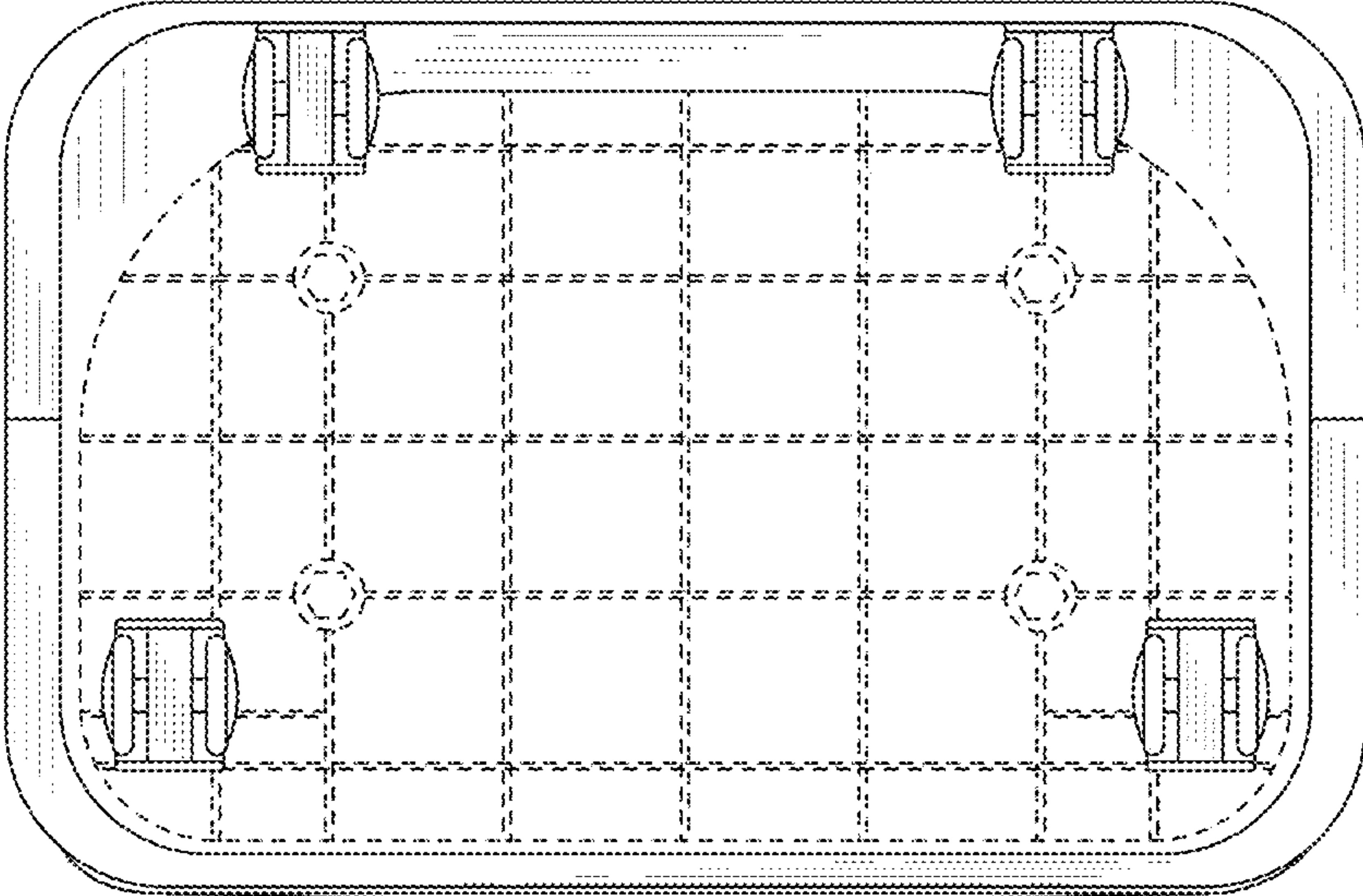
