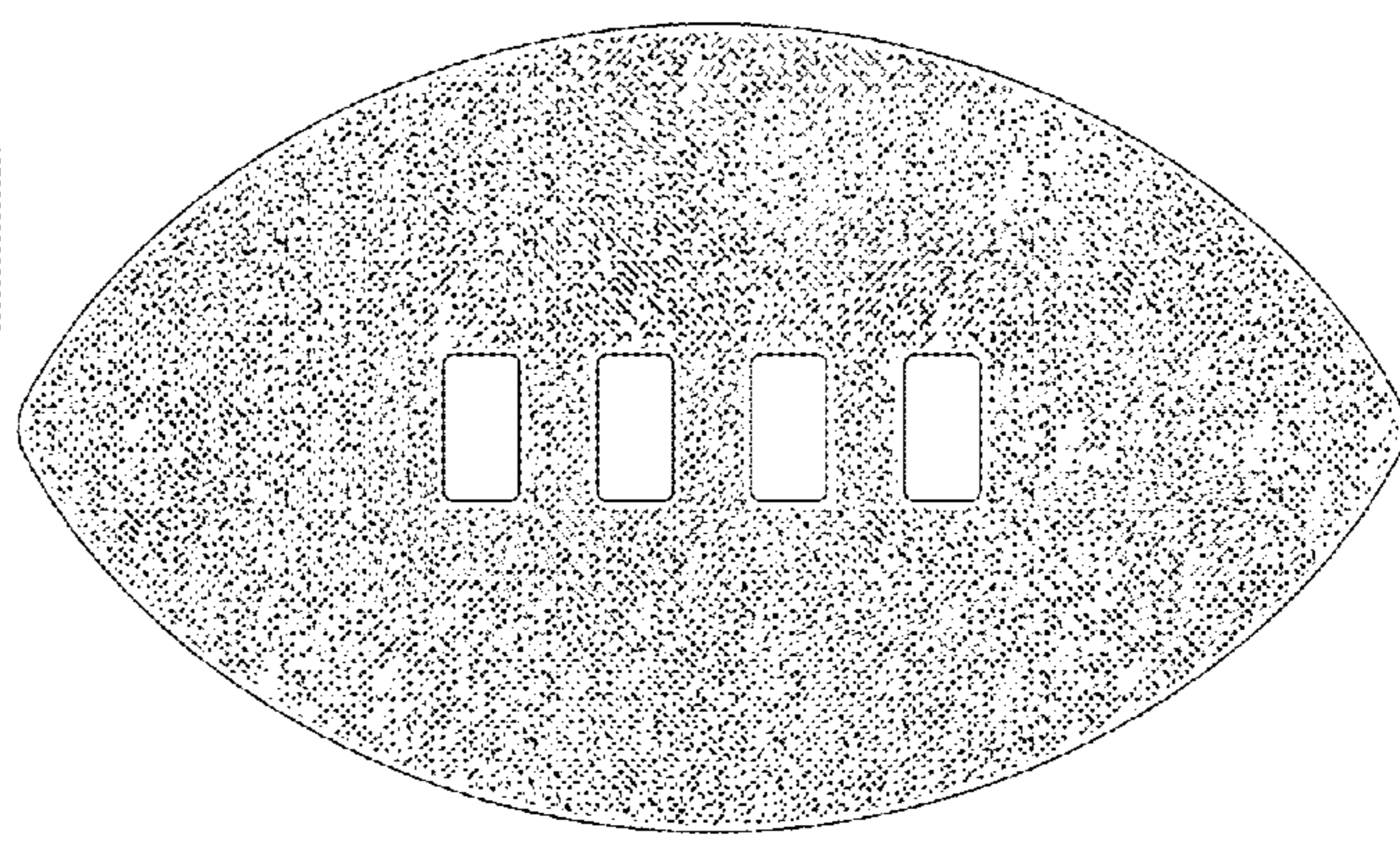
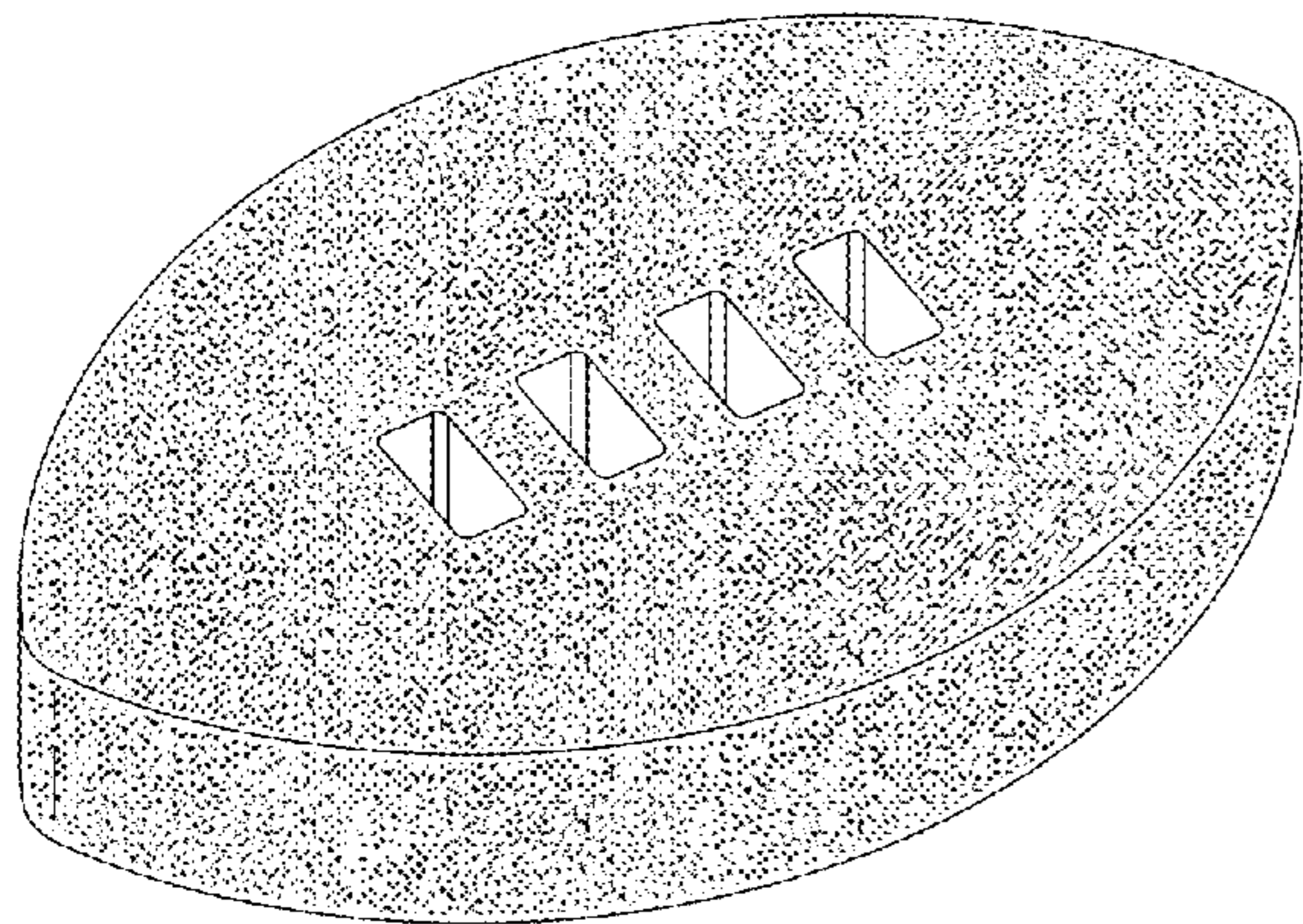
(57) **CLAIM**

The ornamental design for a formed potato piece, as shown.

DESCRIPTION

FIG. 1 is a perspective view of a formed potato piece embodying the new design;
FIG. 2 is a left side elevational view thereof;
FIG. 3 is a right side elevational view thereof;
FIG. 4 is a front elevational view thereof;
FIG. 5 is a rear elevational view thereof;
FIG. 6 is a top plan view thereof; and,
FIG. 7 is a bottom plan view thereof.
The stippled shaded areas and the other portions of the formed potato piece claimed represent a contrasting appearance.

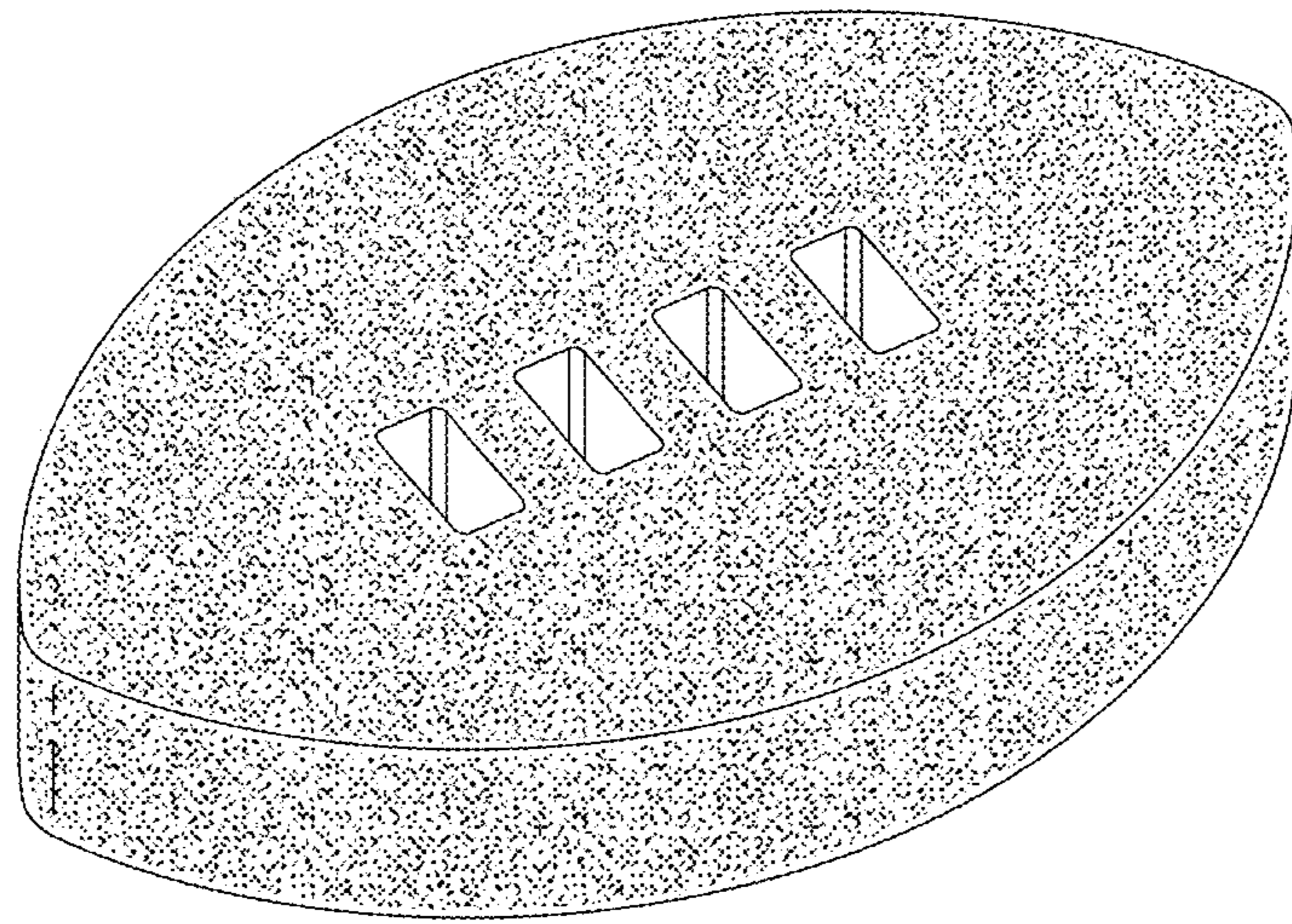

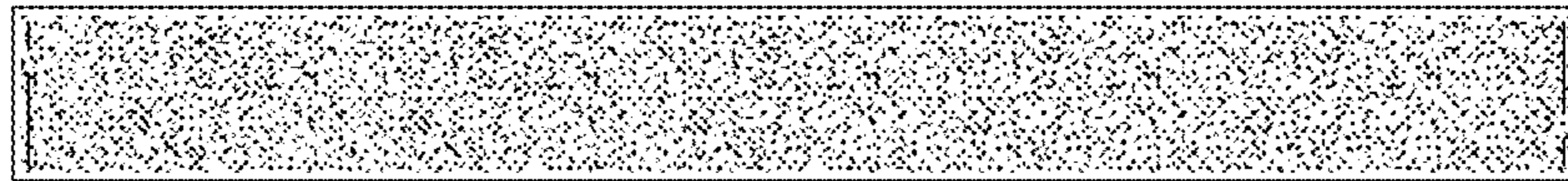

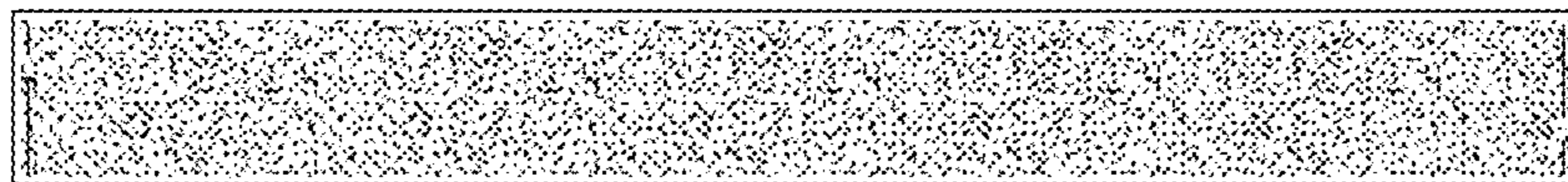

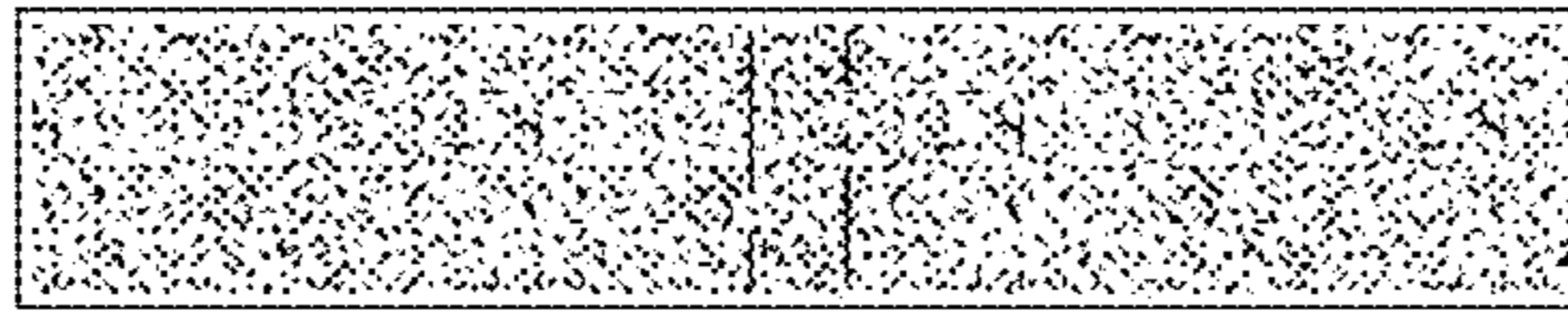

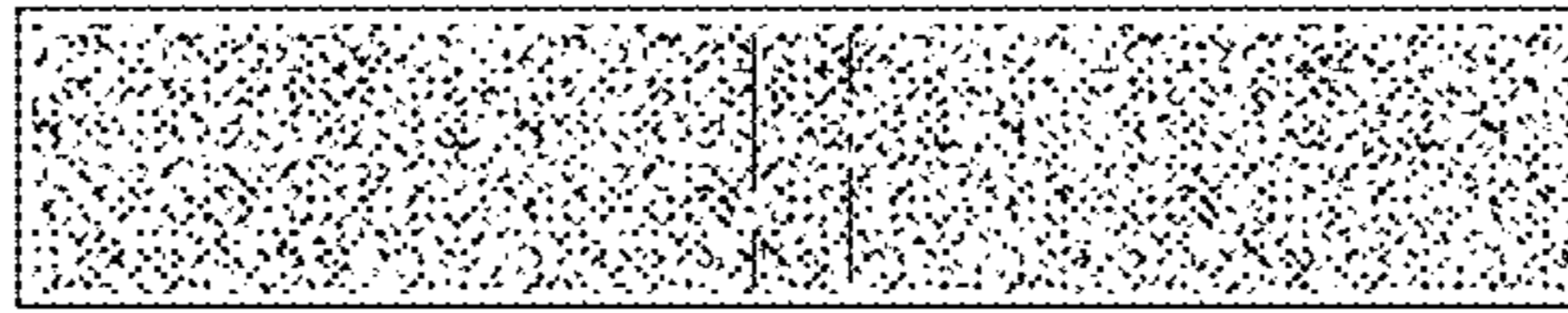

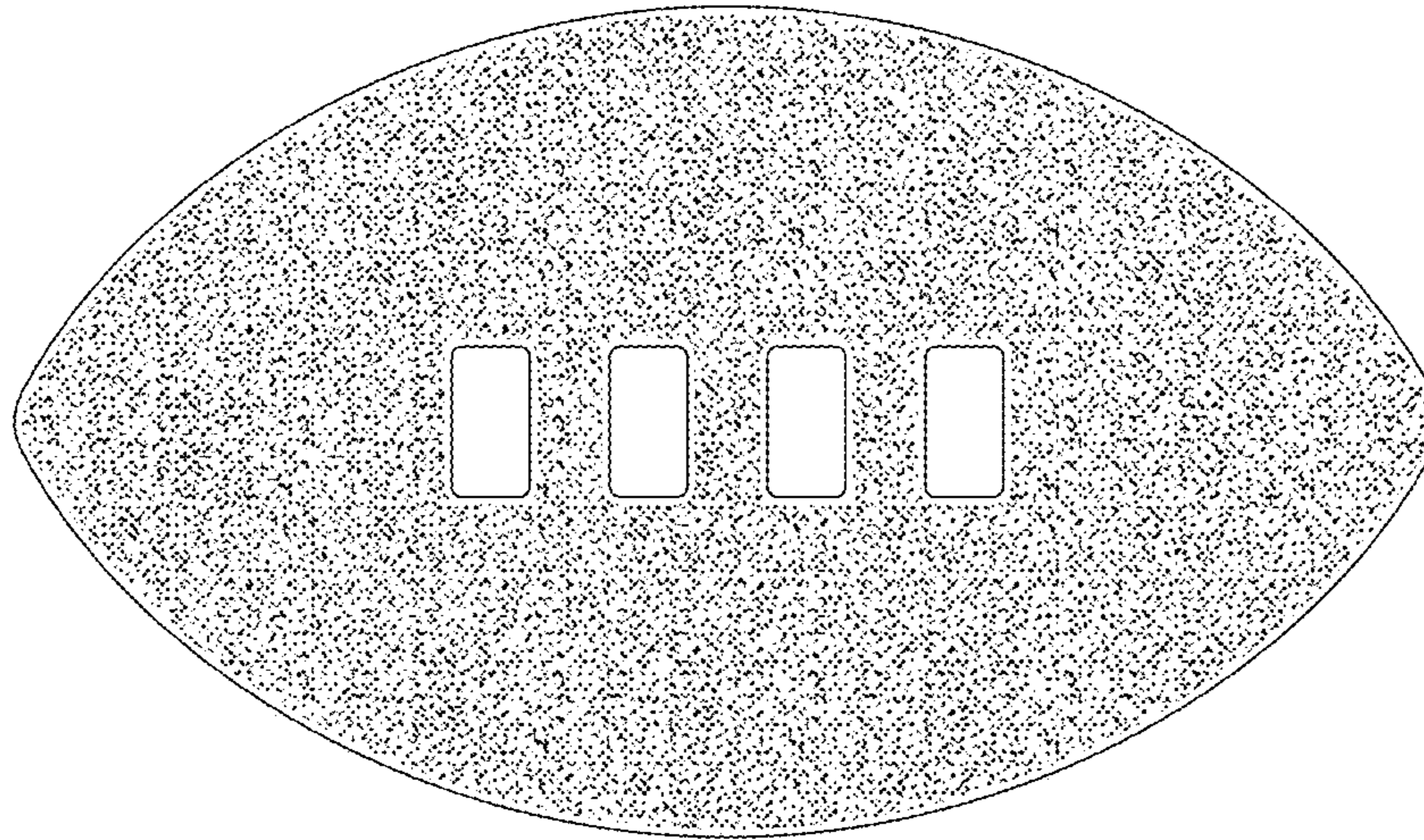

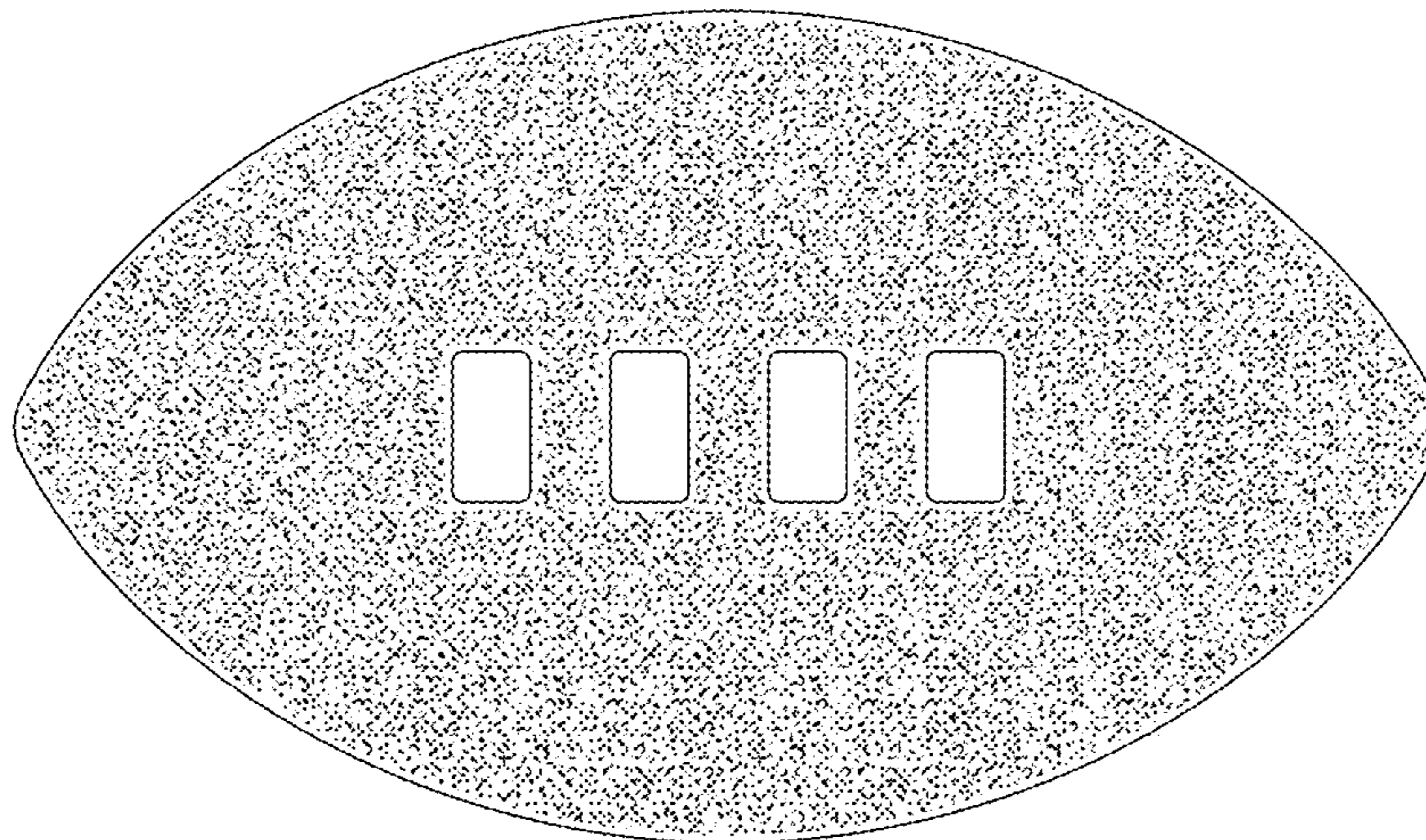
