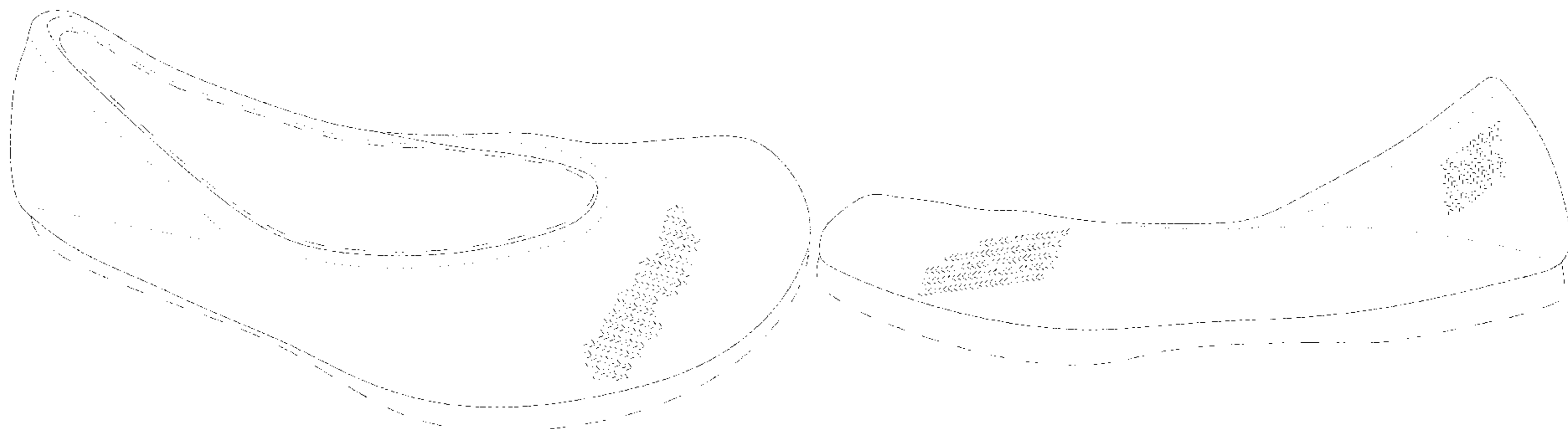
(57) **CLAIM**

We claim the ornamental design for a shoe upper, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a shoe upper showing the new design.
FIG. 2 is a top view of the shoe upper.
FIG. 3 is a lateral side view of the shoe upper.
FIG. 4 is a medial side view of the shoe upper.
FIG. 5 is a front view of the shoe upper.
FIG. 6 is a rear view of the shoe upper; and,
FIG. 7 is a bottom (sole) view of the shoe upper.
The dashed lines within the top opening of the shoe upper show unclaimed boundaries of the claimed design. The broken lines showing the sole and vertical shape at the heel of the shoe upper form no part of the claimed design. The short broken lines on the shoe upper depict stitching, which forms no part of the claimed design.

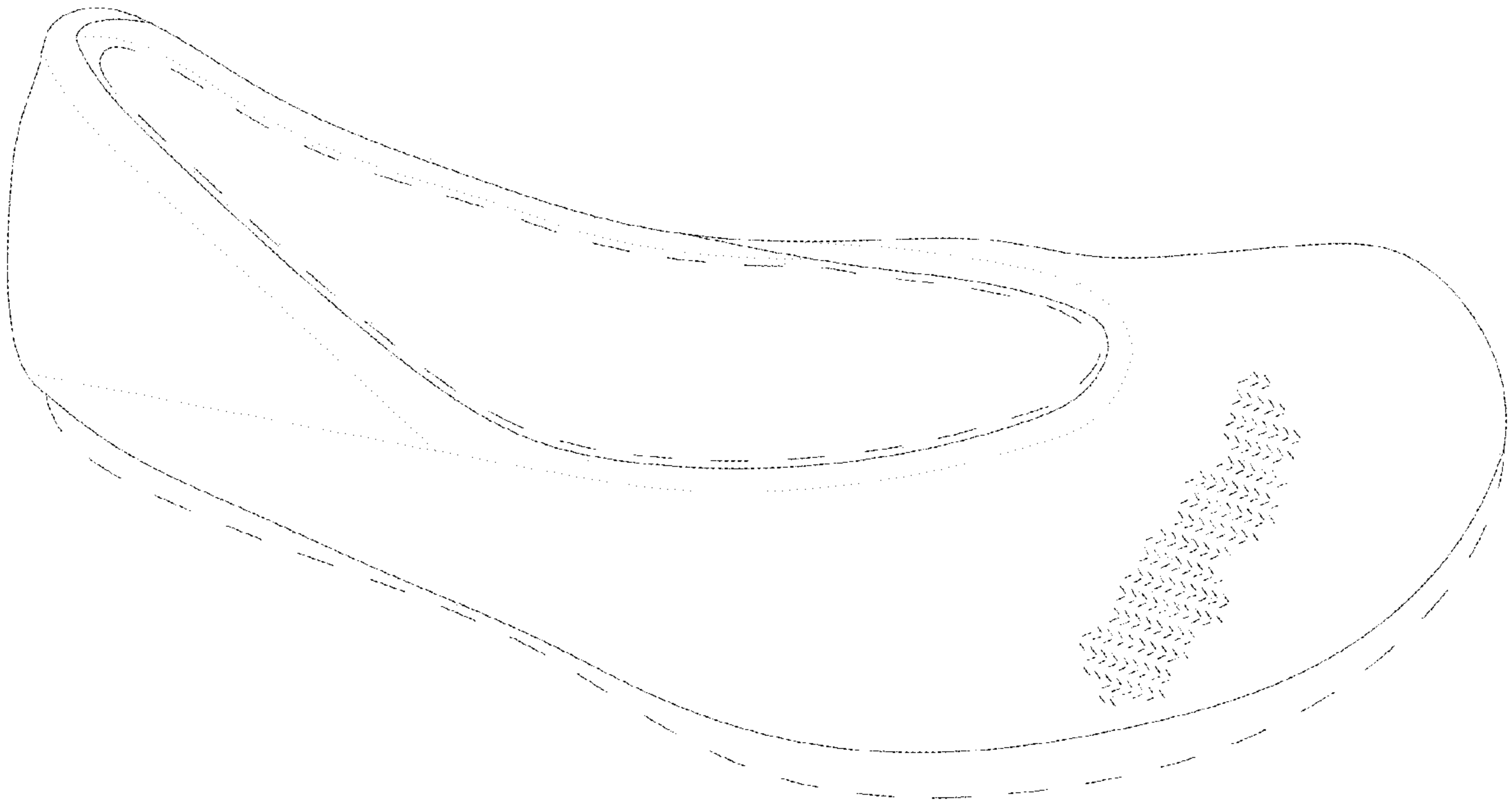

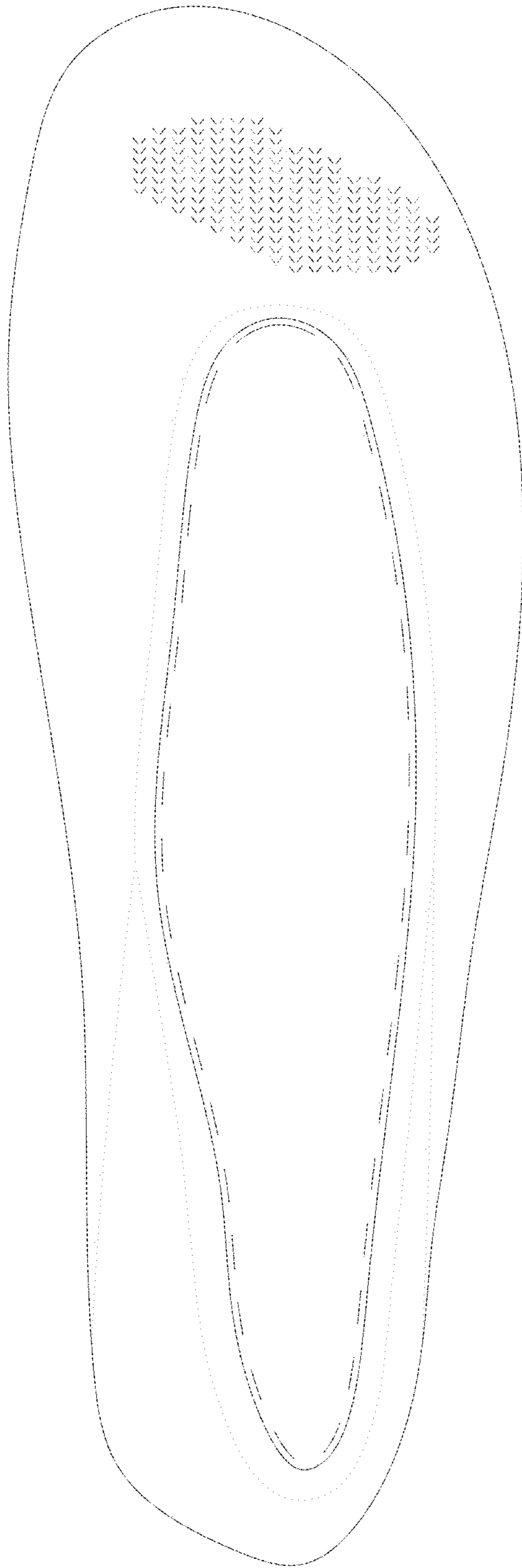

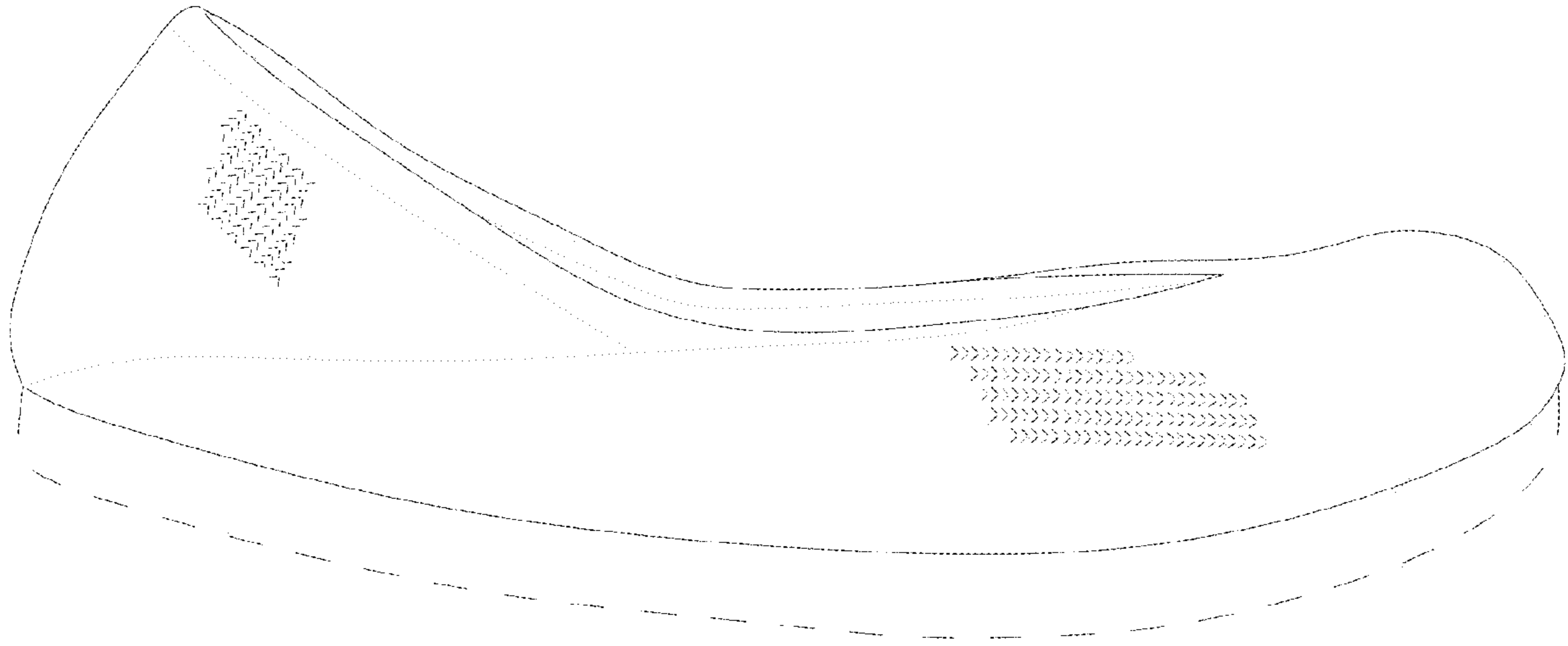

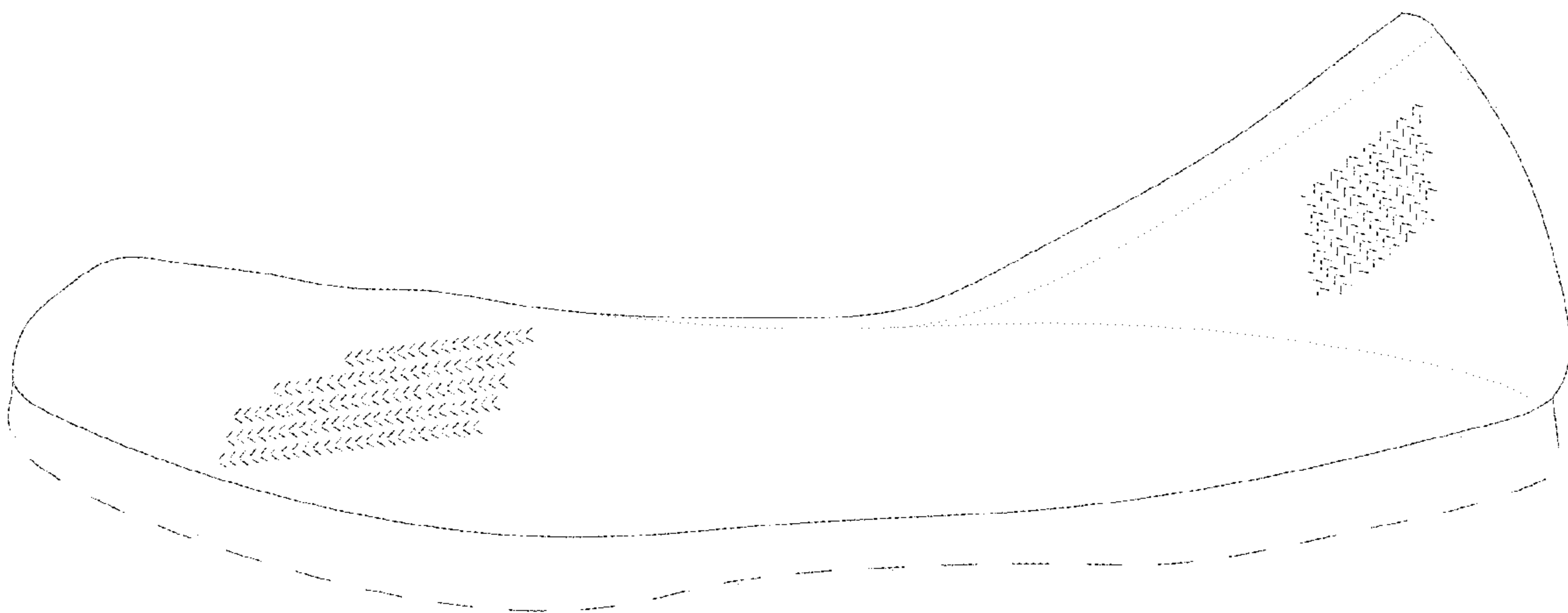

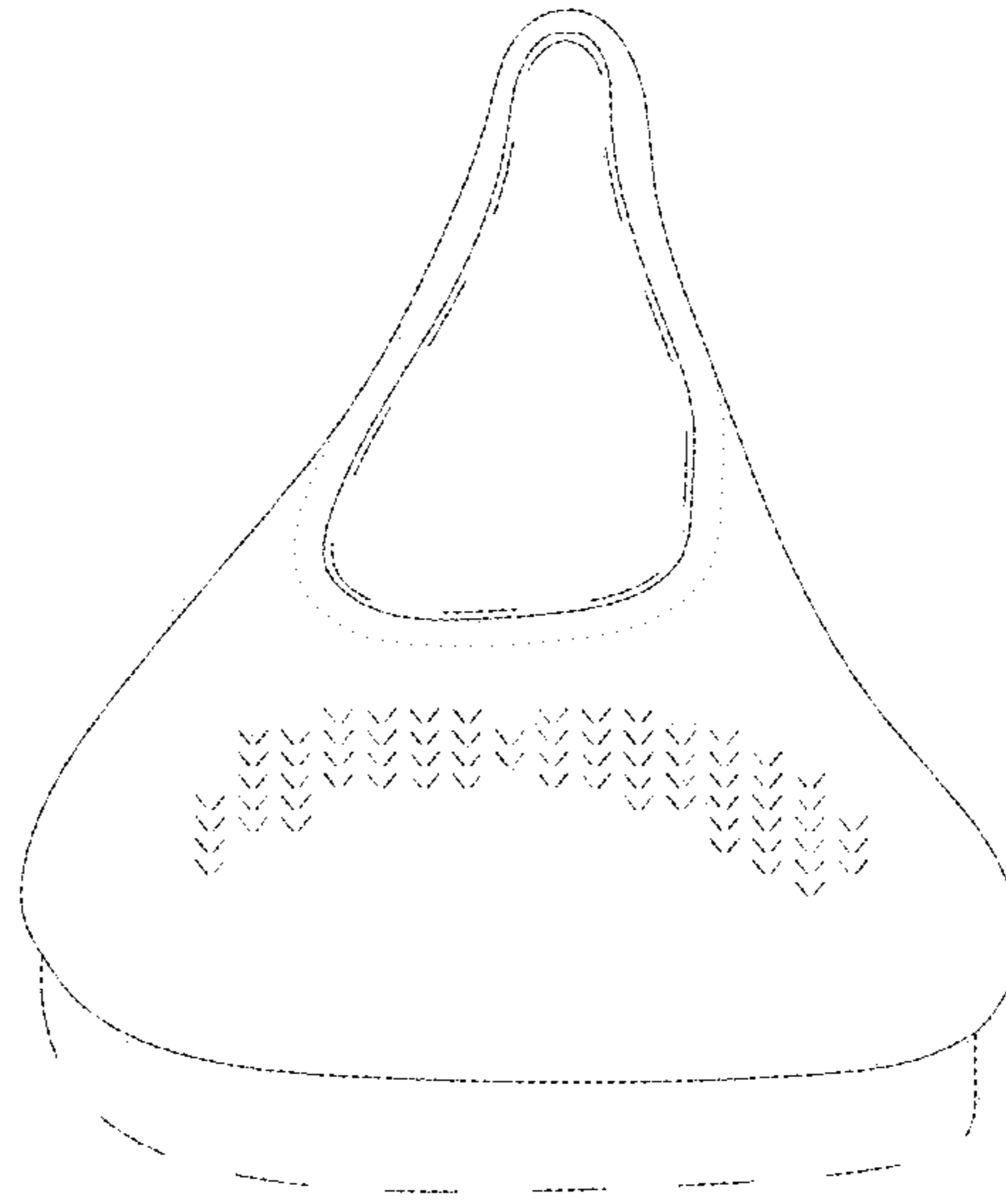

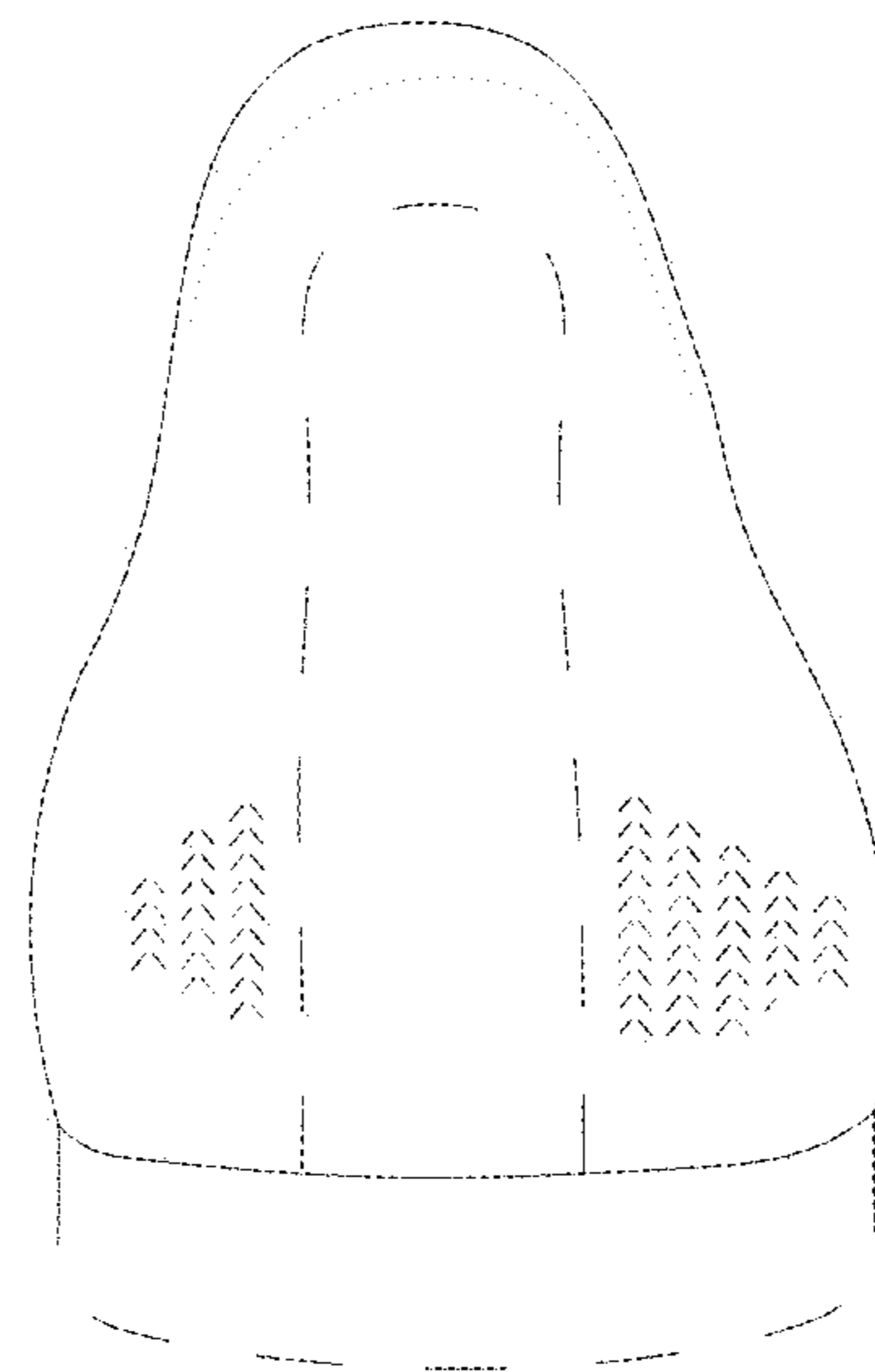

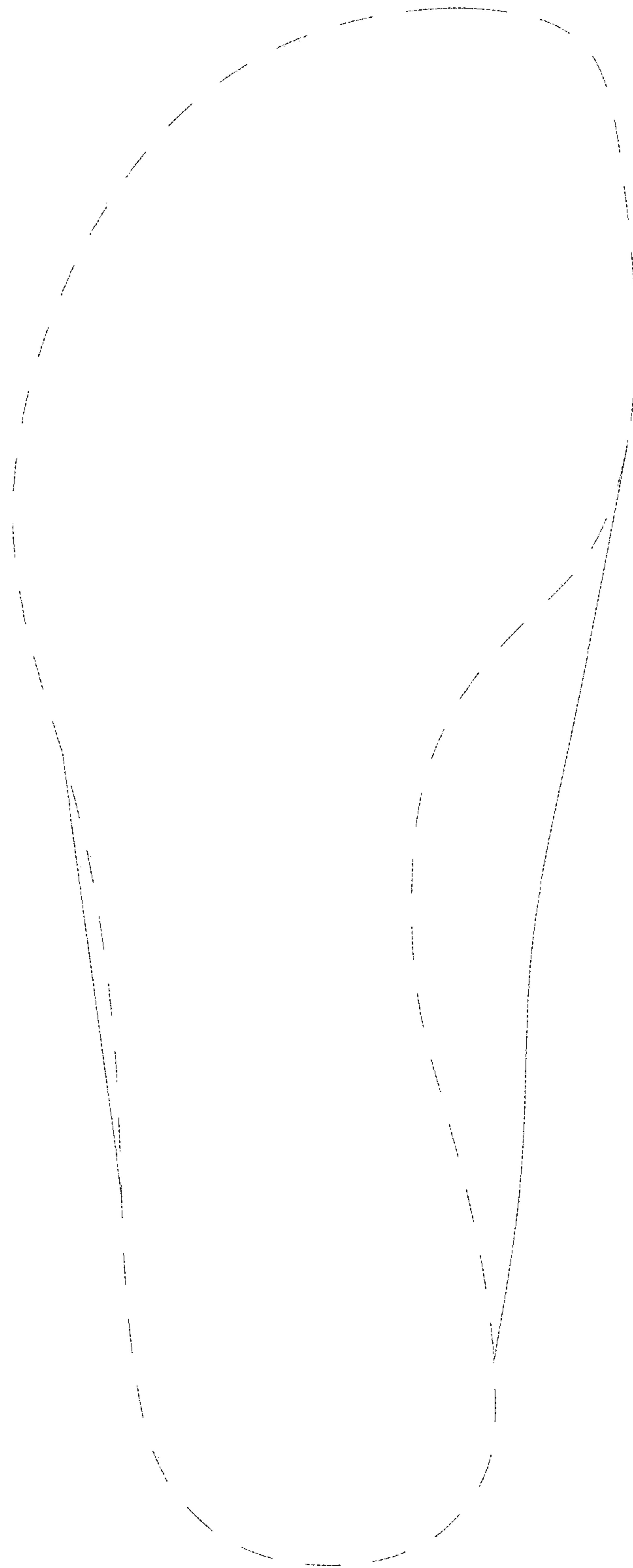
