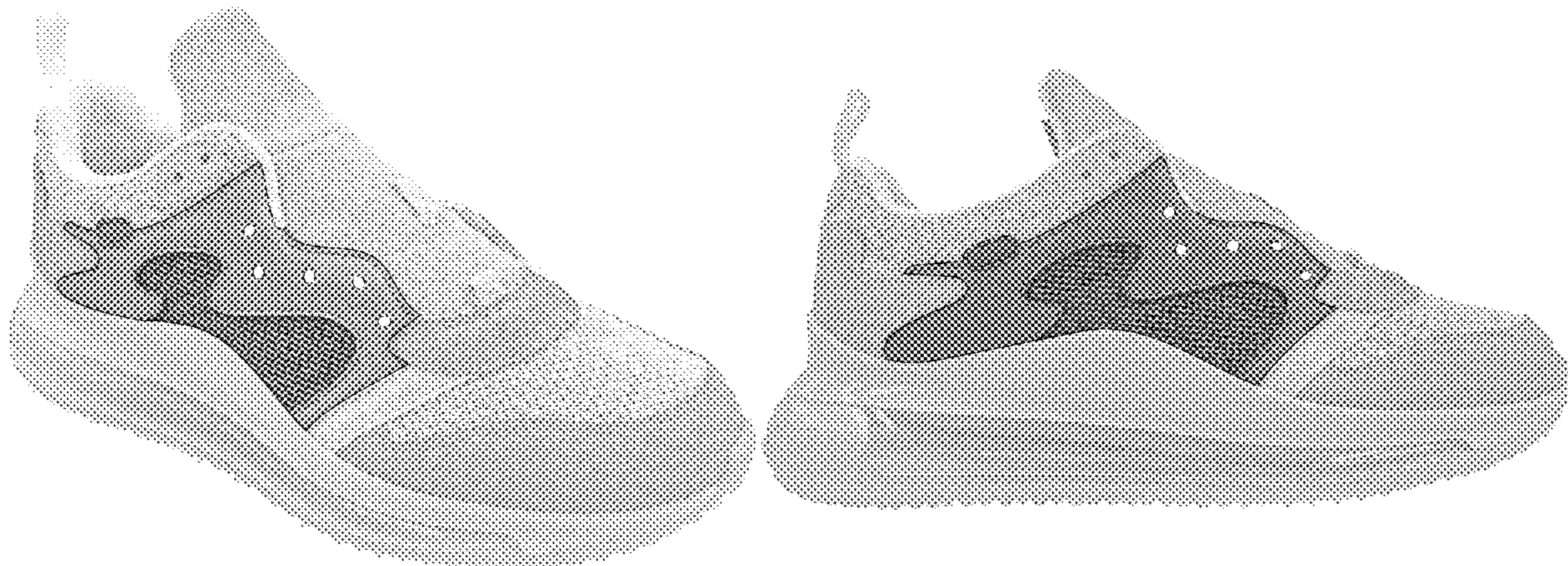

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing my new design; and  
FIG. 2 is a side view thereof; and,  
FIG. 3 is an enlarged view of the claimed portion as shown in FIG. 2 with environment removed for clarity purposes. The lighter grey portions are for the purposes of illustrating environment and form no part of the claimed design. The five unshaded broken line circles within the photographic area represent eyelets which form no part of the claimed design. The broken line immediately adjacent to the dark grey photographic area represents the bounds of the claimed design and forms no part thereof.

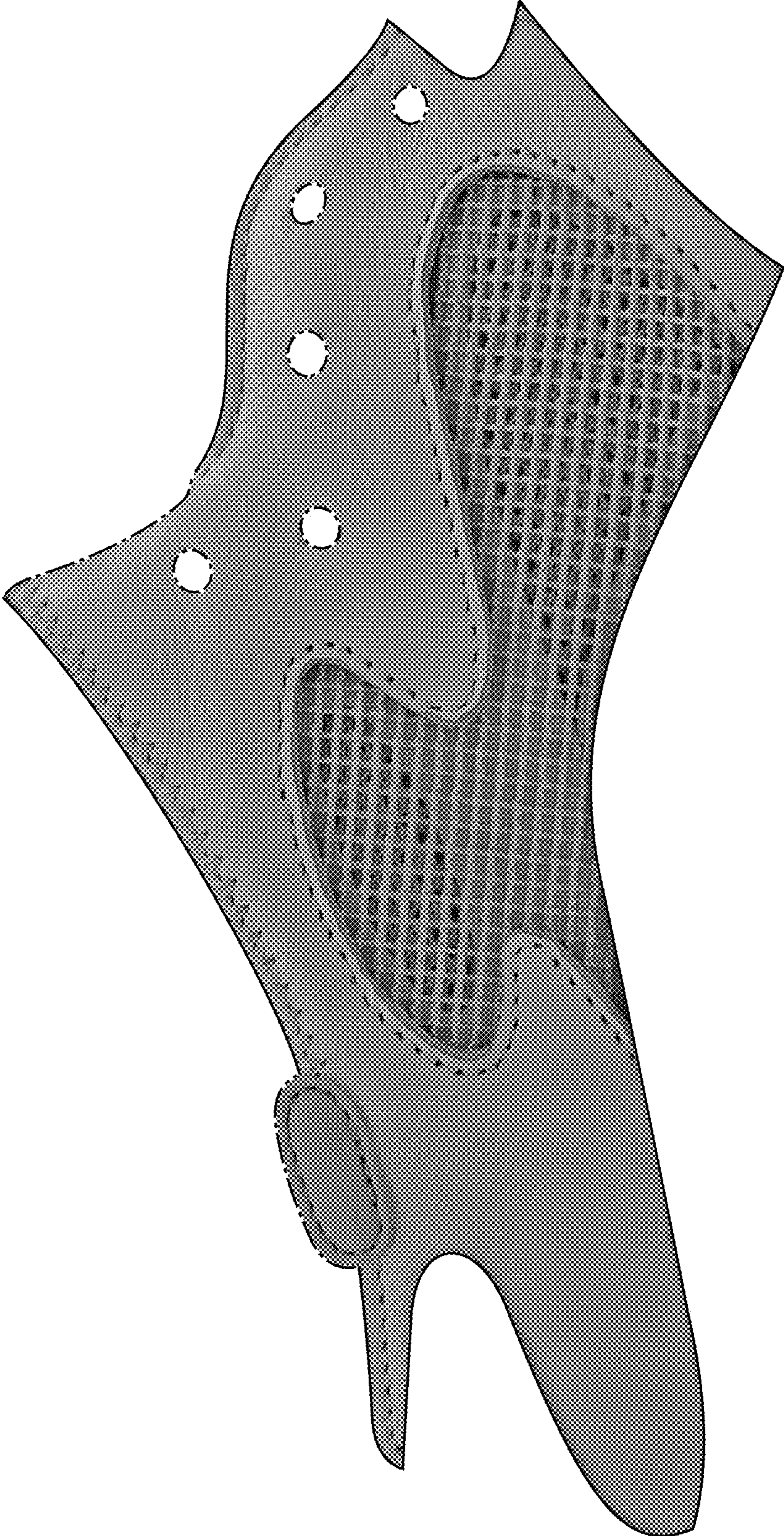
