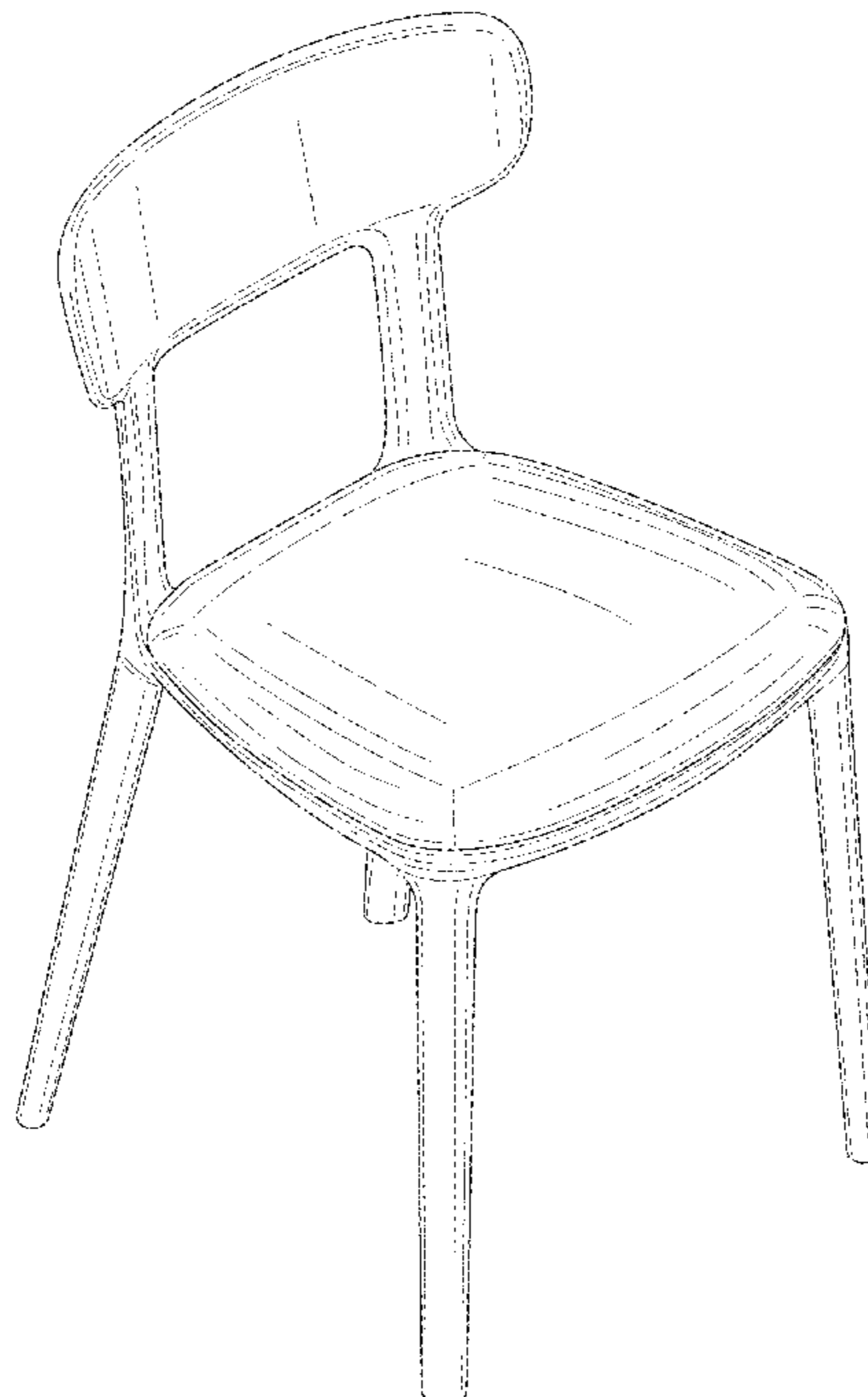
(57) **CLAIM**

The ornamental design for a seat, as shown and described.

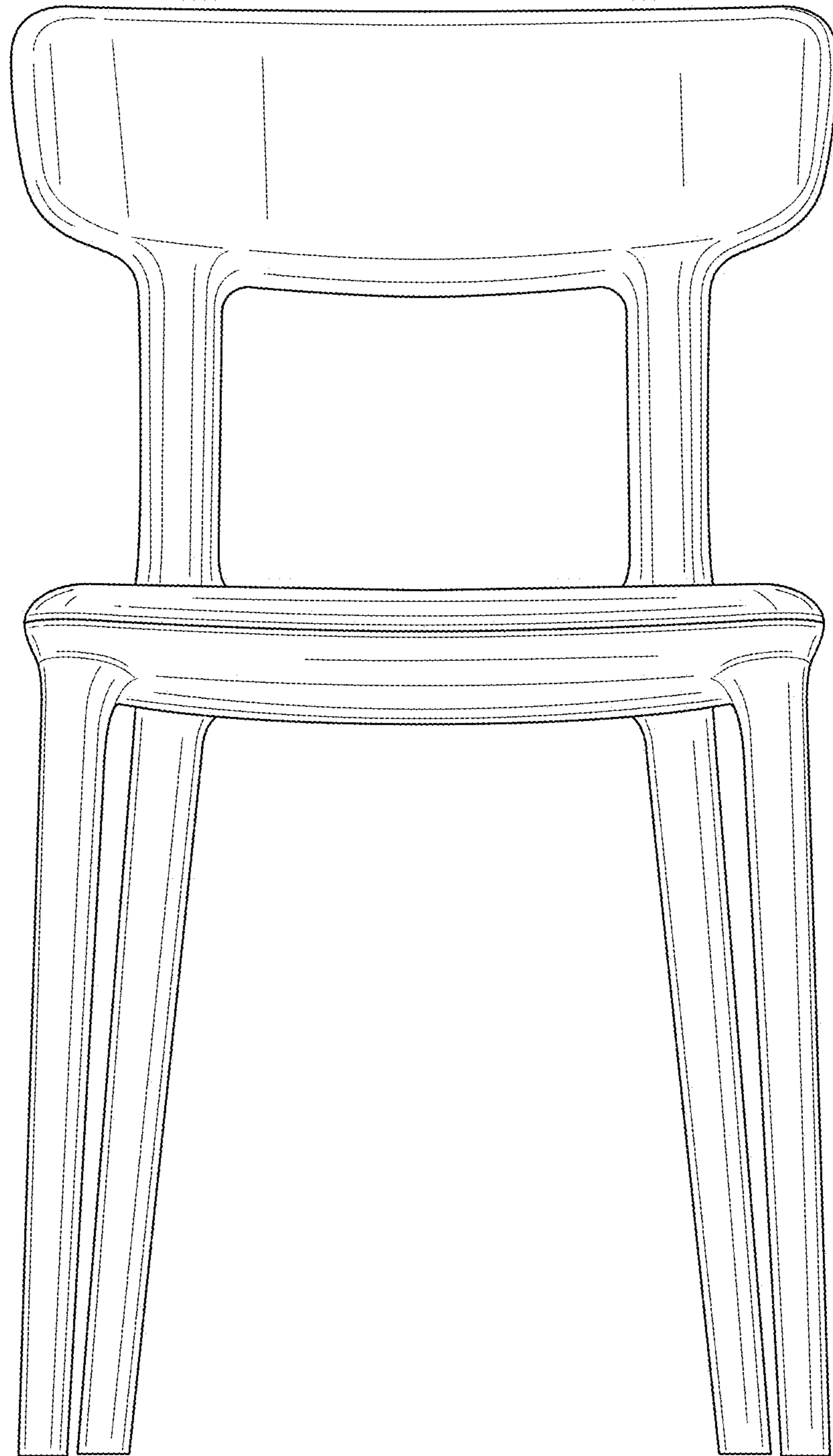
DESCRIPTION

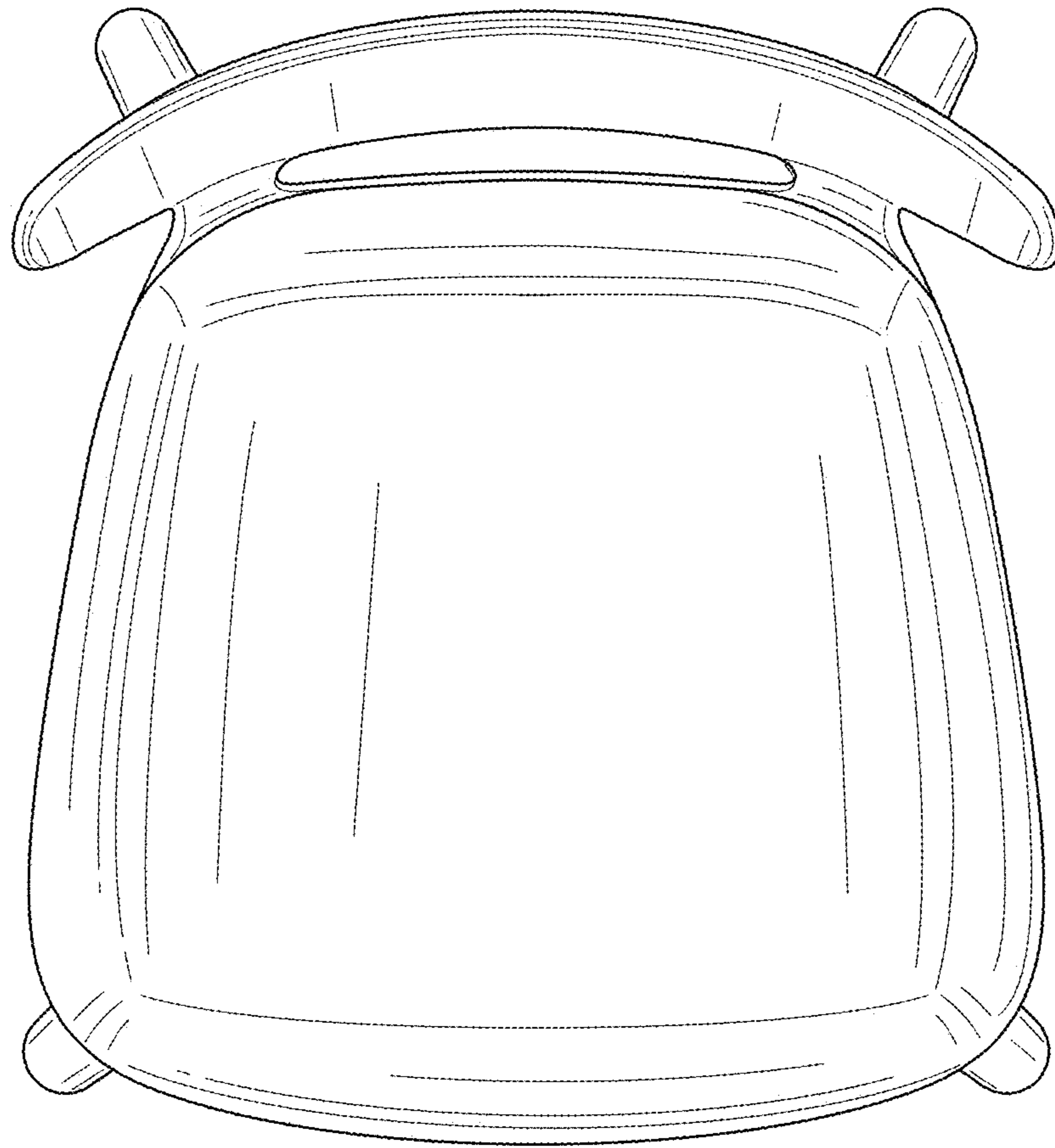

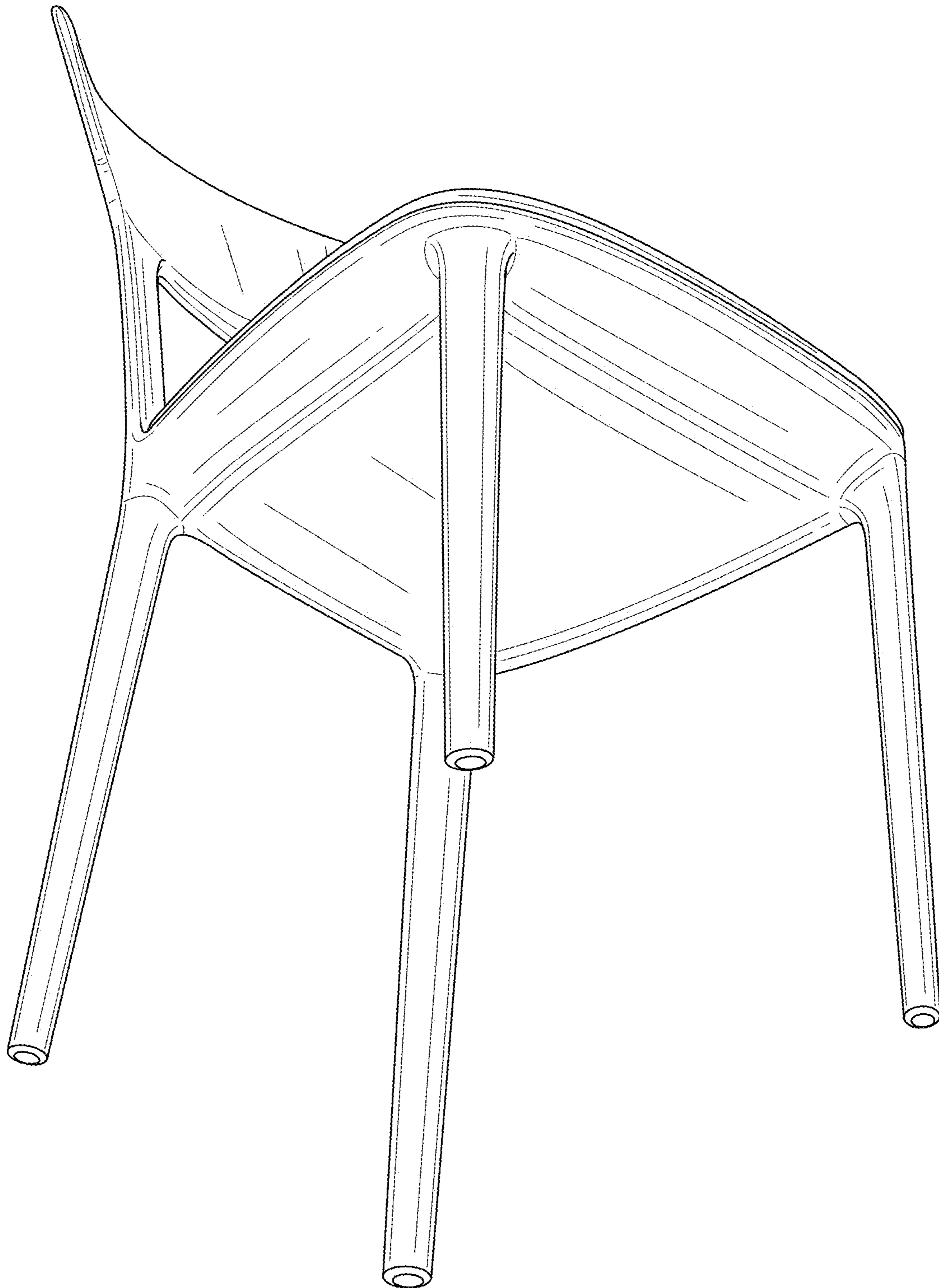

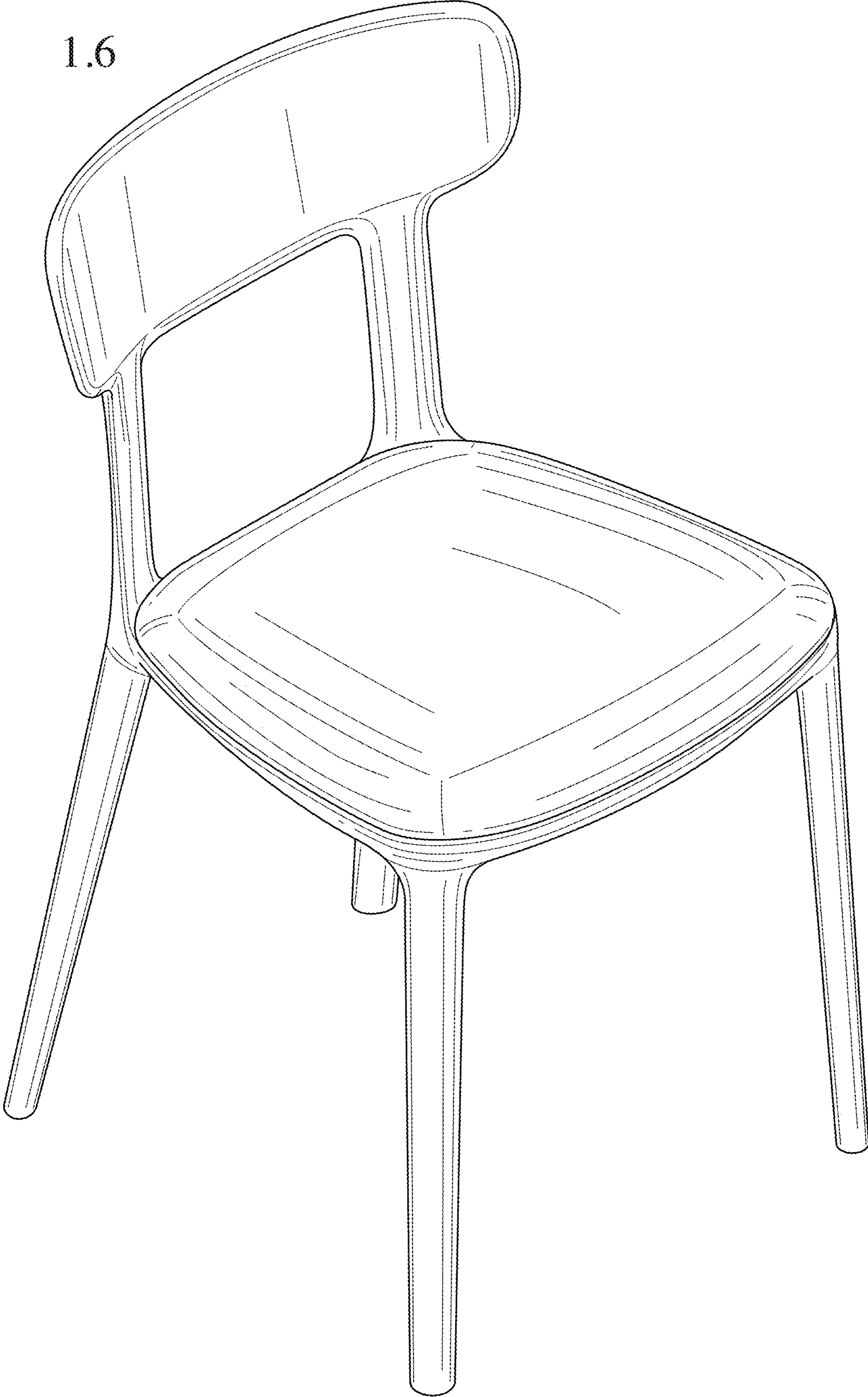
