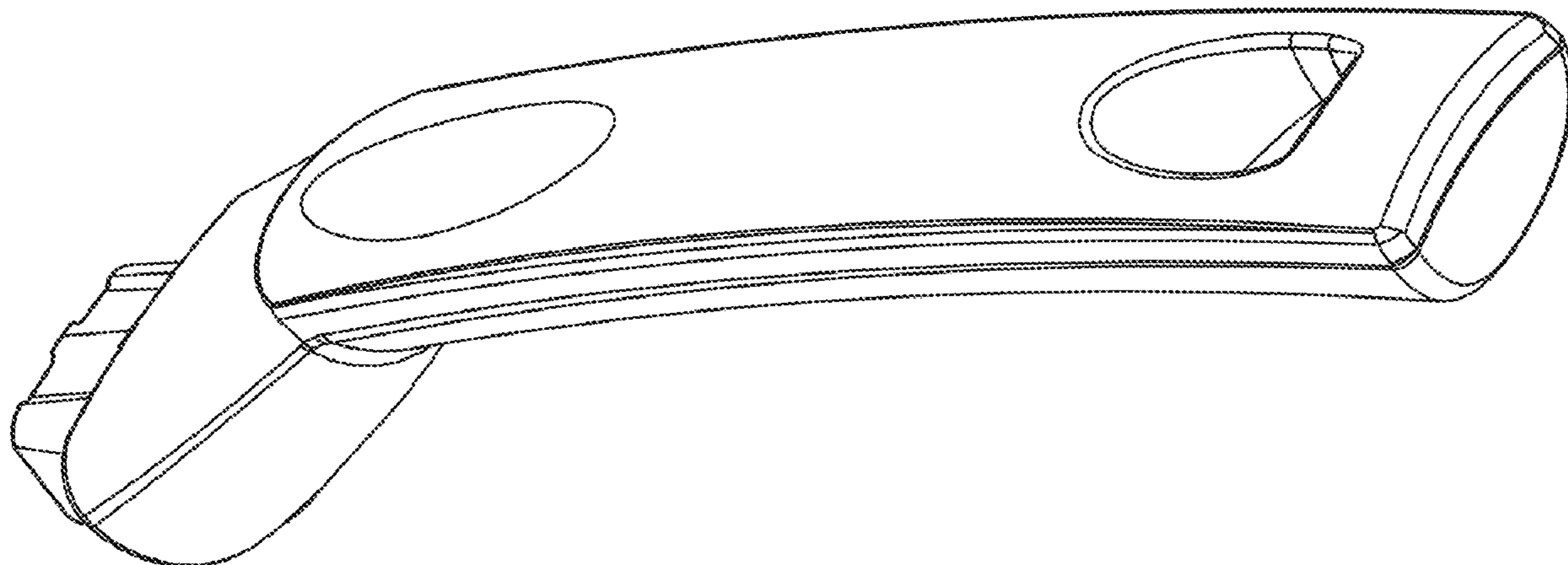

I claim, the ornamental design for a handle for cookware, as shown and described.

DESCRIPTION
FIG. 1 is a perspective view of a handle for cookware, showing my new design;
FIG. 2 is a side view thereof;
FIG. 3 is a front view thereof;
FIG. 4 is a rear view thereof;
FIG. 5 is a top view thereof;
FIG. 6 is a bottom view thereof;
FIG. 7 is another perspective view thereof; and,
FIG. 8 is a side view thereof, opposite from that of FIG. 2.
The broken lines and the areas within them represent portions of the handle for cookware and form no part of the claimed design.

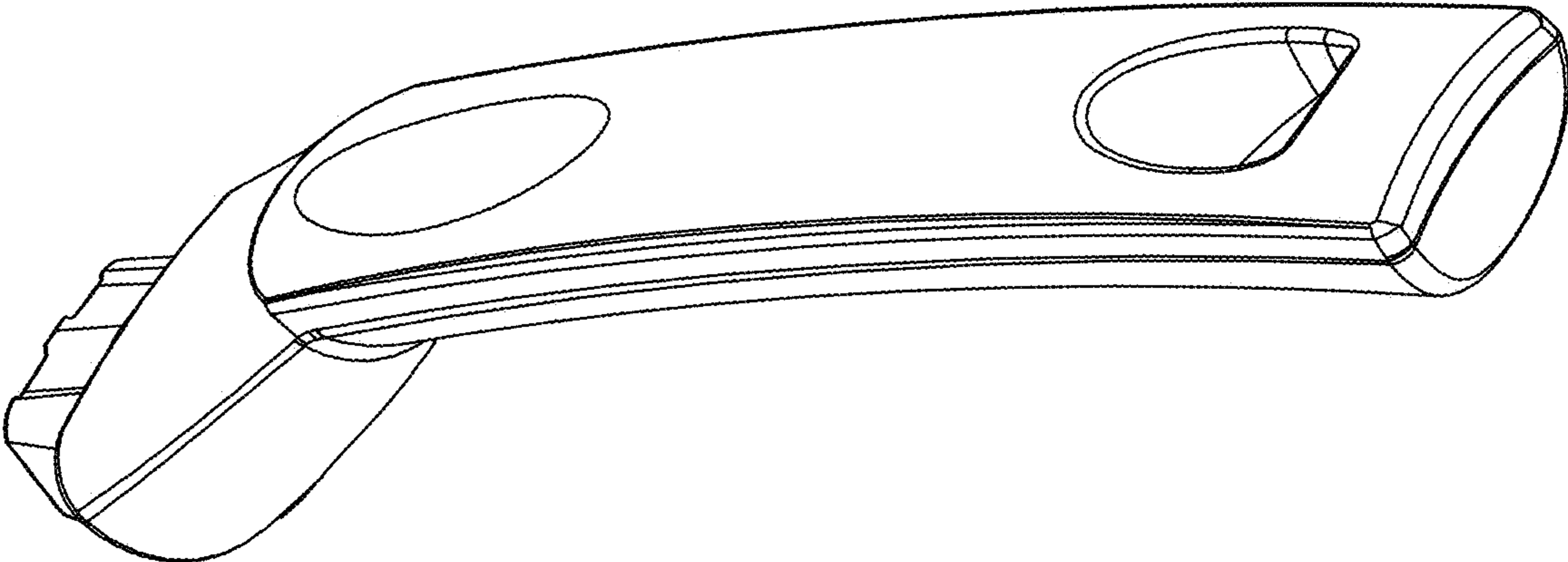

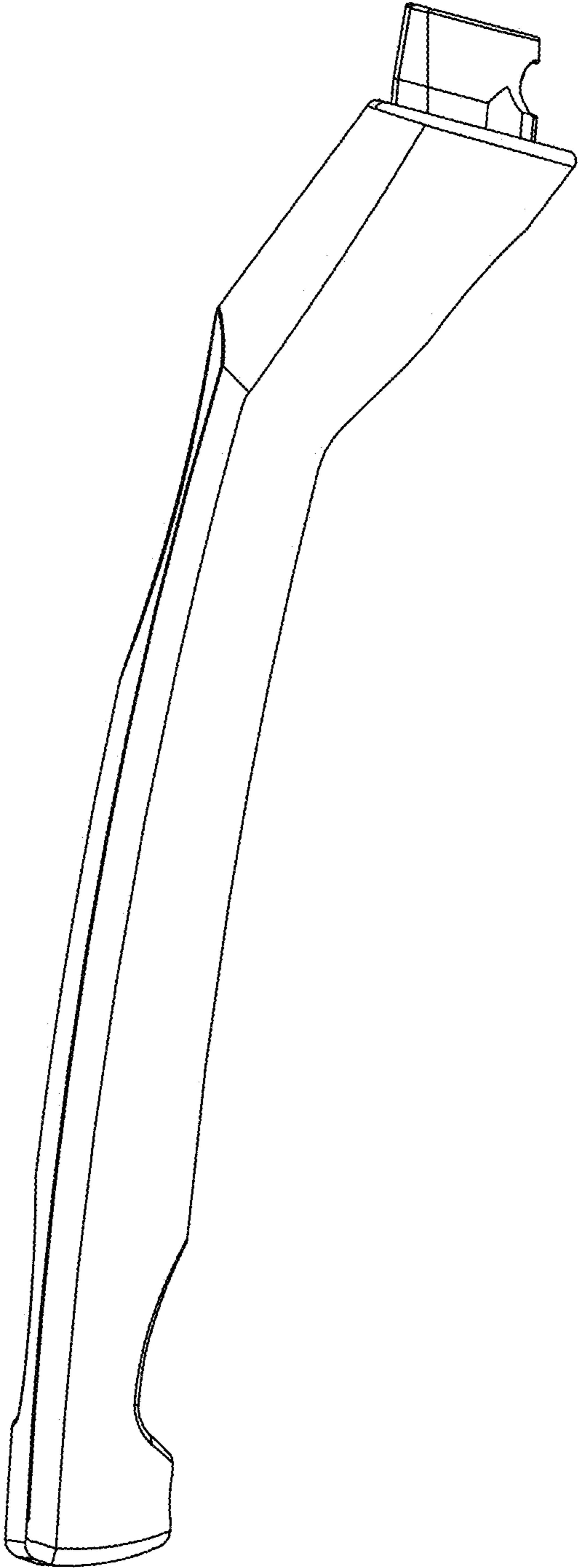

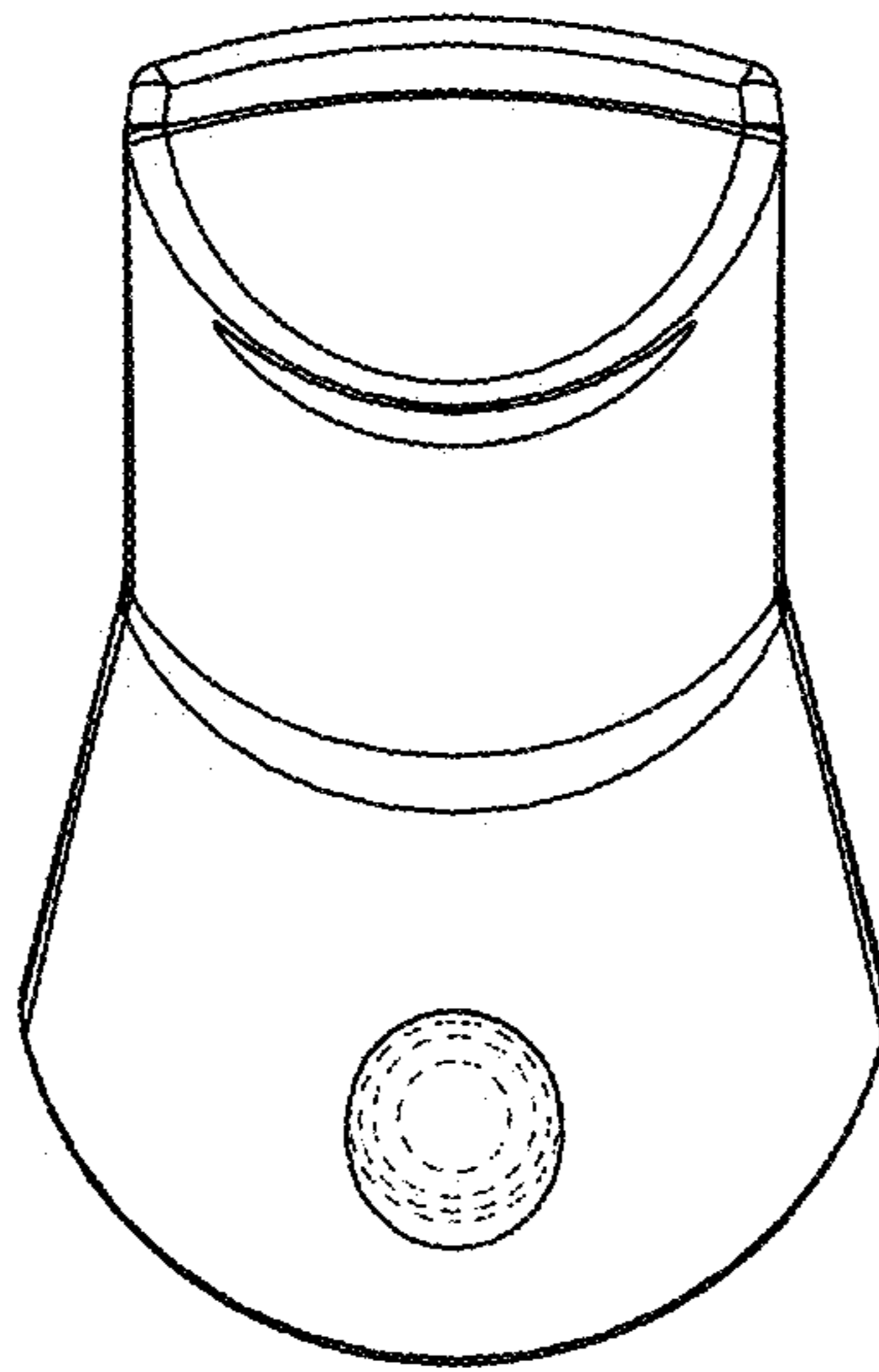

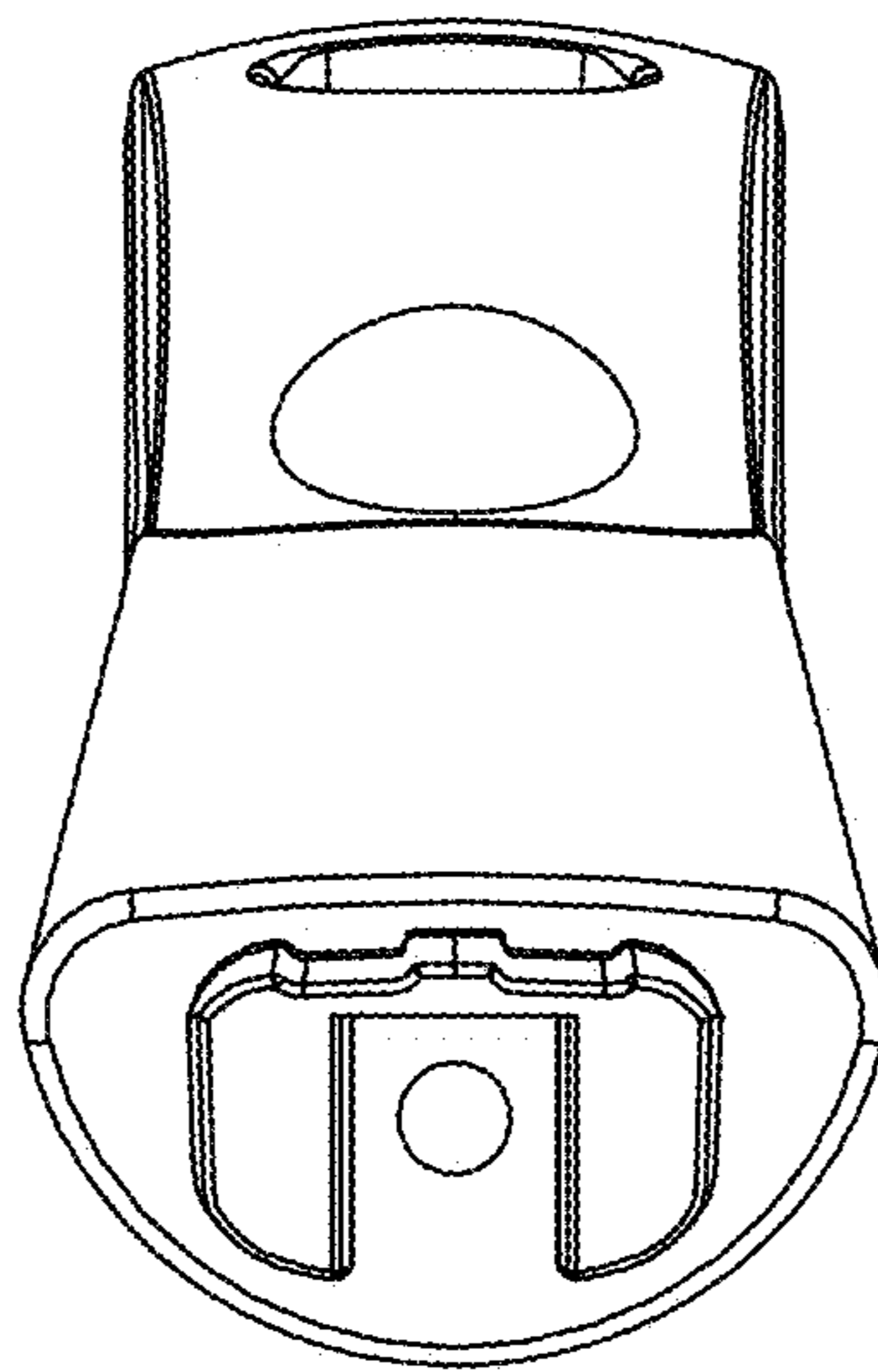

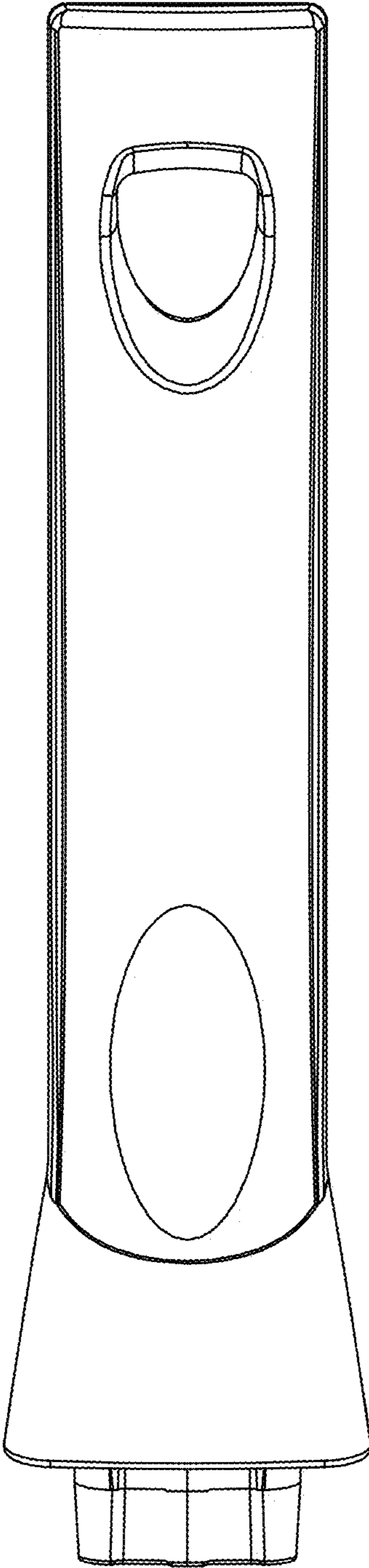

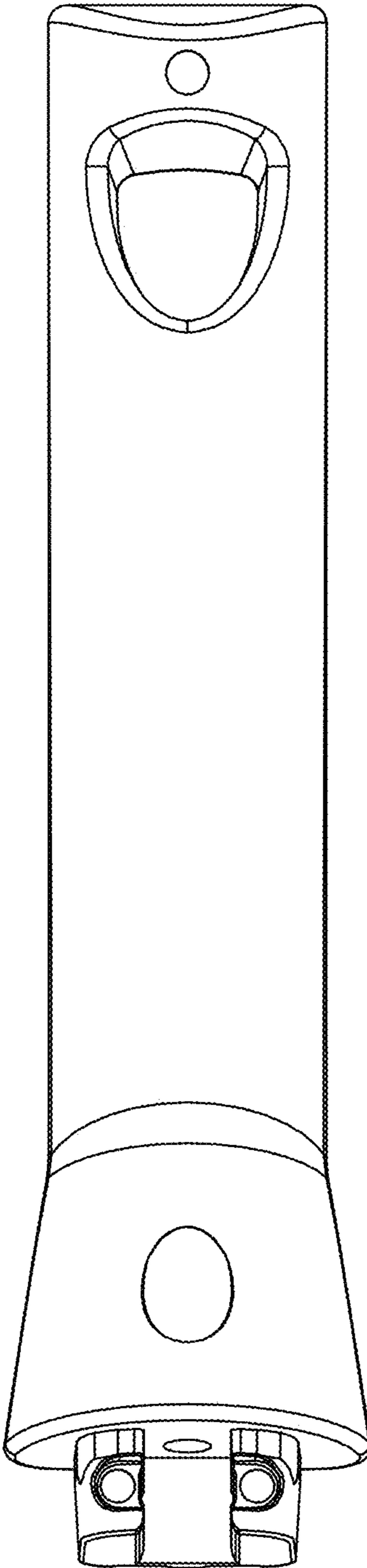

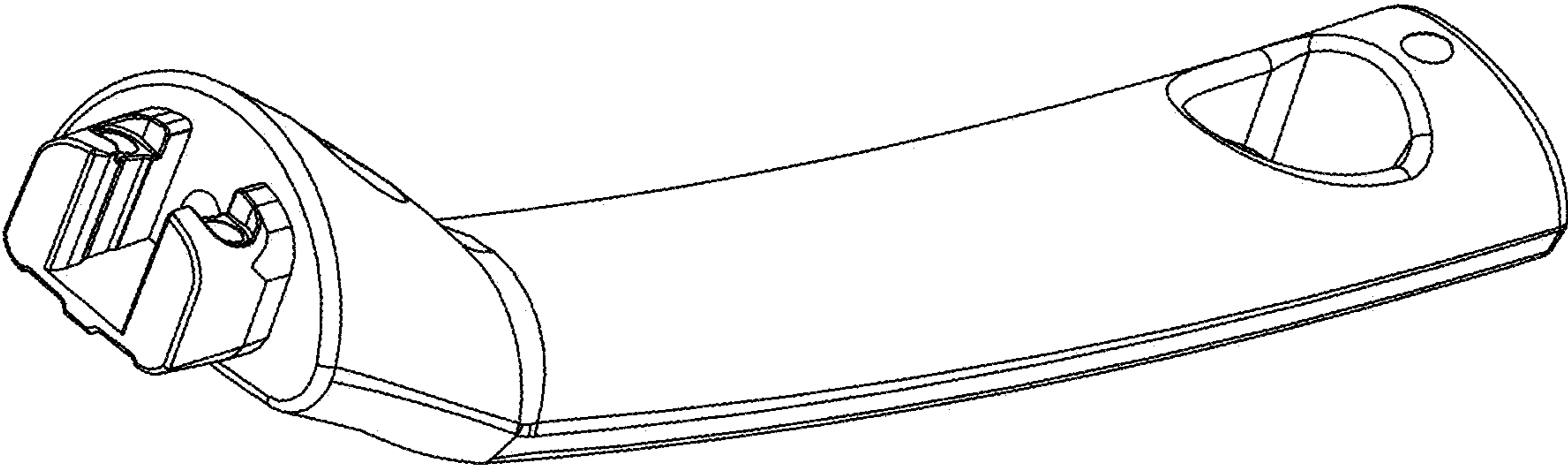

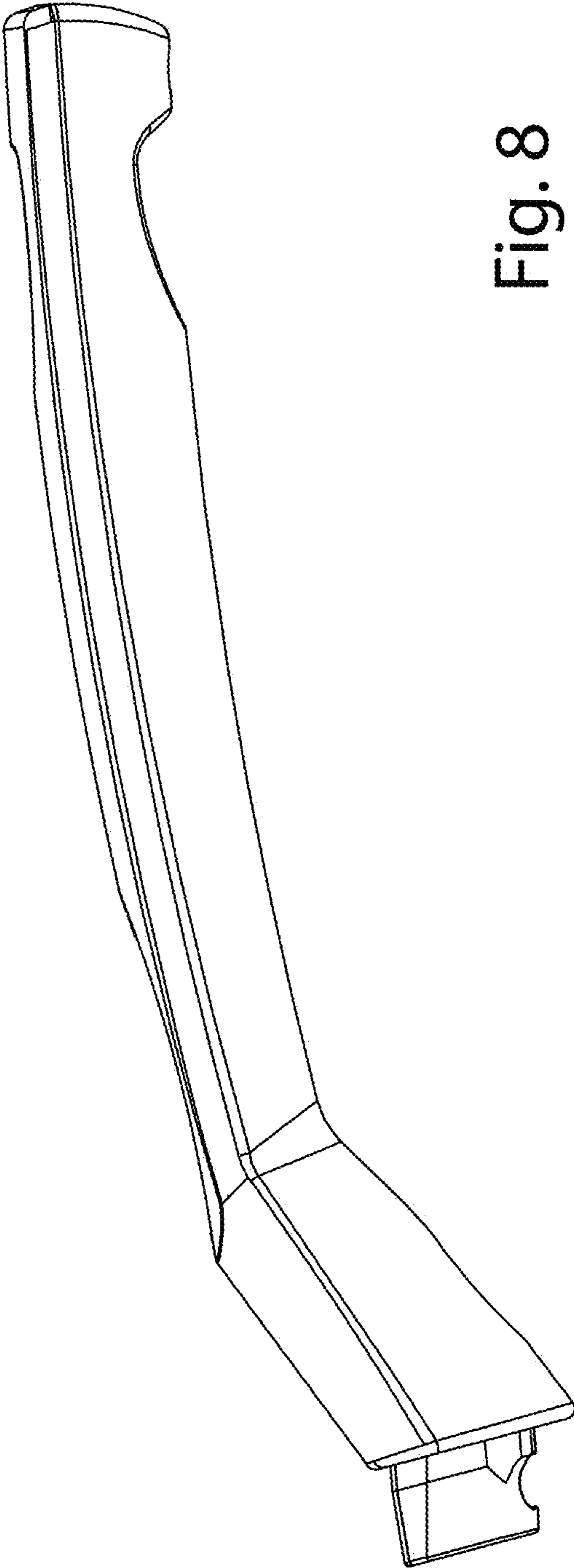
